"Holiday Lighting Budget to Exceed \$2 Million" [Issue #941]

The holidays are upon us here in Beverly Hills. The decor, the lighting, the special programs are a source of pleasure to all residents and guests.

I should like to point out that besides sharing December dates there is no relationship between Christmas and the Jewish period of Chanukah.

Christmas celebrates a significant birth in the history of world religions. I am most respectful of all those who find contentment and meaning therein.

Chanukah is not mentioned at all in the Bible. It is the annual remembrance of the first war fought to teach the message of RELIGIOUS FREEDOM for all people.

When the Maccabees 2200 years ago challenged the mighty Greek Empire that was their message. All people deserve the right to worship freely without coercion.

I have no argument with our city council allocating more than \$2 million for holiday decor. However, since percentage-wise

Council Won't Review 9200 Wilshire

Per Councilmember John Mirisch's request, the City Council considered—and then denied—reviewing a previous decision by the Planning Commission to approve a development at 9200 Wilshire Boulevard.

The project, which was originally approved 3-2 by the Planning Commission on October 12, will serve as a mixed-use





building with 54 residential condo units, about 14,000 square feet of ground floor commercial space, and up to 283 parking spaces located in a four level subterranean garage.

But Commissioners Craig Corman and Joe Shooshani dissented in the final vote, with Corman commenting that the project did not "advance the objectives of the overlay zone" because of modulation changes, and Shooshani expressing frustration regarding the lack of parking.

As to why he requested the item be brought before the Council, Mirisch said that to not do everything in their power to improve the project as much as possible "would be a dereliction of our duty."

"We have the ability to approve and



Mirisch also commented that the project was a prime example of an "age old developer ploy," in which the developer proposes an unfavorable project to make their actual goal appear more agreeable.


On July 13, The Planning Commission denied a request to add an additional 36 residential units to already 54-unit project, citing traffic concerns and noting that 90 units was simply too many for the area.

Planning Chair Lori Greene Gordon encouraged the Council to accept the commission's final decision but acknowledging that the project wasn't ideal to

begin with.

"I don't like the whole concept, but as long as we have the whole concept, this is the best way to approach it," said Gordon.

Ultimately Mirisch stood alone in his request for the Council to review 9200 Wilshire Boulevard. with Mayor Lili Bosse deeming the lengthy process thorough.





Matson Appointed to

mously recommended Matson to replace Commissioner Gidas Peteris, whose term is scheduled to end on December 31,

Matson is an architect currently residing in a "Modernist" house he renovated and remodeled in Beverly Crest. The architect member-at least one of which is required on the Architectural Commission-doesn't have to live in

Beverly Hills.

Matson must attend all Architectural meetings for six months from July 2018 through December 2018 leading up to his appointment on January 1, 2019.

Future Focused Schools Moves to Development Stage

Now that The Future Focused Schools team has toured the four K-8 schools and focused on building relationships, the group will now move into the development stage.

Superintendent Michael Bregy originally brought the Future Focused Schools idea to the Board in a presentation that discussed the BHUSD's currently unsustainable financial path.

Bregy said that because the district is currently at a financial "tipping point," the Future Focused Schools program would aim to "improve educational opportunities for students while ensuring long-term financial sustainability."

Committee member Jonathan Prince said that the next stage will consist of listening to professional educators in the coming weeks to discuss what happens

"The most important thing we can do is listening closely to [them] because they know lots of things we don't know," said

Currently, Prince says everything is on the table, from the potential of a middle school to a charter school.

"We have a big job ahead of us," said Prince. "We're able to ask of each other the hard questions, the unpopular questions, that lead to what's best for the school."

Prince noted that many committee members have a "different memory" of the old school district which had higher enrollment numbers and arguably a much higher degree of excellence. Others, on the other hand, have only experienced the current district.

"The disconnect is that there are those who say 'Why can't it be the way it used to be?' and there are others who say 'What's so great about the way it used to be?" said Prince.

The coming weeks, says Prince, will be dedicated to really listening and asking questions to outside experts in order to determine the best possible recommendation.

The group also plans to present their findings at a town hall meeting in the future so that community members can ask questions. The date is currently TBD.

City to Join Community Choice Aggregation Program

The City Council opted on Tuesday to join the Los Angeles Community Choice Clean Energy (LACCE) county-wide Community Choice Aggregation (CCA).

This will allow the City to join other districts in pooling electricity needs and purchasing and developing environmentally sustainable energy on behalf of residents, businesses and municipal agencies.

The decision comes after the City Council adopted in 2015 a resolution allowing the City to participate in a CCA feasibility study with other cities in LA County. The County of Los Angeles Community Choice Energy Business Plan concluded that the formation of a CCA program in LA County would be sensible and would yield "considerable benefits" to residents and businesses, according to the staff report.

It's estimated that end-user rates could be at least 4 percent lower than those of Southern California Edison, the city's former investor-owned utility. The difference would likely be even greater when comparing the rates for 50 percent and 100 percent renewable energy. The CCA would deploy about twice as much

renewable resources.

The Joint Powers Agreement negotiation meetings began in January, but the County intends to hold the sessions until a reasonable consensus is reached between the interested cities and the County.

The meetings focused around items like agreement recitals, the method of committee formation, special voting requirements, and board structure and distribution of voting shares.

A phased approach will roll out the CCA in an effort to address transition issues before residential customers join at the end. Phase 1, which includes county municipal facilities and municipal facilities in other cities like Beverly Hills, will begin in January 2018.

BHHS boys' water polo team loses in quarterfinals

Norman football team routed in season finale

Max Altan scored his second goal with four minutes, 24 seconds left in the third quarter to pull Beverly High within a goal of Valley View in their Southern Section Division 7 boys' water polo quarterfinal Saturday.

However, the Eagles scored the next four goals and led by at least three for the rest of the game in a 15-10 victory at Santa Monica High.

"We could have done a better job keeping our cool and staying focused" during Valley View's decisive run, Norman cocaptain Jonathan Artal said.

The Normans (11-11) led only once, 1-0, when Severyn Segal opened the scoring 51 seconds into the game. Beverly Hills tied the score for the final time 22 seconds before halftime when Ryan Abrishami scored the third of his

five goals, tying the score, 5-5.

Shane Randle's goal 12 seconds later gave the Eagles (17-14) a lead they would never relinquish.

Segal ended Valley View's run of four consecutive goals by scoring with 12 seconds left in the third quarter.

The Eagles scored the first two goals of the fourth quarter, increasing their lead to 13-7 with 5:35 to play.

Two goals by Abrishami and one by Nickolas Forys pulled the Normans within three, 13-10, with 2:52 left, but Shane Randle scored for Valley View with 2:49 and 1:10 remaining to seal the victory.

"They were an exceptionally strong team," Artal said of Moreno Valleybased Valley View, which was ranked second in the final Division 7 poll, five spots above Beverly Hills.

Culver City 49, Beverly Hills 0

The Normans ended their second consecutive winless season with a loss at Culver City Friday night in an Ocean League game.

"Kids played on a bad end of a team with a lot of speed which we don't have," Beverly Hills coach Steve Geanakos said. "We couldn't keep up with them. We moved the ball well. We couldn't get it in the end zone."

The shutout was the second straight the Normans (0-10, 0-5 in league play) suffered and fifth this season. They were held to seven points to other times.

Beverly Hills running back Ilai Dardashti, defensive lineman Greg Carter and tight end Jonathan Tansey drew praise from Geanakos for their play.

The Centaurs (10-1, 4-1) were ranked first in the final Southern Section Division 11 poll which was released Oct. 30.

The Normans are winless in their last 15 games with Culver City, a streak that includes two ties.

Beverly Hills was better than it was in 2016, Geanakos' first season as coach, when they were also 0-10 and were outscored 496-28, he said. The Normans were outscored 400-62 in the 2017 sea-

Beverly Hills has reached verbal agreements to play nonleague games in 2018 against Gardena and Sotomayor and

will again play nonleague games against Cerritos and Malibu, Geanakos said.

Gardena was 0-10 in 2017, Cerritos 1-9, Sotomayor 4-6 and Malibu 6-4.

Former Beverly standout center Chance Comanche scored four points in three minutes, 28 seconds of play in his debut with the Memphis Hustle of the NBA G League Saturday in Southhaven, Mississippi.

Comanche made his only shot and both free throws and pulled down two rebounds in a 120-116 loss to the Sioux Falls Skyforce, the Miami Heat's G League affiliate.

Comanche had two points, making his only shot, and one rebound in 3:27 of play in Memphis' 102-99 victory over the Salt Lake City Stars, the Utah Jazz's NBA G League affiliate, Sunday at Southhaven, Mississippi.

The Hustle (1-1) is the Memphis Grizzlies NBA G League affiliate.

COUNCIL SHOOTS DOWN LAGO VISTA

But the Mega-mansion owner's attorney says he will

The City Council voted on Tuesday night to deny both an appeal of staff's interpretation regarding the Municipal Code's basement definition and an appeal of the Planning Commission's decision to deny a Hillside R-1 permit at 1260 Lago

The project sought to export 2,498 cubic yards of earth-more than the allowed 1,500 cubic yards on a street less than 24 feet wide in a hillside, meaning that it would have needed an R-1 permit.

On May 11 the Planning Commission denied that request, citing that they were unable to make the findings due in part to resident concerns about the narrowness of the street

Woodbridge Investments LLC., the developer, hired attorney Benjamin Reznik to file an appeal on May 18 for not only the commission's decision, but also for staff's written interpretation of the municipal code's basement definition.


The interpretation explained how exactly to determine what portions of a singlefamily residence qualify as basement and therefore are exempt from counting toward the maximum allowed floor area on a site

The proposed project on 1260 Lago Vista Drive as designed did not comply with the Municipal Code. Specifically, about 3,000 square feet of the building's lowest level would have either needed to be eliminated or redesigned to qualify as basement under the interpretation in order for the project to be code compliant, according to the staff report.

But Reznik argued that staff's interpretation of that definition is a violation of due process and should not be applied to the Lago Vista

Property.

"While it may be called an interpretation, it's not an interpretation," said Reznik. "It's really a code change without a code process."



mously denied the appeal, citing both the city staff and city attorney's opinion that the interpretation upholds the code and upholds the intent.

This decision effectively rendered the Hillside R-1 Permit moot, which moved staff to offer several courses of action including withdrawing the appeal and receiving a refund of appeal fees, or continuing the hearing to a future date to allow the applicant time to redesign the


Reznik, however, decided not to go with either option but rather to move forward with the hearing.

"What we proceeded with was the right to have a certain amount of earth material be hauled out with proper safety conditions. That has nothing to do with ultimate final adjustments to the plan. There was no need to hold up the hauling permit," Reznik told the Weekly of his

decision to proceed.

No residents showed up in support of the project. Neighbor Anne Ostroff-whose

> husband Peter will soon join the Planning Commissioncalledthe plans "inadequate and not buildable" and resident Larry Murphy commented on the narrowness and downhill slope



"I've lived here many years and have never seen such galvanized opposition to a project," said attorney Ronald Richards, who lives on the street and represented 13 neighbors.

The Council acknowledged this opposition, but went back to the fact that the project is essentially nonexistent because of their previous decision on the basement definition interpretation.

"When we're talking about an R-1 permit, it's about something that can be built. Based on what we did with the last item, this cannot be built," said Mayor Lili Bosse, adding that she sat somewhere between shock, anger and frustration.

Ultimately, the Council voted unanimously to deny the appeal. Reznik says his client will now file a lawsuit.

FROM SAN FRANCISCO TO THE STATE

Fiona Ma on her first "Walk with the Mayor" and running for office

You've served on the San Francisco Board of Supervisors and in the State Assembly. What inspired you to run for state treasurer?

My first office was the San Francisco Board of Supervisors and I ran on a platform of helping small businesses, which I felt like I did. And then after you do a job for a while, you kind of get comfortable and you want to do a little bit more. The state assembly seat opened up where I could actually propose statewide changes. San Francisco-we're a very progressive city and we have a precautionary principle, so that means if something is thought to cause harm, we can actually pass it. We don't really debate [how much science there is]; we just say, "If a chemical is bad and people say it's bad, then let's ban it." I wanted to take it statewide. We wanted to pass free kindergarten statewide and ban toxic chemicals. The state gave me an opportunity to do that. I got 60 bills signed by two different governors—Arnold Schwarzenegger as well as Governor Brown in six years during the great recession. These bills were not tweaks to existing laws; they were actually real bills and first-inthe-nation bills. I was really happy, I felt I was successful in the legislature and then I faced term limits, so I had to sit out for two years. Then I ran for the State Board of Equalization which was a tax board. I really wasn't sure I wanted to go back into taxes because I was thinking maybe I'd run for state senate. But they took away the senate seat through redistricting. We changed to a citizen redistricting committee. They said, "Why does San Francisco, with 800,000 people, have two senators and two assemblymembers," so they [decided] to keep two assemblymembers and just have one senator. They

took away one of the senate seats, so that's why I decided to run for the Board of Equalization. Johan Klehs, who was also in the assembly at one time and on the Board of Equalization, convinced me that this would be the best job of my life. Honestly, it's a great job. I got to work again directly with small businesses, taxes is something that I understand, we hear tax appeals, so being that arbiter, that judge of the people listening to everyday cases was really

interesting. But I've been working on banking for the cannabis industry and trying to figure out how we can have a paper trail and make it safer for our communities who are dealing only in cash. So this is something I've been working on, so when

the opportunity to run for treasurer came up, I said, "I want to be the state banker. I've been working on it, I want to lead, I want to push the envelope."

You've been a strong advocate for Hepatitis B awareness and prevention. Why?

One out of ten Asians was born with Hepatitis B, and it was usually a mother to child transmission up until the 80's when the kids got vaccinated at birth. So my grandmother had Hepatitis B, who gave it to my mother, who gave it to me when I was born. In 2007 I did a press conference and a liver specialist said, "Ms. Ma, you have chronic Hepatitis B. One out of four people like you will develop liver cancer or require a liver

transplant." So of course I went home and [told my] mom that we needed to get our livers checked. We did, and actually caught my mother's liver cancer early. So she was one out of the four. Now, for me, every six months I'm supposed to go get my blood test and just keep track of my liver. But I am seen as the poster child in this campaign. We try to raise awareness, break the stigma, and just let people know that because you have Hepatitis B doesn't mean you can't have a normal relationship. It doesn't mean you can't have friends, you can't have a job. Because in China, it was treated like AIDS. Nobody wanted to talk about it because you could lose your job, you could get denied school, you could get kicked out of housing. And that's why it kept spreading, and that's why it's so prevalent in the Chinese community. By me talking about it, people have said, "We thought we were a pariah. Thank you for letting us know that you can get treated, that you don't have to die of liver cancer."

on the Board of Equalization. How has that background helped you?

The fact that I have actually prepared tax returns has given me a lot of insight and background when we hear income tax cases from the Franchise Tax Board. So if you get audited by the Franchise Tax Board

and you don't agree, you can either pay or you can come before the Board. There's not one case that has come before us in the last three years where I did not know the issue. That has been very helpful. I look at every case as, "Has the taxpayer tried to do the right thing? Did they follow their tax profes-

sionals? Or are they really trying to cheat the system?" Because I prepare tax returns and have worked with so many clients, I have that perspective of, "Did the client really try to do the right thing or where they relying on professionals and they just didn't know?" Sometimes you start a restaurant and you buy a POS

[point of sales] system, and the computer company didn't set it up right. How was a little mom-and-pop immigrant running a restaurant supposed to know? They bought a system, they trusted it, they didn't try to not pay their taxes. That's kind of the mindset that I have to come in with because I've worked with so many small businesses and I've done a lot of income tax returns. There's five of us [on the Board of Equalization], so a lot of times it's 3-2 on some of the more difficult cases. So sometimes I'm the swing on either side so I bring that hat into these cases.

Your husband [Jason Hodge] is a firefighter, who recently fought the Santa Rosa wildfires. Tell us about that.

He has a specialty—he is a logistics specialist. So when there is a fire happening and all these different 911 responders are coming, someone has to set up the camp and make sure it's organized for when people come in. [He covers] where they're going to report, where they're going to sleep, where they're going to get food. Someone needs to organize that whole thing so that's his specialty. He's been on four different wildlife fires this past year.

You attended this week's Walk with the Mayor. How was that?

Mayor [Lili] Bosse actually announced me and so people were like, "Oh who are you? Can we take a picture?" One guy gave me a hat. It was great. I got exercise, I met great people, we stopped at three different small businesses along the way. Zina Jewlery—a lot people said, "Hey we drive by all the time, we've never been in here," so the fact that they were open was good. And [there was] also Bloch Galleries. The owner came in and specifically opened up the gallery [for us] so they had great artwork. It was a great experience.



New Smoke-Free Multi-Unit Housing Ordinance

In order to promote healthy living and reduce unwanted exposure to secondhand smoke, the City Council has adopted a Smoke-Free Multi-Unit Housing Ordinance that will prohibit smoking in all multi-family residences, including apartments, duplexes, and condominiums.

- On January 1, 2018, smoking will be prohibited in indoor and outdoor common areas and in all newly leased or renewed/extended rental units.
- On January 1, 2019, smoking will be prohibited in all multi-family units, including all renter-occupied and owner-occupied units.
- Property managers such as landlords and homeowners associations have additional requirements.
