#### "Anonymous Letters Claiming Malicious Acts Target Police, City Staff, Residents" [Beverly Hills Courier Nov. 24]

I am in receipt of [the Courier's] defamatory article written by Victoria Talbot. There are several defamatory statements for which I demand both a retraction and an apology. It is easy to understand why [the Courier] would like to defame Captain [Mark] Rosen and myself. Ms. Talbot was personally named in our lawsuit against the City, a fact [the Courier] fails to inform [its] readers. [It] also neither had the journalistic integrity, nor honesty to even ask me about some anonymous letters that have apparently been written, but which I have not even read.

[The Courier's] article contains several false statements, starting with [its] belief the letters might bolster our lawsuit. Anyone that knows me, knows that if I write something, I stand behind it. I do not send anonymous letters. I never have and never will. If I take a position, it is clear and unambiguous. This letter bears my name because I stand up for what is right.

If [the Courier] had taken even a minute to

conduct research for [its] defamatory article, [they] would know that Greg Smith is an attorney I have known for decades, and respect greatly. He was my sponsor for the American Board of Trial Advocates [ABOTA]. He is the last person I would send a letter about as I have the greatest respect for him, and his abilities. If [the Courier's] paper, or reporter, asked Mr. Smith, he would have told you he was certain I did not send out any letters with his name. If anyone bothered to ask me, I would have advised [them] that having been involved in numerous lawsuits with Mr. Smith over the years I know he is not the type of person that would send an anonymous letter either.

ABOTA stands for the American Board of Trial Advocates. Only the top lawyers with extensive trial skills can even qualify. I do not write anonymous letters to settle lawsuits, I try them. I have approximately 19 verdicts in excess of \$1,000,000.00. I was nominated five times for Trial Lawyer of the Year. I as nominated twice for Street Fighter of the Year. One does not obtain these accolades without trying cases. Because of my trial skill I have been selected to the Super Lawyers every year since 2005, and one of the Top 100 Lawyers in America.

Why would Ms. Talbot want to defame Captain Rosen, or me? That is easy to understand simply by viewing the lawsuit we have filed. Some of the pertinent allegations in the suit state:

closed doors. Thereafter Spagnoli had lunch with reporter Vicky Talbot, from the Beverly Hills Courier."

"After lunch on December 27, 2016 Spagnoli met with ROSEN, saying, I hope the Courier does not pick up the story of the Vela arbitration decision in which Spagnoli poorly portrayed ROSEN, without justification. "

"On December 29, 2016, reporter Vicky Talbot, from the Beverly Hills Courier published a defamatory article about ROSEN, holding him in a false light."

Having been embarrassed by our lawsuit, it appears that Ms. Talbot now is seeking to defame Captain Rosen and me in retaliation for the claims. Not only is that improper Journalism, it is actionable.

While I set out in writing the evidence, Ms. Talbot hides behind anonymity, saying (falsely) "some sources believe the letters could be a way to bolsters allegations in a lawsuit." Ms. Talbot since your article hides behind a cloak of anonymity, I must ask, did you write these anonymous letters as a way of seeking to discredit us? Come clean. Who are your imaginary "sources?"

[The] article claims, "[O]ne source said that Gage has used "tactics like this" in litigation in the past." The assertion is false. I never sent an anonymous letter to bolster any claims. If [the Courier has] such a source, why not name him or her? Let them (and you) face cross examination in a deposition. I am sure once you are placed under penalty of perjury, you will either confess that your

claims are without merit, or you will simply refuse to answer the question. Either way, an apology and retraction from your paper is in required to mitigate the damages you have now caused.

[The] article also places Greg Smith and I both in a false light by suggesting, "Smith expressed bewilderment that any attorney would do such a thing." While Greg probably is bewildered that someone would use his name, as am I, I know that Greg never suggested I had involvement, and indeed, advised that he did not believe I would be involved, so [the] statements again mis-state the truth.

Before I sent this letter, I actually spoke with Greg Smith. Here is what he said, about [the Courier's] accusations against me "That's bull . The brief conversation I had with them (Courier) I told them I did not believe you (Brad) would do such a thing, that I've known you for years." Fortunately, [the Courier's] irresponsible reporting has not harmed a long term friendship I have had with Greg for years, because we did what [the Courier] should have done, we spoke to one another about [the] claims.

If there is secret sworn testimony as [the Courier claims], why did someone share that with you? Who is your source, Ms. Talbot? Why are you hiding behind anonymity? Did you write the letters?

### NOTICE OF PUBLIC HEARING

The Council of the City of Beverly Hills, at its meeting to be held on **Tuesday, December 5, 2017 at 7:00 p.m.**, or as soon thereafter as the matter may be heard, in the Council Chamber of the City Hall, 455 N. Rexford Drive, Beverly Hills, CA 90210, will hold a public hearing to consider:

AN ORDINANCE OF THE CITY OF BEVERLY HILLS REVISING REGULATIONS RELATED TO BASEMENTS IN SINGLE FAMILY AREAS OF THE CITY AND GRADING AND RETAINING WALLS IN THE HILLSIDE AREA OF THE CITY

The proposed ordinance includes the following measures, which may be further modified by the City Council:

- The definition of "floor area" in single-family residential zones is proposed to be amended to define a "basement" as an area that is located directly below the portion of a story above which has a finished floor level that is a maximum of three feet (3') above finished grade at any cross-section cut through the building with certain exceptions for driveways, light courts, pools and water features, and stairs and access ways that might otherwise cause a basement to be exposed by more than 3' above grade. The proposed amendments would also require a basement that extends beyond a story above to be located entirely below both finished and natural grades. (Proposed amendment to Beverly Hills Municipal Code [BHMC] § 10-3-100.)
- A definition of "light court" is proposed to be added to the BHMC. As proposed, a light court would be an excavated area adjacent to a building that extends more than 4'-0" from the building perimeter that is enclosed on four sides, open on the top, and allows light into a below grade level of a building. The BHMC does not currently contain a definition of light court. (Proposed addition to BHMC § 10-3-100.)
- The definitions of "finished grade" and "natural grade" are proposed to be added to the BHMC to ensure clarity of the code and consistency in its application. (Proposed additions to BHMC § 10-3-100.)
- The language governing the maximum height of walls, fences, and hedges within the Hillside Area of the City is proposed to be amended to limit the total height of any wall fence or hedge to 12'-0" regardless of the side of the wall, fence, or hedge from which a measurement is being taken. (Proposed amendment to BHMC § 10-3-2516.)
- The language governing the construction of series of walls in the Hillside Area of the City is proposed to be amended to allow for a maximum cumulative height of 12'-0" for all walls constructed on the same property within any 50' perpendicular section. A 10'-0" landscaped horizontal distance must also be provided between each wall. (Proposed amendment of BHMC § 10-3-2516.)
- The calculation method provided in the BHMC that defines the total cubic yards of landform alteration (cut/fill) allowed on a site in the Hillside Area of the City within a five year period is proposed to be amended. (Proposed amendment of BHMC 10-3-2521.)
- The regulations regarding import/export of earth material within the Hillside Area of the City are proposed to be amended to clarify that cubic yardage will be based on in-ground earth volumes. The code does not currently stipulate whether the amount of earth material is in ground compacted earth material or excavation un-compacted earth material. (Proposed amendment of BHMC 10-3-2521 and BHMC 10-3-2521.1) The City Council may also consider revisions to BHMC Section 10-3-2521 and 10-3-2521.1 to reduce the number of cubic yards of earth material that may be imported or exported from sites in the Hillside Area to account for the difference in volume from in-ground compacted conditions, and post-excavation un-compacted conditions.
- The definition of "height of building" is proposed to be changed to bring the method of measuring the height of buildings in the Hillside Area of the City in line with the method of determining whether or not a portion of a building can be considered a basement. (Proposed amendment of BHMC 10-3-100)
- The findings pertaining to Hillside R-1 Permits are proposed to be amended to add a provision that the total number of construction-related vehicle trips associated with a project as a whole may be considered by a reviewing authority when considering a Hillside R-1 Permit for import and export of earth material. (Proposed amendment of BHMC §10-3-2550)
- Other non-substantive changes to reorganize and reorder Article 25 of Chapter 3 of Title 10 of the BHMC, which contains development standards applicable to the Hillside Area of the City.

This Ordinance has been preliminarily assessed in accordance with the authority and criteria contained in the California Environmental Quality Act (CEQA), the State CEQA Guidelines, and the environmental regulations of the City. The City Council will consider whether the adoption and implementation of the Ordinance be found exempt from CEQA pursuant to Section 15061(b)(3) as there is no possibility that adoption and implementation of the Ordinance may have a significant effect on the environment because the Ordinance does not authorize construction and it would impose greater restrictions on certain development in order to protect the public health, safety and general welfare. Additionally the City Council will consider if adoption and implementation of the Ordinance is eligible for a Class 8 categorical exemption pursuant to Section 15308 of Title 14 of the California Code of Regulations for actions taken to assure the maintenance and protection of the environment.

At the public hearing, the City Council will hear and consider all comments. All interested persons are invited to attend and speak on this matter. Written comments may also be submitted and should be addressed to the City Council, c/o City Clerk, 455 N. Rexford Drive, Beverly Hills, CA 90210. The comments should be received prior to the hearing date. Any written comments received by Tuesday, November 28, 2017 will be attached to the agenda report regarding this item. Any comments received after November 28, 2017, but prior to the public hearing, will be distributed to the Council under separate cover.

Please note that if you challenge the City's action in regards to this matter in court, you may be limited to raising only those issues you or someone else raised at a public hearing or in written correspondence delivered to the City, either at or prior to the end of the public hearing.

#### Former Friar's Club Site Goes Back to the Drawing Board

At a special meeting on Tuesday night, a unanimous Planning Commission deferred a request for an Overlay Zone at 9908 South Santa Monica Boulevard, formerly the Beverly Hills Friar's Club, to allow a mixed-use project with 27 residential units and 3,541 square-feet of ground retail uses in a commercial zone.

The project would include a total of approximately 93,374 square feet of floor area and a ground floor with retail and residential units. It would also include two levels of underground parking containing a total of 83 parking spaces for residents and customers.

Several residents spoke at the hearing both in opposition and support of the project, citing traffic concerns and a necessity for more housing.

Former Architectural Commission member Barry Bernstein, said that the new project would be a "great" addition to the City as he and his wife are considering downsizing.

"We really hope you approve the 9908 Santa Monica project," said Bernstein. "It's exactly what we would be interested in—a smaller upscale development that provides us with our own private outdoor space and walking access to where we want to be."

Commissioner Alan Block, who lives near the project, expressed concern about traffic, height, and the character of the neighborhood if the project were to be implemented.

"If this building is approved, it's clearly



going to change the character of Little Santa Monica and there's no retrieval from that," said Block. "I think 66 feet is too high. We look at the Peninsula Hotel right across the street, which is a 45 code compliant project and a good neighbor to everybody. Five stories is too much."

Commissioner Lori Greene Gordon asked if former Mayor Tom Levyn, who is representing the developer, would be willing to give up the Overlay Zone.

Levyn requested that instead of simply denying the project, the commission meet with the developer and see what kind of project they could come up with that would be code compliant.

"If it turns out that you like every part of it but not the Overlay Zone, we would understand that," said Levyn. "Give us the opportunity to come back."

The commission opted to continue the hearing to January 2018 with a project design revision. At that point, if the commission is satisfied with the changes, they will establish an ad hoc committee.

# **Tokens Singer Mitch Margo Passes**

Singer-songwriter Mitch Margo—best known as a member of the Tokens—passed away in his sleep on November 24 at his home in North Hollywood. He was 70.

Raised in Brooklyn, NY, Margo was a professional recording artist by age 14 with the Tokens. Not long after, the band enjoyed success with the Billboard #1 hit, "The Lion Sleeps Tonight" in 1961.

The group also had their own publishing company, Bright Tunes Publishing; produced hit records for The Chiffons, The



Happenings, Randy & the Rainbows and Tony Orlando & Dawn; and wrote the song "Laugh" for The Monkees. They performed annually at the "Concerts on

Canon" series in Beverly Hills.

Margo released his first solo album, ABCDEFG, in 2010 and was also an artist whose paintings have been exhibited in galleries and children's books.

Earlier this year, both Mitch and Phil Margo co-directed a workshop production at Beverly High entitled "Oh My Goddess."

Margo's survivors include his brother and bandmate Phil Margo and sister-in-law Abbie Margo; sons Damien, a 1991 Beverly High graduate, and Ari; nephews BHUSD Board of Education member Noah Margo and Laura Hornwood Margo, and Joshua Ginsberg-Margo and Lynn Ginsberg-Margo; niece Neely Margo Irwin; sister Maxine Margo and mother Ruthie Margo, both of Chappaqua, NY.

A service will be held at 10:30 a.m. on Thursday at the Riverside National Cemetery in Riverside.

#### Dog Park to Enter Trial Period

The City Council heard last Tuesday a progress update of the Community Dog Park following the completion of its first year of operation.

On September 18, Recreation and Parks Liaisons Mayor Lili Bosse, Councilmember John Mirisch, Chair Howard Rosoff and Vice Chair Simone Friedman met to review the progress

and formed several recommendations for Council.

They recommended maintaining the hours of operation from 8:00 a.m. to 8:00 p.m. seven days a week, expanding park access for a six-month trial period, keeping the registration process in place to ensure Dog Park users' dogs have current vaccinations, and having a Park Ranger present during peak hours, High Holy Days and weekends.

Councilmember Robert Wunderlich suggested that the opening time be moved from 8:00 a.m. to 6:00 a.m., which would potentially change the peak hour for the ranger. It was also suggested to move the closing time from 8:00 p.m. to 9:00 p.m.

"We would have to observe it when we do switch the hours to see if 6 a.m. to 8 a.m. becomes peak and if 8 to 9 becomes peak and extend the hours accordingly," said Management Analyst Stephanie Harris. "[But I'm] not sure what volume of patrons we'd receive initially."

Councilmember Lester Friedman said that the allowance of non-residential dogs should be looked at first because without that information the Council wouldn't have a full picture of what the impact would be.

"I'd like to seethe proposal as presented go into effect first with the non resident dogs and then look at this again in six months," said Friedman. "[But] I don't have an objection to [changing the open hours]; I just think it would skew the statistics we're going to have."

Ultimately, the Council showed general consensus to extending the open hours to 6:00 a.m. to 9:00 p.m

#### City Receives New Art Pieces

The City Council has accepted two new Fine Art Donations, "Folded Square—Alphabet G (Folded G)" by Fletcher Benton and "Sense of Place" by Jose Davila.

"Folded G" was created in 1980 and installed in resident Mark Lucheim's backyard. Upon moving, he proposed the donation of the 8", 1,300 lb. piece to the City.

Lucheim has already paid to have the piece moved from his home into a storage facility. He also plans to pay for relocation and installation of the piece onto city property, the creation of a concrete base, and restoration of the piece. The City will pay for trenching and lighting the piece and a basic engineering study to deter-

mine the base's composition.

Nancy Hunt-Coffey said that the piece is structurally in good condition, but could use a coat of paint. She said that although Folder G could be susceptible to minor scratches, maintenance would be similar to how playground equipment is treated, calling the piece "durable" with a "hard finish."

The costs, not to exceed \$10,000, will be financed by the City's Fine Art fund—reserved for art-related expenditures.

"This piece has been in Beverly Hills for a long time and it's a quality piece. It will be wonderful for our city," said Mayor Lili Bosse.

Davita's "Sense of Place" is comprised of a number of pieces which fit together to create a cube. The entire cubic piece was first installed in West Hollywood Park and is currently being taken apart into 40 pieces that will be placed in different locations. One to three of these 40 pieces will likely be placed in various areas around the Beverly Hills City Hall campus.

It will be installed by March 2018 and on exhibit for about two months at which point the pieces will be reassembled back into the cube. It will have no fiscal impact as the piece is a temporary loan.

At the recommendation of the Fine Art Commission and City Council liaisons Bosse and Councilmember John Mirisch, the City Council accepted the loan.

"Free fine art is the best fine art," said Mirisch.

The conversation will be moderated by Tananarive Due, author, activist, and professor of Afrofuturism and Black Horror at UCLA. honor his legacy. We are now thrilled to have Joe, Tavis, Shamell, Lula and Tananarive together on our stage to discuss not only the lasting contributions of Mr. Gregory, but also what the next generation of artists and activists can do to further the conversation surrounding racism and social justice."

What made you want to pursue ministry?

In the early 1980s, after operating a successful singing telegram business in Fort Wayne, Indiana, I moved to

Los Angeles and I thought I was comtheater. I'm conservatory trained. A voice said "Go west, young man" so I came to Los Angeles. I heard about this church that Pat Boone went to and it really changed my life. That's really when I became a

dedicated Christian. With the Foursquare Church I ended up working on staff and later I went to seminary, I met my wife [Cecilia] here in LA thirty years ago. Both my wife and I were on the staff of that church. So that's how I got into the ministry. We are both licensed and ordained ministers. We've been in Beverly Hills for five years now.

Tell us about being a teacher in the Los Angeles Unified School District.

I teach sixth grade for LAUSD because I am a bivocational pastor, meaning that I work so that we can actually support the

My mantra is that we have to touch their hearts before we touch their heads, so I am very relational and anyone who knows me knows that. You have to touch someone's heart—that can be in ministry, that can be in education, that can be in sales. Tell us about your family.

#### There aren't many practicing Christians in Beverly Hills. What's it like being a minister here?

The church [has been] in Beverly Hills for 32 years. It started out at the Beverly Hilton.

We have a lot of Jewish friends in Beverly Hills and God-fearing people. There are a lot of synagogues that serve the area an we're blessed in Beverly

I deal with hurting people and healthy people all the time. Beverly Hills is a wide open field for people to experience and receive God's love. Christians and Jews have a shared history. I feel like God has given us the community. Yes, we have our church but we have an even greater outreach just to love to love on the community.

We are the proud parents of a beautiful 26-year-old daughter, Jessica. After getting her degree in psychology from Azusa Pacific University, she's now completing beauty school. We live in Northridge. We would love to live in Beverly Hills; we just need to find affordable housing.

#### Why do you think religion is important in 2017?

People need anchor. There's П havel of a world famous celebrity on my left playing music driving her Rolls Royce, and on my right is a home-

less person taking food out of the trashcan. I'm sitting in the middle as a pastor in the City and I'm thinking that they both have needs. They both have stuff going on in their life. I will tell you this, Beverly Hills is a hard place to minister because many people don't think they need God. When people are searching, they're searching for answers. Everybody is giving an answer right now. I know that what the Lord did in my life—if he can take me and turn my life around and give me a solid foundation, he wants to do that for other people too. We're there just doing what we do.

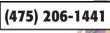

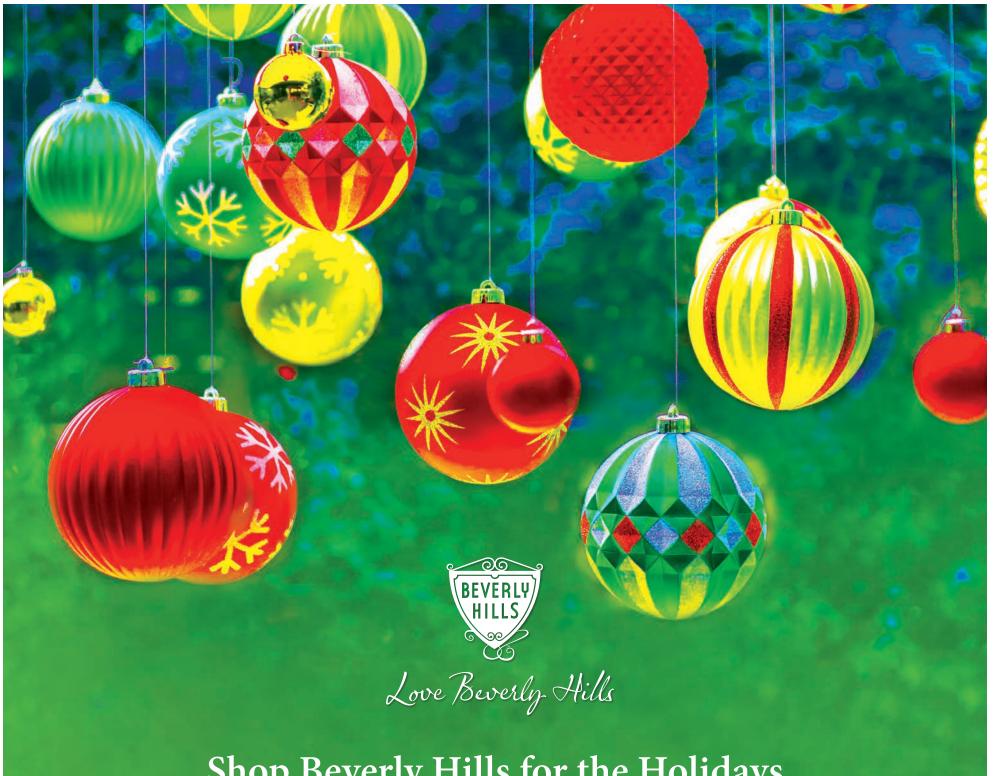
