The Beverly Hills Fire Department (BHFD) sent out a strike team yesterday to the Tomas Fire. As a part of a mutual aid agreement with other agencies, the strike team worked to assist with the wildfires that enveloped numerous locations in Southern California, including nearby

"Future Focused Schools" Adds Meetings

Although its last meeting was initially slated for November 30, the BHUSD Future Focused Schools (FFS) group has added three more meetings as the committee nails down the specifics of school reconfiguration.

Former BHEF President Jonathan Prince—a member of the committee said that the need for additional meetings stems from the fact that the committee has not yet reached a general consensus. They are still learning about the "hard numbers" of what potential changes might mean for the district-from athletics to arts to, of course, reconfiguration.

Prince said that a split has somewhat divided the members into those who are willing to embrace change, and those who desire to keep the district the way it is-many of whom have been rooted in the community for years.

Although this mindset might make the decision an emotional one, Prince says it must be based on financial realities.

"Often we stick to traditions and history because we love it so much, but we're not paying attention to how times are changing and how that might require us to at least pay attention to the possibility of changing the way that we are educating our kids," said Prince.

One of those possibilities is reconfiguring one of the campuses as a middle school instead of maintaining the currently K-8 model the district has used for

Prince said that by having additional meetings, FFS will be able to delve deeper into the possibilities of reconfiguration. This includes learning about teachers' contracts, certification of teachers at the middle school level, and the potential financial impacts of maintaining the cur-

"I would say that right now what we aren't prepared to do is tell anybody what we think, because we're still a bunch of individuals," said Prince. "But people are beginning to understand the price that we'll pay if we don't make significant changes.'

Once consensus is reached, the FFS committee will present their findings not only to the Board, but at a Town Hall event open to the community.

Superintendent Michael Bregy first brought forth the idea of the now-22-member committee several months ago in a presentation that discussed the BHUSD's currently unsustainable financial path.

Bregy said that because the district is currently at a financial "tipping point," the FFS program would aim to "improve educational opportunities for students while ensuring long-term financial sustainability."

The next meeting will take place on December 18.

Korbatov Selected Board President Despite Repeated

Lisa Korbatov was unanimously elected the new Board of Education president on Tuesday, but not without having missed, left early, or arrived late to several Board meetings over the last few years.

According to the chart below, Korbatov has arrived late or left early nine times since February 9, 2016. She has been absent from 12 meetings since April 12, 2016.

Although Korbatov's election was unanimous, Mel Spitz and Lisa Korbatov the Board appeared more divided when it came to the vice presidency. Korbatov and Goldstein nominated Board member Noah Margo for Vice President, stating that the position shall be determined by rotation based on how long each member has served on the Board.

"That's the way our by-laws read," said Goldstein. "It doesn't talk about concurrent or a break. It talks about service on the Board based on how long you've been a member. Therefore the rotation that we undertook two years ago was Mr. Spitz, Mrs. Korbatov, Mr. Margo, and Mrs. Hacker. That is the rotation that this Board decided to work with and that's the precedent that we have set."

But Board member Isabel Hacker-who was the top vote-getter in the 2015 Board election and thus, next in line for the vice presidencysaid the full Board did not have a previous conversation about the interpretation of the by-laws.

"I think it's incumbent upon the future Board to really zone in on this policy and adopt one or the other so that there is clarity going forward," said Hacker.

Both Hacker and outgoing Board President Mel Spitz abstained, with Spitz stating that electing Margo is a "violation of the by-laws" since Hacker was, in his view, the rightful successor.

Board Approves City's Offer to Monitor Oil Well

The Board of Education voted 4-0 (with Board member Lisa Korbatov absent) on November 28 for the City to pay up to \$8 million to monitor the Beverly High Oil Well drill site, which includes plugging and capping 19 oil wells.

The offer follows energy company Venoco's April decision to file for bankruptcy, which put the District in charge of all well operations. The company agreed to pay the district \$760,000 as apart of the final settlement agreement.

But that's not nearly enough to cover the almost \$14 million projected cost of capping the well and fixing the site.

The agreement with the City acknowledges "that the District does not unencumbered reserves in excess of that required to fund its reasonable multi-year

operating projections," according to the staff

The City will assume responsibility for the preparation of plans and specifications, as well as the retention of contractors, contractors' insurance and general liabili-

Currently, the district pays \$17,7000 a week to monitor the oil well, in addition to already having shelled out over \$400,000 on repairs and permits.

The City formally approved the agreement on Tuesday.

New Commissioners to be Appointed

The City Council approved on Tuesday three new replacements to the Cultural Heritage Commission and two new replacements to the Health and Safety Commission.

Former Recreation and Parks Commissioner Jill Tavelman Collins



Craig Corman

will fill the position Commissioner Lisa Greer whose term is scheduled to end on June 30, 2018. Current Planning Commissioner Craig Corman, second the appointment,

will fill the position of Commissioner Maralee Beck whose term is scheduled to end on December 31. And the third appointment, Kimberly Reiss, will fill the position of Commissioner Rebecca Pynoos whose term is scheduled to end on June 30, 2019.

Craig Corman retired from the Planning Commission last year, but returned in March at request of the City Council. His term ends on December 31.

Although the Municipal Code states that a commissioner must wait one year after the end of their term before applying for another commission, the Councilmembers said that Corman's case was unique, as he was technically completing Commissioner Howard Fischer's

"With Craig, it's an exception in that we had asked him to serve," said Mayor Lili Bosse. "In this instance I feel an extension should be made, but in the future we should go forward with the one year

The decision follows the Cultural Heritage Commission Interview Panel's meeting on November 20 where they interviewed six applicants for two upcoming positions. The Interview Panel consists of Councilmember John Mirisch, Councilmember Robert Wunderlich, Cultural Heritage Commission Chair Noah Furie and Cultural Heritage Commission Vice Chair Richard Waldow.

Cathy Baker will serve as the first Health and Safety Commission appointment, filling the position of Commissioner Lisa Kay Schwartz whose term is scheduled to end on December 31, 2018. Cedars-Sinai Cardiologist Kirk Y. Chang, MD will serve as the second appointment, filling the position of Commissioner Myra Lurie whose term is scheduled to end on June 30, 2019.

Both must attend all meetings for the six months leading up to their respective appointments.

North Elm Could Replace

The Recreation and Parks Commission showed support for replacing the Idaho Locust trees on the 100-300 blocks of North Elm Drive with Drive Chinese Elm

The discussion came after a group of residents had expressed concern for several years that there were ongoing failure to thrive issues with the Idaho Locusts, originally planted in 1996 as a part of the Street Tree Master Plan.

Last year, North Elm residents presented a petition requesting that the City replace the trees with healthy new ones. 65 percent of the affected addresses signed the petition, which was over the minimum 50 percent requirement.

The Recreation and Parks Commission voted in May to develop a Street Tree Master Project to replace the trees, encouraging the installation of Drake Chinese Elms.

At the meeting, though, Pfalzgraf suggested changing all 50 of the Locust Tree sites in order to create symmetry with the surrounding area.

"I understand your desire for symmetry, but I have a real problem with cutting down healthy trees," said Commissioner Alissa Roston. "I think that's not a wise

Ultimately the Commission voted just to replace the Idaho Locusts on the 100 to 300 blocks of North Elm. The cost to remove them is approximately \$7,000. The cost to plant 53 Chinese Elm Drake trees is \$35,000, making the total project

The proposal will now be presented to the City Council at a future date.

New Avra Restaurant to Remove Trees

Avra Restaurant, also known as the former Hakkasan space within the MGM building, will remove two trees from the public right-of-way in order to establish and open air dining area.

Avra has sad that the trees would othervise restrict the boundaries of the open air dining area. The restaurant also requested installing an elevated deck within the open air dining area in order to make the open air dining area level with the inside of the building.

The subject trees are one Mexican Fan Palm and one Indian Laurel Fig, located adjacent to the restaurant's proposed open air dining area. Because of the location, the sidewalk path of travel would be reduced drastically if the City Council had chosen to keep the trees in place.

According to the staff report the applicant did not express interest in reducing the open air dining area, claiming that it would "adversely impact the design and viability of the restaurant."

Although the City's Urban Forest Manager Ken Pfalzgraf generally doesn't support the removal of trees without replacement, an assessment of the project led to the conclusion that replacement is just not possible because "sufficient space does not exist within the right-of-way." Additionally, the staff report noted that the subterranean garage beneath MGM encroaches under the sidewalk, thus precluding the establishment of new tree wells.

Because the applicant would be required to compensate the City for the tree removal, the proposal would have no fiscal impact.

"I'm a little bit reluctant to have trees removed, but this looks like a worthy project," said Councilmember John Mirisch. "Whatever we do, we should have in place legal protection that if the restaurant moves the trees are restored."

Pfalzgraf said that the trees are a "good size" and can easily be removed and placed elsewhere.

David Merabi Stem Cell Donor

26, performed a cheek swab in order to enter the National Marrow Donor Program. The purpose? To register into a database that would potentially find his

friend Adam Krief a life-saving bone marrow transplant.

Although Krief's Facebook campaign page, "Hope 4 Adam", amassed over 15,000 likes and registered over 23,000 people, the father of three tragically did not survive.

As of July, however, 45 other patients matched a donor as a result of individuals who signed up for Adam's campaign.

Merabi was one of them, having received a call just five months after signing up that he could be a match for somebody. After two preliminary blood work tests to ascertain that he was the best possible match, Merabi donated stem cells to an unidenti-

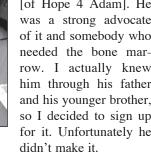
About six months ago, David Merabi, fied woman on November 29 at Scripps Hospital in La Jolla. Donation rules allow the donor and recipient to meet after one year has elapsed.

The Weekly talked to Merabi about his

experience with the donation process.

Where and when did you sign up for the **National Marrow** Donor program?

I signed up for Adam [of Hope 4 Adam]. He was a strong advocate of it and somebody who needed the bone marrow. I actually knew him through his father and his vounger brother. so I decided to sign up for it. Unfortunately he



When did you get the call that you could be donor?

I would say it was about five months after I signed up that they reached out to me and asked if I was interested in continu-

ing the process, that I was a preliminary match with somebody. I said, "Of course." I went from there to UCLA to get my first blood work done to see if I would or wouldn't be the best match. After they took my blood work, they told me "The doctor saw your blood work and determined you are the best possible match to make sure that this person's life is saved." So there was one round of testing which was the initial blood work, and then after they choose you they do another round of blood work just to make sure everything is the same. Because 90 days after the initial blood work, things can change. When they told me, I felt like I had some sort of cure to cancer with my body. I didn't think about it twice; I said "Of course I'll do it."

What was the donation process like?

I did the [Peripheral Blood Stem Cells] donation. So five days leading up to the donation I was to get four injections every day and what those injections did was speed up my white blood cell count. Those were four injections into my stomach. At the same time as I was receiving this, the patient was receiving a high dosage of chemotherapy to kill off her cancer cells. So, at the time that she gets my bone marrow, she'll be well enough to receive it. There was a little bit of pain and a little bit of stress on my bones because when your white blood cell count increases, your bones start to get more dense because you're also building bone marrow. When they shoot you with the injection, it increases your white blood cell count.

You're having trouble breathing because when your lungs expand, it hurts your rib cage. It was basically equivalent to having some sort of soreness and pain from being in a car accident. It was a little difficult but I pushed through because she's going through way worse. She's getting chemotherapy and [what I went through] was nowhere near what she went through.

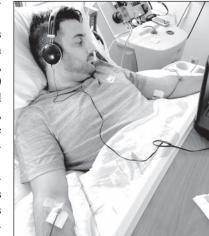
You underwent the procedure not even one week ago. How has recovery been?

Recovery's great. I got to the hospital at 7:00 a.m. and finished my donation a lot quicker than they anticipated because my white blood cell count was so high. It was higher than they said they had ever seen. They finished in, I would say, two hours and 45 minutes. It was initially supposed to be anywhere from four to six hours. They got more than what they needed. Right after it was done I felt great. They said to me that [I] might have headaches, and be sensitive to light, fatigued and tired. I would say the only thing I had was fatigue a little bit, but I drove home the same day. I was perfectly fine. I went to work the

What made you want to be a firefighter?

I've always admired the profession and wanting to help people as always

been something I've done growing up. I was always involved with different activities that were either community based than six years on the or just even giving job, which is great for back. 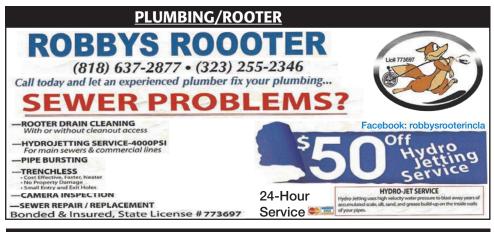

AN ORDINANCE OF THE CITY OF BEVERLY HILLS REAUTHORIZING AND READOPTING THE CITY'S PUBLIC, EDUCATIONAL, AND GOVERNMENTAL ACCESS SUPPORT FEE

ORDINANCE NO. 17-0-2742

AN ORDINANCE OF THE CITY OF BEVERLY HILLS AMENDING THE BEVERLY HILLS MUNICIPAL CODE REGARDING LEGISLATIVE ADVOCATES SERVING ON COMMISSIONS AND COMMITTEES

THE CITY COUNCIL OF THE CITY OF BEVERLY HILLS DOES HEREBY ORDAIN AS FOLLOWS:

Section 1. The City Council hereby amends and restates Sections 2-2-104 of Article 1 ("General Provisions") of Chapter 2 ("COMMISSIONS AND COMMITTEES") of Title 2 ("ADMINISTRATION, PERSONNEL, AND PROCEDURES") of the Beverly Hills Municipal Code to read as follows:

2-2-104: APPOINTMENT AND QUALIFICATIONS:

- A. Appointments to any commission or committee shall be made by the city council
- B. Any person appointed to a commission or committee shall be a resident of the city, unless otherwise designated in the instrument creating such commission or committee, and shall meet such other requirements as designated by council.
- C. Any person appointed to a commission or committee shall serve without compensation for service on such commission or committee.
- D. Any person appointed to a commission or committee (other than the Sunshine Task Force Committee) shall not have been a Legislative Advocate as defined in Section 1-9-102 for at least two (2) years prior to the start of the term and once appointed, shall not function as a Legislative Advocate while serving on a commission or committee; provided, however, the foregoing provisions shall not apply to the Architectural Commission or Design Review Commission if necessary to meet the membership requirements specified in Section 10-3-3002 or 10-3-4402, as applicable, of this Code and the Legislative Advocate limits his or her Legislative Advocacy to the area of expertise for which he or she was appointed.

Section 2. Section 2-2-104(D) of the Beverly Hills Municipal Code shall not apply to any currently seated Commissioner who has registered with the City as a Legislative Advocate as of the effective date of this Ordinance. In addition, the two (2) year cooling off period referenced in Section 2-2-104(D) of the Beverly Hills Municipal Code shall not apply to any Commissioner who has been appointed as of the effective date of this Ordinance.

ORDINANCE NO. 17-0-2743

AN ORDINANCE OF THE CITY OF BEVERLY HILLS REGARDING THE VALIDITY AND EXPIRATION OF CERTAIN BUILDING PERMIT APPLICATIONS

THE CITY COUNCIL OF THE CITY OF BEVERLY HILLS, CALIFORNIA DOES HEREBY ORDAIN AS FOLLOWS:

Section 1. Validity of Certain Pending Building Permit Applications. Notwithstanding any other ordinance, any application for a building permit that was: (1) submitted to the City before January 1, 2017 and (2) that was submitted to plan check, originally or the response to comments, after January 1, 2016, shall be and remain a valid building permit application through the close of City offices on May 6, 2018. This shall include building applications that may be considered expired under Beverly Hills Municipal Code Section 9-1-107.L.3, or that may expire under that section prior to May 6, 2018. All such applications shall be expired upon the close of City offices on May 6, 2018 if the applicant has not received a valid building permit from the City before that time.

Section 2. CEQA Exemption. This Ordinance addresses the validity of building permit applications; it is administrative in nature and will not result in a physical change to the environment. As such, it can be seen with certainty that there is no possibility that the Ordinance may have a significant effect on the environment. The proposed Ordinance is exempt from environmental review because it is not a "project" pursuant to Public Resources Code Section 21065 and furthermore, would qualify as exempt under CEQA Guidelines Section 15061(b)(3). The City Council hereby finds that the adoption of this Ordinance is exempt from CEQA because the project merely

clarifies existing administrative regulations regarding building permit applications and it can be seen with certainty that the Ordinance will have no significant effect on the environment.

Section 3. Publication. The City Clerk shall cause this Ordinance to be published at least once in a newspaper of general circulation published and circulated in the City within fifteen (15) days after its passage in accordance with section 36933 of the Government Code, shall certify to the adoption of this Ordinance, and shall cause this Ordinance and the City Clerk's certification, together with proof of publication, to be entered in the Book of Ordinances of the Council of this City.
