"Future Focused Schools Adds Meetings" [Issue #949]

AN OPEN LETTER TO THE BHUSD SUPERINTENDENT

I am writing to you as an individual Council member in reference to the letter sent yesterday by the letter from the Future Focused Schools Team, which was sent out to the Community by the BHUSD Communications department.

While I appreciate the spirit of volunteerism and the dedicated work done by the comm ittee members, having read through all the materials available on line, I need to express some serious concerns about the committee's work, concerns that numerous Community members have shared with me.

While the committee writes that the members "all feel we've had a crash course in 'BHUSD 101,'" I want to make clear that this is a course I myself have been taking for the better part of my nine years on the City Council. The City continues to be a major funder of the BHUSD and I have strongly supported past JPAs and would support future JPAs which, in my opinion, pass muster (I will be opposing the current JPA because of procedural, legal and accountability concerns). I recognize the vital importance of our schools to our City as a whole.

I am currently one of the City Council's liaisons to the District, and have been in past years, as well, so I am fully aware of the background of the current discussion as well as the challenges that the District faces. As the only Council member with a child in our District and as the only Council member with three generations of family in the District, I care as much about the future of our schools as anybody in our Community.

The FFST's letter suggests it "is not locked into any single position;" however, my concerns and those shared with me by other parents and community members, is that there is indeed a bias towards a dedicated middle school, 6-8, model.

It is completely clear to me and many in the Community that the status quo is not sustainable, mainly from a fiscal perspective; Horace Mann's Facebook page clearly indicates that the rationale behind the current discussions is a result of these fiscal issues. While I understand we are all now tasked with making the best out of a less-than-ideal situation, any discussions should include full transparency and a full acknowledgements of facts, including fiscal ones.

In short, if we don't acknowledge how we got here, we may not be able to avoid the same pitfalls going forward. If we were not in a precarious financial situation, we would likely not be having these discussions at all. As such, the committee's contention, "We are not burdened by budgetary expectations" doesn't make much sense. Of course, they are, as we are all burdened by budgetary expectations in order to avoid the fiscal mistakes which brought us to this point in the first place.

Nonetheless, absent the pressing fiscal concerns, it would be difficult to suggest that the K-8 model has not served the Dis-

trict well for almost one hundred years. The presumption should be on the side of retaining this model, if we are fiscally able to do so.

I have examined all the data on the FFST website and the information seems incomplete, at best, and the responses to some of the questions asked are repetitive and, in some cases, contradictory. While the information may be adequate to ask further questions, it is hardly sufficient to draw any meaningful conclusions (apart perhaps from fiscal ones).

In the Dec. 6 committee notes we can read: "We decided that we need to be very transparent about the fact that people are likely to say that we had this decision made all along and that we are only just now revealing it."

Unfortunately, this now seems like a self-fulfilling prophecy and an almost ineluctable conclusion that any reasonable community member would draw after reading, a few paragraphs prior, that the FFST narrowed down the options for full further detailed study to a mere two: "Leave things exactly as they are and the 3, K-5 and 1, 6-8 middle school options."

In my opinion, none of the data presented on the website supports such a conclusion. The status quo is clearly not an acceptable nor a sustainable option: in fact, the whole reason we are discussing a reconfiguration is precisely because we can't continue with the status quo. By providing one clearly unacceptable option with one other sole option, the FFST is, unfortunately, presenting an inherently biased recommendation, which, whether intended or not, has the clear and obvious effect of trying to steer the Board in the direction of a dedicated middle school.

Again, this conclusion is not supported by the evidence. Despite the rhetoric and attacks from some FFST members who have been suggesting that voices, such as my own, who feel the presumption should be on the side of the K-8 model, are simply "resistant to change" there is no data – at least on the website, if the goal is to be truly transparent – which would leave any reasonable person to recommend only looking at a dedicated middle school as an alternative to the status quo, and not, for example, looking further at a three K-8 model or a K-6, 7-12 model, among other alternatives.

Furthermore, this narrowing down of options is directly at odds with the following statement from yesterday's letter: "We have asked our District administrators to put together the financial, educational, enrichment, and facility information we need so that we can examine <u>all of the options</u> (emphasis added) that have been floated by our team and by many members of our community. We are focused on recommendations that will optimize and deliver the best education to our students, not one that is merely economically viable or systemically efficient."

How does this statement make any sense in view of the committee's Dec. 6 recommendation to narrow down the options to the status quo and a dedicated middle school?

Aside from the Dec. 6 binary recommendation itself, further evidence of bias is visible in the committee's Dec. 5 update, in which one of the members states that K-8 campuses are a "convenience and more of an 'emotional' choice than a choice that's educationally sound." This is clearly an uninformed and – quite frankly – inflammatory statement towards those parents who feel retention of the K-8 model is in the best interests of our kids, without any basis in fact.

Why is a K-8 model a "convenience"? Why isn't it "educationally sound"? Wouldn't "educational soundness" mainly be dependent on the quality of the teaching? Was the model not "educationally sound" when we were among the top Districts in the US? And why is the emotional well-being of our kids not seen as a prerequisite to their ability to unfold their full potentials intellectually? How about a deeper-dive into some of the studies of the various models along with what they can contribute to our kids' EQ not just IQ? How about not dismissing a history - which goes beyond mere "tradition," which the group seems to be dismissive of - and a record of proven success upon which we can build?

Copying a dedicated middle school model, which forces an additional transition upon our kids, hardly seems to be "thinking outside the box" and suggestions that those who want to find ways to make our District's K-8 model work are simply "resistant to change" is itself a form of name-calling and an attempt to dismiss true Community concern.

Furthermore, in addition to the FFST's unbalanced recommendation, pro-middle school committee members have been lobbying for their position, showing very little of openness which yesterday's letter would seem to intimate. Far from being open, it seems that some of the members, at least, have their minds made up and are now attempting to impose their views on community members who have expressed reservations about the benefits of a dedicated middle school.

Some Community members I have spoken with feel afraid to speak out openly, as they have felt themselves under attack when they have made their concerns known. I'm standing up for them, too. Again, while I appreciate the FFST's dedication and efforts, I feel it is my duty as an elected official and Community representative -- not to mention as a concerned parent -- to point out the serious concerns with the committee's communications and conclusions. The statement from the committee's Dec. 6 notes which raises the possibility that the Community may think the entire process is rigged is not without merit due to the conclusions and actions of committee members.

Our kids truly deserve the finest education available anywhere, both academically and emotionally. Our goal must be to prove within the District that public education at its best is every bit as good as a private-school education. Nobody is served well by groupthink which is so dismissive of the concerns and voices of our parents and our Community members who recognize the clear benefits of a K-8 model and who would like to look at ways to preserve it.

1260 Lago Vista Embroiled in Bankruptcy Filing

Sherman Oaks real estate developer Woodbridge Group of Companies has filed for bankruptcy, which includes the 1260 Lago Vista Drive project that the City Council denied earlier this month.

The Lago Vista property was purchased for \$4.5 million and has acquired liens totaling \$12,277,300. In order to file a lawsuit against the City, the Lago Vista applicant would need a bankruptcy court approval.

Attorney Ronald Richards, who represented the surrounding neighbors, said that Woodbridge's position in bankruptcy court is different than they took when they sold the "fraudulent debt" on the property. He pointed out that the company was raising money on fictitious value as the property is without plans and entitlements.

"When Woodbridge sold these investments to these poor individuals, they said 'You have a secured deed of trust on a very expensive property in Beverly Hills.' Then, when they filed for bankruptcy, they're now saying, 'You can't do that. You're just an unsecured creditor, so you'll get paid last," said Richards.

As a result, the individual note holders have formed their own creditor committees in order to fight Woodbridge.

According to Richards, the SEC has been

investigating Woodbridge for possible violations such as fraud for over a year.

Public Works Hears Stormwater Update

The Public Works Commission discussed an update last Thursday regarding recently passed legislature that will expand the definition of wastewater to now include stormwater.

By including storm drainage in the definition, agencies will be allowed to use the utility rate process to raise funds for stormwater projects that would support integrated water resource systems.

The concept has gained attention during the California drought, as the state had laws and court cases that prohibit municipalities from considering stormwater as a utility compared to drinking water and sanitary sewer utilities. Therefore, a lack of funding sources to support and manage stormwater projects has the potential to support the state's integrated water supply portfolio.

SB 231 aims to create smarter management of stormwater as part of both wastewater and water systems. The legislation provides agencies with a funding mechanism to support stormwater projects throughout the state.

After staff recommended following the implementation of SB 231 statewide, Public Works Commission Chair Jeff Wolfe asked whether or not the conceptualization of the current projects satisfy the requirements of SB 231. Environmental Compliance and Sustainability Programs Manager Josette Descalzo said that the City needs to first

determine there is indeed a benefit.

"For example, with La Cienega we have to determine that we will be able to have those benefits. If we determine those are clear and there is a direct benefit, then we would try it."

Since implementation the legislation is still in its infancy stages, the Commission opted to follow legal experts' recommendation to establish precedent or wait for a constitutional amendment to include stormwater as a utility like the others, as well as to rely on other funding mechanisms to fund stormwater projects.

SB 231 was signed into legislation on October 6 and will be effective January 1, 2018.

Council Approves Extra Gospel Concert Costs

The City Council approved on Tuesday an additional \$5,850 for an anniversary concert at the Wallis in conjunction with the Faithful Central Bible Church of Inglewood. The concert marks the 25th anniversary of a similar concert held following the 1992 L.A. Riots.

Approved on November 7, the original cost totaled \$21,468 for labor, steel deck rental and ticketing services. That estimate, however, included the line terms "Backline Rental Total" and "Audio Equipment Total" which were labeled "Unknown requirements" without attached amounts.

Since then, the Wallis and City staff learned that the aforementioned terms are actually for the rental of musical instruments and additional equipment that cannot be transported from the church. The "Backline Rental Total" is now \$3,455 and the "Audio Equipment Total" is now \$11,350, totaling an extra \$5,850. The funds will come out of the Policy & Management Department's contractual services budget for this fiscal year.

Councilmember Lester Friedman inquired whether or not staff made an effort to seek out other sponsors to support the concert—a suggestion he made when the Council originally considered the item several months ago—to which Former Mayor Robert K. Tanenbaum, who was mayor during the 1992 concert, said no.

"I support the idea, I just would have liked to see an effort in getting other cosponsers [involved]," said Friedman, who added that he supports the project nonetheless since the process was so far along.

The new revised estimated cost of the concert is \$27,318.

Homicide Suspect Arrested

The Beverly Hills Police Department has made an arrest in connection with a homicide investigation.

On September 26, the Beverly Hills Police and Fire responded to a medical emergency at Rodeo Plastic Surgery, 421 North Rodeo Drive, after receiving a 9-1-1 call of a patient not breathing. The 71-yearold patient had undergone surgery that morning and stopped breathing in recovery.

The BHPD detectives initiated an investigation into the circumstances surrounding the patient's death. They discovered that the anesthesiologist who assisted in the surgery, licensed physician Dr. Stephen Kyo-Sung Kim, was under the influence of narcotics during the surgery.

The Medical Board of California, the Los Angeles County District Attorney's Office, and the BHPD detectives conducted a threemonth long investigation, ultimately leading to the conclusion that Kim administered a lethal dose of Demerol to the patient during recovery.

On December 13, Dr. Stephen Kim was arrested and charged with one count of murder. His bail is set at \$1,000,000.

Kim appeared at the Foltz Criminal Justice Center for arraignment on December 14.



Writers Bloc Hosts Senator Murphy

On December 17, Writers Bloc, with support from Temple Emanuel of Beverly Hills, hosted United States Senator Chris Murphy (D-CT) (at right in photo) in conversation with Los Angeles City Attorney Mike Feuer (left) on the subject of gun control in America.

They discussed the challenges and opportunities for gun control legislation on local, state and national levels. Senator Murphy is an outspoken member of Congress on the issue of gun violence; he was the Congressman representing Newtown, CT at the time of the Sandy Hook massacre.

City Attorney Mike Feuer is as passionate about gun control as is Senator Murphy, and has been responsible for drafting many laws about gun and ammo sales and ownership. About 250 people attended the event.

Commissioners Reappointed for Second Term

On Tuesday, the City Council approved the reappointment of several commissioners on the Architectural, Design Review and Traffic and Parking Commissions.

The first terms of Architectural Commissioner Sheri Hirschfeld, Design Review Commissioner Ilona Sherman, and Traffic and Parking Commissioner Nooshin Meshkaty are ending on December 31.

At the discretion of the City Council, commissioners are eligible for reappoint-

ment to a second term of up to four years on the same commission. Appointees who have served two successive terms shall not be eligible for reappointment for the same commission, according to the Beverly Hills Commissioners' Handbook.

Each reappointed commissioner submitted a letter of interest to the City.

"It is indeed an Honor to serve," wrote Sherman in her letter. "I will work hard to create innovative change with respect to codes and incentives to limit the run-away construction of 'BOXES' being built in our City, which 'impersonate' authentic Residential Architectural Design."

Sherman, Hirschfeld and Meshkaty will each serve another four-year term until December 31, 2021.

Planning Commission Discusses North Crescent Project

The Planning Commission discussed and reviewed last Thursday a Draft Environmental Impact Report prepared for 100 North Crescent Drive. The application requests the creation of a new overlay zone in order to allow increases in height, density, and use of non-standard parking spaces to fulfill parking requirements.

The proposed project would involve a

comprehensive renovation of the existing threestory office building which would include the construction of two additional stories of commercial office space and increase the building height from 43 feet to 72

feet, plus elevator shafts on the roof that would be an additional 10 feet above the roof deck.

The project would also include upgrades to the existing screening room and conversion of office floor area to create a restaurant at the ground floor. The overall floor area would increase from 106,085 square feet to 161,155 square feet.

Some neighbors have expressed concerns about the project—particularly architectural, zoning, privacy and traffic issues.

"The height of the glass from floor to ceiling was pitched as a wow factor, that is opposite of what it should be when they are next to residential properties," wrote Wiseman Dawoody in an email.

But others spoke in support of the project, such as Chamber of Commerce CEO Todd Johnson.

"We feel the project will provide an important upgrade to the City's stock and an important opportunity for economic development," said Johnson.

Commissioner Craig Corman said that the commission should have a more indepth discussion about the legacy of the project's architect, Gin Wong. The EIR currently states that the project doesn't meet any of the set criteria, but Corman noted that one section said the project must be an "exceptional work by a master architect."

Corman clarified that Gin Wong is listed on the City's list of master architects and that "exceptional work" is a defined term in the City's code.

"The term incorporates an objective threshold of publications," said Corman, who then proceeded to recite various architectural publications and books. "These are all resources that need to be looked at because if in fact the work was published twice, that makes it an eligible property that needs to be addressed in this EIR."

Last Thursday's meeting was part of the public's allotted 45-day comment period, but the actual hearing of the project will likely take place in early 2018.

The planning commission supports the abandonment of a storm drain. But neighbors say it's an easement giveaway. By Olivia Anderson

The Planning Commission determined last Thursday that a request for two proposed projects for residences located at 1193 and 1184 Loma Linda Drive are consistent with the City's General Plan. The projects involve the abandonment of a storm drain easement that the City says is no longer in use.

The easement, which runs through the developer's property, could affect the future of the development. City Planner

Ryan Gohlich said that because there is no use for the easement, the City would not receive compensation for its vacation.

Applicant Loma Linda Holdings' request for vacation of the easement was previously considered by the Planning Commission and the City Council, and referred back to the Planning Commission for further review for consistency with the City's General Plan. The Council vote was 3-2, with Councilmember Lester Friedman and Vice Mayor Julian Gold dissenting. Councilmember John Mirisch voted in favor but said he opposed vacating the easement, but supported Mayor Lili Bosse's suggestion to send the project back to the Planning Commission for advice and to bring it back after staff determines whether or not it is by-right.

After reviewing the request, city staff found that the portion of the easement in question is no longer needed for the purposes for which it was initially acquired since the City's original storm drain line located in the easement was abandoned and replaced by a Los Angeles County Flood Control District storm drain line in 1971. (See attached map.)

But several neighbors expressed concerns about the project, urging the commission to put off making any final decisions.

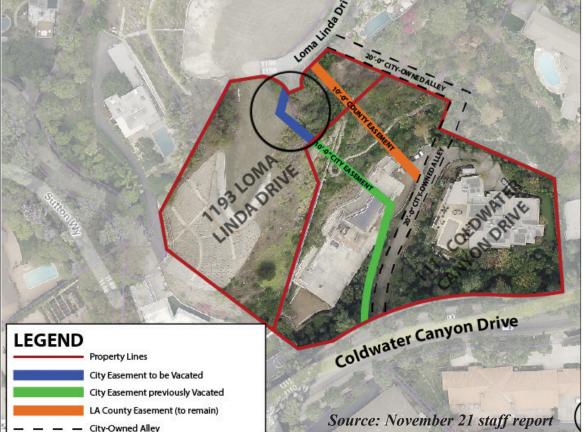
"I would like to bring to your attention the questionable methods the developer is using to fit under the byright project numbers so that they don't

have to go through an R-1 review," said Lago Vista resident Anne Ostroff. "I would really like you all to take a serious look at this process and put this off until we are certain that this project is by-right."

Ostroff's husband Peter will be joining the Planning Commission next year. "By right" devel-

"By right" developments refer to projects that are permitted under their current zoning and do not require any legislative action or public hearings.

Attorney Ronald Richards, who also lives on neighboring Lago Vista Drive, called attention to the fact that the City Council sent the project back to

Planning after concluding there was no evidence to deem the project by-right. Richards said there is "no good cause" to approve the project as it is.

"You have no data in front of you that suggests this is even going to be approved yet," said Richards. "The correction letter is as long as some loan documents—they need to be addressed. The residents need time to get their own professionals and evaluate [the items]. There are some serious capacity issues [and] some serious transparency issues."

But at deliberation, the commissioners highlighted the fact that the commission was asked to complete a very "narrow" task: deciding whether or not the project is consistent with the General Plan.

"That's an important element to consider. To the extent that the City Council indicated they would prefer not to vacate an easement until the project is determined to be by right or not—that's their prerogative," said Commissioner Craig Corman. "That's not our bailiwick; that's theirs."

The Planning Commission voted 4-0, with Chair Lori Greene Gordon abstaining, that the 1193 Loma Linda project is consistent with the City's General Plan.

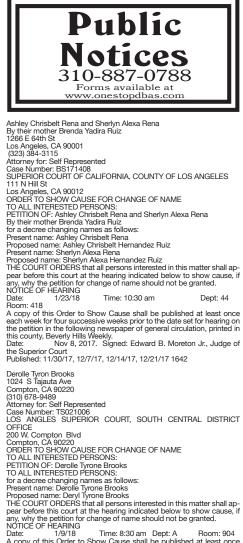
