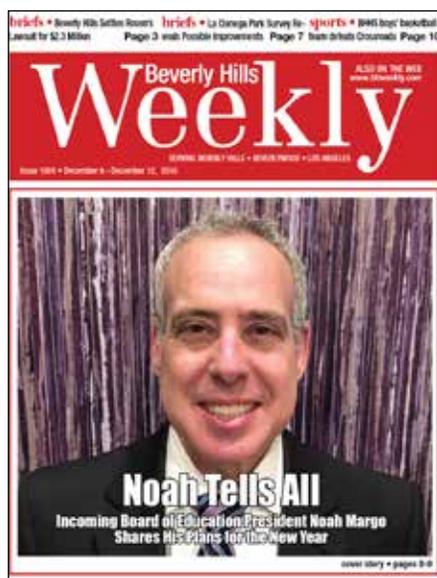

City Council Address Spagnoli Lawsuits; Mirisch Calls Allegations 'Slut Shaming'

After weeks of silence, the Beverly Hills City Council publically addressed the allegations of discrimination, harassment and retaliation made against BHPD

Chief Sandra Spagnoli at Tuesday night's meeting.

Mayor Julian Gold read a letter into the record on behalf of the Council specifically addressing the settlement of recently retired BHPD Captain Mark Rosen's lawsuit against Spagnoli, in which he alleged the police chief did not promote him and barred him from professional advancement after he reportedly overheard the chief and other department officials use discriminatory language to describe Jews, African Americans, members of the LGBT community, Mexican Americans

and Catholics.

“We believe it is important for everybody to understand that there were many factors which contributed to the insurance company’s settlement of that lawsuit. As you might imagine, many of those cannot be discussed here publicly this evening. Captain Rosen’s lawsuit represented a significant impediment to the department’s ability to implement the Council’s direction to change the culture of the police department,” Gold said. “It was important to the City to resolve this lawsuit with Captain Rosen leaving the City, which the settlement allowed us to achieve.”

Following Gold’s announcement, Vice Mayor John Mirisch requested the ability to speak on his own behalf in regards to the lawsuits and allegations. City Attorney Larry Wiener warned against any Councilmembers making additional statements, stating that the Mayor’s comments were “sufficient,” but Mirisch spoke anyway.

“I just want to say something from my perspective that is mine and mine alone, if I may. In my opinion, personally, I believe that unsupported allegations against the Chief or any woman are a rather nasty and unseemly form of slut-shaming,” Mirisch said. “Shame on those who would engage in slut shaming against the first female Chief in our City’s history. It’s immoral.”

It is unclear how these comments and perspectives will affect the more than 9 other lawsuits currently filed against Chief Spagnoli.

Council sends Calle Vista Project Back to Planning Commission

The Beverly Hills City Council voted 3-1 on Tuesday to send media mogul

Byron Allen’s controversial 1115 Calle Vista Drive project back to the Planning Commission for review and requested that the commission create an ordinance

that would more clearly outline whether or not a legally nonconforming property, like the project site, would be allowed an R-1 permit.

Mayor Julian Gold and Councilmembers Robert Wunderlich and Lester Friedman voted in support of that decision, while Vice Mayor John Mirisch voted against it. Councilmember Lili Bosse recused herself from the discussion of the project after receiving a Fair Political Practices Commission (FPPC) decision requesting that she do so.

The original project was tentatively approved by the Planning Commission through a 3-2 vote in August despite Assistant City Attorney David Snow’s view that it was illegal under the City’s Hillside Ordinance. Vice Mayor John Mirisch later called the project up for a hearing before the Council for that same reason.

“I think it’s our responsibility,” Mirisch said in October. “There are too many irregularities in the decision-making process. It’s a very significant project. I also am concerned and disturbed by the fact that the Planning Commission majority completely disregarded our lawyer’s advice and would instead listen to the advice and interpretation of an applicant and lobbyists. That, to me, is concerning.”

Beverly Hills Hillside Protection Association (BHHPA) President Ronald Richards also filed an appeal of the commission’s decision to support the original project, but said on Tuesday he had withdrawn that appeal as the project had been revised to reflect discussions he had with Murray Fischer, who represents Allen in the project.

Those revisions include a decrease in total basement square footage from 11,002.89 to 9,402.89, total export of compacted earth material from 4,617.8 cubic yards to 3,953.3 cubic yards, total demolition area from 43.1 percent to 42.2 percent, and sloped area square footage from 19,965.05 to 18,253.26. The level pad area square footage was also increased from 28,594.34 to 30,306.24 and the maximum allowable floor area increased from 10,860.79 square feet to 11,220.26 square feet.

“After the Planning Commission hearing I had the chance to meet with the applicant and encouraged him to reduce the size of the project. He did,” Richards said. “So, we agree that the City Attorney’s interpretation is the correct one and we do think this project should be exempt for a lot of reasons, but those should be decided by the Planning Commission in a public hearing that everyone can weigh in on. So, we would request that you remand the matter

to the Planning Commission and ask them to adopt the City Attorney’s interpretation, not the one that was originally advanced.”

Ultimately, the Council did decide to do much of what Richards requested, though added a request for a clearer ordinance related to legally nonconforming structures.

According to City Planner Ryan Golich, the creation of such an ordinance would take significant time due to required noticing timelines, Planning Commission availability, and the need for it to come

back before the Council, among others.

“My best guess for a timeline would be late April, early May,” Golich said.

Both Allen and Fischer spoke to that timeline and requested that the project

and ordinance be expedited.

“How do we move this along so my family and I can simply move into our home? This hasn’t been fair. We were told we were in compliance with CEQA. It was Commissioner Ostroff who said we weren’t. We fixed it. We didn’t argue with him. We fixed it immediately,” Allen said. “When we talked to Mr. Richards, he said reduce it. We did. We gave up things we didn’t want to give up. We did. We said we would do everything to get into our home. I’m sorry I was late but it was my kid’s birthday. All I’m trying to do is get my kids and my family into this home. The Planning Commission has voted on this twice. Then, a legal issue came up. So, when I listen to both sides of the aisle I find us in a dryer that is just spinning around. We want to stop the spinning. We just want to move into our home.”

Councilmember Wunderlich appeared inclined to allow some expedition in his motion, which the Council ultimately approved.

“What I would suggest is that we send it back to the Planning Commission with the instruction that we accept the City Attorney’s interpretation and that the Planning Commission try to resolve the issue of how to make a clearer ordinance that would explain whether or not a legally nonconforming property in this sense would be allowed to an R-1,” Wunderlich said. “In the interest of balancing the equities and avoiding extra months of delay, I would also ask for them to consider simultaneously, if they were to decide that an R-1 could be applied for, to do that consideration at that time.”

BHPD Assessment Recommends New Promotion Ranking System

At its study session on December 11, the Beverly Hills City Council was presented with feedback on the Beverly Hills Police Department’s progress in implementing recommendations from a 2015 review

hiring and disciplinary practices, interviewed 35 employees. Those interviewed include the City Manager, City Attorney, Police Chief, the former Interim Chief

of Police, Assistant Chief, three Captains, eight permanent and acting Lieutenants, seven randomly selected sergeants, five randomly selected officers, the police officers association president, and several others.

The feedback from those interviews indicated there was concern among employees about “lack of promotional opportunities and how some promotions have been made,” according to the 2018 report. It also said that creating a tiered ranking system for promotions that eliminates “precise scores,” which Management Partners recommended in 2015, would likely alleviate concerns about how promotions are made within the department.

“We noted in our 2015 report that the practice of appointing the person with the highest score limits the ability of the department to appoint individuals who are indeed highly qualified but may be one point off. More important, the numerical scores are not scientific since they combine both subjective assessments and written examinations. Giving a precise numerical score implies objectivity, but the objectivity cannot be guaranteed simply using numbers,” the report said. “Unfortunately, the misunderstanding that can result from these practices has led to an erosion of trust in the promotional process and the interviews we conducted indicate that it has affected morale.”

Promotional opportunities, the report said, are available.

“We see this is an opportunity for the chief to counter the misimpression with the facts, whether through meetings, in writing or in other ways,” the report said.

Aside from recommending changes to the promotional system, Management Partners also suggested the department: provide clarification about the role and responsibilities of the assistant chief, establish a set of expectations and norms for command staff meetings and all aspects of their roles as leaders of the department, review existing and identify additional

strategies for sharing information with department employees, provide a briefing about recruitment strategy, practices and outcomes since 2015, articulate the department’s philosophy and approach about empowering supervisors to handle minor incidents related to the disciplinary process, assess whether gaps in coverage for critical functions are occurring along with the reasons for the gaps, reprioritize department objectives and tasks to provide a greater focus on the most important items and moderate the pace of change, clarify and communicate the objectives and procedures associated with the department training plan, conduct a review of recordkeeping for all department recruitments, modify procedures to allow for easy data analysis, and conduct a staffing review of the administrative and analytic functions related to recruitments.

Council Extends Ban On Electric Scooters, Shared Mobility Devices

Just over a month after dockless scooter-share company Bird filed a lawsuit against the city related to its urgency ordinance banning shared mobility devices, the Beverly Hills City Council voted 4-1, with Vice Mayor John Mirisch dissenting, to extend the ban for a full year.

The extension will take effect on January 18, 2019 and will have a 12-month sunset.

According to the staff report provided to the Council at Tuesday’s meeting, the extended prohibition is intended to give the City more time to “explore the feasibility of a potential pilot program for the use of shared mobility devices.”

Since the Council first banned shared



mobility devices in July, City staff has met with two vendors, U-Scooter and Spin, to develop their proposals specific to Beverly Hills. Staff is also scheduled to meeting with Bird representatives in the next few weeks.

As of November 29, approximately 1,562 shared mobility devices have been impounded by the Beverly Hills Police Department. E-scooter vendors have incrementally collected their devices on a weekly basis, with approximately 13 units remaining in impound. The release fee for each device is \$123; no storage or tow fees are applied

Commission Supports Tour Bus Pilot Program on North Camden Drive

The Beverly Hills Traffic and Parking Commission voted 4-0 to support a pilot program that would create a new tour bus zone for active loading and unloading adjacent to 414 North Camden Drive for one full year. Vice Chair Jay Solnit did not vote and recused himself from discussions of the potential program because he has a business in the area.

If approved by the City Council at a

later date, the zone would be monitored daily from 10 a.m. to 6 p.m. by a Beverly Hills Ambassador to ensure that the area was being used only for loading and unloading and not for staging. The commission also suggested that the ambassador could hand out maps to tourists as they get off the bus that would help them navigate the city, which they hope would address the concerns of business tenants at 414 North Camden who spoke about the potential for tourists to block the front of the building.

“A lot of the medical doctors in that building see patients who are elderly, terminally ill, or who have disabilities and are dropped off through rideshare programs or by family members. When this was attempted a few years ago, it created many problems for those patients trying to get in and out of the building,” Steve Pavlovski, a regional manager for the Douglas Emmett real estate investment trust company that owns multiple properties in Beverly Hills including the site at 414 North Camden, said on behalf of the tenants. “Apart from that, there is concern about the crowd

that could form and affect egress and ingress into the building. We are a part of the community, but we have a hard time with the idea that this could be done in front of a medical building and having it affect people with bigger concerns to worry about and doctors who are trying to deal with medical situations.”

Jeff Gross, the owner of Mickey Fine Pharmacy, also said that “loitering” had been a problem when a similar tour bus program was attempted in the same location previously, though he was still supportive of the pilot program.

“The biggest issue was that it was being used as a hub for Starline tours, so if people wanted to go from Hollywood to San-

ta Monica Boulevard they'd have to be dropped off in Beverly Hills and wait for the yellow bus to come in and go. So, for lack of better word, they were loitering for fifteen minutes to half an hour. That was the biggest issue, the amount of people staging there," Gross said. "For a simple drop in and drop off, I think this will work for the community and make the medical building safer for people to get access to."

The hourly cost to employ a Beverly Hills Ambassador is approximately \$25.78. The cost to assign one Ambassador for eight hours daily, as would be required under the program, is approximately \$75,000 per year.

Commissioners David Seidel and Jake Manaster voted in favor of the pilot, but questioned what made this program different from previous programs like the temporary relocation of a tour bus zone to the same location in 2010 and more than five other failed attempts.

"I'm kind of intrigued by the track record of failure here," Seidel said. "There have been loading zones on the 300 block and two on the 400 block, which later moved north and failed there. What the heck is the difference with this?"

Staff explained that the difference was that previous tour bus zones had allowed for staging, which the pilot program does not allow.

"I am with Commissioner Seidel in that I am utterly confused about why it failed except for complaints in the past," Manaster said. "There has to be a balance here. I'll remind everybody that the businesses in this town pay for 80 percent of what the residents consume, which is 80 percent of the budget. So, the businesses are super important and their desires, if well planned, are things that I have always believed we should be friendly to and listen to."

Beverly Hills Conference and Visitors Bureau CEO Julie Wagner echoed Manaster's comments about business in her comments at the meeting,

stressing the idea that the city faces more competition from the surrounding areas now than it ever has.

"We hear quite often actually that it's too hard for tour buses to come to Beverly Hills. They say we're not friendly or accommodating and that the tickets they receive when they do come here are huge and prohibitive. So, they'd rather go to surrounding areas like Westfield and the Beverly Center. Ten years ago we didn't have the competition we have now," Wagner said. "I think it's important to continue to provide opportunities for the retailers to continue to flourish because, as Commissioner Manaster explained, the businesses offer a huge amount of revenue to the city's coffers."

Chamber of Commerce CEO Todd Johnson took a slightly different approach, though he also hinted at outside competition that could steal tourist dollars from Beverly Hills if the city did not create ways of drawing outsiders in.

"This is a program where the buses will bring in people who will spend money. Will they spend it on Rodeo Drive? I don't know, but they will get something to eat," Johnson said. "Our restaurants will flourish. Some of the smaller stores will flourish and some of the bigger ones will as well. We have this brand image of Beverly Hills and a lot of people want to come here. I don't think it's very business friendly to not allow that to happen."

Before going before the City Council for a vote, the recommendation will go to the Tour Bus Ad Hoc Committee, which includes Councilmembers Lili Bosse and Lester Friedman, for consideration.

MARK ROSEN SPEAKS

Recently Retired Captain Mark Rosen Responds to Settlement and 'Sour Grapes' Allegations

On November 30, the City settled with former Beverly Hills Police Department Captain Mark Rosen for \$2.3 million in the first of several lawsuits filed against BHPD Chief Sandra Spagnoli. This week, in an exclusive interview with the Weekly, Rosen talks about his experiences, the lawsuit and what's next.

Tell us how you came to the decision to file a lawsuit against the City and Chief Spagnoli.

That was a really tough decision. I had struggled for months with increasing feelings of discrimination and retaliation and a low level of hostility from the Chief. I was just taking it for a while and dealing with it on my own. It became harder and harder, and it became more apparent that was what was happening. When these things first start occurring in your life I think it's natural to try and find a justification for it. You say, 'Well, maybe it's not what I'm thinking. It's probably something else,' but after a while it became apparent and it became harder to take.

HR was not an option. Actually, I'll use a different word. I think HR was complicit in all of this. I don't want to say they were ineffective. They were complicit. I had gone to HR early with Lieutenant Michael Foxen complaining about some discrimination that a lesbian employee had received. She was getting unfair, disparate pay as opposed to her male counter part. We went to HR and HR refused to do anything about it. When Spagnoli got there, we brought it to her with the hope that she could intervene. She did not. She refused to get involved and shortly thereafter I was reassigned from running the largest division in our department to running a smaller division with a smaller budget and smaller personnel, and I think that was a direct retaliation for my going to HR with this. Lieutenant Foxen was also moved to an inferior position after that, so that was really one of the first defining moments.

Then, the anti-Semitic remarks started to become more frequent and more hurtful. I didn't feel at that point that I could go to HR and I didn't feel like the city government was a source for me, so I sought out Mr. [attorney Brad] Gage. I talked to him and probably at least a couple months went by between my first visit with Gage and the time when I finally filed a lawsuit out of frustration. The purpose of filing it was to stop ev-

erything that was occurring to me and happening to me.

The City settled with \$2.3 million last week and you retired as Captain. Is that the outcome you wanted?

I'm satisfied that the dollar amount vindicates me in this, despite the way the City is trying to play it off by saying the insurance company made them do it. I think a settlement of \$2.3 million, one, is fair compensation of what I had to go through over the last two years. It has been quite the ordeal. Secondly, it shows vindication. I think it was right and whether the City wants to admit fault or not, it does vindicate me in that respect.

I'm very disappointed now that the City is taking the position that they had to do this and that it doesn't mean anything. Had I known that, I think maybe I would have gone to trial so that we could've gotten a definitive answer in a public setting with 12 unbiased people making that decision. I think if Mayor [Julian] Gold had felt so strongly that these allegations were false, he should've taken it to court and cleared the City's name. They chose not to because, I think, they knew they couldn't win this in court. I think it's easy after the fact to say, 'We would've won if we went to court,' or, 'We were forced to make a decision.' They weren't forced. If they felt this strongly about it, they could've gone to court. They could've had their day in court and had everything presented—all the facts. A jury would've decided it and there wouldn't be anything for anyone to hide behind.

The City Council has stood by Chief Sandra Spagnoli despite the allegations made against her. What is your response to that?

Professionally, I have never seen a Chief of Police with this many lawsuits still in the job. If you Google 'police chief loses job over retaliation or discrimination complaints,' you'll see this chief had two complaints, another chief had two complaints, this chief two lawsuits. This is just unheard of. When I started this I was out on a ledge by myself in this for a full year. I could see where it would be easy for the City at that time to say, 'Oh, it's Mark Rosen. He's just doing this because of sour grapes,' or whatever they want to say. But a year later, three more top ranking officers in the department filed lawsuits. They should've taken notice at that

time. Even then, giving them the benefit of the doubt, maybe they thought they were my friends and that we were using the same attorney so there was nothing there. Now, there's upwards of 15 different people suing, sworn and civilian, and four different law firms.

Our policy and our procedure is to protect people from whatever is taking place. So, we've put people on administrative leave before and we do that when we think that person poses some sort of threat, either a physical threat or an emotional threat or some unlawful conduct. We have historically removed people from the department to protect either the people in the department or the community until we get to the truth. We have brought people back from administrative leave. We have also terminated people at the end of administrative leave. It can go either way. The way the police department operates and the way the City operates, at least to my knowledge, is that you can't remove the victims. That's retaliatory. So, the practice is to remove the person accused of causing the issue or threat. In this case, we have a Chief who is accused of retaliation, discrimination and harassment by multiple victims. You can't remove the victims, so the thing to do is remove the Chief until the investigation is completed and you prove or disprove the claims. You then handle it accordingly. That was never done here, so the result of not doing that is that people will continue to be discriminated against and retaliated against while she remains there. If they had followed this procedure after the first lawsuit or the second lawsuit or even third, they might not have 15 plus lawsuits and victims today, but they do.

Some have claimed that the litigation stemmed not from any misconduct on Spagnoli's part, but from a power struggle over the chief's position, which you also applied for in 2016. Can you understand why some feel it was 'sour grapes'?

I've heard these "sour grapes" comments and that's really easy for the City to try and hide behind, but that's never what this case was about. When I applied for the Chief of Police job I think 80 people applied. Anybody going for a job in law enforcement knows that

79 are going to walk away disappointed, so I had no sour grapes. I felt I should have been selected, but that's just how the process works. Now, the Assistant Chief spot was different because I felt very strongly that the Assistant Chief should have come from within the department.

It made sense especially for the safety of the community. When you have a Chief from outside the agency in the number one spot, then it makes sense that the second in command come from within the agency so you maintain the culture, the knowledge of the community, the knowledge of how we respond to calls, the crime problems in the city, and how to keep the community safe. I'd be very surprised right now if a serious call happened within the city and the Chief or Assistant Chief could actually find the call on their own without having someone drive them there. They don't know the community. They're changing things within the department like the way we respond to calls and the way we respond to service having never been in a Beverly Hills police car responding to those calls. I don't think they have that ability. Not only did they come from outside of the department, but they also came from outside of the southern California area. Myself or anyone up for the number two spot already had established relations with the LAPD, LA Sheriff's Department, Santa Monica Police Department, Culver City, Glendale, Burbank. We knew how to get in touch with them if there were resources we needed to pull together to keep the community safe. They don't have those connections. So, there's a learning curve and, yes, it can be overcome, but it doesn't make sense to have to work through that when you have that ability right there for the second in command.

So, this was never about sour grapes or me deserving something more. That's just easy for the City to try and claim. I think that's evidenced by me not filing a lawsuit for almost a year after not getting Chief. I was very happy to support the new Chief when she came in.

I just want to add a few things about the "Me Too" movement, which the *Courier* brought up. They think people are just jumping on the bandwagon here, but the Me Too movement made it okay for victims to come forward. It took that one person of courage to go out there and say, 'Hey, somebody did x, y, and z,' and other people who have been victimized and were sitting quietly at home were inspired by that. They felt empowered to have a voice. I think that

happened in Beverly Hills. I made my claims and it took a full year before the next three victims came forward. After that, people felt safe enough to come out and tell their stories and file lawsuits to try and get help for their situations. I'll tell you that there are many people both sworn officers and civilian personnel in the Beverly Hills Police Department right now that continue to be victimized, discriminated against, retaliated against, and ridiculed solely because of their race, their religion, their sexual orientation, or their national origin, and they haven't come forward yet. It's pervasive and the City continues to ignore it. In fact, they deny it. You've seen in the *Courier* that their response is this doesn't exist, but it does exist. They're not doing anything about it and that's just going to create more victims.

I also want to talk about the report that the City keeps bringing up about how great things are [Management Partners Assessment of Police Department Hiring and Discipline Practices, see brief on page 4]. The company that put the report together was paid a lot of money. They were paid a lot of money for the work they did in 2015. The City continues to hire them for other projects. The Chief of Police continues to hire them for other projects. You get what you pay for. You get what you ask for. If the end product doesn't give you what you desire, then the next time you need a report you go to a different company. I can tell you that I know personally, because I was interviewed for that and know at least five or six others who were interviewed, that all the comments weren't positive. Our comments weren't

positive or supportive. Our comments specifically talked about decreasing morale and the negative impact that would have on the City and crime, things of that sort. None of our comments were in that report. I read the report. There's no negativity and I know for a fact that negative information was provided to them. Even before talking to them, we asked, 'Hey, before we go out on a limb here, we're afraid of retaliation.' We told them that and initially we declined to speak to them. Then, we were actually ordered to speak to them. We sat there and we said, 'We'll give you the information if you're going to use it,' and they said, 'Oh, absolutely, we will and there won't be any retaliation. It'll be anonymous.' They didn't use any information we provided.

They wanted to be able to say they hired an independent company to find information, and it's not an independent company. It was and continues to be paid for. It's a public relations piece. That's what it is.

In *The Los Angeles Times*, they asked Mayor Julian Gold about the allegations and they wrote that he "scoffed at the suggestion that [Spagnoli] ever made an anti-Semitic remark" because 11 elected officials are Jewish. What is your response to that?

I am so disappointed in Mayor Gold. I have known him for many years. He has known me for many years. These are not allegations that haven't been supported. People that heard them, in depositions, have supported them and there haven't even been firm denials from the Chief.

People want to say she was joking. They want to say that these anti-Semitic

remarks were jokes. First of all, I don't believe they were jokes. Second of all, even if you want to go that route, the Chief of Police has no business making anti-Semitic remarks as a joke. Both of my parents are Holocaust survivors. Most of my family was exterminated during World War II. I'm very disappointed in [Councilmember] Lili Bosse, who is also a child of Holocaust survivors. She should be just as sensitive as I am to these comments because these comments were made. They're not wild allegations that aren't supported. They were supported. They were heard. They were admitted to.

Even if we said the remarks the Chief made were jokes, which I don't think they were, the City would still have to take action, up to and including termination, for repeatedly making these jokes. The remarks, or 'jokes', if you want to call them that, go against city policy. I don't understand how, with the evidence that's here, Mayor Gold can say it's something he has to raise an eyebrow at. If he wants to say, 'I haven't heard these,' that's not surprising. I wouldn't expect her to make these comments to her bosses. I wouldn't imagine her making anti-Jewish or anti-African American or anti-Hispanic remarks in front of the Council. I'm quite confident that he hasn't heard these comments personally from her, but that doesn't stop her from saying these things to her subordinates.

Is it true that the City attempted to ban press from the trial?

Yes, that's true.

You grew up in Beverly Hills, which is unusual for a BHPD officer. What are your future plans?

I don't know yet. It's too new. My retirement was rather sudden, I have to tell you. It has been a very rough two years. It has been rough on my entire family and me. It's been hardest on my wife. So, I need some time to power down from this and let things settle in. I'd like to perhaps pursue a career in law enforcement again sometime down the road or something in the periphery of law enforcement. I'm still young enough and have a strong background with a lot to offer, but right now, I haven't laid down any definitive plans.

Summarize some of the key moments in your BHPD career.

I enjoyed every minute of every day and woke up loving to go to work, except for my last two years. The last two years were the hardest two years of my entire career. I had been there since I was 15, starting out as an explorer, then was a cadet

while I was in college. I was a reserve officer and gave over 10 years total of free time driving a black and white for free because I loved the job so much. My son is now a police officer, so I passed down that love of law enforcement to him. I love the community. I graduated from Beverly High. I wouldn't have had a different job. I wouldn't have asked for anything different except for the last two years. As I'm trying to look now in my mind and as time goes on, I hope to put the last two years out of my mind and try to focus on the 40 years plus before that.

BHHS boys' basketball team finishes fourth in tournament Norman girls' basketball team routs St. Monica

Beverly High boys' basketball coach Jarvis Turner

said he was "not very happy" with his team's play in its 58-50 loss to El Camino Real in the third-place game of the 78th Beverly Hills Basketball Tournament Saturday night.

"We showed a lack of focus, a lack of toughness," Turner said after the Normans second loss in two nights when they held a halftime lead. "I got to do a better job of keeping them together at the end of games."

Turner attributed the lack of focus and lack of toughness to "maturity, selfishness."

"Those two areas we've got to grow, we've got to get better," Turner said, later adding a "lack of leadership" as another problem.

"Hopefully somebody will step up and become a leader and kind of get us to do what we need to do as a group collectively," Turner said. "I tell my guys peer influence is the biggest influence and we're going to do as our team does."

Another area of improvement cited by

Turner is playing better at the start of the second half.

Beverly Hills led 32-19 at halftime and had three 16-point early in the third quarter before going scoreless for more than four minutes to end the quarter as the Conquistadors scored 14 consecutive points to end the quarter, cutting the deficit to 40-38.

The Normans were called for 14 fouls in the third quarter to four for El Camino Real which "kind of let them back in the basketball game and kind of got some of our guys in foul trouble," Turner said.

The third-quarter fouls "took us out of rhythm offensively," Turner said.

The Conquistadors outscored the Normans 10-1 over the first two minutes, 50 seconds of the fourth quarter, with Jahville Collins making two 3-point baskets and a free throw, taking a 48-41 lead.

The Normans pulled with four, 52-48, with 36 seconds to play, but could get no closer as the Conquistadors (6-2) made seven of eight free throws in the final 33.9 seconds.

Beverly Hills (5-2) committed three turnovers in the first half and 10 in the

second, Turner said.

"That's something that we preach about," said Turner, whose team was ranked eighth in the Southern Section Division 2AA poll released Dec. 3. "We've got to do a better job taking care of the basketball."

"For us it starts in practice. We've got to have better practice habits as a team. I've got to make sure these guys are just focusing on fundamentals, make the simple plays."

The Normans should have won three games in the tournament, Turner said.

"The way we just leave points and free throws out on the floor and the mistakes that we make are just fundamental mistakes," Turner said. "Those are the type of plays that really hurt. Mentally if we sharpen our focus a little bit I think we'll be a little better."

Marcel Stevens led the Normans with 22 points, including three 3-point baskets. Nicholas Andrews added 14, with two 3-point baskets, Ben Ramirez six with a 3-point basket, Sib Malagon with three on a second-quarter 3-point basket, Chandler Sooferan with three and Blake Lander with two.

In other tournament games:

Redondo 59, Beverly Hills 47

The Normans suffered what Turner called a "mental breakdown" Friday night, leading 29-22 at halftime, then being outscored 18-8 in the third quarter and 19-10 in the fourth in a third-place semifinal.

"These guys (have) to become a little more mature as a group," Turner said. "That comes with leadership. Guys have to step up. They got to want to win the game."

"We can only try to do so much as a staff to put them into position to be successful. At the end of the day, they have to want it more than the other team. That's what it's coming down to. It will happen."

Ramirez scored 16 of his 17 in the first half, including 11 in the first quarter, making three 3-point baskets, as Beverly Hills outscored the Sea Hawks, 17-9.

Sooferan added 10, Stevens eight, including 3-point baskets in the first and fourth quarters, Andrews six, including a first-quarter 3-point basket, Malagon four

and Lander two.

Beverly Hills 67, Oaks Christian 54

Stevens scored 17 of his 33 points in the second half and Ramirez scored all 12 of his points in the second half, with three 3-point baskets, as the Normans overcame a 32-23 halftime deficit for the victory in a championship quarterfinal Dec. 5.

Stevens scored 12 points, including two 3-point baskets, and Ramirez nine, also making two 3-point baskets, as Beverly Hills outscored the Lions, 27-12, in the third quarter, taking a 50-44 lead.

Stevens scored five points, Lander four and Ramirez made a 3-point basket as the Normans outscored Oaks Christian, 17-10, in the fourth quarter.

Stevens scored 10 points, including making two of his four 3-point baskets, in the first quarter, which ended in a 13-13 tie.

"We were confident and played great defensively," Turner said.

The tournament was played in the Swim-Gym.

A nonleague game against Santa Margarita scheduled for Tuesday was not played because the Swim-Gym floor would not close, according to Timothy E. Ellis, the Beverly Hills Unified School District's director of athletics.

What's Next?

The Normans are scheduled to play host to El Segundo Friday at 7:30 p.m. in an Ocean League game at the Swim-Gym.

Q&A

Metro Publishes Answers to Community Questions

Dozens of parents and residents gathered at City Hall last month to ask a panel of professional experts selected by the Metropolitan Transportation Authority (Metro) their questions related to the agency's controversial Purple Line Extension project and the tunnel set for construction beneath Beverly High. Earlier this week, Metro published the experts' answers to all of the submitted questions they were unable to address at the November 7 meeting.

Here, we've collected a selection of those answers that address subjects parents seemed most concerned with, including potential health risks, explosions and the realignment of the tunnel to Santa Monica.

Question: How about all the oil wells done from 1970s-2000s that are not documented? How do you address the 75-80 unmapped oil wells that caused the cluster cancer in students?

Answer: There are volatile compounds in oil that are also toxic and/or carcinogenic. The prior litigation involving the Venoco drill site alleged that some of those compounds might have been released into the air in conjunction with Venoco's oil production activities. Some former BHHS students may have been exposed to those compounds over an extended period of time. The number and locations of the wells at BHHS are reasonably well defined. There are six older wells on the property and one well offsite adjacent to the west property line. There are also 19 more recent wells that were operated by Venoco at the southwest corner of the site. As discussed during Metro's presentation, Metro has retrieved and reviewed state (DOGGR) records and historic aerial photographs of BHHS going back to the early 1920's to confirm the locations of these wells and to look for evidence of other wells. Metro has found no evidence that suggests there are 75 to 80 unmapped wells at BHHS. Please also refer to response MRB2 in Appendix J of the Final SEIS.

Question: BHHS is under major construction above ground to better our students, now they'll have construction above and below ground. Where are they supposed to breathe? Athletes are at school for 9 hours a day and the entire school is outside. How is this functional for them?

Answer: As stated in slide 106 of the November 7 presentation, the quantity of emissions being emitted during construction of the Westside Purple Line Extension project are generally lower than those predicted to be emitted by the BHHS modernization project. This is due in part to Metro's implementation of its Green Construction Policy that

calls for the use of Tier 4 construction equipment, which has lower emission rates than older equipment. In addition, electrically powered equipment will be used when possible. Emissions from the Westside Purple Line Extension project are not predicted to cause an exceedance of the ambient air quality levels, nor are they predicted to cause an excess health risk. The health risk assessment was based on a 12-hour exposure to outside air, a scenario that no student is likely to experience. Metro has agreed to install air filtration systems in the classrooms adjacent to the construction site. Please also refer to response MR-A1 in Appendix J of the Final SEIS for a detailed discussion of the air quality and health risk assessment.

Question: What consideration was given in the environmental reports to the children from the high school (and others) being at the high school beyond 3:00 pm, until as late as 6:00 or 7:00 pm? (i.e. sports, activities). Doesn't that increase their exposure?

Answer: The Health Risk Assessment conservatively assumed a 12-hour daily exposure to outside air, which would account for students being on campus that long. The results of the analysis were below the excess risk of 10 in a million. Please refer to response MR-A1 in Appendix J of the Final SEIS for a detailed discussion of the air quality and health risk assessment methodology.

Question: Why have you started without signing the MOA?

Answer: Metro is in the process of negotiating an MOA with the City of Beverly Hills. The MOA is not a requirement to start construction. FTA signed the Record of Decision for the Final EIS in 2012 and the Metro Board of Directors certified the Final EIR in 2012, allowing construction activities in Century City to commence.

Question: What are all the toxins that the students will be exposed to that heighten their risk to cancer by 3.6 percent?

Answer: The Health Risk Assessment, which is conservatively based on 12 hours of outdoor air exposure, indicates a 3.6 out of a million cancer risk, not a 3.6% increase in cancer risk. If the 3.6 in a million were converted to a percentage, it would be 0.00036%. Please also refer to response MR-A1 in Appendix J of the Final SEIS for a detailed discussion of the air quality and health risk assessment.

Question: What if you hit one of the 80 unmapped oil wells? What will happen? What if there is an explosion directly under the school?

Answer: Metro has found no evidence to suggest there are 75 to 80 unmapped wells at BHHS. That statement does not appear to be plausible and its basis is not known. To the contrary, the available records indicate there are six older wells on the property and one well offsite adjacent to the west property line along with 19 more recent wells that were operated by Venoco at the southwest corner of the site. The available records and testing results indicate that none of these wells are within the limits of the tunnel excavation. The state (DOGGR) records indicate that all of the abandoned wells have surface casings and cement plugs along, and below, those surface casings – as is required for the drilling and subsequent abandonment of a well. If a well casing were to somehow avoid documentation by DOGGR, detection in historic aerial photographs, detection by the surface magnetometer surveys, detection by the ground penetrating radar surveys, and detection by the planned subsurface magnetometer surveys, and if it was encountered by the tunnel boring machine (TBM), it is likely that both the TBM and the well casing would be damaged. The surface casings typically only extend to depths of about 100 feet below the ground surface. They do not extend to the depths where oil-bearing deposits are present thousands of feet below the ground surface. As such, the primary risk associated with encountering a well casing would be damage to the TBM. Please also refer to response MR-B2 in Appendix J of the Final SEIS.

Question: Spending some time right next to your current constellation construction; it sounds like a roller coaster collapsing every few minutes. How are you realistically expecting students to study in bungalows against the construction wall, which is less than 15 feet away?

Answer: Noise from construction activities will not interfere with academic or recreational activities on the BHHS campus, and BHHS will be able to continue to operate as it does under current conditions. No exceedances of the City of Beverly Hills noise limits were predicted at the existing classroom locations. Although the analysis predicted a daytime noise exceedance of the City of Beverly Hills daytime noise limits by up to 8 dB at the temporary classroom locations, with implementation of Metro's proposed mitigation, noise levels are not predicted to exceed the City noise limits. The contractor will construct a sound wall around Area 2 and Area 3 and use low noise emission construction equipment. With these noise control measures, noise levels during construction are predicted not to exceed the City of Beverly Hills Municipal Code construction noise limit of existing ambient by +5 dBA at the BHHS temporary classrooms and school recreational facilities. In accordance with mitigation measures, noise levels will be monitored by the contractor during construction. If the measured construction levels exceed the noise lim-

its, the contractor will provide appropriate abatement measures and/or modify the activity responsible for the exceedance. Please also refer to response MR-A2 in Appendix J of the Final SEIS.

Question: What are you going to do with the high school students, if there are high detection of gases? Will you close the school?

Answer: If methane is detected at significant concentrations (as defined in the FEIS) in the crawl spaces beneath the buildings or on the interior of the buildings, those spaces will be ventilated. This is standard protocol – such as when gas is detected from a utility line leak. If significant concentrations of methane are detected at or above the ground surface, the source of the methane will be investigated and addressed. It is highly unlikely that significant concentrations of methane will be detected and even less likely that concentrations would be detected that would warrant temporary closure of a building.

Question: What happens if there is an explosion under our high school and the high school collapses?

Answer: This is not a plausible scenario. As discussed in slides 58-70 of the November 7 presentation, three conditions are necessary for there to be even a potential for explosion in a building: a significant volume of methane, high concentrations of methane (>55,000 ppm), and elevated gas pressures. None of these conditions exist along the subway alignment at BHHS. As such, there is no potential for this scenario to occur based on the available information.

Question: Since the decision to move the route from Santa Monica Blvd to underneath Beverly Hills High School is purportedly based on allegations that there is seismic activity under S. Monica Blvd, we request proof (tangible) that there is seismic activity. We ask that you conduct boring to confirm that seismic activity does exist under S. Monica Blvd.

Answer: As part of the evaluation of faults in the vicinity of the routes being considered, extensive geologic investigation was performed, including 56 continuous core borings, 192 Cone Penetration Tests, and 5 geophysical profiles along 7 transects. The test data confirmed that there is no evidence of faulting near the Century City Constellation Station, whereas there was evidence of complex faulting, potentially including multiple strands of active faults, at potential station locations along Santa Monica Boulevard. Further details of the evaluation are described in the Supplemental EIS and the technical report appendices. The data collected by Metro was subsequently independently evaluated by the California Geological Survey (CGS), in addition to data from other investigations along the Santa Monica Fault, and the CGS thereafter published an Alquist-Priolo Earthquake Fault Zone Map of the

area with an associated report dated January 15, 2018 (“The Hollywood, Santa Monica, and Newport, Inglewood Faults in the Beverly Hills and Topanga 7.5’ Quadrangles” Fault Evaluation Report FER 259). In the CGS report and map, the Santa Monica Fault is shown as active, and CGS concludes that “The principal traces of the Hollywood, Santa Monica, and Newport-Inglewood Fault Zones... are recommended for zoning as they are well-defined and there is sufficient evidence to conclude they are active.”

The full list of answered questions has been split into four sections—health risks, noise, oil well and methane gas, and seismic—and can be found online in Metro’s December 5 Construction Update email.
