Planning Commission to Recommend Revising Basement Regulations

After much deliberation, the Planning Commission voted unanimously to adopt a resolution recommending an ordinance revising regulations related to basement single-family areas and grading/retaining walls in the Hillside area of the City.

The decision follows several years of community concerns about the intensity and scale of development in single-family areas as well as general development standards in the Hillside area.

These concerns related not only to development scale, but also to degradation of the natural hillside contours, increased construction impacts, and slope destabilization.

At the Planning Commission meeting on October 26, 2017, the commission adopted a resolution recommending changes to the Council. On December 5, the Council considered how the changes in the ordinance would impact projects currently under City review (a.k.a. “pipeline projects”).

The Council ultimately directed the Planning Commission to discuss an additional amendment to the draft ordinance to allow deviation from the revised regu-

lations for wall height/location through a Hillside R-1 Permit.

At their January 11 meeting, the commission oscillated at length before arriving at their decision, calling the project difficult.

“I’m really struggling with this,” said Commissioner Andy Licht. “Everything comes down to fairness. Who are we going to be more fair to?”

Regarding the pipeline projects, residents have argued that the pending projects could have negative impacts on the neighborhood and surrounding properties due to design features that would no longer be allowed under the new code provisions.

Staff provided a recommendation of following five category goals for handling pipeline projects, including tenants like exempting pipeline projects in Central and Trousdale areas, and those that have active entitlement applications as of the effective date.

Chair Lori Greene Gordon said she agreed with most of the goals with the exception of number five: Hillside pipeline projects that are submitted for building plan check as of the effective date of the ordinance that either 1) are a new single family home, or 2) are increasing the cumulative floor area on a site by more than 50 percent, will be required to seek an R-7 permit should they wish to move forward under the existing code provisions.

Gordon indicated she would like the City Council to be advised of staff’s orig-

inal recommendation for “Category 5” pipeline projects, so that the Council can make its own determination.

Recreation and Parks Hears Capital Improvements Update

At their January 23 meeting, the Recreation and Parks Commission received an update on the Capital Improvements Project.

Community Services Director Nancy Hunt-Coffey said that staff met with Friends of Greystone on January 10 and 16 to discuss priority items. The library design began on January 22.

Regarding the Beverly Gardens Park Restoration, Phase 1 construction, which included blocks 17-20 (Camden through Walden) was completed on December 31, 2017.

Phase 2 construction, blocks 9 (Elm/Foothill), 13 (Hunter and Hound statue), 14 (Lily Pond), 15 (Beverly/Rodeo), 22 & 23 (Carmelita through Whittier) was completed on January 15.

Construction documents for Phase 3 were issued for Bid on December 29, 2017. Bids were due in January. Phase 3 includes blocks 1-8 (Doheny through Elm), blocks 10-12 (Foothill through Crescent).

The Beverly Gardens Restroom (block 13—Hunter Hound) was “substantially complete” by January 22, and is slated to

open soon.

Hunt-Coffey also said that bid documents have been issued for the Coldwater Park and playground renovation. The bid was due on January 18.

Commissioner Howard Rosoff inquired what was specifically included on the bid, to which Hunt-Coffey replied that the demolition, removal, relocation, and entry is included in the bid.

“[Fencing] all the way around the playground came in a little high at \$27,000,” said Hunt-Coffey. “So we’re looking into why that came in high. I think it’s important to include that if we can afford it.”

NOTICE OF PUBLIC HEARING

The Council of the City of Beverly Hills, at its meeting to be held on **Tuesday, February 6, 2018 at 7:00 p.m., or as soon thereafter as the matter may be heard**, in the Council Chamber of the City Hall, 455 N. Rexford Drive, Beverly Hills, CA 90210, will hold a public hearing to consider:

AN ORDINANCE OF THE CITY OF BEVERLY HILLS REVISING REGULATIONS RELATED TO BASEMENTS IN SINGLE FAMILY AREAS OF THE CITY AND GRADING AND RETAINING WALLS IN THE HILLSIDE AREA OF THE CITY

The proposed ordinance includes the following measures, which may be further modified by the City Council:

- The definition of “floor area” in single-family residential zones is proposed to be amended to define a “basement” as an area that is located directly below the portion of a story above which has a finished floor level that is a maximum of three feet (3’) above finished grade at any cross-section cut through the building with certain exceptions for driveways, light courts, pools and water features, and stairs and access ways that might otherwise cause a basement to be exposed by more than 3’ above grade. The proposed amendments would also require a basement that extends beyond a story above to be located entirely below both finished and natural grades. (Proposed amendment to Beverly Hills Municipal Code [BHMC] § 10-3-100.)
- A definition of “light court” is proposed to be added to the BHMC. As proposed, a light court would be an excavated area adjacent to a building that extends more than 4’-0” from the building perimeter that is enclosed on four sides, open on the top, and allows light into a below grade level of a building. The BHMC does not currently contain a definition of light court. (Proposed addition to BHMC § 10-3-100.)
- The definitions of “finished grade” and “natural grade” are proposed to be added to the BHMC to ensure clarity of the code and consistency in its application. (Proposed additions to BHMC § 10-3-100.)
- The language governing the maximum height of walls, fences, and hedges within the Hillside Area of the City is proposed to be amended to limit the total height of any wall fence or hedge to 12’-0” regardless of the side of the wall, fence, or hedge from which a measurement is being taken. An R-1 Permit is also proposed to be added to allow relief from these regulations (Proposed amendment to BHMC § 10-3-2516.)
- The language governing the construction of series of walls in the Hillside Area of the City is proposed to be amended to allow for a maximum cumulative height of 12’-0” for all walls constructed on the same property within any 50’ perpendicular section. A 10’-0” landscaped horizontal distance must also be provided between each wall. An R-1 Permit is also proposed to be added to allow relief from these regulations (Proposed amendment of BHMC § 10-3-2516.)
- The calculation method provided in the BHMC that defines the total cubic yards of landform alteration (cut/fill) allowed on a site in the Hillside Area of the City within a five year period is proposed to be amended. (Proposed amendment of BHMC 10-3-2521.)
- The regulations regarding import/export of earth material within the Hillside Area of the City are proposed to be amended to clarify that cubic yardage will be based on in-ground earth volumes. The code does not currently stipulate whether the amount of earth material is in ground compacted earth material or excavation un-compacted earth material. (Proposed amendment of BHMC 10-3-2521 and BHMC 10-3-2521.1) The City Council may also consider revisions to BHMC Section 10-3-2521 and 10-3-2521.1 to reduce the number of cubic yards of earth material that may be imported or exported from sites in the Hillside Area to account for the difference in volume from in-ground compacted conditions, and post-excavation un-compacted conditions.
- The definition of “height of building” is proposed to be changed to bring the method of measuring the height of buildings in the Hillside Area of the City in line with the method of determining whether or not a portion of a building can be considered a basement. (Proposed amendment of BHMC 10-3-100)
- The findings pertaining to Hillside R-1 Permits are proposed to be amended to add a provision that the total number of construction-related vehicle trips associated with a project as a whole may be considered by a reviewing authority when considering a Hillside R-1 Permit for import and export of earth material. (Proposed amendment of BHMC §10-3-2550)
- Other non-substantive changes to reorganize and reorder Article 25 of Chapter 3 of Title 10 of the BHMC, which contains development standards applicable to the Hillside Area of the City.
- Language pertaining to the applicability of the proposed ordinance to projects that are currently under review by the City of Beverly Hills (pipeline projects). The proposed ordinance, which may be modified by the City Council, includes exempting the following pipeline projects from the new provisions: all pipeline projects in the Central and Trousdale Areas of the City, pipeline projects in the Hillside Area of the City that have previously received an R-1 Permit, pipeline projects in building plan check in the Hillside Area of the City that were submitted prior to January 11, 2018, and pipeline projects that have been submitted for entitlement review prior to the effective date of the ordinance. Pipeline projects that are not exempt will be allowed to request an R-1 Permit for review of the project under the existing code provisions by the Planning Commission.

This Ordinance has been preliminarily assessed in accordance with the authority and criteria contained in the California Environmental Quality Act (CEQA), the State CEQA Guidelines, and the environmental regulations of the City. The City Council will consider whether the adoption and implementation of the Ordinance be found exempt from CEQA pursuant to Section 15061(b)(3) as there is no possibility that adoption and implementation of the Ordinance may have a significant effect on the environment because the Ordinance does not authorize construction and it would impose greater restrictions on certain development in order to protect the public health, safety and general welfare. Additionally the City Council will consider if adoption and implementation of the Ordinance is eligible for a Class 8 categorical exemption pursuant to Section 15308 of Title 14 of the California Code of Regulations for actions taken to assure the maintenance and protection of the environment.

At the public hearing, the City Council will hear and consider all comments. All interested persons are invited to attend and speak on this matter. Written comments may also be submitted and should be addressed to the City Council, c/o City Clerk, 455 N. Rexford Drive, Beverly Hills, CA 90210. The comments should be received prior to the hearing date. Any written comments received by Tuesday, January 30, 2018 will be attached to the agenda report regarding this item. Any comments received after Tuesday, January 30, 2018, but prior to the public hearing, will be distributed to the Council under separate cover. Please note that if you challenge the City’s action in regards to this matter in court, you may be limited to raising only those issues you or someone else raised at a public hearing or in written correspondence delivered to the City, either at or prior to the end of the public hearing.

According to applicant spokesperson Cynthia de la Torre, the view owner and one of the foliage owners are in the midst of finalizing a private agreement for the removal of three trees at one of the properties, 1119 North Hillcrest Road.

The applicant has not yet reached an agreement with the other property—1100 Maytor Place.

Community Preservation Division issued the 1100 Maytor Place property owner an order requiring compliance with the City's hedge height regulations by November 16, 2017. The foliage owner's attorney subsequently requested an extension to the compliance order and the City granted an extension through January 16.

Community Preservation Division staff completed a field visit on December 13, 2017 after the foliage owner's attorney communicated to the City that trimming of the hedge to remedy the code violation had occurred.

"The code enforcement case regarding the non-conforming hedge at 1100 has not been resolved," said de la Torre. "An administrative citation was issued after a field visit [in] December confirming that the hedge was still in violation."

Per Commissioner Joe Shooshani's inquiry, de la Torre said that the Planning Commission only receives these types of cases when private mediations have been unsuccessful.

"Oftentimes, when it is resolved, I

don't see the private agreement," said de la Torre.

Should both parties fail to reach a resolution, the Planning Commission may issue a View Restoration Permit to a view owner with a protectable view where the protectable view form a viewing area is "substantially disrupted" by foliage, according to the staff report.

Through issuance of a View Restoration Permit, the Planning Commission may require restorative action on the foliage owner's property.

The commission unanimously approved the February continuance date, as it is the earliest meeting where representatives of both the owner and foliage owner at 1100 Maytor Place are available.

Fine Art Commission Oks Gagosian Gallery Loan

The Fine Art Commission voted at their meeting on January 18 to accept a loan from the Beverly Hills Gagosian Gallery for an art piece by Walton Ford called "La Madre."

The watercolor piece features the California Grizzly Bear, which, according to the staff report, served as the chief reason the Gagosian opted to lend the work to a civic site in California.


Gagosian will pay to ship, install and insure the \$1.5 million piece.

Staff recommended the rotunda of City

Hall (which doesn't get much traffic) or in the library near the teen zone (which gets lots of traffic). The gallery has expressed interest for the City Hall location, deeming it a better fit for the piece given that compared to the library it is a more "grandiose" location.

Commissioner Carolyn Hiller said that the piece would be "exciting" to have as it more than fits the commission's standards for placement in the City, but others noted that at approximately 400 pounds, the piece might damage the walls of City Hall.

Chair Michael Smooke suggested placing another temporary while behind the piece to prop it up as a solution.



Although the commission didn't decide on a location yet, they did move unanimously to accept the piece.

"I think it's a great idea and a great opportunity. I think we have to take advantage of it as quickly as we can," said Commissioner Alan Kaye.

City to Expand CCTV System

On January 22 the City announced plans to continue expansion of its Closed Circuit Television (CCTV) project. The City currently operates and monitors over 600 CCTV cameras within Beverly Hills.

Current plans include an expansion of CCTV cameras into residential neighborhoods as a mechanism to thwart crime, apprehend suspects and increase public safety. Cameras will be strategically place in key areas within the City with significant consideration for the privacy interests of residents.

Part of the expansion also includes a plan to provide awareness to residents and visitors. Residents and visitors will soon see signage within the City providing notice of the use and monitoring of CCTV cameras.

"The City Council is in full support of this absolutely essential technology," said Mayor Lili Bosse. "We must send a clear message that the City of Beverly Hills is watching and criminals will be caught and prosecuted."

The City of Beverly Hills is proud to utilize this advanced technology to increase public safety and provide an optimal experience for residents and visitors.

City Responds to New Study on Earthquake Fault Zones

The City is currently reviewing a revised study released by the California Geological Survey (CGS) showing a possible earthquake fault zone extending into Beverly Hills.

According to the study, the Santa Monica Fault Zone could extend eastward through Century City, through Beverly Hills parallel to Santa Monica Boulevard to the border of the City of West Hollywood.

The City will be contesting the findings.

Because of the prevalence of earthquake faults in the region, the City is working to implement proactive mitigation measures. For example, since 2014, all new commercial and multi-family construction must include a seismic study to determine if faults lie underneath the property.

The City is working to educate employees, residents and businesses on how to prepare for and respond to a disaster. For information on how to prepare to an emergency, visit beverlyhills.org/emergency-preparedness.

"Safety and resiliency in a disaster is one of the City's highest priorities," said Mayor Lili Bosse. "The entire region is an active earthquake zone. We should always be prepared."

CVB CEO Julie Wagner on the upcoming Chinese New Year Event

How did the Chinese New Year event (coming up on Feb 11) first come about?

The event is seven years old. We first started this event for a couple of reasons. One is because Chinese travel at that point in time was just booming in Beverly Hills. A lot of our retailers were curious as to how they could capture more of the Chinese travelers that were coming here. We originally designed this event to help give us messaging that we could put out there to build the local Chinese community as well as overseas as part of a bigger Chinese strategy. Over time, the events have just grown bigger and bigger and bigger until—I think this is our fourth year working with the Chinese government. They got involved and developed a partnership with us, and the event has grown to be what it is today.

Why do you think it has resonated with so many people?

I think it's a few things. We have such a strong relationship with the local Chinese community and with Los Angeles Con-

sulate of the People's Republic of China. They're very supportive and they get the word out there. I think that the show itself is fun and cultural and exposes people to traditions and artistry that they may not normally be exposed to unless they have the good fortune of being able to travel overseas. I think it's fun. It's a fun event, and that resonates with people as well.

What is different about this year's event?

We're doing two nights [for] this year's event. One is a matinee that's open to the public on Sunday. The event the night before is more for friends of the Chinese community, the consulate, VIPs and [such]. They have added a couple of cities—usually they just bring entertainers from Beijing, [but] this year they're bringing entertainers from the three provinces in the area. We'll have not just acrobats and music; we're also going to have martial arts demonstrations, there'll be magic, there'll be new performers and new acts that we haven't seen in the past. So that's always fun. We never quite know

who is coming and what the acts will be; it's always a bit of a surprise. They always bring some folk art type element so that people can see the traditional art of the country. Usually what they do—because they're very excited about the winter Olympics being held in Beijing—is bring something like photos to highlight what the Olympics are going to be like and what they were when they held them in the past. This year, they're bringing some folk artists that will do paper cutting, floral arrangements, and incense. A woman creates incense stamps and then burns them. So there's always an element like that going on in the lobby as well.

What's in store for the CVB this year?

We had incredible success with Beverly Hills Open Later Days [BOLD], so we'll be talking to the City about bringing that back for the summer. We haven't mapped out exactly what that means and of course we'd be working with in

conjunction with Rodeo Drive and the Chamber of Commerce on that. All the lighting installations that we did—we own a lot of that now, so we're going to start talking now about what the holidays [will look like]. It's never too soon

to get started on the holidays! So we'll be talking about that with the City and Rodeo Drive. And then, we're going to be doing a spring campaign that is an extension of what we did this past spring which is all about "WELLthy" living and how to marry your mind, body and spirit in Beverly Hills. Shopping is a big part of who we are, but [the message is] that you can take your healthy lifestyle and your goals for maintaining your wellbeing with you no matter where you travel and Beverly Hills very focused on being able to cater to that.

BHUSD FILES ANOTHER METRO LAWSUIT

Despite previous unsuccessful attempts, on January 26 the BHUSD filed suit against the Federal Transit Administration (FTA) and the Los Angeles County Metropolitan Transportation Authority (“Metro”).

The district alleges that the FTA and Metro violated federal law by conducting a faulty and biased supplemental environmental analysis of the impacts of Metro’s Westside Purple Line Subway Extension project, which is currently planned to run underneath Beverly High.

The district is seeking an injunction requiring the agencies to conduct a proper environmental analysis, evaluate the serious health effects the project and associated construction next to campus will have on the students, and prohibit the FTA from obligating federal funds to the project until the agencies have fully complied with federal law.

Metro and FTA were ordered to prepare a supplemental environmental impact report (SEIR) by the Federal District court as a result of a prior lawsuit brought by the School District. On August 12, the Federal District court ruled that Metro failed to perform a complete analysis of impacts of the construction, including to public health, and ordered Metro to specifically analyze whether a feasible alternative route exists, to evaluate the public health impacts of dust and diesel particulate matter, and to disclose risks associated with methane migration and possible explosion potential under unprotected buildings.

According to the complaint the November 22, 2017 SEIR ignores alternative routes and an alternative staging area for construction farther from the campus, fails to properly analyze health effects and does not adequately address

the impacts of constructing subway tunnels running at shallow depths beneath the campus.

In its lawsuit, the District challenges the legal sufficiency of the SEIR. They argue that Metro’s planned tunnels will threaten the high school’s recreational areas, historic structures and ability to modernize and expand. They also argue that emissions from construction of the westerly fence will threaten the health of students and faculty.

“This lawsuit is critical to protect Beverly Hills High School, its students, and the community,” said Board of Education President Lisa Korbatov.

But Metro says they are “confident” the supplemental environmental work meets all legal requirements.

“This additional analysis confirms that Metro can safely build the project,

including the portion beneath Beverly Hills High School,” said Metro spokesperson Dave Sotero.

“Metro is committed to delivering the project on time and on budget. Construction of the first subway section between Koreatown and La Cienega in Beverly Hills is well underway. Metro is already conducting design and pre-construction work for Section 2 through Beverly Hills and Century City. We anticipate breaking ground this spring. Metro is working cooperatively with the City of Beverly Hills on a weekly basis to deliver this critically important transit project to all taxpayers of Los Angeles County.”

BOARD STILL UNDECIDED ON SCHOOL RECONFIGURATION

But several members indicate consensus to study 7-12 at Beverly High

Even though their Tuesday meeting hovered around six hours long, the Board of Education did not make any final decisions regarding the future of BHUSD school reconfiguration.

Some did, however, express interest in further studying a 7-12 model instead of the proposed 6-8 dedicated middle school the community-led Future Focused Schools Team (FFST) recommended.

For four months the FFST studied some two-dozen options for a district reconfiguration to address the BHUSD’s unsustainable financial path, ultimately whittling down their search to a small handful of viable options.

These included keeping the cur-

rent model; closing a school site so as to maintain three TK-8s and one high school; and consolidating a middle school and eliminating a school site so as to have two TK-5s, one middle school and one high school.

But at Tuesday’s meeting, several public commenters and Board members suggested that perhaps the 7-12 option was thrown out prematurely and should be looked at more closely.

“The 7-12 model is very enticing to me, very practical, and time should be allotted to explore that option as well,” said Board of Education member Noah Margo.

Board president Lisa Korbatov agreed

with this sentiment, stating that while she has no interest in closing a school, there is an “inescapable problem with the 6-8 experience at every school.” She added that Hawthorne is structurally and seismically insufficient.

Hawthorne also has yet to undergo construction.

The other board members, including student Board member Jonathan Artal, expressed interest in a pursuing a dedicated 6-8 middle school.

According to an student survey, referenced by Artal, 76 percent of Beverly High ASB students said they would have preferred going to a dedicated middle school for sixth, seventh and eighth grade.

ASB also scheduled a forum for all students, many of whom were not in ASB and didn’t participate in past discussions, to make their opinions about reconfiguration heard. 78 percent of the

students at this forum felt a dedicated middle school was the strongest option.

“My job on behalf of students is to represent their interests,” said Artal. “Overwhelmingly, students largely feel that a dedicated middle school is the strongest option.”

Still, the Board majority recommended that the Superintendent’s cabinet look into a transitional reconfiguration that involves removing Hawthorne’s 6-8.

More specifically, they requested a detailed plan and cost benefit analysis of what a three TK-8 model and one TK-5 model would look like—from student schedules, to offerings, to attached finances, to the logistics.

Superintendent Michael Bregy will present more information at the meeting on February 6.

Board members Korbatov and Howard Goldstein announced that they will not seek re-election in November.


Wallis to Premiere "The Flying Lovers of Vitebsk"

BHHS boys' basketball team loses to Crossroads on last-second shot Normans defeat Santa Monica, Lawndale

Beverly High erased a 13-point first quarter deficit and led in the fourth quarter, but Shareef O'Neal made the tie-breaking jump shot from just inside the free throw line as time expired in Crossroads 63-61 victory in a Take Flight Challenge game.

O'Neal scored 24 points, making 11 of 14 free throws and had 10 rebounds. The 6-foot-10-inch O'Neal is 5 inches taller than the tallest Beverly Hills player, junior Chandler Soferan.

The game was played last Thursday on a soundstage at CBS Studio Center in Studio City where TNT's "Inside the NBA" crew of Shaquille O'Neal, Shareef O'Neal's father, Charles Barkley, Kenny Smith and Ernie Johnson conducted its usual broadcast accompanying the network's Thursday doubleheader.

The Normans were outscored 18-5 in the first quarter, but outscored the Roadrunners 24-6 in the second quarter to take a 29-24 halftime lead.

Beverly Hills led 46-40 entering the fourth quarter, but were outscored 23-15 over the final eight minutes.

Norman sophomore guard Ben Ramirez scored a game-high 26 points, making six of nine 3-point shots, three of six 2-point shots and both free throws.

Daniel Zahabian added 15, Nick Andrews nine on three 3-point baskets, Marcel Stevens five, including a 3-point basket, freshman Blake Lander four and Soferan two for Beverly Hills (15-7), which was ranked 12th in the Southern Section Division 2AA poll released Jan. 22, one spot behind Crossroads (11-8).

The Normans opened the season with an 80-77 loss to the Roadrunners in the St. Monica Catholic High School Basketball Tournament Nov. 27.

The younger O'Neal has signed a letter of intent to accept an athletic scholarship from the University of Arizona.



Dear Beverly Hills Neighbors,

Almost two years ago we introduced the Beverly Hills Open Space & Garden Initiative. We believed that bringing the project directly to Beverly Hills residents for a vote was the proper way to move forward as none of the major issues from our previous approvals were changing, including traffic, total square footage or any other conditions.

Over the past year, we have continued to talk with Beverly Hills residents about the future of the Waldorf Astoria Residences. We continue to believe that a single residential building on Santa Monica Boulevard and landscaped open gardens on Wilshire Boulevard is the best use of the property for us and the City's residents.

Last week we filed a new application with the City for the Waldorf Astoria residences. Our filing is the beginning of the City's mandated planning process. During the next year, we are committed to providing clear updates, details and visual information about the Waldorf Astoria Residences as we go through the City's process, which will facilitate full public comment and input. We will continue to listen and respond to the community and the City's leadership.

The Waldorf Astoria Residences have been redesigned to be architecturally compatible with the Waldorf Astoria hotel. The new design is 3 stories shorter than the plan we presented in 2016.

The size of units has also been reduced to gear them towards Beverly Hills residents who are "empty nesters" who want to downsize from their large homes and still live in Beverly Hills. This reorganization of bedrooms creates more units without increasing the square footage of the project. We expect that the City's studies will show no significant traffic or environmental impacts. We are also dedicating a public garden similar to the garden One Beverly Hills is providing the City.

Our existing greywater system, the first in the history of Beverly Hills, will be expanded throughout the gardens to increase the environmental sustainability of the entire 9 acres.

We have already invested \$5 million in road and traffic safety upgrades on the public streets around the property. The Waldorf Astoria and the Beverly Hilton are projected to generate \$15 Million for the City of Beverly Hills. The Waldorf Astoria Residences, once built, will generate an additional \$5 million annually in property taxes to fund essential city services and neighborhood schools.

Thank you for the opportunity to introduce the Waldorf Astoria Residences. We look forward to a thorough and transparent process.
