### “Measure BH”

This week there was an assault on our PTA in response to a newsletter that informed parents what exactly Measure E paid for at Hawthorne School (2% of the total Measure E budget) based on factual information that was published in the Weekly last week and also provided details on what Measure BH, our new \$385 million bond would pay for at Hawthorne and how much it would cost taxpayers. Details that are outlined in the BHUSD Facilities Master Plan and sets aside approximately \$12,370,000 (3%) of the total bond budget to rebuild Hawthorne’s auditorium that was closed down three years ago after our District deemed it unsafe.

After sending out this information, our PTA leaders were pressured into apologizing for our lack of “protocol” and sent out a statement to parents apologizing for this error. Why are the Yes on Measure BH supporters afraid of discussing the facts?

Measure BH is asking for \$385 million from our community to “Build a Brighter Future” but doesn’t talk about the future of BHUSD at all? Our Board has stated that our current school model is not financially sustainable and this was confirmed

by Los Angeles County of Education (LACOE) earlier this month which identified considerable concerns about our budget over the next few years. The Future Focused Team that was created last year by our Superintendent to explore possible district reconfiguration came to the conclusion that reconfiguring our District to include a middle school would benefit not only our students but also the budget so why doesn’t Measure BH address this?

Measure BH is expecting our community to support a new \$385 million dollar bond and uses figures based on the BHUSD Facilities Master Plan which doesn’t address reconfiguration at all. If passed, Measure BH combined with Measure E would give our schools \$720,000,000 in tax dollars (almost three-quarters of a billion dollars) and is only accountable for building three new schools. How can this be? Doesn’t our Community deserve to know how this \$385 million will be spent? And if Measure BH has based its funding on the Master Plan, isn’t it our District’s responsibility to include in the Master Plan a possible reconfiguration plan?

I don’t see Measure BH as building a brighter future but rather trying to pass another bond like Measure E, that has the potential to be mismanaged and lacks true vision. Don’t our students deserve better than this?

## Walker Announces Board of Education Candidacy

Tristen Walker, a 1987 Beverly Vista and 1991 Beverly High graduate, announced last week her candidacy for a seat on the Board of Education in the November 6 election.

Walker has five children, four of whom currently attend BHUSD schools: Jacob Walker, 17, attends New Roads School; Nick Walker, 15, and Jeremy Shuman, 15, attend Beverly High; and Charlotte Walker, 13, and Courtney Shuman, 9, attend El Rodeo.

Walker's husband David Shuman graduated from El Rodeo in 1984 and Beverly High in 1988. Shuman is the CFO of Hay-mon Sports.

An entrepreneur of Beverly Hills Concierge Notary, Walker previously managed the children's apparel company Dust Bunnies Baby. Walker earned her B.A. in Communications from Boston University. She formerly served as a member of the Future Focused Schools Team (FFST) and currently serves as co-chair of the YES on BH campaign.

## Ballot Statements For/Against Measure BH Submitted

With the June 5 primary election rapidly approaching, many have begun taking sides regarding Measure BH—a \$385 million proposed bond for the BHUSD.

The Board of Education has said that the funds, if approved, will go toward "protecting students" by enhancing security at all five school sites, "modernizing

the Beverly High and Hawthorne auditorium, equipping classrooms with educational technology, and improving ADA accessibility."

"Measure BH utilizes fiscally conservative financing and tough taxpayer accountability directed to specific construction projects at all five BHUSD schools," reads the Board's statement, signed by all five members. "Whether or not you have school-age children, safeguarding our students and the local quality of public education is a smart investment."

In opposition of the measure is Tim Ferreira, a libertarian running for Lieutenant Governor of California this year.

Ferreira contended in his statement that a vote for the bond is a vote for "wasting your money on vague, unenforceable promises."

The "vague" promises he's referring to include the lack of specificity in projects the bond would fund. Ferreira argues that this is because it would restrict the district from spending money on other projects.

Ferreira also pointed out that the district has issued almost \$262 million in facilities bonds since 2013.

"Where has all that money gone?" asked Ferreira. "Measure BH's intentionally vague language gives the district a blank check with no accountability."

Vice Mayor John Mirisch also opposes the proposed measure, imploring the Board to work through reconfiguration options before "sticking it again" to the resident taxpayers.

"With a legacy of construction problems and repeated broken promises, our residents should reject Measure BH, which is asking us to pay for some of the exact same things we paid for—and continue to pay for—under Measure E which passed less than 10 years ago," said Mirisch. "The Board needs to establish trust and show us it can provide the residents with value-for-money before upping the taxpayer ante to almost a billion dollars."

If approved, Measure BH will cost property owners an average of \$44 on \$100,000 of assessed value. For example, this means an additional \$1,760 per year for properties assessed at \$4 million.

The June 5 ballot measure requires 55 percent approval to pass.

## Board Argues Over LACOE Meeting Attendance

What began as a conversation regarding the Los Angeles County Superintendent of Schools (LACOE) interim report turned into a squabble over transparency and attendance at meetings.

Board member Isabel Hacker asked why Vice President Noah Margo was absent at the recent meeting with LACOE, to which he replied that he "was asked but couldn't attend."

Hacker suggested that because the future Board will include herself, Mel Spitz and Margo, members should discuss appointments and attendance.

"In the future we could have a discussion and vote on who is going to be appointed if the vice president wasn't here," said Hacker.

Hacker pointed out that she wasn't privy to the conversation and did not receive an invitation to the LACOE meeting, suggesting that the invitation should have come from the superintendent so as to include all five board members.

LACOE recently sent out a letter to the Board expressing concern for the district's deficit spending, whose General and Special Reserve Fund is projected to decrease from \$15.8 million to \$3.4 million over a three-year span.

President Lisa Korbatov invited just Margo and Board member Howard Gold-

stein to attend the meeting, which would have been violation of the Brown Act as it allows only two members to be present.

"The way it was related to us as a body was that you were going to be there," said Hacker told Korbatov. "I think we serve the Board better when we're all informed that there's an opportunity for more than one to participate."

Hacker called this practice "unfair," suggested that this was not an isolated incidence.

Korbatov said that addressing Hacker's concerns would be a "waste of [her] time."

## Planning Commission Discusses General Plan

The Planning Commission discussed the City's General Plan at their Thursday meeting, which covers the community's development goals and guides the City's land use and public

investment decisions.

The overarching themes of the City's General Plan include sustaining great places, growing smarter, maintaining a resilient economy and provision of services, living lightly and reducing the carbon footprint, and developing a sustainable future.

Commissioner Peter Ostroff pointed out that changes in state law will indeed affect the City, and as a result are something they should "think about a lot." Ostroff brought up SB 827, a transit bill killed in committee in April, stating that similar bills will return.

"If we are inconsistent with state law respecting density, respecting height limits etc., that would supersede and have control over us," said Ostroff. "We need to get ahead of it."

Each jurisdiction in California is required to have a general plan by California Government Code. The requirement to have an overarching plan dates back to 1937, when California became one of the first states to require all cities and counties adopt such a document.

According to the staff report, a general plan "expressed the vision for the future of the jurisdiction, and contains broad policy statements and goals that guide the jurisdiction toward the envisioned fu-

ture."

This conversation was the first of a study session series from the City's General Plan. Further sessions will provide more in-depth discussions about specific chapters of the plan.

## City Celebrates Arbor Day

The City celebrated the 33rd Annual Arbor Day on April 27 at Coldwater Canyon Park. The event included the planting of a California Live Oak and awards ceremony to recognize the Tree USA Award, of which the City has been a recipient for 33 consecutive years. According to a press release, significant factors of consistently receiving the award include the annual Arbor Day program, the Street

Tree Master Plan, a "well-managed" tree care program, and a commitment to "responsible" environmental efforts.

## Council Reappoints Commissioners

The City Council reappointed several commissioners for a second term at their Study Session on Tuesday afternoon.

This decision was based on a recommendation by the City Council Liaisons: Mayor Julian Gold, Vice Mayor John Mirisch and Councilmembers Robert Wunderlich, Lili Bosse, and Lester Friedman—each of whom serving as liaisons

for various commissions.

Reappointees include Sharon Persovski of the Architectural Commission, Stephanie Vahn of the Fine Art Commission, Andy Licht of the Planning Commission, and Jay Solnit of the Traffic and Parking Commission.

All four of their terms expire on June 30, but each is eligible for reappointment to a second term of four years. The commissioners have submitted correspondence indicating willingness to serve a second term.

“Serving on the [Planning] commission has been rewarding, educational and engaging,” said Licht in a letter to the City. “I have enjoyed getting to know the City’s staff, leaning about new projects and dealing with applicants.”

### City Council Hires Consulting Group to Look at Community Development Programs

The City Council discussed Tuesday afternoon the results of a study about the management and operational systems of the City’s Development Services and Community Preservation programs in the Community Development Department.

The studies, conducted by Matrix Consulting Group, worked to evaluate and analyze these programs in an effort to create more efficiency and effectiveness in the departments’ delivery of customer service and sound work practices.

Completed in December 2017, the scope of the Matrix Study focused on the

range and extent of services provided; the workload, service levels, staff utilization and work practices, how the current services compare to best practices, and customer satisfaction.

To gather data, Matrix conducted interviews with department staff to identify the key issues and trends impacting the programs’ operations. They subsequently conducted three customer focus groups to identify key concerns impacting satisfaction levels and suggestions for improvement opportunities.

Matrix identified program strengths including the establishment of a one-stop permit center, certifying all code enforcement officers, having over-the-counter review for certain types of permits, and using certified combination building inspectors to respond to building, electrical, mechanical and plumbing inspection requests.

Focus group participants also identified several areas of improvement. With regard to the Development Services Program, these included enhanced customer access to staff and information, further streamlining of the plan review process and greater consistency within the plan review staff.

For the Community Preservation Program, these included a desire for greater consistency in service focus, increased enforcement and more training.

The City Council reached unanimous consensus to proceed with an implementation plan in order to improve these departments, receiving semi-annual status

### BHPD Cracks Down on Vehicles with No License Plates

The Beverly Hills Police Department (BHPD) partnered with the Los Angeles County Taskforce for Regional Auto Theft Prevention (TRAP) on April 26 in an effort to reduce the number of vehicles on the roadways that do not display a front or rear license plate as required by law.

Detectives and traffic investigators from throughout Los Angeles County have found many crimes are being captured on surveillance video; however, many hit and run accidents and avoidance of toll road fees, photo red light enforcement. Registration fees and concealment of driving a stolen vehicle.

During the four hour game plan on vehicles with no plates, police officers con-

ducted 128 traffic stops, issued 78 citations, issued 34 parking citations and one vehicle was impounded.

Beverly Hills Police Chief Sandra Spagnoli stated, “Criminals routinely attempt to hide their identity from law enforcement by concealing their license plates.” The efforts made by these officers demonstrate their commitment to public safety and do not go unnoticed.”

The Beverly Hills Police Department urges everyone to please display their license plates on their vehicles. If anyone has purchased a new or used vehicle within the last 90 days and have not yet received your license plates, please contact the dealer, seller or your local DMV office to avoid being cited.

## LOMA LINDA STANDOFF CONTINUES

But neighbors claim the City's lawyer went beyond his purview

In a unanimous vote, the City Council approved a building permit for 1184 Loma Linda Drive at Tuesday's meeting.

The Council received an update on the status of the pending building permit application for 1184 Loma Linda Drive—as well as complaints from neighbors.

1184 Loma Linda completed 10 rounds of review through the City's plan review process. Additionally, the City's independent geotechnical engineering firm GeoKinetics peer reviewed the grading calculations.

Staff's review of the project ultimately concludes that "all applicable codes have been complied with and the project qualifies as a 'by right' project with no outstanding corrections."

Regarding grading quantities, GeoKinetics concluded that the total amount of export to be generated by the project will be 1,149 cubic yards. That's 351 cubic yards below the City's 1,500 cubic yard

threshold that triggers discretionary review.

The update follows the approval for two single-family residences on Loma Linda. The City Council approved in November, 2017 a fire turnaround involving dedication from both properties, and directed the Planning Commission to consider whether the vacation of a storm drain easement over the 1193 property was consistent with the City's General Plan. The commission determined on December 14, 2017 that it was.

But since the easement runs through the developer's property and could potentially affect the future of development, many neighbors questioned the validity of the project or whether it was actually "by right," and urged the commission to put off making any final decisions.

"By right" developments refer to projects that are permitted under their current zoning and do not require any legislative

action or public hearings.

At the March 6 meeting Councilmember Lester Friedman noted at deliberation that the project was brought back before it had been determined to be "by right"—something the Council wanted confirmation on before they reviewed the proposals.

He suggested at that time that the Council affirm the selection of an independent consultant and direct completion of the review.

But the independent study results raised eyebrows from some neighbors, one of which includes attorney Ronald Richards.

Although Loma Linda Holdings received approval to adjust the lot line back in 2013, Richards could find no evidence to suggest the applicant was granted a request for an extension.

On January 11 Richards sent an email to Community Development Director Susan Healy Keene formally requesting all records relating to a waiver or extension from 1184 Loma Linda's covenant agreement.

Staff responded by saying there were "no documents responsive" to Richards' request. Last month, however, the City's independent lawyer Rick Jarvis embarked on what Richards calls an "im-

proper fact-finding mission."

On April 16 Jarvis called an unnamed staffer to orally provide information of a granted waiver, which Richards says is a "meaningless exercise."

Richards said that aside from the issues



posed by the project, the City's lack of transparency is what troubled him most.

"This flies in the face of overwhelming and undisputed evidence to the contrary and contradicts the staff reports given previously," said Richards. "Furthermore, there is no evidence that this unnamed staff member was ever delegated any authority and that he/she ever gave a waiver of extension to anyone. The opaque facts that are blurred the report cannot be relied upon and have zero value."

As a result, staff implemented a new rule that requires the City to provide written confirmation of a waiver.

WHEREAS, individuals, acting alone or in concert with others have used improvised weapons to inflict injury on members of the public attending these events and law enforcement personnel responding to these events, thereby posing a real and serious threat to life and safety; and

WHEREAS, various improvised items have been used to injure attendees and harm or incapacitate law enforcement officers, including wood and metal pipes, poles, bats, chains, projectiles (such as rocks, concrete, pellets and ball bearings), glass bottles and containers filled with flammable or noxious substances, and aerosol sprays deployed to cause flames or attack olfactory systems; and

WHEREAS, it is imperative that individuals engaging in peaceful expressive public activity, and law enforcement personnel dedicated

to protecting such activity, be allowed to do so without suffering injury.

NOW THEREFORE, THE CITY COUNCIL OF THE CITY OF BEVERLY HILLS DOES HEREBY RESOLVE AS FOLLOWS:

Section 1. Article 2 ("Parades And Assemblies") of Chapter 3 ("OTHER ACTIVITIES REQUIRING REGULATORY PERMITS") of Title 4 ("REGULATION OF CERTAIN TYPES OF BUSINESSES AND ACTIVITIES") of the Beverly Hills Municipal Code is hereby amended and restated to read as follows:

#### 4-3-209: PROHIBITIONS:

The following prohibitions shall apply to all demonstrations, rallies, picket lines, parades and assemblies:

A. It shall be unlawful for any person to carry or possess, while participating in any parade or assembly, any length of lumber, wood, or wood lath greater than one foot (1') in length, unless such object is of wood, is blunted at its ends, and is one-fourth inch (1/4") or less in thickness and two inches (2") or less in width, or if not generally rectangular in shape, such object shall not exceed three-fourths inch (3/4") in its thickest dimension.

B. It shall be unlawful for any person to carry or possess any length of plastic pipe or metal greater than one foot (1') in length or greater than one-quarter inch (1/4") in its thickest dimension.

C. It shall be unlawful for any person to carry any sign, poster, plaque, or notice, whether or not mounted on a length of wood as specified in subsection A of this section, unless such sign, poster, plaque, or notice is constructed solely of a cloth, paper, or cardboard material no greater than one-quarter inch (1/4") in thickness.

D. It shall be unlawful for any person to ride, drive, or cause to be ridden or driven any animal or any animal drawn vehicle upon any public street, unless specifically authorized by a permit.

E. It shall be unlawful for any person to carry or possess any projectile launcher or other device which is commonly used for the purpose of launching, hurling, or throwing any object, liquid, material or other substance.

F. It shall be unlawful for any person to carry or possess weapons such as firearms, knives, swords, sabers or other bladed devices, axes, hatchets, ice picks, razor blades, nun chucks or martial arts weapons of any kind, box cutters, pellet or BB guns, conducted electrical weapons (CEWs), including, but not limited to, Tasers or stun guns, metal/composite/wooden knuckles, or any chain greater than 20 inches in length or greater than 1/4 inch in diameter.

G. It shall be unlawful for any person to carry or possess any balloons, bottles or any other container containing any flammable, biohazard, or other noxious matter which is injurious, or nauseous, sickening or irritating to any of the senses.

H. It shall be unlawful for any person to carry or possess any aerosol spray, tear gas, mace, pepper spray or bear repellent.

I. It shall be unlawful for any person to carry or possess glass bottles, whether empty or filled.

J. It shall be unlawful for any person to carry or possess shields made of metal, wood, hard plastic or any combination thereof.

K. It shall be unlawful for any person to carry or possess bricks, rocks, pieces of asphalt, concrete, pellets or ball bearings.

L. It shall be unlawful for any person to carry or possess baseball or softball bats, regardless of composition or size; provided, however, that such items are permissible when configured of cloth, cardboard, soft plastic, foam or paper for expressive purposes.

M. It shall be unlawful for any person to carry, possess or wear, any gas mask or similar device designed to filter all air breathed and that would protect the respiratory tract and face

against irritating, noxious or poisonous gases.

N. It shall be unlawful for any person to fail to abide by the instructions of a traffic control officer given for the purpose of accommodating traffic, including emergency vehicles, through and across a parade route, demonstration, rally, picket line or assembly.

Nothing in this section shall prohibit a disabled person from carrying a cane, walker, or similar device necessary for providing mobility so that the person may participate in a demonstration, rally, picket line, parade or assembly.

**Section 2. Severability.** If any section, subsection, subdivision, sentence, clause, phrase, or portion of this Ordinance for any

reason is held to be invalid or unconstitutional by the decision of any court of competent jurisdiction, such decision shall not affect the validity of the remaining portions of this Ordinance. The City Council hereby declares that it would have adopted this Ordinance, and each section, subsection, subdivision, sentence, clause, phrase, or portion thereof, irrespective of the fact that any one or more sections, subsections, subdivisions, sentences, clauses, phrases, or portions thereof be declared invalid or unconstitutional.

**Section 3. Publication.** The City Clerk shall cause this Ordinance to be published at least once in a newspaper of general circulation, published and circulated in the city within fifteen (15) days after its passage in accordance

with Section 36933 of the Government Code, shall certify to the adoption of this Ordinance and shall cause this Ordinance and the City Clerk's certification, together with proof of publication, to be entered in the Book of Ordinances of the Council of this city.
