The Planning Commission of the City of Beverly Hills, at its REGULAR meeting on **Thursday, June 14, 2018**, will hold a study session beginning at 1:30 PM, or as soon thereafter as the matter may be heard to provide an opportunity for the public and the Planning Commission to discuss the potential to establish a new Hillside R-1 Permit for certain single family residential projects in the Hillside Area of the City. At the April 24, 2018 City Council study session public comment included a proposal to require an R-1 Permit for any new homes or projects that would increase the existing floor area by more than 50% on a site in the Hillside Area of the City. The suggested purpose was to provide the Planning Commission with the opportunity to review such projects and impose conditions as necessary to address identified potential impacts. The City Council indicated a willingness to study this proposal and directed that the item to be agendaized for review by the Planning Commission.

At this study session the Planning Commission is expected to discuss the merits of the proposal and potentially direct staff to undertake further work on the subject. This could include Planning Commission discussion of what projects would be subject to any new review established, if any projects would be exempt from review, and what the findings could be for the new R-1 Permit, should it be established.

Because this is a study session, no decisions will be made at this meeting. Any decisions by the Planning Commission on this topic will be made at a future noticed public hearing. A study session is an opportunity for the public to provide comments and the Planning Commission to consider this change and provide staff with direction.

Any interested person may attend the meeting and be heard or present written comments to the Commission. Any comments submitted will be considered as part of the public record. toric buildings and facilities on all five campuses, it will also build brand-new athletic and learning spaces, update and improve our technologies and improve school safety across the District. It's important we make this happen now. Delaying this crucial construction will only make it more expensive both because construction costs are currently escalating at a rate of 20% per year and also because we will lose \$18 million in State Matching Funds if we do not act.

I've heard the arguments against passing Measure BH and if you are worried I invite you to visit voteyesonbh.com to read the FAQ page there so that you can make an informed decision and put your mind at ease. Ultimately however, finishing our schools is a task that must be accomplished. What other choice do we have? Our teachers and our students de-

serve to teach and learn in permanent classrooms on beautiful campuses. Let's pass measure BH and make construction, not classrooms, the only "temporary" in the lives of our students. Vote yes on Measure BH!


5 ballot.







The BHUSD announced Thursday that Sarah Kaber will be the new Hawthorne principal, a position which the Board of Education approved at a special meeting.

Kaber is currently the Interim Assistant Principal at Hawthorne, having previously served as a technology coach. She was also a kindergarten, third grade, fifth grade and middle school math intervention teacher at Hawthorne, Horace Mann and Beverly Vista.

"I love our Hawthorne community and how well I've been able to get to know our students this year," said Kaber. "I've spent time in

every grade and in every classroom, and I can't wait to see how much our kids continue to grow.

"Ms. Kaber is highly intelligent and deeply committed to improving teaching and learning experiences for our K-8 students," said Superintendent Michael Bregy. "In a time of rapid change and increased expectations on schools, her natural ability to connect with students, parents and staff is of critical importance."

Interim Principal Richard Waters will continue in his role as Hawthorne Assistant Principal.

"I'm so excited to continue to work with Mr. Waters and the rest of our staff," said Kaber, "Our team has really moved Hawthorne forward this year and we'll continue to build on that success."

Hawthorne has had significant administrative turnover in recent years, with five principals in the last decade.

Former Principal Michelle Halimi recently returned from maternity leave and is currently the Title I coordinator at Horace Mann. She did not respond to the Week-

ly's request for comment.

Snowden Receives Art of Leadership Award

Former BHPD Chief Dave Snowden received the Art of Leadership award at a Costa Mesa dinner last Thursday, where about 250 people gathered to honor local community leaders.

Presented by the Coasta Mesa Chamber of Commerce and South Coast Metro Alliance, the Art of Leadership aims to emphasize the importance of arts education as a "critical component" of a complete and successful education.

Prior to Beverly Hills, Snowden was the Costa Mesa Police Chief for 17 years, having worked to develop "community-oriented policing efforts, and was deeply involved with local business and charities," according to the Daily Pilot.

"I trust people; I delegate to people; I'm not afraid to pick people that I think are a hell of a lot smarter than I am to get the job done," said Snowden at the event.

Planning Commission Approves Gores Group Plan Amendment

The Planning Commission approved on Thursday an amendment to a previously approved Development Plan Review, which will now permit rooftop structures and uses on buildings located at 9800 Wilshire Boulevard and 121 Spalding Drive.

The Gores Group, which submitted the requested, was represented by attorney

Mitchell Dawson on Thursday. The company will now be able to provide food and beverage services on the rooftops and allow guests to utilize these rooftop facilities from 8:00 a.m. to 10:00 p.m. Monday through Friday, and 9:00 a.m. to 10:00 p.m. Saturday to Sunday.

The project will function as an ancillary component of a new co-working office use located within the first two levels of office space in the 9800 Wilshire Boulevard building, and the first and fourth office levels of the 121 Spalding Drive building.

The office space on the third floor of the architecturally distinct 9800 Wilshire Boulevard building will continue to be occupied by the Gores Group.

The vote was 4-0 with Commissioner Andy Licht absent.

Morales to Lead Rent Stabilization Program

The City has appointed Helen Morales to the position of Deputy Director of Rent Stabilization in the Community Development Department. Morales will oversee the newly created Rent Stabilization Program.

Morales has held management positions in local government for over 14 years, serving most recently with the City of Los Angeles in the Housing and Community Investment Department (HCIDLA) where she managed the Rent Stabilization and Foreclosure Registry Programs. Before that, she worked for the Los Angeles County Community Development Commission, establishing and managing the public housing integrity and fraud detection program and worked as an administrative hearing officer. Previously, she was a paralegal, primarily in the area of corporate restructuring and insolvency.

"Helen's extensive experience and knowledge of regional housing issues will be invaluable in working with our community to establish this very important rent stabilization program," said Community Development Director Susan Healy Keene.

Morales' salary will be \$141,000 annually.

The pilot was written by April Blair, who had been an executive producer on the 2013-17 CW historical romantic drama "Reign," a co-executive producer on the 2011-15 CW comedy-drama "Hart of Dixie," a consulting producer on the AMC action-adventure drama "Into The Badlands" and MTV slasher anthology series "Scream."

"All American's" executive producers

include Greg Berlanti, an executive producer of six other series on The CW's fall schedule -- "Supergirl," "Riverdale," "The Flash," "Arrow," "Black Lightning" and "DC's Legends of Tomorrow."

Scenes depicting Beverly High were filmed at El Segundo High School.

Like many projects inspired or based on true stories, "All American" strays from reality and uses dramatic license.

Paysinger was raised in South Los Angeles and attended Beverly High through its since-eliminated multi-cultural program. His father Donald and uncles Carter and Vonzie are all BHHS graduates who coached football at the school, with


“I was at the victory party in Ambassador Hotel when Senator Kennedy was shot. I had been a volunteer organizer and then a driver in the campaign during my freshman year in college. There was panic and pandemonium. Everyone was crying. We had no idea about his condition and rumors were flying to the extremes – he was wounded but okay or he was dead. It ranks as one of the worst evenings of my life.”

“I found out that RFK was assassinated on the morning of June 6th. I was resting at home recovering from an appendectomy. My mom came in that morning crying saying that Robert Kennedy

was dead, killed. I was gobsmacked. I couldn't believe it and thought she was wrong, there had to be a mistake. I remember feeling so horrified by his being killed so close to the assassination of Martin Luther King, Jr. If I hadn't had emergency surgery I would have been at the Ambassador that night.”





