Council Bans Electric Scooters... For Now

At its July 24 meeting, the Beverly Hills City Council voted 4-1, with Vice Mayor John Mirisch dissenting, to approve an emergency ordinance banning shared mobility systems and devices such as Bird or Lime electric scooters and "dockless" bikes within the city for six months.

Specifically, the ordinance defines a "shared mobility device" as "any wheeled device other than a vehicle or motorcycle that is powered by a motor; is accessed via an on-demand portal, whether a smartphone application, membership card, or similar method; is operated by a private entity that owns, manages, and maintains devices for shared use by members of the public; and is available to members of the public in unstaffed, self-service locations."

Bicycles, skateboards, and similar devices are not included in the emergency ordinance. Motorized bicycles would be banned if they are "dockless."

Under the ordinance, it is unlawful to park, leave standing, leave lying, abandon, or otherwise place a shared mobility device in a public right-of-way or on public property anywhere in the city. It

also makes it unlawful to operate a shared mobility device in a public right-of-way or on public property anywhere within the city and to provide or offer for use a shared mobility device anywhere within the city.

It also gives the city the ability to impound shared mobility devices that have

been offered for use, placed in public right-of-way or on public property, or operated in public right-of-way on public property in violation of this chapter. Shared mobility device vendors would be required, under an adjoining resolution also approved by the Council, to pay the standard costs of impounded vehicles in

Beverly Hills.

The Council came to the decision following robust public comment at both their July 24 study session and regular meeting, including commentary from several stakeholders in shared mobility device companies.

Many of these stakeholders mentioned

that these devices would provide a last mile solution for the transporta-

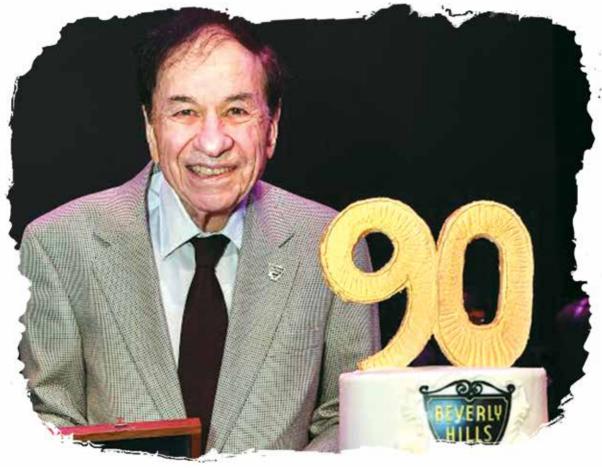
Tim Harder, of Bird electric scooters, and Jeff Joyner, who co-founded and co-chairs the e4 Mobility Alliance at the Los Angeles Economic Development Corporation, both stood against the ban, stating that a ban would send the "wrong message" about an industry trying to solve transportation problems.

"Our scooters can solve the micro-transit problem we've been facing for twenty years," said Joyner. "A ban would send the wrong message about an industry trying to solve that problem."

The emergency ordinance does not prohibit shared mobility device companies from ever doing busi-

ness in Beverly Hills, but is meant to give businesses time to come to the Council with new ideas for addressing the concerns of the council, which include safety of pedestrians and other people on the road, user knowledge of local traffic rules and laws, the hiring of independent contractors to collect scooters, and ensuring

devices aren't left in public right-of-way areas, among others.

Councilmember Lester Friedman also expressed that he felt the companies behaved as "bad actors" when they allowed these devices to enter into the city without communicating with the city in an effort to force the Council to act.

"I am extremely receptive to the additional mobility that these devices can provide. I think it's an excellent attempt to resolve the first and last mile issue and it's a clean air alternative that lowers the carbon footprint in terms of transportation. However, the fact that this was launched without any contracts or permits, contact with cities, or business licenses is an outrage," Friedman said. "These companies brought this to the forefront very quickly. That was their goal. They have significant funding and were aware of the regulatory requirements. There was no show of concern for pedestrians or its riders. I think they have a responsibility to enforce license and helmet restrictions and I think they've only given lip service to it, rather than actually addressing it.'

Mayor Julian Gold agreed with Friedman's assessment, saying he had no problem supporting the ordinance considering the behavior of the device vendors.

"Once they released this in a single city and saw the impact it had on that city, they should have known enough to stop and fix it. They saw it was wrong. They did not. The only regard they have is for their profit. That's all this is about, profit," Gold said.

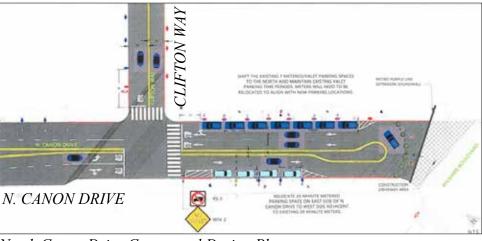
"We had someone this afternoon that the corporations did this because they wanted to move the needle. This was their way to make cities speed up. Interesting strategy," he continued. "I think the needle has gone too far in the other direction and that's why we're here tonight. It's one thing to beg forgiveness instead of asking permission. That doesn't mean that you get it. This is an instance where forgiveness is not to be given. They put everyone here at risk."

The ordinance was placed into effect immediately.

Council Approves Design Plans for North Canon Closure

At its July 24 meeting, the Beverly Hills City Council unanimously approved recommended roadway designs for North Canon Drive and Clifton Way for the temporary closure of North Canon Drive at Wilshire Boulevard, which is a result of Metro Purple Line Extension construction.

Specifically, the plans for North Canon Drive include the construction of a sound wall along the northern boundary of the property at 160 Norton Canon Drive, creating a cul-de-sac, creating one southbound lane to accommodate turning vehicles around the cul-de-sac, retention of two northbound lanes, shifting parking stalls on the east side of the street to the north to provide space for the sound wall and vehicle traffic, relocating one 20 minute metered parking stall on the east side of North Canon Drive to the west side of the street, and the creation of a new 10-

foot wide pedestrian crossing area, which includes new curb access ramps on each side of the street.

At the request of local stakeholders the designs for North Canon retain seven existing valet spaces, a second north-bound lane that valet drivers can use to more quickly move vehicles off of the cul-de-sac, a second northbound lane to minimize the possibility of southbound vehicle queuing, and the existing metered parking for business patrons traveling to the area outside of valet hours.

For Clifton Way, the design plans include the installation of a new traffic signal at the intersection of Clifton Way and Crescent Drive, temporary removal of parking on the south side of the street to allow the center line to be shifted south for wider travel lanes, temporary conversion of the one-way southbound alley that intersects with Clifton Way into a two-way alley, temporary parking removal on the south side of Clifton, and the temporary removal of one parking stall on the north side of the street at the intersection with North Canon Drive.

The sound wall that will be constructed along the property at 160 North Canon Drive will be covered with artwork, which has not yet been selected or commissioned. Vice Mayor John Mirisch suggested that Metro partner with the Fine Arts Commission to find an appropriate artist or piece of artwork for the wall.

Other art options include working with the Next Beverly Hills committee to develop a mural program, using the wall to showcase past winners of the Beverly Hills Art Show, creating a graphic design to incorporate elements of the Winter Bold graphics, and creating a graphic associated with the previously approved public information graphics that will be applied to the other sound walls in the Wilshire/Rodeo station area.

The approved design plans are meant to address noise, vibration, and pollution generated by Metro construction activity, and to mitigate possible driver confusion due to lane closures required during various construction activities.

Tracey Spillane, who represented Wolfgang Puck's Spago, was one of the stakeholders who worked with Metro and the city on the plans and stated that she saw placing a cul-de-sac with an art wall on the street as an opportunity.

"We are creating a kind of neighborhood at the end of the street," Spillane said. "We have something happening in Beverly Hills that is a little scary. It's not

going to be pretty. There are opportunities with the artwork on the wall to tell a positive story."

Spillane also suggested that the area could be a neighborhood meeting place where local restaurants could invite the public out to try their food offerings.

Councilmember Robert Wunderlich agreed with Spillane's suggestion of turning the cul-de-sac into a neighborhood meeting area and even suggested developing it into a public pedestrian plaza.

Councilmember Lili Bosse supported the idea of a plaza, saying the area could potentially become a "hotspot" for residents to spend time in, similar to the table and chair communal area on Rodeo Drive.

Ultimately, the council did not include provisions to develop a pedestrian plaza space but requested that additional study be done to see if there could be space for a communal area, which would be presented to the Council at a later date. The design concepts were previously approved by the Beverly Hills Police Department and the Fire Department.

Board of Education Approves Resolution Expanding Powers of COC

The Beverly Hills Board of Education voted on July 24 to adopt a resolution expanding the responsibilities of the Independent Citizens' Bond Oversight Committee (COC) to include the review of expenditures of both Measure E and the Measure BH bond proceeds.

Previously, the COC only had jurisdiction over Measure E bonds. Because of this, the board also approved an amended and restated version of the COC bylaws, which set forth the expanded power and responsibilities of the committee.

The new bylaws state that the committee "shall confine itself specifically to bond proceeds generated under Measure E and Measure BH," and that "regular and deferred maintenance projects and all monies generated under other sources shall fall outside the scope of the Committee's review."

The expansion of COC powers was in compliance with Proposition 39, which requires the district establish, populate, and empower an independent Citizens' Bond Oversight Committee.

In other business, the board established the interdistrict permit cap at zero and accepted the completion of construction on the multipurpose room and selective

Second Hilton Public Scoping Meeting Held at City Hall

A public presentation of the Draft Supplemental Environmental Impact Report (EIR) for the proposed Beverly Hilton Specific Plan Amendment was held at the Municipal Gallery at City Hall on July 18.

The meeting marks the second scoping meeting for the modified Hilton project, which includes the construction of a single 23-story residential building, the demolition of Palm/Oasis Court, construction of subterranean parking to accommodate 2,193 vehicles, renovation of Beverly Hilton Wilshire Tower and pool area/features, and the construction of a one-story conference center, and was intended to give local residents the chance to participate in the planning process.

Several members of the community spoke at the meeting and expressed concerns regarding the impact the developed by stating that staff does not decide whether a project is approved or not and that there will be more time for the public to express their concerns before the project gets off the ground.

'Our goal is to make sure decision makers have enough information to make smart decisions that reflect your interests," Gohlich said. "We want to make sure everyone has a chance to be involved in this process."

Attendees also questioned why the amended version of the project would not require an entirely new environmental impact report, as the previous studies were conducted when the project was first approved in 2008.

Gohlich and Associate Planner Cindy Gordon explained that this was due to criteria outlined in the California Environmental Quality Act (CEQA) that allows development projects to re-use data that has not changed since 2008.

COC Report Critical of Board of Education **Litigation Spending**

In its recently released fiscal year 2016-2017 report, the Citizens Oversight Committee (COC) expressed concern that the Beverly Hills Board of Education has not been transparent regarding the use of public bonds to pay for litigation opposing the proposed Metro Purple Line Extension project.

"The Committee has requested redacted legal invoices, and also has attempted to obtain a legal opinion addressing whether Measure E funds can be used for the litigation," the COC wrote in the report. "The Board of Education has not facilitated the requests basing its refusal on attorney-client privilege. The Committee has also expressed concern about certainly hourly rates charged for legal consulting services.'

According to the report, Measure E funds have been used to fund the cost of litigation against the Purple Line Extension project, which would place a subway tunnel would run beneath Beverly High.

The total amount spent from the inception of the Measure E bond initiative relating to Metro litigation was \$14,227,000, the report said.

Relatedly, the committee also stated that "legal expenditures reduce bond funds available for construction," and noted that the district does not have a budget for the federal lawsuit it filed in January 2018 requesting that adjustments to the proposed Metro Purple Line Extension project should be made.

The report also includes the details of a performance audit conducted by Moss Adams 456 North Rodeo Drive LLP and of a financial audit conducted by Moss, Levy & Hartzheim LLP for July 1, 2016 through June 30,

In the performance audit, Moss Adams LLP found that labor charges totaling \$96,770 were allocated between the bond program and other district activities without direct cost identification and that, based on 52 sampled invoices, district payment procedures lack adequate documentation to validate compliance with their own policies and contractual agreements regarding payment terms on sampled expenditures.

Moss Adams LLP also found that the district did not have competitive solicitation documentation available for professional service contractors, was unable to substantiate compliance with the Informal Bidding Requirements Policy for procurement of work projects between \$45,000 and \$175,000 in contract value, and was unable to demonstrate prior Board approval for a \$33,228 amendment with professional service provider Knowland Construction resulting in noncompliance with policies and procedures.

Architectural Commission Approves Façade Modifications at 456 North Rodeo Drive

The Beverly Hills Architectural Commission approved a request for a façade modification and signage requests for Celine at 456 North Rodeo Drive during its July 18 meeting.

The specific request was for a façade modification, sign accommodation for multiple business identification signs, and a sign accommodation to allow business identification signage to face property and/or an alley.

The approved façade modifications include a polished stainless-steel storefront system along Rodeo Drive, specialty door handles, low iron clear glass, black specialty tile at entry, and retention of re-



maining existing façade treatments.

"We have a project here that can go forward without a memo. That almost never happens, so that's great," Commission Chair Sheri Hirschfeld said.

In other business, the commission gave a preliminary review of the construction of a new five-story multi-family residential building at 425 - 429 North Palm

In October 2014, the commission first reviewed an alternate design for a new contemporary style five-story condominium building as a previous item at this site. In January 2015, the commission approved a development plan review and an R-4 Permit to allow the construction of a new 20-unit multi-family residential development at the same location.

The preview project most recently put before the commission was a significantly altered iteration of the 2015 design, according to Kevin Tsai, the architect working on the development.

Tsai said the new design fits into a streamlined formalist modern aesthetic and was created based on symmetrical organization with emphasis given to a recessed green wall on Beverly Boulevard and glazed terra cotta clad pilaster features highlighted along the North Palm elevation.

Notice regarding State Farm California Personal Property Depreciation Decision

The case regarding State Farm's method of depreciating personal property in California was tried in Santa Clara County Superior Court in November and December of 2015. After hearing the evidence and arguments presented by both sides, the Court issued its decision on April 20, 2016. The Court held that for certain claims State Farm did not calculate depreciation according to the requirements of California law and also failed to adequately notify its policyholders, in writing, of the basis or reasoning for its calculation of depreciation.

Since this lawsuit was filed, State Farm has changed its claim adjustment practices. State Farm now asks policyholders who make a personal property claim to rate the condition of each item of lost or damaged personal property they claim. State Farm then factors condition into its calculation of depreciation. The full text of the Court's Decision is available at statefarmpersonalpropertysettlement.com.

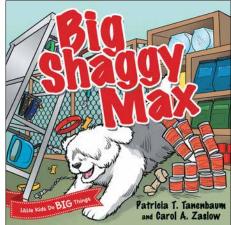

Tanenbaum and Zaslow Teach Community Service Through Literature

Longtime Beverly Hills resident Patti Tanenbaum and lifelong friend Carol Zaslow have published their new book, "BIG SHAGGY MAX." The book is the first installment in a new series titled, "Little Kids Do BIG Things," which they hope will teach children the importance of being active, kind participants in their communities.

You recently published your first children's book, "Big Shaggy Max." What inspired you to become a children's book author?

Tanenbaum: It's a little tangential, but we decided to do this together after knowing each other, or knowing of each

other, for many years. We were in the same neo-natal unit after we were born and our parents knew each other. We were apart after that for many years, but we later reconnected and there were so many similarities between us. We both started community service programs at our kid's schools, we were both teachers, we were then PTA presidents. Growing up, our dogs even had the same name and were both French poodles. Now, we have the same wallpaper in our house.

We did all of this totally independent of each other, but that's sort of the story of how we came to do this together.

Specifically about the children's books, we both taught and had sort of a similar history in teaching and community service. We also both come from families who served and had mothers who really taught us the importance of serving the community. We taught our children to volunteer. So, this is just channeling that energy, doing what we've always done, in a different medium. It feels good to

The book is the first in a series entitled, 'Little Kids Do BIG Things.' Will the next installment in the series focus on the same set of characters from this first book?

Zaslow: We are working with reoccurring characters. We have a few that will take on more dominant roles in this book. Those are characters that were in the previous book, but who we didn't focus on as much. The two little boys and Big Shaggy Max will return for sure.

Patti's husband, former Mayor Robert K. Tanenbaum, is also an author. Did he give you any advice as you got started with this book?

Tanenbaum: Well, you know, he produces these huge books rather rapidly and we've been working on this for years. He's always been encouraging. He would read it and let us know what he thought. He was always very kind about it, but he always said to me when I asked for advice that he was afraid if he helped that it would become his story when it really should be the story we want to tell. He's definitely very supportive.

When and where will your book be available for purchase?

Zaslow: You can buy the book in three

Assemblymember Autumn Burke on legislation that affects every **Beverly Hills resident**

By Kelcey Caulder

Beverly Hills Weekly sat down with Assemblymember Autumn (D-Marina Del Rey) on Friday to discuss policies and legislation of interest to Beverly Hills residents, including her bill to offset the effects of President Donald Trump's tax bill and the Reproductive FACT Act, which she co-authored and was recently vetoed by the U.S. Supreme Court.

What are some of the specific goals you have for the next legislative session?

For next session, we'll take the results of the report that our poverty taskforce puts together and start developing legislation from that report. So, our goal for next year is really to create a Lifting Children Out of Poverty package.

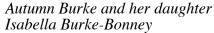
The governor approved AB 1520, which establishes the Lifting Children and Families Out of Poverty Taskforce, in October 2017. Can you tell us about this legislation?

There are two million children living in poverty in the state of California. We wanted to lift one million of those children out of poverty over the next 20 years. The taskforce will be coming up with a report that includes analysis of housing, health, workforce, and a few other areas. It will be a comprehensive report that looks at what looks at what specific steps need to be taken to ensure we meet the goal of lifting one million children out of poverty over 20 years. Then, from that report, we will develop legislation instead of just creating what we think might help. This is our way of creating a data-driven package of leg-

A lot of your work centers on supporting working families. What impact does your background as a working mother with a young child have on the policy positions and initiatives you support?

It's being a working mother and it's coming from a district that has struggled. 70 percent of children that enter into high school levels never see a community college or university. That is a lot of young people to not have a

future. Not every student is going to go to college, but we have found that career technical education does help more children go to a secondary education. By 2025, there will be over one million jobs that only require certificate to have a \$50,000 a year job. So, those people, that 70 percent of students, are my focus because they're the forgotten ones and they're a majority. I think that's unacceptable.



This January you were named Chair of the powerful Assembly Revenue and Taxation Committee. Tell us a little more about AB2217, a bill you authored to combat the effects of the Trump tax bill on California by allowing taxpayers to transfer 90% of charitable contributions to the state in exchange for a lower state income tax liability.

So, that bill establishes the Bridget 'Biddy' Mason Golden State Credit Program. We spent a lot of time with professors and legal experts because we wanted to create a program that we did not think would get any legal challenges or that could sustain legal challenges if there were any, which is part of the reason ours is different from State Senator Kevin de Leon's bill in the sense that you can donate to any nonprofit. You can also contribute to a public high school or you can contribute to a secondary university like a community college or a Cal State or any school as long as they take Cal Grant students. So, we believe that ours has a stronger legal standing than some of the other alternatives that have been put out there. Our bill is similar to de Leon's. I've been asked if at some point they might come together and the answer to that is absolutely and I absolutely have no issue with that. Right now, they are two separate bills on their own tracks, but ours focuses on taking care of taxpayers and nonprofits, which we were afraid might take a hit, at the same time.

The U.S. Supreme Court recently ruled against the Reproductive FACT Act, which authored you Assemblymember David Chiu, in a 5-4 vote in NIFLA v. Becerra. After that

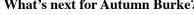
decision, you said you were proud of California's history of guaranteeing a woman's right to reproductive choice, but felt that became an "empty promise" if women aren't provided with adequate information to make healthcare decisions. Do you still feel

I do. I felt that way when we did the bill and I feel that way now. I just really cannot imagine my daughter growing up in a world where she is not provided all the factual information that she deserves. We have consumer protections for everything else we do in the state of California and to not provide women with the same consumer protections makes little to no sense. It is an empty promise that we are going to protect

What's next for Autumn Burke?

I don't have a lot of plans for what comes after this. Right now, I just want to do a good job. I just want to do the best job I can for the [62nd] district that trusts me and elects me every two years. That's what is really important to me right now.

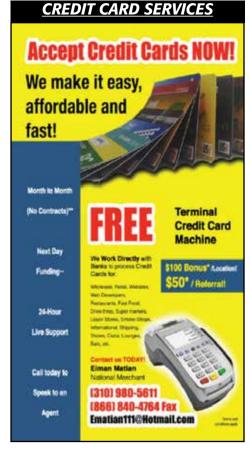

ORDINANCE NO. 18-O-2756

AN ORDINANCE OF THE CITY OF BEVERLY HILLS AMENDING THE BEVERLY HILLS MUNICIPAL CODE REGARDING LOUD AND UNRULY GATHERINGS

THE CITY COUNCIL OF THE CITY OF BEVERLY HILLS DOES HEREBY ORDAIN AS FOLLOWS:

Section 1. The City Council hereby adds Article 3 ("Loud and Unruly Gatherings") to Chapter 1 ("NOISE REGULATIONS") of Title 5 ("PUBLIC HEALTH, WELFARE, AND SANITATION") of the Beverly Hills Municipal Code to read as follows:

Article 3. Loud and Unruly Gatherings

5-1-301: Definitions.

For the purposes of this Article, the following definitions shall apply:

- A. "Loud or unruly gathering" means a gathering of three (3) or more persons for a social occasion or any other activity at any residential unit during which loud or unruly conduct occurs that constitutes a violation of the California Penal Code or is otherwise a threat to the public peace, health, safety or welfare, including, but not limited to, any or all of the following:
- Loud noise or music from any source that results in a violation of the noise regulations contained in Chapter 1 of Title 5 of this Code;
- b. Obstruction of a street or other public right of way (as defined in Section 8-7-2 of this Code), or a portion thereof, with vehicles or pedestriens:
- vehicles or pedestrians;
 c. Public intoxication or drinking in public;
- d. The service of alcohol to minors;
- e. Possession and/or consumption of alcohol by minors;
- f. Assaults, batteries, fights, domestic violence or other disturbances of the peace;
 g. Vandalism or destruction of real or per-
- sonal property;
- Littering of any trash, debris, bottles, cans or other items of personal property on real property or on a public right of way: or
- i. Urinating or defecating in public.
- B. "Minor" means any person under the age of 18 years old.
- C. "Owner" means any person(s), including any individual, firm, association, organization, partnership, trust, business, corporation, company or other entity, who owns the residential unit where a loud or unruly gathering occurs, as shown on Los Angeles County's last equalized property tax assessment roll, or the supplemental roll, whichever is more current.
- D. "Residential unit" means any residential "dwelling unit," such as a single-family dwelling or residence, and each unit of all multiple dwelling unit properties that were developed as apartment buildings, duplexes, triplexes, fourplexes, cooperatives ("co-ops"), condominiums, or townhomes. A residential unit also includes: (i) any other buildings, structures and improvements on the premises, as well as balconies, decks, patios, yards, and all other interior and exterior areas; and, (ii) common use or other areas of multiple dwelling unit properties. However, "residential unit" does not include any room or unit of a hotel or motel.
- E. "Responsible person" means and includes without limitation:

- 1. Any person(s) who owns, rents, leases or otherwise is in charge of the residential unit where a loud or unruly gathering occurs: or
- 2. Any person(s) (including any individual, firm, association, organization, partnership, trust, business, corporation, company or other entity) who organizes, promotes or sponsors a gathering that becomes loud or unruly: or
- a. Any person(s) who attends or is present at a gathering and engages in loud or unruly conduct
- If the responsible person is a minor, then the parent(s) or guardian(s) of such minor shall also be considered a responsible person.

5-1-302: Loud or Unruly Gathering—Public Nuisance.

It shall be unlawful and constitute a public nuisance for any person to cause or allow a loud or unruly gathering to occur at any residential unit within the City. A loud or unruly gathering may be abated by the City by all reasonable means, including, but not limited to: (i) an order of a peace officer to a responsible person to immediately terminate the occasion or activity; and/or, (ii) an order of a peace officer to all non-resident persons at a gathering to immediately leave the premises. It shall be unlawful and a violation of this Article for any person to fail to comply with an order of a peace officer that is issued in connection with a loud or unruly gathering. The abatement of a loud or unruly gathering by peace officers shall not preclude the City from exercising its other remedies against persons who violate this Article, including without limitation, the issuance of administrative or criminal citations.

5-1-303: Absentee Owner - Liability Exceptions

Any owner who does not reside within the residential unit at the time a loud or unruly gathering occurs shall not be liable under this Article if such owner has: (1) included covenants within the written lease or rental agreement for the premises on which a loud or unruly gathering occurs that contain specific language prohibiting the activities described in this Article; and (2) demonstrated due diligence in abating an unmanageable tenant(s) or responsible person(s) for a loud or unruly gathering. Prior to September 1, 2019, owner who does not reside within the residential unit and has a written lease or rental agreement dated on or before the effective date of the Ordinance adopting this section for the residential unit on which a loud or unruly gathering has occurred shall only need to demonstrate due diligence in abating an unmanageable tenant(s) or responsible person(s) for a loud or unruly gathering to not be liable under Section 5-1-302 this Article.

5-1-304: Liability for Subsequent Responses to Loud or Unruly Gatherings.

When a peace officer intervenes (by issuing one or more of the orders stated in Section 5-1-302) at a loud or unruly gathering, the responding officer shall issue a written notice to the responsible person(s) stating that such responsible person will be held liable for the costs of providing police personnel over and above the normal services provided by the police department to those premises. A first warning shall be deemed to be the normal services provided. If after the issuance of first warning, police personnel are required to respond to address another violation of this Article at the same residential unit within one year after issuance of said notice, then the responsible persons shall be jointly and severally liable for the costs of each subsequent police response necessary to abate the condition, as set forth in Section 5-1-305.

5-1-305: Cost Reimbursement.

- (A) The responsible person(s), or if such person is a minor, then the parents or legal guardians of the minor, shall be jointly and severally liable for all of the following costs attributable to the loud or unruly gathering:
- (1) The actual cost incurred by the City beyond the initial response by the City necessary to abate the loud or unruly gathering, including but not limited to police and

fire response;

- (2) Damage to public property;
- (3) Injuries to City personnel; and
- (4) Administrative costs incurred by the City in connection with the billing and collection of such costs.
- (B) The police department shall accurately compute the cost to the City of providing such services pursuant to paragraph (A) of this section. The responsible person(s) shall be billed for these costs by the City and payment shall be due and payable within 15 days of the billing date. Should the amount of the bill not be paid when due, the City may collect the debt, as well as any costs incurred in collecting the debt due to nonpayment, pursuant to any available provision of the law.

5-1-306: Administrative Citations.

For any violation of this Article, the administrative fine shall be one thousand dollars (\$1000.00) for each violation.

5-1-307: Written Notice.

The Chief of Police is authorized and directed to prepare appropriate advisory procedures to be followed by officers responding to a loud or unruly gathering, including preparation of written materials advising the responsible person or persons of the provisions of this Article.

5-1-308: Appeal.

Any person receiving an administrative fine or a bill for City services provided pursuant to this Article may file a written request for appeal pursuant to the provisions provided in Article 3 ("Administrative Penalties") of Chapter 3 ("Code Violations") of Title 1 ("General Provisions") of this Code.

<u>Section 2</u>. The City Council hereby amends and restates paragraph A of Section 1-3-323 ("COLLECTION OF ADMINISTRATIVE FINES AND COSTS; LIEN PROCEDURE") of Article 3 ("Administrative Penalties") to Chapter 3 ("CODE VIOLATIONS") of Title 1 ("GENERAL PROVISIONS") of the Beverly Hills Municipal Code to read as follows:

1-3-323: COLLECTION OF ADMINISTRA-TIVE FINES AND COSTS; LIEN PROCE-DURE:

A. If the responsible person fails to satisfy in full the assessed administrative fines and costs by the time specified in the administrative hearing officer's decision or the administrative order, and no timely appeal of the administrative officer's decision has been filed with the Los Angeles Superior Court, the City may recover the outstanding fines and costs by imposing a lien against the real property on which the violation occurred.

<u>Section 3.</u> The City Council hereby amends and restates Section 1-3-324 ("APPEAL OF DECISION OF ADMINISTRATIVE HEARING OFFICER") of Article 3 ("Administrative Penalties") to Chapter 3 ("CODE VIOLATIONS") of Title 1 ("GENERAL PROVISIONS") of the Beverly Hills Municipal Code to read as follows:

1-3-324: APPEAL OF DECISION OF ADMINISTRATIVE HEARING OFFICER:

Within twenty (20) days after service of the administrative hearing officer's decision upon the responsible person, the responsible person may seek review of the administrative hearing officer's decision by filing a notice of appeal with the Los Angeles Superior Court, Stanley Mosk Courthouse, Clerk of the Court/Room 102 (Civil Filing), 111 North Hill Street, Los Angeles, CA 90012. The responsible person shall serve a copy of the notice of appeal either in person or by first class mail upon the citing department. If the responsible person fails to timely file a notice of appeal, the administrative order shall be deemed confirmed.

<u>Section 4.</u> <u>Severability.</u> If any section, subsection, subdivision, sentence, clause, phrase, or portion of this Ordinance or the application thereof to any person or place, is

for any reason held to be invalid or unconstitutional by the final decision of any court of competent jurisdiction, the remainder of this Ordinance shall remain in full force and effect

Section 5. Publication. The City Clerk shall cause this Ordinance to be published at least once in a newspaper of general circulation published and circulated in the City within fifteen (15) days after its passage in accordance with Section 36933 of the Government Code, shall certify to the adoption of this Or-

dinance and shall cause this Ordinance and the City Clerk's certification, together with proof of publication, to be entered in the Book of Ordinances of the Council of this City.

<u>Section 6.</u> <u>Effective Date.</u> This Ordinance shall go into effect and be in full force and effect at 12:01 a.m. on the thirty-first (31st) day after its passage.
