# **"Rent Stabilization Ordinance**"

I have been a resident of Beverly Hills for almost 40 years. During that time, while the city has become less affordable the city services and amenities have not improved. Introducing rent control would be the latest bad decision by the city council that would make the city less livable and more expensive in the long run.

For 20 years, we have maintained an office at 9171 Wilshire Blvd. Our rent more than doubled in the last 5 years due to the NIMBY policies, such as undue restriction on new construction. We are now in the process of moving our office to Culver City, where we will also benefit from the lack of city taxes.

So with prices on the rise and housing scarcer than ever, why act to make housing even more expensive especially to the new renter, to the landlord, and to the city?

Since Beverly Hills was incorporated in 1914, we have enjoyed a high quality of life with few complaints about housing. As a landlord with properties around the metropolitan area, I can attest that the market in Beverly Hills works much better than in Los Angeles and Santa Monica, with buildings in better repair, tenants getting better service, and apartment values rising (and bringing in higher property taxes).

Collecting data of the square footage of my apartment, my rent, and in general, "protecting" me is not only very expensive for the City (and the taxpayer), but much worse, it is inefficient. After all, isn't that what the legal system is for? Besides, the City itself lists on its website several resources for tenants. What could more draconian City regulations possibly add?

## **Resolution Passed Approving Open Air Dining Permit**, **Extended Hours for Urth** Caffé

After multiple discussions and robust public comment, the Beverly Hills Planning Commission passed a resolution last week approving a one-year Open Air Dining (OAD) Permit and Extended Hours Permit for Urth Caffé.

The resolution allows the café to continue operation of open air dining on private property and on the public right-of-way, change its hours of operation to 6:00 a.m. to 11:00 p.m. Sunday-Thursday and 6:00 a.m. to 12:00 a.m. Friday-Saturday, waive 16 code-required parking spaces associated with the open air dining on private property, and allow for a total of 952 square feet of open air dining.

Because of prior feedback provided by Beverly Hills residents at the commission's July 12 meeting, four conditions were incorporated into the resolution with the intent to mitigate the effects that a restaurant opening earlier and staying open later might have on the surrounding community and neighborhood.

These conditions include implementing a sound attenuation barrier at the southwest corner of the restaurant to help reduce noise disruptions to the residential properties located west of the café, the development of an employee manual or handbook that

outlines restaurant operations, conducting public outreach to patrons and neighbors to the 200 block of South El Camino Drive with the goal of encouraging them to maintain a clean and peaceful environment wherein disturbances related to the café can be reported immediately, and the removal of litter from the surrounding neighborhood twice a day, seven days a week.

Commissioner Peter Ostroff urged Shallom Berkman, who owns Urth Caffé, to follow the conditions of the permits closely if he wants to renew them again in a year.

"There are some pretty significant con-

ditions that have been attached to this one year extension and I hope that you will adhere to those. I'm sure you intend to and I encourage you to do that," Ostroff said. "With respect to the public, there were quite a few people who expressed concerns and I would urge you to be vigilant."

## **Planning Commission Denies Proposal for 331 North Oakhurst Drive**

At its July 26 meeting, the Beverly Hills Planning Commission adopted a resolution denying requested variances and development plan review for the construction of a two-story building at 331 North Oakhurst Drive.

The commission previously heard five requests for potential construction at the project site. Most recently considered was a proposal for the establishment of an adhoc committee, which the commission denied. Two new proposals were heard on Thursday, though only one was agendized and presented through the proper channels.

Hamid Gabbay, who is the architect for the 331 North Oakhurst Drive project, submitted one proposal to city staff prior to the meeting detailing one set of construction plans. This proposal was

given to the commission for review. The proposal submitted to staff in advance of the meeting detailed plans for a

two-story, one-unit building. It would be approximately 22'2" tall with a 3'6" parapet and would cover 2,329 square feet. It would be constructed on a 3,324 square foot lot. The plans also included three uncovered parking spaces ,a request for a habitable basement area, which is not typically allowed in a multi-family zone,

reduced rear and side setbacks, and a new curb cut on Third Street.

The initial plans also requested that the commission conduct a development plan review for the construction and nine variances, including variances that allow the reduction of the required side yard setback, reduction of the required rear yard setback, extension of a porte-cochere to encroach into a rear yard setback, extension of the basement lightwell to encroach into a required side yard, encroachment of a porte-cochere into a required rear yard, and several others.

This was not, however, the presentation that Gabbay brought before the commission. He brought a new set of plans not yet reviewed by city staff, which included difference like an enclosed garage and a change to the square footage of the construction.

When asked by the commission why he felt it was appropriate to present them with new information that they were not able to study before making a decision, Gabbay responded that he proposed the new floor plan on Monday and that staff suggested he present it at the meeting.

'What I would like to do if the commission agrees is present the new floor plan and, if it's okay with the commission, you could give us a preliminary approval," Gabbay said. "Then, we'd come back with a complete set for your review or you could refer it to the department to review and approve."

Commission Chair Andy Licht said he was open to hearing a new, revised version

of the proposal but noted he could not make a decision on any project until it had been properly reviewed by city staff. "I person-

relation to the 9200 Wilshire Boulevard mixed use project, which has been in the works since 2007.

The text amendment eliminates "elevator penthouses" from the list of rooftop structures that are allowed to exceed the 60-foot maximum height of the M-PD-4 zone, where the project site is located, by 10 feet and instead allows the penthouses to reach 15 feet in height above the ad-

jacent roof deck. The amendment is expected to improve constructability and functionality of elevators providing rooftop access and brings the zone in line with standards in other zoning areas around the city.

Because the M-PD-4 zone was created in 2007 by the City Council and includes only the property located at 9200 Wilshire Boulevard, the zone text amendment applies only to the project site and would not affect other city zoning regulations.

The commission also found that proposed changes to the project are in substantial complains with plans previously approved by the Planning Commission in October 2017.

These modifications include the construction of 248 additional subterranean parking spaces, up from 220 in the 2017 proposal, modification of the configuration and number of ground floor parking

spaces to 19 spaces, a 1,167 square foot reduction in the north (Wilshire Boulevard) side building modulation and corresponding increase of 877 square foot to the south side building modulation related to the size and location of balconies and other common open space, and other minor modifications to the design of the building including minor changes to the window configuration on the south side of the building and the reversal

of locations of loading spaces to accommodate building equipment.

Commissioner Peter Ostroff questioned why the adjustment would be necessary for elevator penthouses. City Planner Ryan Golich said that it was part of ensuring the building provided Americans with Disability Act (ADA) access to those areas

With regard to the elevator, the code allows 15 feet and it seems infeasible to

build it with 10 feet, so I'm supportive of that change. The additional parking is obviously a benefit," Vice Chair Alan Block said.

"I think the elevator is obvious, parking is great, and modulation is very, very small. I can support this and make the findings," Commission Chair Andy Licht said.

In other business, the commission approved a recommendation from staff to put off any decisions related to a hillside R-1 permit revision request for 1506 Lexington Road, due to unpermitted construction activity completed at the site.

## **City Council Tables Possible Crosswalk Installation on Third Street**

At its July 24 study session, the Beverly Hills City Council tabled a request from city staff for direction regarding the possible installation of a mid-block crosswalk along Third Street, west of Maple Drive, due to extended discussion regarding the use of shared mobility devices within the city.

Four treatment options have been suggested by Fehr & Peers, the city's on-call transportation engineering consultants, following the competition of a traffic circulation review in the area adjacent to the Maple Drive post office.

These treatment options include improving the existing crosswalk at the west leg of the intersection of Third Street and North Maple Drive with high-visibility continental crosswalk markings; installing a mid-block high visibility crosswalk with bulb-outs, enhanced signage, and additional lighting on the north and south sides of the street; installing a high visibility raised mid-block crosswalk, including enhanced signage and additional lighting on the north and south sides of the street; and considering installation of a mid-block crosswalk after construction is complete at 325 North Maple Drive to evaluate traffic and pedestrian activity.

Estimated costs for these options range from approximately \$5,000 to approximately \$160,900.

An additional option is to add a second on-street Americans with Disabilities Act (ADA) space on the south side of Third Street immediately adjacent to the currently existing ADA space. The installation cost of a second on-street ADA space, including staff time and materials, is approximately \$400.

If approved, the decision to install a new mid-block crosswalk would be the latest effort in a string of transportation improvements aimed at calming traffic and providing public parking for persons with disabilities in the area.

In August 2017, the Council approved the installation of eight 10-hour parking meters on the north side of Third Street, west of Maple Drive, and later added parking on the north side of the street as a traffic calming measure in November 2017. Parking meter heads were installed in December 2017.

Resident David Gingold later expressed concern to the Council regarding the lack of parking for persons with disabilities near the 325 North Maple Drive post office on the 9200 block of Third Street.

As a fix, he requested the city remove the 10-hour parking signs on the north side of the street and replace them with 1-hour parking signs, and install on-street ADA parking spaces on the north and south sides of the street adjacent to the post office.

The city followed through on Gingold's request in January 2018 by installing an ADA parking space on the south side of Third Street in January 2018 and replacing the 10-hour parking signs with 1-hour parking signs.

The building at 325 North Maple Drive, which has been closed for construction, is tentatively set to open in August 2018. Upon opening, 19 parking spaces, including two marked ADA spaces, will be available for post office patrons at no charge in the underground parking garage.

The Council will revisit the topic at its next meeting on August 7.

## **Beverly Hills Collaborates** with UCLA for Mobile **Stroke Unit Services**

At its last meeting, the Beverly Hills City Council entered into an agreement with UCLA Health System for the provision of 'Mobile Stroke Unit' (MSU) services, or emergency stroke transport services, within the city for 36 months as part of a pilot program.

The MSU is a modified ambulance, equipped with a mobile computed tomography scanner, stroke correlating medication, medical personnel specific to managing stroke patients (a UCLA neurologist, UCLA critical care nurse, UCLA CT technician, a Santa Monica firefighter/ paramedic to operate the MSU and assist with patient care as need, and telemedicine equipment.

Under the agreement, the MSU will provide rapid, on scene, advanced diagnostics and therapeutic interventions for patients with ischemic stroke in collaboration with the Beverly Hills Fire Department.

BHFD will make contact with the MSU any time they are presented with a stroke patient so that the unit can come to the scene to provide medical care. Additionally, the MSU will be able to screen calls

from BHPD's Emergency Medical Dispatch and 'self-dispatch' if a call resembles a possible stroke.

The unit will operate in Beverly Hills every other week, 4 days per week, 10 hours per day for the length of the pilot program.

# **Keith Sterling New Public Information Manager City of Beverly Hills**

Longtime Beverly Hills Public Information Manager Therese Kosterman retired last week. Keith Sterling, a former television journalist and public information officer for multiple cities, universities, and school districts, has been named as her successor.

Can you tell us a little bit about your background in media and government?

I began my career in television journalism as a news re-

porter and anchor. I did that for seven years. Then, about 15 years ago, I transitioned into communications and public relations. I've when they can still use worked in several cities, at universities, and in school districts as a communication officer or pub-

I'm now looking forward to meeting community members and residents and doing my best to tell the story of Beverly Hills.

mize the resources that we have to tell the city's story. In the coming months, I'll be working to develop a strategic communications plan for the city where we take a closer look at our current communication tools and see where our strengths are and maybe where we can have some improvement.

### You get calls from media all over the world. Give us a few examples of those calls.

I have only been here a few weeks and I've spoken with reporters from The Wall Street Journal and The Hollywood Reporter. Those are the two that jump immediately to my mind. For me, though, what is really important and, I think, valuable is the local media and reporters in Beverly Hills. They serve our community every day; so it's important to me that information get to those local reporters. But, to go back to your question, yes. Because of the high profile nature of the city, we do tend to attract attention from all corners of not only the country, but also from all around the world. Therese told me she routinely heard from international media during her tenure with the city. I've experienced that a little bit in my short time here and I'm sure that will continue to be the case.

### Finish the sentence. Good communication is...?

Timeliness and transparency. Those are the two words that come to mind for me when I think about what good communication has to be. It's all about making sure people have information that is useful and helpful when they can still use it. It has to be delivered in a timely manner. Good communication is also about being transparent and open with our operations and about how the city works.

### **ORDINANCE NO. 18-0-2757**

AN ORDINANCE OF THE CITY OF BEVER-LY HILLS ADDING CHAPTER 6 (SHARED MOBILITY DEVICES) TO TITLE 7 (TRAFFIC, PARKING, AND PUBLIC TRANSPORTA-TION) OF THE BEVERLY HILLS MUNICIPAL CODE TO PROHIBIT SHARED MOBILITY DEVICES FROM BEING PLACED IN ANY PUBLIC RIGHT-OF-WAY OR ON PUBLIC PROPERTY, OPERATED IN ANY PUBLIC-RIGHT-OF-WAY OR ON PUBLIC PROPER-TY, OR OFFERED FOR USE ANYWHERE IN THE CITY

THE CITY COUNCIL OF THE CITY OF BEV-ERLY HILLS HEREBY DOES ORDAIN AS FOLLOWS:

Section 1. Dockless electric scooters and bicycles, available to be rented on demand from unstaffed locations, arrived in the City suddenly and unexpectedly, and have since proliferated rapidly. These shared mo-bility devices are unregulated, and are fre-quently abandoned by users in streets, sidewalks, and other public places throughout the City, creating serious safety concerns, especially for the City's most vulnerable pe-destrians. Moreover, due to the spontaneous nature of these rentals and their appeal to young people, shared mobility devices are nearly always operated by users-often mi--without helmets, in contravention of norsstate law. For the immediate preservation of the public peace, health, and safety, the City Council has initiated urgency legislation to address the hazards posed by shared mobil-ity devices placed in and operated on public property.

Section 2. This Ordinance was assessed in accordance with the authority and criteria contained in the California Environmental Quality Act (CEQA), the State CEQA Guidelines, and the environmental regulations of the City. The adoption and implementation of the Ordinance would prohibit shared mobility devices from being placed in the public right of-way or on public property, operated in the public right-of-way or on public property, or offered for use anywhere in the City. The Ordinance is exempt from the requirements of CEQA pursuant to CEQA Guidelines Section 15061(b)(3) because it can be seen with certainty that there is no possibility that prohibiting shared mobility devices from being placed in the public right-of-way or on public proper-ty, operated in the public right-of-way or on public property, or offered for use anywhere in the City will have a significant effect on the environment. The Ordinance is additionally exempt from CEQA pursuant to CEQA Guidelines Section 15301(c), as it involves no ex-pansion of the use of existing facilities, a category that includes streets and sidewalks.

Section 3. The City Council of the City of Beverly Hills hereby adds Chapter 6 (Shared Mobility Devices) to Title 7 (Traffic, Parking, and Public Transportation) to read as follows:

<b>"CHAPTER 6</b>	SHARED MOBILITY DEVICES
Section 7-6-1:	Purpose.
Section 7-6-2:	Definition.
Section 7-6-3:	General Requirements.
Section 7-6-4:	Violations.
Section 7-6-6:	Sunset Provision.

### Purpose.

7-6-1 The purpose of this chapter is to prohibit Shared Mobility Devices from being placed in the public right-of-way or on public property, operated in the public right-of-way or on pub-lic property, or offered for use anywhere in the City, so as to allow for adequate pedestrian traffic flow and to promote public safety.

#### Definition. 7-6-2

For purposes of this chapter, "Shared Mobility Device" means any wheeled device, other than an automobile or motorcycle, that is powered by a motor; is accessed via an on-demand portal, whether a smartphone application, membership card, or similar method; is operated by a private entity that owns, manages, and maintains devices for shared use by members of the public; and is available to members of the public in unstaffed, self-service locations, except for those loca-tions which are designated by the City.

#### General Requirements. 7-6-3

A. It is unlawful to park, leave standing, leave lying, abandon, or otherwise place a shared mobility device in a public right-of-way or on public property anywhere within the City.

B. It is unlawful to operate a shared mobility device in a public right-of-way or on public property anywhere within the City.

C. It is unlawful to provide or offer for use a shared mobility device anywhere within the City.

### Violations.

7-6-4

A. Violations of this chapter shall be punishable as provided for in Title 1, Chapter 3, Article 1 of this Code. B. Peace officers, Traffic Control Offi-

cers, Parking Enforcement Officers, those City officials designated by the City Manager, and any party contracted by the City to specifically impound shared mobility devices are authorized to impound any shared mobility device that has been offered for use, placed in a public right-of-way or on public property, or operated in a public right-of-way or on pub-lic property in violation of this chapter. The impound shall be subject to an impound and storage fee established by resolution of the City Council.

#### Sunset Provision. 7-6-5

This chapter shall remain in effect for six months from the date of its adoption, at which time it shall become ineffective unless the City Council acts to readopt the provisions herein.

Section 4. Severability. If any sec-tion, subsection, subdivision, sentence, clause, phrase, or portion of this Ordinance or the application thereof to any person or place, is for any reason held to be invalid or unconstitutional by the final decision of any court of competent jurisdiction, the remainder of this Ordinance shall be and remain in full force and effect.

The City Section 5. Publication. Clerk shall cause this Ordinance to be pub-lished at least once in a newspaper of general circulation published and circulated in the City within fifteen (15) days after its passage in accordance with Section 36933 of the Government Code, shall certify to the adoption of this Ordinance, and shall cause this Ordinance and this certification, together with proof of publication, to be entered in the Book of Ordinances of the Council of this City.

<u>Section 6.</u> <u>Effective Date.</u> Pursuant to Government Code § 36937, this Ordinance

shall go into full force and effect immediately upon its passage by a four-fifths majority of the City Council.
