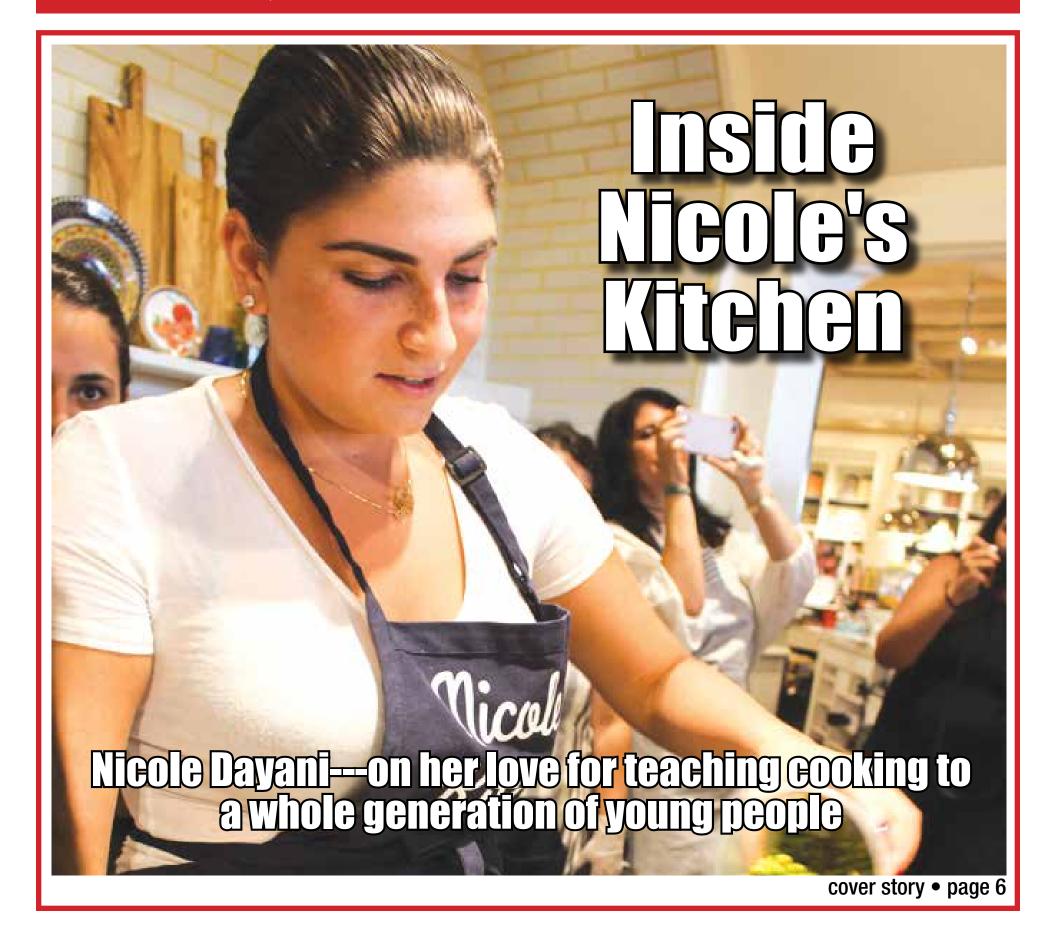

New Organics Waste Program for Multi-Family and Qualifying Business Customers Now through August 2019

As part of the City's new organics waste program, the City will be providing green waste containers for multifamily residential buildings to dispose of green waste. Qualifying commercial business customers will get a site visit and a green waste container for their organic waste. Businesses and multi-family properties of five units or more that generate 4 or more cubic yards of solid waste per week will be required to recycle its organic waste. Organic waste includes items like food scraps and landscape waste.

This is part of the City's ongoing efforts in working with residents and businesses toward achieving the State's sustainability goal and reducing greenhouse gas emissions.

Third Street Tour Bus Station & Restroom Facility Project

Now through April 2019 (weather permitting)

Construction on the public right-of-way along the south side of West Third Street is underway. The project will enhance the overall City visitor experience, as well as the aesthetics of this location. The improvements entail replacement of the existing parkway with a new sidewalk and new landscaping against the Edison yard wall. Features of the project will be comprised of seating alcoves, a bus shelter, and an information kiosk. Improvements will also include replacement of concrete curb and gutter and reconstruction of three curb ramps at the intersection of Foothill Rd. and Third Street.

A new restroom facility will be constructed on the northeast corner of Civic Center Dr. and Third Street within the Public Works warehouse yard area.

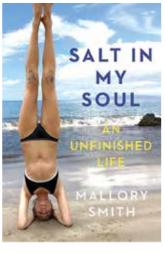

Salt in My Soul: An **Unfinished Life Tells Mallory Smith's Unforgettable Story**

Salt in My Soul: An Unfinished Life, the memoir of 2010 Beverly High graduate Mallory Smith, who passed away in November 2017, was published last week. The book chronicles Mallory's lifelong fight against Cystic Fibrosis and what it is



like living with chronillness, ic particularly as a young person.

" More specifically, she talks about what it's like to live with chronillness, ic to straddle the line be-

tween the sick and well worlds, and to look for—and ultimately find—love," her mother, Diane Shader Smith, said.

Mallory, 25 at the time of her death, was diagnosed with cystic fibrosis at three

years old, and kept detailed journals in which she wrote about battling her illness and coming into her own as a teenager and young adult. One of the journal entries that made it into the book comes from May 6, 2008 and shares a letter from Mallory to one of her teachers at Beverly High.

"Letter to my teacher," the excerpt begins. "You asked me to tell you why I haven't been in class. I was growing four types of infection in my lungs and the options were to be hospitalized for another round of IV antibiotics or to do extra treatments at home. I decided on the latter, which means adding one in the middle of the day (during your class). That's also why I wasn't in STAR testing. You said you didn't understand how I could choose to go to a swim meet instead of your class. My doctors drilled in me that health comes first, athletics second, school third. That might contradict your thinking, but swimming is extremely important in keeping me healthy and skipping it for a quiz is not an option. I hope you understand why what you said offended me because I care about doing well in your class, and missing school is not my choice but a necessary evil. I understand that you were annoyed about so many students wanting to make up tests on their own time, and I'm sorry to have to ask. I will see you tomorrow for the quiz."

The excerpt, both heart wrenching and almost unbelievably understanding given her own situation, hits at the heart of what Mallory hoped her journal would do, based on her own words-it allows readers a glimpse into a world they otherwise could not understand.

"I have a strong urge to do something... something that will change people, that will have an infectious influence on the way they think and feel that will last. I want to create a piece so moving that people are in disbelief," Mallory wrote. "And I want it to be like handing people a pair of glasses, giving them a way of seeing something they didn't even realize they weren't seeing.'

According to reports from The Hollywood Reporter, Salt in My Soul will not be the only medium through which Mallory's story is told—a documentary based on her life is being directed by the Emmy-winning and Oscar-nominated Kirby Dick and Amy Ziering, who directed both The Invisible War and The Hunting Ground.

Ziering reportedly told THR that the film would pair excerpts from Salt in My Soul with home videos of Mallory and interviews with family, friends and medical experts to create "an incredibly moving, haunting and uplifting portrait of a courageous and indomitable spirit who has much to teach us all about how to live more meaningful and present lives.

Filming, the report said, began February 20.

Beverly High Students Make History at State DECA Competition

A record-breaking 26 Beverly High stu-

dents placed in the top ten at the 2019 California State Career Development Conference in Anaheim at the end of February, scoring top marks for entrepreneurship and marketing skills against more than 1700 other students from across the state. Of those

students, 13 achieved scores that automatically qualified them for the International Career Development Conference (ICDC) in Orlando, Florida.

Approximately 1730 high school students from across the state competed in the four-day competition, which began February 28 and ended March 3. Beverly students, led by DECA Co-Presidents Mia Grossman and Sean Toobi, participated in role-plays that allowed the to showcase their skills and knowledge in subjects like community service, food marketing, buy-

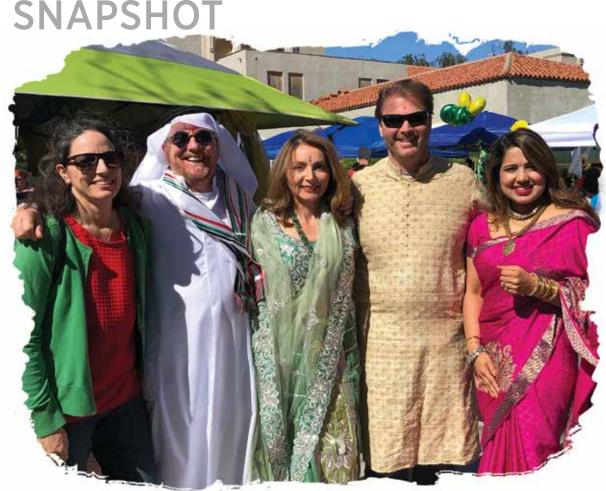

Potential Plans for La Cienega Park Include Pools, **Tennis Courts, Library**

Plans for renovating La Cienega park are well underway following months of discussion and several town hall meetings related to what should be included in a complete "recreation complex." Ideas have so far included a 30,000 square foot recreation center, indoor basketball courts, and a 25,000 square foot

community center.

Architect Jim Favaro presented a tentative master plan for the renovation to the Beverly Hills Recreation and Parks Commission on February 20. The plan, still in its early stages, offered up three options for the actual field configuration

of a renovated La Cienega Park. The first option would leave the fields in their current configuration, while the second would pull the two softball fields currently on-site farther apart from one another so that a regulation adult size soccer field could be placed between them. The third option would expand the footprint of the Fenton Field space to create a regulation softball field. It would also reorient one of the softball fields on the eastern side of the park, which allows for the intro-

> duction of an adult regulation size soccer field as well as two T-ball fields for Little League players.

Currently, Cienega Field #3 is the only regulation size baseball field in Beverly Hills and is used by the high school teams for practices and games, the Bever-

ly Hills Little League, and for the City's adult wood bat league. The outfield is also used for soccer games and sports camps. Director of Community Services Nancy Hunt-Coffey has previously stated that the Beverly Hills Unified School District has plans to install a regulation size baseball field at the high school in the future, though that work is unlikely to be completed for approximately ten years.

At the Recreation and Parks Commission meeting, Favaro addressed the possibility of the high school adding a baseball field to its campus and how plans to do so might affect the development of the park.

"That may come to pass and if that does it's a fairly simple thing to take out the baseball field altogether or transform it into a softball field or any number of uses," Favaro said.

According to Favaro, a potential recreation center could contain three indoor basketball courts, a 50-meter by 25-yard fitness pool, a 25-yard by 20-yard family recreation pool, and 16 tennis courts if approved. It would also provide 430 parking spaces. If approved by the City Council, the proposed 25,000 square foot community center would contain one large multi-purpose room, six classrooms, one art studio, a teen center, and a library.

Both the recreation center and community center could likely be housed at the park at the same time, though Favaro said the challenge is finding a way to fulfill the Council's request that all facilities at the park be consolidated into one multi-story building on the west side of La Cienega.

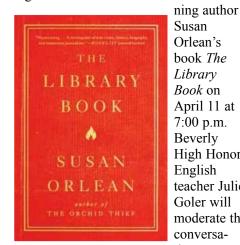
Favaro outlined several disadvantages to following this request on February 20, including a reduction of open space, the building being isolated from parking, and the loss of many of the stakeholders requested inclusions like the park or tennis center, though he said it was still a possible set-up to consider.

Susan Orlean's book The Library Book on April 11 at 7:00 p.m. Beverly **High Honors** English teacher Julie Goler will moderate the conversation.

In The Library Book, Orlean unravels the unsolved mystery of the most catastrophic library fire in American history and delivers a dazzling love letter to some of our most beloved institutions - librar-

The fire described in the book broke out on April 29, 1986 in the Los Angeles Public Library. Patrons and staff cleared out of the building quickly to avoid the flames, which grew quickly. As one fireman recounted later: "Once that first stack got going, it was goodbye, Charlie." The fire was disastrous. It reached 2,000 degrees and burned for more than seven hours. By the time it was extinguished, it had consumed 400,000 books and damaged 700,000 more. Investigators descended on the scene, but more than 30 years later, the mystery of how the fire began remains.

Weaving her lifelong love of books and reading with the fascinating history of libraries and the sometimes-eccentric characters that run them, Orlean presents a mesmerizing and uniquely compelling story as only she can. With her signature wit, insight, compassion, and talent for deep research, she investigates the legendary Los Angeles Public Library fire to showcase the larger, crucial role that libraries play in our lives.

In her search for answers, Orlean visits the different departments of the library, encountering an engaging cast of employees and patrons and experiencing alongside them the victories and struggles they face in today's climate. She also delves into the evolution of libraries across the country and around the world, from a metropolitan charitable initiative to a cornerstone of national identity. She reflects on her childhood experiences in libraries; studies fire and attempts to burn a copy of a book herself; and re-examines the case of Harry Peak, the blond-haired actor long suspected of setting fire to the library more than 30 years ago. Along the way, she reveals how these buildings provide much more than just books.

Fred Koch





Retired Beverly Hills Police Department Captain Fred Koch passed away in Rancho Mirage on February 27 at the age of 81.

Koch, a U.S. Air Force veteran, first joined the BHPD in 1962 and worked his way up through the ranks over time, starting as a patrolman in the Trousdale Estates area. He later became an automobile theft detective before being promoted to Sergeant in 1972. Koch was promoted again in 1976 to the rank of Lieutenant and formally became a Captain in 1980. He retired at the rank of captain in 1992

Koch earned both his BS and MS degrees at Pepperdine University, where he graduated Cum Laude, and was a graduate of the FBI National Academy 123rd Session in 1980. He was instrumental in the implementation of many innovative law enforcement ideas during the years he spent as the Support Services Bureau Commander and was recognized numerous times over his professional career for his outstanding police work and service to the community. Upon retirement, Koch was proclaimed a Beverly Hills Citizen of Honor by then-Mayor Vicki Reynolds.

Koch is survived by his wife Gina, daughter Gabrielle, and son Phillip. Funeral services were held at Forest Lawn Glendale on Friday, March 15 at 10:30 a.m.

INSIDE NICOLE'S KITCHEN

Nicole Dayani---on her love for teaching cooking to a whole generation of young people.

So how did you start teaching cooking?

I started cooking as a hobby, while I was studying at UCLA, and my friends pushed me to start posting my daily creations on the internet, and on Instagram. I started getting inquiries for catering and cooking classes. My specialty is something that's not really taught in the Los Angeles area, and it was something people really wanted and were really eager to learn family recipes that were passed down to me. My parents were not fond of me cooking as a career; they thought it was just a hobby. I had to turn a lot of people down who asked me to work with them and teach cooking, and I worked as a realtor at Sotheby's. So many people were sending me inquiries, asking me to teach, and I was saying no. Finally, someone asked if I could teach a cooking class for a charity for Children's Hospital -- in this case, my parents gave me the green light to teach the class. I was still working at Sotheby's as a real estate agent, but at the same time this class took place, my following started growing rapidly. People were gathering 20-30 people in their homes and asking me to teach classes for charity. I was teaching two to three cooking classes a week and doing cooking demos for charity. After one year, of not taking any income, I finally got the approval from my dad to start a corporation and begin teaching as a career.

So many young people don't really learn to cook at home anymore. Tell us about that.

I think that the demographic that I started to appeal to first were mostly families that were first generation American, and their families really wanted them to pursue a career that required an education. The families of most of these students didn't make learning to cook at home a priority. It was kind of like you either had to pick a career, or pick being a housewife, and I wanted to change that for my community. I wanted to show people that you can have a career, be educated, but also cook for friends and family and host them. I wanted to create a system where people can do everything. You don't have to make a choice between career and cooking.

How do you teach classes? Do you have a special kitchen you use?

I teach classes in the Beverly Hills area, at people's homes, predominantly. It's important to me that my students learn to cook in an environment they are already comfortable in. I also travel to teach classes all over Los Angeles. I get inquiries to teach in other states, but because I am so busy here in LA I don't really get the chance to travel and teach but the next goal is to offer online cooking classes that way people from all over the world can watch. I plan to do a monthly subscription system to teach cooking online through a portal for people to learn how to cook.

Give us examples of some of the dishes you teach, and how do you teach them?

My specialty is "Persian Fusion". The way that I teach, it's as if my students are sitting in a class, so they watch me do a demonstration. I do offer communal cooking experience classes, as well, where everyone helps each other prepare dinner. This is a much more hands on experience. I am predominantly an instructor and my students watch me basically perform, as though they are in a classroom. Think of it like a Food Network cooking show! Most of my demographic are students between the ages of 25 to 55 years old. Men and women!

So you grew up in Beverly Hills? Tell us about that.

I feel like I was raised in a very tightcommunity which has definitely helped my business going to Beverly Hills schools - everyone is really connected in this area. That is what has really helped me grow my following - the community that was behind me. I graduated from Beverly High in 2010. I took cooking as an elective in high school, and I loved it! I wrote that I wanted

to be a chef in my 5th grade yearbook at Hawthorne. Actually, I wrote that I want to be an "ashpaz" which is a "soup-maker", in Farsi.

How do people sign up for your classes? Is it largely word of mouth?

They can either sign up for public classes online, or private group classes by e-mailing me or messaging me through my website. Most people find out about my classes through word of mouth and Instagram. My business is

based primarily on lots of referrals! I have worked to teach cooking classes with companies like Neutrogena, Warner Brothers, Hyundai Motorsports, and more, all through word of mouth.

Explain what you love about cooking and food.

I love the conversation surrounding food, and the conversations that take place after teaching a class. It's enjoyable to see people meeting each other through the dialogue of food, talking about taste and flavor. I like the fact that cooking is a little bit messy, it really helps my students escape day to day stress and anxiety. A lot of people kind of "escape" the outside world when they

come to the kitchen. I love creating new recipes, and the challenge of using different ingredients that you would think initially wouldn't work well together. Also, I love serving people. I am honored to serve.

My biggest inspiration in cooking is my grandmother, Soraya Halimi, because my grandparents house is always open and welcome to everyone. I grew up watching her putting a lot of effort and love in her food and it made every-

one feel so safe and warm. Cooking for others was a seed she had planted in me without knowing. It wasn't intentional, but through her I learned how amazing it was to serve other people. I believe my purpose in life is to bring strangers together around the dinner table and to make people to feel more comfortable to open their home to others and that cooking is not such an overwhelming task.
