### "Beverly Hills Recycling"

The importance of recycling has rarely been questioned in California, and for many years the state has pursued a goal of diverting a large percentage of solid waste through recycling.

The phrase "reduce, reuse, recycle" has been widely used and trumpeted, including by the City of Beverly Hills.

Californians have been told that recycling helps to conserve landfill space for solid waste, to preserve the natural resources available to produce products, and to conserve energy.

Granted, there have been some recent news stories that have noted that China, the largest buyer of America's recyclables. has severely limited the stream of recyclable materials to that country. However, such reports have usually also pointed out that there continue to be other outlets, as well as myriad uses for such materials in the United States.

Turning now to recycling and the City of Beverly Hills. I am a frequent visitor to my brother's home [on San Ysidro] in Beverly Hills, and he and I have - with the best of intentions, placed recyclable materials (including glass bottles, magazines, newspapers, unwanted mail, corrugated cardboard, and the like) in the blue bins provided by the City for what we thought was the City's curbside recycling program.

When he recently inquired on a trash collection day about getting a replacement recycling bin for the deteriorating one that he and I have been using, the driver of the collection truck told my brother that the materials in the blue recyclable bins are -and have been for years - treated as mixed waste and sent to a facility where they might be later separated. The driver said there was no reason to use the blue bins. He ended by saying that we should dump recyclables with regular garbage in trash containers

My brother and I were surprised to hear this, and I followed through by sending a request to the City under the California Public Records Act. On March 26, 2019, I received an email response and it read: "The City does not have a recycling program, but instead utilizes a mixed waste collection system, whereby trash and recyclables are collected in one bin, and then separated later at a material recovery facility".

While my request also asked for records providing information on the companies that recycled such materials, and records evidencing that the materials picked up in the residential recycling bins are treated and processed as recycling and not like

trash that is dumped in a landfill, no such records were provided by the City.

The first question that all of this raises is just how much of Beverly Hills' waste is recycled, and how much of it gets dumped in landfills. It would seem that the City of Beverly Hills should answer the question about recyclable materials in terms of volume and landfill diversion rates. A corollary question is how much of the recyclable materials gets contaminated and soiled by the trash those materials accom-



### Middle School Sports Program Could Receive \$150,000 Budget

At their March 26 meeting the Board of Education discussed a budget proposal of \$150,000 for the Middle School Athletic Program.

This would encompass league entry fees (\$500), transportation (\$400), coaching stipends (\$2,000), equipment (\$2,000), uniforms (\$2,000), a trainer (\$25/hour) and training supplies (\$100)—totaling a cost estimate of \$50,000 per season.

Presented by Athletic Director Tim Ellis, the PowerPoint also highlighted the benefits, sports offerings, and mission of a middle school sports program as reconfiguration approaches.

"[The goal] is to offer all middle school students the opportunity to participate in a variety of competitive sports, which will provide an avenue to develop lifelong traits of teamwork, persistence, self-sacrifice and self-discipline," said Ellis. "There really are traits and things you learn on an athletic field that you never learn in a classroom."

Ellis went on to emphasize the goal of building a "comprehensive competitive" athletic program that will provide equal opportunities for all students.

Potential sports offerings could include cross-country, flag football, basketball, track and field, volleyball, cheerleading and soccer.

The presentation also touched on possible benefits of an athletic program like pany in the mixed waste system. Such contamination can ruin recyclables - so that they cannot be recycled, or can decrease the value of the materials. Moreover, the City should provide information on what materials are actually recycled.

The last, and maybe most important, question is whether - and how much of - the dutiful curbside recycling efforts of the residents of Beverly Hills are simply an illusion.

increasing the average GPA, reducing the use of tobacco, drugs and alcohol and creating a better awareness of overall health and eating habits.

Board President Noah Margo expressed concerns regarding the proposed 2.0 minimum GPA for participation, which Ellis said was the standard CIF eligibility guideline across the state.

"We should be above the standard," said Margo. "If we're going for a district of excellence, everything we approach should be [above] the standard."

Next steps include presenting the information at the April 25 middle school student orientation and May 2 open house.

The Board will determine an annual financial commitment by May 1.

### Traffic and Parking Commission OKs Pilot Southwest Traffic Calming Plan

On Tuesday the Traffic and Parking Commission discussed—and ultimately approved—an ongoing proposal for a pilot Southwest Traffic Calming Plan.

Presented by the Southwest Homeowners Association, the approved proposal will include several elements, the first of which being to create traffic circles with stop signs at the eight intersections on Charleville and the eight intersections on Gregory.

It will also include peak hour turn restrictions off of South Santa Monica onto Charleville and off of Moreno onto Durant, Robbins and Young from 4:00 to 7:00 p.m. during weekdays; peak hour rightturn restrictions from 7:00 a.m. to 10:00 a.m. on weekdays from Olympic onto the eight north-south streets; and lengthening the a.m. and p.m. peak "green time" on the Olympic/Beverly Drive signal to lessen the traffic frustration for commuters on Olympic and thereby lessen cut-through traffic. The pilot program will run for three

months with the intention of "testing the effectiveness of the overall plan" and "to determine the reaction of the residents."

Other potential options included turn restrictions, traffic circles, and "speed

lumps" (soft rollout); turn restrictions and traffic circles; and just turn restrictions.

The Southwest Homeowners Association, however, critiqued these options during their presentation—stating they would "not achieve virtually any of the intended goals of a trial plan."

Speed lumps on Spalding Drive, they argued, would "simply deflect traffic to Linden and McCarty and will not be any accurate measure on whether they would work on the eight single family residential streets."

The group also argued that testing only two traffic circles along Charleville, as proposed by staff, would not accurately measure whether a series of them at each of the eight intersections would or would not reduce traffic volume and speed.

Commission Vice Chair Jake Manaster expressed agreement with the critique of speed lumps.

"I have absolutely no confidence there will be any reduction in congestion without some kind of turn restriction," said

Manaster, adding that the crux of the pilot program stems from the fact that it's impossible to widen Olympic and Santa Monica Boulevard. "This isn't about protecting one neighborhood and letting everybody else fend for themselves; this is a pilot to see if some of these tools or instruments may help so that they can then be implemented elsewhere in the City."

First brought to the commission's con-

sideration on March 7, the proposed plan garnered significant community input, some of which included testing the effectiveness of the entire plan and thus including all traffic circles and turn restrictions, concern of traffic diversion from Spalding Drive, and concern that speed lumps will cause noise, congestion or pol-

lution. The commissioners unanimously voted

in favor of the Southwest Homeowners Association's proposal.

### City Council to Discuss Animal Grooming Ordinance

Although they ran out of time at Tuesday's Study Session, the City Council is set to discuss an animal grooming ordinance that would establish new regulations for animal grooming facilities in order to protect animals.

Some requirements would include requiring groomers to be certified from a nationally recognized organization and to remain within four feet of the animal during all grooming processes, equipping all tethering devices with a quick-release feature, and implementing video cameras in bathing and styling areas of grooming facilities.

Inspired by West Hollywood's similar amendments to their own animal grooming ordinance, the modifications stem from ongoing concerns about the dangers of groomer's nooses.

According to the staff report, this noose prevents an animal from sitting, laying down, or moving. There have been instances, however, where an animal either slips or jumps off an elevated grooming table or out of a bathtub, which in turn has led to injury and/or death.

The City Council Legislative/Lobby Committee, comprised of Mayor John Mirisch and Councilmember Lester Friedman, originally reviewed this item in December, 2018 where they recommended that staff bring it to Council.

"The City has a long history of supporting measures that promote the protection of animals and animal rights," reads the staff report. "An animal grooming ordinance would be in line with this past practice."

The item is set to appear at a City Council Study Session later this month.

### **Recreation and Parks Commission Reviews Town** Hall Meeting

At their March 26 meeting, the Recreation and Parks commission discussed a prior Town Hall meeting regarding the La Cienega Parks and Recreation Complex Master Plan project.

Held at the La Cienega Community Center Auditorium on February 27, the meeting served as an opportunity for community members and stakeholders to express questions and concerns about the upcoming park renovation.

Groups represented were Next Beverly Hills, the Academy of Motion Pictures, Beverly Hills Little League, the Bridge Club, and members of the general public.

After receiving a PowerPoint presentation from architect firm Johnson Favarro highlighting the top priorities discussed in earlier meetings and public engagement work, attendees split into four groups to discuss questions intended to "spark conversation and ensure that [the City] is where [it] should be at this point, said Recreation Services Manager Jennifer Lev.

The questions presented were as follows: 1) Are there any aspects or areas of what was presented that you feel do not reflect what the community has states? 2) Are there aspects or areas of what was presented that you feel have not been addressed? 3) What excites you most about what has been presented?



According to Lev, the public provided a generally positive response on the direction the park is currently headed in-especially regarding a potential land bridge that would

overlook La Cienega Boulevard.

Lev also, however, noted that some concerns were brought forth as well, particularly about parking, restroom use, and the park's proximity to the new Metro station. Additionally, the Academy of Motion Pictures representative said they would like to be "more involved" in the discussion, as the building sits adjacent to the park.

At the commission meeting, Commissioner Frances Bilak urged the creation of a "Friends of La Cienega Park" group to solicit private funding for the park, as renovation estimates are currently hovering between \$80 million and \$100 million.

"It would be wonderful to do everything [we want to do] because it is our last green space we can really have for the residents," said Bilak. "But I want to put that out there now so that once we get an idea of how much is going to be allocated, I have a feeling there's going to be more than what we may have funding for."

Community Services Director Pam Shinault said that six to eight months ago, staff spoke with "Friends of Beverly Gardens Park," who preliminarily expressed interest in such an idea, but that the idea has not been further discussed.

Shinault also said that now is a bit early to create a "Friends of" group, but that the idea is "certainly an option" as they get closer to needing funding.

"Hopefully within the next few months we'll get in front of the Council and some tough decisions will be made [regarding] where we're going with the park," said Shinault.

### Registered Dietitian Nutritionist Robyn Goldberg

### You grew up in Beverly Hills. How did you get into nutrition?

I got into it initially based on my family history of heart disease. My father was alive at the time and I grew up hearing about high cholesterol and heart attacks. And then I was a college tennis player and thought, "Well, perhaps if my fuel is sufficient, maybe my performance will enhance." Finally I had three roommates in college all with bulimia nervosa, and now that's probably what 60 to 80 percent of my practice. I merge the medical with body image because even if someone's coming to me for a medical issue, oftentimes they have disordered eating and/or thinking.

### What's it like running a private nutrition practice in Beverly Hills?

I think any large city is definitely a great place to have a practice. But in LA/Beverly Hills/Hollywood, where entertainment is the focus to many, there's so much emphasis on what you eat, how you look, how much you move your body, that I feel like we are in the mecca of the land of eating disorders. The other part is that eating orders don't discriminate against gender, age, and body size. You could be anywhere; you could walk outside your office door and anyone you come into contact with could have an eating disorder or disordered thinking. It's that prevalent.

### Society also places a forceful emphasis on diet culture that's hard to ignore.

Diet culture is very problematic. Anyone can put any kind of statement on social media and television. Unfortunately California doesn't have the Licensure Act, so anyone can say they are a "nutritionist." I always like to say that all Registered Dietitian Nutritionists are nutritionists but not all nutritionists are Registered Dietitian Nutritionists (RDN's). Even more important is to be able to find someone that is a Certified Eating Disorder Registered Dietitian (CEDRD) through IAEDP (the International Association of Eating Disorders Professionals). So even if someone doesn't have an eating disorder but is a victim of diet culture, having someone who is a CEDRD can help you connect your feelings centered on food and observe that even if the diet failed, you didn't fail.

Nutrition research is advancing rapidly, especially over recent years. For instance, fat used to be considered a major threat to one's health, but is now hailed as a nutrition staple. What are some of the biggest changes you've noticed about the field over the years?

I'm a certified intuitive eating counselor, so I really help people to get back to a place of being able to figure out how to nurture their body rather than being in the biology of starvation and excluding food, so I help people get back to a place of learning how to eat when they're hungry and stop when they're satisfied. Sometimes we eat because we're bored or stressed or the food is in front of us and it tastes good, but when a person is an intuitive eater, they're able to make food choices without having feelings of guilt or shame or an ethical dilemma. They're able to honor when they feel satisfied and also experience the pleasure of eating. They don't have guilt around eating. So in the field, there are more and more RDN's who are being weight inclusive nutrition therapists. They practice from the lens of being a "health at every size" clinician. That, I would say, is very different.

When I started out, I was always an intuitive eating RDN because I knew putting people on diets is not going to help them succeed in life. I always peripherally implemented a "health at every size" practice, but now it's a movement, and it's really being viewed as a social justice movement that really creates this inclusive and respectful community where I think people of all body shapes and sizes can learn how to find compassion and take care of themselves. So I think it's important to recognize that there's body diversity-we all wear a different shoe size, we have different hair colors, we look different. But also, working on how we can implement self-care-that, I would say has become rather popular. Self-care can be in any profession; maybe it's recognizing you need to take a nap or to be able to actually sit down and eat a snack rather than multi-task while

eating it. It's really important to be able to understand pace.

# Regarding fats and carbs, what's the truth? How should we approach each when it comes to our diets?

We need some carbs, some protein and some fats. Everybody's body is different in regards to what is fulfilling for them. Some people have more energy when they're having more fat in their diet or more carbs. It's so individualized based on their activities or stress; it's not a onesize-fits-all approach.

You can overeat any food or food

group. You can overconsume avocados just like you can overconsume lard. I think people stagnant; remain they're afraid of new information. I like to explore where the resistance comes from and where they pick up this information from because there are so many misconceptions and unfortunately many healthcare providers are outdated and not aware. You can't be an expert on everything. It's also about understanding the reasons why you need fats-if vou don't have fats you'll shrivel up like a dried prune. Fats

provide cushion and satiety, so eating fat does not make you fat. When we're getting more than our body needs, that's when our bodies can change.

### How do you feel about calorie counting?

I'm very much against it. We are not meant to be human calculators. That can definitely result in obsessive thinking; it can take away pleasure and learning how to be present and mindful and conscious when we eat. Also, when someone starts calorie counting that oftentimes stems from them looking at what area of their life they can control. I have many different types people I see that fall into all these pitfalls.

Of your practice, you've said that you approach nutrition from a "behavioral standpoint" through "reprogramming people's natural intuitive eating cues." Tell us about the emphasis you place on intuitive eating.

I think an individual has to be ready to leave the dieting world and recognize that there's got to be a different way to approach food than they have. It's thinking, "Wow, wouldn't it be nice to choose your food with pleasure and eat and never have to count or weigh or measure, to be able to eat without confusion and guilt?" It's about looking at what each individual's goals are when they work with me, and I always make it clear that if they're looking for a quick fix, I'm not the right person.

### You founded Race to Erase MS. Tell er to work as a team to never duplicate us about that.

About 27 years ago I was diagnosed with Multiple Sclerosis (MS) and at the time there was no known cause, no cure, no drugs on the market. I was very lucky I could go get second opinions, and I went to many doctors basically hoping someone would tell me I didn't have MS. I was a young mom, with three

kids, and it didn't fit into my job description for the rest of my life to just go home and go to bed -- which is basically what I was told. I was told I couldn't do anything except operate basically the remote control

for the rest of my life. And it was rather upsetting/depressing, and I was so young and full of life and wanted to accomplish so many things in my life and I was told everything was off the table at that point.

So, in going to many of the best doctors around the country, they all unfortunately did say I had MS. But when I listened to the research they were doing all over the country, they were all doing identical research as each other but were very convinced they were the only ones doing the research. So, kind of a light bulb went off in my head, and I thought gosh I have this very unpopular disease with very little hope so if we could at least put the best and the brightest togeth-

research, to constantly communicate, we will find a cure much quicker. So essentially I put something together called "The Center Without Walls"- and we've never spent a penny on mortar and bricks - we do events every year and the money that we raise goes to funding really important basic science research studies that would probably never would have

gotten funded ever. these things exist

today that really did not exist and from doing our event Race to Erase MS so much has really changed so that young person being diagnosed today with MS, instead of being told go home and go to bed like I was told, there's so many options - there's so many different things you can do - there's different drugs, different therapies, and the true hope is that we will actually find a cure.

### Who can be affected by MS?

At least three times as many women as men get affected by Multiple Sclerosis. It's usually in the prime of your life, in between the age of 20 and 40, when you're just sort of starting out your life

### How long have you called Beverly Hills home?


