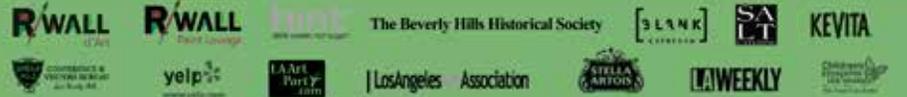

Hunt Named Beverly High Assistant Principal

The Board of Education approved Tuesday the appointment of Jill Hunt as one of three Assistant Principals at Beverly High.

Hunt brings 18 years of first-hand practice in Secondary Education with a background in special education and leadership. She joins the district from the Centinela Valley Unified School District, where she worked as a Special Education Coordinator.

Hunt holds a Doctorate in Education from the University of California Los Angeles, a Masters of Education in Leadership and Administration from California State University Northridge, a Masters of Education in Secondary Education from the University of California Los Angeles, and a Bachelor of Arts in English Literature, Minor in Spanish from the University of Redlands.

Hunt will assume the position in July.

Public Works Commission Discusses Water Treatment Update

Last Thursday the Public Works Commission discussed an update regarding the Foothill Water Treatment Plant and the La Brea Subarea.

Initially approved on April 16, the design of a pre-treatment system for the Foothill Water Treatment Plant (FWTP) replaced the previous Phase I Progressive Design-Build-Operate-Finance (DBOF) agreement.

City staff, Carollo Engineers staff and owner representative NV5 held the first workshop on May 1 to set parameters for the design and operational needs followed by a trial run of the FWTP from May 7 to May 9.

According to staff, the objective of the trial run is to characterize the current water quality conditions from the four Hollywood Wells and two Maple Wells in order to "effectively design and scale the pre-treatment stage of the plant."

The next step to assess the overall per-

formance and condition of existing wells and water treatment equipment after more than two years of dormancy. Staff and NV5 will also work with NV5 to expedite the design schedule by pre-purchasing certain equipment.

Advantages of pre-purchasing include an "expedited design with early design collaboration between the vendor and the City's consultant and reduced equipment purchase costs," according to the staff report.

Regarding the La Brea subarea update, staff is currently focused on developing the Coffee Bean and Tea Leaf production well and corresponding conveyance pipeline to ensure maximum supply capacity for the Water Treatment Plant once it becomes available online.

Staff is also working with a realtor to identify other additional properties in the desired hydrogeological zone for future La Brea Wells. To date, several commercial/industrial sites from approximately .25 to .5 acres have been identified.

Milles Could Join City's Art Collection

At their meeting last month the Fine Art Commission heard a presentation about Swedish artist Carl Milles, in hopes of possibly adding the artist's work to the City's collection. Delivered by Millesgarden Museum Director Onita Wass, the presentation emphasized Milles' ability to tell a story, which she said Beverly Hills also does well.

Wass presented a slideshow of Milles' sculpture work as well as an in-depth biography of the artist's life.

Board Talks Traffic Issues at Beverly Vista

At their May 7 meeting the Board of Education discussed the possibility of staggering the BHUSD start and drop-off times.

Although a concrete decision has yet to be made, Board members generally agreed that data and studies show that older kids, particularly of the middle and high school age, are more receptive to later start times because their circadian rhythms change.

"It doesn't matter [whether] they go to bed earlier or later—that's not what it's based on," said Board member Tristen Walker.

Walker pointed out that there is less traffic going from the east to the west so it would be ideal to start K-5 earlier, "because we know that the kids at that age group get up the earliest and are more receptive to learning earlier."

"At a time like this when we have the option to be progressive in our decision-making and to plan for the benefit of our students, I think we ought to take this time now and do that," said Walker.

Board president Noah Margo agreed.

"The older they get, the more they want to sleep in," said Margo. "When my child was young, K-5, they liked going to school. They looked forward to it. [I have to] drag my teenager out of bed. So why are we fighting that? We talk about doing

BHUSD to Issue Measure BH Bonds Soon

Following the passage of a general obligation bond last June, the District is planning to issue its first series of bonds within the next few months.

The \$385 million Measure BH, passed on the June 5, 2018 ballot, bond permits the sale of bonds to finance capital projects.

The Board will discuss potentially advancing its own funds “on the knowledge that it could be reimbursed for amounts expended on such improvements from the subsequent sale of any Bonds,” according to the May 14 Board agenda.

In order to qualify for the reimbursement of such costs from the proceeds of

AN ORDINANCE OF THE CITY OF BEVERLY HILLS AMENDING THE BEVERLY HILLS MUNICIPAL CODE TO CLARIFY THAT ACCESSORY STRUCTURES ON ESTATE LOTS IN THE TROUSDALE ESTATES AREA OF THE CITY MAY NOT BE CONSTRUCTED OFF THE EXISTING LEVEL PAD.

Currently, the Beverly Hills Municipal Code (BHMC § 10-3-2621) states that an applicant may request a Trousdale R-1 Permit from the Planning Commission to place an accessory structure anywhere on a site, if the site is an estate lot (24,000 square feet or larger) in Trousdale Estates. At a study session held on December 13, 2018, the Planning Commission provided staff direction to draft an ordinance clarifying that an applicant may request a Trousdale R-1 Permit to locate an accessory structure anywhere on the existing level pad, not anywhere on the site. The Planning Commission considered the draft Ordinance and adopted a resolution recommending the ordinance to the City Council on February 28, 2019. The proposed Ordinance would include modifications to the existing code language to make this clarification.

The Ordinance has been assessed in accordance with the authority and criteria contained in the California Environmental Quality Act (CEQA), the State CEQA Guidelines, and the environmental regulations of the City. The adoption and implementation of the Ordinance represents minor language changes to the existing code to clarify a code section. There is no possibility that adoption and implementation of the Ordinance may have a significant effect on the environment because the Ordinance does not authorize construction and it would impose greater restrictions on certain development in order to protect the public health, safety and general welfare. Accordingly, the City Council will consider the staff recommendation to find the Ordinance exempt from the environmental review requirements of CEQA pursuant to Section 15061(b)(3) and Section 15308 of Title 14 of the California Code of Regulations.

Angela Maddahi on being recognized at the Sinai Temple "Stronger Together" Gala

Angela, you are being recognized at Sinai Temple's "Stronger Together" Gala on June 16th. Tell us about that.

The purpose of the Gala is to raise funds for the synagogue. Every other year, the outgoing president of the synagogue is honored for their two-year service to the Congregation. And, as I have been the President since July 1, 2017 and my administration ends on June 30th of this year, I'm being honored.

Who else will be honored?

We are honoring two other young couples. One couple is Cici and Dr. David Hallegua, they are alumni parents of the school. Cici has been a very strong and involved parent at the school. She was head of the school budget committee and has been sitting on the school board. And Beatrice & Sean Dayani, they are very active parents in the religious school. So, we are representing the entire community, including both school communities -- and that's why the theme of the Gala is "Stronger Together" because as a community, we have many different sub-communities, which allow us to make connections as individuals but altogether as one synagogue we are much stronger.

How can one attend the Gala?

We still have a lot of room since it's a month away.

How long have you served on the board at Sinai Temple?

I started on the board in 1997. And I have been serving on and off ever since.

There is a 6 year maximum that you can serve on the board. I served from 1997 to 2002 and then I came back on the board in 2006. And I have served in the capacity of Treasurer, Vice President of Administration, I served in two administrations as Vice President of Education overlook-

ing the school (Sinai-Akiba Academy).

You're currently an undergraduate at UCLA. Tell us about that.

I got married very young in life, at the age of 21. I came to the United States to travel and I happened to meet my husband, I was in the middle of college then. Met my husband and I stayed. You know, I was born and raised in Germany, and for spring break my mother decided we should come to LA to visit our relatives who had come to the United States after the revolution in Iran. So, we came, and I met my husband the first week I came, and so my stay got extended and I got married and it was not possible for me to continue my studies but I had a dream of always getting my bachelor's degree and I always wanted to get it at UCLA. So in 2016, I started taking classes at Santa Monica College and then I applied to UCLA and I got elected to be President and also admitted to UCLA within 5 days. So, I asked UCLA for a two-year extension and they gave me one. So the first year of my administration I was given off school but this current year I was a full time student at UCLA and president of the synagogue concurrently. My major is Comparative Literature and my Minor is Hebrew and Jewish Studies, and I'm just finishing my Junior Year. G-d willing, next year, I will turn 60 and graduate

within a few months. So, it's the typical grandma-going-back-to-school scenario.

You are well known throughout Beverly Hills for your involvement in philanthropic and volunteer work. Tell us more about the community work that you do.

I'm a member of Hadassah. When I was very young, I was one of the founders of the Persian Friends of the City of Hope, under Mrs. Hekmat. I support JQ, which is the LGBTQ section of the Jewish Federation. I've also been very active in AIPAC and leading our Congregation

How has living in Beverly Hills made an impact on your philanthropic values?

Living in Beverly Hills has given me a sense of belonging and a sense of community. And I think that sense of community is what I've brought into the synagogue. I think as we grow our families and we grow older, we realize that we don't live in a vacuum -- that we live with other people and we have to respect and understand o t h e r

people. And I think that Beverly Hills, having such a diverse group of residents, is really a wonderful example of how we can all work together. And I brought that idea into the synagogue, because we are also a very diverse group. I cherish that and it's important to me.

Tell us about your family.

I have three children, a daughter in law, a son in law, and two grandchildren. My children are 35 (Ben) is married to Roxana. Amanda is 32, and Amanda is 30 and she's married to Asi. Ben went to USC and my daughters went to UCLA. My husband (Jamshid) is a cardiologist at UCLA, we were married in 1981. I love my family, I cherish them, I'm grateful to have an extended family on both sides and we're very involved and active and close.

What do you consider your greatest accomplishment?

My family -- raising a family that is involved, aware, lives by Jewish values and gives back to the community and is kind to others. That's my greatest accomplishment.

What are some of the issues surrounding Beverly Hills that you're most passionate about right now?

I was very passionate about one thing in Beverly Hills -- and that was the traffic on Sunset Blvd -- and thanks to the leadership of [Beverly Hills City Councilmember] Lili Bosse, we really got that solved. I live at an intersection on Sunset where there were accidents almost weekly, and people had died. And under the leadership of Lili Bosse there was an investigation about that and a study was

The mission of my soul, if I can say that, is the continuity of Judaism. And having had the opportunity to be in a leadership position at one of the largest conservative synagogues in the United States -- and as a woman -- has been a true privilege and an honor. And I think that the tone that I set was one of a strong Jewish community, and so receiving recognition for that, although you don't do it for that, is very meaningful. And I look forward to celebrating with all my friends and just being with people I love. I really look forward to that.

Anyone who goes to court against banks, insurance companies and government feels the brunt of injustice. Twelve years ago Daniel Borsotti entered the legal system believing justice would dominate. Instead, he found the courts saturated with corruption. Backed by armed marshals, judges wield their power without accountability. Borsotti found a fearsome remedy in the law: the "court of record". The court of record shifts the balance of power in favor of the people, so much so that judges blatantly break the law to suppress it. In one case, the judges ordered Borsotti to enter the court building to attend scheduled hearings. In another case a marshal struck him because he attempted to file a paper. And, without cause, he

was denied counsel of choice, witnesses, and discovery process. All because Borsotti regularly claims real rights guaranteed by the Constitution (not privileges). Complaints to higher authorities go unanswered. "That's just the tip of the iceberg."
