Athens Workers March on City Hall in Demand for Better Benefits

Union leaders joined Athens Environmental employees in a march through Beverly Hills to show support for the sanitation workers' requests of "benefits and protections" on August 22.

The march was organized by the Los Angeles Alliance for a New Economy's (LAANE) campaign "Don't Waste LA." The campaign is organized by a coalition

"Sanitation is an important job, and a dangerous one. The brave men and women who pick up the city's trash work in the fifth most dangerous industry in the nation, more than firefighting, mining, and construction," LAANE Communications Manager Cassidy Higley said. "These work- Athens Sanitation Workers Protest on City Hall ers just want to be heard, and

right now, they don't feel like they have a voice.'

The workers are fighting for better benefits and protections, according to Athens employee Julio Ticas.

"We wake up at 2 am every morning to keep the City of Beverly Hills pristine," said Ticas. "We take pride in our work and appreciate being a part of what makes Beverly Hills so magical. All we want is to have the same kind of benefits that other workers in the industry enjoy, which is full family medical, and more protections on the job."



Higley said that, although wages have increased for Athens workers, it "pales in comparison to the price increase of healthcare."

Athens Environmental Services is a subsidiary of Athens Services, a large regional waste hauler servicing major cities throughout Los Angeles County and Beverly Hills.

Last week's cover story detailed Athens' investment of \$50 million into a new recycling facility.

"This is a dispute between Athens and its workers," City Public Information Manager Keith Sterling said. "We hope they will come to an agreement in the near future."

Athens Vice President Greg Lammers did not return a call for comment.

•Tier 2 – Other households being displaced from the project site due to the development of the new project;

•Tier 3 - Senior households that have been recently displaced or will be displaced from a multi-family property in the City due to redevelopment;

•Tier 4 - Other households that have been recently displaced or will be displaced from a multi-family property in the City due to redevelopment;

•Tier 5 – Senior households;

•Tier 6 – All other income qualified households.

The Ordinance has been assessed in accordance with the authority and criteria contained in the California Environmental Quality Act (CEQA), the State CEQA Guidelines, and the environmental regulations of the City. The adoption and implementation of the Ordinance appears to be eligible for a class 5 categorical exemption for minor changes in land use limitations and the Ordinance could be found to not have a significant environmental impact. Further, it can be seen with certainty that there is no possibility that the adoption and implementation of the Ordinance could have a significant effect on the environment. In 1984 the City Council adopted an ordinance to establish regulations for hotel development in the Beverly Hills Municipal Code (BHMC). This ordinance included a provision capping the number of hotel rooms that could be approved in the City after November 1, 1984 at 1,000 rooms (BHMC Section 10-3-2869). On May 14, 2019, the City Council held a study session to discuss the hotel room cap and ultimately directed staff to work with the Planning Commission to amend the municipal code to remove this limitation on the number of hotel rooms that may be approved by the City. On July 25, 2019, the Planning Commission adopted a resolution recommending the Ordinance that would remove the hotel room cap to the City Council.

The Ordinance has been assessed in accordance with the authority and criteria contained in the California Environmental Quality Act (CEQA), the State CEQA Guidelines, and the environmental regulations of the City. The amendments will not have a significant environmental impact and are exempt from CEQA pursuant to Section 15305 of Title 14 of the California Code of Regulations because they represent minor alterations in land use limitations and do not result in any changes in land use or density. Further, it can be seen with certainty that there is no possibility that the amendments may have a significant effect on the environment. Accordingly, the City Council will consider the recommendation to find the Ordinance exempt from the environmental review requirements of CEQA pursuant to Section 15061(b)(3) and Section 15305 of Title 14 of the California Code of Regulations.

The landscaping has been schematically designed to provide a lush and modern California courtyard that provides a calm natural respite to the Chanel clientele. The species are to be native California plants that provide drought tolerance, reduce irrigation requirements, and help beautify the Current Storefront project site, according to the applicant's report.

> "We very much thought about the pedestrian experience when we worked on this project," Head Architect Stan Jones said.

All commissioners voted in favor of the façade changes except Vice Chair Sheri Hirschfeld.

Chanel will move to Proposed Storefront a temporary location on

Wilshire Boulevard while the store on Rodeo Drive undergoes construction.

ARTISTIC DIRECTION Commission Chair Stephanie Vahn on the Transition from Fine Art to Arts & Culture

What inspired you to apply for the Arts & Culture Commission?

I was a member of the Fine Art Commission, and my entire background is in art. I majored in Art History in college at the University of Wisconsin and I've been involved with MOCA, and LACMA. I was also a docent for many years. I have such a passion for art and I thought that we had started such a beautiful collection in the city of Beverly Hills, it would be really nice [for me] to get involved since I was born and raised here. I knew it would be the commission that I could contribute the most to.

What public art piece are you most proud of having obtained for the City?

That's an interesting question. I like our entire collection, the [Plenza] with the multi-languages man is probably a personal favorite. We're working to restore the [Chrisama], which is probably our most important artist. And we are hoping to purchase an Ai Wei Wei, who is probably the most famous contemporary artist in the world right now.

So it's fabulous to bring these monumental artists into our City and our collection. It's really a privilege to have them.

Are there any updates on the Ai Wei Wei piece that the commission has been working so hard on acquiring?

We're working on the contract; as always, and as a [Commissioner], like the public, we'd like to see things done quickly, but there is a process that involves getting the Council's approval, because we serve at the discretion of the Council. Then there's the contract that involves the purchase, so we're in the middle of the process right now.

And like you said, he is a very well known artist, almost like a celebrity?

I think he is a celebrity, but he is also an extremely important artist. He might be a little controversial, but that's what art is all about. It speaks to the artist's mind. It's not only beautiful to look at, but it has a meaning.

That leads into sort of what I hope to accomplish this year with a docent program. Our commission is working on a brochure to identify the pieces and let you know where they are; I'm hoping to implement a docent program where this program would have educated docents [informing] the public and visitors at a designated time once or twice a month, so that they can learn a little more about the different artists in our collection.

Because, I think the more you know about a piece of art, the better it is. I think art is emotional, and it's personal, and everyone reacts to it in a different way. Art is for that. I'm hoping to have a docent program installed by the end of this year.

Would you say that is one of your top priorities as Chair?

That's a personal priority, the bigger priority is that we've turned from the Fine Arts Commission to the Arts & Culture Commission, which is exceptionally exciting. You still have the duties of the Fine Art Commission to buy, purchase, and maintain that art, and grow the collection of fine art based on that criteria.

But the Arts and Culture Commission is going to be just so much more inclusive of the arts and culture of the City. We're hoping to put on events that involve partnerships with different stakeholders, and just have a lot more for the residents to do. Right now we're in the process of establishing a website to do that.

Do you have any opinion on the Ringo Starr "Peace and Love" sculpture?

This is why the Arts & Culture Commission is terrific. Because, originally the Ringo Starr piece did not meet the criteria for [the Fine Arts Commission].

Now that we are covering public art, we're going to have an ability to consider art such as [that], which is fabulous. It's going to be so much fun for the City. Right now, we're discussing placement, and I think that's really important for this piece in particular because it's going to draw a lot of attention and people are going to be excited to interact with it.

In our interview with former Commission Chair Michael Smooke in Issue #930, we asked him what goes into the decision-making process of what pieces you bring to the City, and he

responded "What's really important is your reaction and interaction with the work. Is there communication that will last?" What goes into your decision-making as you review pieces for the City?

I think you have an emotional reaction with all pieces of art, there isn't anything you're supposed to like, or not supposed to like. You can be educated in artistry, which is very important ... there's a reason why certain artists achieve great fame, it's a continuum of art history and who's the first to change something or who has done something differently.

But I think that, personally, I react emotionally. I look at something, and I'm drawn to it; I want to know more about it, I want to see it again, I want to see it often. That is how I collect art, and in terms of public art, I do think you consider what you already have and what might add to the collection. We should have diversity. We need to consider the materials and the elements.

Can you tell me a little about your family, are they as interested in art as you are?

I have a very small family, I've been married 34 years to my husband Leon. He is in real estate, and we've lived in Beverly Hills always. We have one son, Jason, who is 30 and is just finishing business school and is starting his adventure in life. So we have a lovely, small family, they mean the world to me.

And who are some of your personal favorite artists?

Oh my goodness, that's really hard! As a docent at LACMA, I was [exposed to] Egyptian art, French art, the Dutch masters, Greek classical art, so it's very hard to say.

I am personally drawn to Ai Wei Wei, I find him very fascinating in what he believes in and how he chooses to express that through art. I'm drawn to why the art is important to [the artist] and why they have to do it; that is very compelling to me, the process of it.

"By using high-quality materials, minimalistic details, and elegant scale, the facade we are proposing will provide a sleek and refined entry to this newly redesigned space," Guess Representative Ryan Reiter said in a report presented to the commission.

The existing storefront system and building elements that protect the current space from external and internal noise will remain. Any area that is damaged during construction will be repaired to like new condition.

All commissioners voted in favor of the proposed façade removal on conditions. The commissioners asked the applicant to consider a more silver matte finish and additional illumination.

BHPD releases DUI Checkpoint Results

The BĤPD conducted a DUI and Driver's License checkpoint on Sunset Boulevard between Sierra and Alta Drive on August 16.

The checkpoint was in place between the hours of 9 p.m. and 2 a.m. During that time, 1,451 cars passed through the checkpoint, 409 vehicles were screened, and one DUI investigation was conducted resulting in no DUI arrests. In addition, 15 drivers were screened for failing to have a valid driver's license in there possession, of which three were cited or arrested for operating a vehicle unlicensed or with a suspended or revoked license. Motor officers wrote 15 citations for various vehicle code violations in the area of the checkpoint.

Working in the Messerchmitt airplane factory and in the mines, he and 300 other prisoners were put on a Death March. [He] ran for his life, and was saved by American soldiers three weeks before the war ended in Europe"
