"Response to Potential Health Hazards of 5G Wireless Networks" [Issue 1044]

I feel compelled to respond to Dafna Tachover's alarmist and completely unsubstantiated claims concerning the safety of 5G wireless technology [letter, issue 1044]. Ms. Tachover is the founder of "We are the Evidence," an advocacy group whose chief goal appears to be litigating over wireless technology. Her letter is full of nonsensical or plain wrong claims, such as 5G antennas will increase radiation levels by thousands of times (not true), that "adverse changes in human, animal, and plant health have been occurring" (overall health continues to improve around the world), or that "non-thermal harm is scientifically proven". Ms. Tachover refers to a 2018 National Toxicology Program report as evidence for the latter and claims that the report finds clear evidence that radiation causes cancer and breaks DNA. The report makes no such claims. In fact, the authors of the study have said that the findings do not apply to humans, and the study has been criticized

illnesses that were examined and for its lack of statistical significance.

Finally, the consensus of the scientific community is that the scientific evidence does not support any link between exposure to regulated radiofrequencies and adverse health effects.

Rather than wasting time on conspiratorial and dubious claims about the safety of wireless technology, perhaps we should be thinking about the benefits that increased connectivity will bring to things like business, emergency response, remote medicine, smart cities, and the robotic vehicles of the future.

"Judge Overturns Jury Verdict in Favor of City"

This past week Mayor John Mirisch and City Attorney Larry Wiener took a victory lap when a judge reversed a jury on one of the four judgments in the summer trial against Chief Sandra Spagnoli, which means that the latest jury verdict cost the City of Beverly Hills \$760,000, not counting attorney fees, rather than the original \$1.1 million (see column 4).

Mirisch and Wiener were so delighted with this small reversal that they posted it on the city web site as an important win. Perhaps because it is the only win in the series of cases against Spagnoli.

Since Spagnoli became chief of our police department, more than ten key leadership positions have been vacated, and most of the remaining leadership is job hunting.

The Department is authorized for three Captain positions. Currently only one full time, experienced captain is on staff.

There are currently four unfilled lieutenant positions, and of those on staff, only two have more than three years of senior management experience. Most have fewer than two years. This represents a serious lack of experienced managerial oversight and leadership in the department.

Further, the majority of sergeants have fewer than three years of supervisory experience, which is cause for serious concern in any law enforcement agency. Lack of proper supervision has been cited in virtually all well-known cases of police misconduct across America.

Spagnoli's limited leadership skills may lead to lawsuits even more damaging and expensive than the plethora of police lawsuits the city already faces.

These are all red flags, and City Council is ignoring them. Did you know that most of the police who have left, did not bother to give two weeks notice? In fact, most didn't give one week's notice. At least four gave just 24 hours notice and walked out. The new trend is to message everyone in the police department, except Spagnoli. These police officers are sending a clear message that Spagnoli is the cause of their departure.

least two police employees have suffered strokes that have forced them to go on leave. Many others have made complaints to the human resources department, and have sought medical treatment for anxiety and depression.

Until Spagnoli arrived, our police were college graduates with backgrounds in sociology, criminology and psychology. She changed all that. College degrees are no longer required, which is characteristic of her approach to training, or lack of it. While a couple of city council members have begun looking into the myriad problems within the Spagnoli department, the council as a whole has yet to remedy this huge problem.

We now have an incompetent police chief and a council with no ability, nor experience to tackle all these major issues.

BHUSD Board Continues Discussion on Academic Calendar Amendments

On September 24, the BHUSD Board of Education discussed the 2020-2021 academic calendar.

Board member Tristen Walker-Shuman opened the discussion by stating that the path the board has taken leading up to last week's meeting has been "non-traditional."

"I think we recognize that [in the] future it will be something we will have to work on," Walker-Shuman said.

"There are certain things that will happen if we vote this down versus voting it up," Walker-Shuman said. "If this is not approved tonight, it's entirely likely that all of the K-8 students will not have school [on October 16], because tomorrow is supposed to be a professional development day."

The day allotted for professional development was present in the last calendar, but the change was not reflected in the tentative agreement presented to the board.

Walker-Shuman pointed out that the PSAT was to take place during professional development, and there would "not be enough staff to run that with [BHUSD] teachers," and that administrative staff would have to be brought in to administer and proctor the PSAT.

Walker-Shuman added that the PSAT is a qualifier for merit scholarship and that "it is important our kids have the most stable environment possible to take this type of a test."

Discussion at a previous board meeting led to an agreement amongst the board that a decision regarding amendments to the calendar was to be made at a later date.

"[September 24] was the first time [the board] really had an open and robust

conversation about why some of us felt very comfortable with this calendar, and four members of the board were opposed for different reasons to the calendar presented to us," board vice president Isabel Hacker said.

"As the days progressed and leading up to today's meeting, more and more information started to come about, and this is the first time I began to understand how this vote is tied to many other issues that affect the operation of the district, as Mrs. Walker had suggested," Hacker said.

Hacker reiterated that she does not support the proposed calendar, but added that she did not believe she had an option to vote no at last week's meeting.

"While I feel that my position today on the board is a bit unfair, I truly believe it would be worse for all the 11th graders to be left out without the opportunity to test for the PSAT tomorrow [October 16], and to cancel school for the rest of the students, these are not options for me," Hacker said, adding that things could have been handled differently, and that they must be looked into.

Board President Noah Margo expressed interest in expediting the process after last week's board meeting "so the community has a calendar sooner rather than later."

All four present board members, Hacker, Margo, Walker-Shuman and student representative Thomas Recupero voted yes.

Judge Overturns Jury Verdict in Favor of Spagnoli and City

A Los Angeles Superior Court judge overturned a jury verdict that awarded damages to former BHPD lieutenant Shan Davis.

Davis was originally awarded \$250,000 by a jury.

During a trial last summer, Davis and three other plaintiffs alleged discrimination, retaliation, and harassment by BHPD Chief Sandra Spagnoli.

Judge Elizabeth Feffer ruled there was no evidence to support the verdict, and therefore overruled the jury's decision.

"This rarely granted motion is certainly a victory for the City and the Chief," said City Attorney Larry Wiener. "Although the jury found there was no discrimination as to each of the plaintiffs, they still concluded there was harassment based on several alleged comments the Chief made in 2016. The City disagreed with the jury's finding these alleged statements rose to the level of harassment, particularly as concerned plaintiff Davis. Obviously, the judge agreed."

The City also brought a similar motion against plaintiff Donna Norris which was not granted by the court.

"The City remains committed to a Beverly Hills Police Department that upholds the highest ideals of fairness, dignity, and equality," Wiener said. "This win sends an important message as the department continues to move forward with great success."

Attorney Bradley Gage represented a total of eight clients against the City of Beverly Hills, including Shan Davis.

"One verdict against Shan Davis that we won with the jury, the court took away. We believed that the jury was correct, obviously. We have the greatest respect for the court and its decision," Gage said. "With that, we

believe that the evidence that was ruled upon [that the jury reviewed] was the same evidence with the same standards that was ruled upon twice."

Gage indicated that they will have to look at more options toward the next step, which his clients are in the process of doing.

"We go on our motion to recover more money for case costs, we have a motion for attorney's fees, and those are the next steps. After that, there are a variety of items that can be taken in connection with the court's ruling, and we are looking at all of those options to see what is the appropriate next step in that regard," Gage said.

"One-to-One" Technology **Program Debated at Board** Meeting

The BHUSD Board of Education discussed the "one-to-one" plan and purchase order, which would provide each student with a laptop to use for academic and classroom purposes.

In order to facilitate equity and access for all BHUSD students, the 2016-2018 approved technology plan called for the purchase of personal computing devices at a ratio of one student to one device. The Board of Education allocated funding for the purchase of these devices out of Measure E, passed by voters in 2008.

The Measure E "one-to-one" funds exhausted before the last two grade levels', grades nine and eleven, could be purchased. The funds for the purchase for these grades, discussed at last week's board meeting, would come from the technology-specific Measure BH funds. The total amount of the proposal is \$761,937.89.

"I have seen first hand classes [with] seniors and juniors, and it's difficult to car-

ry out a task when only half the class has laptops," Student Board Member Thomas Recupero said.

Board member Tristen Walker-Shuman indicated that there has been a change in leadership in the BHUSD's technology department, and a pivot away from the learning management system (LMS) decided at the previous board meeting.

"What I haven't seen yet is a plan for what these computers will be used for, how they will be deployed [for use] in the classrooms, and what type of technology will be used in which classrooms," Walker-Shuman said. "This for me is a huge concern.'

Walker-Shuman added that she believed there was not enough information provided to approve the almost \$800,000 purchase order.

"I understand the need for it, but I think we need to have a plan before we execute such a large expense," Walker-Shuman said in closing.

As a comparison, the Los Angeles Unified School District (LAUSD) launched a well-publicized but failed iPad program in 2013, attempting to give every student a tablet computer equipped with a digital curriculum.

The program initiated by the LAUSD required the purchase of 650,000 Apple iPads, networking gear, and educational software from Pearson, at a cost of nearly \$1.3 billion. Then-LAUSD Superintendent John Deasy launched the program, citing it as a "way to help the city's low-income students."

Deasy gave LAUSD approximately three months to implement a plan before putting the initiative out to bid in 2013, and the purchase was allocated from construction bonds typically used to build and repaid school buildings.

Educators expressed that they were not properly trained in using the new technology brought into the LAUSD, and many students learned how to bypass security features. Deasy resigned in October 2014 and LAUSD officially ended the initiative and canceled the Apple contract that December.

Board Vice President Isabel Hacker echoed Walker-Shuman's concerns, adding that teachers should be implementing the technology more or, rather, providing the technology to teachers who are more interested in implementing the technology.

Board President Noah Margo concurred that a plan should be set into place prior to the purchase.

"Because of the way the technology has been going, I don't want to rush into anything anymore without it being vetted. It needs to be revisited whether or not we are optimizing our current technology," Margo said.

Margo added that the "one-to-one" model did not work at the middle school for many reasons, and that there are unused laptops there currently.

The BHUSD board tabled the item until staff can present clarification as to the proposed uses of the technology.

Mirisch to Debate SB50 with Wiener on October 25

Mayor John Mirisch will debate state Senator Scott Wiener (D-San Francisco) over Wiener's bill, SB 50, on the "Gimmie Shelther" podcast between 9 and 9:45 a.m. on October 25

lines and job centers leading to more dense housing in these areas.

Mirisch denounced proposed state legislation SB 827 designed to increase housing density introduced by Wiener in 2018. Although SB

827 died in committee, SB 50 is similar, with modifications, and would supersede local laws to allow higher density zoning near public transportation.

Mirisch called SB50 a "war on single-family housing."

"Scott Wiener once famously remarked that 'local control isn't biblical.' Yet this type of sneaky, duplicitous behavior could never happen in most local govern- Proposed Signage at CVS ments," Mirisch said during a

June Council meeting. "Here we have yet another textbook example of why more decisions should be made closer to home rather than by Washington and Sacramento politicians.'

Wiener stated in an interview with NBCLA's Conan Nolan that "Los Angeles needs every kind of housing, and SB 50 will deliver every kind of housing.'

Wiener argued that SB 50 will open up "a lot more geography where you can build affordable housing," noting that Los Angeles currently does not allow for multi-family units on existing single-family property.

During the Council discussion, Mayor Mirisch emphasized the importance of continuing to advocate for workable, community friendly solutions to housing affordability.

SB 50 won't come up for a vote until January 2020. Supporters of the bill include Habitat for Humanity, San Francisco Mayor London Breed, AARP, and the California League of Conservation Voters.

Architectural **Commission Reviews Sign** Accommodation at CVS on Wilshire

Lyndsee Veltre, the applicant representing Fluresco Services for CVS Pharmacy, requested approval of a sign accommodation to allow for multiple business identification signs and for signage on an architectural element and a parking entrance sign.

CVS Pharmacy is located at the northeast corner of North Doheny Drive and Wilshire Boulevard. The proposal is for the updated branding for the signage at this site with the replacement of existing retail signs, including signage for the underground parking structure entrance. The signage overall is in-keeping with the previously approved signage at the site and the quality of the signage is similar to the earlier signs with halo-illumination proposed.

Veltre indicated that she was proposing "less sign square footage than what is existing.

Commissioner Tim Devlin said the proposed design was nice and "minimal overall," in regards to the changes being made to the existing logo.

However, all commissioners expressed the need to clean the façade of the building, which Veltre indicated is an issue to be brought up with the landlord rather than with signage.

"The building façade is not in good con-



dition, [there are] stains on the sides, you are going to change the sign, but it wont look great without [these changes]," commissioner Jennifer Schreiber said.

The sign will be facing Wilshire Boulevard and Doheny Drive at 39 square feet, halo-illuminated with single-faced internally illuminated reverse pan individual channel letters.

No change will be made to the storefront window on Wilshire Boulevard, at 8.69 square feet, non-illuminated existing vinyl graphic.

An architectural element signage on the awning facing Wilshire Boulevard and Doheny Drive at 4.16 square feet, non-illuminated will be flat cut out aluminum letters.

Commission Chair Sharon Persovski also voiced concern of wayfinding signage in the parking lot of the CVS store.

"The parking area has a downhill [path] creating a blind spot, and because there's no correct entrance or exit signage, people drive in the middle. For me that is really a big concern, and the signage should communicate to people the entrance and exit ways [clearly]," Persovski said, adding that she and others she knew personally have either been in accidents or have come close to experiencing one when driving into the parking lot.

The Architectural Commission approved the changes on various conditions: that the façade be repaired and repainted, that there be consideration toward revising parking enter and exit signage, and that the applicant consider repainting the entire building in the near future.

The commission unanimously approved the proposals on these conditions.

Architectural Commission Reviews Signage and Façade Modifications for Lucid Motors

Paul Scanion, representing Lucid Motors at 9022 Wilshire Boulevard, requested approval of a business identification sign and façade modifications at an Architectural Commission meeting last week.

Scanion proposed various modifications to the façade, including the painting and re-plastering in shades of black and gray, installation of black aluminum metal cladding at the storefront projection, installation of new entry doors on the front façade and automotive access door at the rear façade, and re-cladding of the existing storefront frame in a black anodized metal finish.

The height of the logo sign was proposed to be 46.7 square feet with stainless-steel channel letters in a black chrome finish.

Commissioner Tim Devlin remarked that "the placement [of the signage] is great and centered nicely," but added concern that it may not be visible during the day.

The applicant said that the creative team behind the logo settled on black chrome and a flushed acrylic white finish and believe that it provides enough contrast.

Commissioner James Matson agreed with Devlin on the matter of visibility and contrast, and suggested that more thought

> While all commissioners agreed that there should be a more contrasting color scheme, vice chair Sheri Hirschfeld said she liked the subtle coloring.

> "It's kind of sexy, like a secret," Hirschfeld said. "It says 'We're not yelling.""

Commission Chair Sharon Persovski added that she "loves the signage" but that she is also concerned about the contrast during the day.

According to Scanion, the property was chosen because of its "long lineage" of housing car sales, dating back to 1940.

Lucid Motors, Inc., formerly known as Atieva, is an American automotive company based in Newark, California that specializes in electric cars. The company was founded in 2007. The property acquired at 9022 Wilshire Boulevard will be Lucid Motors' first site in Southern California.

Citizens Oversight Committee Provides Updates on Measure E and BH Funding

The Citizens Oversight Committee (COC) met last week to discuss updates on Measure E and Measure BH funding throughout the BHUSD.

Measure E funding project expenditures to date on combined El Rodeo improvements total \$19,908,100. All modular buildings have been removed from the campus. Modular disconnect and demolition projects are complete, with a contract closeout in progress.

At Hawthore, the current expenditure total is \$7,306,687, Beverly High totaled \$67,429,957, and Beverly Vista totaled \$4,046,042 in expenditure costs.

Horace Mann construction saw the highest cost of project expenditures to date at \$83,046,346.

The voters of the BHUSD authorized Measure BH bonds in the amount of \$385,000,000 on June 5, 2018, that are to be used to upgrade and replace inefficient heating and cooling systems, classrooms, science labs, deteriorating restrooms and leaky roofs, and to provide modern classroom technology.

A total of 115 live cameras were implemented throughout the district as well, according to the report.

Of the 19 oil wells on Beverly High's campus, 13 have been successfully plugged and cemented. Well 14 is to be complete by October 31.

COC Chair Richard Baron also expressed interest in conducting tours for community members to personally see

changes and updates in construction in the BHUSD.

"It is important to give [residents] the opportunity [to tour]. The average person sees everything is blocked off and not much going, and for a while, nothing was going on," Baron said. "Now we're making progress. The taxpayers spend a lot of money, and [deserve to] see how it is spent."

Strategic Planning Committee Discusses Possible Architectural and Signage Changes in Southeast Area

The Strategic Planning Committee met last week to discuss possible changes throughout the city in terms of architecture and signage.

City Planner Timothea Tway began the committee meeting demonstrating the recognizable uniformity of various cities, such as New Orleans, Santa Barbara, and Santa Fe, and brought up to discussion the possibility of creating a more uniform aesthetic in the City.

Tway also mentioned that Los Angeles County has redesigned their signage regulations to capture the feeling of Broadway, a major thoroughfare in central Los Angeles from 3rd to 9th street. The area is considered a "Historic Core" and was the city's main commercial street from the 1910s until World War II, and is lined with theatre signage unique to the street.

"All new signage has to be [similar] to this theatre signage, and [the City can require] that too, that all new signage on Robertson needs to be pedestrian signage so it feels more like a village," Tway said, and pointed to Santa Barbara as an example.

Mayor John Mirisch commented that buildings at ground level should be more pedestrian-friendly.

"We've discussed that in the Southeast as well, where you have lawyers on the ground floor, but they should be somewhere else. You want to have ground floor spaces that people can walk to and that give a sense of community," Mirisch said.

Much of the discussion was focused on

the Robertson Boulevard stretch.

"The block between Robertson and La Cienega is in massive need of help. You've got dilapidated structures that if we took them by today's code structures, might be red-tagged, and they're single-story, they're disgusting, and many are vacant," Recreation and Parks Commissioner Julian Javor said.

Other possible interventions discussed were to require non-reflective glass on buildings, require amount of opening on ground floor, require smaller tenant spaces on ground floor such as more doors on more businesses, and to encourage more indoor and outdoor business that spill into public space.

There was also discussion on whether or not there should be more stringent requirements for style of buildings or more uniformity, to foster an environment of unique buildings and eclectic architecture, or a possible theme.

Architectural Commission Reviews Signage at 9495 Santa Monica Boulevard

Landmark Street, LLC, representing Flour Shop at 9495 South Santa Monica Boulevard, made a request to the Architectural Commission last week for approval of a business identification sign, façade modifications, and a construction graphic.

The proposed material for the façade is paint with a smooth matte finish, white in color with a six inch black trim. The brand-specific graphic with signage and logo is proposed on the main street-facing elevation. The barricade graphics will be installed on the interior and within the existing glazed storefront areas.

The project also consists of the installation of new entry doors and awnings in white with a multi-colored striped pattern, and new signage comprised of metal-cut individual channel lettering. Awnings were proposed by the applicant to be of fire-proof cotton canvas, white in color with rainbow stripes.

The Recreation and Parks Commission discussed and provided direction on what methods to use to evaluate the success of the six-month Pickleball pilot program at a meeting on Tuesday.

Pickleball is a paddleball sport that combines elements of tennis, badminton, and table tennis. The games are comprised of two or four players who use solid paddles made of wood or composite materials to hit a perforated polymer ball, similar to a Wiffle Ball, over a net.

The sports shares features of other racquet sports and the dimensions and layout of a badminton court. Pickleball courts should be 20' by 44' for both singles and doubles play. The net is lowered to 36" on the ends and 34" in the middle.

At the Commission's June 25th 2019 Regular meeting, the Commission heard a presentation on the results of the Pickleball survey that was administered February 25th through May 31st earlier in the year. The history of the sport of Pickleball was also shared at the meeting. The Commission expressed interest in conducting a Pickleball pilot program to evaluate interest in the City for Pickleball.

The City's tennis concessionaire, The Tennis Place Inc. helped administered the Pickleball survey, and discussions have occurred with them to enlist their involve-

ment in the pilot program expected to be launched in January and go through June of 2020. In preparation, a City staff team has been meeting to explore options, determine operational processes, and to begin to consider how to determine whether the pilot program was successful.

In June, the commission recommended the City provide Pickleball courts for community use on a trial basis with reports back to the Commission on usage and satisfaction for 6 months from the date of commence-

ment. The Commission recommended that two tennis courts at La Cienega Tennis Center and one court at Roxbury, during established times, be part of the pilot.

The commission asked that hours be available during both peak and non-peak hours and one weekend day from 8:00

SONIA SAYS

The Human Relations commissioner discusses the criteria for kindness recognition during "Civility Month"

By Allyson Aleksey

Tell us about some of the things you've accomplished during your time with the Human Relations commission.

Sonia Berman: Some of the things I've done with the commission is "one book, one city," which is a book reading for the entire city where we would have the author come and give a lecture. The kids from [Beverly High] would be reading the book as well.

We've also done "Civil City," which is civility month, the month of October. We go to City Council the last week of October with our honoree for that award. Plus, we're honoring all the previous recipients of the award, which is the first time we've done that.

Originally, when I got on the commission, we were dealing with rent stabilization.

It's interesting that rent stabilization was discussed in that commission, as it's brought up at City Council meetings regularly.

When I came on [as a commissioner],

the Human Relations commission was charged with listening to residents, be they owners or tenants, about their concerns, their complaints, their criticisms, any and all of the above, regarding putting in any kind of rent stabilization ordinance.

We've heard hundreds of people over the course of months, pro and con. Some thought [ordinances] were a great idea, some didn't. We turned [those findings] over to the city, and at that point, there was a rent stabilization department developed. So that task was taken away from the Human Relations commission.

When I was appointed to the commission, that was one of the biggest pieces of the tasks of the commission, to try and flush out what was going on with rent stabilization.
