Council Extends Scooter Ban

At their November 5 meeting, the City Council opted to extend a scooter ban essentially restricting all share mobility de-

Although the Councilmembers generally agreed that the City is headed in that direction, they argued that the current congestion issues and landscape doesn't make an e-scooter system viable "yet."

"That's what troubles me is that I have the safety issue versus mobility issue that I'm weighing," said Vice Mayor Lester

Friedman. "I'd like to get to the point where I can say the mobility issue outweighs the safety issue but I don't think I'm there yet and there's been enough done yet to make me go in that direction."

Originally passed in July 2018, the ordinance was set to expire on January 17, 2020. It has received support from community members concerned with safety and interference of shared mobility devices on public and private property.

The ordinance prohibits the use, placement, parking and offering of shared mobility devices in the City, which has caused pushback from e-scooter vendors.

In February, Councilmember Julian Gold and Councilmember Lili Bosse held an Ad Hoc Committee meeting to hear scooter company Spin's pilot program proposal. Another meeting was held in June with the City Council and the Traffic and Parking Commission Liaison Committee to hear presentations from companies Spin, Bird and Lime regarding a shared mobility pilot program.

During the November 5 meeting, representatives from Bird and Spin once again made their case for a pilot program.

In Spin's presentation, Partnerships Director Tim Alborg emphasized the company's prioritization on safety, organization, responsiveness and equitable service. This would mean an in-app feature to fine riders using the scooters incorrectly, and communicating closely with Beverly Hills by "never launching without a city's permission."

Alborg also addressed the Council's ongoing questions about congestion and commercial areas.

"Scaling responsibly is important," said Alborg. "We're not looking to drop hundreds and hundreds of vehicles on day one. We want to grow this thing organically, partnering with the City."

Alborg emphasized the importance of education campaigns, education screens in the app and the use of ambassadors.

The Council, however, expressed continued concern regarding the City's current ability to sustain a citywide implementation of a pilot program.

Councilmember Robert Wunderlich said he "could be" receptive to receiving proposals about operating in some less congested areas of the City or the Santa Monica Boulevard bike lanes.

"And of course, any proposal that we could would have to describe how these things are going to be operated safely, what are the best things we can do to make sure they're not going on the sidewalks, and what are the best things we can do to guarantee that they won't be parked half-hazardly all over the place," said Wunderlich. "If we can get assurance on those sorts of factors I could see some limited scale access but not an implementation citywide at this point."

The ordinance extension will appear on the November 19 Consent Calendar.

Council Continues Autonomous Vehicle Discussion

Although they didn't reach a final decision, the City Council discussed the City's future with autonomous vehicles at length.

At their November 5 meeting the Council heard a report from the Autonomous

Vehicle Liaison Committee regarding the work that has been completed so far on a previously passed resolution

They also "workshopped" various potential alternatives before finalizing the AV plan and considered whether or not there was a desire for AV's in the first place.

When tasked with nailing down the core point of the symposium, Mayor John Mirisch suggested asking the question, "How can AV's improve our lives?" which both Councilmembers Lili Bosse and Robert Wunderlich called a "loaded" and "leading" question.

But Mirisch called the question necessary. "If in theory you come to the conclusion by asking that question that there's no way we can possibly take this technology and use it to make our community a better place, that's a potential answer. But I don't think it's an unfair question to ask, because three years ago we decided this would be a benefit to the community."

The decision follows a resolution passed in 2016 declaring support for Autonomous Vehicle (Avs), where the Council directed staff to help develop an AV program.

Since then, staff held various meetings with AV manufacturers and academics to "formulate plans on the role of AV's within the larger public transportation environment," according to the staff report.

Currently, a proposed project plan is in the works, in addition to an implementation schedule, budgets, and a pilot project.

During deliberation the Council deviated a bit onto technicalities and philosophical side streets, but ultimately agreed they were on the same page regarding addressing the most important question: How would the implementation of AV's most impact the community, from seniors to high-schoolers?

"We should have experts on both sides to answer whatever questions get posed, but it should not be a discussion of the experts around the nuances of autonomous vehicles," said Councilmember Julian Gold.

The item will now go to the Liaison Committee and then return back to the Council at a future date.

City Denies Partnership with MIT in Autonomous Oriented Development Study

Brought forth by Mayor John Mirisch, a potential partnership with the Massachusetts Institute of Technology (MIT) for an autonomous oriented development study took up a portion of the Council's November 5 meeting.

Mirisch met with representatives from

MIT's Leventhal Center for Advanced Urbanism (LCAU) at an autonomous vehicle event. The LCAU is a research center that conducts studies related to the design and future of metropolitan environments.

Mirisch said that the City possesses a "unique" set of circumstances like having a three-minute response time, a fiber network, etc. Membership to the program, he argued, would allow the City to take a leadership role in influencing other similar communities and effecting change.

"We need to get beyond this notion of transit-oriented development because it is no longer something that is the latest in where we should be. We need to be thinking ahead," said Mirisch. "I think we can see that there are negative ways in which cities are being planned because they're not being planned for the future."

Potential work products that could result as a result of a membership include producing a "handbook" for autonomous oriented development. The handbook could provide guidelines for future development of urban areas as autonomous vehicles become more prevalent and change mobility patterns. Research will be primarily based on case studies around the nation, with a portion addressing issues specific to Los Angeles and Beverly Hills.

At the meeting, the Council discussed the cost of membership to the LCAU, which is \$70,000 to enter and \$30,000 each subsequent year. The City would need to either directly fund the research projected (estimated at \$150-\$200,000 per year) or work on identifying and securing funds for research.

According to the staff report, total costs to the City would likely be \$300,000-\$400,000 depending on the length of the project.

Councilmember Julian Gold expressed concern regarding the uncertainties of the many uncertain variables and financial impact.

"As much as I like the goal, we'd pay \$70,000 for the privilege of spending half a million dollars to develop this project which may have some applicability to our city but which may also have a broader applicability, but I'm not sure we're the ones



Mayor John Mirisch and community members attended a complimentary lecture on November 10, presented by Professor Renata Stih and Professor Dr. Frieder Schnock on "Art and Memory in Berlin."

Stih and Schnock are Berlin based visual artists who explore how memory functions in the social sphere, and how it is reflected symbolically in urban spaces. Their multi-media art installations refer to contemporary artistic formats and traditional rituals inside museums and art galleries while encouraging public interaction and engagement.

In their joint lecture on "Art and Memory in Berlin," Stih and Schnock reflected how their idea of art in public space affects everyday life through their art projects, focusing on their decentralized memorial "Orte des Erinnerns, Places of Remembrance" in Berlin.

Stih currently teaches art and technology, film and media at Beuth University of Technology in Berlin, and is the Chair of the Art Advisory Board to the Senate of Culture and Europe in Berlin. Schnock is

FOR LOVE AND CHOCOLATE

Tom Gallop on the Challenges of Running a **Beverly Hills Small Business**

Tom, you and your fiance Tara Margolin are celebrating the one year anniversary of your store Beverly Hills teuscher, What inspired this business?

As far as inspiring the business, I give Tara all the credit in the world. We were actually dating, and looking for a business to get into. And teuscher, which has been in Beverly Hills for 35 years, [Aviva Covitz] retired about seven years ago, she left the shop to her sons, Mark and Phil Covitz, [who now own AndSons Chocolatiers across the street], they ran the original store for about seven years, and they decided to do their own thing. So they were off, kind of hiring a pastry chef and they were going to make their own chocolates in downtown LA, meanwhile teuscher is an iconic brand. Tara's

me don't you?" And I said, "of course I love you." She said, "Will you buy me a chocolate shop." So, I reached out to a couple of other Teuschers, and got Mr. Teuscher's e-mail, and I e-mailed him directly I let him know "I'm Tom Gallop, I've lived in Beverly Hills for 28 years, and I want to talk to you about carrying the baton." And that's how we kind of came to be.

What makes your chocolates unique?

I think what makes teuscher so special is, it's been made since 1932. And they've been doing it the same way for three generations of chocolatiers for 87 years. The chocolates are made with milk of Swiss dairy cows. If I'm coming back as anything, I want to be a Swiss dairy cow. They are grazing in

the most beautiful scenery, eating the freshest grass with the most incredible nutrients. And that winds up in the milk, which ends up in the chocolates. There are only seventeen stores in the world, which means Mr. teuscher can keep his eye on all of them -- and for him, it's all about quality, and making sure the chocolates are always fresh

daughter worked there for a year and a half, came over on Father's Day with a box of champagne truffles, and said "Hey guys, here are some champagne truffles, they're the last you're ever going to see in Beverly Hills, they're closing teuscher." And her mom, got really sad, and I think I actually saw a single tear start to cascade down her cheek. And she looked at me, and she said: "Baby, I can't live without my champagne truffles." And I said, "I'm sorry for your loss that sounds really, really terrible." and she said, "No, no, no, you don't understand, this is a terrible day." And she said, "you love

How did you and Tara meet?

I met Tara getting takeout at The Honor Bar [on South Beverly Drive].

No way! That really is a Beverly Hills love story.

That's a true story. We were both getting kale salads, and I was speaking to the manager, waiting for my salad, and she was waiting for hers at the bar -- I was dressed in like a college T-shirt and Dolphin shorts, and she was dressed like she was going to the opera. And I kind of saw her out of the corner of my eye, and then after the manager [Randy] walked away, I went to look at her and I stared just a little too long. And after I stared for a little too long, she said "What?" And I said, "I'm a fan, you're beautifully dressed, sitting here all by yourself drinking champagne-- it's just classy, I'm a fan." And she said, "Actually. it's not champagne, it's sparkling wine." And we have been bantering like that for the past five years.

I love that you two met in Beverly Hills, that's awesome. Speaking of Beverly Hills- How has being located here impacted your business?

I mean, I think the fact that we are directly across the street from where [the original] teuscher was for the past 35 years, was a must-have. It was paramount to the success. Every day since we opened, and this is NOT an exaggeration, we get at least 2-3 people who come into the store and say "Oh my gosh, I am so glad you're back!" And I want to say, I think since we've opened [this location], we've had close to 11,000 customers come through the doors. We are

here to stay. We love being part of the fabric of Beverly Hills. the same way that Tiffany's is, and you're favorite restaurants that have been here forever. You know, I've lived here for 28 years, [and Tara for much of her life] and we ride our bikes to work, we're just enjoying this chapter.

What has made your business successful?

We take this business very seriously. When I first took over the franchise, a woman down in La Jolla, named Karen Bacon, she said there are two things to consider, and if you're okay with these two things you'll be incredibly successful. And that was one, you can't do it for the money - and two, you have to have a passion for it. And the fact is, we are, without knowing how passion we would be, Tara and I are incredibly passionate -- about not only the chocolate and the packaging, but about how dear and passionate our customers are. You know, we've had three generations of customers that keep coming in for chocolates, for holidays and for gifts, and people, they have stories. It's not just the chocolate; it's really something that connects generations. And of course, Tara's daughter Marlee Blakeman was really instrumental in all of this. The transition, which could have been a complete cluster-you-know-what, was as seamless as it could have been because Marlee was essentially managing teuscher. So she just really helped us.

You were recently voted "Retailer Of The Year" in the annual Best of Beverly Hills Golden Palm Awards. Tell us about that.

Yeah! So first, it's going to sound cliche, but it was an honor just to be nominated. And I think it was our publicist may have alerted us to the fact that we were nominated. Honestly, I didn't know much about it, we just did a little research and realized it was something that was going on for years, and that it would be really cool to win it. And it was decided by a vote. So I think we spent the last week of the voting, which ended mid-October, really putting in a grassroots effort, I reached out to everyone I knew and asked them to vote.

Congratulations on the award. What can we expect from teuscher in the next year?

I think that we will obviously still be serving up the same beautiful small batch chocolate that's flown in fresh every week from Zurich. You know, I wouldn't be surprised if we had a second shop. Maybe by this time next

year. We'll have to see. If our current pop-up shop [on North Canon] is really successful, maybe we would look for a permanent place, somewhere where it's far enough away from the current shop. Or it might make sense for us to be in Brentwood or Santa Monica. I think that's what we're looking for. We really enjoy the events we're doing -- we just sponsored the Elizabeth Taylor AIDS Foundation benefit, and were the sweet/ dessert component of the evening... that was nice. I think more of the same. This first year has been a whirlwind, we really didn't know what to expect, but we're so



Ordinance No. 19-O-2792

AN ORDINANCE OF THE CITY OF BEVERLY HILLS AMENDING THE BEVERLY HILLS MU-NICIPAL CODE REGARDING ASSIGNMENT OF PLANNING AGENCY FUNCTIONS.

WHEREAS, California Government Code Section 65100 creates a "planning agency" in each city in California, and requires the legislative body of each city to assign by ordinance the functions of the planning agency to one or more planning commissions, administrative bodies or hearing officers, a planning department, itself, or a combination thereof, as it deems appropriate and necessary.

WHEREAS, on February 7, 1978, the City Council of the City of Beverly Hills adopted Resolution No. 78-R-5776 designating the Planning Commission as the Planning Agency for the City of Beverly Hills, and thereby having "the responsibility for performing all duties as may be imposed by law or by the Council."

WHEREAS, pursuant to Government Code Section 65402, planning agencies are responsible for reviewing certain real property acquisitions and dispositions and reporting as to the conformity with the City's General Plan.

WHEREAS, in order to streamline the City's real property acquisition and disposition pro-cess, the City Council opts to reserve to itself the planning agency role of reviewing real property acquisitions and dispositions for conformity with the City's General Plan.

THE CITY COUNCIL OF THE CITY OF BEV-ERLY HILLS HEREBY ORDAINS AS FOL-LOWS:

Section 1. This Ordinance was assessed in accordance with the authority and criteria contained in the California Environmental Quality Act (CEQA), the State CEQA Guidelines, and the environmental regulations of the City. The allocation of planning agency functions between the City Council and the Planning Commission constitutes an organizational and administrative action of the Čity that will not have a direct or indirect impact on the environment, and thus adoption of the ordinance is not a project for CEQA purposes. Even if it was a project, it can be seen with certainty that adoption of the ordinance has no possibility of having a significant effect on the environment. The City Council hereby finds that this ordinance is not a project, as defined in CEQA Guidelines Section 15378, and in the alternative that this ordinance is exempt from CEQA pursuant to Section 15061(b)(3) because it has no possibility of having a significant effect on the environment.

<u>Section 2.</u> The City Council hereby amends section 10-1-102 of Chapter 1 of Title 10 of the Beverly Hills Municipal Code by adding a new paragraph I to read as follows with all other provisions in Section 10-1-102 section remaining unchanged:

"I. Act as the City's planning agency and carry out the duties of the planning agency as set forth in State Planning and Zoning law, except that the City Council shall serve as the City's planning agency for purposes of reviewing real property acquisitions and dispositions for general plan conformity when conformity review is required by Government Code Section 65402, as it may be amended from time to time."

<u>Section 3.</u> The City Council hereby rescinds Resolution No. 78-R-5776, which shall be of no further force of effect upon the effective date of this ordinance.

<u>Section 4.</u> <u>Publication</u>. The City Clerk shall cause this Ordinance to be published at least once in a newspaper of general circulation

published and circulated in the City within fifteen (15) days after its passage in accordance with Section 36933 of the Government Code, shall certify to the adoption of this Ordinance, and shall cause this Ordinance and her certification, together with proof of publication, to be entered in the Book of Ordinances of the Council of this City.

<u>Section 5.</u> <u>Effective Date.</u> This Ordinance shall go into effect and be in full force and effect at 12:01 a.m. on the thirty-first (31st) day after its passage.
