## Traffic and Parking OKs Whitworth Stop Sign Installation

Per a request by the Los Angeles Department of Transportation (LADOT), the Traffic and Parking Commission discussed and subsequently approved installing an all-way stop sign at Whitworth and South Clark Drive.

The current two-way, north-south stop control is located at an intersection shared between Beverly Hills to the north and Los Angeles to the south.

The newly approved request will require five additional feet of red curb to be installed on the northeast curb face of Whitworth for clearance.

Although he expressed general support of the request, Commission Vice Chair Jake Manaster also voiced concern that the nearby multi-family buildings create blind spots. He pointed out that as the intersection becomes "more cavernous," drivers who glance to the right only have a view of said large buildings.

This impediment to one's line of sight, said Manaster, poses a threat to safety as well as a possible discussion about the City's zoning rules.

"Four-way stops are certainly better

to slow things down, but it prompts the question of urban planning when you see very tall buildings going right up to a corner,” said Manaster.

After receiving the LADOT request in September, the City’s Department of Transportation initiated a traffic engineering study for an all-way stop sign installation.

According to the staff report, the study included an investigation of the physical conditions and existing traffic controls, field observations of traffic movement through this intersection, and a review of Los Angeles Police Department and City records of traffic collisions.

The study results indicated that the intersection “satisfies” the Department’s guideline for a stop sign installation.

Mailers were sent to residents within 500 feet of the intersection—including the 400 South blocks of Clark, Swall and La Peer Drives and Robertson Boulevard, but no one spoke at public comment.

During deliberation Commissioner Nooshin Meshkaty said that while this specific project involved a collaborative

effort with the Los Angeles, the neighboring city hadn’t always been so easy to work with.

When the commission reached out several months ago to install a left-turn pocket at Olympic and Century Park East, it had “the hardest time” getting Los Angeles to respond, said Meshkaty.

She suggested that this newfound open communication channel with Los Angeles could be a jumping off point to discuss further safety issues.

The installation will occur within 120 days of the commission’s unanimous approval.

**Mandatory Seismic Retrofit Ordinance No. 18-0-2767**

The City of Beverly Hills Ordinance No. 18-0-2767 became effective on January 11, 2019 and is intended to strengthen existing multi-family wood-frame soft-story buildings. The ordinance requires property owners to retrofit their buildings within 3 years of the Notice to Comply date.

Properties subject to the Ordinance were identified and given a Tier I, Tier II, or Tier III designation. A description of each tier and the milestone deadlines are listed below. Notices to Comply have currently been distributed to property owners with Tier I and/or Tier II buildings. Tier III building property owners will receive notices at a future date.

The Council of the City of Beverly Hills, at its regular meeting to be held on **Tuesday, January 28, 2020 at 7:00 p.m., or as soon thereafter as the matter may be heard**, in the Council Chamber of the City Hall, 455 N. Rexford Drive, Beverly Hills, CA 90210, will hold a public hearing to consider:

### EXTENSION OF AN INTERIM ORDINANCE OF THE CITY OF BEVERLY HILLS TO PROHIBIT RESIDENTIAL DEVELOPMENT PROJECTS THAT FAIL TO COMPLY WITH INCLUSIONARY HOUSING REQUIREMENTS AND CERTAIN PUBLIC NOTICING REQUIREMENTS AND DECLARING THE URGENCY THEREOF.

The Council will consider whether or not to extend the interim ordinance for a period of ten months and fifteen days, in accordance with the provisions of Government Code Section 65858. The extension of the interim Urgency Ordinance will require a four fifths vote by the City Council.

This Interim Ordinance has been assessed in accordance with the authority and criteria contained in the California Environmental Quality Act (CEQA, Public Resources Code Sections 21000 et seq.), the State CEQA Guidelines (California Code of Regulations, Title 14, Sections 15000 et seq.), and the environmental regulations of the City. The adoption and implementation of the Interim Ordinance represents minor alterations in land use limitations and noticing procedures for certain projects and do not result in any changes in land use or density. It can therefore be seen with certainty that there is no possibility that the proposed amendments may have a significant effect on the environment. In addition, the Interim Ordinance consists of an action taken by a regulatory agency for the protection of the environment due to the fact that it will apply inclusionary housing regulations to all multi-family housing developments. Accordingly, the City Council will consider the staff recommendation to find the Interim Ordinance exempt from the environmental review requirements of CEQA pursuant to Section 15061(b)(3), 15305, and 15308 of the California Code of Regulations because it can be seen with certainty that there is no possibility that the activity in question would have a significant effect on the environment.

All interested persons are invited to attend and speak on this matter. Written comments also may be submitted and should be addressed to the City Council, c/o City Clerk, 455 N. Rexford Drive, Beverly Hills, CA 90210. Written comments should be received prior to the public hearing date. The Planning Commission of the City of Beverly Hills, at its REGULAR meeting on Thursday, January 23, 2020, will hold a public hearing beginning at **1:30 PM**, or as soon thereafter as the matter may be heard to consider the following:

**Conditional Use Permit (CUP).** A CUP request pursuant to BHMC §10-3-2862 to allow a hotel use to operate on a property located within the C-3 Commercial Zone. The project proposes the adaptive reuse of an existing ten-story office building to a 154-room hotel with restaurant and ancillary uses. The proposed project will not increase the floor area or height of the existing building. The project site includes a detached 6,757 square foot restaurant (former Kate Mantelini) and a 5-story parking garage with 138 parking spaces. The proposed project also includes the use of an off-site parking garage located at 140 South Doheny Drive with 108 parking spaces. Additionally, pursuant to BHMC §§ 10-3-2733 and 10-3-2741(B), the CUP application includes a request for off-site parking in excess of ten spaces within 750' of the site, and a request for modified vehicle loading spaces.

**Historic Incentive Permit (HIP).** A HIP request pursuant to BHMC §10-3-3252 to allow deviations from development standards described in BHMC sections: 10-3-2863 (Ground Floor Street Frontage); 10-3-2865 (Capacity of Other Uses); 10-3-2867 (Hotel Access Area); 10-3-2868(B) (Residential Adjacency); 10-3-2868(C4) (Maximum Height and Floors); and 10-3-1953(A) (Solid Masonry Wall).

This project has been assessed in accordance with the authority and criteria contained in the California Environmental Quality Act (CEQA, Public Resources Code Sections 21000 et seq.), the State CEQA Guidelines (California Code of Regulations, Title 14, Sections 15000 et seq.), and the environmental regulations of the City. Upon review, the project appears to qualify for a Class 1 Categorical Exemption (Existing Facilities) and a Class 31 Categorical Exemption (Historical Resources Restoration/Rehabilitation) in accordance with the requirements of Sections 15301 and 15331 of the state CEQA Guidelines. Class 1 Categorical Exemptions are applicable to the operation, repair, maintenance, or minor alteration of existing public or private structures and facilities, involving negligible or no expansion of use. Class 31 Categorical Exemptions are applicable to projects limited to maintenance, repair, stabilization, rehabilitation, restoration, preservation, conservation or reconstruction of historical resources. Accordingly, pursuant to the provisions set forth in CEQA, the Planning Commission consider a recommendation to find the project exempt from the environmental review requirements of CEQA.

# people & profiles

## CONTRA-TIEMPO Founder Ana Maria Alvarez

In celebration of its 15th anniversary, Urban Latin Dance Company CONTRA-TIEMPO will present joyUS justUS at the Wallis' Bram Goldsmith Theatre January 17-19.

**You're a dancer, choreographer and teaching artist. How did you found the Los Angeles-based dance company CONTRA-TIEMPO?**

The company itself grew out of my thesis work at UCLA. I moved here from New York to get my Masters in Choreography. Through my Masters work I was really exploring how dance could be used as a tool for social change. When thinking about the idea of resistance, dance was this incredible metaphor for resistance and powerful interactions and dynamics, specifically around the immigration battles happening 15 years ago. Bush was talking a lot about how resisting anything that he was saying about immigration was anti-American. I was interested in looking at Salsa as this metaphor for resistance and pushback and

engagement with a partner. If you don't push back and engage, you don't actually exist in the conversation. That's what it meant to be in the United States—our relationship with resistance is so fundamental and so crucial.

So I created this whole piece really about pushback and engagement and resistance. As I've gotten older, resistance has become less about resistance from the idea of struggle, but [rather] resistance as a powerful standing for love, joy, connection and community. This work brought us full circle; joyUS justUS, the piece we're performing at the Wallis, is really about community and connection and how we can build a more just and equitable world through joy. Joy

is a superpower we all have access to. Through dance, we can all see and share our humanity and connection. There is this real sense of "we are one."

**Your college thesis examined the abstraction of Salsa. What piqued your interest about the world of Latin dance?**

I'm Cuban-American. My father is Cuban, I grew up speaking Spanish and dancing Salsa. So before I was ever in a dance studio learning how to "dance," in these family spaces music and dance was just a part of growing up and being a person. Latin dance is very much a part of who I am and where I feel called and comfortable and at peace. In high school I discovered Afro-Cuban dance and went back to Cuba about 12 different times working with dancers there, studying, training and learning more about my roots. Through that study and through that inquiry it became more clear that who I am as a dancer is not apart from who I am as a person or who I am culturally, that they're all interlinked

and connected.

**CONTRA-TIEMPO is a self-described "tapestry," containing a diverse range of members like dancers, educators, and immigrants. Tell us about that.**

Because I came from this idea that dance is not separate from life, this idea of the dancer not being this person up on a pedestal and separate from humanity, as an artist I was always very interested in how we connect our artwork to what's happening in real life. What are our realities of people and how does that inform and connect to the art I'm interested in making. I've always been really interested in working with large groups, I've always been interested in working with people, my interest in art-making is very

much my passion and love for people and for connecting groups and communities. Through connection we actually understand more about ourselves. That is very present through the work of CONTRA-TIEMPO but also for me as an artist it's just part of my ethos. I'm not interested in being a solo artist or creating solo work. I'm interested in the incredibly magical things that are possible when people get together and create together.

**The group is based in South Los Angeles. How have you found that backdrop to be influential?**

Our company is from all over Los Angeles, but our work for the last three years has been very much rooted in South Los Angeles. South LA is where we have been doing a lot of our community organizing and our creative process has happened. We worked with an organization called Community Coalition; they've been around for decades and have been doing incredible advocacy work in South Los Angeles. We connected with them because they were really interested in integrating art into their organizing work and we were really interested in figuring out how art can be a mechanism for social change. So it was a perfect blending of those two desires. Through the last two years that was the creative process of joyUS justUS, we gathered in South LA every night and had these [meetings] called Sabor Sessions, which are kind of like community get-togethers—basically people getting together on a Friday night and [treating] joy as if it were a practice. Whatever you had happen that week you'd come and connect and you'd dance, and you got it all out.

It was really this beautiful practice we developed for two years. And it was amazing because as the piece was being developed we were continuing this practice, so when we had new things to share we'd bring them to the Sabor Sessions, and do choreographic labs where we'd share some of the work, get feedback, do some story circling, and we'd all get up and dance together. Wherever we go, even though we also continue to get to hear new stories and new [interpretations] of what the piece means as we go to new places, South Los Angeles is definitely where the piece was rooted and the place where it began.

**CONTRA-TIEMPO's joyUS justUS show celebrates the power of joy to overcome inequalities. Why is important to use art as a way to express social resistance?**



Art has the capacity to help us understand and be in relationship physically and viscerally with our humanity. When you dance or

move or see a piece of art or hear a specific song, it access and evokes feeling. And feeling is the place where we make decisions from. It's where we choose our values or decide how we're going to move forward in the world. There's a reason that in radical political revolutions artists are shut down or told not to create; freedom of speech is not encouraged during times of political instability, and I think the reason for that is because art is so powerful and has the capacity to really move people and have people change their minds about things or see things differently. I think that's what the whole piece is about: intersectionality.

**Your upcoming performance at the Wallis will mark the group's 15th anniversary. What does that mean to you?**

It's very special to be able to share our work at the Wallis. As a dance company, for the first decade of our existence, so much of our work was performed outside of Los Angeles. It was really about touring and sharing our work as much as possible because we didn't find as many people here in Los Angeles willing to bring our work to our stages. So it's been incredible over the last few years to partner with local presenters. They've been able to give our local community access to the work that we do. We love being able to share the work in and around Los Angeles; it's always more powerful and special than any of our other shows because it's our home.

To celebrate our 15th year, it's really special to be back in LA. The Wallis is such a beautiful venue [so it's] great to be able to share our work out loud in this beautiful space with our home community. And also, the fact that the Wallis this year booked all local Los Angeles-based dance companies is really cool and we're so excited to be part of that.

# MISSION TO MANILA

## Tiffany Majdipour on the outreach trip that provided free dental care in the Philippines

USC dental students traveled to Manila, Philippines with the student-run Dental Humanitarian Outreach Program to provide free dental care to an underserved community in Malabon City. 2011 Beverly High graduate Tiffany Majdipour, a member of the delegation, spoke with the Weekly about the trip.

### How did your dental organization choose to go to the Philippines?

Choosing a destination for each trip always involves a lot of consideration. We try to choose somewhere that we know is in need of dental care and there are always so many options. This is actually the first year that DHOP has returned to a destination we have been to before. Five years ago, DHOP traveled to the Philippines and we decided to return because our contact there was so strong and reached out yearly to have us return. We remembered how truly devastating the states of their oral health was on our first visit and knew the people there were in need.

### What countries has the group been to in the past?

Destinations we have visited in the past include Panama, Cambodia, Nicaragua, Belize, Jamaica, Kenya, Colombia, and Honduras.

### What makes Malabon City, where you based your dental clinic, unique?

The children and adult patients in Mal-

abon are so special. The children that we treated were so patient and thankful, even after multiple hours in the dental chair. It was an area that truly had no access to care. Not a single patient in the 400+ that were seen had an existing filling or history of dental treatment aside from extractions. Sadly, we found that many patients were missing more teeth than had teeth, which was heartbreaking. Tell us about some of the specific procedures you performed there.

The procedures we perform there include oral hygiene instruction, sealants, regular cleanings and deep cleanings, fluoride varnish, composite fillings, root canals on front and back teeth, baby teeth root canals, stainless steel crowns, and extractions. We completed all of these procedures with pre-op radiographs as well as post-op radiographs. Each patient is required to receive a cleaning with us as well as an area of need in their mouth for either restorative, endodontic or oral surgery treatment.

### What kind of dental issues did you see there that you don't see in the U.S.?

The dental issues there are different than in the U.S. mainly because of lack of access to dental care and lack of information. One of the biggest issues that we encountered there that we don't see as often in the U.S. was young adults and children, as young as 14 years old, who had already lost several, if not all,

of their front teeth.

### What did you personally find most fulfilling about the trip?

The most fulfilling and also humbling thing about DHOP and this trip was that we were most of the patients' first dentists and basically their first ever dental experience. To be able to change people's lives in this way is indescribable and equally as life-changing for us as dental professionals. DHOP's purpose is to provide quality dentistry to a community in need but it's other main goal is to teach dental students high quality dentistry in some of the most remote communities in the world. By doing this, we hope they take this passion that they develop on these service trips and in turn apply this passion to their dental careers and future patients. We make sure to bring the top dental materials, radiology equipment, autoclave sterilizers and the best faculty in order to provide the patients the best care they deserve. This way, dental students are seeing that no matter the location or community, they must never give less than their best when it comes to treating their patients, whether their patients live in Beverly Hills or Malabon.

### Does the university finance the trip or do students pay?

The program is a student run program with guidance all year by two faculty advisors. This year, the group included 51 students, 10 USC-credentialed faculty and three staff members. Students pay for direct costs (flight / housing / food) and we fundraise and accept donations for the clinic costs. The DHOP student board fundraises each year for the dental supplies and some equipment rentals. They must fundraise about \$30k while each faculty and student pays between \$2000-2500 for their individual trips. So we invest about \$30k while providing over \$200k in free dental services to the community of Malabon. USC helps us tremendously with the equipment and many dental supplies while providing resources for fundraising and supply donations.

### Where does the group plan to go next year?

The new DHOP board collectively decides where to go and the location is released every September.
