

# Response to Rosenstein Letter [Issue #1059]

The Human Services Division of the City of Beverly Hills applauds your passion in creating an important dialogue around the issue of homelessness. Most Beverly Hills residents and Angelenos would agree with you, that the current homelessness epidemic has reached crisis levels. The effects of homelessness can be felt throughout the 481 cities within California, so much so that Governor Newsom recently issued an executive order making homelessness a priority issue. The solution to our homeless crisis will be a coordinated effort that includes our city, county, and state leadership working together. However, what the City of Beverly

Hills can do, in this moment, is to continue to be responsive and compassionate towards people who are experiencing homelessness in our community.

The Beverly Hills Human Services Department has created strategic partnerships with key agencies including People Assisting the Homeless (PATH), Step Up on Second, and the Saban Community Clinic. We work to ensure that every person experiencing homelessness comes in contact with our outreach team and is offered referrals for shelter services, showering facilities, medical and mental health care, and assistance with transportation.

When a member of our community sees someone experiencing homelessness, we ask they act with kindness and give us call. Please pick up the phone and contact our Beverly Hills Outreach Team at (310) 487-0313. We are available Monday – Friday 8:00AM - 5:00PM. In the business triangle, the BH ambassadors can be contacted seven days a week 24 hours a day at (424) 302-1487. Our ambassadors can ensure appropriate linkage to outreach homeless services. In our 15 parks, Beverly Hills Park Rangers patrolling the area, can also provide linkage to the appropriate services.

Homelessness is an issue we must solve together and the City remains committed to continuing the important work to do so.

# Planning Approves CUP, Historic Incentive Permit at Former Gibraltar Building

The Planning Commission unanimously approved on January 23 a Conditional Use Permit and Historic Incentive Permit at the former Gibraltar Square bank tower.

The approved project will allow applicant Arman Gabay to establish a 154-

room hotel at the current 10-story office, located on 9111 Wilshire Boulevard, situ-ated between Oakhurst and Doheny. The site is currently 43,741 square feet.

It also includes the adjacent former Kate Mantillini restaurant and a five-story parking garage containing 138 parking spaces.

Under the new CUP, project applicant Arman Gabay of Oakshire has received approval for modified vehicle loading spaces and the use of an off-site parking garage located at 140 South Doheny Drive for an additional 31 parking spaces.

Under the Historic Incentive Permit, Gabay is permitted to deviate from the City's Municipal Code requirements for

ground floor street frontage, capacity other uses within a hotel, residential adjacency for hotel uses, hotel access area, maximum height and a solid masonry wall.

The site has been formally designated as a historic resource on the City's Local Register of Historic Properties.

One neighbor, however, repeatedly expressed opposition of the project several times over the past few months, cit-

ing potential noise impacts, traffic congestion and safety concerns.

The Commission, as a result, has worked with staff on mitigating these issues to the best of their ability.

Commissioner Andy Licht said last week that because this a remodeling project, most of the work will take place inside the building. The commissioners collectively agreed that the project wouldn't cause a "substantial adverse impact," adding that the impacts would be far worse if a new building was being constructed next-door.

"I think this is a great project. We're taking an existing building that's a landmark designated property, we're improving it and bringing it up to standards, [and] it will vitalize the area," said Licht.

#### L'Ermitage to Extend Hours

The Planning Commission has opted to conditionally approve a request by the Viceroy L'Ermitage Hotel to renew a Conditional Use Permit, Development Plan Review, and Extended Hours Permit.

The approval passed in a 3-2 vote with Commissioners Lori Greene Gordon and Peter Ostroff dissenting, and includes conditions such as altering timeframes to events concluding at 10:00 p.m. instead

of 9:00 p.m., and returning valet-parked vehicles to patrons in the parking garage rather than Burton Way.

It allows for entitlements for the continued operation of the hotel's restaurant that is open to the public within a legally non-conforming hotel located in the R-4, Multiple Family Residential Zone; the continued operation of open air dining associated with the hotel restaurant located within a courtyard that would be served by existing parking

supply and valet operations; and the continued use of the rooftop area with live entertainment.

Gordon stated that while she voted against the project as a whole, she did support the renewal of a Conditional Use Permit. Ostroff said he voted against the entirety of the request, citing the "completely improper delegation of responsibilities" to staff respecting interpretations

of the resolution.

Submitted by L'Ermitage representative Jonathan Riker, the request originally garnered concern from community members regarding excessive noise related to rooftop events, parking and loading vehicles in unpermitted areas, and trash and debris



that may have been generated from hotel and restaurant patrons across the street from the hotel, along Burton Way.

Ultimately, based on police department incident reports and calls for service related to the hotel, the commission did not approve the request to amend rooftop hours to 10:00 p.m. after failing to reach an agreement with the hotel on the additional condition "without further assessing potential liability concerns with their legal counsel."

They instead voted to continue the item to last Thursday to allow for hotel representatives the time necessary to "evaluate the feasibility" of the potential condition.

On Thursday the L'Ermitage representatives indicated that they are amenable to including a condition that requires the pick-up of trash and debris generated by the hotel on the south side of Burton Way, between Foothill Road and North Maple Drive.

Specifically, the amenable section to the existing condition says that staff "shall walk the north side of Burton Way between Foothill Road and Maple Drive once each day and collect and dispose of any trash or debris that may be present on the sidewalk or parkway that was generated by hotel operations."

But at the meeting Commissioner Peter Ostroff raised concerns of past situations where staff has interpreted the commission's final resolutions differently than the commission intended.

This misinterpretation, he said, has the potential to result in staff issuing permits and authorizing final actions that should have been ran by the commission beforehand.

"If there are issues about interpretation of our resolution, the staff, in my view, cannot properly be the final arbiter of that," said Ostroff. "As a matter of practice, we need to be the ones that decide what our resolutions mean."

Ostroff advocated for the addition of a sentence stating, "In the event of a dispute respecting the interpretation of this resolution, that dispute should be resolved by the Planning Commission."

The final approval is appealable to the City Council within a 14-day period.

census tracts covering the entire City. This year, a total of 17 homeless individuals and 1 recreational vehicle were counted by volunteers. This is very similar compared to last year's count of 16 individuals, one recreational vehicle and one car.

Every day, about 130 individuals come out of homelessness, while another 150 fall into homelessness. The 2019 Homeless Count found a 12% increase in homelessness in Los

Angeles County from 52,765 to 58,966 individuals, and a 19% increase from 4,401 to 5,223 individuals experiencing homelessness on the Westside of Los Angeles. While homeless count numbers have continued to rise throughout LA County each year, Beverly Hills homeless count numbers have continued to remain steady. "We attribute this to innovative collaborations and partnerships," said Rachel Evans, Human Services Clinical Program Coordinator.

"The City's Human Services Division works with the Chronic Homeless Assistance Team (CHAT), comprised of the City's Police and Fire departments and the City Prosecutor, to coordinate services and concentrate resources on the most severely ill homeless individuals who suffer from mental health, physical health and/or substance abuse.

In addition, the City's homeless outreach team focuses on intensive case management. The City holds monthly Homeless Collaboration meetings with community stakeholders including faith-based organizations in the City, the Beverly Hills Homeless Outreach Team, Beverly Hills Public Library staff, City parking staff, Park Rangers, the Beverly Hills Ambassadors Team, and other community organizations to coordinate homeless service efforts," says Evans.

In addition to the annual count, Human Services, CLASP, the Police Department, Park Rangers and the Ambassadors provide regular reports on homeless individuals in the City's parks, parking structures, resident areas and business district to keep a pulse on homelessness throughout the year.

The City of Beverly Hills began participating in the LAHSA's official count since 2009, when 42 homeless individuals were recorded. LAHSA's three-night, street-counting effort consisted of 168 deployment sites and over 8,000 volunteers. Count numbers are reported by the Department of Housing and Urban Development (HUD), and directly influence federal funding directed to Los Angeles County.

For this event, the dance troupe presents the world premieres of To Lula with Love created for the occasion by celebrated choreographer Christopher Huggins, a former member of the Alvin Ailey American Dance Theatre and an alum of Lula Washington Dance Theatre, and Hands Up: A Testimony by company alumnus Tommie Waheed Evans, who received a 2019 Princess Grace Foundation Honorarium Grant to create the work, which focuses on his experience growing up in

# The City of Beverly Hills Sues Los Angeles County Over a Ballot Design They Say is Confusing

# By Olivia Anderson

An ongoing dispute between Los Angeles County and Beverly Hills has led to the City filing a lawsuit regarding a new electronic voting system.

At taxpayers' expense, the lawsuit was filed in LA County Superior Court last Thursday over trepidation pertaining to the county's new VSAP (Voting Solutions for All People) touchscreen system.

As it stands, only four of five candidates will appear on the first screen of the ballot-marking device for in-person voters. To view additional candidates, the voter must select the "MORE" button. If the voter instead presses the "NEXT" button, however, they will not see all the candidates in that particular race.

In the City's case, incumbent Julian Gold is the only candidate set to appear on page two, which many have called unfair and potentially detrimental to his campaign.

During a television interview for Beverly Hills View on Friday, Gold indicated that other cities are facing a similar issue.

For instance, five candidates running for the Mayor of Whittier has lead to incumbent Mayor Joe Vinatieri being placed on the second page.

In the same television appearance, candidate Lori Greene Gordon claims she identified this problem back in September at a practice voting center, before the total number of candidates was de-

"I saw immediately that there were four positions, and you had to push a button that said "MORE," said Gordon. "I informed as many people as I could [that] this is a potential problem. I literally felt like I was talking to ears that didn't want to listen to me. Nobody cared."

City Attorney Larry Wiener said the Council is "deeply troubled" that voters will be disenfranchised by the new sys-

"All candidates should be presented

in an equitable and. transparent way to the voters. As the system is currently designed, a voter may not realize they are bypassing additional candidates. We believe this issue can be easily resolved."

According to City Clerk Huma Ahmed, the City has attempted negotiations with LA County. They have requested that the "NEXT" button be grayed out until the voter has moved to the last page of that individual race and viewed all the candidates, and also that the instructions be included on the first screen indicating there may

be additional candidates than the first four names listed and to select "MORE" to view all choices.

The lawsuit is a response not only claiming that the system is "unfair," but also in frustration of LA County's unwillingness to reach an agreement. Councilmembers Lili Bosse and Julian Gold recused themselves due to their

> appearance on the ballot, so the lawsuit was authorized by the other three councilmembers.

But some election law experts are skeptical about the City's odds of emerging victorious.

"I think the timing of this lawsuit would make it difficult for the City to prevail at this point," said Stephen Kaufman, an election attorney who is not representing either party. 

Since Propositions 60, 90, and 110 passed, the State of California allows for the transfer of a property's base year value from an existing residence to a replacement residence, under certain conditions, for qualified persons over the age of 55 or older or persons of any age who are severely and permanently disabled.
