

“City Council Election”

We are very concerned about a misleading flyer which was recently circulated city-wide by a PAC (political action committee) named “Beverly Hills United to Support Bosse and Gold for Council 2020”. Much like Citizens United, a PAC can be utilized to circumvent campaign donation limits while advancing the interests of a candidate. In Beverly Hills, city council campaign donations are limited to \$125 per contributor if more than \$80,000 is spent by the campaign, and \$450 per contributor if the \$80,000 campaign spending limit is observed.

The flyer included the Beverly Hills shield as if the flyer had been sent by the City of Beverly Hills, which is not only misleading but it violates common law and federal trademark laws. Additionally, the flyer provided voting instructions as if they were instructions from the City; and it included photos which suggested that John Mirisch, the Mayor of Beverly Hills, endorses both Bosse and Gold, which is inaccurate. The real question is why the re-election

of two nine-year incumbents is so important to big money people that they would engage in deceptive practices to assure their goal, and we are concerned about the resulting unfair damage to the campaigns of other worthy city council candidates.

The attorneys who represent Beverly Hills United to Support Bosse and Gold for Council 2020 was questioned about our concerns. Without any explanation he wrote:

“The mailer meets the applicable legal requirements, and the Committee has filed publicly available reports with the City Clerk detailing contributors and expenditures.” He also provided those reports showing the following contributors and contributions totaling \$85,998 so far.

Dominium Management Corporation, 9629 Brighton Way, Beverly Hills, donated \$9,500.

Duesenberg Investment Company, LLC, at 1800 Avenue of the Stars, Suite 1400, Los Angeles, 90067, donated \$9,500.

Gearys Beverly Hills, 351 N. Beverly Dr., Beverly Hills, donated \$9,000.

Steven Gordon, 9990 Santa Monica Boulevard, Beverly Hills, donated \$9,500.

KMJ DE LLC, 100 Wilshire Boulevard, Suite 1600, Santa Monica, donated \$9,500.

Stephan Massman, 361 N. Canon Dr., Beverly Hills, in property management, donated \$9,999.

Outsourcing Management Concepts, Inc., 240 N. Beverly Dr., Ste. 300, Beverly Hills, donated \$5,000.

S & A Realty Corp., 9350 Wilshire Blvd., Beverly Hills, donated \$9,999.00.

Barbara Sanborn, 1233 Mission Viejo Rd., Santa Barbara, an architect, donated \$9,500.

Walter M. Marks, Inc., 8758 Venice Blvd., Ste. 100, Los Angeles, donated \$4,500.

In addition to these contributors donating thousands of dollars more than it is legal to donate to a candidate, some of the contributors do not even appear to be based in Beverly Hills.

Again, we wonder why the re-election of two nine-year incumbents is so important to these people, that they would sponsor a misleading flyer and donate so much more than the amount a candidate is allowed to accept?

We hope our fellow residents will share our concerns.

Candidates Exchange Barbs at Municipal League Candidate Forum

In a two-hour forum hosted by the Municipal League of Beverly Hills last week, City Council candidates debated—sometimes heatedly—a wide array of issues from traffic to parks to air quality.

All six candidates, one of which qualified as a write-in candidate that morning, shared their individual visions for the City and took questions from the moderators, the audience, as well as each other.

At one point, candidate Robin Rowe questioned incumbent Lili Bosse on her “Walk with the Mayor” event, intended to improve the City’s “BH Healthy City” initiative.

“I’ve done Walk with the Mayor many times with you, and it doesn’t seem that healthy to me,” said Rowe. “I’m worried about the air pollution; some of the neighborhoods we walk through have twice the amount of air pollution as other neighborhoods, and I’ve never heard you [say] that the air we’re breathing as we’re on the walk is not that great.”

Rowe proceeded to ask Bosse what explicitly she would do about fixing the air if she were to be elected. Bosse declined to answer the question as she did not have a specific answer.

The issue of traffic also made an appearance at the February 3 meeting, with incumbents discussing how to make the City more “walkable.”

Incumbent Julian Gold stated that a great deal of traffic comes from Los Angeles and improvements might lie in the advent of autonomous vehicles for mass transit and an emphasis on speeding enforcement.

The election will take place on March 3.

Council Undecided on Additional Sales Tax

At their February 4 Study Session the City Council discussed Measure X, which will appear on the March 3 ballot for the City of Torrance.

If approved by voters, Measure X would authorize a ¾ cent sales tax in Torrance. It would only be levied if a district sales tax

measure has qualified for a ballot and may continue to be imposed only if that district measure receives voter approval.

The Council debated the pros and cons of following Torrance’s lead and placing such a tax on the ballot. They considered potentially lifting the cap and how to avoid a “free rider” situation.

The legal maximum in California for sales tax is 10.25 percent. Because Torrance’s current sales tax is 9.5 percent, .75 cents is the maximum sales tax that could potentially be imposed.

The goal of Measure X is not necessarily to increase the sales tax in Torrance, reads the staff report, as much as it is to block other government agencies from being able to implement a new sales tax.

Councilmember Robert Wunderlich said that although the tax has “obvious appeal,” he also believes it raises significant concerns about government.

“In my view, this is not a model for good government. There are some things that are best handled on a local scale; there are some things that are best handled on a regional scale. Some things are fundamentally regional problems [like] transportation, fire prevention and homelessness,” said Wunderlich.

He asserted that anything that doesn’t know the artificial boundaries of municipalities are more regional issues than municipal issues, and that this type of tax “runs counter to that.”

Recently, several other cities in Los Angeles County have passed ballot measures to increase the sales taxes collected in their jurisdiction to 10.25 percent. These

include Culver City, Santa Monica, Pasadena, Glendale, Burbank and Pomona.

Ultimately, the Council directed staff to request more information from the City of El Segundo, which implemented a similar tax recently that passed by 85 percent. They also agreed to re-agendize the item after Torrance’s election, and to engage with the community and voters to measure interest in the tax.

“Before we even put it on the ballot for the voters, we need to have a lot more participation from the community and I think we ourselves need more information,” said Councilmember Lili Bosse.

City Council Approves Friars Club Site EIR

In a three-hour discussion last Tuesday, the City Council approved several modifications to the former Friars Club site.

The Council voted unanimously to approve a development agreement between the City and the 9908 South Santa Monica Boulevard LLC for the project. They also voted 4-1, with Mayor John Mirisch dissenting, to certify the Final Environmental Impact Report and approve an ordinance amending the Municipal Code.

In both resolutions, the Council opted to change the approved 41 parking spaces to 54 parking spaces.

The approval follows the City Council’s direction at their January 8 meeting for the applicant to discuss various concerns raised by the Peninsula Hotel—which is located across the street from the site—with the hotel before returning to the

After doing so, the applicant returned with certain rooftop design changes they indicated are responsive to the concerns raised by the Peninsula Hotel. This includes adding landscape buffers and the reconfiguration of roof deck space to reduce the ability for large groups to congregate on the eastern side of the rooftop.

But the Peninsula Hotel requested the Council delay adopting the CEQA (California Environmental Quality Act) resolution, which would introduce an ordinance regarding the development agreement and zoning ordinance, since it doesn't take effect for another two weeks.

Developer Cliff Goldstein expressed frustration in the delay request, highlighting that Peninsula Hotel owner Robert Zarnegin has not called him in four years and remains rigidly against negotiating a compromise.

In 2004 and early 2005, Zarnegin spent millions to defeat potential competition from the Montage Hotel. Beverly Hills voters in March, 2005 approved a referendum which led to the new hotel being built.

"The Peninsula is asking to delay this again and again. We've created a development agreement, we've negotiated with

the City, I don't know what resolution is if [Zarnegin] decided that he's just decided 'no,'" said Goldstein. "We have accepted all of [the changes] so we would very much appreciate that we move forward."

The Council opted to delay the CEQA resolution and continue the item on February 18 after the Peninsula Hotel has commented on the condition.

Arts and Culture Studies Art Walk

The Beverly Hills Art and Culture Commission selected art pieces Tuesday to be included in an upcoming Beverly Hills art walk event.

The art walk is an event the commission has been working on since 2019, and will be a walking tour of several art pieces in the city. Commission members voted to finalize which art pieces to include in the brochure that will serve as a guide for the event.

There were 75 pieces on the agenda for approval from the commission, 52 of which were chosen to be a part of the tour. Pieces were mainly rejected for having a lack of walkability, such as "Statue of An Official" which was inside a lobby.

Commissioner Zale Richard Rubins said that approving these art pieces was an important first step toward finalizing this project and that the commission must start laying out how the art walk will be structured next. He said that this will likely be decided before its next meeting.

"We'll approve the tours next month and try to divide it into thirds so it works for people," he said.

He added that the budget for the event hasn't been finalized yet, but once it is that they'll be able to determine details like including an app describing the tour.

Traffic and Parking OKs South Crescent Parking Permit Modification

The Traffic and Parking Commission voted last Thursday in favor of modifying a preferential parking permit regulation on South Crescent Drive so only residents could park in the area.

Residents had created a petition to change the 200 block of South Crescent Drive between Charleville and Gregory Way from allowing one hour parking to no parking at any time, unless they live

on the street. This was due to complaints of traffic, safety and lack of parking in the area.

The commission voted 3-1-1, with Commissioner Chair Jay Solnit abstaining from a vote. The issue will be brought forward to the City Council next to determine if it will be approved.

Community members brought forth many issues to the commission during the meeting. Several complained about having their driveways blocked during events at Beverly Vista down the street. Others complained about employees from businesses on Beverly Drive parking in the area all day while they are at work. Several residents complained that traffic on the street makes it difficult to navigate.

Solnit said that he had concerns with whether approving the petition would actually solve the issues residents complained about.

"If we start standardizing all these streets, we are going to start strangling parking for the businesses on Beverly Drive – there's no doubt," he said. He added that he understands residents' complaints and sympathizes with their problems.

Vice Chair Jake Manaster said that he believes the best solution to the problem would be for districts to be in charge of parking regulations, rather than the city.

"We are the only city in the county that handles this on a street by street basis, it is absolutely absurd. We have 72 or I believe now 74 streets with different enforcement zones," he said. "That's difficult for any police officer to enforce. Until that changes, we will continue to have these problems."

READY FOR TAKEOFF

Recreation and Parks Commission Chair Julian Javor on Park Signage, Intramural Sports, and Pet Pilots

You've recently been installed as the new Recreation and Parks Commission Chair. What initially made you want to serve on the commission?

I've lived in Beverly Hills since I was eight years old. I've seen the good, the bad and the ugly when it comes to local government and policy. I didn't ever think I would get involved in it, but I did Team Beverly Hills when I was 23, and I really was impressed by how much goes into building and maintaining a community. Once that happened, my attitude toward the whole subject of local government changed and I actually thought, "Wow, I should do my part and get involved."

But I didn't want to get involved in controversial subjects; I didn't want to get into the politics. I wanted to be involved in something I could make a difference with, so I'd been slowly joining things left and right and whatnot, but at age 24 an opening showed up on the Recreation and Parks Commission and I thought, "You know what? I'm young, I probably won't get it, but I'll apply anyways." And I got a call that I had received it.

You're one of the youngest commissioners. What initially sparked your interest in city government as a young person?

Honestly, attending Planning Commission meetings and City Council meetings my entire life I just felt I had a foundation in it. It was really the fact that the Recreation and Parks opening occurred that initially encouraged me to apply and get involved. I think it was the perfect commission for my foray into local government.

What are some of your top priorities as chair?

That's an interesting question. Recreation and Parks has a fairly limited scope. Even with that limited scope, we're just an advisory body. So, pursuing any sort of dream or desire has to be cleared with City Council first. But for me, when I first joined something I thought was really cool was the adult sport league and nar-

rowing the focus of an adult sport league and creating a young adult sport league [for] people who are in their twenties or early thirties. I thought it would be really cool if we could actually have our local brother and sister communities like West Hollywood and Culver City create a young adult intramural sports league

and play against other cities. I haven't really looked into creating it just yet, [but] I thought that would be really cool.

Another big thing for me is that I think there should be a more elegant signage convention throughout all the parks. We just put a massive investment into the Beverly Gardens park and I would like to work with the Cul-

tural Heritage Commission to make a virtual tour throughout the park where there are QR signs in every park that show you old pictures of what that block used to look like, what kinds of things used to happen there, and how that land became dedicated to the City.

I also would like to address the condition of the dog park. Obviously it's up to the discretion of the City Council, but I think that because of the lack of shade in the park and because of the surface of the park, it is underutilized. It might cost more to maintain a grass park, but if that means the park gets way more utilization, I don't know that there's a greater cost in having underutilized land, given that land value is so high right now, so it's something to look at.

The La Cienega Park rehabilitation is slated to cost over \$100 million. What are some of your concerns on the project?

As a Recreation and Parks Commissioner, what's important to me is that the uses that are currently there are maintained. The design aspect of it doesn't really fall into our purview, the costs are certainly not part of our consideration—although I'm sure it is a Community Services Capital Improvement project item—but what really matters to our commission is that the services that are currently offered will stay. This includes

a lot of little league and things of that nature.

What advice did outgoing Chair Alissa Roston give you?

Alissa was amazing. Alissa actually had me in on all the agenda planning meetings, which really showed me what it meant to be chair, how to be on top of everything, how to manage the collective interests of the commission, and guiding staff to the best way they could possibly help us. She was also really good about directing all questions the commission had about their packet to the chair and staff prior to the meeting so they'd have ample time to prepare for that question. Additionally, how to manage deliberation and how to make sure every commissioner gets the opportunity to say what's on their mind and speak their concerns, and the chair goes last—she really did an amazing job with that. So if I can be as good a chair as Alissa was, I would be thrilled.

You're a pilot as well as the founder of "Pet Rescue Pilots." Tell us about that.

I've been flying pets since I received my commercial license in September, 2017. It's been a developing passion of mine. When I got my commercial license I had to find a way to use that skill in a positive way, because I was never going to be the type of pilot that just enjoyed flying halfway up the coast to go get a burger, and coming home. I'm so passionate about aviation and I needed to fly, so I was looking for ways to use that skill positively. This niche happens to be the marriage of two of my passions: animal rescue and flying. It's been such a learning process for me, but over the course of the two years I flew until basically last summer, I just was looking at all the rescues I work with, how hard they work, and how all of their work is almost, in a sense, meaningless for the entire world. Of course it means everything to the particular dogs that we got out of the shelter, but those dogs were immediately replaced by more dogs. So I realized that rescues are too close to trees to see the forest, and I thought that by leveraging the fact that flying and animals and whatnot is cool and seems to generate quite a buzz on Instagram, I might be able to generate more of an impact if I create this organization and operate it as such. Since then, pilots have

been messaging me asking how they become a Pet Rescue Pilot and things like that. As of November, 2019 I was incorporated as a non-profit. The IRS has my application and we're expecting a response within 50 to 90 days from now to get our final letter, but we suspect that even if they have some changes to make, we will get that final letter.

It's exciting, and the reality is that while transportation is still going to be a big part of what I do, ultimately what I really want to do is education. I want to get into schools, I want to talk about my story, I want to give a presentation where I can come in and say, "Hey, I'm a pilot. I was

in your shoes not too long ago, and as a generation you guys need to step up and make sure that today's problem is not tomorrow's problem."

Tell us about your family.

My mom [Kathy] grew up in Beverly Hills her entire life and only lived outside the city for a short while. We've been here forever, really. My grandfather owns property here and I help manage them, and we really consider ourselves Beverly Hills lifers. My grandparents [George and Erika Kobor] moved here in the late 1960's, my mom grew up here and I grew up here, so we're really just a Beverly Hills family.

What is something you hope to have accomplished one year from now?

I would like the parks of Beverly Hills to become something that people think about when Beverly Hills is talked about. Because honestly, the parks are the community. They're community meeting spots, they're community leisure and recreation spots, and I think parks are really important. We have a lot more parks than our neighboring cities do. I'd like to see improved enrollment in the City's programming, or perhaps improved awareness. A lot of people don't realize how many services the Community Services Department provides. I'd also like to see more collaboration between commissions that overlap; we should probably have more of a liaison experience with the Public Works Commission, the Cultural Heritage Commission and the Cultural Arts Commission. I think that having a meeting every two months between each of the commissions just as a quick catch-up, a brainstorming session, would be really helpful.

WHO WILL WIN THE COUNCIL RACE?

Our Election Editorial

Incumbents Lili Bosse and Julian Gold have served with distinction. With the exception of the Draconian farce known as the Rent Stabilization Ordinance, and the ongoing/unending/largely self-inflicted travails of Police Chief Sandra Spagnoli, there have been relatively few bloopers or scandals over their nine years in office.

The venerable City Manager George Chavez is well-respected, and enjoyed a smooth transition from retiring City Manager Mahdi Aluzri. City Clerk Huma Ahmed, despite being a first time City Clerk, has garnered praise for grace under the pressure of a lawsuit with the County over voting equipment (see discussion below). City Attorney Larry Wiener has tremendous integrity, and is a steadying hand over several decades in office. Public Information Manager Keith Sterling, who has an extensive background in broadcast news, has markedly increased the visibility of the Council on television. Most, but not all, of the department heads are highly regarded.

If one believes the city is being well-run, then voters should re-elect the incumbents. If one believes change is needed, they should vote for the top challenger, Planning Commissioner Lori Greene Gordon.

Historically, the Weekly has always supported a two-term term limit for the City Council and Board of Education. The reason for this is clear: we are con-

cerned about a situation where we become like the City of West Hollywood, in which one city councilmember has served for over 35 years, and the other councilmembers rarely turn over. We believe new ideas and perspectives are healthy, and vital to a civic democracy. If we lose regular turnover on the council, we are appointing monarchs, which we see in many other small cities throughout the state. A council that never changes concerns us greatly.

JULIAN GOLD

Councilmember Julian Gold surprised some when he announced his intention to seek a third term, after initially telling supporters he would only seek two terms (and the 2015 election was cancelled due to a lack of candidates). His campaign has attempted to make the best of a bad situation when the random alphabetical draw placed him as the fifth candidate of five, on page two of the ballot (see our cover story “Ballot Battle” in Issue #1061, for a lengthier discussion of the issue).

The problem with the City’s unsuccessful (at least so far) attempt to change the voting equipment is two-fold: on the one hand, yes, it’s very unfair that Julian is the only candidate on the second page. On the other hand, it smacks of fellow incumbent protection when three Councilmembers (Mirisch, Friedman, Wunderlich) voted in closed session for taxpayers (and not Julian’s campaign)

to pay for said lawsuit challenging the county. Had Rabbi Simchah Green been the fifth candidate on the ballot, does anybody really think the City would have sued?

LILI BOSSE

Councilmember Lili Bosse will be re-elected regardless. She has run an aggressive campaign and has been endorsed by most of the major stakeholders. We maintain, however, that Lili is better suited for a higher office, such as the ultra-powerful County Board of Supervisors, where Sheila Kuehl will reportedly not seek re-election in 2022. Lili would be an ideal candidate for the 3rd district seat, representing two million people, for many reasons. One is her experience in local government; the other, her ability to self-finance a campaign, which means she would not be beholden to public employee unions, who at least in recent years have called the shots when it comes to county/state government. (In a final stroke of irony, Kuehl reportedly pulled her endorsement of both incumbents after the ballot lawsuit was filed, even though both of them rightly recused themselves from the vote to sue!)

LORI GREENE GORDON

Planning Commissioner Lori Greene Gordon is the leading challenger, and has run an energetic campaign for council. She announced her intention to run early (last summer), her supporters are dedicated, and have knocked on almost every door. On the commission, Lori has accrued a largely slow-growth record, which is more or less where a majority of the community stands these days (but a world away from the Council we covered when the Weekly was founded in 1999). When fellow Planning Commissioner Joe Shooshani unexpectedly dropped out of the race, it probably hurt Lori, because two strong challengers would have given the incumbents a much tougher race.

Lori definitely has the momentum in the closing weeks of the campaign—but will it be enough to knock off an incumbent?

Please take notice that on **Thursday, February 18, 2020, at 7 p.m.**, or as soon thereafter as the matter may be heard, in the Council Chamber of City Hall, 455 N. Rexford Drive,

Beverly Hills, CA 90210, the Council of the City of Beverly Hills will consider adopting an ordinance entitled "AN ORDINANCE OF THE CITY OF BEVERLY HILLS APPROVING A DEVELOPMENT AGREEMENT BETWEEN THE CITY OF BEVERLY HILLS AND 9908 SANTA MONICA BLVD., LLC, FOR DEVELOPMENT AND USE OF THE PROPERTIES AT 9908 SOUTH SANTA MONICA BOULEVARD FOR A MIXED USE PROJECT INCLUDING RESIDENTIAL CONDOMINIUMS AND COMMERCIAL RETAIL USE." A summary of that Ordinance, prepared in accordance with the requirements of Government Code Section 36933, is as follows:

This Ordinance approving a development agreement is associated with a 25-unit, four-story residential and commercial mixed-use Project located at 9908 South Santa Monica Boulevard. The Project requires the approval of various City entitlements, including: a Final EIR for the Project; a resolution approving a general plan amendment; an ordinance approving a zone text amendment and zone change; and a resolution approving a planned development and vesting tentative tract map for the Project.

The Development Agreement eliminates uncertainty in planning and provides for the orderly development of the Project in a manner consistent with the City's Official Zoning Regulations and the City's General Plan. The agreement provides assurance to the Developer that the Project can proceed with the uses, density and other land use characteristics specified in the Project approvals. The City has determined that substantial benefit to the Public will accrue as a result of the development of the Project, including without limitation, the provision of additional housing in the area, the development of a mixed-use retail and residential project on currently vacant land, revitalization of an area of the City with new retail uses and luxury housing, and a monetary contribution to the City.

The Development Agreement includes the following terms:

- The requirement that the Developer pay the City a Public Benefit Contribution Fee of \$5 million dollars. \$1 million dollars shall be paid within 10 days of the effective date of the agreement or within 10 days of any tolling

period related to any challenges to the Project's approvals or the Project EIR. \$1.5 million dollars shall be paid at the earlier of: 30 days after the issuance of a Building Permit or 36 months after the first payment. \$2.5 million dollars shall be paid prior to issuance of the first Certificate of Occupancy for the Project.

- An Environmental Mitigation and Sustainability (EMS) Fee is required to be paid concurrent with the close of each sales transaction associated with the Project. This EMS fee is required for the life of the Project. The EMS fee for the first sales transaction(s) is 2% of the sales transaction amount. A 3% EMS fee is applicable to any subsequent sales transactions.

- The Development Agreement has a 5 year term. The Developer has the option of exercising up to 2 one-year extensions. The Developer must pay a \$500,000 extension fee to exercise the first extension and a \$1 million dollar extension fee to exercise the second extension.

- Public Parking Obligation. The Developer is required to provide 54 parking spaces at their project site to the public. The maximum charge for this public parking cannot exceed the rate charged at nearby City parking facilities.

The Project, including the Development Agreement, has been assessed in accordance with the authority and criteria contained in the California Environmental Quality Act (CEQA), the State CEQA Guidelines, and the environmental regulations of the City. A Final Environmental Impact Report (Final EIR) was prepared to analyze the potential environmental impacts of the Project. On February 4, 2020, the City Council reviewed the Final EIR and, by resolution, certified the EIR and adopted a Mitigation Monitoring and Reporting Program.
