




## T&P Suggests Coldwater Canyon Drive Changes

The commute to Beverly Hills on Coldwater Canyon Drive might get longer for drivers but safer for residents, after the Traffic and Parking Commission considered changes to the street last Thursday.

The Public Works department is replacing a water line on the street in 2021, which will result in major reconstruction. The Commission examined how that allows the city to reconstruct the street to deter traffic and safety issues in the future, as well as experiment with ways to do so in the interim.

Residents from around Coldwater Canyon Drive, including Planning Commissioner Peter Ostroff, previously met with city staff to suggest increasing street parking and removing the center lane in order to address concerns about traffic, speeding cars and car accidents in the area. Staffers later had an evaluation conducted into how to address these concerns effectively and added the issue as an agenda item to the Commission's meeting last Thursday.

Commissioners agreed with the staff's recommendation to add five delineators to deter people from passing lanes and add more if that's found to be effective. They also agreed for staff to test out the effectiveness of rumble strips, which are small bumps on the road that prevent speeding, for the first time in Beverly Hills.



Prospective changes to Coldwater Canyon Drive include adding delineators, reflective pavement markers and changing driving lane sizes.

Chair David Seidel said that if rumble strips are used on a regular basis, the noise would likely begin to annoy residents. He said that the best solution to him is installing a traffic signal that would manage people's downhill speed.

The Commission also recommended that city staff continue to look for other ways to increase safety on the street. Among other suggestions, staff will determine if closing the center lane on Coldwater Canyon Drive will prevent lane passing and if the city should add more street parking.

Commissioner Sharon Ignarro said her priority isn't convenience for drivers but that she wants to instill changes that would guarantee safety for residents. She said she supports the trial of delineators and wants to also look into speed lumps and traffic signals.

"In the short term, people may be unhappy but of course my thought of safety is always going to be number one," Ignarro said.

Ignarro added that she's in favor of right sizing the lanes to 10 feet. The staff report said that it didn't recommend narrowing lanes down past 12 inches.

The city will also refresh faded lane markings and paint yellow reflective pavement markers on Beverly Hills streets, including on Coldwater Canyon Drive. It will also increase signage, including speeding, parking and stopping restrictions. These plans are estimated to be completed by the end of summer.

Attorney Ronald Richards, president of the Beverly Hills Hillside Protection Association and who lives on a neighboring street, said the association is in favor of revisions to the speed of traffic flow.

"The current traffic process has endangered Hillside residents who live on Coldwater and who travel on Coldwater from the side streets," Richards said. "The City's attempt to tackle this problem is commended and hopefully will result in a safer environment instead of Coldwater being a mini 405 freeway."

About 0.9 miles of Coldwater Canyon Drive are within Beverly Hills. According to the staff report, roughly 24,000 cars take Coldwater Canyon Drive on weekdays. Many of these drivers are commuters from San Fernando Valley.

## Red Light Camera Issues Disproportionate Amount of Tickets, Expert Says

A red light camera at the Olympic Boulevard and Beverly Drive intersection is reportedly issuing a disproportionate amount of tickets to drivers.

According to Safer Streets Los Angeles, the intersection at Olympic Blvd and Beverly Dr is closely spaced to the intersection at Olympic Blvd and Beverwil Drive. The group said that this has resulted in about 15 \$500 tickets being issued to drivers everyday at the eastbound direction of the intersection.

Jay Beeber, Executive Director of Safer Streets LA, said that this issue is because of the closely spaced intersections and the

timing of its light changes.

"People don't have enough roadway in between those two intersections to stop so they have to keep going depending on where they were when the light changed initially," Beeber said. "Both of those intersections turn yellow and then red at the same time."

Beeber said that traffic light changes between intersections would usually be staggered, but because it isn't, drivers are forced to run the red when they get through the first intersection and can't stop at the second.

Beeber met with Mayor John Mirisch, Deputy Director of Transportation Aaron Kunz, Director of Community Development Susan Healy Keene and others in February to discuss fixing the red light camera issue. He said he made suggestions to stop the disproportionate amount of issued tickets, such as suspending tickets in the eastbound direction of the intersection and allotting a three second grace period after the light turns red.

Beeber said that the city initially agreed there are issues with the intersection's red light camera but later said that it won't be doing anything because its changing traffic light vendors and might remove the camera completely. Instead, Beeber said the city told him the police officer at the intersection will practice more discretion when issuing tickets.

BHPD Spokesperson Elisabeth Albanese said that since January 1st, the Photo

#### 03/02/2020 UPDATE TO NEIGHBORS OF THE NEW PROJECT LOCATED AT 9200 WILSHIRE BOULEVARD BETWEEN PALM DRIVE AND MAPLE DRIVE.

In order to maintain good communication with our neighbors, we will periodically issue updates to describe major milestones or changes that will be occurring at the jobsite. This is to notify you that in approximately two weeks we will begin installation of our tower crane. Your safety is extremely important to us, and at no time will you be exposed to any danger or safety hazard. The crane will be used for about twelve months to erect the concrete structure of the new building which consists of six above ground levels with three levels of below ground parking. Construction is expected to be completed in the fall of 2021.

Beginning at 7 P.M. on March 13th through 10 P.M. March 15th additional traffic control measures will be implemented along Wilshire Blvd. During this time period traffic control representatives will be directing traffic in the safest routes to maintain a consistent traffic pattern. ## Are Voters Tiring of School Bonds?

A measure that would have given \$15 billion in bonds to California schools failed to pass in the primary elections last Tuesday.

Proposition 13, also known as the School and College Facilities Bond, proposed distributing \$15 billion in bonds to fund school facility improvements throughout the state. As of Wednesday, the proposition has 45.9% votes in favor and 54.1% votes opposed.

In Beverly Hills, 1,995 people voted for the bill, while 1,892 people voted against it as of election day.

BHUSD Assistant Superintendent of Business Services Wade Roach said that BHUSD is disappointed that Prop 13 wasn't successful.

"Funds from this measure could have been used alongside our Measure E and

Measure BH funds to support and expand our much needed facility modernization projects," Roach said.

The initiative would have given \$9 billion to preschools and K-12 schools, \$4 billion for universities and \$2 billion for community colleges. According to its ballot summary, schools would have appropriated money from the General Fund to repay the bonds.

Proponents allege the distributed bonds would have gone toward improving school facilities' health and safety initiatives, such as disaster preparedness and removing lead from water. It would have also gone toward affordable student housing,

Of the \$9 billion that would have gone

to preschools and K-12 schools, \$5.2 billion would have been for modernization and \$2.8 billion would have been for new construction. \$500 million for charter schools and \$500 million for career technical education was also included

within that amount.

The opponents to the measure included Senator Brian Jones and the Howard Jarvis Taxpayers Association.

Jon Coupal, president of Howard Jarvis Taxpayers Association, wrote in the Daily Breeze that there are strict limits on how much bond debt local schools districts are allowed to carry but a hidden provision in Proposition 13 nearly doubles it.

"This means huge increases in property taxes are a near certainty. Who pays property taxes?" Coupal said. "We all do, either directly in property tax bills or through higher rents and other costs. Unlike the Proposition 13 from 1978, this Proposition

The proposed Ordinance would modify the Beverly Hills Municipal Code (BHMC) with respect to the regulation of trees on private property. The modifications include:

- Defining "Tree Species of Higher Flammability." This definition would include tree species that are considered to be undesirable in the VHFHSZ due to physical or chemical properties that could contribute to high flammability as defined in the fuel modification standards of the Beverly Hills Fire Department. At this time this includes the following trees: Juniper, Pine, Eucalyptus, Acacia, Cypress, Cedar, Palm & Fir.
- Establishing standards and procedures for removal of such trees through a ministerial action if located in the Very High Fire Hazard Severity Zone (VHFHSZ).

This Ordinance intends to align regulations in the zoning section of the BHMC with fuel modification standards set forth in California Fire Code (CFC) Chapter 49, California Code of Regulations Title 14, and the BHMC, and enforced by the Beverly Hills Fire Department.

This Ordinance and the Amendments were assessed in accordance with the authority and criteria contained in the California Environmental Quality Act (CEQA), the State CEQA Guidelines, and the environmental regulations of the City. Therefore, the Planning Commission will consider finding the Amendments exempt from further review under CEQA pursuant to Section 15304 (Class 4) of Title 14 of the California Code of Regulations because the Amendments will allow for ministerial removal of high-flammability trees on private property, which constitutes urban forest and fuel management activities to reduce the risk of wildfire, and will not result in the taking of endangered, rare, or threatened plant or animal species or significant erosion and sedimentation of surface waters.

Any interested person may attend the meeting and be heard or present written comments to the Commission. According to Government Code Section 65009, if you challenge the Commission's action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence delivered to the City, either at or prior to the public hearing.

On January 23, 2020, the Planning Commission adopted Resolution No. 1907, approving a Conditional Use Permit (CUP) and Historic Incentive Permit (HIP) to allow the adaptive reuse of an existing 10-story office building into a 154-room hotel, with restaurant and ancillary uses, at 9111 Wilshire Boulevard. In its approval, the Planning Commission recommended that the eastern half of the alley directly north of the project site be re-designated from a one-way west bound only operation to a two-way east-west bound operation. This would allow vehicles to exit the project site from the alley to the signalized intersection at North Doheny Drive, thereby limiting traffic onto North Oakhurst Drive and other local streets.

The Ordinance has been assessed in accordance with the authority and criteria contained in the California Environmental Quality Act (CEQA), the State CEQA Guidelines, and the environmental regulations of the City. The amendments will not have a significant environmental impact and are exempt from CEQA pursuant to Section 15305 of Title 14 of the California Code of Regulations because they represent minor alterations in land use limitations and do not result in any changes in land use or density. Further, it can be seen with certainty that there is no possibility that the amendments may have a significant effect on the environment. Accordingly, the City Council will consider the recommendation to find the Ordinance exempt from the environmental review requirements of CEQA pursuant to Section 15061(b)(3) and Section 15305 of Title 14 of the California Code of Regulations.

puts all taxpayers at risk of higher taxes.”

According to the Public Policy Institute of California, in 2018-2019 58% of funding for K-12 schools came from the state, 32% from property taxes and local sources and 9% from local government.

Proposition 13 was the only statewide measure on the 2020 primary election ballot.

Beverly Hills has had four local bond measures since 1993, most recently Measure BH in 2018. They total close to \$1 billion.

## Beverly Vista Will Begin Construction on New Orchestra Room

Beverly Vista Middle School will begin a \$100k re-construction project to change its choir room into an orchestra room.

The middle school is planning to change its existing choir room into an orchestra room because of reconfiguration at the school, which is estimated to cost \$109,508.06. The Beverly Hills Unified School District Board approved the project at its Tuesday night meeting.

The school will install new storage cabinets for instruments and clothing. It will

also add audience seating, a stage and a music library. The total cost of the project includes delivery, installation and new materials.


## Sculpture's Landscaping Will Get Makeover

The city will remove the landscaping that obstructs a sculpture in Beverly Gardens Park, after an Arts and Culture Commission meeting Tuesday.

The Arts and Culture Commission unanimously voted in its Tuesday morning meeting to change the landscaping that surrounds the sculpture *Sitting On A Short Bench* by Magdalena Abakanowicz. The current landscaping is overgrown and does not allow for the piece to be seen from all angles.

Vice Chair Carolyn Hiller read a letter from the Magdalena Abakanowicz Foundation in Warsaw, Poland in the meeting. The letter said that the sculpture should be presented in a way that benefits its social significance and historical value, which means that no elements that would disturb the piece's perception should be used in proximity to the work.

The landscaping surrounding the piece was first installed in 2015, after Former Mayor MeraLee Golman asked the city

to plant it for the art's protection. It was later taken out to remove a beehive in the ground.

In that same year, the donor of the piece asked for the city to plant the landscaping back to prevent people from placing their heads on the sculpture. Commissioners said in the meeting that the landscaping has not been maintained well, which is why it became overgrown.

Hiller said she thinks they can work on landscaping that is very low that you would have to tread on it to approach the piece, but that they can't control how people respond to a piece of art as long as they don't physically harm it.

Commissioner Zale Richards Rubins said he's for removing the bushes because they overpower the piece.

"[The sculpture] is not only the most important, but it's also the most valuable piece I believe we have in the collection," Rubins said. "I think those are things that are being put down by the bushes."

*Sitting On A Short Bench* is one of multiple sculptures on display at Beverly Gardens Park. The park also has sculptures by Henri Alfred Marie Jacquemat, Barry Flanagan, Yayoi Kusama and others.

## Kaber Shares Upcoming Events and Goals



## Library Announces No Overdue Fines For Minors

The Beverly Hills Public Library announced they are eliminating overdue fines on materials checked out by youth and teens under 18 years old.

“We have found that overdue fines prevent young patrons from checking out books and other materials and we are here to encourage people to use library services, not obstruct them from doing so,” said Karen Buth, Library Administrator.

“We also cleared all current youth accounts, so those who may have had fines associated with their accounts now start with a clean slate,” Buth said. “We want our materials to be returned on time but understand that children are not able to come to the library without their caregivers, and we hope this new policy provides the flexibility they need.”

While fines are eliminated, fees for books not returned after 30 days will be

assessed as lost and billed accordingly. Patrons will have 30 more days to pay the bill or return their books.

“While we don’t want late fees to deter people from using our services, we value our collection and will continue to charge for lost books so they can be replaced and to ensure our collection remains complete,” Buth said.

The library also instituted another new policy – no charge to place a reserve on books or other materials. Patrons are allowed up to 10 reserves or requests per account; once the item is reserved, it is held for seven business days.

## Beverly Hills Student Named Geographic Geobee California State Semifinalist

The National Geographic Society named Charles Mordaunt Huart II, a seventh grader at Good Shepherd Catholic School in Beverly Hills, as one of the semifinalists eligible to compete in the National Geographic GeoBee State Competition. The contest will be held at California State University Fresno on Friday, March 27.

This is the second level of the National Geographic GeoBee competition, which is now in its 32nd year. To determine each school champion, GeoBee competitions were held in schools throughout the state with students in the fourth through eighth grades. This year, an estimated 2.4 million students competed in the GeoBee, with 8,661 students becoming school champions. School champions also took an online qualifying test, which they submitted to the National Geographic Society. Up to 100 of the top-scoring students in each of the 50 states, the District of Columbia, Department of Defense Dependents Schools and U.S. territories were invited to compete in the State GeoBees.

State champions will receive a medal, \$1,000 in cash, and other prizes, as well as a trip to Washington, D.C., to represent their state in the National Championship where they will compete for additional

The National Champion will receive a \$25,000 college scholarship, \$1,000 in cash, a lifetime membership in the National Geographic Society and an all-expenses-paid Lindblad expedition to the Galápagos Islands aboard the National Geographic Endeavour II. The second-place finisher will receive a \$10,000 college scholarship and \$1,000 in cash; the student finishing in third place will receive a \$5,000 college scholarship and \$1,000 in cash; and seven runners-up will

## Deadline To Register For Earthquake Brace + Bolt

California homeowners have until March 19 to register for the Earthquake Brace + Bolt program, which provides mitigation incentive programs to help homeowners complete seismic retrofits on their houses.

EBB provides qualified California homeowners \$3,000 grants to go toward completing a code-compliant seismic retrofit. A typical retrofit may cost between \$3,000 and \$7,000 depending on the location and size of the house, contractor fees, and the amount of materials and work involved.

Houses that meet specifications are typically wood framed constructions built before 1980, built on a level or low slope, constructed with a 4-foot or less cripple wall under the first floor or constructed with a cripple wall between 4 feet and 7 feet or have a raised foundation.

The program was created by the California Residential Mitigation Program in 2011. Its sponsored by Assemblyman Richard Bloom (D-Santa Monica).

## MUSICIAN'S MERIT

### Grammy Award-Winning Violinist Johnny Gandelsman Performs March 21 at the Wallis

*Johnny Gandelsman, a grammy award-winning violinist, will be performing Bach's Complete Cello Suites at the Wallis on Saturday, March 21. In his first solo Los Angeles performance, he will become the first violinist to play the complete suite in a performance.*

**You're performing the complete Bach Cello Suite on violin at the Wallis. Describe what this upcoming performance means to you.**

I'm very excited about it. It's my debut concert in LA as a solo performer and performing the Cello Suite in one night is part of my new project. I just released an album with the same music and now I've been enjoying touring it around the country. It's the first time that this music is being done [in a] violin performance in its completion and I'm excited to play it in a small theater, the Wallis, because it'll be a very intimate setting for the audience and for myself.

**Why do you think that this performance is something other violinists haven't attempted before?**

Honestly, I'm not sure. Violinists have done the complete Sonatas and Partitas that Bach wrote for the violin and maybe people have thought that they don't want to encroach on the cellists. Actually, the Cello Suites have performed on other instruments like the viola, double bass, mandolin, banjo, or marimba – they just haven't been done on the violin. The music is just so wonderful and [it] sounds really great on the violin, [its] light and [has a] sense of dance which is basically what the [Cello] Suites are. The dance feeling comes out very strongly on the violin. I can't wait to share it with people who have loved this music for a long time and also for people who may be hearing it for the first time.

**Why is the five string violin not considered common in the classical world?**

I can't really answer that. I guess most of the repertoire that exists for violin is not written for five string instruments. It is actually a very common instrument in the folk tradition, a lot of folk fiddlers [and] bluegrass fiddlers play on a five string violin or have a five string violin that they pull out when they need it. Also, on Broadway these days the violinists have a high string violin. But in a traditional classical concert hall, you won't hear somebody playing the five string violin. I don't know any great classical violinists who are out there touring who

play on such an instrument. It's been really fun to learn how to play on it and experience the sixth Cello Suite, which was originally written for a five string cello and play on a five string violin which has a beautiful, really different kind of resonance than a regular four string violin ... it's been a great experience for me.

**You've been described as an advocate for new music and have performed songs from several new artists. Why do you think it's important to celebrate new music as well as the classics?**

We live in the world and composers are writers, like storytellers, [who] often respond to the society they live in. I think for musicians, whose job it is to interpret music, I think it's essential to represent [new traditions] just as we represent traditions of the past. We also have to move the tradition forward by playing music of composers who are alive today. When we play music composers who are no longer around, [like] Beethoven, Brahms, Tchaikovsky, Stravinsky or whoever, we can kind of estimate what they meant. There's a lot of scholarship around every single piece of music that was written by those guys. But it is a completely different experience to be able to open a score that was just written and interpreted, but then also be able to have a conversation with a composer and get as close as possible to what they meant. I tried to kind of realize their vision, while also being true to [myself]. That kind of work then in turn informs my work when I play music. As composers, I tried to look at their score and interpret what they meant. There's just a sense of empathy. There's the composer and also the sense that regardless of how much information there is in a score, the composer [is] never able to notate exactly what they mean. You have to have a leap of faith, a leap of imagination to bring something like that to life.

**With so many genres of music, why do you think people have still gravitated to classical music throughout the years?**

It's some of the greatest creations in western history. Just [like] great places or paintings are there for us to admire, try to understand or just enjoy for what they are. Music, not just western classical music, but music from all over the world has a way to transport us and to evoke emotions without having to talk about it, which is really powerful. It's a great art form.

**What drew you to playing the violin?**

I was born in a family of musicians. My parents are musicians, my mom is a pianist, my dad is a violist [and] my sister is a violinist. So we had music in the house all the time. I started when I was five years old.

**What are your music inspirations?**

There are too many to mention. I love music from so many parts of the world and so many different genres. I love people who are kind of innovators in their positions. In my work I've been very much inspired by people like the incredible banjo musician Bela Fleck, the Irish fiddler Martin Hayes or the great singer and banjoist Rhianon Giddens. People who are great at their tradition, and [who] then constantly look for ways to move traditions forward, expand the limits of their instruments and their craft – which is very much what Bach was doing when he was writing the Cello Suite.

**Can you describe how you came to establish the musical groups Brooklyn Rider and join the Silk Road ensemble?**

Brooklyn Rider is a string quartet of friends who've known each other for many years before we formed the quartet. We had the chance to play in different ensembles and have a lot of musical experiences before we ever formed the quartet. We have a lot of similar musical loves and inspirations, and we wanted to take that love and kind of explore it further. When we formed the group, we knew that we didn't want to be a group that only plays classical music, new music, or folk music. We wanted to do it all and we wanted to be able to follow each individual member's individual passions and explore them within the group. The group has been around for about 15 years now and it's been an incredible source of learning and inspiration. [It's] a big part of forming who I am as a musician.

Silk Road Ensemble is a group that I joined in 2002, so almost 20 years of playing in [this] collective of musicians from all around the world. Again, it very much informed who I am as a musician and as a person in the world.

**You won the Grammy for Best World Music Album. Can you describe to me what that was like to experience?**

It was kind of surreal. We made a beautiful album that I was very proud of. It was cool, of course. It's something I never really thought would happen but it

happened. I mean, it may never happen again and that's fine too. But I'm glad that it did. My parents are very glad that it did.

**Can you describe some of the challenges you faced as a violinist?**

Managing time – I have a family, I have two kids [who are] six and 10. Being away from home is always challenging but also this work is really fulfilling and I guess it's a big part of who I am so I feel pretty lucky to be able to first express what I want on a musical instrument and then be able to share it with people. It's pretty special.

**A lot of people would describe being a musician as a non-traditional career path. Have you faced any challenges in terms of pursuing this as a career?**

I didn't always know that I was going to be a musician. I pursued it but I had a lot of doubts and kind of had to find a path that made sense to me before I could commit to being a musician. Of course, there's difficulties in having enough work to support a family living in New York City. But there's no shortage of ideas and projects that I want to do. It's just time, money and regular things that so many people think about. I think all the other jobs are non-traditional.

**Can you just tell me about what your childhood was like?**

It seemed like a regular childhood, there was a lot of music. When I practiced enough, I was able to go play soccer which is something I really loved. But I skipped days from school when I had to practice or perform. I never finished high school [and] didn't get a degree in college. It's seemed normal, now that I look back at it maybe [it] wasn't so normal, I don't know. But also if I did anything differently, I wouldn't be where I am today so I'm okay with all of that.

**What else are you planning to do after your performance of the Wallis?**

[The Wallis performance] is part of a short trip to California for performances. I have a show in Santa Inez, then in San Diego, then I come back to [play in] New York, [and] then there's a bunch of stuff with my quartet. This is a busy year.

## BHUSD FORETELL ANOTHER OIL WELL

### Possible Abandoned Oil Well Beneath Beverly High Building

The Beverly Hills Unified School District will remove several modular buildings from Beverly High to investigate if there is an abandoned oil well beneath them.

The district found drilling fluid seep-

ing from the ground on Beverly High's campus and believes it might be coming from an abandoned oil well beneath modular building V-10. The board unanimously voted to remove modular buildings V-09, V-10 and V-11 in order to in-

vestigate its source.

Estimates for plugging all the oil wells on campus are upwards of \$30 million.

Modular building V-10 is near the school's

fence and currently used for storage. To be able to inspect the source of the fluid, the district must remove several modular buildings in the region its oozing from. It believes that horizontal drilling from campus construction might have caused

the drilling fluid percolation, but won't know for certain until an investigation is complete.

Removal of the three modular buildings will involve disconnect-

ing electrical and network connections and making alternative connections to avoid disrupting other connections on campus. The projected costs of that specifically are \$59,340.65, according to an Edgar Garza Construction proposal.

The City of Beverly Hills ("City") and Oasis West Realty, LLC, ("Developer") entered into that certain development agreement (the "Development Agreement" herein), recorded as instrument No. 20082184012 on December 11, 2008, in connection with the redevelopment of the Beverly Hilton Hotel site, located at 9876 Wilshire Boulevard, to add a new twelve-story luxury hotel; renovation of the existing Beverly Hills Hilton Hotel to add restaurant space, construct a new two-story conference center, and reconstruct the hotel's pool areas; and construc-

tion of two residential condominium buildings, one eight stories tall and one eighteen stories tall (the "Project").

Section 2. Developer has requested an amendment (the "First Amendment") to the Development Agreement to give Developer the option to execute up to five (5) additional one-year extensions, for a total of ten (10) possible one-year extensions. The First Amendment to the Development Agreement is attached hereto as Exhibit A, and is hereby incorporated herein.

Section 3. The First Amendment has been environmentally reviewed pursuant to the provisions of the California Environmental Quality Act (Public Resources Code Sections 21000 et seq.) ("CEQA"), the State CEQA Guidelines (California Code of Regulations, Title 14, Sections 15000 et seq.), and the City's Local CEQA Guidelines. The City previously prepared and certified a final Environmental Impact Report ("EIR") for the 9876 Wilshire Project (State Clearinghouse No. 2006091053), and this EIR remains valid in assessing the environmental impacts associated with the First Amendment. There have been no changes in circumstances, new information, or changes in the Project that warrant further CEQA analysis. All previously identified mitigation measures remain in full force and effect. No changes to the CEQA findings adopted in conjunction with the Project and the Development Agreement are made necessary by the First Amendment, and the City Council finds the First Amendment to be within the scope of the Final EIR's analysis. The City Council further finds that it can be seen with certainty that the requested extension options do not have the potential to cause a significant effect on the environment, and thus the First Amendment is exempt from further environmental review pursuant to State CEQA Guidelines Section 15061(B)(3).

Section 4. On February 13, 2020, the Planning Commission conducted a duly noticed public hearing to consider the First Amendment. At the close of that hearing, the Planning Commission adopted Resolution No. 1909, recommending that the City Council approve the First Amendment.

Section 5. On February 18, 2020 the City Council conducted a duly noticed public hearing to consider the First Amendment, and agreed to provide the option for annual extensions of the Development Agreement through June 30, 2026, with a \$1,000,000 extension payment for each one-year extension.

Section 6. The City Council hereby approves the First Amendment, as set forth in Exhibit A, and authorizes the Mayor to execute the Development Agreement on behalf of the City.

Section 7. No later than ten (10) days after the effective date of this Ordinance, the City Clerk shall record with the County Recorder a copy of the Development Agreement and the notice shall describe the land to which such contract applies.

Section 8. The City Clerk shall cause this Ordinance to be published at least once in a newspaper of general circulation published and circulated in the City within fifteen (15) days after its passage, in accordance with Section 36933 of the Government Code; shall certify to the adoption of this Ordinance and shall cause this Ordinance and this certification, together with proof of publication, to be entered in the Book of Ordinances of the Council of this City.

Section 9. Effective Date. This Ordinance shall go into effect and be in full force and effect at 12:01 a.m. on the thirty-first (31st) day after its passage.

FIRST AMENDMENT TO THE DEVELOPMENT AGREEMENT BETWEEN THE CITY OF BEVERLY HILLS AND OASIS WEST REALTY, LLC RELATING TO THE PROPERTY AT 9876 WILSHIRE BOULEVARD, BEVERLY HILLS, CALIFORNIA

Amendment of Section 5 of the Development Agreement Related to Term of Agreement

1. This First Amendment to the Development Agreement (this "Amendment") is entered into as of this \_\_\_\_\_ day of \_\_\_\_\_, 2020, by and between the CITY OF BEVERLY HILLS, a municipal corporation (the "City"), and OASIS WEST REALTY, LLC, a Delaware Limited Liability Company (the "Developer"), and is an amendment to a Development Agreement between the City and Oasis West Realty, LLC dated December 11, 2008.

RECITALS

A. Pursuant to California Government Code Sections 65861-65869.5, the City and the Developer entered into a Development Agreement (the "Agreement"), effective December 11, 2008, to provide greater certainty and predictability in relations between the City and the Developer with respect to a development project on property located at 9876 Wilshire Boulevard, Beverly Hills, California, as more fully described in Exhibit A, attached hereto, and incorporated herein by reference. The Agreement was recorded as Instrument No. 20082184012 on December 11, 2008, in the Office of the Los Angeles County Recorder.

B. The parties now desire to amend the term of the Agreement to grant the Developer the ability to purchase five additional one-year extensions of the Agreement.

C. On February 13, 2020, following a duly noticed public hearing, the Planning Commission adopted Resolution No. 1909, recommending that the City Council approve this First Amendment.

D. At a duly noticed public hearing on February 18, 2020, the City Council considered the information in the previously certified final Environmental Impact Report ("EIR") for the Project (State Clearinghouse No. 2006091053), found the proposed First Amendment within the scope of the certified final EIR, and in the alternative that it is covered from CEQA pursuant to the State CEQA Guidelines Section 15061(B)(3) and approved this First Amendment.

NOW, THEREFORE, in consideration of the mutual covenants and agreements contained herein and other good and valuable consideration, the receipt and legal sufficiency of which is hereby acknowledged, the parties do hereby agree as follows:

1. This First Amendment shall be effective when City Ordinance No. 20-O-\_\_\_\_\_ that approves this First Amendment becomes effective.

2. Section 5 of the Agreement is hereby amended to read as follows:

"5. Term of Agreement. The initial term of this Agreement shall commence on the date the Agreement becomes effective, and shall continue for five (5) years. If a voting trustee subdivision map is approved in connection with the Project and, thereafter, approval of a final subdivision map for the Project is achieved in a timely manner, the term of this Agreement shall be extended until the expiration of the voting rights that accompany the voting trustee map for the Project. In addition to the above, at any time, the term may be extended for one year or more provided that the total extension period does not exceed more than 10 years. An extension pursuant to the prior sentence shall be effective upon written request of Developer

provided to the City at least 90 days before the expiration of the term (including any previous extension) and a corresponding payment to the City of the following amounts: for the first and second years of extension, Developer shall pay one hundred fifty thousand dollars (\$150,000); for the third year of extension, Developer shall pay five hundred thousand dollars (\$500,000); and for each of the fourth through tenth years of extension, Developer shall pay one million dollars (\$1,000,000). The term of previously extended third year of extension is hereby extended through June 30, 2020, and any subsequent one-year extension periods exercised by the Developer shall run from July 1 through June 30 of the following year.

Notwithstanding the term set forth above, the obligation to pay the \$125,000 fee and the Municipal Escrow pursuant to Section 10 shall continue indefinitely as provided in Sections 10 and 12."

3. No Other Change. Except as expressly amended by this First Amendment, the Agreement shall remain in full force and effect as written.

4. Reproduction of Amendment. No later than ten (10) days after the Effective Date of this First Amendment, the City Clerk shall record an executed original of this First Amendment in the Official Records of the County of Los Angeles.
