### **New Mayor Sworn-In**

Lester Friedman was sworn-in as Mayor of Beverly Hills over a teleconference call Tuesday.

Robert Wunderlich was sworn-in as Vice Mayor and Councilmembers Lili Bosse and Julian Gold were sworn-in for another four years on the council. Outgoing Mayor John Mirisch will also continue to serve as a councilmember.

An installation ceremony was originally scheduled for April 6th, where it was planned for Friedman to be swornin and for there to be a celebration party. However, because of the pandemic, the council decided to cancel the celebration and move the installation up to Tuesday, March 31.

Friedman said that when he was making preparations for becoming mayor, he had a vision of the platform "Beverly Hills Together." Shortly after starting arrangements, however, he said travel restrictions from China were announced and the coronavirus was spreading throughout the United States.

"In this unprecedented time, I cannot think of a more appropriate theme than "Beverly Hills Together," Friedman said. "Though with a completely different emphasis than what I had first imagined."

Friedman said there is a lot of hard work and difficult times ahead, but that the community needs to stick together to move the city forward.

"The novel coronavirus has changed our lives in every way imaginable, our streets are quiet, most of our stores are temporarily closed, and there is a sense of indefinite uncertainty," Friedman said. "But in the midst of this public health crisis, there is also a sense of unity and community - something Beverly Hills is all about."

He said that the council's actions so far have been necessary to ensure public safety and that it will continue to take action to stop the spread of COVID-19.

"It was incredibly difficult to make decisions that would directly affect the livelihoods of residents, business-owners and employees across the city," Friedman said. "However, we had to put the health of our community first - it was the right thing to do.'

The councilmembers also individually thanked Mirisch for his service as mayor in the past year.

"It had been your guidance through this last year and especially during the last month, that this community is indebted to you for," Friedman said. "I thank you so much for that."

Gold said that Mirisch's legacy is that he made a difference in the city throughout his term

"Your passion for the city is extraordinary and it shows in everything that you do - it's so embedded in your soul," Gold said.

Friedman is serving his first-ever term as mayor. He was first elected to the City Council in 2017. Prior to that he served on the Traffic and Parking Commission for six years and was its Commission Chair in 2015.

### **Coronavirus Pandemic Carries On**

The coronavirus pandemic carried on this week, with 39 confirmed cases of COVID-19 in Beverly Hills as of Wednesday.

According to the County of Los Angeles Public Health Department, LA county has 3,518 confirmed coronavirus cases and 65 total deaths as of press time. Neighboring city West Hollywood has 64 confirmed cases.

Gov. Gavin Newsom said in March that California schools are likely not going to open until at least summer break, though no official mandates have been made as of press time. The BHUSD originally extended home-learning to May 4th, however its expected for the district to remain physically closed for longer.

BHUSD students had their first week of online education last week. Classes

Hacker the pandemic is an unprecedented moment in history and asked people to understand the challenges of quickly adjusting to the many changes being made.

"Every stakeholder should continue to build our community up and not down," Hacker said. "Be supportive and productive of our motivation and efforts because our students in the school and families deserve no less."

The Beverly Hills Education Association, the union that represents BHUSD faculty, sent a letter to school administrators last week that discussed several issues teachers have been having with home learning. In response to the district increasing the number of hours teachers are required to give online education, BHEA also said that it sent an Memorandum of Understanding that discusses what it feels are appropriate hours and will use it to bargain with the district.

Hacker said that she is not permitted to speak about negotiations, but assured stakeholders that there are many districts that find themselves in the same position that BHUSD is in.

"I'm confident and optimistic that together we're going to work with BHEA to provide the best instruction BHUSD can deliver to our students," Hacker said.

City Council established an Advisory Medical Taskforce to provide it guidance on policies it makes to address the virus. It includes medical professionals from local

medical centers and hospitals, including Cedars-Sinai and UCLA. The taskforce met last Tuesday to discuss new policies and will continue to meet with the council throughout the pandemic.

According to medical experts, Los Angeles is expected to have its peak number of coronavirus cases around mid-April.

### **City Council Approves Temporary Full Closure** of Wilshire Blvd for Metro **Purple Line Construction**

City Council approved an accelerated construction timeline for the Metro Purple Line Project and a temporary full closure of Wilshire Boulevard Tuesday to take advantage of reduced traffic throughout the city during the COVID-19 emergency.

The temporary closure between Crescent Drive and Beverly Drive, and a portion of Beverly Drive at Wilshire Boulevard, will expedite subway construction and mitigate future impacts of the project.

"This is truly a unique circumstance that will allow for minimal disruption in

our City," said Mayor Les Friedman. "After collaborative discussions with both our residential and business communities. this plan has received support as an effective strategy in an unprecedented time."

The work is expected to begin in the coming days and will include new hauling hours between 7 a.m. and 9 a.m. and 4 p.m. and 7 p.m. Metro may work on non-religious holidays such as Mother's Day, Memorial Day and Father's Day. All other authorized work hours and days will remain in effect.

During the full Wilshire closure, changeable message boards, detour signage, and traffic control officers will be present throughout the area to route traffic to Olympic and Santa Monica Boulevards. Soft closures will be in place along Wilshire Boulevard within the detour area to allow local access. Local access to businesses will be maintained.

Metro hosted a webinar on April 1 at noon before work commenced to explain the changes. Both the city and Metro will communicate through a digital outreach campaign including email notices, website and social media postings.

This specially authorized Metro work may continue until the City's local emergency is cancelled or within five days of notice from the City Manager or designee. For more information, please visit www. beverlyhills.org/purpleline

### **Medical Professionals Speak** at COVID-19 Council Meeting

The City Council held a virtual meeting

on the coronavirus pandemic Thursday, which was joined by the newly created Advisory Medical Taskforce made up of healthcare professionals dealing with COVID-19.

The taskforce was created to advise councilmembers on policies meant to prevent the spread of COVID-19. It includes doctors and healthcare professionals from nearby medical centers, including Cedars-Sinai and UCLA Medical Centers.

The taskforce answered questions from the council and community members on how their respective hospitals are handling the pandemic and other general questions on how the virus operates.

Dr. Sam Torbati, the Cedars-Sinai Medical Center's Co-Chairman and Medical Director, said that the center has been preparing for the virus for the last couple weeks in anticipation of its spread. (For an in-depth interview with Dr. Torbati, see page 10.)

"It's sort of a battle cry for us. We understand how this is going to affect us," Torbati said. "We know that the wave is

coming and we're seeing more and more of it."

Torbati said that several weeks ago, they had patients coming into Cedars-Sinai with a cold. Now people are coming in with more dangerous cases like actual pneumonia, he said.

"Patients are getting sicker, they're getting more complicated, many of them are requiring hospitalization,"

Torbati said. "The entire medical center is focused on the care process - everything is being looked at."

Dr. Rachel Zabner, an Infectious Disease Specialist at Cedars-Sinai Medical Center, said that people should stay away from supplements and other home-remedies that are advertised to help cure the disease. She said that they're not proven to be effective and can sometimes be harmful.

Zabner also said that Plaquenil, which is a drug being experimentally offered to certain patients, is not something that community members should seek out. The drug has been rumored to be an "antidote" to COVID-19, causing certain community members to wonder if they should stock up on it.


There are limited quantities of the drug for patients who really need it, therefore community members shouldn't further limit what's still available, Zabner said. She added that the drug is given to patients with consent forms because it can have dangerous side-effects, including arrhythmia.

Dr. Jonathon Fielding, a professor of Health Policy and Management at UCLA, said that the most important thing right now is to prevent people from contracting the disease. He said that the best way to put an end to the pandemic would be to test everyone that suspects they might be sick, however that's currently not possible.

Cedars-Sinai Medical Center has about

forty cases of COVID-19 as of Thursday. That number is expected to steadily increase over time.

Dr. Daniel Uslan said that the key to reducing the number of cases right now is up to individual community members.

"Really, the only effective tool at this point is very aggressive social distancing," Uslan said.

The taskforce includes Dr. Jonathon Fielding, Dr. Irving Posalski, Lee Hilborne, Mike Altschule, Rhonda Curry, Dr. Daniel Uslan, Dr. Enrique Terrazas, Dr. Karen Grimely, Dr. David Agus, Dr. Rachel Zabner, Dr. Sam Torbati and David Hopp. The members will continue to advise the council on what policies it should enact to slow the spread of COVID-19 throughout the pandemic.

### **BHUSD Teacher Layoffs**

Every year, the BHUSD Board of Education must decide which certificated and classified positions will be adjusted for the upcoming school year before March 15. There are currently no classified position lay-offs, according to Executive Director for Human Resources Luke Pavoné.

FTE stands for "full time equivalent" and is the number of hours, or in this case class sections, someone works as a fulltime employee. BHUSD defines FTE as teaching five sections, meaning each individual section someone teaches is equivalent to 1/5 or 0.2 FTE units.

Below is a chart listing which certificated positions will be reduced or eliminated.

Bregy said that the administration feels that its likely the district will be closed for longer than expected and has begun discussions on what the second phase of home-learning will be.

In response to parents complaints that the district is rolling information out too slowly, Bregy said the district must walk before it can run.

"To be completely transparent, this pandemic is a true test for our school district as we are being pushed faster than we are ready," Bregy said. "We did blindside our teachers with this news, we gave [them]

### **Bregy Updates the Community on Home-**Learning

BHUSD Superintendent Michael Bregy gave updates on how online schooling will be carried out in the district last Tuesday, while schools are still closed for the quarantine

Bregy said that he understands there are concerns about the district's online learning program, but that many concerns came before home learning began on March 24.

Bregy said that he received several emails from parents complaining about a lack of information on home-learning during spring break. He said that while administrators were working during this time, teachers had a deserved vacation and weren't supposed to be working to prepare lesson plans.

Other school districts have followed BHUSD's lead, according to Bregy. He said that the work they are putting out is being used by other districts and the Association of California Administrators has shared BHUSD's resources with the state.

"We're off to a good start, but there are improvements to be made as we move forward," Bregy said.

BHUSD is collaborating to create more structure and support to prepare for a longer school shutdown. It is also open to learning about other districts who have moved their instruction completely online, meaning that all five hours of daily lessons are done virtually every school dav.

Bregy also said that having a camera on your laptop doesn't change a classroom lesson to an online lesson. He said a reason why the district is rolling things out slowly is to give time to students and parents to learn about the expectations of video conferencing.

"I'm already getting reports from teachers about students that are being disrespectful on the video chats and making some bad decisions - playing loud music, swearing," Bregy said. "In addition, I've also been made aware of parents and students taking videos and photos of the conferencing and posting them to social media "

The district has sent out policies on expected behavior during video conferences, which includes rules like no screenshotting or creating memes.

"We want to be able to support everybody in the learning environment and not have to remove people from the video apps because of poor choices," Bregy said

The College Board has canceled the SAT's original May dates and the next date will be June 6. The ACT test has been rescheduled for June 13. The College Board is working on remote learning for Advanced Placement tests. CAASPP testing in Math and English for grades 3-8 and 11 have been canceled for the school vear

### Los Angeles Establishes **Meal Deliveries, Special** Grocery Hours and COVID-**19 Testing for Seniors**

Los Angeles has begun programs to assist seniors and other vulnerable communities during the pandemic, including special hours in grocery stores, meal deliveries and accessible testing for COVID-19.

City and County of Los Angeles operated congregate meal sites are closed until further notice, according to a press release from the Los Angeles Department of Aging. The city is distributing packaged and frozen meals for older adults enrolled in its meal program at meal sites. Adults 65 and older must send someone under the age of 65 to pick-up these meals from their sites. To enroll, people can call the department at 213-482-7252.

Seniors who already receive regular home meal delivery will have their services continued and the city is also working with its providers to increase other home-deliveries for meals. To see a map that shows the status of each elder nutrition site and whether or not delivery has been implemented, people can go to https://bit.ly/2JbY04T.

The city has made COVID-19 testing available for residents of Los Angeles with symptoms who are 65 and older. To make an appointment, people can go to Coronavirus.LaCity.org/Testing. People can also call the Mayor's Help Desk at 213-978-1028 if they don't have internet access.

Many local grocery stores have early morning hours for seniors and other vulnerable groups to shop, including Ralphs, Walmart, Target and many more.

tinuing to go to work at City Hall amid the pandemic.

"This isn't World War II, it's nothing as drastic as that. But it's still something that's unreal for all of us," Mirisch said. "I think the city government and the city needs to continue to run."

City Hall is operating virtually with staff members working from home, while first responders are continuing to physically go to work. Mirisch said that City Hall has been lonely during the pandemic, but that he thinks it important for him to go.

Mirisch also said other Los Angeles County mayors have been having joint conference calls and he's also been speaking individually with mayors on how to best handle the pandemic. He said that things likely won't return to normal in the city for some time.

"It could be that way for a long while, we just don't know. That's one of the things that when the crisis is over, it's not going to be that we snap our fingers and it's all over," Mirisch said. "It's sort of a faucet that you gradually turn on until it eventually gets normal."

### **Board of Education Holds Off on Education Morale** Survey

The BHUSD Board of Education chose last Tuesday to hold off on sending a morale survey to teachers, parents and students until its schools reopen.

Board President Isabel Hacker said it would be valuable to send a morale survey at the end of the school year or summer to identify what the district is and isn't doing well. The board reached the consensus it would revisit the topic and send a survey at a later date, so results wouldn't be affected by the COVID-19 quarantine that has shutdown BHUSD schools.

President Isabel Hacker and Board member Noah Margo were in favor, while Vice President Rachelle Marcus, Boardmember Mel Spitz and Boardmember Tristen Walker-Shuman were opposed to the potential survey's timing.

Hacker said a survey would identify the needs of important stakeholders, if the district is meeting its goals, if programs are organized and more. She also said that a survey could also be sent to students to see how they feel about their schools.

"I watch a few gardeners [on Youtube], ones from Michigan, ones from Australia, from a bunch of different countries and climates," Walker said. "I think I learned most of the gardening information from them."

Walker said his favorite plant to grow is pumpkins, which grow best in Fall. The plants he's growing right now are best for Spring and Summer.

"They grow moderately fast in the fall and I think the fall season is one of the best seasons to grow crops in general," Walker said. "But also pumpkins are super versatile."

Nate n' Al's announced on its Instagram Sunday that it would be closing on Sunday, March 29 at 8 pm. The diner's

### Tell us some of your goals as mayor.

My initial goals as mayor, and we're still going to get there, is the theme of "Beverly Hills Together." I want to integrate all of the different aspects of our city so that we are all in tune together. I think in the past, there have been some fractions of the school board and the city council that weren't really getting along well, and I thought that we would work towards getting that to be more cohesive. Working with our business community and doing everything that we can do together to make Beverly Hills a place that we all love to live in, to work in and to play in.

You were first elected to the City Council in 2017 and served on the Traffic and Parking Commission before that. How has your view of local government changed in the three years you've served on the council?

It's really good, it's really improved. I see how responsive our city government is. We really care about our residents and

our businesses. I don't think there's a community around that is as responsive to the needs and requests of our citizens and our businesses like Beverly Hills is. Our residents can pick up the phone and speak to managers [and] they can speak to councilmembers. I don't

think that's what occurs in other cities, such as Los Angeles or other bigger cities. We are unique in that we really want to communicate with our residents and our businesses [to] make ourselves available.

This will be your first time serving as Mayor, while your predecessors for the last couple of years have all been mayor at least twice. What challenges do you anticipate facing?

We may take different directions on different types of issues but our goal always is to better the experiences in Beverly Hills. 



# Dr. Sam Torbati

### **Cedars Sinai Co-Chairman and Medical Director on The Pandemic**

You're on the front line in the Cedars-Sinai ER during the coronavirus pandemic. Tell us about that.

Well, we started seeing a lot of patients that had symptoms of COVID several weeks ago. We anticipated that the patients were going to come and in anticipation of that, we changed a lot of processes in the ER. We developed and built a whole model of care involving the tents that we developed outside the ER and over the past several weeks, as expected, the patients are continuing to come to the hospital. Now they are more and more ill, as we are getting more and more into the pandemic. More and more patients are now developing the pulmonary complications, the pneumonia associated with the COVID-19.

## Why do you think cases are becoming more severe?

The natural history of this viral infection is that it starts off in most patients with mild symptoms and usually, after about a week, some patients go on to develop more severe symptoms. It tends to peak around day eight or so, where at that point, some patients develop a lot of lung complications. They have great difficulty breathing, their oxygen levels are low, they're very weak and that's when they tend to really need a lot more emergency department and hospital care.

### Is the hospital currently more overwhelmed than usual?

The hospital is fully equipped to take care of every other patient. At the moment, we are continuing to prepare and adjust all of our patient care processes so that we can take care of patients that have COVID-19 and other issues. We certainly have a lot of the COVID-19 patients, both in the ER, that we're taking care of – some we're hopefully will get to go home and many others that are being hospitalized. As you can imagine, a lot of people can get a little bit of a viral infection but can have other issues too. They can fall and break their hip, they can develop heart attacks. So we are continuing to work out how we would safely take care of additional issues, even if the COVID-19 is not the primary issue.

Certainly, we're working on how to take care of patients with COVID-19 as the primary issue. Lots of work and preparation. At this point, we are anticipating to be hit very hard in the next week or two. It's been a little bit of the relative calm before the storm. We're still fairly busy. We're not quite as impacted as I anticipate we will be in the upcoming weeks. Same way that we're hearing in places like New York and in weeks past in Seattle.

How have you seen this virus affect patients at Cedars-Sinai, in terms of lifethreatening cases? Please be specific. We're clearly seeing a lot more people coming in where their primary issue is difficulty breathing in different ways. Some people who are older are coming in comatose and they just can't breathe at all together. We have to initiate resuscitative interventions, things like placing them on ventilators.

Other patients are coming in with similarly severe symptoms, but if they're

younger, they may not require immediate intubation or ventilatory support. But they do require oxygen and they are requiring hospitalization. Again the characteristics of the patients are exactly what we sort of anticipated based on the predictive models that the health department and others predicted based on the experience elsewhere in China, Singapore and other countries before it came to the States.

What's been the most difficult part of this pandemic for doctors at Cedars-Sinai in particular?

The hardest part is the fact that we can become patients ourselves. As we're helping patients get through this, hopefully helping them survive, we can get very ill too. The fear of many of

the doctors and the nurses and everybody else that's involved in the care of these patients, is that they're afraid that they may end up on a ventilator. They're afraid that they may take this virus home and they can infect their kids and their families.

This has had a tremendous emotional toll on all healthcare providers because we can become the patient ourselves. That's usually not the paradigm. With other illnesses or conditions, heart attack, strokes, car accidents, things that we commonly take care of in the ER – we're never afraid that we're going to immediately turn into that patient. But in this scenario, within a short period of time after being exposed, we could get sick ourselves.

### Are there any precautions Cedars-Sinai is taking to prevent healthcare providers from contracting the virus?

There's a ton of work and training going into training our staff and making sure that we have the personal protective equipment that we need. There's all kinds of work being done on a policy standpoint to make sure that our policies are congruent with our understanding of how this disease transmits. Cedars is at the forefront and doing everything it can to protect its staff. Similar to other centers, the supply chain is an issue for us too. But we're working very hard to make sure that people have what they need to take care of patients.

### Is there any important information to share about the virus that isn't widely known to the public?

I think the public has a very good handle because of all of the appropriate press coverage, as well as the appropriate steps that our local, state, national government has taken to try to get the curve to be not as severe and try to get the curve in terms

> of illness rates down. I hope that the public understands that this is going to take quite some time until it's all over. It's not like a storm or earthquake, where you get hit once and then you recover. This is a sort of a prolonged hit. We need to figure out how to sustain our energy so that we continue to practice all of the safety steps. In terms of the space isolation that we maintain and all of the other efforts to reduce the risk of transmission from continuing to occur. That's a really hard thing for people. We've never been in a time like this in our modern history, where we've had to deal with an infection like this, that has affected us in such a way.

Many experts have shared that this virus generally isn't life-threatening to

people under 65, however last week we saw the first death in California for someone under the age of 18. Is that something accurate to say? Why or why not?

We know that this virus is far more deadly than the common influenza. We know that influenza affects not just the old but also younger patients and children. This virus tends to spare children, but it doesn't exclude them completely. Although most of the people that are going to get very sick are going to be middle-aged [or] elderly, there are going to be a fair number of younger patients too – teenagers, young adults and children. A small percentage of them may have severe complications and death. I don't want to scare anybody, but the reality is that this is a concerning issue. Even if a young person may not require hospitalization and may not die, they certainly can transmit that illness to their parents or their grandparents. I don't think anybody would feel very good knowing

that they were the cause of their elderly loved one's demise.

The phrase "flattening the curve" and "social distancing" have been said often throughout these past few weeks. What do those phrases actually mean for putting a stop to the virus' spread?

[Social distancing] basically means that we want people not to be in physical contact. I actually think a better term is "physical distancing." We want people to be social in terms of keeping an eye on their loved one and calling them and caring. We want society to continue to be a loving society. We just want to reduce physical contact between people and we want to create a physical space between people so that if one person is sick, coughing and [has the] virus it doesn't get transmitted to the person next to them. Best way of doing that is to create space between people. Physical space.

### You're part of the Beverly Hills Advisory Medical Taskforce. What will you do as a member of the taskforce?

I received an invitation from the mayor's office [to join]. I believe the taskforce's purpose is to give counsel to the councilmembers and the Mayor to help them come up with policies that help the residents of Beverly Hills. This is one of those scenarios where the solution to this medical crisis is not medical. It's actually social. Similar to how the way you prevent car accidents is to come up with good social policy around drinking, driving, speeding, helmet, seatbelt laws.

That's how you save lives, right? This is another one of those instances where in order to save lives, our government and our city leaders need to make difficult decisions on how to manage the city and what kind of ordinances to maintain. They're in a tough position because they have a lot of pressure to allow the city to get back to work. Yet at the same time, there will be pressures because we're concerned that if the city returns too early then this virus can continue to spread at a faster rate.

What's something that community members can do, other than stay at home and socially distance themselves, to help the efforts of flattening the curve?

There's a lot they can do. They can check on loved ones, they can check on the elderly. They can be involved with a lot of internet and non-physical ways of serving the community and serving those in need. For themselves and their families, they can continue practicing safer hand hygiene practices – washing hands, washing surfaces. They can continue to become accustomed to practicing a lot of the safety issues, as they feel like sneezing and such making sure they sneeze into their sleeve.

To the extent they can, many hospitals continue to have needs around equipment. Many hospitals [including Cedars-Sinai] have set up hotlines and internet sites where people who have the resources and wish to donate things like supplies that hospitals may be lacking.



"With other illnesses or conditions, heart attack, strokes, car accidents, things that we commonly take care of in the ER – we're never afraid that we're going to immediately turn into that patient. But in this scenario, within a short period of time after being exposed, we could get sick ourselves" -Sam Torbati
