City Council Considers Bike Lanes

The City Council decided against converting travel lanes to bike lanes temporarily during the lockdown Tuesday.

Vice Mayor Robert Wunderlich requested the council discuss temporarily dedicat-



ing travel lanes for bicycle and pedestrian use. According to the city's staff report, the potential new lanes were meant to help facilitate physical distancing since s i d e w a 1 k s don't have room for bikes

Mayor Les Friedman and Councilmembers Lili Bosse and Julian Gold said they were against implementing the lane changes. Councilmember John Mirisch said he was fine with adding bike lanes if it was done in a cost effective way.

Wunderlich said he was in favor of adding bike lanes on major streets, rather than

lanes in each direction to create bike lanes with barriers to protect bikers from cars. The cost of implementing the changes could have ranged from \$1,000 to \$150,000, depending on which streets had been closed and for how long.

A few streets the closures might have occured on include South Santa Monica Boulevard, Robertson Boulevard, Olympic Boulevard, Canon Drive, Crescent Drive, Beverly Drive, and Wilshire Boulevard

Gold said he would like a study to be conducted on which streets could best implement bike lanes. However, he said he was hesitant to invest money into implementing bike lines if it would be a short lived benefit to few people during the lockdown.

"I'm willing to be convinced, but I think as we sit here today I don't have a concept that I can agree to go forward," Gold said.

Since the quarantine, speeding has reportedly increased throughout the greater Los Angeles area. According to the city's staff report, the Los Angeles Department of Transportation General Manager Seleta Reynolds shared that drivers are driving about 12 percent to 25 percent faster.

'Repurposing the traffic lanes also does help to mitigate some of the excessive speed we're seeing on our streets," Wunderlich said.

Bosse and Friedman were concerned the lane changes would promote more people going outside, rather than staying in for the lockdown.

Bosse said bike lanes would send a contradictory message to the city's stay at home order.

'My concern is that if we were to do this, we actually are going to encourage more people to come out and I'm afraid of the social distancing by having designated areas where people will be cycling or walking - I think we'll have more people there," Bosse said.

Friedman said he doesn't want to encourage gatherings, which the bike lanes might do. He also said it could impact the city's transportation plans long term.

"If we are not successful in rolling this out properly, I think we're going to take a big step backwards in our ultimate goal which is to encourage multimodal transportation," Friedman said.

Community members also reacted to the potential addition of bike lanes.

Former Mayor Robert K. Tanenbaum said the temporary addition of bike lanes is deceptive. He said bike lanes shouldn't cost drivers their parking spaces.

'This is another foot in the door for that kind of outrageous activity that the people of Beverly Hills will overwhelmingly never support," Tanenbaum said.

Tanenbaum added that there hasn't been adequate notice of the lane conversions.

'Nobody is saying cyclists should be restricted but to expand these rights at the cost of driving cars to and fro is a total outrage," Tanenbaum said.

If it had been approved, Beverly Hills would be joining other cities who have closed driving lanes for pedestrians and bikers.

Oakland closed 10% of its streets with neighborhood bike routes and Denver closed streets in areas with denser populations. Minneapolis closed two parkways and an eastbound travel lane. The Massachusetts Department of Conservation and Recreation also closed portions of three parkways.

However, other cities have also decided against street closures.

New York reopened streets it had previously closed due to costs. Portland, which already has well-established bike lanes, has not closed any streets because its mayor was concerned it would contradict efforts to increase social distancing.

Los Angeles has also not closed any streets for bikers as of press time.

Property Owners Question Eviction Moratoriums

Beverly Hills property owners have reacted negatively to the city's temporary eviction moratorium, which was ordered by the City Council in March and prevents tenants from being evicted during the COVID-19 lockdown.

The Apartment Association of Greater Los Angeles sent a letter to the council asking for it to repeal the ordinance Tuesday.



are having trouble meeting ongoing financial obligations - not just costs associated with their rental properties, but expenses for their own housing, healthcare, and the food on their table," Yukelson wrote.

The eviction moratorium, which went into effect on March 15, does not allow landlords to evict tenants if they fail to make their rent during the span of the lockdown. Unpaid rent is not forgiven, but tenants are given six months after the moratorium ceases to pay it. Landlords cannot charge late fees for rent deferred under the

moratorium.

The council issued this ordinance alongside the ordinance that required non-essential businesses to close in March, which left many residents without a source of income.

"All your eviction moratorium and urgency ordinance has done is empower many dishonest people to take advantage of landlords that are in a bad situation and facing unbalanced City ordinances," Yukelson wrote to the council. "Yet, you continue to harm and antagonize landlords for merely investing in our neighborhoods and providing housing to those in our community."

Yukelson asked for the city to require tenants repay unpaid or deferred rent on or before vacating their rental unit or at least allow for security deposits to offset unpaid rent and require renters to furnish a forwarding address.

"Please don't leave rental property owners 'holding the bag,"" he said. "They will never collect amounts owed to them once a renter has moved out."

The council discussed updating the eviction moratorium in its Tuesday meeting, but decided to table the discussion to a later date so it could get more legal information on the topic.

Yukelson is a former member of the Planning Commission.

Fate of BHUSD Graduation and Promotions Debated

Graduations and promotions at Beverly Hills schools have an uncertain future in the wake of quarantine and coronavirus, but the BHUSD Board of Education attempted to give the ceremonies some clarity last Tuesday.

While the board does not have the jurisdiction to determine how graduations or promotions will be conducted, or even if they will happen, it gave recommendations to schools on how they can move forward with the events. It suggested planning ahead for alternatives to traditional ceremonies, but not yet making any final decisions to cancel or postpone them.

"I would like to encourage admin, staff, parents and students alike to be really creative to come up with some ideas for how we can make some of these things happen so that these seniors don't lose out on all of these opportunities," said Board member Tristen Walker-Shuman.

No graduation or promotion ceremonies have been canceled as of press time, but school staff have been looking into alternatives for celebrations in case public gatherings are still not permitted by June.

Hawthorne Principal Sarah Kaber and Horace Mann Principal Craig Bugbee also attended Tuesday's meeting to discuss what their schools are planning. They both said that they are speaking with teachers to plan for alternative celebrations in case graduations are postponed or canceled.

Board President Isabel Hacker said that each month will be drastically different during the pandemic and it's too soon to say what June will look like. She said postponing graduation to a later date would be the most ideal scenario, but schools should plan ahead in case that doesn't happen.

"The best thing we can do is prepare for

the best and plan for the worse," Hacker said.

Board Vice President Rachelle Marcus said she would never endorse an activity that would put the safety of students in jeopardy. She added it's too early to cancel or postpone any graduations.

The contingency plans have to be made so we will be able to have something, when and if we are able to have something," Marcus said.

Coronavirus Updates: Quarantine Week Six

The pandemic continued this week, with 99 confirmed cases of coronavirus in Beverly Hills as of Tuesday.

Los Angeles County has 15,140 cases and 663 deaths as of press time. West Hollywood has 120 confirmed cases, Brentwood has 61 confirmed cases and Culver City has 44 confirmed cases.

The Beverly Hills City Council met on Tuesday to discuss the fiscal impact of the COVID-19 crisis on Beverly Hills, closing travel lanes for bikes, and other issues. The council canceled its annual Art Show, which was originally planned for May, due to the stay-at-home order.

The BHUSD Board of Education had a special meeting on Monday, in which they discussed creating virtual graduation videos for Beverly Vista and Beverly High graduates. Graduations for the 2020 classes have not been canceled or postponed as of press time, though schools are preparing for that scenario just in case.

Beverly Hills Rotary Club has continued to meet virtually over Zoom every Monday. It created custom face masks with its logo and passed them out to members last Friday at the fire station while pracsocial

According to Lushing, they are coordinating getting custom masks to other Rotary Clubs outside Beverly Hills as well.

If you are found eligible, an appointment confirmation number will be sent

to your email that can be used the same day. People without internet access can dial 2-1-1 for assistance making an appointment. Immigration status, insurance status, age and underlying health issues do not affect eligibility for a COVID-19 test.

Testing locations near Beverly Hills include Cedars-Sinai Medical Center and the VA Parking Lot 15 on 100 Constitution Ave in West LA. There are currently 29 operational testing locations throughout LA County, which include both drive-up and walk-up sites.

Council Assesses COVID-19's Economic Impact

The City Council analyzed the economic impact of the COVID-19 crisis and consequential business closures throughout the city in its meeting Tuesday night.

An Ad-Hoc Committee and city staff have been developing a financial forecasting model that will predict how the city's finances will be affected by the pandemic. While this model is a work in progress, the council discussed some of its key findings Tuesday.

The COVID-19 crisis is predicted to be different from other recessions because the source of the economic issues are attributed to travel restrictions, temporary business closures, and other social distancing requirements. Past recessions have been linked to underlying economic issues that had built up for several years, such as the housing bubble, rather than sudden economic changes.

Key revenue assumptions in the forecasting model include reductions to Transient Occupancy Tax Sales Tax, Business Tax Licenses & Permits, charges for Services Parking & Moving Violations and other areas of General Fund revenue.

The reductions in revenue are predicted to result in the COVID-19 crisis being significantly worse than the great recession.

During the great recession, property tax went from 9.5% in 2008-2009 to 4.9% in 2009-2010. It's estimated that the property tax in Beverly Hills will shift from 8.6% in 2019-2020 to 3% in 2020-2021.

The fiscal year of 2020-2021 will be where the economic impacts of COVID-19 will be most noticeable, since only the last four months of the 2019-2020 fiscal year have been impacted by the virus.

Los Angeles Mayor Eric Garcetti announced that City of Los Angeles employees will be furloughed Sunday, but there has been no discussion of City of Beverly Hills employees being furloughed as of press time.

School

Fees for New Residential and **Commercial Construction** Approved

New residential and commercial buildings that are developed within the Beverly Hills Unified School District will now have to pay an increased school facility fee to continue construction, after a Board of Education vote last Tuesday.

Assembly Bill 2926 was signed into law in 1986 and established that school districts can impose impact fees on new residential development and commercial development. The State Allocation Board reviews if these fees should be increased every other year, based on state income and other factors. The SAB approved an increase to the maximum school fee to be \$4.08 per square foot on future residential development and \$0.66 per square foot on commercial/industrial development in January

The board reviewed a report on the fee increases in its Tuesday meeting, which highlighted how new residential development has impacted school districts throughout the years and why fees have increased. The board unanimously approved the resolution to implement updates to the residential and commercial buildings fees.

School districts must use these fees to fund construction or reconstruction of school facilities. In order to enforce that they are paid, cities or counties can not issue building permits until a development project pays its fees in full.

Board of Education member Mel Spitz said that he had been very interested to see the report and was glad to see its results.

"I think this is significant for us because anybody that drives around the streets of Beverly HIlls sees there are a significant number of single family residences being torn down and in its place larger square feet are going in," Spitz said.

He added that the difference in squarefoot is now being charged accordingly.

Board member Tristen Walker-Shuman was also in support of the increase and said she was happy with the report.

"This is good news in a time that it's nice to have good news," Walker-Shuman said.

The Reality of Being Labeled a "Non-Essential" Business

Instead of store owners flipping their "closed" signs to "open" on the morning of Monday, March 16, businesses throughout Beverly Hills remained shut for the first day of many more to come.

The Beverly Hills City Council, in a nine hour meeting the night before, had issued an ordinance that would require "non-essential" businesses to close for the foreseeable future in order to halt the spread of coronavirus in the city.

'Non-essential" was applied to a swath of businesses - from fitness centers to live performance venues. But despite the different services each store provides, having to shutter their doors indefinitely has given many business-owners the common struggle of economic uncertainty.

Sabba Kamal, the owner of women's clothing and jewelry boutique Kamal Beverly Hills on North Bedford Drive, said

anymore," Kamal said.

Kamal is able to continue paying her employees a percentage of their salaries, but said her business can't sustain paying their full salary and still survive through the mandatory closures. She's been talking to her accountant about her financial options, including the Payment Protection Program loan that the federal government offered to help businesses continue their payroll. But she doesn't know yet if she's qualified to apply.

"It is definitely disappointing to not be able to carry on with your normal routine, and the challenges of being an employer and then not being able to provide your employees their full salary is very difficult," she said.

Kamal Beverly Hills has an e-commerce store that ships items to customers, but it's had a decline in orders since the lockdown. Kamal said it's been disappointing to not be there for her customers on a day to day basis in the store, like before.

But even when the mandatory closures are lifted, the future for businesses in Beverly Hills still remains uncertain.

Kamal predicts shoppers will have anxiety going back to stores and being in close proximity with other people unless there's a COVID-19 vaccine available. She said since her store is relatively small, when there were about five shoppers it would feel crowded and women would be comfor Los Angeles-area schools," said LACO executive director Ben Cadwallader. 

BHUSD to Create Digital Graduation Videos

The BHUSD is creating digital graduation videos for Beverly Vista and Beverly High graduates, which would cost the district a total of \$44,500.

The BHUSD Board of Education discussed creating the videos for the 2020 graduating classes in a special meeting Monday. According to the board's staff report, the contract for creating the videos with Huntoon & Co. for Beverly Vista graduates will be \$13,000 and \$31,500 for Beverly High graduates.

According to the board's staff report, the district does not want to leave students with nothing if governing authorities advise graduation cannot take place due to the coronavirus outbreak.

Ronald Richards' Letter to the City Council on the Face Mask Ordinance

Dear Mayor and City Council,

Our association received notice that George Chavez, the City Manager, issued the following order on April 9, titled

City of Beverly Hills Director of Emergency Services Order No. 1 Order Regarding The Use of Face Masks and **Temporary Closure of All City Parks**

After reviewing the April 9 order, certain Constitutional issues arose as well as certain portions of the order clearly conflicted with other criminal statutes that could possibly create unintended consequences for members of our community. Furthermore, the order signed by Mr. Chavez as written, interfered with medical and legal professionals engaged in their professions, as well as endangered persons with respiratory issues. Moreover, the order as written, could be applied to infants and the infirm. Finally, the order threatened criminal sanctions for violations even though the order was deficient in both a mens rea or intent requirement and incorporated other non-defined terms that made the statute problematic from a drafting perspective in creating a statute that carried with it jail as one of the consequences.

Fortunately, as always, the City Attorney was amenable to have discussions regarding the genuine legal concerns advanced by myself on my family's behalf and that of numerous parents and residents in the Hillside area. We believe he listened to the concerns and after his own research, has proposed modifications. It is my understanding, the ordinance has grafted upon it, numerous suggested carve outs relating to medical conditions, professional exclusions for lawyers and doctors in the course of their profession, as well as the removal of a conflict between one statute that requires compliance with officer direction (Penal Code 148) versus keeping on a mask as mandated by the statute. The City is also going to supply masks free of charge for anyone that requests them and who does not have them. This should be publicly disseminated. The statute's enforcement mechanism has been reduced to administrative instead of criminal which eliminates a criminal intent requirement and removes a great many of my association's concerns.

As some background, here are some further concepts to consider for this statute. We would like to see the mandating of masks on children between 2 and 10 changed to the discretion of the parents. We support encouraging parents but not forcing them. Frankly, it is optimistic that children between the lower end of this range are going to keep a mask on. They should not be cited by a park rang-

er or police officer for removing a mask. If a child suffers from autism, or some other behavioral limitation, you are putting the child's mental well being at risk by compelling face wear. Also, you are burdening parents with something that will have little medical effect at all and as long as their children are practicing social distancing, there is nothing in the record that suggests compulsion of toddlers wearing masks dramatically increases safety. The City is going too far in mandating mask conscription on the children of Beverly Hills to the extent it would subject them to fines and charges.

We strongly support the proposed professional exemption. Many commercial buildings are closed. The way the order was issued on April 9, medical professionals would be precluded from removing the mask of a patient for treatment. As an attorney, many clients want to meet in person still for privacy and other reasons. Meeting at the residence of the attorney or the client is not practical and could expose the families of each. A public park or talking while walking



sometimes works, or even pulling up alongside vehicles in works. The attorney has a right to speak to their client without government

interference

area

and the client has the right to counsel without the government mandating the parties communicating orally through an opaque mask. Certain attorney disciplines are better practiced if the attorney and the client can see each other's complete faces and expressions. Certain types of information need to be communicated with the full face of compassion or direction, not a face blocked by a face mask. The deficiencies as applied to medical professionals were also obvious and we support the professional exemption that is being considered in the revised ordinance.

We believe there still needs to be a water and food exemption while walking, exercising, or just taking a family stroll. The current order would make violators if the mask was removed to consume an energy bar, water, or to feed a hungry child. Previously, giving an infant a bottle during a walk would criminalize the infant and make the mother or father an aider and abettor. The aftermath of the April 9 order was a textbook example of why orders like this should have the benefit of public input.

The order should exempt anyone who gets congested and has to medically expel sputum or for any reason, believes the mask is preventing them from breathing properly or from having normal bodily functions. The order should excuse temporary removals of the face mask for these things and not make people feel that they have to cause themselves physical discomfort because they are having a short mucus issue or are simply thirsty.

The order should allow removal of the mask in connection with any application for a government ID like driver's license, passport photo, or visa photo.

The order should make clear that anyone who wears it while driving with the windows open is not violating Penal Code section 185 which prohibits the wearing of a mask to hide your identity in the commission of a public offense. For example, if they run a red light camera (21453 Vehicle Code) and are issued a citation, the wearing of the mask may clear them of the ticket but the police can't claim they violated the face mask wearing section of the Penal Code. So we are clear, all infractions are public offenses. The statute should make it clear driving a convertible through a red light with a mask will not make you a violator of the state's face mask law.

You should also note the CDC does not criminalize or mandate face masks simply to go outside the home. They recommend them. The LA County ordinance requires businesses open to the public like a market or store to have their customer's wear masks. The LA County mask guidelines are not directed at individuals. They only are required for essential businesses open to the public. This order goes above any guideline in LA County. I have attached a copy of the April 10, LA County Safer At Home Order. I have also attached the latest CDC page on face masks

The current order actually violates CDC guidelines. The CDC carves out certain individuals and recommends a mask when social distancing is not practical, like a grocery store. We believe the current order was issued based upon a misunderstanding of the various and ever changing directives from multiple public health officials. The check and balance is that now the City Council gets input from its constituents, many of whom are Constitutional attorneys who have spent their entire careers protecting the rights of the accused, the Constitutional, and have drafted criminal statutes. We believe the current order needs to be dramatically changed to comply with the County and CDC guidelines,

the California and US Constitutions, and remove undue interference with essential business professionals and parents. We look forward to next week's meeting and hope you will consider the revised ordinance and some of our suggested further revisions

Finally, this virus nor any past virus, did not tear up the Constitutions. People still have the right to protest, to assemble for the sake of political protest, etc. The current order should make it clear that nothing is intended to abridge or limit lawful protests. You will note that not a single health order precludes lawful protests nor was martial law declared. Please feel free to contact me with any questions and thank you for reading this letter.

Editor's Update from April 21 City **Council Meeting**

The Council considered the face mask ordinance at its meeting on Tuesday, in which Richards shared his legal criticisms of the law during public comment and councilmembers read his letter above

People who don't comply with the face mask ordinance will now face monetary fines, among other changes made in the ordinance's revisions Tuesday. The first citation costs \$100, the second will cost \$200 and the third will cost \$500.

Richards later sent an email to Mayor Les Friedman and Vice Mayor Robert Wunderlich in which he said the council shared mistaken facts and legal assumptions when they were discussing the ordinance. He said an update to the law was passed based on no science and erroneous legal analogies to a New York law.

"The public was not on notice you were going to consider that NY order. The public was deprived of comment as no one knew in advance that NY order was on the table," Richards wrote. "Had this been part of the packet, I for one would have addressed it legally.

Richards added the updated law is better than the one issued on April 9, but the council's reasoning was based on inaccurate legal assumptions.

He said he could not rebutt or address anything the council discussed after his initial comment, even when the council spoke of his statements specifically, because of the meeting format.

"This is embarrassing and could have been avoided if public comment was not abridged and meaningful or there is a stop button before you vote," he wrote. "That would make the process better and more accurate.'

Richards recommended the council reopen public comment so the public gets to comment on a new order that was not *in the packet.*

coverstory **TOY FACTORY BECOMES HOSPITALS' LIFELINE** MGA Entertainment CEO Isaac Larian on **Producing Medical Supplies Amid Pandemic**

By Ani Gasparyan

Isaac Larian, CEO of MGA Entertainment which is best known for its creation of the Bratz dolls, has begun donating to hospitals across the country. However instead of toys, he's now producing and donating medical supplies.

Larian's company has shifted to producing face masks and ventilators to be distributed to at-need hospitals in the U.S. and internationally. Larian answers

some questions about why he started this program, which he has dubbed "Operation Pac-man."

What is your company doing to assist hospitals during supply shortages?

We set up this nonprofit organization called MGA Entertainment Cares Operation Pac-Man, where we have [funded] this organization with \$5 putting PP material and freely distributing them to hospital workers at the frontlines. To date, we have PP materials to over 70 hospitals and we continue to do so.

Why did you decide

to name this "Operation Pac-man"? I wanted to make sure that it is fun, we're in [the] toy business. When you look at Pac-Man, it's eating the balls. I thought it would be fun and get publicity for us so people can join us.

Why did you want to help hospitals in this way?

I have a lot of friends who are doctors and I started getting calls from them panicking and saying they cannot get basic supplies, they're worried about their own health trying to help others and [asking] if MGA with our supply chain can help. We have offices all over the world, so we decided to do that. We did that when the virus happened in China first, we bought and shipped PP materials to China. Now we're doing the reverse of it.

In an April 13 LA Times article, it read

masks? Really, there are two kinds that we created. [The first] we did [in] collaboration with UCLA. The issue is, if a patient has this virus and is in intensive care or hospitalized, they can infect other people. Whether they sneeze or even the act of breathing. When the patient's situation becomes severe, they have to be put on ventilators or other devices. The way the ventilators work is with intubation, so you literally put a tube down the patient's throat in his/her lungs to put oxygen in there. The patient usually gags or spits, and those particles can come out and infect the doctor or nurse. The first type of these masks is basically worn by the doctors or nurses. It's completely airtight [and] it's connected to an oxygen source. So when they are administrating ventilation or other services, they don't get infected.

Who invented these masks?

We have our designers and engineers at MGA [who] came up with these about two [to] three weeks ago. We're in production now. We have shipped some of those to UCLA, as I mentioned, and we are getting FDA approval. Hopefully, we will ramp up and ship it to everybody else.

You have a factory based in Ohio. Tell us a bit about where your products are produced, including your masks?

We own Little Tikes and Little Tikes has had a factory in Hudson, Ohio for the past 50 years. As a matter of fact, [it] is the largest standing toy factory in America still. We have converted a portion of that factory to produce not only these masks, but also face shields and other products.

With the pandemic, businesses have had to close their doors and people aren't shopping as much due to economic anxiety. How has your business been affected by the virus?

Yeah, it has been affected drastically like every other business. When stores such as Kohl's, and other retailers who buy our products, they're just closed. Consumers cannot go and buy them. So it has definitely adversely affected our business so far.

I'm an optimistic person. But even with my optimism, I think our business, like every other business, is going to be affected for at least 12 months.

How is your company adhering to new regulations meant to prevent COVID-19, especially considering you still have employees creating masks?

We are 100% compliant. I am happy to report that we had an inspection from the Health department in Ohio where they said we have gone above and beyond the regulations. They took some of the things that we do, to recommend for other factories. The safety of our employees is our number one concern.

Everybody has to wear masks from the moment they walk into the door. We have hand sanitizers all over. In the factory, we have put taping on the floor [to mark it so] every employee is six feet away from another employee. We have cut back

our shifts. At peak, when we had let's say 300 workers in the factory, we cut that back drastically so it's crowded. We don't have to do that, but we're doing it because [the] safety of our employees is most important to us. So far, knock on wood, it has been good. We have not had any bad situations.

How can hospitals get your supplies donated to them?

Basically, all they have to do is go on our website mgaecares.mgae.com. They can order what they want from there or they can donate.

You mentioned that people can donate on your website, but how else can people help out with your cause?

Give us ideas [on] how we can do what we do better. We set this up literally three weeks ago, we are not experts in charities and how they work. So we welcome people's contribution, even suggestions on how we should do things better.

To end on a positive note, do you have any advice for people and other major business-owners during this time?

I went to India in November, and took a meditation class called "Vipassana"silent meditation. One of the things that I learned during that 10 days is that nothing in life is permanent and everything will be fine. The best thing is to be happy. This shall pass. I know people are anxious from sitting home [and] etcetera, but look at this like a vacation. It will pass soon and [you can] go on with your life. It doesn't do any good just to be anxious and worried.

I have learned that the more I give, the more I get. There's a satisfaction in giving. So do whatever you can do to give, whether you make a donation - no necessarily to Operation Pac-man. Any legitimate organization that is doing something to help in this pandemic. Donate time, donate money if you have [it], and be positive.

My advice for other business owners is, frankly, step up to the plate. Do something, anything. A lot of people, unfortunately, think that it's not [their] problem. It's everybody's problem. For me, [just] after I launched Operation Pac-Man, it hit me at home. My aunt died from this and my cousin is in intensive care.

"It's pretty amazing actually that we have something that spread so quickly, that's been as lethal as it has," Gold said. "It's frightening, it's a throwback to the days of other types of plagues and the flu epidemics.

Gold added that the death rates are slowly coming down, as healthcare professionals gain more experience handling it.

The councilmember also shared how Beverly Hills has been fairing with the pandemic and what city ordinances have been passed to slow its spread. He said Beverly Hills has begun requiring face masks be worn in public, similarly to the


