City Announces Change to Beverly Hills Police Department After George Floyd's Murder

The City of Beverly Hills is reviewing its police policies and procedures in response to George Floyd's murder by Minneapolis police officers and has temporarily banned the carotid control hold.

The City Council has requested a review of the Beverly Hills Police Department's policies. There will also be a meeting with community members in the future to listen to their concerns and suggestions about the department.

According to the city's website, the '8Can'tWait' movement has cited eight policy suggestions about law enforcement's use of force which the city already addresses.

The city compared itself to '8Can'tWait' suggestions by stating the following; it already does not not allow for use of chokeholds or strangleholds, de-escalation techniques are already in use, officers are trained to give verbal warnings, officers only use the amount of force that reasonably appears necessary given the facts and circumstances, officers are required to intercede to prevent the use of unreasonable force and also require the reporting of those instances to a supervisor, shooting at moving vehicles can only be used when there are no other ways to address the threat of great bodily harm posed by the vehicle and written reports are required after force is used

In addition, Interim Police Chief Dominick Rivetti informed Beverly Hills Police Department officers Sunday that use of the carotid control hold will be suspended until further notice.

Gov. Gavin Newsom informed Califor-

nia's Peace Officer Standards and Training that it would need to remove training courses that use any form of the carotid control restraint Sunday. The department has thus made the decision to suspend its use and training, according to an email Rivetti sent police staff.

"We believe it is prudent to keep all of our training consistent with POST standards and policy; therefore, we are suspending the use of the Carotid Control Hold until we see what direction the state legislature, governor, and POST officially moves forward with," Rivetti wrote.

Businesses Move Forward After Looting and Graffiti, Davs After Re-Opening

Rodeo Drive, once filled with luxury shoppers and tourists, has been empty for months - first due to the city's stay-athome order and later due to looting amid protests against police brutality on May

The lootings, which were mainly concentrated at an Alexander McQueen store, resulted in the City of Beverly Hills issuing a 1 p.m. curfew for its business district and businesses boarding up their windows early last week.

Multiple stores had graffiti sprayed onto them, with phrases like "Black Lives Mat-

ter" and "Justice for Floyd." Some stores had their windows shattered as well, including an Avedon store

Nicola Ca-Presgliata, ident of the Rodeo Drive Committee. said its unique

how businesses were closed due to the COVID-19 outbreak and are now closed because of the riots.

"We didn't have enough time to go back to work ... to feel [a] difference," Cagliata said. "It just feels like we just kept going on a path that we've been [on] for almost three months now."

He said business-owners are sad and worried - but they understand that safety must come first and the situation is developing.

Cagliata's store is part of the Richmond Group, which is a regional group that owns several brands, and was not looted. He said if you drove past it last Wednesday, it would be boarded up like all other stores on Rodeo Drive.

"I know that many [other businesses] were signed with graffiti and things like that," Cagliata said. "But after [Saturday] I think everybody eventually boarded up.

Protests did resume throughout Los Angeles last week, but there was no further looting in Beverly Hills.

"We are very sad and worried about the outcome of what happened this past weekend at Rodeo Drive. But at the end of the day [it has] also been explained to us how the situation was properly managed,"

Cagliata said. "And even though it looks like there was a lot of criminal activity on Rodeo Drive – it was actually pretty much contained."

More Black Lives Matter Protests in Beverly Hills

Demonstrators gathered in Beverly Hills throughout last week to protest against police brutality and the deaths of George Floyd, Breonna Taylor and Ahmaud Ar-

There were around 100 protesters Friday, according to the City of Beverly Hills Public Information Manager. They gathered on the corner of La Peer Drive and walked down Wilshire Boulevard.

There have been no incidents of looting or violence since earlier this month, when protests first broke out throughout Los An-

According to the Los Angeles Times, Black Lives Matter organizers have intentionally organized protests in predominantly white and affluent neighborhoods. 81.1% of Beverly Hills residents were White, 9.5% were Asian and 1.7% were Black in 2019, according to the U.S. Census Bureau.

The LA Times reported that BLM organizers want to convey their message to communities that don't face police brutality and can therefore ignore the issue.

Ron Hasson, the president of the NAACP Beverly Hills and Hollywood chapter, said there is a need for the city to look at and address its actions.

"The question is policies and procedures moving forward - whether they're looking into [if] they're working and whether [there] is systemtic discrimination and [looking] at those laws that are not reasonable in terms of the treatment of people of color," Hasson said. "And certainly in the fact that the police department has had a [consistent history] for their past actions."

Hasson is likely referring to the Beverly Hills Police Department's former Chief Sandra Spagnoli, who retired earlier this year. The city had faced an array of lawsuits against Spagnoli since she was first hired in 2016, including allegations of racism, ageism and sexual harassment.

City Declares Local Emergency Over Protests and Riots Against Police **Brutality**

The City of Beverly Hills once again declared a local emergency Friday. This time not regarding the pandemic response, though — rather protests against police brutality.

Protesters gathered in Beverly Hills May 30 in response to the murders of George Floyd, Breonna Taylor and Ahmaud Arbery. A riot and looting later broke out on Rodeo Drive, the brunt of which was reportedly concentrated in an Alexander McQueen store.

In response, City Manager Geroge Chavez declared a local emergency and enacted an 8 p.m. curfew. The City Council unanimously approved ratifying the local emergency Friday.

Chavez or the Director of Emergency Services are able to use city funds without limitations or a bidding procedure under a local emergency proclamation, according to a city staff report. Purchases are excluded to supplies, equipment or services needed for the emergency and councilmembers must approve the expenditures.

The city's expenses for the protests have been taken from the 2019/2020 budget and are being documented to submit to the Federal Emergency Management Agency in case a 75% reimbursement becomes available as of press time, according to a city staff report.

City Repairs Public Artwork By Ringo Starr, Roxy Paine, Others After Vandalization

Several of the city's public artworks were repaired in early June, after being graffitied during protests against police brutality the day prior.

Rivetti Reflects on Weekend Demonstrations Against Police Brutality

Interim Police Chief Dominick Rivetti reflected on the protests in Beverly Hills last Wednesday, saying that the police department did a professional and courageous job of protecting the city in an interview with the Weekly.

Rivetti said protesters came to the city in mainly three groups. The first group had over 2,000 people, the second had approximately 1,200 people and the final group had over 500 people. He said the protests in Beverly



68 protesters had been arrested between May 30 and June 3. They were arrested for a variety of charges, including vanand dalism looting. One looter also shot another looter, who sustained

minor injuries and was taken to the hospital.

The department enforced curfews and received aid from other police departments and the National Guard throughout last week. Rivetti said the department will be doing everything it can to keep the city

"We are in maximum deployment and will be on maximum deployment until the violence and the threats to our community stop," Rivetti said. "We're utilizing mutual aid - we have the National Guard here."

He added that the curfew, which was set for 1 p.m. in the city's business districts and 4 p.m. in surrounding areas, is an important tool to keep the community safe and determined by city leaders day-by-day depending on the conditions.

Another protest was held last Tuesday, which dissipated at 1 p.m. Rivetti said they were cooperative and the police department was in communication with the organizers the entire time.

"We had, maybe at one time, probably 200 demonstrators that came in earlier in the morning," Rivetti said. "And they did their demonstrations, protests and marches and we accommodated that."

Rivetti said the police department is doing everything it can to help facilitate people practicing their constitutional rights, but violence and criminal activities can't be tolerated.

"What happened to Mr. Floyd is a tremendous tragedy, it's hard to watch that on T.V.," Rivetti said. "You can't describe how bad that is and how badly it reflects on our profession even though 99.9% of police officers are very professional and do a great job of protecting their various communities.'

Arts and Culture Commission Approves Sculptures Addressing Anti-Black Stereotypes, Celebrating Black Identity

Life-size sculptures that celebrate black

identity and disrupt anti-black stereotypes by the artist Genevieve Gaignard will be displayed in Beverly Hills Garden Park in the future.

Gaignard first created her sculptures by taking the heads off of "mammy" figurines – a racist archetype of black women

that was prominent throughout the United States, particularly in the South. She then put the heads on dolls in dresses.

'The mammy figurines are such a disrespectful image of how blackness was portrayed in America, so I collect these two items and remove the heads from both," Gaignard said in a presentation to the Arts and Culture Commission. "The mammy head is then put on the body of the doll in the dress, which is then seamlessly put together and repainted, and now is having this new moment where she can just be this whimsical, free creature and not this stereotype of blackness."

The Commission unanimously approved the sculptures.

The total cost of the project, including materials, creation and promotion, is estimated to be \$480,050, according to a city staff report. The city will conduct fundraising to help pay for the art pieces, with a goal of raising \$437, 500.

According to a city staff report, Gaignard wants to display the sculptures in a public space to "stir-up the sanctity of white spectatorship, celebrate Blackness, and infiltrate spaces of hegemony."

The sculptures were originally proposed to be 9 feet high and created from laminated fiberglass with gelcoat surface, internal stainless steel armature, seaming, chasing and smooth surface preparation with primer, base coat paint, scenic decorative painted elements and a gloss acrylic urethane clear coat, according to a city staff presentation.

"I thought it was sad that there's no relatable figurine for a black woman," Gaignard said in the presentation. "She's always in the position of server or entertainer—not the belle of the ball, I decided to change that."

Rent Stabilization Commission Hosts First Meeting

The Rent Stabilization Commission held its first meeting last Thursday over GoToMeeting.

The Commission was created to give recommendations to the council on rent stabilization and any other additional duties the council determines.

The Commission is made up of at-large members, which include its Chair Lou Milkowski, Donna Tryfman and alternate Ryan D. Gurman. It's landlord members include Remmie Maden, Neal Baseman and alternate Frances E. Miller. It's tenant members include Kathryn Cavanauh, Gwendolyn Owens and alternate Kathy Bronte

Baseman was selected as Vice Chair by random selection, in which Milkowski pulled a name out of a hat.

Commissioners were also divided into two-year and four-year terms. According to City Attorney Larry Wiener, Commissioners who have two-year terms can serve for a maximum of six years and those who have four-year terms can serve for a maximum of eight years.

Baseman, Milkowski and Cavanaugh will have two-year terms, while Maden, Tryfman and Owens will have four-year terms. The length of terms was randomly selected by Baseman by dividing names into even and odd numbers.

Alternates, who are Gurman, Miller and Bronte, automatically have four-year

Five Commissioners are required to be at every meeting to have quorum - two landlords, two tenants and one at-large member, according to a city staff report.

Its meeting June 3 was primarily to train new Commissioners and set dates for future meetings. A representative from the City Attorney's office gave a presentation on Brown Act Training, Commissioner Handbook Training and Rent Stabilization Ordinance Training.

New Textbooks Approved for **Beverly Vista Students**

The BHUSD Board of Education approved new science textbooks for Beverly Vista students Tuesday.

The middle school's current science textbooks were initiated in the 2007-2008 school year. Its new books will cost \$146,201.19, which will be funded through the District Textbook Lottery Funds.

Beverly Vista's science department had completed an analysis of textbooks and support materials to determine which new textbooks to adopt, according to a board agenda. It narrowed down the search to four publishers that met instructional needs and fulfilled state requirements.

After a presentation from each publisher, the adoption committee recommended the SAVVAS Learning's "CA MS Elevate Integrated Science' programs." The agreement is recommended for a five-year adoption cycle.

City Council Will Consider Labor Agreements at the June 16 City **Council Meeting**

The Beverly Hills City Council will consider the memoranda of understanding with the Safety Support Association and Firefighters' Association at the Tuesday, June 16 City Council formal session beginning at 7 p.m.

In accordance with state law, the City of Beverly Hills participates in labor negotiations with its employee associations. The results of the negotiations process are written agreements or contracts reached between the city and the city employee associations. These agreements are commonly referred to as MOUs.

The Safety Support and Firefighters' MOUs have been ratified by the respective employee associations and are subject

to the adoption of the City Council on June 16. The proposed Safety Support Association MOU covers salaries and benefits for a four-year period, and the proposed Firefighters' Association MOU covers salaries and benefits for a five year and eight month period.

The MOUs, independent fiscal analyses, and summaries of significant terms are posted on the City's website at https:// www.beverlyhills.org/negotiations.



Current events are now inspiring an impassioned outcry for justice and demands that each of us explore our explicit or im-

We have watched with optimism as people have exercised their First Amendment rights by taking to the streets to advocate for much needed and overdue change. Yet we are dismayed that some opportunists have used these protests as a cover to bring deliberate destruction and looting to our communities

We are taking this opportunity to listen to the concerns and demands of the protestors and reflect on how we can engage in better community policing in our neighborhoods

We must seize this moment to ensure our leaders and police departments reform policing and eliminate the corrosive impact of racism in our society. One issue that needs immediate attention is the use of tear gas/pepper spray for crowd control. The use of tear gas has short and long-term negative health impacts, and when combined with the COVID-19 virus those negative impacts are only exacerbated. Just this week an open letter to law enforcement, which was signed by nearly 1,300 medical and public health professionals urged the police to stop using 'tear gas, smoke, or other respiratory irritants, which could increase risk for COVID-19 by making the respiratory tract more susceptible to infection, exacerbating existing inflammation, and inducing coughing.'

To our constituents we want to leave you with this; we share your anger and join you in your pain; we are listening. We promise real change that affirms that, in California, Black lives matter."

Wilshire to Reopen Monday

Wilshire Boulevard is anticipated to reopen June 15, after being closed for approximately two and a half months for Metro Purple Line construction.

According to Metro Communications Manager Dave Sotero, the crews worked extra to make up for lost time caused by the City of Beverly Hills' curfews. Beverly Hills had curfews earlier this month in response to a Black Lives Matter protest in the area that broke out into looting.

"All deck beams and deck panels have been placed," Sotero said in an email statement. "Our contractor needs to perform additional work to restore the street and sidewalk around the decked-over station excavation."

A portion of Wilshire Boulevard was closed April 2 for Purple Line construction, to take advantage of low traffic caused by the COVID-19 pandemic and consequent stay-at-home orders.

"Prior to COVID-19, we anticipated that decking would have been completed during 13 weekend closures stretching into early 2021," Sotero said in an email

Taniguchi said stories bring a sense of wonder and curiosity and recommended several books for Beverly Hills residents to add to their bookshelves this summer.

For young readers, she suggested "Look Both Ways: A Tale Told in Ten Blocks" by Jason Reynolds, "The Unteach-

ables" by Gordon Korman, "New Kid" by Jerry Kraft, "Be Prepared" by Vera Brosgol and "The One & Only Ivan" by Katherine Applegate.

"I almost didn't read ["Look Both Ways: A Tale Told in Ten Blocks"] by the way because the first chapter was two children, a boy and a girl [who are] two friends, and their conversation started out about boogers... but I pushed myself to read it and I absolutely loved it," Taniguchi said. " And I hope to recommend it to lots of young

For children, she recommended "Camp Tiger" by Susan Choi, "The Cardboard Kingdom" by Chad Sell, "Fox the Tiger" by Corey Tabor and "Saturday" by Oge Mora.

"Some of my favorite books are [by] children's book authors," Taniguchi shared.

Lewis was published in two literary magazines before 'Raw Temptation" was released. She recalled when her middle school teacher told her about a flash fiction contest, which she participated in and won.

"[My middle school teacher] was really inspired by [my story] and he was like 'There is a flash fiction thing that's going to be going on at our school," Lewis said. "So I entered, I ended up winning first place and that's how I got published for the first time."

Lewis is a member of WriteGirl, a non-profit organization that promotes young girls in their writing. She has also been published in their magazine and currently serves as a mentor with the group, helping younger girls with their own writing ambitions.

But despite all this, Lewis said she doesn't plan on being a writer full time. She said she's considering going into psychiatry or veterinary school.

"I think it'd be awesome but when you become a writer professionally you have deadlines and you have

stuff like that," Lewis said. "I think for some people that I've talked to, it's taken the fun out of it at times so I think I would want to just keep it as a hobby.'


