BHUSD Schools Remain Closed as LA County Remains on the COVID-19 **Monitoring List**

Superintendent Michael Bregy said BHUSD schools can not reopen until Los Angeles County is off the COVID-19 monitoring list for 14 consecutive days last Tuesday, in a BHUSD Board of Education meeting

According to Bregy's presentation to the board, Los Angeles County must meet six metrics to get off the monitoring list. Once it does, schools in the county may reopen in accordance to Gov. Gavin Newsom's order.

The metrics include: 150 daily COVID-19 tests performed per 100,000 people in the county, a testing positivity rate below 8%, case rate per 100,000 residents below 100 cases, hospitalization rates, available ICU beds and patients using ventilators.

Bregy said that LA County has been struggling the most with the third metric - having a case rate below 100 cases per 100,000 residents.

'With six metrics that we've been looking at and following everyday, there's one metric that seems to be standing in our way and that is the metric for the case

rate," Bregy said.

As of last Tuesday, Bregy said the county has been making some progress. The LA County case rate was 197 at the time of last week's board meeting, which Bregy said the district is monitoring everyday.

Council Reviews Audit on City's Real Estate Portfolio and Property Management

The City Council reviewed an audit report on the city's real estate portfolio and property management Tuesday, in accordance with the city's annual audit work plan.

According to a city staff report, the audit covered the fiscal year 2016-2017 through 2018-2019. The audit's goals were to identify city assets, determine if the city can manage its asset portfolio, determine the value of its assets, identify any potential uncollected revenue and assess city staff's capacity and structure for managing real estate.

Beverly Hills reorganized its real estate operations to have new personnel in 2016. Former Beverly Hills Property Manager Brenda Lavender pled guilty to felony grand theft and was sentenced to threeyears probation, 200 hours of community service and was ordered to pay \$100,000 in restitution to the city in 2017.

Lavender had not collected more than \$800,000 from a city tenant in the span of three years, did not report that the tenant had not made their lease payments and did not report a \$15,000 loan she received from another tenant.

According to a city staff report, the city has not addressed all the findings and recommendations from its 2016 audit. The 2016 audit revealed the city has issues collecting late rent fees and inconsisten-

cies between lease inventories and lease documents.

The audit report states that those deficiencies are due to the following issues, according to a city staff report:

• A lack in proper man-

agement oversight, adequate staffing and resource capacities, clear policies and procedures, and a strategic plan necessary for the management of commercial-leased properties.

- A lack of performance metrics.
- The city does not have an Asset Management Plan.
- The city does not always assess common area maintenance charges as required.

The audit report recommended 13 changes to the city's property management, which city management has agreed with. These include the following, according to a city staff report:

• A designated person is accountable for

- Beverly Hills will create an Asset Management Plan.
- Policy and Management will continue its review of Administrative Regulations.
- Policy and Management will establish baseline performance metrics.
- Policy and Management will develop standard lease late fee language.
- City Manager George Chavez or a designee will develop and implement a policy for assessing common area maintenance.
- Policy and Management and the Finance Department will assess updated late fee and common area maintenance clauses
- The Public Works Department will continue to capture labor, time and parts and materials costs.
- The Public Works Department will formalize written policies and procedures for maintenance requests.
- Policy and Management will update and/or develop staff responsibilities.
- Policy and Management will review and update inventory on a periodic basis.
- Policy and Management will provide updates to the council on its progress on real estate management.

City Shares Plans on Voting Centers and Ballot Drop-off Boxes For November 3rd Election

The City of Beverly Hills is making preparations for the upcoming November 3rd elections, which include establishing the locations of in-person voting centers.

Beverly Hills will have two Vote By Mail drop boxes, according to City Clerk Huma Ahmed. They will be placed in City Hall and Roxbury Park and accessible 24 hours a day. Each box has a capacity of 5,000 ballots and will be managed by the Los Angeles County Registrar's office.

There are also three USPS facilities in Beverly Hills for ballot drop-offs. These facilities include the Beverly Hills Main Office, the Crescent Postal Store and the South Beverly Station.

Ahmed said the post office has assured the city that they will do everything in their power to ensure that the ballots reach the LA County Registrar's office. According to Ahmed, the post offices have been working with the LA County Registrar's office and the California Secretary of State's team.

"In light of various concerns regarding the mail system, our office has been in contact with our local Beverly Hills USPS officials," Ahmed said. "Representatives from the post office have indicated that they have special measures in place to ensure that vote-by-mail ballots are forwarded directly to the Los Angeles County Registrar Recorder County Clerk's office."

She said ballots must be postmarked by Tuesday, November 3rd to be counted.

The city will also have in-person vote

centers, despite the pandemic. Ahmed said the pandemic is one of the reasons the ballots are being directly mailed to registered voters and in-person vote centers are being reduced.

"Per the California Elections Code, an in-person vote center is required for voters to cast their ballots should they wish," Ahmed said.

Ahmed shared four locations for vote centers: the first floor of the 450 North Crescent Parking Structure, Horace Mann School's auditorium, the Beverly Hilton Hotel's Wilshire Ballroom and the Beverly Hills Women's Club.

She added that her office has also looked at Roxbury Park as a potential vote center. She said the city is not done looking at options, but that it needs to have some vote centers in place before it adds more.

Ahmed also shared that LA County has developed an online system called "Ballot Trax," which is a mail ballot locator and notification system.

BHUSD Shares Plans for Return to School Once Pandemic Restrictions Lift

The BHUSD shared its plans for returning to school – once that becomes a possibility for LA County schools – with several COVID-19 health and safety precautions in late July.

The district's Return 2 Learn Think Tank, a group organized to help plan out the necessary steps and precautions each BHUSD school will have to take during the pandemic, presented what the reality of reopening might look like for some schools.

According to the group's presentation, Beverly Vista might have a new entrance on Elm Drive that students would have to line up six feet apart to enter. They may each be monitored for COVID-19 symptoms, such as fever or loss of taste, before they are allowed into the school.

An isolation room was proposed to be designated for any students who exhibit COVID-19 behaviors to wait in while they wait for their parents to pick them up. According to the presentation, this is to prevent any sick students from infecting others.

Among other precautions include restroom monitoring, signage reminding students about COVID-19 symptoms and safety measures and certain high-touch areas of campus, like water fountains, will be closed off.

The group recommended "custodial checklists" for each classroom and office, to ensure that necessarily cleaning tasks like vacuuming and trash removal are completed. This may be displayed on the back of the door.

Porous furniture would be removed for reopening, according to the presentation.

The Think Tank said that they have several unique obstacles that still need to be considered, which includes how to conduct lunch time, cleaning between lunch and classes, how dismissal will operate and what happens to the rest of the school when there is a single infection.

BHUSD Board of Education candidate Frank Chehcel said the middle school and the high school have a unique challenge, because just one infection will cause a bigger issue than the elementary schools.

"In the elementary school, you have one class that generally has one teacher and those kids are together most of the day,"

Chechel said. "In middle school, if one kid becomes sick six or seven teachers are then needing to quarantine and probably a hundred to 150 kids need to quarantine. Basically – a third of the cohort if

my math is right."

The district's elementary schools, Hawthorne and Horace Mann, will similarly monitor students for COVID-19 symptoms before they enter. Many of the other schools' proposed plans shared in the board's July meeting were similar to Beverly Vista, with some exceptions such as potentially buying new desks for certain grades to make classrooms engaging despite social distancing requirements.

Council Approves Emergency Stockpile Purchase

The City Council approved the purchase of stockpile emergency food and water supplies Tuesday, in order to prepare for future emergencies like the COVID-19 pandemic.

The City Council first approved funding allocations for emergency food and water supplies on June 29. This included \$418,285 for stockpiling emergency food, water supplies and storage for those items.

According to a city staff report, city staff solicited unsealed written bids to receive the emergency food supplies more quickly due to the virus. The city accepted Emergency Essentials Holdings, LLC's bid for \$50,000, which City Manager George Chavez approved.

Councilmembers approved the change purchase order, which will allow city staff to use the remaining \$368,285 for more emergency stockpile supplies.

According to a city staff report, all Beverly Hills households will be given a three day supply of food and one five-gallon refillable water container during an emergency. The water container can be refilled at water reservoirs, mobile water trailers and other water resource locations in the city.

Planning Commission Debates Allowing Modifications to Lexington Drive Mansion, Fears it Would Become "Party House"

The Planning Commission considered proposed modifications to a mansion on Lexington Road last Thursday, with some commissioners expressing concerns over

the home becoming a party destination.


Built in 1979, the single-family residence on 1506 Lexington Road has a lot area of about 67,031 square feet. According to Zillow, its estimated home value is \$47.7 million.

Gabbay Architects, which has designed several buildings in Beverly Hills such as the Nessah Synagogue and La Cienega Medical Building, is the architect for the project. The architectural group applied for several modifications to the Planning Commission's previous approval of a Hillside R-1 permit, on behalf of Ming Hsieh.

These modifications include increasing the space covered by an open-sided cabana, adding roof canopies and floor plan changes to the home's subterranean garage.

Commissioners approved the amendments to the previously approved R-1 permits with a 5-0 vote, under the condition that the property-owner agrees to limit the number of large events in the cabana area consisting of more than 50 people and events in excess of 100 people are limited to four per year.

The property-owner had been the first to offer limiting parties at their home to four each year. They may exceed these limitations once a year, as long as they give at least 48 hours notice to the Director of

Community Development.

Chair Peter Ostroff said no one is accusing the homeowner of proposing to have a huge party where there are gunshots.

"But we need to protect the community," Ostroff said.

Ostroff was likely referring to a large party held near Beverly Hills in early August, which made headlines after one person was killed and at least three were injured from gunshots.

Vice Chair Lori Greene Gordon said the project had made a major turnaround since she viewed it with Ostroff and city staff earlier that week, when they had concerns about the home becoming a potential party house.

Gordon said she read the homeowner's bio and saw they are not the kind of person who is going to have the kind of party houses they have seen in the news.

"I hope this is a family home that you will continue to use for many years," she said.

Gordon later added that she doesn't want to be too restrictive, so if the homeowner's daughter was for instance getting

married they could not have 250 at their home.

"I just want to be sure that everyone is comfortable with this restriction, because I want to be fair," she said.

Commissioner Andy Licht said it is a beautiful project and he does not view the restriction on the number of parties as necessary.

"I think it was very generous of the applicant to offer the restrictions on four parties a year. I'm not really clear why that's necessary," Licht said. "I don't know of any other home that we have imposed such a condition on."

Last Thursday was not the first time Commissioners had discussed the Lexington Road home.

The Planning Commission had first approved a Hillside R-1 Permit for the mansion in 2013, which involved the construction of a subterranean parking garage, basement mezzanine and abovegrade cabana.

In 2015, the commission approved modifications to the permit which allowed for the construction of an open-sided cabana and a subterranean parking garage with a below-grade mezzanine.

LA County Permits Hair Salons, Barbershops to Reopen with Limited Capacity

The County of Los Angeles issued an updated Health Officer Order Wednesday, which continues to relax restrictions during the recovery period from the COVID-19 pandemic.

Hair salons and barbershops can reopen in LA County indoors at 25% capacity. This update allows businesses in the City of Beverly Hills that fall within these categories to begin operating immediately if County Department of Public Health guidelines and Appendix H protocols can be met.

When provided by the county, the updated appendix will be available at beverlyhills.org/coronavirus.

Hair Salons and barbershops are encouraged to continue operating outdoors through the City of Beverly Hills 'Open-BH' program, as limited capacity for inside services will continue for some time. For more information about applying for an OpenBH permit to move salon services outside, visit www.beverlyhills.org/Open-BH

Nail salons may not operate inside under the current LA County Health Order and must continue to operate solely outside.

Wednesday's updated order also allows for limited, on-campus operation for schools in LA County. Beginning Monday, September 14, schools K-12 may offer in-school services for small cohorts of students with Individualized Education Plans, students requiring instruction for English as a Second Language or students needing assessments or specialized inschool services, as long as the school is able to fully implement the County Health Officer's re-opening protocols.

The Department of Public Health will

not be opening the waiver program for instruction of students in grades TK-6.

City Announces Proposed Solid Waste Rate Increase

The City of Beverly Hills will begin notifying residents and commercial businesses about its proposed solid waste rate adjustments and upcoming town hall meetings scheduled in the coming months this week.

If approved at a public hearing scheduled for October 27, the proposed rate adjustments will be effective starting July 1, 2021 with future adjustments occurring annually for the next five years.

According to the city, the proposed rates for solid waste services are meant to ensure adequate revenues are available to deliver services to the community.

As the cost to provide solid waste services continues to increase for the city, cus-

tomer rates are reviewed regularly to ensure that customers pay the correct charges for the type of service they receive. This is the first time the city has proposed a rate adjustment since 2011.

Beginning in 2021, a single-family residential 6,620 square-ft. lot, for example, will see a bimonthly increase of \$6.75 while multi-family residential housing will see an increase of \$5.38 per unit. In addition to the proposed rate adjustments, there will also be changes to commercial and residential services.

"While we understand the hardships many are facing during COVID-19, we have worked to ensure this rate increase is minimal to continue providing a high quality service to the community," said Public Works Director Shana Epstein.

Council Debates Recording Liaison and Ad Hoc Committee Meetings

The City Council debated whether liaison and ad hoc committee meetings

should be recorded and made available to view on the city's website Tuesday.

The city currently records and uploads videos of City Council and City Commission study sessions, regular meetings and special meetings. While liaison and ad hoc committee meetings have traditionally not been recorded, members of the public are able to listen to the meetings live by calling a toll-free number listed on the agen-

Examples of liaisons and committees include the Sunshine Task Force, Next Beverly Hills Committee, Planning Commission Liaison and Design Review Commission Liaison. According to a city staff report, most liaison committee meetings happen on an "as needed" basis.

Expanding the city's meeting video recordings to include liaisons and committees was most recently broached by the Sunshine Task Force in its meeting on August 24.

The task force was created to study ways to create more transparency and public involvement in local government. Its members reached a consensus that recording meetings so members of the public could more easily access information was a form of transparency the City of Beverly Hills should research.

According to a city staff report, meetings are held over GoToMeeting - an online video conference website - and can be recorded by using a "record" feature. There may be no or little cost associated with uploading the meetings online during the pandemic, while GoToMeeting is in

Once the pandemic is over, the city may need additional resources to record meetings held at City Hall. According to a city staff report, the costs of that are currently unknown.


Writer's Bloc Presents A Live Streamed Event with **Timothy Snyder**

Four BIPOC Musicians Announced as Los Angeles Orchestra Fellowship's Second Class

Four top-tier postgraduate musicians that are black, Indigenous or a person of color have been announced as the second class of the Los Angeles Orchestra Fellowship, a program designed to increase diversity in American orchestras.

Launched in 2018, the program was conceived by a partnership of Inner City Youth Orchestra of Los Angeles, the country's largest African-American-majority youth orchestra; Los Angeles Chamber Orchestra, one of the world's leading chamber orchestras; and USC Thornton School of Music, one of the country's top music programs.

Violist Wilfred Farquharson, violist Jay Julio Laureta, horn player Malik Taylor and cellist Myles Yeazell will receive a 360-degree view of a career as an orchestral musician with a range of practical, in-the-field experience to elevate musicianship in this training program, now expanded from two to three years due to the coronavirus pandemic.

A pillar of the fellowship is the artistic mentoring the fellows receive from LACO musicians, administrative staff and USC Thornton faculty. In turn, fellows will actively mentor, teach, and guide young

ICYOLA musicians.

Among the other opportunities provided are extensive performance and rehearsal experience; compensation, benefits, housing; and unprecedented support to prepare participants to win auditions in professional American orchestras. Included are entrepreneurship classes and training to ensure the fellows develop skills and self-sufficiency to sustain their careers no matter how the music industry changes.

The fellowship was developed to address the fact that less than 5% of America's

orchestra workforce is African American, Hispanic or Native American, according to a 2016 report on diversity issued by the League of American Orchestras.

In a joint statement, ICYOLA Founder/Executive Director/Conductor Charles Dickerson, LACO Executive Director Ben Cadwallader and USC Thornton Dean Dr. Robert Cutietta welcomed the new musicians.

"A partnership of ICYOLA, LACO and USC Thornton, the fellowship began two years ago with a number of innovative and unique elements. This fellowship stands alone in having an institution of color leading the way and in offering pipelines of support in every direction," they said. "It is the first to include a youth orchestra, a university and a professional orchestra, each bringing unparalleled expertise to the program."

SALUTING A LOCAL HERO

Beverly Hills Athletic Alumni Association Creates Scholarship in Joe Sutton's Memory

Tell us about "BHAAA Assist" and the Joe Sutton Scholarship.

DAVID CORWIN: This is actually something that has been in the works for some time and obviously with the current state of the world and people's struggles with COVID and the economy it seemed like the appropriate time to get it going.

STEVEN FENTON: BHAAA is always about meeting the needs of the athletic department and meeting the needs of our alumni. In 2006, when we started BHAAA, the athletic department facilities were in disarray. Whether it be

the locker rooms. rusted basketball backboards – the facilities were in shambles.

So there were about 60 of us that started BHAAA and we raised quite a bit of money to take care of the immediate needs of the athletic department right then and there. That also included uniforms, equipment, etcetera. Over the years, we've always been about meeting the needs of the athletic department.

I think on average, BHAAA spends between \$40,000 and \$80,000 a year on meeting the needs

of the athletics department. But needs change and we have found that a lot of our alumni are now in need. We have plenty of money to continue to take care of the needs of the athletic department and we always will.

You can call this maybe BHAAA 2.0, we have pivoted and started BHAAA Assist and [it] is here to meet the financial needs of our fellow alumni that are struggling. Through BHAAA Assist, we will be handing out the Joe Sutton Scholarship which is a financial scholarship to help our alumni that are struggling.

How did you come to the decision to name the scholarship after Joe Sutton, who passed away in July?

SF: It really was a no brainer. Joe has been such a champion of Beverly High Athletics and the student athletes of Beverly High. Generation after generation of kids have been positively affected by Joe

Can you expand on how Sutton was involved in the BHAAA?

MICHAEL SUTTON: My father passed July 16, just a little over a month ago. David and Steven are lifelong friends of mine. We all grew up in the AYSO and Beverly Hills Little League program here, coached by our fathers. So that history of knowing the family and community that was basically built by all three of our fathers lent itself to BHAAA Assist becoming the namesake of the Joe Sutton scholarship.

Whereby a lot of the people who were touched and influenced by my dad and quite honestly, both Steven's and David's

> fathers as well, along the years of AYSO and Beverly Hills Little League were mentored, inspired and coached. The idea was that he helped shape this generation and this was continuing to give back in the same way he gave while he was alive for his legacy moving forward.

> Sutton was a wellknown publicist and represented celebrities like Drew Barrymore and Burt Reynolds. Why do you think BHAAA was important to him?

MS: It's pretty simple – his priority in life was his kids. As much as he had celebrity success and was around

fame, all the things other people could admire, my dad couldn't care less about that. It was all about his kids and then this community became an extension of that

I think that really defined him and that's why this would be so important. Because it was his priority in life to know what's important and that's what he put his time and energy towards. It was about people, love and a commitment that was unwavering.

What sports did Sutton coach?

MS: My brother is 15 months younger, his name is Robbie [Sutton]. He was five or four years old and started T-ball. My dad coached the T-ball team and subsequently the T-ball team the following year. Then AYSO and continuing for a decade, he just continued to coach those two sports for us.

He wasn't the type of coach who didn't engage with everybody and all those kids became his students, his sons [and] his protegees. His namesake is going to continue in the community he helped build.

How was Sutton a mentor to Beverly Hills vouth?

SF: Joe had a wonderful connection

to the athletes of Beverly Hills. Joe was a second father to many of us. He really is synonymous with BHAAA, meaning Joe was always there for the kids of Beverly Hills. And BHAAA is always there for the kids of Beverly Hills.

DC: It's really hard to put into words. He was such an engaging personality, was always so positive and someone who really listened and cared about people other than himself. [He] would find the best in somebody no matter what their situation was. That's why I think it's so

[wonderful] to have this [scholarship] named after him, because we're trying to help people get to a better place and he spent his life doing that. [He] was such an amazing influence on so many people.

MS: I must have had 30 people come to me with stories that I didn't know [about] until after my dad's passing, where they said "You know, Mike. I reached out to him years later and I said, 'Can you meet

me for coffee?" And my dad met them for coffee and continued to guide and mentor them

It wasn't one story, it was 30 stories [like that]. Funnily enough, sometimes my dad may have mentioned it to me if it was maybe my cohort group. But 30 people came to me that I had no idea my dad met with and they shared stories about how he picked up the call right away, returned the call within a day of them wanting to see him and just always made time way after Little League [even] when they were in their 30's -

It's remarkable to hear that that just continued to be my dad's DNA. Like Steven said, BHAAA Assist will continue that spirit of helping people in the community if and when they need it.

Michael - you've been an actor on several television shows such as General Hospital and are now in real estate. What career advice did your father give you?

MS: My dad was so willing to let me find a path that made me happy that no matter what it was, he said do it if it

makes you happy and you're going to spend your time productively and engaged doing it. I think that's the beauty of it – it wasn't confined to what he thought I should do. I think he was aware that in his life, the choice he made to follow his dreams was the best thing he was able to do. He definitely paid that forward and said please, find whatever makes engage with everybody you happy and pursue that completely.

I was offered the ability to go into his PR firm after college and he had a lot of successful clients and a thriving business. It wasn't for me at that

time, [though] I appreciated and knew its value. But I needed to go down my own path, at that time it was to try to be an actor for whatever crazy reason. I had a lot of fun. The support was always there. His advice was always that, follow your dream and don't let anyone stop you. If you don't make it right away, keep punching and pursuing. He was a fighter

to the end.

Expand on how people can qualify for the Joe Sutton Scholarship, how much is being donated and so forth.

SF: We have raised close to \$100,000 thus far. Right now, the maximum scholarship that any one individual can receive is \$3,000. We're not going to solve any of our former teammates' problems, financial but what we will do is hopefully be a stopgap, lend a helping hand and be a bridge for our former teammates that are in need. If you played a sport at Beverly [High] at any point, you would be eligible [for the Joe

Sutton Scholarship].

DC: There are no specific guidelines as for what the money can be used for ... This would really be for someone who can't make their utility payment or their rent payment for a month because they've come on hard times. These are more immediate needs to help someone

With that amount of money, while it's meaningful, it's not going to turn someone's life around but if it can help them and take some pressure off [so] they don't have to worry about coming home and their apartment being locked or their water not being on. That's really what it's designed for.

Not only alumni who play sports, but other people who participated in the athletic program [can qualify for the scholarship]. So if there's a coach who spent some time in high school, they would be eligible too.

SF: [The scholarship] is for people who have touched the athletic department. Cheerleaders, team managers –

those people are also eligible. But just to expand on David's point, if there is a graduating senior who sends in an application, says "I have a parent who's sick and my mother has caregiver needs," and is looking for some money to pay for that – absolutely we'll try to help if we can.

What do you hope the Joe Sutton Scholarship accomplishes?

DC: It's really just expanding our reach and giving back to our own, if you will. This was set up initially as an outline to help the current athletes of the highschool. And because of the affinity of the experience that a lot of us had, how some of us got involved to begin with.

[Beverly High Athletics] is always an important part of our lives, [but as] you get involved in your kids' lives and other things it gets challenging and you lose



that connection a little bit as times goes

BHAAA Assist is something that can help people now and help the alumni that helped form this organization. And not only give to the student athletes that are at the school currently, but give to people. That's really what it's about, maintaining that connection. [With this scholarship] people can keep that connection with Joe.

SF: It really is a through line, it really is. We want to meet the needs of our student athletes today and tomorrow. We know that a lot of the kids today have been the recipient of BHAAA generosity. We hope that we will always

be able to meet their needs in the future, well past their days at Beverly [High].


