

Why does the *Weekly* go out of its way to call Trump rallies protests? The text begins, "Protesters gathered," and continues, "... protesters ... plan to protest every weekend ..."

## One Beverly Hills Project Prepares Draft EIR Report, Hosts Public Meeting

The One Beverly Hills project, a pro-

posed \$2 billion condominium hotel-complex in Beverly Hills, is in the process of preparing a draft environmental impact report.

A public scoping meeting was held Monday to discuss the preparations being made for the report. The draft EIR report will assess potential impacts the project may have on its surrounding environment and also address alternatives to the current project. This includes a "No Project Alternative."

Rincon Consultants, Inc is preparing the draft EIR. According to an initial study prepared for the One Beverly Hills project's "Overlay Specific Plan," it will assess the following areas:

- Air Quality
- Public Services
- Cultural Resources
- Transportation
- Greenhouse Gas Emissions
- Tribal Cultural Resources
- Hazards and Hazardous Materials
- Utilities and Service Systems
- Land Use and Planning
- Mandatory Findings of Significance

The public hearing was held virtually Monday to present the project's Overlay Specific Plan publicly and allow community members to share environmental issues important to them, according to a city staff report.

Principal at Rincon Consultants Deanna Hansen said the September 21 meeting is the first of many public meetings about the project, and the Plan-

ning Commission and City Council will also review it before moving forward.

"We anticipate that the draft – the supplemental EIR – will be released sometime this winter for public review and during the 45-day public comment period, the Planning Commission will also hold a public hearing and study session to solicit comments and provide input to the draft document," Hansen said.

She added that Rincon expects the Planning Commission and City Council public hearings to be scheduled in the winter or spring

The One Beverly Hills Overlay Specific Plan is made up of two new residential buildings, a new hotel/residential building, updates to the Beverly Hilton hotel and a new parking structure. It will also include structures supporting project amenities and features, according to a city staff report. The residential buildings are proposed to have 303 units all-together, while the hotel would have 42 all-suite rooms and 37 residential units.



The project is being developed with the Beverly Hilton Hotel, Waldorf Astoria Hotel, a 76 service station and a vacant lot which was once the Robinsons-May Department store. It would make up 17.4 acres in total, with eight acres dedicated to a botanical garden.

If approved, it would also become the tallest building in Beverly Hills.

"I'm wondering if there's any study that's been done to show the shadows and wind effects, or even the perspective of the tallest tower from my bedroom window looking out towards Santa Monica," one public commenter asked at the end of the meeting.

Rincon Consulting submitted the question and others asked for the draft EIR report's consideration.

Alagem Capital Group Hospitality President Ted Kahan said Alagem, which is developing the project, looks forward to a robust EIR to emerge from this process.

"We are encouraged by the turnout at the scoping session last night and are glad that many residents were able to join and ask their thoughtful questions online," Kahan said

## Nate 'n Al's Continues **Operations on North Beverly Drive**

The City of Beverly Hills and "Nate 'n Al's Then and Now" announced today that the iconic Beverly Hills dining institution Nate 'n Al's will continue to operate at its current location at 414 North Beverly Drive and will eventually relocate, hopefully to a new space within the city.

When the original Nate 'n Al's building was sold and the lease on North Beverly Dr. ended, the owners of Nate 'n Al's had hoped to make a move to a new space owned by the city located on North Cañon Drive. After careful review with the owners and the city, it was determined that the facility would not meet the needs of the restaurant and Nate 'n Al's will not be going forward with the proposed move to that space.

"While we are certainly disappointed the space on Cañon was not a fit, we are hopeful the legendary Nate 'n Al's will continue to call Beverly Hills home for generations to come," said Mayor Lester Friedman.

Shelli Azoff of Nate 'n Al's said the new owner of the 414 North Beverly Dr. building has graciously allowed them to remain at the current location for now.

"Our plan is to stay at our current location on Beverly Dr. until we have some clarity and evaluate what our location choices are moving forward. The city has supported us throughout this process, and we know they will help us in the future," Azoff said, "It is our hope to remain in Beverly Hills where the Mendelsons started their journey in 1945 and have provided us with the best deli around. We continue to offer delivery and curbside service during the pandemic and don't be surprised if you see a few new items on the menu."

## **Rent Stabilization Commission Will Review Dispute Between Landlord** and Tenant

The Rent Stabilization Commission will

review Wednesday night a dispute with a landlord on a tenant's inability to pay rent due financial reasons related to the COVID-19 pandemic.

The tenant Sarah Lazow claims that she has been financially impacted by the pandemic and therefore cannot pay rent for her South Roxbury Drive apartment. According to a city staff report, Lazow works in film production – which is a non-essential business.

Rent for the unit is \$15,500, according to a city staff report. Lazow informed her landlord she could only pay \$5,200 earlier this year. The landlord's representative Ari Kashani later informed Lazow that without proof of her finances, they believe she has failed to show that she is unable to pay rent due to the pandemic. He also stated that they expect the full-amount for April and May monthly rent.

The hearing was previously heard on September 9 but continued to September 23, according to a city staff report.

During the hearing Wednesday, Lazow will be able to make a presentation about her case and have others testify in her favor. The landlord's party will be permitted to cross-examine Lazow and her witnesses, after which Commissioners will ask questions. The landlord will follow the same procedure.

There will also be a public comment portion and then both parties will be allowed a rebuttal. Once final questions are asked, the commission will deliberate and determine if the tenant's appeal is approved.

## California Employment **Development Department Conducts Fraud and Identity Theft Arrests**

The Beverly Hills Police Department has arrested 44 individuals within the City of Beverly Hills responsible for EDD fraud and identity theft since September 3.

A total of 129 fraudulent EDD credit cards have been recovered with a value over \$2.5 million dollars and over \$289,000 in U.S. currency has also been located on the suspects and subsequently seized. Officers have also located seven handguns carried on the suspects' persons or within their vehicles.

Earlier this month, the Beverly Hills Police Department learned criminals were fraudulently obtaining EDD benefits loaded onto EDD debit cards using stolen identities. The monetary value placed on the cards by EDD can be as high as \$20,000. Cardholders are able to withdraw up to \$1,000 per day, per card. Suspects have traveled primarily from out of state to obtain these fraudulent EDD cards in California. The suspects will most often

have numerous EDD cards in their possession with other people's identities, along with large amounts of cash. They will then use the cards to lease short-term rentals, rent luxury vehicles, dine at restaurants and purchase high-end merchandise.

In response to this growing trend and the numerous arrests and seizures, the BHPD met today with local, State and Federal law enforcement agencies 457 North Oakhurst Drive

and have agreed to work in partnership to combat this issue. This includes the Los Angeles Police Department, the Los Angeles County Sheriff's Department, California Highway Patrol, the United States Secret Service, U.S Postal Inspector's Office, U.S. Department of Labor and the Internal Revenue Service.

"There are millions of tax dollars being spent fraudulently as a result of this trend,' said Police Chief Dominick Rivetti. "The Beverly Hills Police Department is also working closely with our business community to keep them well informed of this trend in an effort to mitigate these crimes within our City."

## **Architectural Commission Approves Permit for North Oakhurst Drive** Condominium

The Architectural Commission conditionally approved an Architectural Review permit for a five-story six unit condominium last Wednesday.

The new condominium will have rooftop uses, a new landscape area and subterranean parking. The applicant for the project is NASCOR, LLC and Diamond Shield Investments, LLC.

Planning Commissioners conditionally approved a development plan review, vesting tentative tract map, R-4 permit and variance for the project site on May 28. The project applicant had requested the Architectural Commission to review the overall design of the home, according to a city staff report.

The applicant's proposals included exterior stucco in dove grey, anodized black aluminum doors and window frames, black metal exterior gates, face-mounted

## NOTICE OF COMMUNITY MEETING AND NOTICE OF PUBLIC HEARING

This notice is to inform the public about TWO upcoming meetings regarding the City of Beverly Hills Mixed Use Overlay Zone Ordinance: an INFORMATIONAL COMMUNITY MEETING on October 8, 2020 and a **CITY COUNCIL PUBLIC HEARING on October 13, 2020**. Detailed information about the City Council Public Hearing is provided below.

The City of Beverly Hills does not currently have uniform zoning code standards that allow for mixed use development (i.e. buildings that contain both commercial and residential uses) in the City. At its meeting on June 19, 2020, the Planning Commission adopted a resolution recommending a draft ordinance establishing a mixed use overlay zone to the City Council.

## **INFORMATIONAL COMMUNITY MEETING - OCTOBER 8, 2020**

On Thursday, October 8, 2020 at 6:00 PM the City of Beverly Hills Planning Division will host an informational community meeting to present an overview of the mixed use ordinance and discuss how the State Density Bonus law could be used in conjunction with the mixed use overlay zone provisions. Staff will be available to answer questions from the public at this meeting. Please note, this informational community meeting is NOT a public hearing and no decisions will be made at this meeting. This meeting is for informational purposes only.

## CITY COUNCIL PUBLIC HEARING - OCTOBER 13, 2020

The City Council of the City of Beverly Hills, at its meeting on October 13, 2020, will hold a public hearing beginning at **7:00 PM**, or as soon thereafter as the matter may be heard to consider:

AN AMENDMENT TO THE GENERAL PLAN TO ALLOW MIXED USE DEVELOPMENT IN CERTAIN COMMERCIAL AREAS OF THE CITY; AN ORDINANCE OF THE CITY OF BEVERLY HILLS TO CREATE A MIXED USE OVERLAY ZONE AND APPLY THE OVERLAY ZONE TO CERTAIN COMMERCIALLY ZONED PARCELS IN THE CITY; AND, ADOPTION OF THE FINAL NEGATIVE DECLARATION FOR THE MIXED USE OVERLAY ZONE PROJECT

The City Council will hold a public hearing to consider adoption of an ordinance to create a mixed use overlay zone and apply the overlay zone to certain commercially zoned parcels in the City.

As currently proposed, the overlay zone would:

- make multi-family housing units included in mixed use buildings an allowed use in the overlay zone,
- allow for a density of up to one residential unit per 550 square feet of site area,
- allow additional height (beyond the current three story/45 foot height limit) for mixed use buildings in certain parts of the overlay zone, depending on the height district of the adjacent residential zoning.
- establish development standards for mixed use buildings to regulate parking, residential unit size, outdoor living space, ground floor uses, height, setbacks, and operational standards, and
- outline the approval process for mixed use buildings proposed in the overlay zone.

Please note that the foregoing standards and processes may change as a result of public input received in conjunction with the public hearing. In addition, if commercial areas of the City are rezoned to allow residential uses, a developer could ask to apply the State Density Bonus provisions to a project on a site, which would allow additional density, and potential deviations from the otherwise-applicable development standards (such as additional height, and reduced parking, among other things).

As currently proposed, the overlay zone would be applied to the following **commercially zoned properties**:

- properties fronting Wilshire Boulevard between San Vicente Boulevard and Rexford Drive
- properties fronting Wilshire Boulevard on the southern side of Wilshire Boulevard between Rexford Drive and South Santa Monica Boulevard

- properties fronting La Cienega Boulevard between the northern and southern borders of the City
- properties fronting Robertson Boulevard between the northern and southern borders of the City
- properties fronting Olympic Boulevard between Rexford Drive and the eastern border of the City
- properties fronting South Doheny Drive between Wilshire Boulevard and Charleville Boulevard
- properties fronting San Vicente Boulevard between Wilshire Boulevard and La Cienega Boulevard
- properties fronting South Santa Monica Boulevard located between Wilshire Boulevard and Moreno Drive
- properties fronting South Beverly Drive between Wilshire Boulevard and Charleville Boulevard

Please note that the foregoing locations may change as a result of public input received in conjunction with the public hearing.

#### **ENVIRONMENTAL REVIEW:**

The project has been assessed in accordance with the authority and criteria contained in the California Environmental Quality Act (CEQA), the State CEQA Guidelines and the environmental regulations of the City. The City of Beverly Hills prepared an Initial Study/Negative Declaration (IS/ND) for the proposed overlay zone ordinance. The Draft IS/ND was made available for public review between June 10, 2020 and July 17, 2020. The initial study analysis indicates that the proposed project would not result in significant impacts to Agricultural and Forestry Resources, Biological Resources, Mineral Resources, and less than significant impacts related to Aesthetics, Air Quality, Cultural Resources, Geology and Soils, Greenhouse Gas Emissions, Hazards and Hazardous Materials, Hydrology and Water Quality, Land Use and Planning, Noise, Population and Housing, Transportation/Traffic, Public Services, Recreation, Tribal Cultural Resources, and Utilities and Service Systems. Accordingly, the City Council will consider adoption of a Negative Declaration in conjunction with the proposed ordinance.

Oral and written comments regarding the project can be submitted up to and at the October 13, 2020 City Council meeting. Pursuant to Executive Order N-25-20 members of the Beverly Hills City Council and staff may participate in this meeting via teleconference/video conference. In the interest of maintaining appropriate social distancing, members of the public can access City Council meetings telephonically, through live webcast, and BHTV Channel 10 on Spectrum Cable.

Written comments will be allowed with a maximum of 350 words, which corresponds to approximately 3 minutes of speaking time. If a comment is received after the agenda item is heard, it will not be a part of the record. Public comment via video conference will be 3 minutes per each individual comment, subject to City Council discretion.

Any interested person may participate in the meeting and be heard or present written comments to the City Council. According to Government Code Section 65009, if you challenge the Council's action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence delivered to the City, either at or prior to the public hearing.

For landscaping, the applicant had proposed to include brisbane box trees, dwarf fortnight lily, agave, mexican sage, red yucca and kurapia sod ground cover.

## Architectural Commision Discusses Commercial Building on Wilshire Boulevard

The Architectural Commission conditionally approved an Architectural Review permit and a Sign Accommodation for a Sign Program for a new three-story building on Wilshire Boulevard last Wednesday.

According to a city staff report, the building will have rooftop uses, subterra-

nean parking and new landscaping.

The Planning Commission had approved a development plan review and minor accommodation for the project on July 23. The applicant requested for the Architectural Commission to review the overall design of the proposed building, according to a city staff report.

According to a city staff report, the applicant Amir Dar, Goggles 8633, LLC had proposed to have tempered frameless glass, alucobond metal cladding and perforated-steel on the building.

Landscaping for the site was proposed to include alley landscaping, long-leafed yellow-wood hedges, Brisbane Box trees, stepping stone paving with gravel and so forth. The rooftop was proposed to have stainless steel clad planter boxes, olive trees, strawberry trees, a fountain feature and Mexican Weeping Bamboo.

## Nessah Synagogue Speaks Out About Potential Ethnic Studies Model Curriculum in High Schools

Nessah Synagogue announced their disapproval of the California Department of Education's Ethnic Studies Model Curriculum in a newsletter last Thursday, stating that there is more work to be done to ensure anti-Semitic language and the Boycott, Divestment and Sanctions movement is removed.

Assembly Bill 331, written by Assemblymember Jose Medina (D - Riverside), would require high school students to take at least one ethnic studies course to receive

their diplomas. The Legislature passed AB 331 on August 31, but Medina has agreed to make several amendments — including allowing school districts to create their own ethnic studies course.

The statewide curriculum model is currently in development.

The synagogue stated one way to advocate for a more inclusive representation of the Jewish American experience

in California history is to advocate to the state Board of Education and Instructional Quality Commission to pledge to four of its recommended changes.

It recommended that the curriculum include: broad Jewish American experiences and teach about anti-Semitism, ensure that denigrating content about Jews and Israel—including support for the Boycott, Divestment, and Sanctions movement—is excluded, include sample lessons reflecting the diversity of Jewish Americans and recommit to transparency and the predetermined process of writing to the ESMC.

# COVERSTORY PICKING THE PORTAL

## Council Weighs its Options for the Metro Purple Line North Portal

The City Council analyzed last Wednesday a draft environmental impact report for the North Portal station, which will be a second entrance and exit for the Metro Purple Line's highly anticipated Wilshire/Rodeo Station in Beverly Hills.

The draft EIR report – which is a legally-required study meant to inform the public about a proposed project's significant environmental effects – assessed three potential portal locations north of Wilshire Boulevard.

These locations include the project site on the west side of North Beverly Drive and two alternative locations on the west side of North Cañon Drive and at the North Cañon Drive Staging Yard.

The potential sites are proposed to have two elevators, one stairway and one escalator going up.

The North Canon Drive Staging Yard is the only proposed location to have a restroom, which would be provided at street-level and have two separate stalls/rooms. This site could also add a second escalator going down if it used a below-ground portion of adjacent land, according to the draft EIR report.

Councilmembers shared their thoughts and areas they felt the draft EIR can better assess the proposed portal locations' impact on the city during the September 16

meeting

Councilmember Julian Gold said the nomenclature portal is deceiving, because he expected it would entail a building with services that might include bathrooms, police stations, parking and dropoff locations. Those services would not be offered at at least two of the possible locations, he said.

"We're not really talking about that kind of structure," Gold said. "We're talking about a hole in the ground with an escalator or two."

He added that the council should later consider where the city can offer those kinds of services if it will not be offered at the North Portal site.

Councilmember Lili Bosse had several questions about the potential portals and how they would be structured.

"Why is there no [down-escalator]?" she asked, referring to how the EIR Report states that the Beverly Drive and Cañon Drive portal locations only have one escalator.

David DeRosa, the Transportation Planning Manager, responded that it's due to their site-size and geometry.

"It would end up increasing the impact out into the street, in the public right of way more if there was a second escalator put into the equation," DeRosa said. Bosse later asked for there to be an assessment on escalator occupancy.

"With two elevators, I do think it's important to understand how many people can fit in each elevator to make sure that whatever is going to be happening can actually work," she said.

Other suggestions made by

Councilmembers included a better assessment on restrooms, traffic impacts based on usage, bike storage and which location would have the best way for people to get to and exit the North Portal.

Public comments were also shared during the meeting.

Beverly Hills resident Phil Savenick, who spoke to the council over a video call on Go-ToMeeting, said the space the city picks for the portal should be where it is the safest to load and unload people off-street.

"A tunnel will relieve some of the Wilshire crossings but not all of it – especially if computer-mapping sends drivers to the south. We need to create something that will send drivers to the north to drop-off and pick-up," Savenick said. "What a North Portal needs is something where the passengers get to the stores."

Savenick added that the draft EIR re-

port does not address bathrooms, a visitors center, way-finding attendants and

security. He said residents want to have a visible security presence wherever the portal ends up being.

"We're trying

"We're trying to attract buyers, we're not trying to attract vagrants — we need to keep a tab on them," Savenick said.

Spago restaurant-owner Barbara Lazaroff also commented via video-call. Her restaurant is located on North Canon Drive, on the same street as one of the potential North Portal sites.

"We absolutely need restrooms and

security," she said.
"Safety is becoming a big issue in
Beverly Hills, it's
going to be more
so."

She said it would be socially irresponsible not to have restrooms at the North Portal.

The public comment period for the draft EIR will

remain open until October 8. Written comments can be sent to northportal@beverlyhills.org.

Councilmembers will decide on a portal location and certify a final EIR report either on October 27 or afterwards. According to a city staff report, the date of that decision is dependent on the number of public comments the city receives.

## HUMAN RELATIONS COMMISSION SHOWDOWN

## Board of Education Member Tristen Walker-Shuman Criticizes Commissioners' Endorsements for Board Election

BHUSD Board of Education member Tristen Walker-Shuman criticized several Human Relations Commissioners for their endorsement of BHUSD Board of Education candidate Donna Tryfman last Thursday.

"Unfortunately, several members of this commission have endorsed a candidate for school board whose been abusive to teachers for years across three campuses," Walker-Shuman said. "A candidate who publicly attacked and made fun of a bruise on my face, joking about fillers and saying I must not care about COVID."

She added that while she is no longer in an abusive relationship, she previously was in one and could never condone those kinds of comments.

"All of you have the freedom to endorse who you choose but when you elevate a candidate who has demonstrated character that's antithetical to the commission you sit on, I can't remain silent," Walker-Shuman said.

Walker-Shuman had attended the commission's September 17 meeting to pro-

vide updates on the district. She serves as the board's liaison to the Human Relations Commission.

Human Relations Commissioners Karen Popovich Levyn, Annette Saleh and Rhoda Sharp have endorsed Tryfman's run for the board, as of press time.

Walker-Shuman's comments later became an item of discussion in the Board of Education's September 22 meeting. President Isabel Hacker read a portion of the board's bylaws, in order to remind board members of the board's policies.

Bylaw 9010 states "when speaking to community groups, the media, or other members of the public, individual board members should recognize that their statements may be perceived as reflecting the views and positions of the board."

It also states that "board members have a responsibility to identify personal viewpoints as such and not as the viewpoint of the board," and "all public statements authorized to be made on behalf of the board shall be made by the board president or, if appropriate, by the Superintendent or other designated representative."

Hacker said Walker-Shuman could take the opportunity to express her opinions during the public comment portion of commission meetings.

"I just want to remind you that when you go to the Human Relations Commission, you're there on official business," Hacker said

Hacker added that she will only permit discussion on the bylaw, and discussion about board candidates will be declared out of order. Hacker later declared Walker-Shuman out of order in her capacity as chair

Walker-Shuman said when board members have endorsed candidates, they have used their titles as board members and none of the other board members have been asked if they support that endorsement

"We each have a right to speak individually as board members without representing the sentiments of the whole board," Walker-Shuman said.

She added that the inverse of the board's bylaws, which state all public statements authorized by the board shall be made by the president, mean any statement not made by the board president are not authorized board statements.

## Writers Bloc Presents Live Stream with Author Jill Lepore

Writers Bloc is presenting a livestream event with author Jill Leopre on September 22 at 11 a.m.

Long before the world grew concerned about the invasive practices of Cambridge Analytica, Google, and Facebook, there was the Simulmatics Corporation, a short-lived data analytics pioneer created and run by oddballs, from charismatic self-promoters to eccentric social scientists.

Hatched in the late 1950's, the Simulmatics Corporation became the prototype

for the ever-present Google, creating a mechanism to mine every detail of human

behavior — for commercial and political profit. Their data simulator, which they christened "the People Machine," churned out predictions on voting behavior for example, that was sold to the JFK campaign for the 1960 presidential election. Madison Avenue would also use Simulmatics and thus it became the new prophet.

Lepore in her new book "If Then," explores the nature and range of The People Machine — and its goal to predict behavior, whether commercial or political, and manipulate the outcome. Lepore, staff writer for the New Yorker, and the David Woods

Yorker, and the David Woods Kemper '41 Professor of American History at Harvard University, excavates a forgotten company whose legacy in predictive analytics is nothing short of the data-mad, algorithmic world we live in now, besieged by the next notification informing what we'll buy, what matters to us and how we'll vote.

**ORDINANCE NO. 20-0-2819** 

## AN ORDINANCE OF THE CITY OF BEVERLY HILLS AMENDING THE BEVERLY HILLS MUNICIPAL CODE REGARDING EMERGENCY WATER CONSERVATION PLAN

WHEREAS, on February 5, 2019, the City Council adopted an ordinance substituting a revenue stabilization rate schedule during water shortages instead of previous baseline methods and penalty surcharges, and intends to conform the Emergency Water Conservation Plan in accordance with such changes.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF BEVERLY HILLS DOES ORDAIN AS FOLLOWS:

Section 1. The City Council hereby amends and restates Article 3 ("Emergency Water Conservation Plan") of Chapter 4 ("WATER REGULATIONS") of Title 9 ("BUILDING AND PROPERTY HEALTH AND SAFETY REGU-LATIONS") of the Beverly Hills Municipal Code to read as follows:

#### Article 3. Emergency Water **Conservation Plan**

## 9-4-301: AUTHORITY OF CITY MANAGER:

A. The City Manager is hereby authorized and directed to implement the applicable provisions of this article in order to protect the public health, safety, and welfare under the following

- 1. In the event of an unforeseeable disaster or water emergency such as an earthquake, reservoir failure or other major disruption in the water supply, the City Manager is authorized to implement the emergency provisions of this article.
- 2. In the event of a foreseeable water emergency, such as an extended drought, the City Manager is authorized to implement the applicable provisions of this article, after holding a public hearing before the City Council.
- B. The City Manager is authorized to determine and declare that a water shortage emergency exists in any or all parts of the City of Beverly Hills and upon such determination, to promulgate such regulations, rules and con-

ditions relative to the time of using water, the purpose or purposes for which it may be used and such other necessary limitations as will, in his or her opinion, relieve the water shortage in such part or parts of the City.

- C. The City Council may review and affirm, reverse, or modify any determination made or regulations, rules or conditions promulgated by the City Manager pursuant to this article.
- D. All references to the City Manager in this article shall mean the City Manager or his or her designee.

#### 9-4-302: GENERAL PROHIBITION; APPLICABILITY:

- A. No person shall use or permit the use of water from the City for residential, commercial, industrial, governmental, or any other purposes in violation of any provision of this article or in an amount in excess of the use that is permitted by the water conservation stages defined below.
- B. The provisions of this article shall apply to all persons, customers and property served by the City of Beverly Hills, Public Works Department - Utilities Division wherever situated.

#### 9-4-303: DECLARATION OF WATER **CONSERVATION STAGES:**

- A. Water conservation stages shall be determined by the amount of water available or the potential for water interruption. The City Manager shall monitor the supply and demand for water by customers. When the City Manager determines that the requirements to declare a water shortage exist, he or she shall recommend that the City Council adopt a resolution to declare the appropriate water conservation stage be adopted.
- B. The resolution shall specify the water use baseline for determining the water conserva-tion measures required by Section 9-4-303 and the water revenue stabilization factors to be applied pursuant to Section 9-4-304. The water use baseline shall be determined based upon such factors as deemed appropriate by the City, including the characteristics of a local emergency, or as otherwise mandated by the State of California or other regulatory agency, or by the Metropolitan Water District of Southern California.
- C. The City Council may modify by resolution any of the requirements contained in the stages of water conservation set forth in section 9-4-303 and 9-4-304 of this article if the City Council determines that the modification is in the best interests of the City or is appropriate to promote compliance with an applicable water use regulation.
- D. The resolution to declare a water shortage exists shall be published within ten (10) days after its adoption at least once in a newspaper of general circulation within the City and shall be posted in at least three (3) public places. The resolution shall continue to be posted until such time as City Council repeals the resolu-
- E. Except as otherwise may be provided by this article or a resolution adopted by the City Council or pursuant to the exercise of emergency powers authorized by Article 1 of Chapter 4 of the Municipal Code, any resolution that requires a reduction in the use of water shall not become effective for at least 30 days.

#### 9-4-304: REQUIREMENTS FOR WATER **CONSERVATION STAGES:**

Upon the declaration of a water conservation stage, the water conservation reductions shall be implemented. The water conservation reductions for each water conservation stage and each class are described in the following

## Water Conservation Reductions by Class



Additional compliance elements for each water conservation stage are described below.

- A. Stage A Requirements:
- 1. A stage A shortage shall be declared when the City Manager determines that a five per-cent (5%) citywide reduction in potable water use is required.
- 2. Stage A compliance may include voluntary reduced irrigation, notification of hotel and restaurant patrons of water conservation

goals, and use of reclaimed water for construction purposes.

- B. Stage B Requirements:
- . A stage B shortage shall be declared when the City Manager determines that a ten per-cent (10%) citywide reduction in potable water use is required.
- 2. Stage B compliance shall include the follow ing mandatory elements:
- a. All public restrooms in the City and private bathrooms in hotels shall notify patrons and employees of water conservation goals;
- Violation by any person of the stage B mandatory requirements shall constitute an infraction and, upon conviction, shall be punished by a fine not to exceed one hundred dollars (\$100.00). The violation of each element, and each separate violation thereof, shall be deemed a separate offense, and shall be punished accordingly.
- C. Stage C Requirements:
- 1. A stage C shortage shall be declared when the City Manager determines that a twenty per-cent (20%) citywide reduction in potable water
- 2. Stage C compliance elements shall include the following mandatory elements:
- a. All public restrooms in the City and private bathrooms in hotels shall notify patrons and employees of water conservation goals;
- b. Water usage from fire hydrants shall be limited to firefighting, related activities or other activities necessary to maintain the public health, safety and welfare:
- c. Landscape irrigation shall be restricted to selected days and times as determined by the City Manager, unless such irrigation uses reclaimed wastewater.
- 3. Violation by any person of the stage C mandatory requirements shall constitute a misdemeanor and, upon conviction, shall be punished by a fine not to exceed five hundred dollars (\$500.00). Water supply through irrigation water services may be terminated for continued excessive use. The violation of each element, and each separate violation thereof, shall be deemed a separate offense, and shall be punished accordingly.
- D. Stage D Requirements:
- 1. A stage D shortage shall be declared when the City Manager determines that a thirty percent (30%) or higher citywide reduction in potable water use is required.
- 2. Stage D compliance elements shall include the following mandatory elements:
- a. All public restrooms in the City and private bathrooms in hotels shall notify patrons and employees of water conservation goals;
- b. Landscape irrigation shall be restricted to selected days and times as determined by the City Manager, unless such irrigation uses reclaimed wastewater;
- c. Refilling of swimming pools, spas or ponds shall be prohibited unless required for health or safety reasons;
- d. Exterior washdown of vehicles shall be prohibited unless:
- (1) Using a reclaimed water system;
- (2) Performed in accordance with an alternative plan that promotes water conservation and is approved in writing by the Director of Public Works or his/her designee; or
- (3) Required to meet laws or governmental regulations to protect health and safety, such as the cleaning of garbage trucks and vehicles to transport food.
- e. Water usage from fire hydrants shall be limited to firefighting, related activities or other activities necessary to maintain the public health, safety and welfare;
- f. Exterior washdown of buildings shall be prohibited unless:
- (1) Using a reclaimed water system and such washing is done: a) no more than once per month for retail building frontage; b) no more than twice per year for office and commercial buildings; c) no more often than is necessary to comply with health laws and regulations for the building frontage of food service uses; or d) no more than once per year for residential structures solely for the purpose of preparing a

- residential structure for painting.
- (2) Using a commercial glass and window
- g. Exterior washdown of sidewalks and the pavement of outdoor dining areas shall be prohibited unless using a reclaimed water system and such washing is done no more often than is necessary to comply with health laws and regulations.
- 3. Violation by any person of the stage D mandatory requirements shall constitute misdemeanor and, upon conviction, shall be punished by a fine not to exceed one thousand dollars (\$1,000.00). Continued excessive use may result in termination of water supply through irrigation water services and/or restriction of water supply through domestic meters. The violation of each element, and each separate violation thereof, shall be deemed a separate offense, and shall be punished accordingly.
- 4. For purposes of this article, "reclaimed water system" shall mean a system that initially uses potable water and then collects the runoff, treats the runoff, and uses the runoff for nonpotable uses for multiple cycles.
- E. Stage E Requirements:
- 1. A stage E shortage shall be declared when the City Manager determines that a catastrophic interruption of potable water supply has occurred or is foreseen.
- 2. The City Manager shall have emergency water allocation authority in the case of a stage E declaration. This authority shall include the authority to interrupt service to any property or City service zone in order to provide the maximum water supply for human health and safety needs. A Stage E declaration will include mandatory shutoff of all irrigation-only service connections.
- 3. In allocating water, the City Manager shall give first priority to health and safety needs of water utility customers. Subsequent water uses are prioritized to provide water supply first to maintain and expand commerce within the City, then to enhance the aesthetics of the environment, and then to facilitate construction activities.
- 4. Violation by any person of the stage E emergency water conservation regulations, shall constitute a misdemeanor and, upon conviction, shall be punished by a fine not to exceed one thousand dollars (\$1,000,00) and six (6) months in jail. The violation of each element, and each separate violation thereof, shall be deemed a separate offense, and shall be punished accordingly.

#### 9-4-305: WATER SHORTAGE REVENUE **STABILIZATION FACTORS**

Upon the declaration of a water conservation stage, the water shortage revenue stabilization factors shall be implemented. The water shortage revenue stabilization factors for each water conservation stage and each class shall be multiplied by the then applicable quantity charge rate for each customer as described in the following table:

## 9-4-306: NOTICE OF VIOLATION

- A. The City shall give notice of violation to the person committing a violation of this article as follows:
- 1. Notice of violation of any water usage percentage reduction provisions shall be given in writing by regular mail.
- 2. Notice of violation of any other mandatory requirement listed in section 9-4-304 of this article shall be given in writing in the following
- a. By giving the notice to the customer personally; or
- b. If the customer is absent from or unavailable at the premises at which the violation occurred, by leaving a copy with some person of suitable age and discretion at the premises and sending a copy through the regular mail to the address at which the customer is normally billed; or
- c. If a person of suitable age or discretion can-

not be found, then by affixing a copy in a conspicuous place at the premises at which the violation occurred and also sending a copy through the regular mail to the address at which the customer is normally billed.

B. The notice shall contain a brief description of the facts of the violation and a statement of the possible penalties for each violation and a statement informing the customer of his or her right to a hearing on the merits of the violation pursuant to section 9-4-306 of this article.

#### 9-4-307: HEARINGS:

Any person receiving notice of a violation of any water usage percentage reduction provision set forth in section 9-4-304 of this chapter shall have the right to request a hearing to appeal the violation. The City Council shall establish the appeal procedures by resolution.

## 9-4-308: ADDITIONAL WATER CONSERVATION MEASURES:

After holding a public hearing before the City

Council, the City Manager may order implementation of water conservation measures including, or in addition to, those set forth in section 9-4-303 of this chapter, in order to encourage proper potable water use or to meet water conservation goals, regardless of supply.

#### 9-4-309: EXCEPTIONS:

Nothing in this article shall be construed to require the City to curtail the supply of water to any customer when such water is required by that customer to maintain an adequate level of public health and safety.

Section 2. Severability. If any section, subsection, subdivision, sentence, clause, phrase, or portion of this Ordinance for any reason is held to be invalid or unconstitutional by the decision of any court of competent jurisdiction, such decision shall not affect the validity of the remaining portions of this Ordinance. The City Council hereby declares that it would have adopted this Ordinance, and each section, sub-

section, subdivision, sentence, clause, phrase, or portion thereof, irrespective of the fact that any one or more sections, subsections, subdivisions, sentences, clauses, phrases, or portions thereof be declared invalid or unconstitutional.

Section 3. Publication. The City Clerk shall cause this Ordinance to be published at least once in a newspaper of general circulation published and circulated in the city within fifteen (15) days after its passage in accordance with Section 36933 of the Government Code, shall certify to the adoption of this Ordinance and shall cause this Ordinance and the City Clerk's certification, together with proof of publication, to be entered in the Book of Ordinances of the Council of this city.

Section 4. Effective Date. This Ordinance shall go into effect and be in full force and effect at 12:01 a.m. on the thirty-first (31st) day after its passage.


