I certainly treated that portion of her remarks as I would any public comment, even though it came after her board report, as I presume my fellow commissioners did as well. That is why neither I nor the other commissioners responded.

Let's do our best to keep our Board of Education election above board and not fall prey to petty tomfoolery.

We already have one perceived negative election occurring on a national level – we certainly do not need that here at the city level.

Rent Stabilization Commission Deliberates Tenant Dispute, Ultimately Sides with Landlord

The Rent Stabilization Commission deliberated last Wednesday on a dispute between a landlord and tenant over the latter's inability to pay rent due to alleged financial losses resulting from the COVID-19 pandemic.

Commissioners ultimately sided with the landlord, with a 4-2 vote. Commissioners Gwen Owens and Kathryn Jacoby Cavanaugh were the dissenting votes. Chair Lou Milkowski, Vice Chair Neal Baseman and Commissioners Remmie Maden and Ryan Gurman voted to reject the tenant's appeal.

Gurman is an alternate Commissioner and participated in the meeting in Commissioner Donna Tryfman's place.

Since the City of Beverly Hills first declared the COVID-19 pandemic a "local emergency," an eviction moratorium has prevented landlords from evicting residential tenants for not paying rent so long as they can prove to have been adversely affected by the pandemic.

This urgency ordinance has resulted in controversy on both ends of the spectrum: Some landlords claim tenants are using it to avoid paying rent while some tenants claim they are being pressured to pay rent they can no longer afford since many non-essential businesses have closed.

One of the Rent Stabilization Commission's roles is to make decisions on COVID-19 appeals. A tenant can appeal to the city to make a final decision on a dispute between themself and a landlord over if they can pay full rent or not due to COVID-19. The commission, which was formed in June, has deliberated on

approximately two rent appeals as of press time.

Last week's hearing was regarding tenant Sarah Lazow and landlord AGCK Property Management. The landlord's representative was Ari Kashani.

Lazow, film producer, informed her landlord that she could not pay her full rent from May onward due to the pandemic. She claimed her income was adversely affected when non-essential businessincluding

film production, shut down.

Lazow's lawyer, Michael Murphy, said she has a medical condition which prevents her from resuming work on set during the pandemic. He was not immediately clear about what that medical condition is.

Lazow offered to pay \$5,200 a month in partial rent. According to a city staff report, the Beverly Hills 2020 rent registration listed her rent as \$18,500. Lazow later applied for a rent repeal and Kashani updated the rent to be \$15,500.

Kashani disputed that Lazow could only pay \$5,200 later that month, stating that without proof of her financial losses she has not proven her inability to pay rent and the landlord wants the full rent amount. In response, Lazow filed an appeal with the city.

Commissioners first deliberated on the tenant's case September 9. After about two hours of debate, the commission voted to continue discussing the item on September 23 to give Lazow the opportunity to provide more financial proof that the pandemic adversely impacted her income.

"All of the projects that she had – including one that had proceeded towards negotiations of an agreement regarding the production – was put on ice and has not resumed," Murphy told the commission.

Commissioners appeared conflicted throughout the meeting about whether to grant the appeal. Some had several questions about missing details in the claim.

Baseman said he was confused by the case, considering Lazow testified she had no job and no income but agreed to pay \$5,200 a month.

"I was a little bit disappointed that there was nothing in the documentation submitted that could support where the \$5,200 is coming from and why it was \$5,200 as opposed to zero because she had no income or some other amount," Baseman said.

According to Lazow's attorney, the full extent of her financial records are difficult to show due to confidentiality agreements – even with redactions.

Commissioner Gwen Owens questioned the lease agreement for the apartment unit. While the landlord claimed Lazow was a holdover tenant, Lazow claimed she had satisfied all contractual obligations to secure her tenancy.

"Can you explain that? Because I think the landlord terms that that's not true," Ow-

Madeline Suchard, Kashani's attorney, said the lease had expired on its own terms on August 9.

"Should Ms. Lazow wished to have extend the lease, she would have been required to provide notice to AGCK Properties at approximately June 25 ... neither [Kashani] nor anyone from his office received any notice," Suchard said

Assistant City Attorney Robin Harris said the commission does not have the authority to compel Lazow to pay the \$5,200 of rent she attested to being able to. Rather, the city's rent relief ordinance would only apply if she paid up.

"If this appeal were decided in favor of the tenant, the tenant is only protected by the ordinance if the tenant pays the \$5,200 a month," Harris said.

According to Harris, the city attorney's office will come back with a resolution memorializing that the tenant's appeal was rejected.

BHUSD Continues Preparations for Eventual Physical Reopening of Schools

Superintendent Michael Bregy updated the Board of Education last Tuesday on the district's plans to eventually reopen schools with COVID-19 health and safety regulations once permitted.

Bregy had previously discussed the State of California's color-coded tier system, which is a new set of criteria that determines when districts can physically reopen schools. He said the biggest challenge the district is facing in its preparations to reopen is that the regulations are constantly changing.

"Our first and foremost responsibility in this reopening is to meet the public health order," Bregy said. "That's our responsibility ... we have to show compliance to this public health order."

According to Bregy's September 22 presentation, the public health order is about protecting students and staff, ensuring physical distancing, ensuring infection control, communication with parents and ensuring access to critical services.

"We have a COVID-19 containment and control plan, which is made up of district and school-site administrators, along with ... our nurse for the district at the high school," Bregy said.

The district's COVID-19 compliance team includes the following BHUSD staff and administrators: Bregy, Assistant Superintendent of Student Services Laura Chism, Assistant Superintendent of Business Services Wade Roach, Director of Public Relations Rebecca Starkins, Director of School Safety Scott Lovelace, District Nurse Ricardo Alatriste, Executive Director of Construction and Facilities Ken Haas, Student Services Coordinator Phil Wenker, Beverly High Principal Mark Mead, Beverly High Assistant Principal Drew Stewart, Beverly Vista Principal Kevin Allen, Beverly Vista Assistant Principal Josh Stern, Beverly Vista Assistant Principal Rich Waters, Horace Mann Principal Craig Bugbee, Horace Mann

Assistant Principal Chris Regan, Hawthorne Principal Sarah Kaber and Hawthorne Assistant Principal Kevin Painter.

According to Bregy's presentation, the district has also created a list of protocols to follow if someone tests positive for COVID-19 and contact-tracing to determine if someone else at the school could be infected if that happens.

"The protocols are that we are to move quickly and swiftly when someone is considered to be positive, where they go, how they're transported home, whether its students or staff – we have a plan in place for either scenario," Bregy said.

He added that the district has to prove to the county that it is able to close again safely and without interrupting opera-

According to Bregy's presentation, the district will have employee screenings for COVID-19, require six-feet social distancing, require masks, only allow visitors on a limited basis, have signage about health and safety precautions at schools, facilities disinfected on a set schedule and hand sanitizer in classrooms, offices and other shared spaces.

In order to maintain social distancing, students will be divided into cohorts. Bregy said the county has recommended cohorts have 12 students each but the state has recommended 16 students.

"We think that ... LA County will change that definition of cohort from 12 to 16, and that seems to be what's happening in other areas of the state," Bregy said.

Council Approves Rent Subsidy Program for Beverly

The City Council approved creating a rent subsidy program in Beverly Hills on September 15, which will help qualified tenants financially impacted by the COVID-19 pandemic pay their rent.

According to a city staff report, the council had expressed an interest in establishing a rent subsidy program earlier this year and directed city staff to research programs in surrounding cities.

The city staff report states that the City of Los Angeles started an emergency rental assistance program in July, which allocated \$103 million of Coronavirus Aid, Relief, and Economic Security Act funds. The City of West Hollywood's program allows eligible homes to receive up to three payments of a maximum of \$1,000 and the City of Santa Monica's program allows tenants upwards of three months of a maximum \$5,000 subsidy.

The majority of these programs are handled through non-profit third-party contracts. Additionally, all the programs make rent subsidy payments out to landlords and require proof of tenancy and financial losses caused by COVID-19.

City staff recommended the Beverly Hills rent subsidy program be handled through Jewish Family Services – a non-profit group which would make payments directly to landlords, require proof of tenancy, documentation that tenants were impacted by COVID-19 and meet the city's qualifying criteria to participate in the program.

The city's criteria to qualify for the rent

subsidy program is the following, according to a city staff report:

- Tenants must reside in a multi-family property subject to the Rent Stabilization Ordinance as evidenced by a current lease; proof of prior rent payments; or utility bill that establishes residency; and be able to demonstrate that they are financially impacted by COVID-19.
- The city may further limit eligibility to those tenants with monthly rents no more than \$4,000.
- Tenant income qualifications will be determined through the Housing and Urban Development Plan's established low-income limits as a qualifying standard for income that was received in the last thirty days prior to the application for rent subsidy.

Councilmembers approved the rent subsidy program with a 5-0 vote.

Councilmember Julian Gold said he thinks the program should be focused on people whose rent is lower.

"That has a better chance of keeping people in their houses. Someone who's

Councilmember Lili Bosse said she wants to begin the program right away.

"As far as I'm concerned, the sooner we can get this going the better - I already feel we're late," Bosse said.

According to Deputy Director of Rent Stabilization Helen Morales, the city has 197 COVID-19 applications who would be eligible to apply for the rent subsidy

Board Passes Resolution Opposing Assembly Bill 331, Claims Proposed **Curriculum is Anti-Semitic**

The BHUSD Board of Education unanimously approved last Tuesday a resolution opposing the current iteration of a bill that would require high school students to take an ethnic studies course, which would be based on a model curriculum that it claims is anti-semitic.

Assembly Bill 331, written by Assemblymember Jose Medina (D - Riverside), was approved by the Legislature on August 31. Medina has agreed to make several amendments to the bill, which includes allowing individual districts to create their own curriculum.

The bill's model curriculum is currently being developed, but a draft version was released earlier this year. It was not well-received by several minority groups primarily Jewish Americans.

Jewish Americans have criticized the proposed courses' contents, claiming that it teaches anti-Semitic material such as anti-Semitic language and the Boycott, Divestment and Sanctions movement. According to JewishJournal, there were 80 Jewish groups that collectively sent a letter asking Gov. Gavin Newsom to reject the bill.

The Board's resolution calls for the following changes to the model curriculum:

- Include broad Jewish American experiences and teach about anti-Semitism.
- Ensure that denigrating content about Jews and Israel — including support for the Boycott, Divestment, and Sanctions movement — is excluded.
- Include sample lessons reflecting the diversity of Jewish Americans.
- · Recommit to transparency and the predetermined process of writing to the ethnic studies model curriculum.

Board President Isabel Hacker said the district is not opposing the requirement to provide an ethnic studies course, rather it is opposing the proposed curriculum as it currently is.

"The purpose of this resolution – as we discussed the last board meeting - is basically to just make sure that we are notifying our disagreements on the curriculum that [was] initially being considered," Hacker said. "Since then ... the state is looking at re-adopting new curriculum that should not have a flare of antisemitism in the lesson plans that are being proposed."

Hacker later added that she has been in contact with State Senator Ben Allen (D - Santa Monica), who is the Chair of the California Legislative Jewish Caucus, for support in ensuring there is no flare in anti-semitism.

Allen released a statement that said like many Jewish organizations, the California Legislative Jewish Caucus has supported ethnic studies.

"While our caucus and the Jewish community had serious concerns about certain aspects of the draft model curriculum, we are hopeful that further discussions and modifications will result in a curriculum that everyone can feel good about," Allen

Board member Noah Margo said there is clear language in the bill that states that the curriculum shall not reflect or promote any bias, bigotry or discrimination. He also said the resolution should be addressed to the curriculum - which is not complete.

"For the state to put forth a mandate in a bill without having a curriculum attached is not the correct order in how it should have been done," Margo said. "School districts should have been allowed to completely vet out and view the curriculum."

Board member Mel Spitz said he is always sensitive about adding graduation requirements because high school students are already carrying a heavy load.

"I always hope that if something like this [curriculum] comes along and needs to be taught, that it can be sort of added into history or social studies [courses] rather than coming up with additional courses that just burden our students unreasonably," Spitz said.

Additionally, the Beverly Hills Rotary Club will have a drive for gently used or new blankets on October 5 from 3 p.m. to 4:30 p.m in front of the Beverly Hills Fire Department. The blankets will be donated to Salvation Transitional for women and children in transitional housing.

According to Beverly Hills Rotary Club Presiden Sharona R. Nazarian, people can pull up in their cars to drop off their donations. The club will also unload items if people are uncomfortable stepping out of their cars.

"The cold months are quickly approaching and many people who are displaced from their homes are in great need," Nazarian said.

T&P Commission Will Discuss Pedestrian and Bicycle Awareness Campaign

The Traffic and Parking Commission will discuss Thursday the city's pedestrian and bicycle awareness campaign, as well as give a recommendation on how a temporary pedestrian and bike-friendly intersection being built in mid-November should look.

City staff applied for a Southern California Association of Governments Sustainability Planning Grant in 2017, in order to implement a pedestrian and bicycle awareness campaign. According to a city staff report, the campaign's goal is to complement the city's complete streets plan by teaching people about bike and pedestrian safety. SCAG awarded the grant in 2018.

Since then, the city has launched the Beverly Hills Mobility website, distributed copies of the Mobility Safety Tip sheet and made social media posts about virtual bike classes and bike safety.

The city also plans to build a temporary demonstration project at the Camden Drive/Brighton Way intersection. It will have decorative pedestrian amenities meant to create a more walk-friendly streetscape and motivate drivers to follow traffic regulations. According to a city staff report, this includes temporary painted curb extensions, decorative crosswalks, a bike rack corral and planters.

The project is expected to be put in place in November and remain for at least

six months.

Commissioners will review and recommend a design for the temporary project for the City Council to approve Thursday. According to a city staff report, the council is expected to review the design on October 13.

The first option for the design is solid color paint on the crosswalks and curb extensions, the second option is multi-colored patterns and the third option is to have no decorative elements.

Traffic and Parking Commission Will Receive Updates on Bike Rack Installations, Bike Share Program

The Traffic and Parking Commission will receive updates on bike rack installations throughout the city and the bike share program Thursday.

According to a city staff report, potential locations for bike racks include commercial corridors with few or no existing racks. Staff will also consider areas that were rejected by the city's Bike Rack-On-Request program, in order to assess if the conditions of those locations have changed.

Installation is expected to begin this fall and winter 2021. According to a city staff report, the city's first bike corral adjacent to a parklet will be placed in front of the restaurant Frida on South Beverly Drive.

The city's bike share program began offering free use of bikes during the pandemic and will be the only bike share program in the area by mid-November. According to a city staff report, UCLA, the City of Santa Monica and the City of West Hollywoods have announced they will discontinue their bike share programs.

Beverly Hills Bike Share has been advertised on the city's website and social media, according to a city staff report. People can use city bikes via the bikeshare app and ride 90 minutes for free per trip, with an unlimited number of trips per day.

Board Approves Removal of Building for Oil Well Re-Abandonments

The BHUSD Board of Education ratified last Tuesday an agreement to demolish a Beverly High building, which will allow for the re-abandonment of oil wells surrounding it.

Superintendent Michael Bregy signed an agreement with ProWest Constructors for the oil well re-abandonments at a cost of \$1,675,068. According to a board agenda, Measure BH will advance the payment and it will be submitted for reimbursement from the Los Angeles Metro Transportation Authority.

Project Manager Don Blake said Building H – the building being demolished – was housing the maintenance and operations spaces. He said it was planned to be demolished in the future master plan program.

"For the mitigation of the oil wells, for in particular [Rodeo] 107, it was expedient to demolish it in order to make a space to provide an intercept for 107 in lieu of putting an oil rig next to Building B-1," Blake said.

"The most important step you should take before making a meal is to make sure your kitchen is safely equipped and that you remain alert," said BHFD Chief Greg Barton. "A cooking fire can grow quickly. I have seen many homes damaged and people injured by fires that could easily have been prevented."

The BDFD reminds residents to follow these tips:

• Never leave cooking food unattended. Stay in the kitchen while you are frying, grilling or broiling. If you have to leave, even for a short time, turn off the

stove.

• If you are

- simmering, baking, roasting, or boiling food, check it regularly, remain in the home while food is cooking and use a timer to remind you that you're cooking.
- Remain alert while cooking at all times.
- Always keep an oven mitt and pan lid nearby when cooking. If a small grease fire starts, slide the lid over the pan to smother the flame. Turn off the burner and leave the pan covered until it is completely cool.
- Create a "kid-free zone" of at least three feet around the stove and areas where hot food or drink is prepared or carried.

Taking Flight

Retired Beverly High ESL Teacher Raquel Ramsey Writes Book on Trailblazing Female Pilot

What inspired you to write "Taking Flight: The Nadine Ramsey Story"?

This book was a promise to my husband, Col. Edwin P. Ramsey 26th Cavalry

Philippines Scouts. He passed away June 28, 2013. He was buried in Arlington with full military honors.

He said to me, "You need to write my sister's book, because she has more guts than I ever did." I said, "Honey, that's not possible." He was the last horse-mounted cavalry charge in U.S. Army history, decorated by General MacArthur and he stayed four years behind enemy lines forming the Guerrilla forces - actually he [was] a green beret even before there were green berets.

And he [responded], "Wait [until] you find her story."

But all I had were boxes of photographs. Just looking at [those] photographs, I was like "Oh wow, I have to do huge research." That's exactly what I did, because my husband passed away ... That was the same year I also retired from Beverly High after 50 years in the profession. I got so busy with his

documentary – I was executive producer of "Never Surrender, the Ed Ramsey Story." And that took me [until] right after he passed away. So three years ago, when I finished the production of "Never Surrender," and all of his honors all over the United States and the world, I started with the research. I found more and more from the National Archives. I found from the

Smithsonian. I realized what an incredible woman she really was.

Your book is about your sister-in-law Nadine Ramsey, who was a Women

Airforce Service Pilot. Tell us about your relationship with her and what she was like.

I talked to her every single day at four o'clock in the afternoon. She's six years older than my husband and so she passed away at the age of 85 in 1997, when they opened the Women's Memorial. Right now, she's there being honored in the Women's Memorial. My husband is buried in Arlington and she is in the women's memorial in Arlington – but they did not allow women to be buried there. So, her ashes were scattered on Long Beach airport here, that goes back to what she wanted her burial to be.

Nadine was the sweetest, most loving person. We had a date, like every day I would call her at four o'clock in the afternoon and she would be waiting for my call. She lived in Long Beach and every week, Ed

and I would go there and take her out of the convalescent hospital after she had to come in because of so many crashes that she had and her spine. But before that, she lived in different places and apartments in Long Beach. So we would go there every Saturday, take her out – she loved hamburgers. She had special places where she wanted this type of hamburger or this

type of hamburger. We would have such fun and spend the afternoon with her. That was like a religious act, every single week. Of course when she passed away, it was

Of course when she passed away, it was so hard. But we went to the opening of the Women's Memorial and we were there walking through the ceremony. Of course, some of her memorabilia was placed in the Women's Memorial.

For those unfamiliar with U.S. military history, what were the Women Airforce Service Pilots?

The Women Airforce Service Pilots [were] women who flew – and [Nadine] flew everything, the P-38's and the P-51's – all the planes. Since the men were at war, they had to bring the aircraft to the places where the men would meet them for the war. So she flew every type of aircraft military, so she was not just a flyer. She became a part of the Women AirForce Service Pilots.

The role was to support men during the war, like flying the aircraft of one airfield to another airfield so that the men when they were there would pick up the aircraft and be able to use it for the wartime. This is all over the United States, Canada and the world. She was always in Canada and the U.S.

How did Nadine get into flying, especially as a woman in the 1930's?

In 1938, she was a spunk and racing pilot. This is what is interesting, because she's a Kansas girl. That's where the Ramsey family [was]. Her mom had no idea that she was already going to school and then going to get training to fly. She was really a woman ahead of her time and she was telling her brother, my husband who rode horses, "No, no, no – you need to concentrate on flying because the war is coming and you need to be ready for that."

My husband loved horses, so he was in the cavalry at the Oklahoma Military Academy where his mom placed him ... My husband is in the [Oklahoma Military Academy] Hall of Fame and when he was inducted into [it] he had mentioned that if it were not for the Oklahoma Military Academy, he would have been a juvenile delinquent. It was mom who had the insight, "Okay, these two – incredible daughter and son."

I have in my house, my mini-museum, two Congressional Gold Medals. Once for my sister-in-law given in 2010 by President Obama. Then my husband in 2018 [received a] Congressional Gold Medal ... by the Philippine Scouts Heritage Society. So I am saying this is an incredible family.

When I thought of writing the book, I said I'm not only going to honor this story of Nadine but I will honor the family. Because [they had] a mom that was a dermatologist in Kansas. This [was in] the 1800's, okay. She is a woman again, ahead of her free time. So I said I'll honor mom, I'll honor Nadine and I'll honor my husband.

You're a retired Beverly High teacher. Tell us about that.

I was 24 years at [the] Beverly Hills Unified School District. I was the coordinator of the english program – english as a second language. I handled international students from all over the world, from K-12 placement. Aside from being coordinator, I was teaching five classes [on] English literature ... poetry, Shakespeare and American literature

Who were some of your colleagues during your time at the BHUSD?

Oh my gosh, they are just wonderful. One of them [was Beverly High Assistant Principal] Toni Staser.

Another person is Karen Boyarsky, she was the librarian at Beverly High who was also there for more than 35 years. We worked [together] every day, because I would bring the students to the library to do research for my classes on biographies and different topics that I would give [them]. The students came from all over the world and they were according to Karen, the most diligent, enthusiastic and fabulous students. I am so thrilled for that.

Corinne Carlson, who is still there. She was the head of my department because it was foreign language and I was under the foreign language department because English was a second language. [She's] a French teacher, head of the Foreign Language department.

What do you hope readers take away from "Taking Flight?"

I think that readers will understand what love does to a family. My message through this book is that not only am I so proud of the heroism of my sister-in-law and my husband, but the whole Ramsey family. They went through the depression, they went through the hardest times during the war. My husband [did] four years behind enemy lines, decorated by MacArthur. They were survivors. Why? Because they wanted to succeed in the mission they carried.





The CITY may refuse to grant prequalification where the requested information and materials are not provided by the due date indicated above. There is no appeal from a refusal for an incomplete or late application, but re-application for a later project is permitted. Neither the closing time for submitting prequalification packages for this Project will be changed in order to accommodate supplementation of incomplete submissions, or late submissions, unless requested by the CITY in its sole discretion.

In addition to a contractor's failure to be pre-qualified pursuant to the scoring system

set forth in the prequalification package, a contractor may be found not prequalified for either omission of or falsification of, any requested information.

Where a timely and completed application results in a rating below that necessary to pre-qualify, an appeal can be made by the unsuccessful Contractor. An appeal is begun by the Contractor delivering notice to the CITY of its appeal of the decision with respect to its prequalification rating, no later than two business days following notification that it is not pre-qualified. The notice of appeal shall include an address where the Contractor wishes to receive notice of the appeal hearing. Without a timely appeal, the Contractor waives any and all rights to challenge the decision of the CITY, whether by administrative process, judicial process or any other legal process or proceeding.

If the Contractor gives the required notice of appeal, a hearing shall be conducted no earlier than five business days after the CITY's receipt of the notice of appeal and not later

than five business days prior to the date of the Notice Inviting Bids for this Project. Prior to the hearing, the Contractor shall, in writing, be advised of the basis for the City's pre-qualification determination.

The hearing shall be conducted by a panel consisting of three members of the Public Works Department senior management staff (the "Appeals Panel"). The Appeals Panel shall consider any evidence presented by the Contractor, whether or not the evidence is presented in compliance with formal rules of evidence. The Contractor will be given the opportunity to present evidence, information and arguments as to why the Contractor believes it should be pre-qualified. Within one day after the conclusion of the hearing, the Appeals Panel will render a written determination as to whether the Contractor is pre-qualified. It is the intention of the CITY that the date for the submission and opening of bids will not be delayed or postponed to allow for completion of an appeal process.
