"Mixed Use Ordinance Receives Mixed Reaction: Planning Commission Recommends Controversial Ordinance to Council" [Issue #1082]

This proposal is a fraud! It purports to encourage low-rise, mixed use buildings on Wilshire Boulevard – like the delightful one recently completed on the southwest corner of Stanley and Wilshire – but, under state law, it will allow much higher, densely populated structures.

Worse it shoves the burden of state-mandated housing increases onto the modest neighborhoods, far away from the ritzy areas north of Santa Monica Boulevard. Spot re-zoning for specific projects should be encouraged. But, if the state law will be invoked, the whole city should share the burden – by putting this fraudulent overlay on Santa Monica and Sunset Boulevards as well as Wilshire.

Bernard Kamine Beverly Hills Our city council will consider passing the ill-conceived mixed use ordinance at a virtual council meeting on Tuesday, October 13 at 7 p.m.

Passing the mixed use ordinance would be devastating since once commercial property is zoned for mixed use, the State Density Bonus Program will entitle developers to build up to six and seven story mixed use buildings, with reduced building standards and reduced or no parking requirements. The ordinance proposes to allow this to occur along most of Wilshire Boulevard, the eastern mile of Olympic, all of Robertson and La Cienega, and portions of South Doheny, San Vicente, South Santa Monica Boulevard and South Beverly Drive.

Such widespread consequential changes would not only adversely affect the beauty and quality of life in Beverly Hills, but will result in a great deal more traffic, a significant reduction of the precious little parking we now have and a decrease of our residents' real estate values.

Planning Commission Chair Peter Ostroff formulated and ramrodded approval of the mixed use ordinance at a 9 a.m. virtual Planning Commission meeting on June 19, despite the pandemic; despite a false and misleading meeting notice that mixed use projects would be limited to three and four stories; and despite the fact that 75% of public comments opposed the mixed use ordinance.

Not surprisingly, none of the planning commissioners who voted in favor of the

ordinance lived near the areas they sought to overly densify, to the detriment of so many other residents.

If this proposed massive developer giveaway is passed, it cannot be reversed because once property is zoned for greater density, it cannot be rezoned to decrease density.

Although the Planning Commission will hold a virtual meeting about how the State Density Bonus Program works with mixed use zoning, on October 8 at 6 p.m., this meeting is no substitute for meaningful public outreach seeking residents' input which should have taken place at community meetings prior to any consideration of such a monumental zoning change.

The city notice ultimately states, ".... [A] developer could ask to apply the State Density Bonus provisions to a project on a site, which would allow additional density, and potential deviations from the otherwise-applicable development standards (such as additional height, and reduced parking, among other things)."

A developer COULD ask? A developer WILL ask, because if the mixed use ordinance is passed, a developer will be EN-TITLED by the State Density Bonus Program, to all of its benefits, plus attorneys fees if the developer has to sue the city.

The only possible excuse for passing the mixed use ordinance is that it could help us fulfill statewide RHNA requirements to add more housing in the city.

But that excuse fails miserably because we could easily meet RHNA requirements by constructing alternative dwelling units, within and outside our homes, and by adaptive reuse – converting existing commercial buildings, with sufficient parking, to mixed use.

We could have added lovely, well-built and well-parked mixed use projects if the Planning Commission had not formulated and forced through approval of this mixed use ordinance. But now, rather than developers applying to build mixed use projects which would meet our city standards, developers are waiting for the mixed use ordinance to pass, under which they will be entitled to realize great benefits to the detriment of our residents. There is just no other conclusion to draw but that the Planning Commission, as comprised on June 19, sabotaged the interests of residents and the city.

It has become apparent why real estate interested donors avoided campaign donation limits and poured about \$80K of PAC money into our last city council election. Now we will learn whether we still have at least three good city councilmembers who will protect their constituents and the city.

Should three or more of our city councilmembers vote to pass the mixed use ordinance, we residents will have no choice but to circulate a referendum petition so that the ordinance can be put to a vote by the residents, in which event it will fail resoundingly. We will need about 2,250 voters' signatures to do that, which is doable. But if we are forced to go that far, we might as well aim for enough additional signatures to orchestrate recalls.

The Tuesday, October 13, 7 p.m. virtual city council meeting could lead to dire results if residents do not weigh in by making three minute calls during the meeting to (310) 288-2288 or sending an e-mail up to 350 words to cityclerk@beverlyhills. org by noon on October 13, with mixed use in the subject line.

BHUSD Releases Its Future Physical Reopening Plan

Superintendent Michael Bregy announced Sunday the BHUSD's "Ready Together" plan – a plan which describes how the district will physically reopen with safety precautions once public health orders allow.

Bregy said the plan is not an academic reopening plan but a physical one based on guidance from the Los Angeles County Department of Public Health Order, the California Department of Public Health Order and expert opinions.

"I have been giving regular updates regarding the changing COVID-19 impact on BHUSD at board meetings and PTA meetings and a consistent question I receive is 'but, are you ready?" Bregy said. "It is important that I specifically show you [BHU-SD stakeholders] how we are physically ready to reopen when the time comes."

The plan, which is still subject to change, includes the district's intentions regarding containment response, physical distancing, hygiene, cleaning, disinfection, site inspections, ventilation, signage and more.

Some aspects of the plan include smaller class sizes for in-person instruction. Classrooms will have on average between one third and half of the student population, according to the plan. Employees, contractors, vendors and delivery personnel have also been given instructions on maintaining physical distancing. There will be signage, tape and plexiglass on campus to ensure physical distancing is being maintained.

There will also be staggered drop-off and pick-up hours for students when possible. According to the plan, the district has expanded its infrastructure to allow for more bike-use.

The district has also refreshed the air filters in its heating, ventilation, and air conditioning systems. A cleaning and disinfecting schedule has been established and visual hangers will be used to show what has been cleaned.

According to the plan, students and staff will be given frequent opportunities to wash their hands and younger students will have regularly scheduled and mandatory hand-washing breaks.

BHUSD staff, faculty, visitors and students will be screened for COVID-19 based on the Center for Disease Control's symptom list. According to the plan, adults and visitors who screen positive or report symptoms are instructed to return home and self-isolate. Children who screen positive or report symptoms are given a mask and taken to an isolation room while plans are made for taking them home.

People will be monitored for having a single symptom of a fever of 100.4 Faherenheit or higher, cough, difficulty breathing, shortness of breath or loss of taste or smell – or two symptoms of chills, headache, sore throat, congestion, runny nose, fatigue, muscle or body aches, nausea,

vomiting or diarrhea.

tive Officer Julie Wagner, tourism in Beverly Hills has primarily been from the drive market people within driving distance of the city.

Wagner said normally the CVB would be focused on international tourism, along with other areas in the United States.

"Right now we're focusing on California," Wagner said."People's ability or comfortability of getting in a car in the past has been four hours, now I see people are willing to travel as long as eight hours in a car."

The hotel packages will be offered through September 21 and December 31. They include add-ons such as complimentary parking, food and beverage credit, room upgrades, late checkouts and complimentary breakfasts.

Beverly Hills hotels have implemented new COVID-19 health and safety precautions. According to Wagner, some hotels are taking temperatures, leaving rooms empty between occupied rooms, using an ultraviolet cleaning robot between stays and more.

Wagner said she thinks things are heading in the right direction, though fall and winter may be a little challenging because of the flu season.

"I do think travel will come back and I do think that this has not dampered people's desire to travel, get away, see the world, celebrate and experience new things," Wagner said. "And so it's just a question of when the stars all properly align and people feel safe again.'

Potential Mixed Use Ordinance Up for Debate

Mixed-use development in Beverly Hills is currently only permitted on a case-by-case basis, but that may change after the City Council discusses a mixed use overlay zone ordinance on October 13

Planning Commissioners recommended

the draft ordinance to the council on June 19. The commission's decision received generally mixed reactions from Beverly Hills residents and developers.

According to a city staff report, the overlay zone could change the following:

• make multi-family housing units included in mixed use buildings an allowed use in the overlay zone, allow for a density of up to one residential unit per 550 square feet of site area

• allow additional height (beyond the current three story/45 foot height limit) for mixed use buildings in certain parts of the overlay zone, depending on the height district of the adjacent residential zoning.

• establish development standards for mixed use buildings to regulate parking, residential unit size, outdoor living space, ground floor uses, height, setbacks, and operational standards, and

• outline the approval process for mixed use buildings proposed in the overlay zone.

The staff report also states that "foregoing standards and processes may change as a result of public input received in conjunction with the public hearing.'

The overlay zone would be applied to the following commercially zoned properties, according to a city staff report:

• properties fronting Wilshire Boulevard between San Vicente Boulevard and Rexford Drive

• properties fronting Wilshire Boulevard on the southern side of Wilshire Boulevard between Rexford Drive and South Santa Monica Boulevard

• properties fronting La Cienega Boulevard between the northern and southern borders of the City

• properties fronting Robertson Boulevard between the northern and southern borders of the City

• properties fronting Olympic Boulevard between Rexford Drive and the eastern border of the City

• properties fronting South Doheny Drive between Wilshire Boulevard and Charleville Boulevard

• properties fronting San Vicente Boulevard between Wilshire Boulevard and La Cienega Boulevard

• properties fronting South Santa Monica Boulevard located between Wilshire Boulevard and Moreno Drive

• properties fronting South Beverly Drive between Wilshire Boulevard and Charleville Boulevard

Prior to the council's October 13 meeting, the city's Planning Division will present an overview of the ordinance, discuss the State Density Bonus law and answer questions on October 8 at 6 p.m. According to a staff report, this meeting is meant to be informational and no decisions will be made during it.

To Trick-Or-Treat or Not To Trick-Or-Treat, That is the **Question for Beverly Hills**

Trick or treaters might have to hang up their witch's hats, superhero capes and candy buckets this year, as the City of Beverly Hills could ban the Halloween tradition due to COVID-19 health and safety concerns.

The Health and Safety Commission

recommended last Tuesday for the City Council to place a ban on both trick-ortreating and "trunk-or-treating" - a relatively new invention where children can collect candy from cars.

Commissioner Kirk Chang said he encourages residents to turn their porch lights off this year and do a better Halloween next year.

"While I recognize and deeply sympathise with the sacrifice that children and young people have made during this pandemic, but if we're all in agreement that there's no risk-

The council is likely to deliberate on this in its October 13 meeting.

Newsom Vetoes Controversial Ethnic Studies Bill

Gov. Gavin Newsom vetoed last Wednesday Assembly Bill 331, which would have required high school students to take at least one ethnic studies course to receive their diplomas.

The bill, written by Assemblymember Jose Medina (D - Riverside), involved a proposed model ethnic studies curriculum for California school districts to potentially base their courses on. A draft of the curriculum garnered allegations of anti-semitism for its inclusion of the Boycott, Divestment, and Sanctions movement, among other criticisms.

After the bill passed through the Legislature August 31, Medina agreed to several revisions - including allowing districts to create their own ethnic studies course. The BHUSD Board of Education passed a resolution expressing it did not support the current iteration of the bill in September.

Newsom said he appreciated the amendments that were accepted to ensure the curriculum was free from bias and discrimination.

"This bill, however, would require ethnic studies to be taught in high school at a time when there is much uncertainty about the appropriate K-12 model curriculum for ethnic studies," Newsom said.

He added that the latest draft curriculum currently out for review still needs amendments.

"In California, we don't tolerate our diversity. We celebrate it," Newsom said.

"That should be reflected in our high school curriculum. I look forward to our model curriculum achieving these goals."

Consul General of Israel Speaks at Beverly Hills Rotary Club Meeting

Consul General of Israel Hillel Newman attended a Beverly Hills Rotary Club meeting Monday to discuss peace deals between Israel, the United Arab Emirates and Bahrain.

Newman said there has been tremendous transformations in the Middle East in the past month. He said the establishment of peace between Israel, the UAE and Bahrain was a process that lasted over a decade and is a pivotal transformation.

"It finally reached fruition over the past month or two with a public declaration and then of course the signing of the approval in the ... rose garden of the White House," Newman said.

He added that Israel is talking with an additional five to 10 countries about establishing diplomatic relations - one of which may form by the end of the year. He said Israel does not name the countries, namely to not be an obstacle to their step forward.

Newman also answered questions from attendees, which included topics such as Israel's stance on the recent war between Azerbaijan and Armenia, the mandatory quarantine for visitors in Israel during the pandemic and the depiction of Israel in film and television.

Chamber Announces Support for North Beverly Drive North Portal Location

The Beverly Hills Chamber of Commerce Board of Directors voted to recommend North Beverly Drive as the second entrance/exit to the Wilshire/Rodeo Subway Station in Beverly Hills.

The City of Beverly Hills is considering three potential options for a second entrance and exit to the Wilshire/Rodeo Subway Station - otherwise known as the North Portal - being constructed as part of the Los Angeles Metro Purple Line Subway Extension. The chamber said it believes the North Beverly Drive option will be the most centralized location to access the business district, provide a convenient location to utilize the subway and provide a great amenity for the community.

The chamber recommended the following elements be included in this portal option:

(1) There be provisions for a second escalator to access the station;

(2) Provisions for bathrooms;

(3) A southbound shared right turn lane or elimination of the right hand turn lane at North Beverly Drive and Wilshire; and

(4) Provisions for multiple transportation options, including a shuttle bus to take people to and from the Wilshire/Rodeo station to other points in the city.

The chamber said it is aware that the

North Beverly option will result in a multi-year closure of North Beverly Drive between Wilshire and Beverly Canon Gardens. Therefore, the chamber is supportive of exploring ways, in partnership with the city and partner organizations, to mitigate the effects of such a closure.

City to Begin Phase One of Water Main Replacement Project

The City of Beverly Hills has contracted with Toro Enterprises to begin its Water Main Replacement Project, which will take place in three phases beginning later this month and ending early 2022.

As part of its Capital Improvement Program, the city will be replacing approximately 4.5 miles of aging pipeline on portions of Loma Vista Drive, San Ysidro Drive and Coldwater Canyon Drive. Replacing these pipelines is critical to maintaining the city's water infrastructure as they connect to six of the nine reservoirs in the city and have contributed to over 25 main line breaks over the years. The pipelines are constructed of cast iron and steel materials, installed in the 1920's to 1960's

Phase one will begin October 26 to April 2021 on Loma Vista Drive between Evelyn Place and Doheny Road. Work hours will be Monday through Friday from 8 a.m. to 6 p.m. Sections of each street will intermittently be reduced to one lane of traffic in each direction during work hours. All through traffic will be advised to use Coldwater Canyon Drive or an alternate route. Local access will be allowed.

Phase two is planned to begin May of 2021 on San Ysidro Dr. and phase three will take place on Coldwater Canyon Drive June 2021.

City to Host Two Virtual Design Charrettes for Connect Beverly Hills on October 14. 15

The City of Beverly Hills is hosting two virtual design charrettes for "Connect Beverly Hills: Meet Me on Wilshire and La Cienega" on October 14 and October 15.

Connect Beverly Hills is a project to develop a series of streetscape plans and design standards for commercial corridors in Beverly Hills. The city is starting with Wilshire and La Cienega Boulevards to prepare for the upcoming Metro Purple Line Extension bringing two new subway stations to Beverly Hills: Wilshire/ La Cienega in 2023 and Wilshire/Rodeo in 2025.

A charrette is a design workshop where stakeholders can provide valuable feedback to shape project recommendations. At the upcoming virtual design charrette, the project team will share ideas for the streetscape plan, design standards and proposed Mobility Hub at Wilshire/North Gale.

Draft designs will be based on public input received so far, including the recent design elements preference survey and Virtual Discovery Charette held in June. The community will get the opportunity to review the survey results and potential design options, and advance draft designs and amenities for the boulevards. The project's new short animated video is a quick and easy introduction to what the charrettes will cover.

According to his website, he was the first Latino district attorney in San Francisco and the first police chief to become district attorney in the United States.

Gascon said that they are being faced with existential questions about where the criminal justice system moves in the 21st century. He said the choices are between the past and the future.

"We can continue to harm our communities and continue to destroy budgets and destroy communities by the work that we do ... or we can begin to look at a 21st century model of law that would look at

how we build as opposed to break," Gascon said





The BHUSD Board of Education candidates went head-to-head in KBEV 6's candidate debate last Wednesday.



The prequalification packages shall be la-beled <u>"CONFIDENTIAL PREQUALIFICATION</u> <u>STATEMENT FOR THE ELEVATOR MOD-ERNIZATION AT THE 221 N. CRESCENT</u> <u>PARKING STRUCTURE AND WHEELCHAIR</u> <u>LIFT REPLACEMENT AT THE SANTA MONI-CA 5 PARKING STRUCTURES"</u>

The prequalification packages submitted by Contractors are not public records and are not open to public inspection. All information provided will be kept confidential to the extent per-mitted by law. However, the contents may be disclosed to third parties for purpose of verification, or investigation of substantial allegations, or in an appeal hearing. State law requires that the names of contractors applying for prequalification status shall be public records subject to disclosure, and the first page of the

questionnaire will be used for that purpose.

Each questionnaire must be signed under penalty of perjury in the manner designated at the end of the form, by an individual who has the legal authority to bind the Contractor on whose behalf that person is signing. If any information provided by a Contractor becomes inaccurate, the Contractor must immediately notify the CITY and provide updated accurate information in writing, under penalty of perjury.

The CITY reserves the right to waive minor irregularities and omissions in the information contained in the prequalification application submitted, and to make all final determinations. The CITY may also determine at any time that the prequalification process will be suspended for the Project and the Project will be bid without prequalification.

Contractors who submit a complete prequalification package will be notified of their qualification status no later than ten business days after submission of the information.

The CITY may refuse to grant prequalification where the requested information and materi-

als are not provided by the due date indicated above. There is no appeal from a refusal for an incomplete or late application, but re-application for a later project is permitted. Neither the closing time for submitting prequalification packages for this Project will be changed in order to accommodate supplementation of incomplete submissions, or late submissions, unless requested by the CITY in its sole discretion.

In addition to a contractor's failure to be pre-qualified pursuant to the scoring system set forth in the prequalification package, a contractor may be found not prequalified for either omission of or falsification of, any requested information.

Where a timely and completed application results in a rating below that necessary to pre-qualify, an appeal can be made by the unsuccessful Contractor. An appeal is begun by the Contractor delivering notice to the CITY of its appeal of the decision with respect to its prequalification rating, no later than two business days following notification that it is not pre-qualified. The notice of appeal shall include an address where the Contractor wishes to receive notice of the appeal hearing. Without a timely appeal, the Contractor waives any and all rights to challenge the decision of the CITY, whether by administrative process, judicial process or any other legal process or proceeding.

If the Contractor gives the required notice of appeal, a hearing shall be conducted no earlier than five business days after the CITY's receipt of the notice of appeal and not later than five business days prior to the date of the Notice Inviting Bids for this Project. Prior to the hearing, the Contractor shall, in writing, be advised of the basis for the City's pre-qualification determination.

The hearing shall be conducted by a panel consisting of three members of the Public Works Department senior management staff (the "Appeals Panel"). The Appeals Panel shall consider any evidence presented by the Contractor, whether or not the evidence is presented in compliance with formal rules of evidence. The Contractor will be given the opportunity to present evidence, information and arguments as to why the Contractor believes it should be pre-qualified. Within one day after the conclusion of the hearing, the Appeals Panel will render a written determination as to whether the Contractor is pre-qualified. It is the intention of the CITY that the date for the submission and opening of bids will not be delayed or postponed to allow for completion of an appeal process.
