Will Beverly Hills Establish Its Own Health Department?

The City of Beverly Hills may be getting its own health department, according to a City Council meeting Tuesday.

Councilmembers passed a resolution last week opposing Los Angeles County's outdoor dining ban and asking for its reversal. The council also gave direction for city staff to research suing the county for its health order and establishing a health department in Beverly Hills.

If Beverly Hills creates its own health department, it could have separate health orders from LA County as long as they comply with the state's health orders. This was how the City of Pasadena was able to continue allowing outdoor dining up until California's stay-at-home was put in place.

Councilmembers discussed the logistics of a Beverly Hills health department Tuesday. The earliest the city could have one would be July 1, 2021, according to a city staff presentation.

It's not yet clear what a health department would mean for the city's budget. According to the council's agenda report, health departments can be subsidized by federal and state funds in addition to local funding.

LA County, which had a population of 10,039,107 in 2019, allocated \$1,131,790,000 for its health department for the 2021 fiscal year. Pasadena, which had a population of 141,029 in 2019, allocated \$15,558,000.

Beverly Hills had a population of 34,183 in 2018, according to the U.S. Census Report.

City staff will continue to research a potential local health department and also look into other options after receiving direction from councilmembers. Some areas they will research include other public health programs and what role a local health officer would actually have.

The council will discuss the topic again in a future meeting.

County Awards BHUSD K-2nd Grade Waiver, But Students Won't Return to Campus Yet

The Los Angeles County Department of Public Health granted the BHUSD a transitional kindergarten to second grade waiver Sunday, which allows lower grade students to return to campus for instruction.

But with COVID-19 cases rising, students won't be going back to school just yet.

The county issued the BHUSD the last waiver before announcing its stay-at-home order in early December. Despite the district's approval, however, the waiver essentially came with a "caution" label.

"The waiver came with a very strong warning that if our students have access to an equitable distance learning program we should continue using it until there is

a significant bend in the curve and cases reduce," Bregy said in an email.

So while the county's assessment team passed Horace Mann and Hawthorne Schools in its inspection, the BHUSD will continue distance learning for the time being.

Schools that have already reopened for lower grades have not been required to close under the recent health order, as of press time. For instance, the Las Virgenes Unified School District has already opened for TK to 2nd grade and was able to add 3rd grade back Monday.

Bregy said everyone wants children back in schools, but the district must put health and safety first.

"I implore you to please follow the health order and I will be in touch as soon as we have a firm timeline to physically return to school for our youngest learners," Bregy said.

As BHUSD Faces Lowering Enrollment, Hawthorne School May Get the Cut

Beverly Hills may eventually have two elementary schools instead of three, as the BHUSD's enrollment numbers are projected to decrease over the next seven years. According to the BHUSD's 7-11 Committee meeting last Thursday, Hawthorne School may be the school that has to go.

A recent demographic study, which was presented to the board last Tuesday, predicted that the BHUSD's enrollment will decline 2.5% annually over the next seven years. There are currently 3,150 resident students in the BHUSD, which the study predicts will drop to 2,555 resident students in 2027.

Lower enrollment means the district may no longer need or afford to manage all of its current school properties. El Rodeo School, the third elementary school in Beverly Hills, is currently closed and under construction.

7-11 Committee member Peter Ostroff said the committee needs the board's direction on Hawthorne School. For instance, the board could tell them to assume the BHUSD will have only two elementary schools and Hawthorne is going to the one removed, he said.

"If they were to say 'assume that,' then we could also deal with how [Hawthorne] could be used – which could be a site for the new administrative offices," Ostroff said.

Superintendent Michael Bregy attended last Thursday's meeting to give feedback to the committee.

"It is very clear that our school district does not need to operate and should not operate three TK through 5 schools – they just shouldn't," Bregy said. "It would be irresponsible for me as superintendent to make that recommendation."

Ostroff said the committee has also had direction that it should look at the administrative offset site as potential surplus property and that it should also potentially look at the district's parking lot on Elm Drive and Gregory Way.

"What we would like to do is go before the board as soon as they can get us on their schedule, hopefully in January, with

a couple things in mind," Ostroff said. "Do they like the concept for the administrative offices and would they like us to take the next step?"

Bregy supported having the 7-11 Committee present at a board meeting in January.

"That would be the first conversation that the board has publicly about any type of change in facility usage outside of what we've done before about reconfiguration," Bregy said.

Council Discusses Affordable Housing Project

The City Council discussed the city's affordable housing development, which was created in response to California's housing crisis, Tuesday.

Councilmembers had given direction in 2019 for city staff to solicit proposals for developing the housing project on city property. According to the council's agenda report, city staff had prepared a draft Request for Qualifications and Conceptual Proposals for the development to be released in March. This was later delayed due to the pandemic.

The project site is located at 9298 West 3rd Street, but the adjacent city-owned property at 9268 West 3rd Street has also become vacant. According to the agenda report, the city can now potentially expand the project from being around 12,104 square feet of land to 60,380 square feet.

Beverly Hills has around \$1.5 million from the Affordable Housing Fund which can be used for the development. According to the agenda report, staff predicts that it will cost between \$131,000 and

\$218,300 per housing unit.

City staff requested direction on if it should move forward with an affordable housing RFP that includes the adjacent property. According to the agenda report, they recommended the following requirements for RFP respondents:

- Demonstrate relevant experience, financial capabilities and conceptual development financing and operations plans.

- Conduct an analysis of the neighborhood characteristics to inform project proposals.

- Utilize existing senior housing development standards.

- Identify a cohesive vision for the project and list the number of proposed dwelling units along with the mix of units.

- Propose income and affordability thresholds for prospective residents, including a potential preference for Beverly Hills residents.

- Propose site amenities.

- Demonstrate the project is financially feasible and that available outside funding sources will be utilized to the maximum amounts possible.

Mayor Lester Friedman said he believes that it should be totally affordable housing, not market-rate housing, similar to the other councilmembers.

"I do think that we need to get onto the public engagement process as soon as we have something that is out there, because we want to know what the public thinks before we get too far down the road," Friedman said.

Council Extends Medical Use Ordinance

The City Council extended the urgency ordinance which modified medical use regulations in certain commercial areas in Beverly Hills Tuesday.

The council had first adopted an urgency ordinance which eased medical use restrictions in November. According to the council's agenda report, this was meant to assist landlords facing economic losses during the pandemic.

Medical uses prior to the ordinance had been heavily restricted in order to prevent an over-concentration of medical offices in the city. The former medical-use regulations included that there must have been one parking space for every 200 square feet and building owners had to "register" their medical buildings to not be considered legally nonconforming.

Councilmembers extended the ordinance by 10 months and 15 days with a 4-1 vote, with Councilmember John Mirisch dissenting. The ordinance had been set to expire in 2021, but the extension will allow it to be in place for a year.

City staff will study permanent medical use modifications during this time.

According to the agenda report, the financial impact of the ordinance is currently unknown.

Medical use buildings are taxed less than many other building uses, which could result in less tax revenue from commercial areas if medical offices replace other businesses. But it is also possible tax revenue could increase if medical offices instead occupy vacant commercial spaces.

Council Addresses Confusion Surrounding "Pipeline Projects"

The City Council discussed resident concerns regarding what is considered a "pipeline project" Tuesday night.

Pipeline projects describe projects that have been exempted from new code requirements because they were approved prior to their implementation. According to the council's agenda report, several residents have expressed concerns about

pipeline projects proceeding under the old hillside code standards.

These concerns have largely surrounded the property located 1280 Monte Cielo Drive. According to the agenda report, the project was submitted before the council approved the Basement Ordinance and had therefore been exempted from the city's new requirements surrounding basements.

Land use applications are often amended during the entitlement review process or if there were discrepancies in ownership information. According to the agenda report, applicants had been given the

opportunity to revise, modify or add information to a project after it has been submitted based on city staff's comments.

The applicant for the Monte Cielo project had amended their original Hillside R-1 Permit to add additional elements, which included changes such as a request to export more than 1,500 CY of earth material and to exceed the maximum thresholds established by the city's landform alteration formula.

After several hours of debate and public comment, the council ultimately decided that the additional R-1 permits are a substantial change and therefore the Monte Cielo project cannot proceed as a pipeline project.

Arts & Culture Commission Discusses Public Art Policies

The Arts & Culture Commission discussed the city's temporary public art installations Tuesday.

The city has a myriad of public art on display from well-known locations like Beverly Gardens Park to the in front of city-owned office buildings. Temporary public art has allowed Beverly Hills to further expand its collection of art pieces, according to the commission's agenda report.

Art consultants Karen Constine and Jessica Cusick presented the policies to the commissioners.

According to the agenda report, the duration for temporary public art may be approved as a long-term installation which can range from one year to 10 years depending on its budget. Artists of any media are allowed to apply to have their art displayed in Beverly Hills.

Additional criteria for these projects include that there must be a compelling reason for the project, it should enhance public experience, it should be appropriate in scale, media and context and it has to be feasible for the city to display.

Potential locations for art projects are City Hall, city-owned fountains, city-owned buildings with tenant cooperation, the Wallis Annenberg Center for the Performing Arts, parking structures and parking lots, The Liner building or other site-specific locations based on the city's initiatives.

There is a three-step review process for public art proposals. First it must be reviewed and verified by staff that the project has met the city's requirements, then it is reviewed by the commission's fine art committee and finally it is reviewed by the full commission.

There are also multiple avenues for funding temporary installations. The city will occasionally partner with a project applicant and may provide partial funding.

Beverly Hills Fire Department Helps Quell Orange County Bond Fire

The Beverly Hills Fire Department helped fight the Bond Fire in South Orange County after receiving a request for mutual aid last Thursday.

The BHFDD had partnered with the Culver City and Santa Monica Fire Departments to create a fine-engine Strike Team. It dispatched two engine companies with eight personnel.

According to BHFDD Deputy Chief Joseph Matsch, the strike team was initially assigned to the Santiago Canyon and

Silverado Canyon for structure protection but was later assigned to protect the Irvine Lake area and a recreational vehicle storage facility.

"Their fast deployment ahead of the fire was instrumental in preventing millions of dollars in damage within their area of deployment," Matsch said.

The strike team returned last Friday, with no injuries or damage to report.

Design Review Approves North Roxbury Drive Home

The Design Review Commission conditionally approved a R-1 design review permit for a two-story home located at 911 North Roxbury Drive.

According to the commission's agenda report, the design for the home includes a mansard roof, balconies and double-height arched facade.

Project applicant BC Roxbury LLC had previously met with commissioners about its home in 2017. The Roxbury Drive residence had been proposed to have french-inspired architecture but despite receiving approval, the project expired

before the building permit was issued.

A resident nearby the home submitted a concern to the commission regarding the project.

Albert Baril wrote that the property had

been left in poor repair for the last three years. He said that he is concerned the owner will not keep the site safe and clean during construction.

"We have had to call the city along with our other neighbors to request that the property be clean and all the weeds and dry brush removed as it posed a fire hazard," Baril said. "The property has also not been properly secured with no real fence in the alley and poor covering to the front fence."

Design Review Commission Approves Design for North Palm Drive Home

The Design Review Commission conditionally approved an R-1 design review permit for the construction of a two-story home on North Palm Drive last Thursday.

Project applicants Jahangir and Homa Shayan had proposed a contemporary modern design for their home on 213 North Palm Drive. According to the commission's agenda report, the design proposal included a gabled roof design with a flat roof area, inset wood eave with metal banding, white cement-plaster and porcelain-tile cladding with anodized aluminum doors.

"The design overall is eclectic and a unique contemporary expression which

breaks from the generally flat-roofed designs of this architectural style," the agenda report read.

Beverly Hills Library Offers eLearning Classes

The Beverly Hills Public Library is now offering eLearning courses, which provides a route to educational, personal and professional development during the pandemic.

All you need is your Beverly Hills public library card to take the thousands of courses the library offers through online learning platforms. Classes include reading strategy for children, creative classes and homework help for teens and personal development and entrepreneurial courses like website design for adults.

The Next Beverly Hills Committee, in partnership with the library, has been offering its members the "Coding Bootcamp" through the library's Gale eLearning services.

Bradley Cook, chair of the Next Beverly Hills Coding Bootcamp said he never expected such mass participation during the pilot ranging from high schoolers all the way up to individuals in their 70s.

Beverly Hills Parks Apply COVID-19 Safety Modifications, Playgrounds Closed

The County of Los Angeles issued a temporary Health Officer Order on November 30 that restricted most public and private gatherings through at least December 20.

Playgrounds are closed, but parks and tennis courts at Roxbury and La Cienega Park remain open with COVID-19 health and safety restriction. Tennis playing is

restricted to members of the same household for singles and doubles play. Tennis instruction will not be available during this time.

Reservations must be made and patrons must check-in with appropriate identification at the tennis office window as usual.

Community Services Director Jenny Rogers said it saddens the department that it must close its playgrounds again and restrict tennis play.

"We know people need to be outdoors, in nature, and we hope that with our parks open, people will find solace in the outdoor space for recreation and rejuvenation," Rogers said.

Rachelle Marcus on Her Plans as BHUSD Board of Education President

What are your goals as the incoming BHUSD Board of Education president?

One of my goals is to have meetings that are well-run. I'm a very organized person – I like meetings to proceed [smoothly] and give everybody a chance to say their piece.

I really want the kids to be able to [have] a good return to campus when we can. That it will be done very smoothly and safely for all the students. It's very important to me that we return with very safe conditions and that everybody can get back to being in school. Of course, that so much depends on what's going on in the county and the state of the union. It really is just a matter of watching it closely.

I want to make sure that the Strategic Plan – that we designed last year – will be put into effect [and] will be closely watched. We will be looking at it with accountability and seeing it administered so the kids are getting the best education possible. The other thing I'd like to make sure that the construction continues on schedule and within budget. Hopefully we will be able to have all the

students back at the high school and El Rodeo when it is completed.

The other thing is trying to resolve the situation with the LAUSD and the BHUSD, in terms of the ownership of the land and getting that settled so that it doesn't impede our moving on with the eminent domain. That's a very big thing – I would like to see that resolved as quickly as is possible without any long legal battle.

I [also] want to see the collective bargaining agreements with the various union representatives and with all of the stakeholders completed to everybody's satisfaction. You never can please everybody all the time, but I'm hoping that we will have a very agreeable collective bargaining agreement in place with all of the stakeholder unions in our district.

What have you learned from your past two years on the board?

I've learned from my past two years on the board how to get along with peo-

ple, how to listen to other people's ideas and how to be able to [have discussions] and come to agreements. Even though I don't often see eye-to-eye with somebody, I can accept their viewpoint and we can agree to disagree. I've [also] learned how to be open to suggestions, not to be so set in my ways and to hear what other people have to say.

I try not to repeat what other people have said [before me]. I've learned that being [the] fourth person to speak [in meetings] that most of the things that I would like to say, have already been said.

I've learned what the jobs of the people on the board are – how to work with the superintendent, [etc]. I've learned how to work with these people so that we can come to common understandings about their jobs and my job.

You were a teacher in the BHUSD for 50 years. Tell us about your career as an educator.

I believe that my career as an education put me in a good position to be on the school board. I learned how to work with teachers, administrators and principals throughout the years. That has helped me be on the school

board at this time.

My love of teaching really transcends my being on the school board because the first most important thing for me is to represent the students. That is first and foremost the most important thing for me. As a [former] teacher, I [also] understand where teachers are coming from. So I [know] how they think and feel because at one time I was [them].

I started as a physical education teacher and I taught all the grades from 1-8 at Horace Mann School. Then due to a health condition, I went to the high school where I taught health and I worked with the students in the work experience program. Then it was penciled in that I would become the next science teacher for the eighth graders at El Rodeo and I did that for 10 years.

I [later] took my first retirement when I was very young. And though I was retired, they didn't let me retire. I worked

for the next three years teaching math, science and social studies at El Rodeo and Hawthorne as a long term substitute teacher basically.

I developed a program called "Project Wild" for all the students in grades 1-5, because at the time most of the teachers in the elementary grades had too many minutes. So they proposed this program where every nine weeks, students in each of the schools would do a unit on poetry, art, music and science. [I handled] the science component of that. [The program] taught the kids an appreciation and understanding of wildlife.

Hawthorne later said "What will it take to stay just at Hawthorne?" and I said, "Just offer me the job to stay at Hawthorne," and they did. So from that point on for the next 25 years, I was the science specialist for the elementary grades. I did science labs for all the kids in grades 1-5 during that time.

What was your favorite subject to teach?

Math and science. Well, I should say, when I started as a PE teacher that was my favorite. After 17 years of teaching PE at Horace Mann, what they were going to do [was start] co-ed PE classes. At that point, it probably was pretty lucky for me because I [didn't] know how I was going to deal with teaching the boys – who I felt should not be teaching with the girls at that time. So that was kind of a proper moment for me to be able to step down from teaching PE.

But I have to tell you, that change revitalized me completely. I absolutely loved teaching eighth grade science at El Rodeo for 10 years. It was wonderful. It was like a new beginning for me.

It was [then] decided that I should teach four eighth grade classes and one seventh [grade class]. It was a new principal, he decided to mix it up. That principal came in and said, "I think we should mix up the seventh and eighth grade. Mrs. Marcus you'll teach four eighth grade classes and one seventh grade. Jim Quider [another teacher], you'll teach four seventh grade and one eighth grade."

I said "You can't do that. It isn't fair to the kids, because there are kids that are going to miss Mrs. Marcus." And that's the way they felt, I mean the parents felt that way. They went to bat for me. At that point, they forced the principal to go back to the old way and he then resigned.

I want you to know that I never had a parent complaint. If a parent came to me, we would discuss it. I don't think there's a complaint in my folder.

When I was at Hawthorne for that brisk three years, both Horace Mann and El Rodeo lost their vice principals. Art Fields [was the principal at Horace Mann] and Steve Fisher was the principal at El Rodeo and they needed an assistant principal until they could find somebody. So Art said, "I think I'd like to have a Rachelle Marcus." And Fisher said "Well, I would like Rachelle Marcus too." They both wanted me. Funny part about it is then they said to [Hawthorne

Principal] Dick Douglas, "You don't have a right to tell Mrs. Marcus no, maybe [she] would like to do it. Why don't we offer it to her?"

Because Art Fields [asked] first, I went to Horace Mann as the assistant principal for two months until they found a replacement. Again, I did a very good job. I believe that my educational experience background as a teacher prepared me to be on the board because of my ability to work with people, to listen to people and to understand the needs of the kids.

LA County school districts, including the BHUSD, had to close unexpectedly when the COVID-19 pandemic broke out in the United States. Since then, the district has worked toward improving distance learning. As a former teacher, what is your opinion on how distance learning is going?

When we first had to travel into distance learning, I was disappointed in the instruction the kids were getting. I thought it was spotty, some teachers did better than others and it wasn't good. But it was what it was because we had to turn to it so quickly. We weren't as ready as we could have been.

Now I am very happy with distance learning. In the beginning, I felt that a lot of the teachers were not sensitive to the amount of time that the kids had to be on computers. But I think they've learned to adjust and they're doing a very good job. Our kids are getting as good an education as they can get – if they want it. In other words, students only do as well as they want to do.

I believe that the amount of work that was put in by the teachers and the administrators just before we came back to school has paid its dividend. We're very lucky that we already had adopted a one-to-one computer policy with our tech people, who are extremely knowledgeable and effective. I am not so convinced about the [Independent Learning Center] program. I don't know if it's good, bad, or indifferent because I don't hear anything about it. But I've always said that face-to-face education is better than a digitized program.

The BHUSD was approved for a K-2nd grade waiver to allow younger students to return to campus and is making preparations to reopen schools with COVID-19 safety precautions once that is permitted. What do you think is the right way to transition back to in-person learning, if at all?

I think that we're going to wait until after Christmas vacation to see what's going to happen. We need to see what's going to transpire there. I'm also hoping that the memorandum of understanding [with BHUSD stakeholders is completed] – I don't know if that's been completed yet for the complete return to [school].

I know we have the waiver. [But] if you would ask me right now, "Should we apply the waiver and send the kids back?" Absolutely not. Once the numbers have reduced themselves to where we can have more safety for the students

and teachers, I think we can return using the lower grades. Then we can transition in the third, fourth and fifth grades.

If the numbers drop to a reasonable amount between seven or 10, I think we can safely [return]. Our schools are ready to bring our kids safely back in the classroom. We have spent a tremendous amount of hours to prepare the classroom for the safety of the teachers and the students.

Do you think COVID-19 will affect the BHUSD and its students long term? Why or why not?

It's hard to say for sure. Until we can really do some proper assessments, I don't know if I can honestly answer that question. I think we're giving them the best education possible but I would love to see the assessments when we can do them and make some comparisons as to how they've done in the past to how they're doing now. [Then] we'll know whether it was a good or bad plan. I think it's a good plan right now, but how can I really evaluate it?

The BHUSD recently filed a quiet title claim against the LAUSD, after the LAUSD claimed to own a portion of the Beverly High property. Do you think the BHUSD will prevail?

The intent of the law was that the property should have been transferred. I would believe that hopefully there'll be a judge that sees it that way. That was supposed to be the way it was, but for

four days it slipped through the cracks and maybe we will have someone that will realize that for us. As far as I'm concerned, I'm just hoping that it will not take a long [time]. I hope that we don't have to have a lawsuit and spend a lot of money on attorneys and legal fees.

Tell us about yourself and your family.

I've been married for 52 years to Edwin Marcus. Everybody knows the story of how we met. We met in the parking lot of Horace Mann School [in the 1960's]. It was a very unusual thing – I was coming out of school late one day and this man was driving his car up on the lot. I got up out of the car and I thought he was going to be a parent coming to a parent conference. [But] he started to walk away from the school. I yelled at him “Hey, you! You can't park here!” [Edwin] turned around and came back.

There were only two or three cars left in the parking lot, because it was late in the afternoon. I was walking toward my car and [Edwin] said “Is that your car with the Minnesota plates?” And I said “Yes.” He says “Are you from Minneapolis?” and I said “Yes.” He said “So am I.” And we were married three months later.

So after 52 years, we have two children [Marty Marcus and Joy Weiser]. Both of my children graduated from Beverly High [and] they went to Hawthorne. My son is an attorney and my daughter is a yoga instructor/entertainer and singer. Now I have two grandchildren.

My son married [Debbi Rubins Marcus, who] he was in school with all the way through high school. They both went to Hawthorne and they had classes together. One day he bumped into her brother [Danny]. He said “How's Debbi?” and [Danny] said “Well, she's not going with anyone. Why don't you call her?” 12 years later, here they are. I have two nine-year old twin grandchildren [from them], Alea Marcus and Ian Marcus.

I'm a big lover of the outdoors. I was born and raised in Minnesota, where [there are] a lot of parks and lakes. I love science and I love boxer dogs. The kids all knew it, everybody knows that Mrs. Marcus loves boxers.

And no matter where I go today – parents, former students [and] administrators always call me Mrs. Marcus. I really have become very fond of that.

We bought the [Beverly Hills] house that we live in 40 some odd years ago. The reason we moved to Beverly Hills was because I was always afraid that the permits to have your children go to school in Beverly Hills might be taken away from teachers. Because LAUSD did not like to give up its children. So we bought a house just before my son started Kindergarten.

One year from now, what are the top three things that you hope to have accomplished?

One, that our students are all back in school and that they are back in regular

education classes. That some of our students will be back at the high school in the buildings – I hope that that will be the case. That we will have resolved the problem with the BHUSD and LAUSD. And that the collective bargaining will have been completed for the next three years.

[Also] just that our kids are getting the best education that we can offer and that they will be doing as well, if not better. Maybe our enrollment numbers will go up a little bit, but that has been a big concern that our enrollment is dropping.

You have continued to work in the BHUSD, even after retirement. Why are you so passionate about the Beverly Hills public education system?

When I moved from Minnesota and I was going to come to California to teach – there was no place that I wanted to teach other than Beverly Hills. I still think it's one of the best school districts around. I think we offer the students a terrific education and I wish that I could even get my grandchildren to go to school here but they don't live here.

I will continue to think that we have a wonderful administration – very dedicated and hardworking. We have good teachers, we have wonderful support from parents and community members and things like the Beverly Hills Education Foundation. It's just the total package.

ORDINANCE NO. 20-O-2828

AN ORDINANCE OF THE CITY OF BEVERLY HILLS ADDING ARTICLE 17.1 TO CHAPTER 2 OF TITLE 4 OF THE BEVERLY HILLS MUNICIPAL CODE TO REGULATE ANIMAL GROOMING

THE CITY COUNCIL OF THE CITY OF BEVERLY HILLS HEREBY DOES ORDAIN AS FOLLOWS:

Section 1. The City Council of the City of Beverly Hills hereby adds Article 17.1 (Animal Grooming) of Chapter 2 of Title 4 to read as follows:

"Article 17.1. Animal Grooming:

4-2-1710: Permit Required:

No person shall engage in, conduct, or carry on commercial animal grooming activity without a permit issued under the provisions of Chapter 1, Article 1 of this Title.

4-2-1720: Definitions:

For the purposes of this Article, the following terms shall have the following meanings:

A. "Animal" shall mean common mammalian household pets such as dogs or cats. The provision of this article shall not apply to reptiles, amphibians, birds, or fish.

B. "Animal groomer(s) or Groomers" shall mean persons engaged in animal grooming.

C. "Animal grooming" shall mean the cleaning, styling, and appearance maintenance of animals, or the handling of animals in preparation for these services, with the exception of preparation for medical purposes or procedures.

D. "Animal grooming facility or business" shall mean any establishment where commercial animal grooming takes place.

E. "Establishment" shall mean a business or other organization, or the place where a business or organization operates.

F. "Grooming arms" shall mean polls or posts, that extend over the grooming table or grooming station, from which tethering devices are attached.

G. "Groom loops" shall mean any tethering devices where a loop is placed around the head or neck of an animal but the amount that it tightens is limited or restricted when pressure is applied.

H. "Grooming noose" shall mean any tethering device where a loop is placed around the head or neck of an animal but the amount that it tightens is not limited or restricted when pressure is applied. This definition does not include "grooming loops".

I. "Mobile animal grooming business" shall mean an animal grooming business operated out of a van or other vehicle that performs animal grooming at locations off-site from the address where the business is licensed.

J. "Nationally recognized organization" shall include, but is not limited to, International Professional Groomers, International Society of Canine Cosmetologists, National Dog Groomers Association of America, or American Ken-

nel Club. Such organization shall adhere to standards of care, safety and sanitation that are similar or equivalent to those set forth by the Professional Pet Groomers and Stylists Alliance.

K. "Self-groom" shall mean animal grooming performed by the owner or guardian of an animal at a commercial animal grooming facility.

L. "Tethering device" shall mean any device used to restrain or tether an animal to a grooming table or other surface.

4-2-1730 Application Information - Animal Grooming Businesses:

In addition to the information prescribed by the Finance Director, all applications for a permit to conduct an animal grooming business must contain the following information:

A. The complete address and all telephone numbers of the animal grooming business;

B. A complete list of the names and residence addresses of all proposed employees employed by the animal grooming business and the name and residence addresses of the manager or managing employee proposed to be principally in charge of the operation of the animal grooming business;

C. If applicable, the two previous addresses of the applicant immediately prior to the present address of the applicant;

D. Whether or not the applicant, in previously operating an animal grooming establishment or similar business in this or any other city or state under license or permit, has had such license or permit denied, revoked, or suspended and the reasons therefor;

E. The applicant must report to City on the permit application form if any employee, with direct contact with animals, ever has had a license or permit, certification or identification for working with animals revoked or suspended, and the reason therefor;

F. All criminal convictions of the business and the owner/applicant involving animals or the animal grooming business; and

G. Proof of current business tax registration with the City of Beverly Hills.

4-2-1740 Operating Requirements:

A. Staff Requirements.

1. Any animal grooming facility shall have a responsible person on the premises to act as manager and supervise employees during all business hours.

2. Groomers that are employed by the permittee on or after the effective date of this ordinance shall not groom any animal without the supervision of a groomer who has met the criteria enumerated in paragraphs (a) through (d) below unless the unsupervised groomer has:

a. Obtained certification for their level of responsibility from a nationally recognized organization; or

b. Graduated from an animal grooming school and have a minimum of one year of practical, professional animal grooming experience; or

c. Completed an animal grooming apprenticeship program commensurate with their level of responsibility; or

d. Been employed as a groomer for no less than the last seven (7) consecutive years, and throughout that period and course of employment has regularly and frequently groomed animals.

B. Inspection Authority. Any city official, city employee, or employee of Los Angeles County Animal Care and Control, authorized to enforce the provisions of this article of the Beverly Hills Municipal Code, such as Community Preservation staff, may conduct an inspection of the premises licensed under this article at any reasonable time to ensure compliance with the provisions of this article. Mobile animal grooming businesses are subject to vehicle inspections to ensure their vehicle(s) used for mobile grooming meet applicable facility requirements, including, but not limited to, requirements to install and maintain video recording devices in good working order that adequately capture the animal and the groomer throughout the grooming process.

C. General Facility Requirements.

1. Facilities for animals must be maintained so as to continuously provide a sanitary environment for the animals kept or to be kept therein.

Equipment shall be maintained in accordance with all applicable laws and industry standards.

2. Animal holding or drying areas shall be large enough to allow the animal to stand, lie down and turn around.

3. Cages and grooming areas such as tables, benches, and tubs shall be structurally sound and maintained in good repair.

4. Animal enclosures, cages or other restraint devices shall be constructed to prevent injury to the animals. Enclosures may have wire flooring provided that the wire is of adequate gauge to prevent sagging under the weight of the animals, and the mesh is small enough to prevent their feet from passing through.

5. Grooming personnel must remain within four (4) feet of the animal during all bathing and grooming procedures.

6. A consultation with the customer shall take place prior to the grooming to discuss health and temperament concerns and to establish the animal's previous grooming history.

7. Grooming nooses, chokers, slip collars, pinch collars, and prong collars shall not be used as tethering devices.

8. All tethering devices shall be equipped with a quick-release feature, which allows the tethering device to be removed quickly and safely. Animals placed on grooming tables in self-grooming areas must be attached to tethering devices with quick-release features. A tethering device is not required to be used if an animal is on the ground.

9. Any tethering device, harness, or restraint used shall be of appropriate style, size, and strength for the animal to which it is attached. Grooming loops or tethering devices used to restrain an animal by its neck are not appropriate tethering devices for cats.

10. Animals with a collapsed trachea or other breathing problems shall neither be tethered nor restrained in such a manner as to inhibit its ability to breathe and all reasonable efforts shall be made to reduce or prevent pressure to the neck of such animal.

11. Tethering devices shall be fastened to the animal in a manner that minimizes discomfort to the animal.

12. Grooming arms, by which the animal is restrained, shall be secure.

13. Video recording.

a. Within eight (8) months of this ordinance's enactment, video recording devices shall be installed and maintained in good working order in all bathing and styling areas of grooming facilities, except those areas where patrons self-groom animals for which the patrons are owners or guardians.

b. Video recording devices shall be installed in such a way to adequately capture the animal and the groomer throughout the bathing and styling process, which may require more than one video recording device to be installed.

c. Video recordings may be stored through cloud storage or local storage.

d. Video must be of a reasonably quality to capture all animal grooming activities. Devices that capture video at a resolution of, or higher than, 1080p HD are presumed to be of reasonable quality.

e. All recordings shall be maintained for a period of no less than seven (7) days. Any recording of animal mistreatment, injury or death shall be preserved for a period of two (2) years.

14. Grooming tabletops shall be equipped with a non-slip surface that is easy to clean.

15. Bath tubs and the floor immediately outside of the tub shall be covered in a non-slip surface.

D. General Operating Requirements.

1. All animal grooming facilities shall have a working relationship and written acknowledgement from a veterinarian to provide timely veterinary care as appropriate for illness or injury. The name, address and phone number, and hours of operation, of the veterinarian will be available to the inspector upon request, and shall be posted.

2. Anti-bark collars and sedatives shall not be used on any animal without written permission of the owner or guardian of the animal.

3. Animals which are natural enemies shall not be quartered or held together or so near each

other as to cause injury or torment.

4. Animals shall not be boarded at the facility, unless the facility is permitted as a pet boarding facility pursuant to Beverly Hills Municipal Code section 10-3-1620.3. The pet boarding area shall be separate from the grooming area. Animals shall only be kept at a grooming facility for a reasonable time in order to perform the business of grooming.

5. Each animal shall be kept in an individual cage unless grouping of animals is requested by the animal(s) owner(s) or guardian(s).

E. Cleanliness Requirements.

1. The interior facility surfaces, walls, cages, counters, and tables shall be constructed and maintained so that they are water resistant and can be cleaned and sanitized.

2. All cages, benches, tables, tubs, etc. shall be sanitized after one animal ceases to occupy the space, before another occupies the same space.

3. Equipment such as brushes, combs and clipper blades shall be sanitized between uses on different animals.

4. The hair or fur on the floor around each grooming station shall be removed after each animal. Common areas of the facility shall be kept in good repair and cleaned each business day.

5. Hair, waste and refuse shall be removed from the facility and disposed of daily so as to minimize odors, disease hazards and vermin infestation.

F. Water.

1. Potable water shall be provided for drinking purposes.

3. Water shall be offered to animals at the facility at least once every hour and water dishes shall be cleaned prior to offering the water dish to another animal.

G. Dryers.

1. Cage dryers with a fully enclosed drying chamber in which the animal is placed, and without safety air vents, are prohibited.

2. Dryers must be located and oriented to be in clear and full view of groomers at all times.

3. Dryers must be monitored by an animal groomer at all times while in operation.

4. All dryers must be equipped with a timer that will automatically shut off the dryer after fifteen minutes, unless it is a hand-held dryer or a dryer directly attended by a person.

H. Records. Current and up to date files of incidents involving injuries, severe illness, seizure and/or death which occur at the animal grooming facility or business must be kept at the facility at all times. The incident file shall cover the most recent three (3) year period. The records shall be available to the public, upon request during regular business hours. Mobile animal grooming businesses may keep incident files at the address where the business is licensed.

I. Reporting. The manager or person in charge must report all grooming-related injuries requiring medical attention and the deaths of any animal at the facility within twenty-four (24) hours of the occurrence of such incident. Notification is to be made to the City of Beverly Hills Community Preservation Manager by telephone. Such notification must include the name, address and phone number of the guardian of the injured or deceased animal.

J. Mobile Animal Groomers. Mobile animal grooming businesses shall be required to have an animal grooming permit and comply with all provisions of this article.

4-2-1750 Enforcement:

A violation of this article is subject to the administrative penalty provisions of Title 1, Chapter 3 of this Code. Where the violation is of a continuing nature, each day or portion thereof wherein the violation continues constitutes a separate and distinct violation.

A permit to operate an animal grooming facility may be revoked or suspended pursuant to the provisions of Title 4, Chapter 1, Article 1 of this Code."

Section 2. Severability. If any section, subsection, subdivision, sentence, clause, phrase, or portion of this Ordinance or the application thereof to any person or place, is for any reason held to be invalid or unconstitutional by the final

decision of any court of competent jurisdiction, the remainder of this Ordinance shall be and remain in full force and effect.

Section 3. Publication. The City Clerk shall cause this Ordinance to be published at least once in a newspaper of general circulation published and circulated in the City within fifteen (15) days after its passage in accordance with Section 36933 of the Government Code, shall certify to the adoption of this Ordinance, and shall cause this Ordinance and this certification, together with proof of publication, to be entered in the Book of Ordinances of the Council of this City.

ORDINANCE NO. 20-O-2829

AN ORDINANCE OF THE CITY OF BEVERLY HILLS AMENDING CHAPTER 6 (SHARED MOBILITY DEVICES) OF TITLE 7 (TRAFFIC, PARKING, AND PUBLIC TRANSPORTATION) OF THE BEVERLY HILLS MUNICIPAL CODE TO EXTEND THE PROHIBITION ON SHARED MOBILITY DEVICES BEING PLACED IN ANY PUBLIC RIGHT-OF-WAY OR ON PUBLIC PROPERTY, OPERATED IN ANY PUBLIC RIGHT-OF-WAY OR ON PUBLIC PROPERTY, OR OFFERED FOR USE ANYWHERE IN THE CITY, AND TO EXTEND THE SUNSET DATE OF SUCH PROHIBITION THE CITY COUNCIL OF THE CITY OF BEVERLY HILLS HEREBY DOES ORDAIN AS FOLLOWS:

Section 1. On July 24, 2018, the City Council enacted an urgency ordinance (Ord. 18-O-2757) prohibiting for six months shared mobility devices from being placed in the public right-of-way or on public property, operated in the public right-of-way or on public property, or offered for use anywhere in the City (referred to herein as "the prohibition"). On December 18, 2018, the City Council enacted an ordinance (Ord. 18-O-2769) extending the prohibition for an additional twelve months until January 17, 2020. On November 19, 2019 the City Council enacted an ordinance (Ord. 19-O-2794) again extending the prohibition for an additional twelve months until January 10, 2021. These extensions of the prohibition were necessary in order to address the serious safety hazards posed by the proliferation of unregulated shared mobility devices being illegally operated on the sidewalk and abandoned haphazardly on public and private property. The City remains open to exploring the feasibility of an alternative regulatory scheme or pilot project involving shared mobility devices. However, there is no pilot project or alternative regulatory scheme yet in place in the City. The City therefore intends to extend the prohibition beyond the January 10, 2021 sunset date as provided in Section 3 below.

Section 2. This Ordinance was assessed in accordance with the authority and criteria contained in the California Environmental Quality Act (CEQA), the State CEQA Guidelines, and the environmental regulations of the City. The adoption and implementation of the Ordinance would extend the current prohibition on shared mobility devices being placed in the public right-of-way or on public property, operated in the public right-of-way or on public property, or offered for use anywhere in the City. The Ordinance is exempt from the requirements of CEQA because it does not qualify as a project under CEQA and pursuant to CEQA Guidelines Section 15061(b)(3) because it can be

seen with certainty that there is no possibility that continuing its current policy of prohibiting shared mobility devices from being placed in the public right-of-way or on public property, operated in the public right-of-way or on public property, or offered for use anywhere in the City will have a significant effect on the environment. The Ordinance is additionally exempt from CEQA pursuant to CEQA Guidelines Section 15301(c), as it involves no expansion of the use of existing facilities, a category that includes streets and sidewalks.

Section 3. The City Council of the City of Beverly Hills hereby extends the prohibition on shared mobility devices found in Chapter 6 (Shared Mobility Devices) of Title 7 (Traffic, Parking, and Public Transportation) of the Beverly Hills Municipal Code by amending Section 7-6-5 (Sunset Provision), to read as follows: "This Chapter shall remain in effect until one year after either the California Governor lifts the Covid-19 State of Emergency, or the City Council lifts the Covid-19 State of Emergency, whichever is later, at which time it shall become ineffective unless the City Council acts to extend it."

Section 4. Severability. If any section, subsection, subdivision, sentence, clause, phrase, or portion of this Ordinance or the application thereof to any person or place, is for any reason held to be invalid or unconstitutional by the final decision of any court of competent jurisdiction, the remainder of this Ordinance shall be and remain in full force and effect.

Section 5. Publication. The City Clerk shall cause this Ordinance to be published at least once in a newspaper of general circulation published and circulated in the City within fifteen (15) days after its passage in accordance with Section 36933 of the Government Code, shall certify to the adoption of this Ordinance, and shall cause this Ordinance and this certification, together with proof of publication, to be entered in the Book of Ordinances of the Council of this City.

Section 6. Effective Date. This Ordinance shall go into effect and be in full force and effect at 12:01 a.m. on the thirty-first (31st) day after its passage.

Section 7. Certification. The City Clerk shall certify to the adoption of this Ordinance.

ORDINANCE NO. 20-O-2830

AN ORDINANCE OF THE CITY OF BEVERLY HILLS AMENDING ARTICLE 2 OF CHAPTER 3 OF TITLE 4 (ENTITLED PARADES AND ASSEMBLIES) OF THE BEVERLY HILLS MUNICIPAL CODE

THE CITY COUNCIL OF THE CITY OF BEVERLY HILLS HEREBY ORDAINS AS FOLLOWS:

WHEREAS, the City of Beverly Hills recognizes the importance of public gatherings that allow the community to collectively express its concerns about public issues, and supports the rights of all people to peacefully exercise their First Amendment rights to free speech and assembly; and

WHEREAS, on October 27, 2020, the City Council adopted Urgency Ordinance No. 20-O-2821, amending Article 2 of Chapter 3 of Title 4 (entitled Parades and Assemblies) of the Beverly Hills Municipal Code to attempt to balance protection of the First Amendment right to demonstrate with the physical and fiscal impacts of these demonstrations on the City, the Police Department, and the City's residents.

The Urgency Ordinance went into effect on 12:01 a.m. on November 4, 2020; and

WHEREAS, on November 10, 2020, the City Council adopted a regular, permanent ordinance making identical changes to the municipal code; and

WHEREAS, the City now seeks to revise its parade and assembly regulations to address issues that were not addressed in the November 10 ordinance; and

WHEREAS, beginning on July 25, 2020, and continuing weekly on every Saturday thereafter, groups of roughly one hundred (100) to four thousand (4000) people have held unpermitted political demonstrations on Saturday at Beverly Gardens Park, primarily on the block between Beverly Drive and Cañon Drive, occupying large portions of the park for several hours each Saturday for eighteen weeks, and regularly spilling over into heavily trafficked roadways; and

WHEREAS, during unpermitted demonstrations participants have encroached into Santa Monica Boulevard, a major arterial, and the bike lane along Santa Monica Boulevard, endangering themselves and distracting and endangering those in vehicles and on bicycles; and

WHEREAS, a number of participants at recent public demonstrations have wielded long, thin metal or plastic rods, including fishing poles, in ways that jeopardized the physical safety of other participants, bystanders, and law enforcement officers; and

WHEREAS, the portion of Beverly Hills Park between Beverly Boulevard and Rodeo Drive contains a popular public art garden, which features many valuable works of art that are installed and maintained by the City; and

WHEREAS, the portion of Beverly Gardens Park between Beverly Drive and Rodeo Drive has been used only sparingly for unpermitted demonstrations; and

WHEREAS, the use of Beverly Gardens Park as an area for unpermitted protests has, due to the park's close proximity to residential neighborhoods, resulted in considerable hardship for area residents as expressed in numerous complaints, including repeated obstruction of local access to and through the park, sudden and sharp increases in illegal parking (including in residential neighborhoods), and safety concerns; and

WHEREAS, the City desires to adopt regulations that will promote the free exercise of First Amendment rights through parades and assemblies, and simultaneously serve the significant interests of protecting the public health and safety of our community, including those involved in or observing parades and assemblies; and

WHEREAS, the City particularly desires to protect its residents' rights to enjoy free and unfettered access to the City's public parks and the features thereof, and to protect the health and safety of demonstrators, drivers, and pedestrians.

Section 1. Section 4-3-200 of Article 2 of Chapter 3 of Title 4 (entitled Parades and Assemblies) of the Beverly Hills Municipal Code is hereby amended to read as follows:

"4-3-200: ASSEMBLIES OF LESS THAN FIVE HUNDRED PEOPLE:

A. Notwithstanding any other provision of this Article, parades and assemblies of fewer than five hundred (500) people will be allowed without a permit in La Cienega Park and on the Crescent Drive side of the City Hall.

B. No sound amplification equipment shall be permitted if it will generate Significant Noise Impacts.

C. To protect public access to City parks for public uses other than parades and assemblies, if La Cienega Park experiences any unpermitted parade or assembly which either: (a) takes place in the park for more than two (2) hours within the same six (6) hour time period for six (6) weeks within a twelve week (12) period, or (b) takes place in the park for at least two hours on a Saturday or Sunday for six (6) weeks within a twelve (12) week period, then the park shall be closed to unpermitted parades and assemblies for a period of six (6) weeks and unpermitted parades or assemblies may take place in another location named in Section 4-3-200(A)."

Section 2. Subsection V is hereby added to Section 4-3-209 of Article 2 of Chapter 3 of Title 4 (entitled Prohibitions) of the Beverly Hills Mu-

nicipal Code to read as follows:

"V. Participants in unpermitted parades and assemblies taking place in any locations listed in Section 4-3-200(A) shall not assemble in an adjacent public right of way, and shall at all times remain at least seven (7) feet back from the curbs alongside La Cienega Boulevard and other major arterial streets."

Section 3. Subsection B of Section 4-3-209 of Article 2 of Chapter 3 of Title 4 (entitled Prohibitions) of the Beverly Hills Municipal Code is hereby amended to read as follows:

"B. It shall be unlawful for any person to carry or possess any length of plastic or metal pipe, rod or other object greater than one foot (1') in length and/or greater than one-quarter inch (1/4") in its thickest dimension, including rods attached to signs, posters, plaques, notices."

Section 4. CEQA. The City Council hereby finds, in the exercise of its independent judgment and analysis, that this ordinance is not a proj-

ect under the California Environmental Quality Act (CEQA) as State CEQA Guidelines Section 15378(b)(5) provides that a project does not include organizational or administrative activities of governments that will not result in direct or indirect physical changes in the environment. This ordinance merely amends the City's regulations governing parades and assemblies, and does not allow any new uses of land within the City that would result in direct or indirect physical changes to the environment. In addition, this ordinance is also exempt from the California Environmental Quality Act (CEQA) as there is no possibility the proposed ordinance would have a significant impact on the environment pursuant to State CEQA Guidelines Section 15061(b)(3). A Notice of Exemption has been prepared and will be filed in accordance with CEQA and the State CEQA Guidelines.

Section 5. Severability. If any provision of this Ordinance is held invalid by a court of competent jurisdiction, such provision shall be con-

sidered a separate, distinct and independent provision and such holding shall not affect the validity and enforceability of the other provisions of this Ordinance.

Section 6. Publication. The City Clerk shall cause this Ordinance to be published at least once in a newspaper of general circulation published and circulated in the City within fifteen (15) days after its passage in accordance with Section 36933 of the Government Code, shall certify to the adoption of this Ordinance, and shall cause this Ordinance and this certification, together with proof of publication, to be entered in the Book of Ordinances of the Council of this City.

Section 7. Effective Date. This Ordinance shall go into effect and be in full force and effect at 12:01 a.m. on the thirty-first (31st) day after its passage.

Section 8. Certification. The City Clerk shall certify to the adoption of this Ordinance.
