BHPD Investigates **Robberies at Fendi and Saint** Laurent

The Beverly Hills Police Department is investigating robberies at luxury retailers Fendi and Saint Laurent on North Rodeo Drive

A group of 10 people stole handbags from the Fendi store and fled into three cars parked nearby Tuesday, according to the BHPD. BHPD Public Information Officer Lt. Max Subin said patrol units located one of the cars and arrested its passengers, who were all minors, for robbery.



"Detectives and the Crime Impact Team are currently investigating the crime which involves locating the other two vehicles that got away," Subin said.

Subin said the BHPD believes the

Fendi robbery is connected to the robbery at the Saint Laurent store earlier this week. He said purses and other items were stolen and no arrests were made

"Due to the on scene investigation and immediate crime follow up, we believe the arrest last night is connected to the Saint Laurent crime earlier in the week," Subin said.

La Cienega Park Project on Hold Due to **Budget Constraints**

The City of Beverly Hills has placed the La Cienega Park project, which was estimated to cost approximately \$100 million, on hold due to budget constraints and the pandemic.

The project, dubbed the La Cienega Park and Recreation Complex Master Plan, proposed for a recreation complex, aquatics center, pedestrian bridge and other community spaces at La Cienega Park. Independent consultant group Consensus and Collaboration Program helped the city conduct public outreach for the project, which included town halls, focus groups, community surveys and in-

terviews. But sometime in 2019, the city placed the project on hold because of a lack of

funding

Assistant Director of Community Services Pam Shinault said the city did not have a clear financing strategy identified for the La Cienega Park project and therefore didn't move forward with its next phase - design development.

"Part of the biggest hurdles with it is funding because it's such a big and expensive project," Shinault said. "A lot of time funding for Capital Improvements like that comes from development activities can't say there's a whole lot of development activity going on that would fund a project that large.'

According to the city's website, the last meeting on the La Cienega Park project was on December 2, 2019. A Recreation & Parks City Council Liaison discussed funding for the center and putting out a "Request for Proposal" for the pre-design of the project.

Shinault said the city didn't secure any additional consultants for the next phase of the project.

"We'll [likely have] a different consul-

tant in the next phase and then we've got to have somewhat of a discussion about possible financing strategies because that's a big nut to crack [before going in] any further with design," Shinault said.

Shinault, who is retiring after four years working with the city, said there isn't an estimate for when the project will recommence. She said that when it is completed, though, it's going to be a really exciting project.

"The amenities will be absolutely stunning and fabulous," she said, "There will be something for everybody if the whole thing gets built. That's always exciting."

City Defers Transient Occupancy Tax Payments Again

The City of Beverly Hills allowed hotels to defer their monthly transient occupancy tax payments last Monday.

Beverly Hills hotels charge a transient occupancy tax from their guests, which the city then collects from hotels monthly. According to the city, the tax is 14% of the gross receipts for renting a room.

But like many businesses, the COVID-19 pandemic had a significant financial impact on the hospitality industry. According to the city, Beverly Hills hotels are at historically low occupancy rates - which has also reduced TOT revenue.

The city, however, has offered hotels some reprieve.

Councilmembers approved a deferral of TOT payments in March, with payments for February, March and April due four months afterward. Councilmembers approved another deferral for February and March in May, with payments due six months afterward.

Peninsula Beverly Hills Managing Director Offer Nissenbaum asked city councilmembers to defer TOT payments once again during public comment.

'Obviously with the recent stay-athome order and the ban on anything but essential travel, cash flow for hotels has come to a complete halt," Nissenbaum said. "It's really a die-hard situation."

Beverly Hills Conference and Visitors Bureau Chief Executive Officer Julie Wagner said the hotels are in a position of very little to no cash flow and are asking the council to review a request to defer TOT payment again.

"Unfortunately, the hospitality and restaurant industry have been hit particularly hard by this pandemic so if anything the council would be willing to do with regard to this matter is greatly appreciated," Wagner said.

The council unanimously supported extending TOT revenue payments.

Beverly Hills Marketing and Economic Sustainability Manager Laura Biery said hotels must opt in to the deferral payment program.

"As in the last two times that we offered deferrals, not all of the hotels chose to participate," Biery said. "But those that did choose to participate entered into individual agreements with the City of Beverly Hills to create a payment plan that worked for them."

According to Beverly Hills Finance Director Jeff Muir, the TOT deferral will have a minor impact on the current fiscal year which will be corrected in the subsequent year.

"There's just some accounting in the background for a few of those months as we get the repayments, that would actually be recognized in the following fiscal year," Muir said."But in totality, we would expect to recover what the city is due."

Councilmember Julian Gold said the city has to do what it can to help.

"The irony of this is because of the fact that the hotels have such a high vacancy rate, the actual dollar amount and impact to the city is diminished," Gold said. "Obviously at full capacity, if we were to defer it it would have a much bigger impact."

Councilmember Lili Bosse said that during a CVB/Marketing Liaison Committee meeting, they unanimously agreed that the tourism market has been among the hardest hit of any industry. Bosse is on the liaison committee with Mayor Les Friedman

"We're a partner with these hotels and they've been a tremendous asset to us with TOT funding in the years past," Bosse said. "This year things are really challenging, we need to be a partner with them as well."

Javor and Greer End Terms as Commission Chairs

The Recreation and Parks Commission and the Public Works Commission both honored their outgoing chairs earlier this month.

Outgoing Recreation and Parks Chair Julian Javor will end his term as chair in 2021. He first joined the commission in 2017 and will continue to serve as a commissioner for three more years.

Commissioner Amie Nebenzahl Sherry said Javor took the reins in a difficult year.

"I'm just always so impressed with your ease that you come to the table [with], your confidence at your age and your commitment to this city to really see the future form of what we can and will be," Sherry said.

Incoming Recreation and Parks Chair Susan Mishler said Javor did a great job. "Your total commitment to the mis-

> sion of this commission is greatly appre-ciated," Mishler said. Javor

thanked the Community Services department staff and his fellow commissioners for the expe-

rience he had this year. ۴I just

couldn't ask for a better commission to be a part of. It feels great to be here and do this," Javor "Thank said. you guys for the experience and I look forward to continuing to serve."

Outgoing Public Works Chair Joshua Greer will also end his term as chair in 2021. He first joined the commission in 2017 and will continue to serve as a commissioner for three more years.

Sale of Tobacco Products **Prohibited in Beverly Hills Beginning This Friday**, **January 1**

The sale of most tobacco products in the City of Beverly Hills will be prohibited beginning this Friday, January 1.

The Beverly Hills City Council unanimously approved in June 2019 an ordinance to prohibit the sale of tobacco products in the city and were the first council to do so in the nation. The decision followed public input and recommendations from the city's Health and Safety Commission.

"This week begins an important new chapter in our ongoing effort to promote and protect public health," said Mayor Les Friedman. "It was over 30 years ago that Beverly Hills became the first city in California to prohibit smoking inside restaurants. Since then, we have continued to implement policies that will ultimately save lives."

The key provisions of the ordinance include:

• Effective January 1, 2021, hotels, existing and future, may only sell to guests;

• Effective January 1, 2021, all other businesses shall stop selling tobacco products:

• An exemption/carve out for existing cigar lounges;

• A limited temporary hardship exemption provision for retailers that demonstrate the ban would cause undue hardship; and

· City Council review of the impacts in three years.

Restricting the sale of tobacco products, which includes smokeless tobacco and e-cigarettes, differs from restricting smoking activity in the city. For more information, including resources on smoking cessation programs, please visit www. beverlyhills.org/smoking.

The proposed project does not comply with the existing zoning on the site (C-3 Commercial) and therefore, the project would require approval of a Zoning Amendment, Zone Text Amendment, Planned Development, and General Plan Amendment.

This project has been assessed in accordance with the authority and criteria contained in the California Environmental Quality Act (CEQA, Public Resources Code Sections 21000 et seq.), the State CEQA Guidelines (California Code of Regulations, Title 14, Sections 15000 et seq.), and the environmental regulations of the City. Section 15270 of Title 14 states that CEQA does not apply to projects which a public agency rejects or disapproves. At this time, staff is recommending that the proposed project be denied, in which case, pursuant to Section 15270, CEQA would not apply.
