City Prepares for Major Budget Deficits in Upcoming Year

The City of Beverly Hills may face a \$10.9 million budget deficit in the upcoming year, according to a City Council meeting Tuesday.

Beverly Hills has faced a number of financial challenges throughout the pandemic, including a significant loss in sales tax and transient occupancy revenue. City staff had previously predicted the city would face a \$3.75 million deficit in 2021, but this was increased by \$6.2 million after the city added additional General Fund appropriations. It was later increased by another \$0.9 million.

According to the council's agenda report, city staff expect the deficit to decrease once the COVID-19 vaccine is more widely distributed.

Last year's audit report revealed the city had a \$2.3 million deficit. According to the council's agenda report, the government does not recognize deferred revenue that was earned but not collected within 60 days of the end of the year. Therefore it didn't recognize approximately \$3 million in transient occupancy revenue, which will now be counted toward the 2020-2021 fiscal year.

Protesters Demonstrate Against Presidential Election Results

The Beverly Hills Police Department

dispersed a protest against the U.S. presidential election results last Wednesday, after a fight broke out between demonstrators.

The Beverly Hills protest was on the same day as far-right protesters rioted in Washington D.C. and broke into the United States Capitol Building. According to BHPD Public Information Officer Lt. Max Subin, there were approximately 150 protesters in Beverly Hills.

Interim Police Chief Dominick Rivetti said in a video that due to the violent protests in Washington D.C., the BHPD brought in extra resources for the scheduled demonstration.

"That demonstration started at 3 p.m. and was peaceful for most of the afternoon," Rivetti said. "However, around 5:30 p.m. there was a fight that broke out amongst the demonstrations which caused us to declare an unlawful assembly and disperse the crowd."

Subin said one assault took place but no arrests were made.

"The victim is desirous of prosecution, but the suspects were not identified," Subin said

He added that private armed security hired by the city assisted the BHPD, while mutual aid from the LA County's Sheriff's Department was on standby.

Board Unclear on Who Will Join Facilities Subcommittee

The BHUSD Board of Education debated over which two board members would be on the district's facilities subcommittee Tuesday.

The facilities subcommittee discusses the district's facilities planning and construction projects in weekly meetings led by the district's project manager Don Blake. Board Vice President Tristen Walker-Shuman and Board member Noah Margo currently represent the board on the subcommittee.

During the board's organizational meeting, however, both Board President Rachelle Marcus and newly-elected Board member Mary Wells expressed interest in joining the subcommittee. But only two board members may attend the meetings due to the Brown Act.

Blake said in a letter to Marcus that he required weekly meetings with two board members, the superintendent and the Chief Business Officer when he was hired by the district.

"It has come to my attention that the board is considering rotating members on the facilities subcommittee," Blake wrote. "Nothing has changed with regard to who and when members are assigned. These decisions are mine. I will not be changing the current members at this time."

The board typically has its members choose which of the district's committees they would like to join. Vendors to the district, such as Blake, have not normally selected which board members they would like on a subcommittee.

Marcus said that excluding the Board president from attending the subcommittee meetings is not normal procedure.

"I feel like I'm being excluded and I personally feel that as president, I should have that opportunity now to sit on the

committee as a representative of the school board," Marcus said.

She said Blake's requirement was only for two board members.

"It did not specify exactly who those two [board] members would be and any longevity or term of office," Marcus said.

It was not immediately clear if the district considers the facilities subcommittee a board committee. It was also not clear why it is significant to be a board committee when selecting which board members can attend its meetings.

The subcommittee was listed as a board liaison on the board's December 15 organizational meeting agenda, along with other committees such as the Finance Committee and the Citizens Bond Oversight Committee. But Superintendent Michael Bregy said the subcommittee has never been a board committee and Blake wrote in his letter that it is not a board or staff meeting.

Wells said that she has the sense that board members have not felt fully informed about the facilities committee meetings.

"There is a gap of information, I think even [Blake] said that not all of that information can be communicated when [he does his] updates to the board," Wells said. "So there is something that gets lost there that would be captured by attending that meeting even if you're not participating in it or making decisions in it."

No decision was made on which board members would be on the subcommittee. Blake said he would take Marcus' input under advisement.

BHUSD Board of Education Anticipates the Year Ahead

The BHUSD Board of Education faced a number of unexpected challenges in 2020. But like most of the population, it's hoping that the year ahead will be more promising.

According to Board President Rachelle Marcus, the board has set a number of goals to accomplish in the upcoming academic year.

"In 2021, the Board of Education is looking forward to moving from distance learning to in-person instruction," Marcus said. "However, the health and safety of students, staff and community at large will remain our first priority."

The BHUSD and the Beverly Hills Ed-

ucation Association, which is the union that represents BHUSD faculty and staff, approved a plan in December to slowly transition students back to in-person instruction. The plan is contingent

on Los Angeles County's COVID-19 cases reducing and will reintegrate students by grade-levels.

A date for when students will return to campus has not yet been determined, but is anticipated take place in the next couple of months

In addition to returning to in-person instruction, Marcus said the district must implement its Strategic Plan and pair it with the impact that the pandemic has had on it.

"For students this may be gaps in academic learning, and for others it could be the social emotional learning or both," Marcus said.

Beverly Hills Fire Chief Receives Fred C. Cunningham Award

Beverly Hills Fire Chief Greg Barton received Tuesday the Fred C. Cunningham Award for Distinguished Service, the city's highest recognition for outstanding service to the community.

The award is named after the city's longtime Executive Director of Public Affairs Fred C. Cunningham. It recognizes an employee who has a vocation for serving the community.

"The City Council is so pleased to recognize Chief Barton for his remarkable contributions to our community," said Mayor Lester Friedman. "During his 25 year career with our city, Greg has been on the front lines working to save lives, property and keep our city safe. On behalf of the Beverly Hills community, we thank him for his dedicated service and the example he sets for all of us."

A committee, consisting of the City Manager, two sitting councilmembers, a former councilmember, the president of the Municipal League, President of the Rotary Club and president of the Chamber of Commerce unanimously selected Barton for the award.

Leading up to his appointment as chief in 2017, Barton served as Deputy Fire Chief, Shift Battalion Chief, Fire Marshal, Deputy Fire Marshal, Fire Captain, Fire Inspector and Firefighter.

Barton currently serves as a member of the Board of Directors for the Maple Counseling Center, Executive Team Member on the Beverly Hills 9/11 Memorial Committee, Director of the Beverly Hills Fire Chief Funds and Governance Board Representative for the City of Beverly Hills on the Interagency Communications Interoperability System.

He has completed many education programs, such as the Naval Postgraduate School Center for Homeland Defense and Security-Executive Leaders Program, the Los Angeles Fire Department Leadership Academy and the International Association of Fire Chiefs – Fire Service Executive Development Institute.

Barton has also led the city's newest program, "Just in Case, BH," which was created to keep the community informed and well connected during natural disasters or local emergencies.

"I am truly honored and humbled to receive the Fred Cunningham Award," Barton said. "If you do something you like to do, you'll never work a day in your life. That is so true, I have a dream job as a firefighter and on top of that, I work for the dream community of Beverly Hills."

According to Marcus, the first year of the Strategic Plan focuses on mathematics.

"In an effort to achieve this, we accelerated our professional development in order to help teachers with instruction using different strategies," she said. "Teachers have been given new technology to use and hopefully will continue to use these tools to engage students in new and creative classroom instruction going forward."

She added that the district is looking forward to teachers implementing two of the Strategic Plan's core values – agility and collaboration.

"These values have been at the forefront since the onset of the pandemic and should continue to be," Marcus said.

The BHUSD will also continue daily assessments and benchmarks, according to Marcus.

"The Educational Services Department [will] continue working with the school sites and provide additional tutoring ser-

vices to children who have been affected by the pandemic," Marcus said. "Additional tutoring will be available through AirTutors which can support students in real time."

AirTutors is an online virtual tutoring service, which students can use to schedule tutoring sessions.

Marcus said that the district will also work with the Beverly Hills Education Foundation to create more opportunities for students that are struggling with their classes. She said that when state assessments are administered at the end of the school year, the district must study them closely to address and evaluate how students progressed during the past year.

"The Board of Education, with its dedicated teachers and administration, will continue to provide a world class education," she said.

Council Considers Appeal of Planning Commission's Decision on Lot Line Adjustment

The City Council debated Tuesday ap-

proving an appeal of the Planning Commission's decision to deny a lot line adjustment for a Beverly Hills home.

The homeowners submitted a lot line adjustment request in August for a property on both Hillcrest Road and West Sierra Mar Drive. If approved, it would have created two lots out of the three lots that currently exist at the site.

A portion of the property is in Beverly Hills, while the other is in Los Angeles.

Planning Commissioners adopted a resolution to deny the lot line adjustment request in October. According to the council's agenda report, the commission could not find that the lot line adjustment would comply with the city's General Plan.

Benjamin Reznik, who represents the applicant, later filed an appeal of the commission's decision that same month. The appeal makes a number of arguments, including that the commission did not consider the information in the staff report regarding the Subdivision Map Act and municipal code and that the City of Los Angeles had already approved the lot line adjustment.

After several hours of debate, the council ultimately decided to continue discussing the appeal in a future meeting.

Beverly Hills Settles Another Spagnoli Lawsuit

The City of Beverly Hills settled in December another lawsuit alleging former Beverly Hills Police Chief Sandra Spagnoli discriminated against her employees.

Spagnoli retired from the Beverly Hills Police Department last April. Her tenure as Beverly Hills' police chief involved a string of lawsuits, ranging from allegations of sexual harassment to racial discrimination. The City of Beverly Hills has paid approximately \$8 million in settlement and legal fees related to Spagnoli's alleged misconduct.

The city's latest settlement involved three Black traffic control officers, who claim the former chief had demoted them from parking enforcement supervisors and denied them work opportunities and benefits based on their race. They also allege Spagnoli and other BHPD employees continually made racist remarks at work.

Bradley Gage, an attorney who has represented several BHPD employees in their lawsuits against the city, said he used deposition testimony from other lawsuits that Caucasian employees accused of making racist comments were promoted by Spagnoli.

"This was part of the whole pattern of practice of discriminating against African Americans," Gage said. "Basically it was an attempt by Spagnoli to make "Beverly Hills Great Again," to coin a phrase."

Another lawsuit against Spagnoli is still ongoing. Sergeant Scott Dibble filed a lawsuit last July that alleges Spagnoli wrongfully placed him on work leave in retaliation to a previous lawsuit he had settled in 2019.

His settled lawsuit claimed Spagnoli had sent him sexually inappropriate text messages and denied him a promotion for not reciprocating her advances. According to Gage, a trial is scheduled for May.

Gage said these lawsuits help provide officers protection from prejudice, discrimination and harassment.



Louis Vuitton Plans Pop-up Store on Rodeo Drive

Luxury retailer Louis Vuitton plans to open a pop-up store on North Rodeo Drive from approximately February to March.

The City Council approved a special event permit for the store Tuesday, which waives the city's sign ordinance and expedited special event and building permits for Louis Vuitton. The store will be responsible for all costs associated with its pop-up.

According to the city's staff report, the store will be titled "Rodeo Drive Men's Pop-up" and include exterior art designs.

sential workers like teachers.

Planning Commission Will Consider Extended Hours Permit for New Restaurant

The Planning Commission will consider approving Thursday an extended hours permit for a proposed new restaurant called Nusr-Et Steakhouse.

The restaurant, located at 184 North Canon Drive, requested the permit to operate between 11 a.m.

and 2 a.m. Monday through Saturday and 7 a.m. to 2 a.m. on Sundays. It will have both indoor and outdoor dining.



According to the commission's agenda report, the city's municipal code requires the restaurant to have an extended hours permit because it is located in a commercial-residential transition area. The permit will allow it to receive patrons after 10 p.m. everyday and before 9 a.m. on weekends.

Planning Commission Will Consider Permits for North Beverly Drive Commercial Building

The Planning Commission will consider approving a request for a Planned De-



velopment amendment and an Open Air Dining Permit for a North Beverly Drive commercial building Thursday.

According to the commission's agenda report, the Planned Development amendment would allow the restaurant in the building to increase its area in excess of 6%. The Open Air Dining Permit is for the establishment of a Sweetgreen restaurant on the ground floor of the building. It would allow Sweetgreen to have around 161 square feet of open air dining.

The property is located at 245 North Beverly Drive.

Will Beverly Hills Install an Emergency Siren System?

The City of Beverly Hills may install

an emergency siren system, but the City Council once again continued a discussion about it to a future meeting.

Councilmembers had previously decided that an outdoor warning siren system would ensure Beverly Hills residents are properly notified of emergency notifications. Mission Critical Partners is developing a preliminary plan for the sirens.

According to the council's agenda report, the sirens would be placed strategically to ensure that most people can hear them. It is not known yet if they can be heard indoors.

The construction costs for the project are still unclear. According to the agenda report, they can range anywhere from \$500,000 to \$1.5 million. The funds would be taken from the city's General Fund.

Since the "I Love My Librarian Award" was established, only 120 librarians nationally have received it. Braun, a congenital amputee, will be the first significantly physically handicapped recipient of the award.

Braun has offered access to digital programs and materials, and organized safe circulation of library resources to students

school is a key moment for most kids, when their sophistication reaches the point where they can begin to make reliable independent judgments about sources, and cultivate foundational information literacy skills that will serve them for the rest of their lives," Braun said. "Without developing these skills, kids can be left rudderless in a growing sea of misinformation and disinformation."

Actor/Singer from "Sinatra: RAW" at the Wallis

Richard Shelton is performing the play "Sinatra:RAW" at the Wallis on January 16 at 8 p.m. The performance will be part of the Wallis' virtual Sorting Room Sessions, which feature live performances on demand.

You're performing at the Wallis this Saturday. Tell us about that.

It's a play called "Sinatra:RAW." It's an intimate look that goes deep behind the blue eyes of the icon, to a stage in his life where he's feeling somewhat redundant. It's the 1970's and the music scene is dominated by the Beatles, David Bowie and rock and roll – which he hates. He's at a point in his life where he's not

married [and] where the world is moving on.

We think of our icons as people who are somewhat untouchable. That their problems aren't the same as ours. But they're not, they're the same. We all face [those] eternal questions; What am I here for? What's my purpose? Where do I fit in? What happens to me when I get old? In other words, just because you're an icon doesn't mean to say

that you might not experience a midlife crisis. So [the play] goes behind the eye of somebody like that in a very intimate setting.

"[Sinatra] brought

a lot of magic and

stardom to Beverly

Hills"

[Sinatra] wants to acknowledge his legacy. This [was] a magnificent life, but [it was] a life that's had its own struggle. The hourglass of the brief moment in Palm Springs – [the play is] set in Palm Springs. It's a partially selected white-board that we imagined with Cary Grant, Sophia Loren and Gina Lollobrigida, who [were] there to share this intimate moment before his retirement concert. [It was] coming up on the 13th of June in Los Angeles.


[Sinatra] just wants to talk. He just wants to tell a few stories, sing some songs with the piano. What happens is that the more he remembers, the more the Jack Daniels ignites his mood and he faces the allegations. It's a confessional, if you like. What we have on stage

is quite literally a piano, a bottle of Jack Daniels and memories.

[Sinatra] addresses the things that we all know about— his beginnings [and] his broken love affair with Ava Gardner, which was a desperate unrequited love. And facts that the people don't really know too much about. His life in Hollywood, his hatred of the press, his alleged [mafia] connection and how he felt about the recording industry. That's all packed into an extremely intense hour. It is absolutely what it says on the ticket—it's raw.

You're known for performing Frank Sinatra's songs. What drew you to the late singer's work?

For my relationship, it's 100% that of an actor. I only know how to evoke him as an actor. I don't impersonate him, that's a different skill which Photo; Jason I don't really have. The journey with him started in London on the Westend stage in a play called "Rat Pack Confidential." It was an expose of the five men in the Rat Pack. It wasn't just Frank Sinatra, it was Dean Martin, Peter Lawford, Sammy Davis Jr. [and] Joey Bishop. So each of the five men's story



I found out during that play that I'm the same size and shape as Frank Sinatra. I have an uncanny resemblance with him. Also, my vocal range. But nobody can replicate Frank Sinatra – impossible. That was a voice given by the gods. But I seem to have an ability to capture the essence of [the spirit] in an acting capacity.

I'm interested in what motivates someone from the inside out. That's a very different experience than somebody who [just] sings Frank Sinatra. That's not what I do. What draws me to it is the acting muscles. It's going deep inside and trying to find out what was going on in the mind and heart of that person at that time and then portraying it.

How do you approach portraying such

an iconic figure?

It [was] in 2002, I think, the first time I [portrayed] him as an actor. We had a five week rehearsal period. There was a great amount, I think [for a week] in that period, that each of the men in [the] drama ["Rat Pack Confidential"] spent watching videos.

You have to be able to replicate physicality. That means lip movements, facial tics, gestures, the way someone walks [and] they move. That has to do with how they center themselves. There's a lot of studying in terms of physically interpreting [Sinatra]. Massive amounts of research, reading, looking at pictures and poring over news articles. Because that's the way you can start to get inside the head of somebody you're portraying.

Is it more challenging portraying a historical figure versus a fictional one?

I don't know that it's more difficult. It's different in the sense that you have a responsibility to get it right. Nonetheless, this is a dramatic interpretation. When you're talking of Helen Mirren portraying the queen, Rami Malik portraying Freddie Mercury [or] Renee Zellweger portraying Judy Garland – these are actors who portray. No one can be these people, because they've been and gone. But you can invoke.

If you invoke and tell a story honestly, then you persuade. That's my journey with him, really. I don't seek to replicate because I don't think you could ever do that. It'd be very unsatisfactory. But if you seek to breathe life into the essence of the person, then you can start to tell the story.

Sinatra lived in Beverly Hills for much of his life. As someone who's very familiar with his biography, what impact do you think he had on the city?

He brought a great deal of drama and integrity. I have a particular interest in Frank Sinatra anyway, because of my dramatic relationship with him. So when I came to LA, of course, I was interested in seeing where he lived. I looked at the house and to me, it was really mind blowing. Like, wow, that's where this icon lived.

It becomes very intimate when you see the home. I'm interested in the homes of the glamour era of Hollywood, possibly Elizabeth Taylor or John Wayne. That particular period where these homes really meant something. I'm less interested in today's staff. I'm less interested in the way that show business moves today because it's so accessible. But there was an inaccessibility in those days. When I saw it with my own eyes it sort of made this feel real. [Sinatra] brought a lot of magic and stardom to Beverly Hills.

Tell us about your past performances and singing/acting career.

I started on the stage. [Then] I was in a television program in the UK for a few years. The show was called Emmerdale. It's a long-running drama. I played a charming, psychotic doctor. I've been in movies like "My Week with Marilyn" and "I Capture the Castle." [I also did] singing performances, including for Windsor Castle for Prince Charles, Elton John, Philharmonic Orchestra [and] jazz clubs. On television in America, I've been in "Jane the Virgin" and "House of Lies."

I am not confined to only Frank Sinatra in an acting role. I have a much more versatile career than that. But music is central to me. I'm just putting out an album which we recorded at Capitol Records. [I launch the record] February 14.

The pandemic has obviously prevented performers such as yourself from being on stage in front of an audience. Can you talk about that and how the industry has had to adapt?

You got to find new ways of performing the shows. Like [for] "Sinatra: RAW" I've done at the Wallis and the Christmas shows, you perform following COVID protocols in front of any empty theater. So you're not performing for an audience and you have to change the way you perform.

You have to think about the people watching you. For example, you can't pause for applause, you can't pause for people who may shout out something, you can't gauge the mood of the room. In a live performance, that's what it's all about. It's all about reading the room.

That's an intuitive thing that comes from years and years of live performance. In this new reality, you have to think beyond that. You have to think through the screen. You're competing with, I don't know, a dog barking or somebody talking in a world that you can't see. That's a new skill.

Which Sinatra song do you enjoy performing the most and why?

It's a very simple song, it's called "In the Wee Small Hours of the Morning." It's so beautiful, so simple and he does it so magnificently. It's a lullaby and by saying so little it says so much. His interpretation does that.

The other song I particularly like is, "That's Life." Sinatra was a champion for the high's and the low's. He was a man who sometimes was ahead and sometimes he was behind. That's how it is for all of us and I think that's how it should be because then it's a life worth living. If you just take the steady road all the time, you're not going to experience the true light and shade of life.



Recreation and Parks Commission Chair Susan Mishler on Grassroots Politics and What Makes Beverly Hills Unique

By Ani Gasparyan

You first moved to Beverly Hills in 1973. Tell us about that.

I moved in [1973 from New York] with my husband Arthur and two daughters Ruth and Sharon. Somebody in the brokerage business found him and asked him to consider moving out to [Los Angeles]. Arthur was a broker and we came out here.

I had never been West of the Mississippi and I came out here to sparkling lawns and palm trees and sun. It was distinctly different than living on the East Coast.

What was Beverly Hills like at that time?

It was always a beautiful residential community with a lot of civic pride and good schools. A lot less traffic and development. It was small - actually we had a five and dime [and] area of the city. The parks were great.

It was always a lovely community a lot of civic pride in most of the residents along with a lot of Hollywood influence. [It was] not unusual to see stars on the street - they were very humble. They

had a lot of humility just like the rest of

I've lived here for 47 years. It was different. It was not unusual to go watch Fred Astaire on the street or Doris Day go into one of the stores like Nate 'n Al's. Hollywood had a big influence on the town and today of course. Now [the city has become an international destination.

Shortly after moving here, you got involved in the Industrial Area debate. What happened?

In the late seventies, a developer wanted to swap land in the Industrial Area

> with the city in order to accrue a contiguous square block so he could build condominiums around the Foothill area. At the time, I was a member of the League of Women Voters and we thought it a bad idea to swap land with a developer and for our city's future.

> The City Council didn't agree with us so we stood in front of stores and schools, knocked on doors getting signatures and took it to the residents as a ballot measure people like Sooky Goldman, Betty Harris and other civic-minded people, we had a petition drive [titled], "Do Want to Swap Civic Land with a Developer?" However, the developer ended up suing Betty, two other residents and numer-

ous Jane and John Doe's.

I got a group of residents together in my living room and we created Citizens for Constitutional Rights in order to support our neighbors who were sued and keep the residents informed. I rounded up attorney residents to go on the letter-

It worked for a while but Betty had to hire a constitutional attorney and fought the litigation all the way up to the [California] Supreme Court where she was

head so we could keep all the residents

found not guilty of any charges years later. That was a proud moment for her, the residents and for our city. We have our Industrial Area decades later.

What made you serve on the Recreation and Parks Commission?

I applied for a seat on the Recreation and Parks Commission because I recognized that I had a lot of institutional knowledge and found parks to humanize our city by what we have done there and do in there over the course of time.

Many of the city's projects have been put on hold due to the pandemic, including the La Cienega Park rehabilitation which was slated to cost over \$100 million. How do you feel about that?

I feel that we don't have much of a choice. What was before the commission was the renovation of La Cienega Park. We did a lot of outreach to the community and people outside of the city adjacent. We had lots of meetings at Roxbury Park to gain input on what people wanted – from the rooftop swimming pool to a wonderful new building on La Cienega. It's no surprise that now fiscally it's impossible to aspire to those same goals.

We intend to put the renovation of La Cienega Park on hold for fiscal reasons and lifestyle changes in our future. Our parks are important to all of us but they may serve different needs.

We may not want a pool on top of a six or seven story building but expand in other ways as we had sketched out in our previous plans. It's hard to be articulate about the unknown.

I think we'll make a readjustment and perhaps focus on signage in the city. I'm a big fan of good signage and we started to do that in the mini-parks when I became a member of the commission. We may refocus on [Beverly Gardens Park]. When I got on the commission, we focused on the mini-parks and improving signage for tourists and for the residents.

What are your goals as chair?

[My] goal is to improve the signage at the parks. Basically, the focus is going to have to be smaller. So maybe we'll look at signage in the Beverly Gardens and be able to pitch [other projects]. [The Arts & Culture Commission] sent out a beautiful [art walk brochure] for tourists

and that's a great thing. Why? Because if you're staying at a hotel and you come here, they created a description of the art. That's really good because they can have something on a hotel desk. I think that's a really great thing, because a lot of cities don't have it. Actually, LA is park-short. So for a [city] our size, we're doing pretty well.

I feel that small mini-parks are lovely and for a town our size we take pride in our parks - passive and active. Because Roxbury is essentially a passive park where people go to every weekend from all over the city and our town.

Tell us about your family.

My husband [Arthur] is still working. I have two daughters. Our first daughter Ruth passed away eight years ago. Our other daughter Sharon [Mishler Moskovitz] lives in Vancouver with her husband Rabbi Dan Moskovitz and their three children Judah, Levi and Estee.

Sharon came [to Beverly Hills] in kindergarten, so she went to Beverly Vista and the high school. It's sad because the border is closed and we haven't seen each other in over a year. But the kids are in school and we're thrilled about that. Everything in Canada is done by the province, in this case it's British Columbia. I'm thrilled to say that the schools in Vancouver reopened the schools about three months ago. [The students are] masked and eight feet apart.

What advice would you give to young parents who want to get involved in the Beverly Hills community?

I happen to personally admire any and all community involvement no matter where you live, especially in Beverly Hills because we have local government at its best. A five-person city council and the ability to get on commissions and really make a difference. I'm a deep believer in grassroots politics and [that] one person can make a difference by their own personal experience in life.

They didn't ask me whether I'm a doctor or a lawyer. I happen to be a retired registered nurse. That doesn't mean I should go on [the] Health and Safety [Commission], though it could be a fit. In other words, you don't have to be a nurse and be on the Health and Safety Commission nor do you have to be a planner to be on the Planning Commission.

I'm a proud proponent of grassroots activities and I became a commissioner because it was a natural fit. Not that I want to make a big difference but I bring a certain amount of experience to the table having lived here for a long time.






