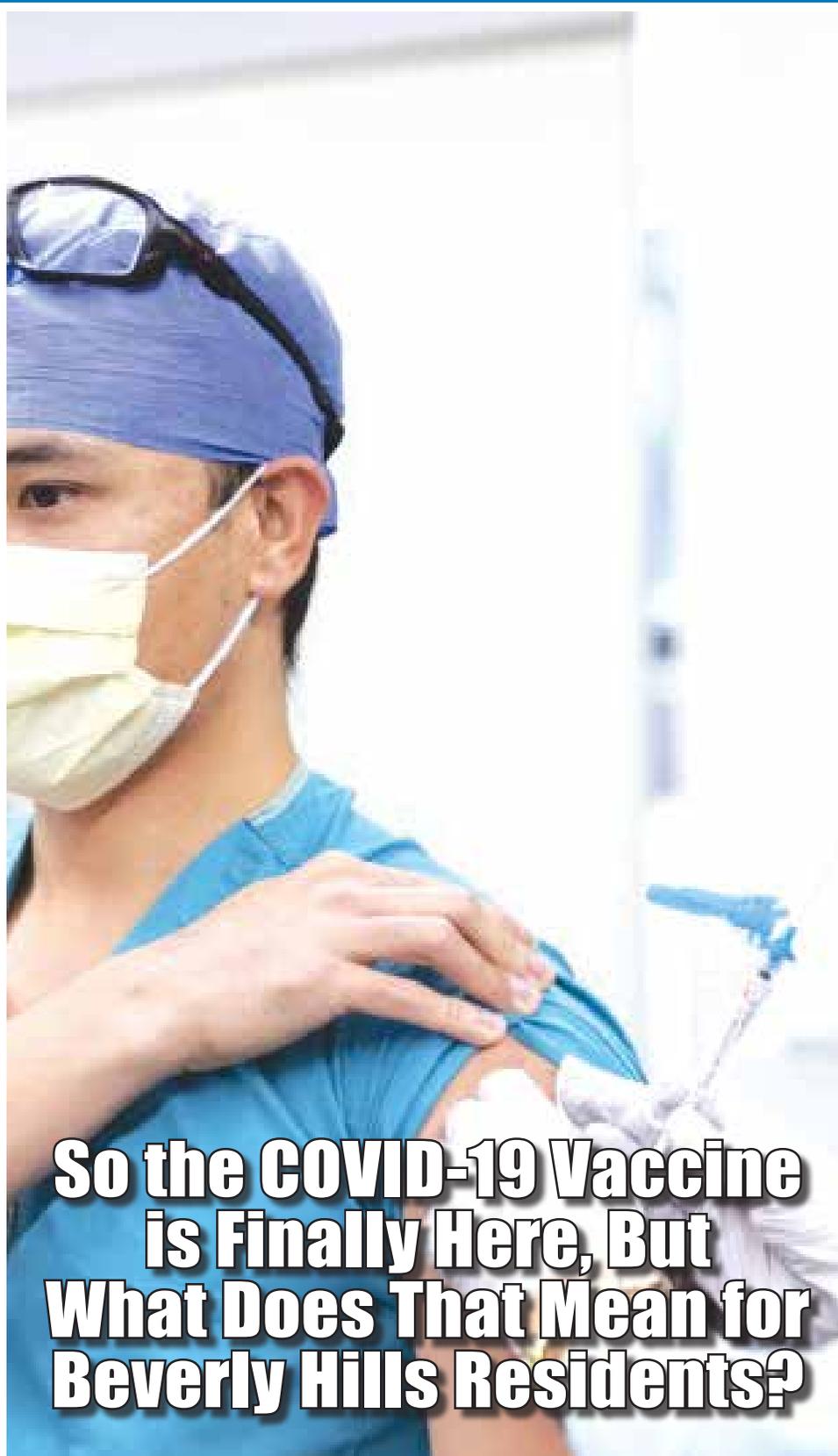

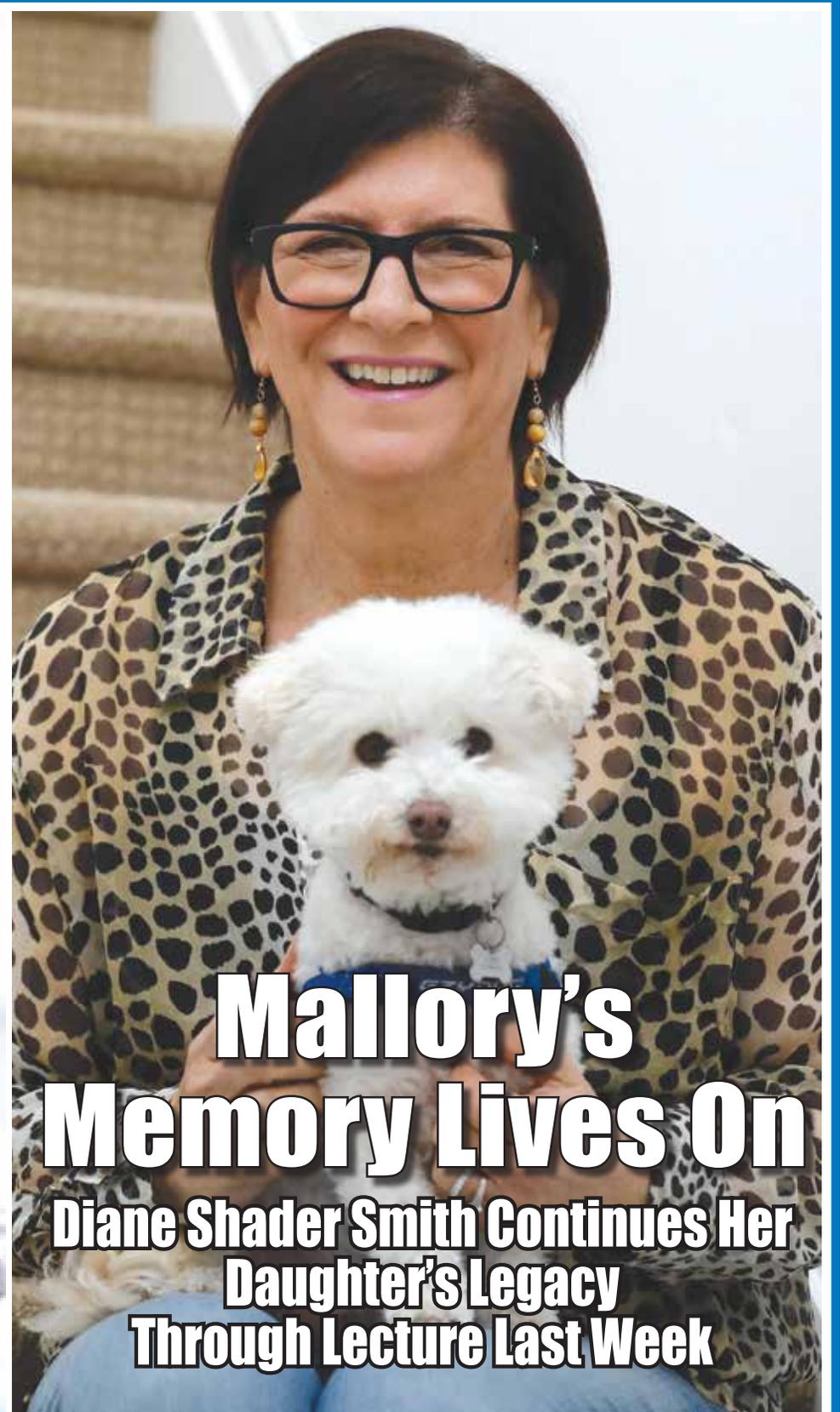

Three Beverly Hills Freedom Rally Participants Arrested for Capitol Riot

The FBI has arrested three people from Beverly Hills for participating in the United States Capitol Riot earlier this month.

Gina Bisignano, who owns Gina's Eyelashes and Skincare on North Camden Drive, was arrested Tuesday morning

from her Beverly Hills apartment. Several videos of her attending the riot have circulated online, in which she can be heard encouraging attackers.

The FBI also arrested Simone Gold and John Strand Monday. Gold was among several physicians who alleged hydroxychloroquine can cure the coronavirus last year, despite no scientific evidence supporting the claim. She has also been critical of the COVID-19 vaccine.

Bisignano was charged with civil disorder, destruction of government property, aiding and abetting, obstruction of an official proceeding and violent entry. According to the Los Angeles Times, her preliminary hearing is scheduled for February 4.

Federal prosecutors charged Gold and Strand with entering a restricted building, violent entry and disorderly conduct. Gold is scheduled for a virtual hearing Thursday. According to the LA Times, no court date has been scheduled for Strand.

Bisignano, Strand and Gold have all attended the Beverly Hills Freedom Rally, which is a weekly protest that criticizes the State of California's COVID-19 health and safety guidelines and expresses support for former President Donald Trump.

Bregy Provides Updates on Reopening Schools, Vaccinating Teachers

FBI Spokesperson Laura Eimiller said the arrests occurred without any incidents and the FBI was assisted by the Beverly Hills Police Department.

BHUSD schools likely won't be reopening for in-person instruction anytime soon, as COVID-19 cases continue to rise to unprecedented levels in Los Angeles County. Still, the district is preparing to follow the state's latest mandates and eventually have teachers vaccinated, according to Superintendent Michael Bregy

last Tuesday.

The LA County Public Health Department reported that the county has 1,031,874 COVID-19 cases as of Monday. While the department awarded the BHUSD a transitional kindergarten to second grade waiver in December, it is now recommending that schools remain closed through January.

The district's contract with the Beverly Hills Education Association, which is the union representing BHUSD faculty and staff, also states that TK to second graders cannot return to campus until the county's daily COVID-19 case rates are between 7 and 10.

"The cases are still expected to go up, just when you think they're not going to go up any higher," Bregy said. "We're really in a very severe situation."

Bregy said the district will continue distance learning to provide continuity to students.

"Some school districts are experiencing these surges, but then some are opening and then some are closing within the next week or two," he said. "Which they're finding to be very devastating for the social, emotional perspective for [their] students."

He added that most schools in LA County, even those that reopened with a waiver, have stopped in-person instruction.

Bregy said the district is awaiting more information on Gov. Gavin Newsom's latest proposal for reopening schools. The legislature has not approved the proposal as of press time, but it includes a plan for reopening schools for kindergarten through sixth grade and weekly testing requirements for staff and students.

It also includes a new adjusted COVID-19 daily case rate of 28 per county, for when TK to second graders can return to campus. If approved, the case rate to reopen schools would be four times higher than the current requirement.

Bregy said if a case rate is that high, the district would have a higher number of COVID-19 cases to manage and have to potentially close its schools.

"I know people want to go back – we want students to go back," Bregy said. "If we do it too early, we're going to have to shut down our schools very quickly [after] they arrive."

The State of California has begun to vaccinate residents in accordance with its vaccination distribution plan. According to Bregy's presentation, the state expects to vaccinate teachers in early February.

"We've extended invitations to people in the state to be able to provide those vaccinations for our staff and perhaps our community when it's time," Bregy said. "We want to be part of the solution and we want to be able to provide vaccines for our staff as soon as we can. We certainly have the facilities and space to do that."

7-11 Committee to Meet with Board About Surplus Property

The 7-11 Committee will meet with the BHUSD Board of Education on January 26 in order to get direction on the district's surplus property.

The meeting will be during the board's closed session, meaning it cannot be viewed by the public. The committee will likely ask for direction on considering Hawthorne School surplus property and potentially relocating the district offices.

Committee members met last Thursday to discuss a memo Committee Chair Peter Ostroff planned to send to the board explaining what it plans to discuss in the upcoming meeting.

Committee member Ronit Stone suggested the committee speak with City Manager George Chavez to see if the city would like to be involved with the project.

"It might be interesting to hear from the city's perspective, in terms of what kind of

hurdles we might face and whether there could be any interest from the city in some kind of joint venture arrangement," Stone said. "Because it seems to me the city could also benefit from this kind of project."

Ostroff said he has discussed it with Chavez and there appears to be some interest.

"There are some possibilities [but] at present they're just possibilities," Ostroff said.

The next 7-11 Committee is scheduled for February 10.

Salt Bae Will Serve Luxury Steaks in Beverly Hills Late Into the Night

Internet celebrity Salt Bae will be sprinkling salt onto \$1,000 gold-leaf steaks late into the night, once his Beverly Hills restaurant opens on North Canon Drive.

Nusret Gökçe, better known as Salt Bae, went viral through a series of videos showcasing his flamboyant way of sprinkling salt and cutting meat. But aside from being a meme, the Turkish chef owns a chain of luxury steakhouses called Nusr-

Notice Requiring Registration of Rental Units

Amendments to the Rent Stabilization Ordinance, adopted by the Beverly Hills City Council in January 2017, require housing providers to register non-exempt rental units with the City of Beverly Hills. Some information, like ownership details and number of units, is required from all registrants.

In most cases, information like current rent amount, is also required.

Notices were sent to housing providers on
JANUARY 19, 2021.

Housing providers must register within
35 days of that mail date (February 23).

3. Returning users must confirm or update prefilled information. New users must enter property and apartment unit information.

PROJECT: Beverly Hills Creative Offices Specific Plan Project

The City of Beverly Hills is preparing a Draft Environmental Impact Report (Draft EIR) for the Beverly Hills Creative Offices Specific Plan (herein referred to as "Project") proposed by the Beverly Hills Land Company (herein referred to as "Applicant"). The public is invited to attend a preliminary "scoping meeting" on

Thursday, February 4, 2021 at 6:30 p.m. to comment on environmental issues that should be addressed in the Draft EIR. Due to the on-going public health issues associated with holding in-person gatherings during the Covid-19 pandemic, the scoping meeting will be held virtually. Access to the meeting is available through: (i) the video conferencing link, and (ii) the phone access information identified at the top of this notice.



Project Location: The 2.49-acre (108,216 square-foot [SF]) Project Site is located in the City of Beverly Hills. The Project Site consists of: a 2.11-acre (92,037 SF) private property formerly occupied by railroad right-of-way (commonly known as "Parcel 12" and currently addressed 9220 North Santa Monica Boulevard) and bound by Santa Monica Boulevard to the northwest, Beverly Boulevard to the northeast and Civic Center Drive to the southeast and southwest; and approximately 0.37-acres (16,279 SF) of Civic Center Drive public right-of-way that the Applicant has requested the City vacate and incorporate into the Project Site. The Project Site also includes a 34,756 SF subsurface merger area located 4-feet underneath Civic Center Drive and extending 25 feet from the existing southern property line of the 9220 North Santa Monica Boulevard parcel. The 9220 North Santa Monica Boulevard parcel consists of Assessor Parcel Number (APN) 4342-015-038 and the western portion of APN 4342-015-040. The Project Site is regionally accessible from Interstate 405 (the San Diego Freeway) and North Santa Monica Boulevard. The private property portion of the Project Site is currently undeveloped and the public right-of-way portion of the Project site is the current location of public on-street parking.

Project Description: The Project is a proposal to construct up to 11 new creative office buildings oriented in a linear fashion within the Project Site area, with the development governed by the proposed Beverly Hills Creative Offices Specific Plan. The buildings are proposed to be spaced between 25 to 30 feet apart with on-site landscaping between and surrounding the buildings. The proposed office buildings would range between approximately 8,500 SF and 21,700 SF in floor area and 3 to 4 stories in height (a maximum of 52 to 60 feet tall per the height standards of the proposed Specific Plan). The proposed 4-story structures would be designed with a stepped back partial 4th-story surrounded by outdoor terrace areas. The proposed Project totals approximately 114,202 SF of new floor area. The proposed floor area ratio (FAR) of the Project is 1.24 to 1 when calculated before the Applicant requested merger of existing public right-of-way with Parcel 12 and 1.07 to 1 when calculated based on the post-merger size of the Project Site.

A two-level subterranean parking structure containing 490 parking spaces is proposed. The subterranean parking structure is proposed to extend up to 25-feet south under the Civic Center Drive public right-of-way from the current southern property line of Parcel 12. This subterranean parking structure is proposed to be accessible from four access ramps located in areas that are currently part of the Civic Center Drive right-of-way, which the Applicant is proposing be vacated by the City and merged with the Project Site. The Project would result in the removal of 74 on-street public parking spaces on Civic Center Drive. The Applicant is proposing to replace the spaces with 74 valet operated public

parking stalls located within the subterranean parking structure. A total of 84 public on-street parking spaces would remain on the north site of Civic Center Drive adjacent to the Project Site. One full-time at-grade loading zone adjacent to Civic Center Drive is proposed near the center of the Project Site. Two part-time loading zones (available from 7 AM to 9 AM) located within the City right-of-way are proposed at each end of the Civic Center Drive Project frontage.

The Applicant also owns two vacant properties located east of the Project Site, commonly known as "Parcel 13" (approximately 2.25-acres in size) and "the Triangle" (approximately 0.3-acres in size). These parcels are also former railroad right-of-way and are adjacent to North Santa Monica Boulevard, running from Beverly Boulevard to the eastern boundary of the City of Beverly Hills. As part of the Project, the Applicant is proposing to transfer ownership of Parcel 13 and the Triangle to the City as a public benefit contribution.

Project Construction is anticipated to commence in 2022 and be completed in 2024.

Initial Study: Based on the conclusions of the Initial Study prepared for the Beverly Hills Creative Offices Specific Plan Project, the following areas of potentially significant environmental impact are anticipated to require analysis in the Draft EIR:

- Aesthetics
- Air Quality
- Cultural Resources
- Energy
- Geology and Soils
- Greenhouse Gas Emissions
- Hazards and Hazardous Materials
- Hydrology and Water Quality
- Land Use and Planning
- Noise
- Transportation
- Tribal Cultural Resources
- Utilities and Service Systems
- Mandatory Findings of Significance

Potential cumulative impacts and potential for growth inducement will also be addressed; and alternatives, including the No Project Alternative, will be evaluated.

Purpose of the Scoping Meeting: The purpose of the scoping meeting is to present the Beverly Hills Creative Offices Specific Plan Project in a public setting and provide an opportunity for a full airing of the environmental issues that are important to the community. The meeting will include a presentation of the proposal and a description of the environmental issues to be analyzed in the Draft EIR. Following the presentation, interested agencies, organizations, and members of the public will be encouraged to present views concerning what environmental issues should be included in the Draft EIR. The oral and written comments regarding potential environmental effects of the Project made during the scoping meeting will be addressed as appropriate in the Draft EIR.

Required 30-Day Comment Period: The City invites all interested members of the public to attend the public scoping meeting. The City also invites written comments on issues related to potential environmental impacts during a 35-day comment period, which started on **Friday, January 15, 2021** and will conclude on **Friday, February 19, 2021**. After the Draft EIR has been prepared, it will be released for public review and comment. The Planning Commission will then hold a public hearing on the Draft EIR and on the Project. Separate notices of the availability of the Draft EIR and of the hearings on the Project will be released at later dates.

Et in Turkey, the United Arab Emirates, Saudi Arabia, Greece and the United States.

He now plans on opening a location in Beverly Hills, next to the luxury steakhouse Spago. Because the restaurant is in a residential and commercial transition area, however, it needed an extended hours permit to stay open past 10 p.m.

The Planning Commission approved the permit last Thursday, under the condition the restaurant would not accept new customers past 12 a.m. Nusr-Et will now be able to operate between 11 a.m. to 2 a.m. Monday through Saturday and between 7 a.m. and 2 a.m. Sundays.

Murray Fischer, counsel for Nusr-Et, said the restaurant had planned to open on January 15 but couldn't because of the COVID-19 pandemic.

"Unfortunately, because of COVID we cannot open up until the health department gives us the okay on that," Fischer said. "But in the meantime, we are working very closely with Spago and the LA County Health Department in order to provide a potential open air tent within the cul de sac."

Chair Peter Ostroff welcomed the restaurant to Beverly Hills and said it's the kind of business the city wants.

"I hope that there's more of you and I hope that you thrive and flourish," Ostroff said.

Planning Commission Says Proposed Hotel Would Cast A Long Shadow on Beverly Hills

The Planning Commission did not approve the construction of a hotel on North La Cienega Boulevard last Thursday.

Commissioners cited several reasons for their decision, including that the hotel proposal violated the city's municipal code standards for height and floor area. The proposed height for the building was a major topic of discussion, with commissioners concerned that it would be too tall for its location and cast a large shadow over the neighborhood.

The hotel, listed as 55 La Cienega Hotel on its application, had proposed for an eight-story, approximately 109-foot-tall building with 216 rooms. The project

would have been 266,800 square feet if the commission approved it in its current form. It would also have had commercial uses on the ground floor, including a retail store and parking garage with 358 spaces.

"I find the project out of character with the neighborhood," said Commissioner

Thomas Hudnut.

According to the commission's agenda report, the hotel had requested a Zoning Amendment, General Plan Amendment, Zone Text Amendment and Planned Development because it did not comply with the city's code standards.

Commissioner Andy Licht said nearby residents would likely have their homes under the shadow of the hotel for a good portion of the day.

"It just seems too big, too massive, too tall for the area to me," Licht said.

Chair Peter Ostroff said the project is not going to happen as proposed.

"This is just so far off of anything that we could really seriously consider that you need to go back to the drawing board," Ostroff said.

Nearby residents also raised concerns with the proposal. Debbie Brown wrote a letter to the city that said she is concerned about sunlight being blocked because of the hotel.

"I am a long time resident on North Hamilton Drive in Beverly Hills," she said. "I live mid-block and have shade/shadow concerns regarding this new eight-story proposed hotel."

Elizabeth Axelrod wrote that the proposal should not even be considered.

"Why doesn't the city consider the impact on the local residents or traffic and congestion?" Axelrod said. "This hotel will cause so much congestion at La Cienega and Wilshire Boulevard."

Katerina Zhuravleva wrote that the project had a great concept, but it's design needs work.

"Density and mass are fine but design needs more work, it is dated and looks like a cheap motel," Zhuravleva said.

City's Water Treatment Plant Projects Move Forward

The Public Works Commission reviewed updates to the city's public works projects last Thursday, which included the Foothill Water Treatment Plant, the La Brea Subarea and the Sand Pit Site.

The contractor for the Foothill Water Treatment Plant, Shimmick Construction Company, began in December setting up electrical conduits, pipe support and other mechanical work. According to the commission's agenda report, this work will continue throughout January.

A portion of the La Brea Subarea project, located at the former Coffee Bean and Tea Leaf property, is expected to finish ahead of schedule. According to the agenda report, the transmission main project will be completed a month early this March.

City staff are working on developing one of the project's wells and a conveyance pipeline that will make sure it has maximum supply capacity. But the equipping project for this well has been delayed and is now expected to be completed by December. This is due to the well drilling

project experiencing extended processing times for its water quality samples.

According to the agenda report, city staff, a consultant hydrogeologist and pre-treatment design firm Carollo Engineers are evaluating the final water quality test results for the well. The design firm is reviewing the results to verify if the water quality is suitable for the proposed pre-treatment system.

The contractor for the project, MNR Construction, has finished pressure testing the pipeline, air valve assemblies, blow-off assemblies and the tie-in into existing piping to the plant for the transmission pipeline. According to the agenda report, the final connection will be made to the plant once the pipeline passes pressure testing.

Work that still needs to be done at the plant includes final paving for the alignment of the pipeline and grouting the annular space for the slipline pipe. City staff are also continuing to search for additional properties, but there were no new properties available recently.

The Sand Pit Site is also making progress. The contractor for the project, NR Development, finished grading the site and is not working on acquiring permits to construct the driveway approach on La Cienega Boulevard from the City of Los Angeles. The Department of Drinking Water approved the Preliminary Design Technical Memo for the proposed monitoring well design criteria and assumptions.

According to the agenda report, city staff are now preparing technician specifications for the DDW's approval. The agenda report also states that the city is working on designs for the future exploratory borehole project.

Eastman Retires from Chapman University, Days After Attending Pre-U.S. Capitol Riot

Chapman University Law Professor John Eastman, who recently worked on the City of Beverly

Hills' Parade and Assembly Ordinance, retired from his position last Wednesday. His retirement came several days after he spoke at the pro-Trump Rally which later became the U.S. Capitol Riot.

Eastman had spoken alongside Trump's personal attorney Rudy Giuliani at the "Save America" Rally on January 6. He made several unproven allegations of vot-

er fraud in the U.S. Presidential Election and Georgia Senate race results.

Chapman President Daniele Struppa said in a statement that Eastman and the university have reached

an agreement for him to retire and not to engage in legal actions. Eastman had previously made allegations of defamation against the university.

"Dr. Eastman's departure closes this challenging chapter for Chapman and provides the most immediate and certain path forward for both the Chapman community and Dr. Eastman," Struppa said.

SO THE COVID-19 VACCINE IS FINALLY HERE, BUT WHAT DOES THAT MEAN FOR BEVERLY HILLS RESIDENTS?

The State of California began distributing the COVID-19 vaccine at the end of last year, but Beverly Hills residents are wondering when they'll be able to get their dose.

Beverly Hills city councilmembers attempted to answer that question last Tuesday, during a discussion on vaccine planning and distribution. However, it remains unknown if the City of Beverly Hills will contribute in any way to the vaccine rollout. As of press time, vaccination distribution locations in Los Angeles County include:

- Six Flags Magic Mountain, 26101 Magic Mountain Pkwy, Valencia, CA 91355

When residents will qualify for the vaccine generally depends on their age, occupation and if they have a high-risk medical condition. LA County is following the State of California's phased tier system, which determines how people are prioritized for the vaccine.

Emergency Management Analysis Meena Janmohamed said the City of Beverly Hills must follow the county's COVID-19 vaccine distribution plan.

"As we all know, the supply of COVID-19 vaccines will be limited for the first two months," she said. "This means that the vaccine will be offered

to different groups of people at different times."

LA County is currently in Tiers 1-3 of Phase 1A, which includes healthcare workers and long-term care facility residents. It announced that it will also begin vaccinating seniors aged 65 and older starting Thursday.

The next vaccine distribution phase is Phase 1B, which essential workers such as teachers. Following that will be Phase 1C, which includes people between ages 50 and 64, and finally a proposed Phase 2. According to LA County's website, Phase 2 will likely be for people between 16 and 49 without high-risk medical conditions.

According to Janmohamed, it's estimated Phase 1B will begin in February, Phase 1C in March and Phase 2 in mid-May or early June. These dates are subject to change.

"It's very important to note that a lot of these are loose definitions," Janmohamed said. "This is fluid and can change at any time. We may see changes in the guidance and the structure in the coming few weeks with the change in the new administration."

She said large sites, such as the Dodgers Stadium, will be the county's solution to widely-distributing the vaccine.

"Healthcare systems that already have the capability to do this mass inoculation will be brought online to support this effort," she said. "Smaller local pharmacies will have the capability to inoculate and eventually this will come down to primary care providers."

Roxbury Park may become a vaccination distribution site if LA County chooses to bring it online, according to Janmohamed. However, she said LA County appears to be more focused on opening larger sites for vaccination distribution.

Janmohamed said Beverly Hills residents will likely go to those larger sites or pharmacies for vaccinations.

"What we've been told is [LA] County Public Health will likely have one [distribution site] per supervisorial distribution, but this has not been defined or confirmed yet," Janmohamed said.

After Janmohamed's presentation, city councilmembers shared their opinions on the vaccine distribution and what the city can do to help.

Councilmember Lili Bosse said she'd like the city to reach out to the community and let them know which stage they fall in.

"I think it would be helpful to let people know we're at this stage, if you fit into this category you're eligible and this is how you go about [getting] it," Bosse said.

Vice Mayor Robert Wunderlich said he's glad the city is doing what it can to facilitate vaccine distribution.

"I encourage you to do the most that we can do, so that we can take advantage of the resources we have in the city to facilitate the rollout of the vaccine," Wunderlich said.

City to Begin New Daytime Street Sweeping Schedule

Since August, the city has resumed its street cleaning services and its new daytime schedule will help improve service efficiency through the installation of clear, visible signage and the new hours will minimize disturbances that were a result of nighttime services. Street cleaning will be performed Monday through Thursday and times vary between the hours of 7 a.m. to 2 p.m. depending on the day and street.

Phase 1A will begin with the region located south of Wilshire Boulevard to

Olympic Boulevard between Moreno Drive and El Camino Drive. This first phase will serve as a pilot before widespread implementation takes place over the course of the next few months. All impacted residents will be notified by mail regarding the new schedule changes.

Blood Donations Urgently Needed at Cedars-Sinai

Cedars-Sinai is one of many Los Angeles area hospitals experiencing blood product shortages this month, and experts are encouraging people to roll up their sleeves and donate.

Armando Romero, associate director of Blood Donor Services, said while demand for blood varies from day to day, the supply has remained consistently low throughout the COVID-19 pandemic, creating extreme shortages.

"Community blood drives in places like high schools, colleges and churches are traditionally our biggest source for blood donations," Romero said. "With these venues closed and no longer hosting events like blood drives, we're struggling to keep up with demand."

Romero said that when the hospital can't supply the necessary blood from its own blood

collection activities, it turns to outside sources like the American Red Cross. But increased demand for blood products from hospitals throughout the country has caused even those sources to run low on supply.

"What ends up happening is that we have to piece together blood deliveries from different sources," Romero said. "If, for example, we need 50 units of Type O blood, one source might be able to give us 20, another might be able to send us 25. We assess the situation daily to make sure we have enough to keep up with the next few days' demands."

Romero had encouraged people to donate blood on Martin Luther King Jr. Day.

"What better way to serve your fellow human beings, than giving of yourself on this national day of service," he said. "Especially now, when blood supplies are so low, your blood will likely be put to use within just a few days, helping a patient safely undergo a surgery they need or receive life saving medical treatment."

Cedars-Sinai is precautions to keep donors safe and prevent the spread of the coronavirus, he said.

Online appointment booking spaces the appointments out so there are fewer donors in the donation center at any given time, and donation beds are set up to create physical distancing. Donors must wear masks at all times when donating blood

MALLORY'S MEMORY LIVES ON

Diane Shader Smith Continues Her Daughter's Legacy Through Lecture Last Week

Diane Shader Smith has continued her late daughter Mallory Smith's legacy by discussing how her family coped with Mallory's cystic fibrosis through presentations.

Shader Smith shared her daughter's story and passages from Mallory's memoir, titled "Salt in My Soul," with Las Virgenes Unified School District high school students Friday. The nonprofit Learn also donated 100 copies of the book to the district, which students were able to pick up throughout the week.

Kearston Stepenosky, a junior at Calabasas High School, introduced Shader Smith before her presentation. She said "Salt in My Soul" has been used across the nation to teach disability from the patient perspective to medical school

students.

"It sparks pivotal conversations about the frequent portrayal and overlooked qualities of individuals with disabilities," Stepenosky said. "I truly believe this book encompasses messages that all can learn from, but it's especially applicable to high school students."

Stepenosky's father, LVUSD Superintendent Dan Stepenosky, was Beverly High's principal when Mallory was a student there. Mallory graduated in 2010.

"Dr. Stepenosky was Mallory's principal at Beverly Hills High School and can definitely attest to her admirable character and determination," Kearston Stepenosky said.

Shader Smith described how Mallory

had turned to writing to help her cope with her illness and document her life. She said Mallory had given her the password to her diaries a couple months before she died at age 25.

imposed by the medical system she depended upon."

"When I opened it, I found 2,500 pages of her reflections over 10 years," Shader Smith said. "The playful writings of a teenager, the somber insights of a young woman facing death and clear instructions for me to publish the parts that might help others."

She said Mallory wanted to leave her mark on the world.

"Mallory was a gifted storyteller who created poetry out of prosaic experiences," she said. "She writes in detail about her treatments, the love and unexpected community she found in hospitals, the transcendent intimacy she developed with her beloved doctors and careteam and the problems

According to Shader Smith, the biggest surprise from reading Mallory's journals was that her facade of perfection hid a darker truth about experiences and emotions she hadn't shared publicly. She said Mallory lived happily, but in her journal she expressed anger at her disease and what living with a disability does to a person.

"Mallory often said that writing helped heal her," Shader Smith said. "If only she had gotten to see that her writing is healing others. She leaves a legacy in her wisdom and her words – the salt in her soul."

ORDINANCE NO. 21-O-2832

AN ORDINANCE OF THE CITY OF BEVERLY HILLS TO INCREASE SOLID WASTE RATES BEGINNING JANUARY 1, 2022, AND EACH JULY 1 THEREAFTER THROUGH JULY 1, 2025

THE CITY COUNCIL OF THE CITY OF BEVERLY HILLS DOES ORDAIN AS FOLLOWS:

Section 1. The City Council of the City of Beverly Hills hereby finds as follows:

A. The City Council is authorized pursuant to the California Health and Safety Code Section 5471 to prescribe, revise and collect rates and charges for solid waste services and facilities furnished by the City.

B. The City Council wishes to increase the rates for solid waste services (the "rates") as provided in Exhibit A.

C. The City Council identified the parcels upon which the proposed rates would be imposed and calculated the amount of the proposed rates.

D. The City Clerk caused a notice of the time and place of a public hearing on the proposed rates to be mailed as required by Section 6 of Article XIID of the California Constitution.

E. Each notice described the amount of proposed rates, the basis upon which the amount of the proposed rates was calculated, the reason for the proposed rates, and the date and time and location of a public hearing on the proposed rates.

F. On December 8, 2020, at the date, time and location set forth in the notice, the City Council conducted a public hearing on the proposed rates and heard and considered all objections and protests thereto and at the close of the public hearing, the City Council determined that written protests had not been presented by a

majority of owners of the identified parcels.

Section 2. Beginning January 1, 2022, and each July 1 through July 1, 2025, the rates listed in Exhibit A for refuse collection rates for residential and commercial customers shall be increased as provided in Exhibit A.

Section 3. The City Clerk shall cause this Ordinance to be published at least once in a newspaper of general circulation published and circulated in the City within fifteen (15) days after its passage, in accordance with Section 36933 of the Government Code; shall certify to the adoption of this Ordinance and shall cause this ordinance and her certification, together with proof of publication, to be entered in the Book of Ordinances of the Council of this City.

Section 4. This Ordinance shall go into effect and be in full force and effect at 12:01 a.m. on the thirty-first (31st) day after its passage.

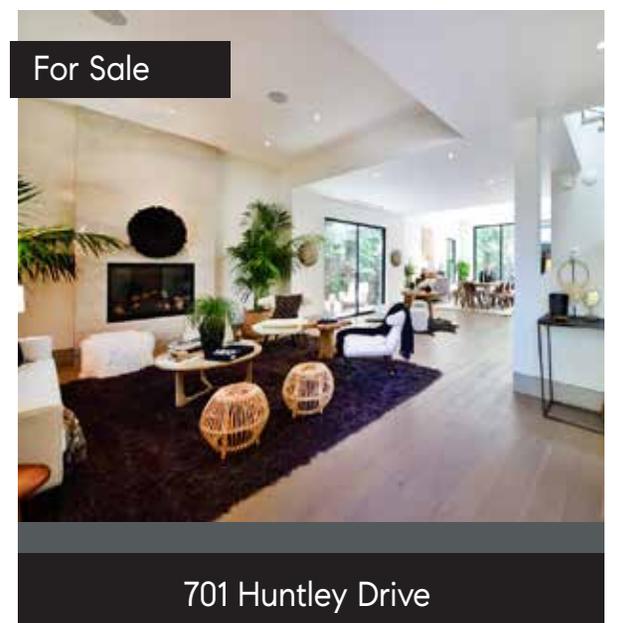
