

"Remembering Former Horace Mann Principal Dr. Art Fields" [Issue #1118]


I learned about the passing of Dr. Arthur Fields when I opened last week's Beverly Hills Weekly. Isolated at home, as are most people at this time, and in the late autumn of my years, my reaction to hearing the news was particularly emotional. Sadly we have lost one of our outstanding educational leaders. For over two decades I worked with Dr. Fields. In retrospect, I was fortunate and thankful to have worked with dedicated and outstanding principals in Beverly Hills. Steve Fisher (El Rodeo), Ben Bushman (BHHS), Ruth Friedman (BHHS) and Irene Stern (BV), each of whom loved their students and along with their stellar staffs continued the educational excellence that is the hallmark of the Beverly Hills Unified School District. Dr. Fields was a unique educator most worthy of his legendary status at Horace Mann.

I read the magnificently written tribute by Merle Bauer and Steven Fenton to Dr. Fields. They both captured the essence and depth of his leadership as the long time Principal of Horace Mann. In point of fact, Horace Mann and Dr. Fields became synonymous terms.

Above all Dr. Fields loved children and his open and encouraging relationship with his teaching and supporting staff. In fact there were so many "all stars" working in Horace Mann that I hesitate to mention any for fear of omitting any.

I knew and admired Dr. Fields throughout my 25 year interaction with him. He was a no nonsense administrator whose clear, gentle and supportive leadership style made Horace Mann a most successful school. In my many visits to Horace Mann, I saw first hand his special interaction with students and staff. On one such visit I can vividly recall students circling him and clamoring for his attention. To this day I hear their cries "Dr. Fields, Dr. Fields ... " Visiting Horace Mann on "back to school night" was an educational wonderland designed to have parents see each child's achievements. On other occasions we visited classrooms randomly and saw students focused on curriculum goals and student involvement in the teaching/ learning process. Such involvement does not magically happen. It is the result of top notch teaching and administrative leadership. I could go on and on.

Dr. Fields was a unique educational leader who deserved all of the accolades he is remembered for. The children who passed through the halls of Horace Mann remember this good man. On my travels throughout the world if I happened to meet a Horace Mann graduate they raved

in fanciful inaccurate renderings, onto the thin strip of land along Santa Monica Boulevard, is the past underhanded, unlawful, reckless conduct by Lot 12 and 13 owners called the Beverly Hills Land Company.

This land strip has been proven to be contaminated with arsenic from years of prior railroad use, likely due to arsenic soaking of railroad ties and pesticide usage.

After removal of the railroad, many trees and brush were left on the property. The lot owners knew of the strong resident opposition to removal of trees, 296 residents having signed a petition to prevent it. The owners also knew that any tree removal would have to be preceded by proper notices to both the city council and residents, and would also have to be permitted and meet the state health and safety requirements of the Department of Toxic Substance Control.

Nevertheless, with a complete disregard for the residents, city, and applicable toxic substance safety laws, on a Thanksgiving weekend back in 2015, without proper notice to the city council or the residents, without a permit, and without following state DTSC precautions to protect public health, the lot owners hired 24 unqualified workers, who were not trained in hazardous substance handling, to remove about 100 trees in one day. No precautions were taken such as the soil being wetted down to prevent the spreading of toxic dust or the air being monitored to assure safe conditions. Not only did the owners intentionally disregard the interests and health of the residents, the owners also exposed the untrained workers to health and safety risks in violation of Cal/OSHA.

The conduct of the Beverly Hills Land Company and their swift, surreptitious, unsafe illegal eradication of about 100 trees and brush, came as a great unsettling, unbelievable, and disturbing shock to nearby residents as well as the DTSC and the city council.

As set forth in an October 2016 report by Parent Smith Investigations, during the investigation into the owners' wrongdoing, the individual owners who comprise the Beverly Hills Land Company would only allow their interviews to be taken in the presence of their attorneys and refused to allow their interviews to be recorded in any manner.

Sometimes, and as we have seen recently with the mixed use ordinance, conduct by our city officials is so incomprehensible that we are left wondering whether they are incompetent or just corrupt. And so it was with this situation in which city staff members who no longer work for the city engaged in conduct described as sloppy or deceptive and failed to assure proper notice to the city council and residents, failed to check the lot owners' counsel's misrepresentation that they were no longer required to comply with DTSC requirements, and staff even made false claims of their own. The investigators concluded, very politely, that members of the city staff were more focused on accommodating and pleasing the developer owner of the contaminated land than meeting their duties and responsibilities to the residents

and the city council.

The DTSC representative recommended legal action against the owners, but one was not pursued because the DTSC did not have the resources for costly legal actions.

Now these owners want a big favor from the city: an extremely lucrative rezoning of the low cost contaminated land from transportation use such as parking, to commercial office building use, with permission to over-build on the strip, in return for the donation of the less choice parcel of contaminated land.

Aside from other reasons to reject this project, many residents feel very strongly that these owners have shown us who they are. They have ignored the law and interests of residents and the city; they have destroyed 100 trees and brush; they have sabotaged the health and safety of many others; and they do not deserve rezoning which would yield them millions of dollars in profit.

BHUSD Begins Offering COVID-19 Vaccine to Teachers

The BHUSD Board of Education approved last Wednesday a contract with a clinic to offer the COVID-19 vaccine to its teachers.

AmWest Ambulance partnered with the district to distribute vaccinations allocated by Los Angeles County. The vaccines are free, but the district will pay \$85 an hour

for storing, supplies and administering the shots to staff from its COVID-19 fund.

According to the board's agenda, the company provided 50 vaccines to a prioritized list of transitional kindergarten to fifth grade staff on Friday.

Board Renews Contract for Armed Security Services

The BHUSD Board of Education renewed last Wednesday a contract for armed security services at the district's schools.

According to Board Vice President Tristen Walker-Shuman, the district hired a security company after the Stoneman Douglas High School shooting in Parkland, Florida that killed 17 students and injured 17 others in 2018.

The board voted 4-1 to approve the contract with security company Nastec International, Inc. until June, with Board member Mary Wells dissenting. The contract will cost the district \$146,430.60.

Wells said the board was given an inadequate time of 28 hours to review the 80 page contract.

"I'm concerned about the transparency and overall how the cost will be managed." Wells said. "I could see this just really become a runaway train for the district in regards to cost and expenses. I would really like to ask that we either wait on voting on this item, so that we could clarify it more and we have more time."

Walker-Shuman said she would like to begin negotiations for a contract with Nastec for summer and fall soon.

"Because if we have summer school on campus in some physical way, we're going to need to make sure we have security for that too," Walker-Shuman said. "I don't want to be short-sighted on this. I think while I'm fine voting to confirm this project today for this time period, we can't really wait to begin writing the next one for the summer and fall."

According to the contract, Senior Program Executive of the district's Bond Program Don Blake will have oversight and administrative responsibilities of the contract.

Blake said the contract began with him being its administrator and his responsibilities were to ensure the armed guard component was consistent with the expectations for the security program.

"We were just carrying forward what we had previously been able to negotiate and the expectation [is] someday I would be living in Colorado, retired again," Blake

said. "Of course when that time comes, the entirety of the security program would be completely operated and managed by the district."

Council Denies Tobacco Hardship Exemption Appeal to Snack Shop on South Robertson

The City Council denied a tobacco hardship exemption appeal for a snack shop on South Robertson Drive last Tuesday.

Beverly Hills became the first city to ban the sale of tobacco products at the start of the year. Despite this, the city allowed qualified tobacco retailers to apply for exemptions that could permit them to continue selling tobacco products temporarily.

Kyrilous Snack Shop, a 34 year old business located at a Shell gas station, did just that. The store requested to sell tobacco products for another two years, after which business-owner Roshdy Sidarous said he would retire.

But the city only granted the shop a one year extension, which led Sidarous to file an appeal.

"The biggest reason we're asking for the full two years is because COVID had a huge impact on the business last year," said Marina Danial, Sidarous' daughter.

According to the appeal, Kyrilous Snack Shop's lease for its 50 square foot space is \$500 a month and it has four employees. Its gross income in 2020 was around \$130,000. This is almost \$70,000 less than it made in 2019, and about \$60,000 less than it made in 2018.

Tobacco products make up 43.6% of the shop's overall sales on average.

"[He] doesn't own any of the property. It's all space that's rented," Danial said. "There is no possibility of moving the business, because it's such a small location and there's nothing comparable to what he's paying now in terms of his lease to make up for any loss of business."

Councilmembers voted 3-2 to deny the business' appeal, with Mayor Lester Friedman and Vice Mayor Robert Wunderlich dissenting.

Councilmember John Mirisch said the council's decision to ban the sale of tobacco was sacred.

"Because it has to do with the health of our city," Mirisch said. "It has to do with values. It has to do with the worth of human beings not just being consumers who corporations can sell deadly items to and profit off of."

Mirisch added the business should consider selling lottery tickets.

But according to Sidarous, businesses are required to provide access and parking to people with disabilities to sell lottery tickets – which he can't do because he doesn't own the property.

"Perhaps our inspectors can help, but I do believe that looking at trying to get lottery tickets or scratchers might be something that could replace cigarettes because they don't require a lot of space," Mirisch said. "They are high-profit items and a lot of people who get gas, if they knew that they could get lottery tickets and saw that the jackpot was a billion dollars, they'd say 'You know what, I'll get some lottery tickets.""

According to the California Lottery, lottery retailers can earn between 4.5 and 6% commission on the items they sell. According to the Ohio Lottery's website, the average retailer earns \$15,000 in commission annually by selling lottery tickets.

Councilmember Lili Bosse said the council unanimously approved a ban on tobacco products and it was one of her proudest moments.

"I appreciate what you had said, that there wouldn't be the same amount of rev-

enue to sell anything else other than tobacco but I would've liked to have seen perhaps businesses try to sell something else," Bosse said.

According to Danial, the city assessed the shop and found that it did not have the ability to sell other items. The shop is too small to sell other items, Danial said.

Wunderlich said he supports the tobacco ordinance, but it had several criteria for tobacco hardships exemptions that Kyrilous Snack Shop meets. He said the criteria it meets includes not being able to sell other items or relocate

"This business does not have the same opportunities to change that some other businesses might have," Wunderlich said. "It's also not as if whether there's a large pipeline of other businesses that are applying for exemptions. This would be a oneoff and so I do vote to overturn the decision of the hearing officer."

He added that the council could grant the two-year extension and it would still be achieving the objectives of the ordinance by limiting tobacco sales overall.

While the appeal was denied, the council agreed to refund Sidarous for the cost of filing it with the city at Friedman's suggestion.

Board Expected to Approve Lavoffs

The BHUSD Board of Education is expected to approve a resolution to reduce or discontinue several teaching positions Wednesday afternoon.

Board members must decide which certificated and classified positions will be adjusted for the upcoming school year before March 15. Layoffs are typically determined by the district's enrollment.

FTE stands for "full time equivalent" and is the number of hours, or in this case class sections, someone works as a full-time em-

ployee. BHUSD defines FTE as teaching five sections, meaning each individual section someone teaches is equivalent to 1/5 or 0.2 FTE units.

Board Approves Guidelines for Facilities & Construction Committee

The BHUSD Board of Education unanimously approved the guidelines to establish a Facility & Construction Committee Tuesday.

According to the FCC's guidelines, it will "act as an independent advisory committee to the Board of Education regarding the district's facilities and construction program." Similar to the district's other committees, the FCC will not have authority to act on behalf of the BHUSD or board.

The district also has a Facilities Committee, which includes Board Vice President Tristen Walker-Shuman and Board member Noah Margo.

But Board President Rachelle Marcus and Board member Mary Wells had said they would like to rotate members and join the committee in place of Walker-Shuman and Margo in January. The board continued the item to a future meeting after it could not reach consensus.

The district's project manager Don Blake, who leads the facilities committee meetings, subsequently sent an email to Marcus stating that the committee is at his discretion and he will not change the board members who attend.

Marcus later initiated the creation of the FCC. At the board's March 9 meeting, she said the FCC would be at the board's discretion and operate by the board's bylaws by being open to the public and having minutes and agendas.

According to Superintendent Michael Bregy at the same meeting, the FCC would not replace the facilities committee and Blake plans to continue holding those meetings as well.

Wells said she recommends and requests that the board receive advice from legal counsel regarding the practices required for the board members attending the facilities committee.

"I want to be really clear that my concerns [are] about board governance and compliance with regards to board bylaws and is in no way a reflection of any concerns about the work being performed or completed by our construction team, in whom I have the utmost confidence and respect," Wells said.

Board Approves Early Retirement Plan for 18 Teachers

The BHUSD Board Education aproved Tuesday an arly retirement plan, hich 18 teachers enolled in

ate savings for the district. Teachers who participated in the program will officially

resign June 30. According to the SRP, there were several benefit options for teachers. These included monthly cash payments for the participants lifetime, modified monthly cash payment paid for the greater of 10 years or the participants lifetime and reduced Joint and Survivor monthly payments paid for the participants lifetime and beneficiary's lifetime.

The projected savings from the program are \$3,420,135 over five years. According to the board's presentation, eight of the 18 positions will not be replaced.

Design Review Commission Discusses its Criteria Process

The Design Review Commission discussed last Thursday its criteria and review process.

According to the commission's agenda report, the commission's design review process for single-family homes is meant to prevent undesirable development and protect the welfare of the community and its existing residential neighborhoods.

This process includes requirements that proposed developments should exhibit internally compatible design schemes, designs that enhance the garden-like quality of the city, enhance the appearance of the neighborhood, respect prevailing site design patterns, and more.

According to the agenda report, the scope of the commission in the central area of the city is limited to reviewing the front facade and sometimes the side elevation of homes.

'Generally, the code requires the commission to focus on the overall scheme or architectural theme of the design presented without concentrating on the more minor or decorative components of the design itself," the report read.

Commissioners reviewed their responsibilities and debated what language needs to be updated to more accurately reflect the work they do.

Rent Stabilization Commission Cancels Meeting Again for Lack of Quorum

The Rent Stabilization Commission canceled its meeting last Wednesday because it did not have quorum.

Commissioners Kathryn Cavanaugh Jacoby and Gwen Owns, who represent tenants in the group, were not present for roll call. This is the second time the commission has not been able to meet because it did not have enough members present.

Beverly High Announces Tentative Football Schedule; School Won't Field Girls' Volleyball, Boys' and Girls' Water Polo Teams

Beverly High is tentatively scheduled to begin its spring 2021 football season March 26 with a game at Leuzinger, Timothy E. Ellis, the BHUSD's director of district athletics, announced Tuesday.

The schedule also consists of home games April 1 against Leuzinger and April 16 against Centennial and an April 9 game at Inglewood.

No spectators, band members or cheerleaders will be allowed into games at the present time. Ellis said he feels that regulation "will be relaxed" before the start of play. Only the coaching staff, medical staff and security will be permitted in the stadiums, on the courts or fields.

The school's first sporting events of the 2020-21 school year will be home boys' and girls' tennis matches March 18 against West Torrance, Ellis said.

The school will not field a girls' volleyball team this school year because the Los Angeles County Department of Public Health has not given its permission for indoor high school sports to begin their seasons. Ellis said.

The school will also not field boys' and girls' water polo teams because the Swim-Gym is undergoing renovations and the lack of a practice facility, Ellis said.

Burke Announces Retirement from South Coast AQMD **Governing Board**

Dr. William A. Burke announced his retirement from the Governing Board for the South Coast Air Quality Management District after 27 years of service. South Coast AQMD will hold a special election at the April Governing Board meeting to elect the next Chair of the Board.

Burke will officially step down on May 31. He is the longest-tenured member and the longest-serving chairman of the South Coast AQMD Governing Board. In February, the Governing Board voted to name the auditorium located in the Diamond Bar headquarters after him for his service as an environmental justice trailblazer.

On his first day as chair in 1997, Burke announced environmental justice would become a central focus of South Coast AQMD. His accomplishments include the expansion of South Coast AQMD's monitoring of air pollution in areas known as toxic hot spots, the establishment of the



job training during the Great Recession of 2009, a call for incentives for the clean-up, removal and replacement of diesel engines, an eight-point initiative reviewing regulations governing toxic air pollutants linked to cancer and birth defects, and the proposal and adoption of four guiding principles for enhancing environmental equity.

"As I've said before, clean air is a right, not a privilege. I have spent my career



fighting to be a voice of the unheard, so that all people have the opportunity to breathe clean air," Burke said. "I'm so proud of the work accomplished during my tenure and when the sun sets on my last day of service, I know I will be able to sleep because I did the best that I could."

Burke is the father of Assemblymember Autumn Burke (D-Marina Del Rey).

Two Postal Service Employees Face Federal Charges

Federal authorities arrested Wednesday two employees of the U.S. Postal Service who allegedly abused their positions to purchase and cash Postal money orders with tens of thousands of dollars of unemployment benefits fraudulently obtained with false claims of COVID-related job losses.

Christian Jeremyah James, 31, of South Los Angeles, who works in the Culver City Main Post Office, and Armand Caleb Legardy, 32, of Inglewood, who works in the La Tijera Post Office on Crenshaw Boulevard in South Los Angeles, are expected to make their initial court appearances Wednesday afternoon in United States District Court in Los Angeles.

A criminal complaint filed on March 3 and unsealed after the arrests charges James and Legardy with conspiracy, aggravated identity theft, access device fraud, and fraud in connection with major disaster or emergency benefits.

The affidavit in support of the criminal complaint alleges that James and Legardy obtained debit cards issued by the California Employment Development Department, which administers the state's unemployment insurance program. Those debit cards were issued based on applications for pandemic-related unemployment benefits submitted under 10 stolen identities.

Both James and Legardy used the fraudulently obtained EDD debit cards to purchase Postal money orders and cash Postal money orders that had been purchased

with those debit cards, according to the complaint, which notes instances in which unidentified individuals used the EDD debit cards to purchase Postal money orders from the defendants while they were on duty at the Post Office.

James and Legardy also allegedly used the EDD debit cards issued in other people's names to withdraw thousands of dollars in cash from ATMs. And, according to the complaint, James and Legardy deposited multiple fraudulently purchased Postal money orders directly into their own Sharon Stone bank accounts, including one in-

stance in which James purchased a \$1,000 money order that was then deposited into Legardy's bank account. According to the complaint, more than \$25,000 in fraudulently purchased Postal money orders were deposited into James' own bank account.

As of late December, the 10 fraudulently obtained EDD debit cards had been used to make \$168,758 in purchases and \$31,133 in ATM cash withdrawals.

The complaint does not accuse James

or Legardy of submitting the fraudulent applications to the EDD. A criminal complaint contains allegations that a defendant has committed a crime. Every defendant is presumed innocent until and unless proven guilty beyond a reasonable doubt.

If they were to be convicted of the conspiracy and two fraud offenses alleged in the complaint, James and Legardy would each face a statutory maximum sentence of 45 years in federal prison. The charge of aggravated identity theft carries a mandatory two-year prison sentence that would run consecutively to any other prison term imposed in the case.

This matter is being investigated by the United States Postal Service - Office of Inspector General, the U.S Department of Labor - Office of Inspector General, IRS Criminal Investigation, and the California Employment Development Department. This case is being prosecuted by Assistant United States Attorney Charles Pell of the Santa Ana Branch Office.


Writers Bloc Presents Live **Stream with Sharon Stone**







BHUSD Elementary Students Return to Campus

Elementary students returned to campus this week for the first time in almost

a year, as in-person instruction resumed at Hawthorne and Horace Mann now is the LA County Schools

The BHUSD first closed its schools on March 13, 2020 in response to the *a stable cohort is and* COVID-19 pandemic. While the district initially planned to initially planned to be closed until April 5, this was indefi- cohorts with changing nitely extended as COVID-19 case rates —Superintendent Michael Bregy union continued to rise throughout the State

of California and Los Angeles County. But with new state and county guidelines and lowering COVID-19 cases, the district was given permission to reopen schools for transitional kindergarten through fifth grade in February. According to Superintendent Michael Bregy, LA County's adjusted COVID-19 case rate is 5.2 as of Tuesday. The case rate was 65.8 at the start of January.

TK through second grade students resumed in-person classes on March 8, while third through fifth grade students resumed in-person classes on March 9.

Bregy said it was a momentous occasion welcoming back elementary students.

"I want to thank teachers, office staff, security, office managers, our administration at all of the schools," Bregy said. "[They did] such a great job welcoming people back and it was just great to see everybody."

Parents of TK through fifth grade students were given the option to have their

children continue virtual learning or begin hybrid learning. Students already enrolled in the Independent Learning Center are obligated to continue the program until the end of the semester.

According to the BHUSD's Memorandum of Understanding with the Beverly Hills Education Association, which is the representing district faculty and staff, students in the

hybrid learning program were placed into "AM" and "PM" cohorts.

Morning cohort students are on campus from 8:30 a.m. to 10:50 a.m. and evening cohort students are on campus

from 12 p.m. to 2:20 p.m. most days of the week. Morning cohorts will start about an hour late and evening cohorts will end about an hour early on Wednesdays.

Students who are not physically on campus will participate in virtual specialist lessons and work on other assignments. There will be no recesses or breaks and lunch will be provided to-go.

Bregy said the district's next step is looking at reopening schools for middle and high school. He said the district is waiting for information regarding how many times a student can change from one group to another.

"The biggest factor now is the LA County Department of Public Health providing us a definition of what a stable cohort is and how a stable cohort will change into the intermingling of our cohorts with changing classes," Bregy said. "We are expecting that information any day right now."

Bregy said the district sent out a 10-day notice to BHU-SD faculty and staff Tuesday regarding reopening middle and high school.

"We do have an agreement in our MOU to provide 10 days notice to employees, which we have sent that working quickly and safely thorne Principal Sarah Kaber to ensure that we are going to

be able to bring back our students and our staff in a timely manner, in a safe manner, for the remainder of the school

ORDINANCE NO. 21-O-2834

AN ORDINANCE OF THE CITY OF BEVERLY HILLS EXTENDING INTERIM ORDINANCE NO. 21-O-2833 AMENDING SECTION 10-2-303 OF THE MUNICIPAL CODE REGARDING ADJUSTING LOT LINES THAT ARE BETWEEN JURISDICTIONAL BOUNDARIES AND DECLARING THE URGENCY THEREOF

THE CITY COUNCIL OF THE CITY OF BEV-ERLY HILLS HEREBY ORDAINS AS FOL-LOWS:

Section 1. Legislative Findings.

The City Council of the City of Beverly Hills is concerned about lot line adjustments which create or increase the size of parcels crossing the boundary of the City. Of particular concern is the fact that the City's regulations permitted the adjustment of lot lines to create or expand parcels located both within the City and another City. The City does not have authority over the development of land within the jurisdiction of another City. Accordingly, when a parcel is located both within the City and another city, a portion of the parcel is subject to the City's regulations and development standards, and a portion of the parcel is subject to the regulations and development standards of that other city. Because the City's General Plan and zoning and building ordinances would not apply to the portion of the lot which is located in another city's jurisdiction, a lot line adjustment creating or expanding a lot that crosses the City boundary will not conform to the City's General Plan or the City's zoning and building ordinances. This negatively impacts the public health, safety, and welfare because buildings that do not comply with City codes can be built with City access, utilities, and other services and buildings can be built under another city's zoning regulations without appropriate setbacks. Con-sequently, the City Council wishes to consider enacting appropriate regulations regarding if and under what circumstances adjusting a lot line to create or expand a parcel that crosses the City boundary may be appropriate.

Because the public process of adopting permanent regulations may be lengthy, and to prevent the adjustment of lot lines which will create or expand parcels that cross the boundary of the City in the intervening period, the City Council adopted Ordinance No. 21-O-2833, an interim ordinance that took effect immediately on January 26, 2021 (the "Interim Ordinance"). The Interim Ordinance amends Section 10-2-303 of Article 3 of Chapter 2 of Title 10 of the Beverly Hills Municipal Code to prohibit a lot line adjustment which would either create or expand a lot that crosses the City boundary.

Section 2. Authority.

Pursuant to Government Code Section 65858, the City Council may adopt, as an urgency measure, an interim ordinance to protect the public health, safety, and welfare to prohibit uses that may be in conflict with a zoning proposal that the legislative body, planning commission, or the planning department is considering or studying or intends to study within a reasonable time. After public notice, the City Council may extend the interim ordinance by a period of ten (10) months and fifteen (15) days, pursuant to Government Code Section 65858. Notice of the public hearing at which the City Council considered adopting this extension ordinance was duly published.

Section 3. Urgency Findings.

The City Council finds and determines that failing to implement immediate changes to the City's lot line adjustment regulations would result in an immediate threat to the public health, safety, and general welfare. As described in Section 1, the City's regulations permit lot line adjustments which create or expand parcels crossing City boundaries, resulting in parcels subject to both the City's zoning and building regulations and another city's zoning and building regulations. Because the City's General Plan and zoning and building ordinances would not apply to the portion of the lot which is located in another city's jurisdiction, such lot line adjustments will not conform to the City's General Plan or the City's zoning and building ordinances. Accordingly, without appropriate regu-lations, the continued adjustment of lot lines to create or expand parcels under split jurisdiction will negatively impact the public health, safe-ty, and general welfare. Thus, to preserve the public health, safety, and general welfare, the City Council declares it is necessary that this Ordinance take immediate effect to prevent these harms.

Section 4. CEQA Findings.

The City Council hereby finds that the adoption and implementation of the Interim Ordinance or extension thereof is exempt from the California Environmental Quality Act (CEQA) pursuant to

Section 15305 of Title 14 of the California Code of Regulations because the average slope of the City is less than 20 percent and the ex-tension of the Interim Ordinance represents a minor alteration in land use limitations and does not result in any changes in land use or density. In addition, the City Council finds that the adoption and implementation of the Interim Ordinance or extension thereof will not have a significant environmental impact and is exempt from CEQA pursuant to Section 15061(b)(3) of Title 14 of the California Code of Regulations, which states that CEQA applies only to projects which have the potential for causing a significant effect on the environment. This exemp-tion is applicable because the extension of the Interim Ordinance would not result in physical changes to the subject properties and no po-tential for causing a significant effect on the en-

vironment exists.

Section 5. Severability.

If any section, subsection, subdivision, sentence, clause, phrase, or portion of this Ordi-nance or the application thereof to any person or place, is for any reason held to be invalid unconstitutional by the final decision of any court of competent jurisdiction, the remainder of this Ordinance shall be and remain in full force and effect.

Section 6. Approval and Extension of Ordinance.

This Ordinance, adopted as an urgency measure for the immediate protection of the public safety, health, and general welfare, containing a declaration of the facts constituting the urgen-cy, and passed by a minimum four-fifths (4/5)

vote of the City Council, shall take effect immediately upon its adoption and shall amend and extend the effect of the Interim Ordinance for a period of ten (10) months and fifteen (15) days. After notice pursuant to Section 65090 of the California Government Code and public hearing, the City Council may extend the effectiveness of the Interim Ordinance for an additional one year period, as provided in Government Code Section 65858.

Section 7. Publication.

The City Clerk shall certify to the adoption of this Ordinance and shall cause this Ordinance and her certification, together with proof of pub-lication, to be entered in the Book of Ordinances of the Council of this City.
