



“Board Approves Guidelines for Facilities & Construction Committee” [Issue #1119]

This letter is in support of Board President Rachele Marcus reinstating the formal Facilities Committee with an agenda, minutes and regular reports. In the last two years, two board members have continued to meet with [Facilities Director] Don Blake without having a formal agenda, minutes or reports to the board.

Mrs. Marcus is totally correct that meetings must be formal or they run the risk of violating the Brown Act and upend the public trust in any discussions surrounding construction. Mr. Blake is not correct in his assertion that he “gets to decide who serves on the Facilities Subcommittee.”

The decision on appointments to the Facilities Subcommittee is something that rests with the board.

In the February 23 board meeting, Board Vice President Tristen Walker Shuman and Board member Noah Margo described the facility meetings as, “working groups.” This designation is ridiculous especially when it comes to the most expensive asset our district has.

In the organizational board meeting of

BHUSD Announces Reopening Dates for Beverly High and Beverly Vista

High school and middle school students may return to in-person instruction later this month, according to the BHUSD's announcement Monday.

Students will return to campus on April 8 if the Board of Education and Beverly Hills Education Association approve the date. Sixth and ninth graders will also have an in-person student orientation on March 23.

The board, in a statement Monday, said it is aware that COVID-19 has impacted families, employees and the community significantly.

"There will be continued pressures as we move forward in our reopening efforts," the board said. "Each member of our community faces different challenges and holds different opinions on how reopening should take place. We commit to you that we will listen and work together with our leadership as we navigate this time."

Students will be placed into "A" and "B" cohorts. The "A" cohort will have in-person instruction on Monday and Tuesday. The "B" cohort will have in-person instruction on Thursday and Friday. All students will receive virtual instruction on Wednesdays.

Lessons will be livestreamed for students who are not on campus.

Parents will have the option to choose to continue distance learning, or begin hybrid learning – which is in-person instruction. Students enrolled in the Independent Learning Center are required to finish the semester in the program.

The BHUSD will notify parents and students about their cohorts and schedules by April 6.

Council Reviews General Plan and Housing Element Annual Report

The City Council reviewed the city's general plan and housing element annual report Tuesday.

According to the council's agenda report, the general plan has been updated to include a mixed use overlay zone after the council approved it last year. It also amended its safety element to include the city's updated hazard mitigation management plan.

The general plan is meant to serve as a blueprint for the city and is updated periodically. According to city staff's presentation, an annual report is sent to the state to report on the city's progress and significant

accomplishments. This includes its progress toward its Regional Housing Needs Assessment.

The council supported moving forward with the report.

Councilmember John Mirisch said he feels compelled to discuss RHNA whenever the council discusses the housing element.

"This is not just about our community, it's about all communities," Mirisch said. "It's about Sacramento in many ways disregarding local democracy and the ability of communities to make decisions for themselves."

North Oakhurst Drive Project Generates Controversy Among Residents

Residents raised concerns about a proposed home on North Oakhurst Drive at a Planning Commission meeting last Thursday. The project was later indefinitely continued to allow the applicant time to redesign his proposal.

The Planning Commission had originally planned to consider a development plan review for the proposed North Oakhurst Drive project in late February. According to the commission's agenda report, the development plan review is for the construction of a three-story single-family home with a basement on 331 North Oakhurst Drive.

Commissioners continued the discussion to their March 11 meeting after residents stated they had not been adequately notified about the project.

Steve Mayer, in February, said the project's plans were too complex for the average person to understand.

"To be able to [give] proper public comment is not available at this time," Mayer said. "Our original premise had been that when we actually requested to be able to look at the plans in I think December, we were told we couldn't because city hall was closed. If we had been able to look at it then, that would have been a different issue."

Several residents attended the commission's meeting last Thursday to share concerns about the proposed project's height and stated that the developer should have conducted a shade and shadow study.

They also shared concerns about the project's proposed driveway, alleging that it could put pedestrian safety at risk.

Commissioners at first unanimously passed a motion to bring back a resolution to reject the project. The project's architect Hamid Gabbay later requested that they continue the item to a future meeting, which they did.

Beverly Vista Principal Announces Retirement

Beverly Vista Middle School Principal Kevin Allen announced Friday he will be retiring from the district at the end of the school year.

"It is bittersweet for me to announce that I will be retiring at the end of this school year," Allen said. "After more than 30 years in this profession, serving as the principal at both El Rodeo and BVMS have been my greatest pleasure."

Allen became the El Rodeo School principal in 2014. He later became the Beverly Vista School principal after the district's reconfiguration.

"I have come to love this district and

community and find it to be my second home," Allen said. "While I look forward to the next stage of my life and the new adventures that it will bring, I will always remember this experience and all that we accomplished together."

Superintendent Michael Bregy said Allen oversaw the establishment of Beverly Vista and created a culture that promotes communication, collaboration and school spirit during its closure due to the pandemic.

"We will always be grateful to Mr. Allen who has truly shaped the future of our district for every student to come," Bregy said. "Mr. Allen, you have left some very large shoes to fill."

The BHUSD will search for a new Beverly Vista principal in the coming weeks, Bregy said.

City of Beverly Hills Receives Over \$6 Million from American Rescue Plan Act

The City of Beverly Hills will receive \$6.36 million from President Joe Biden's American Rescue Plan Act.

Biden signed the \$1.9 trillion economic stimulus package last Thursday. According to the Washington Post, \$350 billion of the package was dedicated to help state, local and tribal governments fix any budget shortfalls caused by COVID-19.

Single-Use Plastic's Days Could Be Limited in Beverly Hills

Plastic cutlery in Beverly Hills could be on the chopping block.

The Public Works Commission discussed last Thursday an ordinance that will either limit or prohibit the use of single-use plastic at restaurants in the city. An ad-hoc committee will review a draft of the ordinance before it is presented to the full commission.

If the commission votes to recommend the ordinance, the City Council will consider it for approval. This process is expected to take approximately a year.

Architectural Commission Will Consider Wilshire Boulevard Office Building

The Architectural Commission will consider approving an architectural review for an office building on 9744 Wilshire Boulevard Wednesday afternoon.

According to the commission's agenda report, the review is for the approval of modifications to the building's facade and improvements to its fourth-floor balcony.

Public Works Reviews Updates to Foothill Water Treatment Plant, La Brea Subarea and Sand Pit Site

The Public Works Commission reviewed last Thursday updates to the Foothill Water Treatment Plant, La Brea Subarea and Sand Pit Site.

Shimmick Construction Company, which is the contractor for the Foothill Water Treatment Plant, installed overhead pipes and completed the installation/anchorage of the Back Wash Waste Tank in February. The construction group also began the installation of the Sand Separators and the Oxidant Media Filters.

According to the commission's agenda report, Shimmick will continue electrical work at the site throughout March.

The La Brea Subarea, located at the former Coffee Bean and Tea Leaf property, continues to be developed. According to the agenda report, the transmission main project needs minor asphalt restoration and is expected to be completed in March.

Zim Industries, which is the drilling contractor for the well, is procuring a temporary pump and piping for the well's maintenance to complete the project. Next, the well will be maintained for several months to ensure the quality of the water and health of the well.

MNR Construction, Inc, which is the contractor for the transmission pipeline, completed the concrete restoration. It will complete the minor asphalt restoration and striping in March.

The Sand Pit Site has also made progress. NR Development, which is the demolition contractor, constructed the driveway approach on La Cienega Boulevard and is in the process of creating minor fencing.

According to the agenda report, the city received three bids for the drilling of the nested monitoring well that are being reviewed.

LA County Moves Into the Red Tier

Los Angeles County moved into the less restrictive red tier Monday as part of the state's Blueprint for a Safer Economy. Select businesses such as restaurants, movie theaters, gyms and more may reopen indoor operations with modifications in place.

The move comes as a result of the county's case rate reaching below the threshold of 10 new cases per 100,000 residents for two consecutive weeks while statewide, two million vaccine doses have been administered to residents living in under-resourced communities.

The new red tier announcement impacts businesses in the City of Beverly Hills that

fall within specific categories. The updated Health Officer Order and appendix protocols can be viewed at beverlyhills.org/coronavirus.

Additionally, on April 1, theme parks may reopen to the public with a maximum occupancy of 15% and will only allow in-state visitors.

According to the red tier, the following may reopen with modifications in place and posted appendices:

- Indoor operations for museums, zoos and aquariums with a maximum occupancy of 25%;

- Indoor operations for restaurants with a maximum occupancy of 25%, or 100 people, whichever is fewer, and at least eight feet of spacing between tables following the guidance listed in Appendix I;

- Indoor operations for gyms, fitness centers, yoga and dance studios with a maximum occupancy of 10%;

- Indoor operations for movie theaters with a maximum occupancy of 25%, or 100 people, whichever is fewer, utilizing reserved seating with at least six feet of social distancing in all directions between groups;

- Indoor retail operations and personal care services may increase maximum occupancy to 50% with face coverings required at all times and for all services;

- Indoor shopping malls may increase maximum occupancy to 50% with common areas remaining closed and food courts may reopen at a maximum occupancy of 25%;

- Institutes of higher education can reopen all permitted activities with required safety modifications except for residential housing which remains under current restrictions for the Spring semester;

- Schools can expand in-person instruction to include grades 7-12 adhering to all state and county directives.

According to the red tier, private gatherings can now occur indoors with up to three separate households, with masking and distancing required at all times. Those who are fully vaccinated can gather in small numbers indoors with others who are fully vaccinated without required masking and distancing. 

Bloom Announces Betty White as Assembly District 50 Woman of the Year

Assemblymember Richard Bloom (D-Santa Monica) has selected television legend and animal rights advocate Betty White as the 50th Assembly District's "Woman of the Year."

White will receive the award in recognition of Women's History Month. She will be honored at a virtual ceremony on March 15 along with other women from across California also being recognized by their state senators and assemblymembers for their accomplishments and contributions to the state.

"Betty White is often called a national treasure," Bloom said. "She is known not only for her prolific career in television, but also for trailblazing a path for women pursuing careers in television, and her staunch animal welfare advocacy."

A seven-time Emmy Award winner, White is recognized as the first woman to produce a sitcom, and was one of the first women to hold positions both in front of and behind the camera. A dedicated supporter of animal health and wellness, White is a trustee of the Greater Los Angeles Zoo Association and serves as President Emeritus of Morris Animal Foundation, where she has been a trustee since 1971.

In 2006, she was honored by the City of Los Angeles at the Los Angeles Zoo as "Ambassador to the Animals" for her lifelong work for animal welfare. She was proclaimed an honorary forest ranger by the U.S. Forest Service in 2010 and made an honorary zookeeper by the keepers of the Los Angeles Zoo, two occupations she considered as a child and before becoming an actress.

"I am surprised and honored to be recognized for Woman of the Year... It is

good to be 99," White said.

Bloom said White represents the best of Hollywood and the business of entertainment.

"A staple on the television screen, she has brought laughter into the homes of generations of families," Bloom said. "She is adamant on using her considerable platform to bring awareness to improving the lives of animals, and always with kindness, warmth, and humor."

White has earned numerous awards during her entertainment career spanning over eighty years which include: an Emmy Lifetime Achievement Award in Daytime, a Career Achievement Award from the Television Critics Association, a Screen Actors Guild Life Achievement Award, a Lifetime Achievement Award in Acting from the American Women in Radio and Television, AP Entertainer of the Year, the Broadcasting and Cable Hall of Fame, a People's Choice Award for "Favorite TV Icon," the TV Land Legend Award, and the Icon Award for Women in Television from the Paley Center for Media.

She has also been added to the Guinness World Records under the title, "Longest TV Career for an Entertainer (Female)" and was named the world's "Most Trusted Celebrity" by Reuters.

The Woman of the Year event was founded in 1987 by Assemblymember Bev Hansen and Assemblymember Sally Turner in response to the California Legislature's lack of events for Women's History Month. The now-annual event, sponsored by the Women's Caucus, allows each state senator and assemblymember to select one woman from their district to be honored for their accomplishments.

Bloom Appointed to the Assembly Committee

Assemblymember Richard Bloom (D-Santa Monica) has been appointed by Speaker Anthony Rendon (D-Lakewood) to serve on the Assembly Committee on Arts, Entertainment, Sports, Tourism, and Internet Media.

"This committee will play a key role, as we emerge from the grips of the pandemic and return to prosperity, for this essential part of our state and local economy," Bloom said. "I look forward to working with the chair and my fellow committee members to address these issues and pass crucial legislation that will benefit my constituents and all Californians."

Bloom remains Chair of Budget subcommittee No. 3 on Climate Crisis, Resources, Energy, and Transportation; and remains a member of following committees: Budget, Budget Sub No. 6, Business and Professions, Higher Education, and Local Government.

He represents California's 50th Assem-

bly District, which comprises the communities of Agoura Hills, Bel Air, Beverly Hills, Brentwood, Hollywood, Malibu, Pacific Palisades, Santa Monica, Topanga, West Hollywood and West Los Angeles.

Wallis Honored with 22 Nominations by the LA STAGE Alliance

The Wallis has been honored with 22 nominations by the LA STAGE Alliance for its annual Ovation Awards, including Best Season in connection with its productions of "Frankenstein," "Love Actually Live" and "Sisters in Law," three of its theater works produced in partnership with Los Angeles-based artists.

Besides the Best Season nomination, the Wallis and Four Larks presentation of a world premiere production of "Frankenstein," created with Four Larks after Mary Shelley's classic novel, received eleven nominations. "These three very distinctive productions, each of which were developed here in Los Angeles with our collaborating partners, are particularly meaningful not only because of their popularity with audiences, but also because of our dedication to working alongside excellent Los Angeles-based performers, creative teams, makers and technicians," Crewes said. "We are grateful to LA STAGE Alliance and the Ovation voters for this honor."

The LA STAGE Alliance Ovation Awards, founded in 1989, are the only peer-judged theater awards in Los Angeles. Voters are LA theater professionals who are chosen through a vigorous application process each year by the Ovation Rules Committee. LA STAGE Alliance is a non-profit arts service organization dedicated to building awareness, appreciation, and support for the performing arts in greater Los Angeles.

Beverly High Alumnus Set to Play in NCAA Tournament

After likely missing out on playing in last year's NCAA men's basketball tournament because of the coronavirus pandemic, former Beverly High standout Maddox Daniels and his Colorado teammates are scheduled to begin play in the 2021 tournament Saturday.

The Buffaloes (22-8) received the fifth seed in the East Region, their highest since the NCAA began seeding the entire field in 1979. Colorado's previous best was an eighth seed, achieved in both of their last two most recent tournament appearances in 2014 and 2016.

Colorado will face 12th-seeded Georgetown (13-12) which won the Big East Tournament after finishing eighth in the conference with a 7-9 record. The Buffaloes are the 20th overall seed in the 68-team field while Georgetown is the 47th overall seed.

The game from Hinkle Fieldhouse at Butler University in Indianapolis is set to begin at 9:15 a.m. Pacific Daylight Time and will be televised by CBS.

Daniels is a 6-foot, 6-inch senior guard-forward who is averaging 5.5 points and 18.8 minutes in 28 games, including three starts.

Colorado was expected to be chosen for an at-large berth in the 2020 tournament. Andy Katz of NCAA.com had projected the Buffaloes as the eighth seed in the East Regional. However, the tournament was canceled three days before Selection Sunday due to the outbreak of the COVID-19 pandemic.

The cancellation was especially disappointing for the team's seniors, Daniels said.

"We're also playing for them this year," Daniels said. "We're not taking our opportunity for granted."

The Colorado team arrived in Indianapolis Sunday from Las Vegas

where they had been since Wednesday for the Pac-12 Tournament, in which they finished second, losing to Oregon State in the final.

The NCAA has given players and other tournament participants little freedom of movement in an attempt to reduce the spread of the coronavirus.

"I haven't been outside in like three days," Daniels said in a telephone interview Wednesday.

Football

Max Menache will be continuing a football career that began in Mexico City in Minnesota.

The Beverly High senior tight end-linebacker-long snapper announced Friday he will play football and compete in track and field at Macalester College, a small private liberal arts college in St. Paul Minnesota that competes on the Division III (non-scholarship) level.

Menache said he emailed video highlights of his play and his statistics following his junior season to about "200 colleges and universities" and "Macalester was one of those that were interested."

Menache said he was offered spots on the college's football and track team rosters in the summer, held a virtual meeting with coaches "had a great connection with them" and visited the college later in the summer.

"I loved the campus," Menache said. "I connected with the coaches even more. I thought it was in a great location. Every-

thing seemed to click."

Menache said other colleges that showed interest in him included Kenyon College and College of Wooster, both in Ohio, Rhodes College in Tennessee, Sacred Heart University in Connecticut and University of Puget Sound in Washington.

Menache described Macalester College as an "amazing college" that provides "top-notch education."

"When I went the people there were so amazing," Menache said. "They were very inclusive. They treat you like you were family."

Menache said he is undecided about a major but is "leaning toward economics." He said his post-college options include playing in Europe, coaching or working with his father and a cousin at their textile manufacturing business.

Menache was born in Mexico City and began playing football when he was 8 or 9 years old, initially as a defensive tackle, center and long snapper, and "completely fell in love with the game."

"Ever since I started playing, I was very insistent to my dad that I wanted to go to the U.S. to play football," Menache said.

Menache said he began playing football because he was "very overweight."

He played soccer and "was bullied a little bit for his weight."

"I found this other sport, American football, and there I was a big body and they love big bodies," said Menache, who is listed on the Normans' roster at 6-foot-1 and 230 pounds.

Menache and his family moved to Beverly Hills in 2017, shortly before his freshman year at Beverly High.

"It was a huge transition to me," Menache said. "Before I wasn't able to walk to school without an adult taking me. I went from that to riding my bike to school, walking on streets without feeling a sense of danger. It was a huge change I'm very grateful for."

Menache said his family moved to the United States because his parents "wanted a better life for" him and his two brothers and two sisters and the opportunity for his father to expand his business.

QUESTIONING GASCON

Council Votes No Confidence in District Attorney

The City Council voted no confidence in Los Angeles County District Attorney George Gascon Tuesday.

Gascon was elected district attorney in November 2020. He has issued several controversial directives, which have included eliminating cash bail for misdemeanors and having certain misdemeanor charges declined or dismissed before arraignment.

After two robberies at luxury retailers last year and a recent robbery that led to a nonfatal shooting at Il Pastaio restaurant, several Beverly Hills residents and city officials have claimed that Gascon's policies have led to an increase of crime in the city.

Councilmembers voted 3-2 to approve the vote of no confidence, with Vice Mayor Robert Wunderlich and Councilmember John Mirisch dissenting. Mayor Lester Friedman and Councilmember Lili Bosse had requested the council adopt the resolution.



Friedman said safety and security is job one for the city council.

"We cannot take the responsibility as a society for the actions of criminals and just disregard them as being a part of our society that needs to be addressed," Friedman said. "The laws which [Defense Attorney] Gascon is ignoring were also democratically passed, but they're being ignored by a democratically elected official."

Friedman added he would support creating the city's own prosecutor's office, which councilmembers had previously discussed potentially doing.

"But the thought that we have as a city to set up another expensive bureaucracy because our current district attorney is not doing his job is really repugnant to me," Friedman said. "The thought of spending millions of dollars from city funds when it is the county's responsibility takes away from our ability to provide services to our community."

vide services to our community."

Bosse said Beverly Hills residents and businesses don't feel safe.

"If we don't act now, we will be part of the reason why Beverly Hills could fail. Under my watch while I'm on the council, I could not in good faith do that," Bosse said. "To me, this is more than a vote of no confidence. This is a message loud and clear, beyond just Beverly Hills but I think to Los Angeles, if there's no consequence to crime we are walking a line that could destroy the community we love."

She added that Beverly Hills Police Department Chief Dominick Rivetti had met with Gascon. According to Bosse, Rivetti had said it was an unproductive conversation and Gascon was not willing to change his directives.

Councilmember Julian Gold said the council's only option is this vote of no confidence.

"I realize this is a significant statement on our part," Gold said. "But truthfully, I

think that the impacts of what he's done really do require that level of a statement."

But not every councilmember supported the vote of no confidence.

Wunderlich said the resolution should be about policies, not about an individual elected official.

"Safety, of course, is the prime responsibility of [the] city council and I absolutely support that," Wunderlich said. "We can achieve that safety, however, by addressing the policies that we oppose and the policies that we support as opposed to addressing an individual."

Mirisch said he agrees the council has to protect the community, but that it can send messages without undermining democracy.

"I do not think that we should do something that we have

never done in the history of the city, which is a no confidence vote," Mirisch said. "The voters did elect him and the voters, as I mentioned, have the ability to recall him."


