## “Why would the Board of Education eradicate the 1938 mural in the Swim Gym?”

The city we know today as Beverly Hills was once the home of the Tongva people, before becoming a ranch known as El Rodeo de las Aguas. The land was granted to Maria Rita Valdez in 1938, a Spanish soldier's widow who raised cattle and bred horses. Soon, the area would be inundated with grazing sheep and vast fields of lima beans.

During the Great Depression, the U.S. government funded the Federal Art Project and hired hundreds of local and international artists who collectively created paintings and murals for municipal buildings, schools, and hospitals constructed under the Works Progress Administration (WPA). The construction of the historic Swim Gym at Beverly Hills High School was one of those WPA projects.

The main purpose of the Federal Art Project was to invoke familiar images on public buildings that spoke of shared American values and reflect the selected community's vibrancy. Some of the 20th century's greatest visual artists were em-

ployed by the Federal Art Project. One of those artists was Ernesto Scotti, a world-renowned painter, set designer, and illustrator from Buenos Aires, Argentina.

The BHUSD is in the process of renovating the historic Swim Gym. One troubling aspect of the renovation is that the school district is planning to cover up the iconic western-styled mural painted in 1938 by Ernesto Scotti. By covering up the mural, the district risks permanently damaging it while also eradicating our city's history. The district would better serve the community by restoring this historic artwork to allow future generations to admire the mural that documents and ties our shared generations.

For nine decades, stewards of this district have chosen to preserve our history. Is the mural out of place by today's aesthetics? Perhaps. As this school board continues the modernization of the district's facilities, they should keep in mind the motto that is on every construction banner: "Building for the future, while preserving the past."

### Traffic and Parking Commission Continues Online Meetings

The Traffic and Parking Commission decided during their special meeting last Thursday that they will continue to meet completely virtually due to the unknown consequences or effects of the new Coronavirus Delta variants. City Council requested each commission decide whether they would return to fully in person meetings or remain fully virtual on or before the Sept. 30 expiration date in the telecommunication exemptions in the Brown Act.

However, members of the public will be able to continue joining city meetings online for the foreseeable future, according to the city Emergency Manager Meena Janmohamed.

Vice Chair Sharon Ignarro voiced concerns of returning to in person meetings and her hesitancy due to the increase of

positive COVID cases in Los Angeles.

"We don't know what's happening with the Delta variant," Ignarro said. "I would be in favor of waiting until October, that gives us an idea, some time to find out what's going to happen with some of these new strains of virus and you know, we've been working very well with this model and I don't see a reason not to continue it for a couple of months."

Commissioner Ron Shalowitz supported Ignarro's position.

"She has some letters after her name that I do not have and she brings facts and statistics with her and being in an enclosed room for three hours with who knows of the public that is going to emerge speaking at us," Shalowitz said.

Members of the public that choose to attend any in person meetings at City Hall, who are not fully vaccinated, will continue to be required to wear a face mask in public, indoor settings. Those who are fully vaccinated have the option to wear face masks, but are not required, including sitting council or commission members.

Vaccine verification will be based on a self-attestation, no proof of vaccination necessary.

### New Virtual Parking Permit System Proposed

A new all-virtual system for parking permits was recommended to the Traffic and Parking Commission at their July 1 meeting that will require residents to have their license plates registered in the BHPD system and use digital license plate recognition, or LPR, equipment that is linked to resident's existing license plates, according to Sgt. Dave Tomlin who gave the presentation.

The new digital parking permit system would allow one household to have up to three vehicles registered per residence and up to two permits per vehicle. However, these new policies will need to be approved by the City Council before being implemented.

One address will have up to five free visitor permits, then the remaining 15 visitor permits will cost \$5 each. Up to 20 visitor permits will be allowed for each residence per month. This new parking permit program comes after BHPD implemented a new parking permit management system in October 2020 called DataTicket, Inc. According to the staff report, the new partnership allowed more flexibility, access and convenience to the parking process for residents, city staff and the community.

This digital-based parking permit program was proposed to begin Oct. 1, 2021, pending council approval. The new virtual permits would replace the existing preferential and overnight physical parking placards or rearview mirror hang tag.

Some benefits for the virtual parking permit outlined in the staff report include being an eco-friendly and cost efficient option, eliminates the use, production or distribution of physical permits, fast, online convenience for residents to pay, renew or manage their permits and the instantaneous approval and activation of their permit that will be uniquely programmed to their virtual license plate making them non-transferable.

Commissioner Lisa Kay Schwartz asked BHPD Tomlin about those who have a handicapped placard and where they are allowed to park anywhere, overnight parking excluded. Sgt. Tomlin responded, "yes, they are allowed to park," but the use of fraudulent handicapped placards and the distribution of them are part of a state-wide issue.

"I will tell you that I had a complaint just last week where an individual was cited the second day in a row and wanted to file a complaint against one of my PCOs because they were being harassed and it was racially motivated," Tomlin said. "The woman was in a nursing outfit, she was a nurse, once again at a local medical building and had admitted on tape to me that her doctor does give out fake placards for people who park all the time and she doesn't know why it's such a big deal."

Tomlin said actions from the state will have to make changes in regards to the use and repercussions of fake handicapped placards, but that there are at least 25 agencies working in the state's movement to hold doctors, "much more accountable to that and actually get some penalties," Tomlin said.

### Board of Education Approves Budget

The BHUSD Board of Education unanimously approved the budget adoption for the 2021-2022 school year at their June 22 meeting.

Within the General Fund Budget the Board approved staffing costs, strategic plans and board goals, local control accountability plans and other operational costs. However, excluded from the current budget report is the state's budget that has yet to be determined, which would inherently affect the district's budget. Adjustments reflecting the state's budget will be addressed and are expected to be presented to the board in September.

Most of the funds for the district's budget comes from local community property taxes. This year the budget is approximately \$57 million from property tax revenue. Increasing at a 3.5% rate, next year it's expected to rise up to \$59 million, then \$61 million for the 2023-2024 school year.

Of the 2021-2022 General Fund Revenue, 5% or \$4.7 million are one-time state and federal COVID-19 funds to make up for any loss or gaps that the pandemic caused. Property taxes/LCFF makes up 72% of the GFR, or \$62.6 million.

General Fund Expenses for the 2021-2022 school year are mostly certificated salaries, employee benefits and services, such as utilities, insurance and other contracts with BHUSD. Included in this year's expenses report are one-time COVID expenses that total \$4.7 million, or 5% of the total fund.

### Ramer Discusses Goals as Student Board Representative

SiNew nce eighth grade, Eli Ramer has dreamt of being a member of the BHUSD Board of Education as an advocate and student representative. The 17-year-old Beverly High senior, who had previously been Secretary of El Rodeo's student

council from sixth to eighth grade, had his eyes set on a larger seat at the table.

"I saw a Board meeting and saw the power that the student board member had and their ability to represent the students on a larger level which is why I initially got involved in student council," Ramer said. "I immediately knew that is what I wanted to do, I want to be able to better the lives of my classmates on a larger scale than I had before and this is the ultimate expression of that."

From hosting open forums during lunch to establishing a student advisory committee, Ramer hopes to be the connecting communication channel between the board, administration and students of all grade levels.

"I hope to establish a little bit more of a platform when I form the student advisory committee which will essentially be a group of students from the high school and the middle school, for all grade levels, that will help back me on the issues most pertinent to the student body," Ramer said.

Ramer hopes to collectively represent the district's student body and amplify their voices on matters or concerns, such as the new bell schedule for Beverly High.

"I do know that the majority of students prefer the block schedule to the full day schedule that we used to have, so that's a definite benefit," Ramer said. "Some people are not the happiest about the lack of a zero period because they think they will be at school too long or it doesn't give them the option to take as many classes as they wanted to and those are generally the extremely high achieving students who take seven or eight classes."

Ramer appreciates the small size of the city's district because it comes with a relatively close line of communication between students and the district or administration. However, he wants to ensure that student voices are heard on issues they care about.

"As a benefit of a small district like our own is that students are able to talk to school and district administration on a pretty frequent basis or whenever they want just because of the size of our district," Ramer said. "But I want to make sure that those voices are truly heard and understood by both the board and the administration so that they are able to have a true impact on their education as they are the most important stakeholders in it."

### Next BH Plan for First Thursdays Events

After the summer block party was cancelled last year due to COVID-19, this year the Next Beverly Hills Committee hopes this First Thursdays series will re-energize and revitalize the community and its residents. Although no date has yet

been set, Next Beverly Hills Chair Noelle Freeman hopes their First Thursdays experience will begin after their next July 22 meeting.

“The goal is to deploy a street team to get city-wide participation,” Freeman said.

At the committee’s June 17 meeting, three concepts were proposed to rejuvenate the city in a post-COVID-19 era. Committee Vice Chair Tiffany Davis presented a First Fridays program and partnership between local merchants, restaurants and or galleries, a Beverly Canon Gardens gathering where residents come together with food and beverage vendors, or close a street with less traffic such as Brighton Way for food trucks and “elevated games” for family friendly fun.

“First Thursdays will be a great way to reenergize the city after the pandemic in a way that benefits residents and local businesses alike,” Business and Economic Impact Co-Chair Noah Eteessami said. “Families and residents of all ages can enjoy quality time together in this unique setting, and businesses can take advantage of the increased foot traffic First Thursdays will bring them.”

Albeit not on the day originally proposed, the committee was in agreement that closing streets for the first Thursday of each month is a way the city can look a little more lively while stimulating local businesses and bringing the community together again after more than a year of social distancing.

## Eight Fern Pines to Line Beverwil Drive

The Water Bureau Program is expected

to present to the Public Works Commission a clean report on drinking water quality for the city at their July 8 meeting. The commission will also discuss the installation of non-native Fern Pine trees along eight vacant lots on Beverwil Drive to replace the Ficus trees that were previously removed due to infrastructure damage and public safety.

The Fern Pine, which isn’t even a pine tree, is native to east Africa according to the staff report. The trees provide shade, textured landscape and do not attract insects or disease. Mature trees can grow up to 60 feet high and 40 feet wide, but roots tend to not be a problem. When first installed, the Fern Pines will be approximately 10 feet tall.

Fern Pines have already replaced old Ficus trees that were removed after the invasive roots caused infrastructure damage and public safety concerns along North Arden Drive. According to the staff report from the Urban Forest Manager, approximately 18% of the original Ficus trees that were planted on Beverwil Drive have been lost or removed due to outgrowing their boundaries and damaging nearby public and private infrastructure.

For eight new Fern Pine neighbors it will cost approximately \$14,000 which will be funded through the existing CIP allowance through the Street Tree Master Plan program.

## Instructional Coach Hired for BHUSD Teachers

Education Services presented the Learning Control and Accountability Plan for the 2021-2023 school years to the BHUSD Board’s June 22 meeting. One item included in the plan is a new position for an Instructional Coach.

This position was created to help mentor new teachers in the district in areas like classroom management, grading, teaching strategies and whatever additional support they need.

Educational Services has hired one Instructional Coach who will start in the middle of July.

“The design of this position is really purposeful and this person is spread really thin,” District Superintendent Michael Bregy said. “Ideally, we would like to be able to have multiple instructional coaches. We know that our eye for coaches exceeds our expectations, they are exemplary and they act as coaches and that model works.”

Included in the 2021-2023 Learning Control and Accountability Plan, or LCAP, are two overall goals: consistent student growth in all academic areas and the district creating a culture where students and classrooms across all grades experience professional, high-level instructional strategies and practices.

The strategic plan presented to the board includes specific areas listed in the three year plan such as learning targets, college and career readiness curriculum, internal SAT/ACT assessments, instructional coaches, AirTutors, National Board Certification, personal protective equipment and helping families in need whether it’s providing funds from Student Services, covering the cost of field trips or college applications.

## Residence Style Review Postponed

A request for the city’s Design Review Commission to study the Central Area’s neighborhood residential buildings to ensure the welfare and conserve the community’s value was presented at Thursday’s meeting.

The commission came to a general consensus and moved to discuss the designs and stylistic guidelines at a later meeting in August when the new commissioners join, with some “tweaking,” according to Commissioner Terri Smooke.

“Almost anything can be approved the way I’m reading the document and I be-

lieve that we have had buildings erected in the city that really don’t follow harmony,” Smooke said. “It’s troubling to me because we work so hard at trying to keep the city as it was intended for this commission to do. But I think it’s too elastic, too porous and too many properties are being built that really don’t follow this.”

When the City Council voiced concerns over new residential developments being built, they adopted an ordinance in 2004 to require design review for single-family homes in the Central Area and approved a Residential Design Style Catalogue that offers a variety of traditional architecture developers, architects or applicants may choose from.

The pre-designed residences from the Style Catalogue qualify for an expedited review called Track One. Track Two design reviews are managed by the Design Review Commission. These are designs that do not comply with the stylistic guidelines of Track One projects.

Any designs or projects the commission reviews must notify neighbors within 100 feet of the property’s project so residents may provide input to the Design Review Commission. This review process is intended to create rapport or a relationship between old neighbors and new neighbors.

## Library Accepting Donations, By Appointment

The Beverly Hills Public Library is now accepting donations, but in order to drop off your books, DVD’s or dictionaries you have to make an appointment.

Donations must be properly packaged in boxes or bags and the library will not accept any items that are damaged, dirty, warped or missing pages. Other items not accepted include magazines, activity books, directories or already opened software sets.

## Boosting Beverly Hills Tourism

At the June 30 Marketing Liaison Committee meeting, the Conference and Visitors Bureau presented this year’s marketing programs that the city allocated over half a million dollars to in hopes of promoting Beverly Hills and enticing tourists to visit and stimulate economic recovery. The “As You Wish Amplification” and “Visit California” Expedia Co-op campaigns were the top ticket items, costing \$230,000 together.

The “As You Wish” campaign ran from March 15 to June 30 and highlighted the variety of personalities and styles found in Beverly Hills through representative canine residents. The partnership with NBC SoCal Broadcast resulted in over 4 million impressions and reached 26.5% of the total available audience. One of the animal ambassadors, “Bently,” toured the city with television host and entertainment journalist Danielle Robay April 12 to May 23.

The city spent \$100,000 to advertise the “As You Wish” campaign with the luxury advertising firm, Sojern, to increase their audience reach. Over 21 million impressions resulted from Sojern’s marketing as of June 30.

“CVB does incredible jobs with your campaigns. They are always out of the box and creative and visionary,” Vice Mayor Lili Bosse said. “I think what you have shown us today is in keeping with that.”

Other avenues the city advertised it’s shopping, dining, arts and culture via video promotions, press releases, social media and other news outlets, such as AP News and CBS-16.

Other campaigns the city will run this year include “Far From Ordinary” for the summer, “Cooler Than Fall” and a holiday campaign towards the end of the year. However, that campaign has yet to be named because the agency charged with naming each campaign has yet to come up with a non-denominational headline.

These seasonal campaigns will utilize coordinated color blocks and “diverse models and typography for a strong visual aesthetic,” according to the presentation from the June 30 meeting. This seasonally-colored concept is what the board chose.

The vintage Beverly Hills shield that will be used in the seasonal campaign is typically black and white, or gold and white. Bosse described these colorful seasonal shields as “Andy Warhol-esque with a Beverly Hills twist.”

Mayor Robert Wunderlich suggested that the CVB campaign and the Rodeo Drive Committee’s holiday decorations be tied together with Rodeo Drive’s theme of returning to tradition.

“I could picture for the yet to be determined logo for the holidays something along the lines of ‘Holiday Traditions, The Beverly Hills Way,’” Wunderlich said “It ties into using the vintage shield, the tradition with a twist, but with a freshening up by using the different colors.”

## Farkus Named New Jewish Federation CEO

Rabbi Noah Farkas was named new President and CEO of The Jewish Federation of Greater Los Angeles on June 30. His term will begin Jan. 1 next year, but Farkas will start his work with the federation this November.

Farkas currently teaches, preaches and leads strategic development at Valley Beth Shalom in the San Fernando Valley. He has also served as commissioner for the Los Angeles Homelessness Services Commission since 2015 where he participates in making budgetary, funding and planning program policies.

“I am overwhelmed with gratitude to have been selected,” Farkas said. “The Federation is uniquely positioned to foster

a flourishing Jewish community and it is a gift to have been asked to serve. I look forward to many years together moving boldly into a future that is both dynamic and caring, but is most of all filled with a spirit of cooperation.”

Current President and CEO Jay Sanderson, who has held that role since 2010, will finish his tenure through Dec. 31 of this year.

## Connecting Bicycles and Beverly Hills

The “Connect Beverly Hills: Meet Me on Wilshire and La Cienega” project advisory committee proposed last May to link commercial corridors with sidewalk amenities and “character zone” districts that will elevate pedestrian’s walk through the boulevard, as outlined in the staff report presented to the Traffic and Parking Commission at their July 1 meeting.

The Architectural and Planning Commission were consulted by city staff to review the plans and designs for the project because the streetscape design is traditionally associated with their purview.

According to the advisory committee’s report, there were several changes made to the project’s final plan in response to stakeholder and PAC feedback, such as adding raised crosswalks to increase pedestrian visibility, sidewalk-level protected bike lanes as a future project, “expanded” options to bus or bike lanes and clarification on color standards that define different zones for traffic.

“I love the new options for Wilshire, especially where we have the same level for the bikers. I do hope that we do get to a point that we can adopt some of those,” TPC Chair Nooshin Meshkaty said. “I look forward to seeing the type of technology implementation we’re bringing because that is key for a developed city like Beverly Hills, that it is supposed to be on the leading edge of technology.”

City staff recommended that the TPC review the Final Plan and present it to the City Council for adoption and approval. The council anticipates considering the final proposal at their July 27 Study Session.

## Sunshine Task Force Addresses Various Issues

The city’s Sunshine Task Force Committee met June 28 for a brief meeting to discuss updates on save the date notices, means and method plans to educate residents or property owners

about construction plans and cleared up some confusion surrounding the reconvoation ordinance and what subcommittee legislative advocates are supposed to report to.

One item that was ready and approved to move forward was the access to building plans ordinance, according to Beverly Hills City Attorney Larry Wiener.

“This ordinance has actually been drafted and I suggest we agendize it for the next Sunshine Task Force meeting if there’s nothing else that needs to be addressed on an urgent basis,” Wiener said. “But this one is ready to come forward.”

Committee member Debbie Weiss agreed with a public comment requesting that the reconvoation ordinance needs more time and eyes on it.

“I would like to see the revocation ordinance go back to the subcommittee, get tightened up and also move forward,” Weiss said at the meeting.

The committee came to a consensus that revocation ordinance would not go back to a subcommittee of Sunshine Task Force members and instead will have it’s own subcommittee to correct and clarify the language used and then report directly to the City Council.

Wiener suggested, “if it’s coming back to the original subcommittee meeting, then shouldn’t we just invite the legislative advocates to that committee since it’s open anyways? I think the idea was we will get the same reaction at the council meeting to this, from the legislative advocates so we might as well just do this at the Sunshine Task Force, get the legislative advocates involved so that when it gets to council it’s ready to go one way or another.”

## \$3,000 Scholarships to Three Beverly High Students

Three local Beverly Hills High School students received The David Heiferman Memorial Award and \$3,000 scholarship stipend from the Beverly Hills Education Foundation on June 29. The recipients and recently graduated seniors Mia De Castro Basto, Ricky Lee and Alana Perkins all plan on attending a university in the fall and continuing their academic career in higher education.

The Heiferman’s nonprofit organization was founded in 1990 in honor of David Heiferman, who was a BHHS alumnus. His mother, Annabelle Heiferman, was

mayor of Beverly Hills from 1984 to 1985. The Heiferman family fund was established over 30 years ago to propel students towards education rather than face a barrier, such as student loans and debt.

“As a family, passing on hope and resources to students is something David and we all want to accomplish,” former Board of Education member Dana Tomarken, foundation trustee and David’s sister, said.

Basto plans on attending Barnard College at Columbia University, Ricky Lee will attend Santa Monica College and Alana Perkins, who also goes by her stage name Alana Morgan, has committed to the University of Florida for the fall semester.

## DCS Celebrates 27 Years of Service

Communication is key, especially during an emergency or disaster. After the 1994 Northridge earthquake knocked out the city’s Water Department radio system, Disaster Communication System (DCS) founders retired officer Ron Derderian and detective Richard Schwab formed the organization.

Operating as a multi-purpose department, overseen by the BHPD, this group of volunteers has been in action for 27 years. Volunteers donate their time, equipment and expertise to fill in the communication

lines when they’re severed or damaged.

Their duties include recovering missing persons, burglary suppression and assisting other emergency responders like the fire department and fire watch. Volunteers undergo quarterly meetings and emergency response training that covers disaster preparedness, CPR/CERT/first aid, extended operating conditions (EOC) and radio communication with the city’s radio system.

The team behind DCS are available 24 hours a day and collectively have given over 50,000 hours of service. Members of DCS include representatives from different departments within Beverly Hills, such as BHUSD, city commissioners, local residents and community leaders. Some DCS members include previous mayors Les Bronte,

Ed Brown and Fire Chief Greg Barton.

The DCS is not currently accepting new members due to COVID restrictions, but Health and Safety Commissioner Lee Hilborne is ready to return to action.

“I’ve got the radio here,” Hilborne said. “So I’m waiting for the hiatus to be over and will be happy to join and be part of it.”

## Concerts on Canon Return, Virtually and In-Person

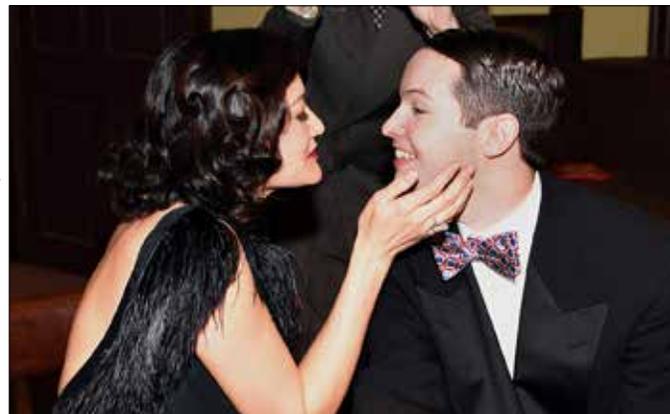

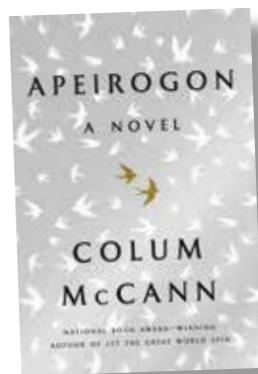

## SUMMER READING

### What Are Your Neighbors Reading

Librarian Karen Butthas cataloged and cared for the books that fill the shelves in the Beverly Hills Public Library since 1983. She first began as a backoffice librarian, cataloging books but has continued reading and serving the community for almost three decades.

Since it's opening in August of 1965, the city's public library has been renovated, redecorated and provided resources for all ages. Engaging with the community is key and one annual activity for all ages aims to do just that; the Summer Reading Club.

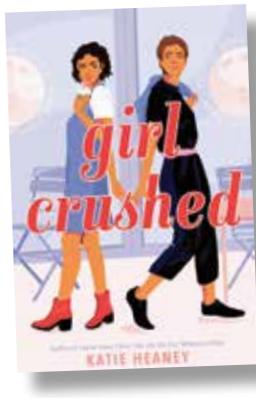
For this year's Summer Reading Club, titled "Reading Colors Your World," kids, tweens, teens and adults are welcome to join the 6-week program. For their biggest reading program of the year that started July 1 and will run until Aug. 6, the library offers in person or online activities, even prizes are up for grabs after completing a book or activity.

"This is always the biggest program for us in the year," Butth said. "We'll be starting planning for [next year's] in about six weeks, so as soon as this one ends."

Those interested in joining the summer reading program can register online and track their progress with a system called [Beanstack](#), or register in person in the library. This online program allows readers to record how many books they have read, how many hours they've read for, what activities they have completed.

Another reason why they chose to use Beanstack is so they can compile a list of all the books people have read throughout the summer and display it for others to see.

ple have read over the summer so that others can have the chance to see what other people thought was great," Butth said.

Other incentives such as prizes will be awarded to those who have first completed five hours of reading, then after 10 hours of reading they can choose one free paperback book. Tweens and teens are allowed to participate in other virtual programs, such as Intro to Quilling, a Color Wheel Challenge, weekly online trivia and a guessing jar where the best guesses win a prize.

Butth is currently reading "Apeirogon," by Colum McCann and the recipient of the 2020 National Jewish Book Award. The fiction follows the friendship between two unexpected men, one from Palestine and the other from Israel.

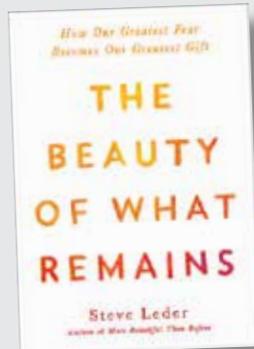
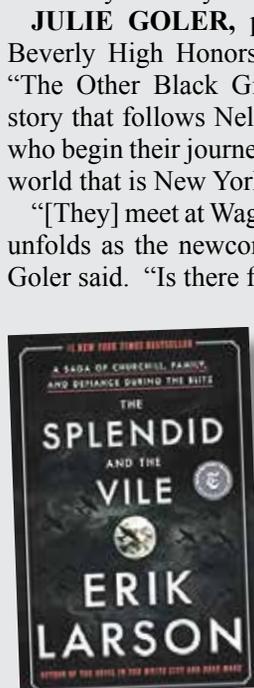
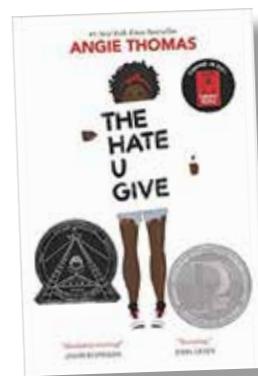

Harris offers up painful social commentary and leads the reader on all kinds of twists and turns in this elevated literary novel."
