

City Council Approves Commission Reappointments

At their Tuesday Study Session the City Council reappointed Charitable Solicitations Commissioner Jodi Galen, Cultural Heritage Commissioner Marc Teren, Health and Safety Commissioner Lee Hillborne, and Public Works commissioner John Millan to serve a second term.

The commissioners' first two-year terms are ending on Dec. 31 and they are eligible for reappointment to a second term of four vears.

Beloved Entertainer Philip Margo Passes

Entertainer Philip Margo passed away on Saturday at the age of 79.

Margo was a multi-media entrepreneur who, along with his late younger brother Mitch, were founding members of the Tokens. Their #1 hit, "The Lion Sleeps Tonight" is still widely played and is one of the best known songs of the 1960s.

Born in Brooklyn in 1942, Margo attended Abraham Lincoln High School, where the band was formed.

It was a music teacher, Margo would tell his audiences, who first told him he had musical talent.



Margo and the Tokens had several gold records as recording artists including such hits as "Tonight I Fell In Love," "I Hear Trum-Blow," pets and "Portrait of My Love."

acts such as The Chiffons ("He's So Fine," "One Fine Day,"), The Happenings ("See You In September," "I've Got Rhythm,"), Randy and The Rainbows ("Denise") and Tony Orlando and Dawn ("Candida," "Knock Three Times," "Tie A Yellow Ribbon"). Though having their roots in Doo-Wop, the Tokens expanded their musical horizons with successful releases spanning four decades including Intercourse in 1968, Cross Country in 1973, Re-Doo-Wopp in 1988 and Esta Noche El Leon Baila in 1996.

The Tokens became a family business as Philip and Mitch continued touring with various offspring through 2017. Philip's son, Noah, toured with the group as a drummer and musician for twenty-five years along with close friends Jay Leslie, Mike Johnson and on occasion Philip's daughter Neely. Philip even got the chance to perform with his grandsons Solomon and Ethan, including appearances at the Beverly Hills Concerts on Canon.

In 1978, Margo moved his family to California, spending over a decade managing the career of Robert Guillaume at the height of his Emmy award-winning show

"Benson." Margo wrote and produced television movies for both Guillaume and Gary Coleman, including a string of successful films such as "The Kid With the 200 I.Q." and "The Fantastic World of D.C. Collins." He also co-wrote and co-produced "This Wife for Hire," as well as "The Goddess of Love." Margo never stopped writing as he published his first novel, "The Null Quotient" in 2010.

Margo took an interest in local politics, running for the Beverly Hills City Council in 1997 and 2001.

"If you hang around long enough," Margo often said, with regard to performing with his children, nephews, and grandchildren, "you can grow your own band."

Survivors include his wife of over 50 years Abbie, sister Maxine, children Board of Education Member Noah Margo, Joshua Ginsberg-Margo and Neely Margo Irwin; their spouses Laura Hornwood Margo, Lynn Ginsberg-Margo, and Daniel Irwin; nephews Damien, Ari, and Elon; and eight grandchildren.

Board of Education Discusses Adding New Graduation Requirements

At their Nov. 9 Board of Education meeting the Board discussed adding new graduation requirements for high school students, including taking at least one AP Exam and requiring students to apply to at least one four year university for graduation.

Board member Noah Margo put the item onto the agenda to increase student rankings.

According to US News and World Report, Beverly High ranked in the top six percent at 1,116th nationally out of 17,857 high schools nationally. Beverly High also ranked in the top six percent in the state taking 164th place out of 2,598 high schools. In the county Beverly High ranks in the top 11% scoring 75th out of 659 schools.

"If we want to be the district that we keep saying we're going to be, kids should want to take the AP class. They should be ready for it when they get to high school and they should want to take them. Not to improve our rankings but to challenge themselves. Because in the end, that's what's going to better their education," Margo said.

The board also discussed covering the cost for AP exams and college applications to decrease the burden on students.

City Council Approves Plaque in Honor of Vahagn Setian

At their Tuesday meeting the City Council approved a request for a landscape boulder and plaque in recognition of a donation made in honor of Vahagn Setian, by the Vahagn Setian Charitable Foundation next to a tree being planted at Roxbury Park.

On Nov. 3 city staff met with Recreation and Parks Chair Susan Mishler and Vice Chair Amie Sherry to discuss the proposal. Both Mishler and Sherry support the proposal and the work that the Setian family has provided to the community.

The tree being planted was selected as part of the annual Arbor Day programming that was pushed back due to the pandemic. The dedication of a plaque affixed to a boulder to scale was proposed for this event. Donations made by the Vahagn Setian Charitable Foundation will go to support the planting of trees by the Urban Forest Department in Public Works.

The Vahagn Setian Charitable Foundation was established after Vahagn, a Beverly High senior, was killed in 2006. The Foundation originally started their contributions to the community by providing musical instruments to children whose families could not afford to purchase one of their own. Karén Setian, his father, has since said he then realized that the core of the Foundation's work should be to address decisions children make.

City Council Discusses Nighttime Weekend Closures of Rodeo Drive

At their Tuesday meeting the City Council discussed a request by Councilmember Julian Gold regarding the possibility of closing Rodeo Drive from Wilshire Boulevard to South Santa Monica Boulevard on weekend nights from approximately 11:00 p.m. to 6:00 a.m. This closure would affect vehicular traffic only and not pedestrian

travel.

From Nov. 1, 2020 to the present, the Beverly Hills Police Department (BHPD) has received about six calls for service on Rodeo Drive regarding unruly and loud groups of bicyclists and cars.

This past Halloween, it was reported that a group of about 150 bicyclists were physically fighting at North Cañon Drive and North Santa Monica Boulevard. When police units arrived, the crowd dispersed and they rode south on Rodeo Drive.

After Police Officers conducted their investigation, they determined two individuals had been involved in a physical altercation with one another and no serious injuries were sustained by the victim.


If the City Council gives direction, the BHPD can work with city departments and close Rodeo Drive from Wilshire Boulevard to South Santa Monica Boulevard on Friday nights beginning at 11:00 p.m. and reopen on Saturday mornings at 6:00 a.m., and repeat the closure as requested for Saturday nights and Sunday nights for a schedule determined by the City Council.

The recommendation to this plan is to include a Traffic Control Officer (TCO) at each closed location to increase visibility of the closure by using their traffic control vehicle and to immediately move a barricade in the event an emergency vehicle needs to make entry into the closed area.

The cost of having six TCOs on special assignment for seven hours per night would cost approximately \$3,276. The total Police Department cost for a weekend closure of Friday through Sunday nights would be \$9,828.

Rent Stabilization Commission Discusses Habitability Standards

At their Nov. 3 meeting the Rent Stabilization Commission discussed possible amendments to the Rent Stabilization Or-

dinance regarding habitability standards, proactive inspections, a mediation board to address habitability violations, associated rent reductions, and to restrict rent increases.

One of the duties of the commission is to make recommendations to the City Council concerning amendments to Title 4, Chapters 5 and 6 of the Beverly Hills Municipal Code (BHMC) that have not been resolved by the City Council. The matter regarding Beverly Hills habitability standards, proactive inspections, a mediation board to address habitability violations and associated rent reductions, and to restrict rent increases are all matters that have not been resolved by the City Council, and are included in Chapter 5 and Chapter 6 of the BHMC.

State regulations provide habitability standards. The City Council discussed that these standards are limited and suggested standards that exceed the state standards.

Beverly Hills currently has a complaint-based inspection process. The City Council discussed a proactive inspection process. Two types of proactive inspections that could be implemented are: a self-certification process or a proactive inspection process.

The City Council discussed the creation of a mediation board, possibly the Rent Stabilization Commission, to determine habitability violations and associated rent reductions. If the commission recommends a mediation board, the commission could consider whether they would work as a mediation board to assist the parties to mediate their habitability concerns, or whether the commission would work as an administrative board hearing habitability matters brought by parties such as the tenant, landlords or the city.

The City Council also asked the commission to discuss restricting rent increases if the property has habitability violations. The commission could recommend that the ordinance be amended to restrict the owner of the property from demanding, retaining, or accepting an annual rent increase if the property has not complied with all of the required habitability standards.

The commission will continue the discussion at their Dec. meeting.

Public Works Commission Provide Burton Way Median Update

At their Nov. 10 meeting the Public Works Commission provided a status update on the Burton Way median project construction and Public Works' Demo Garden educational program.

The Burton Way median project is currently in construction and was identified in the stormwater compliance program as a candidate site for a green streets project to demonstrate the functions of a water efficient landscape to the community.

The project is to ensure that the city complies with the regional National Pollutant Discharge Elimination System (NPDES) stormwater permit and water conservation regulations. The project consists of the installation of two 15 foot wide infiltration swales, which spans the entire length of the project, to assist with groundwater recharge and enhance the groundwater supply in the city.

The project also includes the replacement of 3.7 acres of median turf with drought tolerant plants to reduce potable water use as part of water conservation efforts. The project includes construction of an underground storage reservoir to store the captured storm water runoff.

According to the staff report, when the project is completed, it will have the capability to irrigate the entire median with captured urban runoff, to allow the median to be 100% self-sufficient by eliminating the need for potable water use.

The project concept was first envisioned in 2016 as a result of the newly adopted regional NPDES permit and water conservation regulations, and the design was completed in Jan. 2020, but was placed on hold pending grant application announcements. In Jan. 2021, city staff presented the re-

sults of the grants to the commission. Staff was then directed to advertise the project for bidding.

In May the city received six electronic bids and recommended the award to the lowest bidder, Los Angeles Engineering, Inc. for \$10,175,000.

The Demo Garden will be used to provide water wise landscaping education to the community by displaying the plant palette and posting it on the city's website.

Planning Commission to Discuss Development Plan Review

At their Thursday meeting the Planning Commission is expected to discuss a request from SVAP II North Beverly, LLC, for a a Zone Text Amendment to amend certain sections of the Beverly Hills Municipal Code (BHMC) related to alternative parking facilities, a Conditional Use Permit to allow an alternative parking facility to meet the parking requirements set forth in the BHMC, a Development Plan Review to construct a new three-story commercial building with an alternative parking facility, and participation in the In Lieu Parking program for 28 in-lieu parking spaces.

The property is located at 317 North Beverly Drive.

The project is located in the Business Triangle and covers a single lot. The site is currently built with a two-story, multitenant building. A parking lot is located to the rear of the project site, adjacent to an alley, with space for 10 vehicles.

The existing building was designed by Allen G. Siple who is listed on the list of Local Master Architects. A review of the Historic Resources Technical Report determined that the integrity of the property has been lost due to substantial alteration and is therefore not considered a historic resource and does not meet the criteria for local landmark designation.

Twelve vehicles can be accommodated in the proposed parking facility, however, the total parking required for the building is 41 spaces. The applicant has requested to participate in the In Lieu Parking Program to satisfy the requirement of 28 spaces.

The City Council approved a pilot program in 2016 for alternative parking facil-

ities that would allow the Planning Commission to approve up to two applications for these facilities through a conditional use permit. The first application was approved for a restaurant use at 250-260 North Cañon Drive; the second application and public emergencies, including the risk of death, property damage, and social and economic disruptions. The Safety Element includes policies and goals that outline preparedness methods to address risks associated with wildfires, floods, geologic

approved was for the Chanel project located at 400-408 North Rodeo Drive.

However, the project at 250-260 North Cañon Drive has since expired and, therefore, the current application at 315 North Beverly Drive would be considered the second application.

Planning Commission to Discuss Safety Element Update

At their Thursday meeting the Planning Commission is expected to discuss an update on the Safety Element as well as proposed changes.

California requires every city to have a Safety Element in its General Plan. Beverly Hills' current Safety Element was adopted in 2010 as a part of the comprehensive update of its General Plan. The Local Hazard Mitigation Plan for 2017-2022 was adopted in 2019 and is included as part of the existing Safety Element of the General Plan, according to the staff report.

The General Plan is a long-term document that guides the development of the city, addresses issues affecting the region and city, and sets forth its priorities for initiatives and programs through the various goals and policies of each element.

The Safety Element specifically looks at how to reduce and plan for the potential risks associated with natural disasters, wildfires, floods, geologic and seismic hazards, hazardous materials, noise, and man-made disasters.

According to the staff report, the Local Hazard Mitigation Plan is a subsection of the Safety Element that looks at the activities that may be able to reduce risk and prevent loss from future hazard events. This anal-

ysis is considered to be the first step for disaster prevention and allows the city to be eligible for federal mitigation funding when disasters occur and to apply for mitigation grants used prior to disaster events. The mitigation plan also includes a variety of resources to assist city departments, residents, and private and public organizations in planning for disasters and hazards.

The city is preparing an updated draft of the Safety Element. The update is taking place at this time due to state law requirements, and the revised Safety Element will include changes and information required by recently adopted laws.

The Planning Commission is expected to provide input and comments that may be incorporated into the draft Safety Element document. The commission will be presented with the draft at a future meeting.

City Council Approves Lease Agreement for Snack Bar at La Cienega Park

At their Tuesday meeting the City Council approved a lease agreement with Destomil LLC for a snack bar at La Cienega Park.

The 100 square feet concession stand in the park is currently vacant. Destomil LLC currently owns and operates Blasteran, a

A five year contract for Bond Management Services between the BHUSD and Don Blake's Team Concept Development Services, Inc (TCDS) has been listed on the Board of Education agenda twice without approval, underscoring the difference in opinion on the board about the performance of the district's ongoing construction program.

Blake has been in charge of the BHU-SD construction projects since 2017.

TCDS is referred to in the agreement as the "Bond Manager" or "BM."

According to Article 1, section 1.1.1, of the proposed contract, the "BM *"With close to \$400*

[Blake] represents that it has the capabilities and skills in program supervision, bid evaluation, project scheduling, claims review and negotiation, project design review and evaluation, and general management

and administration bond management and related capital improvement program as set forth in Government Code section 4525, et. seq."

However, this exact Government Code requires a valid license. According to the State Contractor's Licensing Board, Blake's contractors license expired in Nov. of 2000. In this same section of the agreement, it also states that "nothing in this Agreement inclusive of its Exhibits shall be constructed as a request by the Owner [the district] or an agreement by Bond Manager to conduct any activity that requires or may require a contractor's license."

It is unusual to allow a Bond Manager with an expired license.

BHUSD attorney Terry Tao wrote the contract, even though he has a retainer agreement with the BHUSD.

Tao and Blake worked together previously in another school district prior to BHUSD

Why would Tao write a contract for an independent contractor that is working with the district when he is supposed to be representing the district? Why did Tao not recommend the district have outside counsel to draft the contract?

According to the contract, there is

also a "Project Management Fee" where Blake is compensated 2.5% of the total construction costs for projects. Construction Cost refers to "all costs less the compensation of Bond Manager, Design Professionals and other consultants, general conditions, the cost of lands, rightsof-way, inspections, surveys, tests, and other costs which are the responsibility of Owner [the district]," as stated in the agreement.

With close to \$400 million in bond funds to be spent, the commission is significant, and totals several millions of

dollars to Blake.

The previous construction company retained by the board, Totem, had no such commission agreement. significant, and totals

If approved as written, the agreement with Blake would last for five years. It is highly unusual for a

school district to have a contract this long. Even the superintendent cannot receive a contract for longer than three years, with a maximum 18 month buyout.

Opponents believe such a long contract for Blake is the first step in then asking voters to approve another \$400 million + bond next year, which would push total school construction spending in over the last 30 years above \$1.3 billion.

In fewer than 30 years, several boards of education have spent slightly under \$1 billion on BHUSD school construction. (See chart)

On Oct. 21 the Board of Education held a special Study Session for a Master Plan update and executive summary to confront the financial challenges faced from implementing the plan.

In 2017 \$750 million in projects had been submitted to the Division of the State Architect (DSA) for approval when the District had bonding authority of \$334 million.

By July 2017, \$189 million had been spent; one new building had been constructed at Horace Mann School by Totem and an existing building which was undergoing modernization.

MTA was also planning to extend its subway under the high school and the district pursued an unsuccessful and highly costly lawsuit against them. There were 19 active oil wells on the high school that became the district's responsibility and an additional seven legacy wells needed to be located and

abandoned. Remediation cost upwards of \$42 million. While closing El

Rodeo School entirely for reconstruction in 2019 was supposed to expedite its completion and save money, the opposite actually proved to be true: the new campus is now not scheduled to open until late 2024, two years later than promised.

The Board also discussed the impacts of the market in the last

six months on the Master Plan. Blake said that from 2018 to Oct. 2021, project cost estimates have increased by 22%. For example, in 2018 a sheet of plywood was \$18. Today it costs about \$100. Steel, drywall and other major commodities cost more than anyone's previous

expectations.

According to this new information, there is not enough funding to complete all construction projects as promised by Measure BH.

Two lawsuits have been filed against Tao in the past six years, including one which names Don

Blake's TCDS.

In June of 2019 a complaint was filed by Plaintiff iXero against Defendants TCDS and Tao, alleging that Tao ad-TCDS wanted iXero to "union bust," or get rid of district security personnel so that only outside armed guards of TCDS' choosing remained.

According to the

complaint, in 2018 iXero entered into a written contract with TCDS in which they agreed to provide, on TCDS's behalf, leading and comprehensive security services to the BHUSD. TCDS, however, breached the contract by failing to make the requisite payments under the contract and prevented iXero to access necessary information and to individuals within BHUSD.

It was further alleged that Tao, a non-signatory to the contract, had improperly interjected himself into the middle of the contract and interfered with the contract by instructing TCDS not to make the requisite payments under the contract and by making false statements about the iXero's performance under the contract.

According to the complaint, TCDS agreed to pay iXero pursuant to a

pre-agreed schedule of hourly rates and agreed to reimburse iXero for its costs in connection with the Security Services. The Agreement required iXero to invoice TCDS on a monthly basis for labor and reimbursable costs and provided TCDS with a five-day time period in

According to the complaint, in Oct. of 2018, TCDS began denying iXero rights and benefits to which it is entitled under the TCDS Agreement, including their

right to contact the BHUSD directly. In one example mentioned in the complaint, iXero requested to present updates directly to the school board. However. Blake refused their request, stating that he

would be the only one speaking to the board in regard to the security services.

iXero claims they could not complete in a timely manner the security services in connection with a contemplated cyber security program because it needed specific technical specs and details from the BHUSD's IT Department. Blake denied their requests to speak directly with the IT Department, and did not respond to their attempts to pass the requests through Blake. This allegedly caused avoidable delays in connection with the completion of the cyber security program.

The complaint further states that though iXero hosted and performed a successful detailed training exercise contemplated by the TCDS

Agreement and attended by the Beverly Hills Police Department, Blake prohibited from them participating in any further training exercises un-

"In or around April 21, 2019, possibly in retaliation for Plaintiff's [iXero] refusal to help fire union security guards, TCDS began improperly withholding payments to Plaintiff under the TCDS Agreement," the complaint alleges.

On May 6, iXero was issued a termination letter containing "multiple unfounded allegations against Plaintiff [iXero], including that Plaintiff improperly billed TCDS for marketing materials produced for Plaintiff's use and that Plaintiff's workers were not qualified to perform the Security Services," according to the complaint.

Tao was dismissed as a defendant in Aug. of 2019, and BHUSD was added as a defendant in Dec. of 2019. The Tao Firm then represented BHUSD in the lawsuit.

presented a revised General Fund financial forecast for fiscal year 2020-21 which, based on information available at that time and taking into account the significant impacts from the pandemic, resulted in an estimated year-end deficit of about \$2.7 million.

City staff has since executed the transfer of a previously authorized City Council earmark of \$15 million from the committed General Fund balance to fund the Metro North Portal project.

There was also an \$11 million surplus between General Fund expenditures and revenues. After accounting for this transfer, the result is a total deficit of about \$4 million

Overall, General Fund revenues were about \$21 million above the forecast, and expenditures were approximately \$7.7 million higher than forecasted.

Based on the results for the fiscal year 2020-21, the city's total General Fund reserves of \$215.3 million, which decreased by about \$4 million from the previous fiscal year's total of about \$219 million.

This decrease was driven by the \$15 million transfer of the Metro Rodeo North Portal Station funding out of committed fund balance, and setting aside that transfer, there was an \$11 million increase to



concrete problem.

On Feb. 11, 2014, attorney D. Michael Schoenfeld contacted AALR&R and demanded that AALR&R withdraw from the Tehachapi Hospital District matter. AALR&R requested additional time to respond to these demands, according to the complaint.

fund balance, according to the staff report.

The economic/contingency reserve is comprised of about 40% of General Fund expenditures and is not supposed to decrease unless it is approved by the City Council. The City Council has also established a budget stabilization reserve that is available for a one-time deficit.

According to the staff report, the utilization of either of these reserve sources has not been necessary during the course of the pandemic.

Additional elements of total reserves include funds committed by the City Council for specified purposes or other restricted funds. This leaves an unassigned fund balance of \$28.9 million, above current restrictions, contingency, and stabilization reserves.

The City Council also approved a General Fund appropriation of \$100,000 requested for recruitment efforts to fill vacancies within the Beverly Hills Police Department (BHPD).

According to the staff report, there are a number of Police Officer and Communications Dispatcher positions to fill and through these recruitment efforts, the BHPD has found that traditional methods of recruitment are less successful than

City Council Approves Amendment to License Agreement for Use of City Shield

At their Tuesday meeting the City Council approved an amendment to the license agreement with Amiri for use of the city shield on apparel merchandise.

The city receives inquiries about the use of the city shield periodically. On Aug.

4, 2020, the City Council approved Atelier Luxury Group dba Amiri ("Amiri") to feature the shield in front of the Amiri logo in either black, pink or white print for a series of apparel items. On Feb. 16 the City Council approved Amiri to expand the use to feature the shield in a rainbow color scheme in front of the Amiri logo for a series of apparel items. On Sept. 14 the City Council approved Amiri to expand the use further to include a gold and purple color scheme.

The current license agreement with Amiri expires on Dec. 31. On Oct. 14 the Branding and Licensing Committee, including City Council liaisons Councilmember Lester Friedman and Councilmember John Mirisch, approved the proposal to move forward to be presented before the full City Council.

The license agreement with Amiri will extend the term of the agreement for an additional 12 months to expire on Dec. 31, 2022.




