I am writing to support the City's intent to pursue more dedicated bike lanes in Beverly Hills. Part of the City's approved Complete Streets Plan proposes protected bike lanes connecting our parks, schools and shopping areas. This is not an easy task since so much of our current space is dominated by cars, which makes riding a bike dangerous. It is easy to say that it can't be done, and that there are not enough people who ride bikes to make it worthwhile. But this is simply untrue; visitors to Paris have seen a city very quickly transformed to be a quieter, safer, and easier to navigate place with its many new added bike lanes. If they can do it, why can't Beverly Hills?

There are (at least) three excellent reasons why we cannot let our streets continue to be dominated by cars:

Safety. When cars rule the roads our streets often become pseudo highways, where speeding is the norm. Redesigned public streets with infrastructure for other modalities-cyclists, pedestrians, and public transit-- are safer for everyone—including drivers—because they calm the traffic down.

The climate change crisis is real and urgent. We need to encourage people to use other modes of transport that do not contribute to the warming and pollution of our city (and the planet). Young, and old alike are concerned about the future of our planet and want to live in vibrant, walkable, bikeable areas that are not car-dependent. The world is moving in this direction, and so should Beverly Hills.

The subway is coming. Like it or not, in a few years we will have two subway stops in Beverly Hills, and residents and visitors will need a way to get there by ways other than by car. Cycling is an ideal solution to the last mile issue.

The reasons to support bike mobility in our city are many: a boon to public health, cleaner air and quieter streets, budget-friendly transportation, fast trips, higher property values, independence for our youngest residents, and fun.

Retail Storefronts Windows Smashed

The Beverly Hills Police Department (BHPD) is investigating two overnight attempted burglaries that occured in the 200 block of North Rodeo Drive and the 9600 block of Wilshire Blvd that took place on Sunday.

Multiple suspects traveling in several vehicles descended on the locations and used a sledgehammer to try to break through front windows of Louis Vuitton and Saks Fifth Avenue.

No entry was made in both cases and BHPD Detectives are investigating this matter.

According to the BHPD, Beverly Hills Police units supported by armed private security have increased patrol in the area.

"Very little is known outside of this, but BPHD Detectives are still gathering video surveillance from the area," Lieutenant Gio Trejo said.

BHPD is also monitoring reports from neighboring communities regarding an increase in "follow-home robberies."

The department routinely monitors all residential neighborhoods with the added assistance of private security companies.

The BHPD wants to remind citizens to always remain aware of their surroundings and report any suspicious activity immediately. If you believe you are being followed, please call 911 and drive over to the Police Department at 464 North Rexford Drive. The BPHD urged residents not to engage or confront anyone who you suspect may be following you.

City Council Discusses South Crescent Permit Zone

At their Nov. 16 meeting the City Council discussed a recommendation from the Traffic and Parking Commission to approve a resolution modifying Preferential Parking Permit Zone "Q" on the 200 block of South Crescent Drive between Charleville Boulevard and Gregory Way with a regulation that states "No Parking Any-

time, Permit 'Q' Exempt."

On Feb. 6, 2020, the Traffic and Parking Commission reviewed a resident-initiated preferential parking permit (PPP) zone modification petition signed by 66% (25 of 38) of the households on the 200 block of South Crescent Drive.

The petition has requested modifying the existing permit regulation of "1-Hour Parking, 8 a.m. to 2:30 a.m., Daily, Permit 'Q' Exempt' to "No Parking Anytime, Permit 'Q' Exempt," to address commuter parking impacts from businesses, traffic impacts from Beverly Vista Middle School and driveway ingress/egress issues.

City staff recommended the Council approve the petition because 65% of the block residents requested the modification, similar PPP zones modifications on the adjacent 200 and 300 single-family blocks of South Cañon Drive were previously approved, the impacts from changing Beverly Vista School to a middle school and to create consistent parking regulations throughout.

According to the staff report, the 200 block of South Crescent Drive has 38 single-family homes with about 67 on-street parking spaces.

In April of 2019, the parking regulations in the adjacent 200 and 300 blocks of South Cañon Drive were modified from "1-Hour Parking" to "No Parking Anytime." The residents petitioned and were approved for a speed hump, with installation scheduled this calendar year pending availability of materials.

On Jan, 20 the city conducted a parking occupancy survey on the 200 block of South Crescent Drive from 8:00 a.m. to 8:00 p.m.

On average, 30% of the on-street spaces were occupied during the 12-hour survey period, with peak-hour occupancy of 42% recorded at 1:00 p.m.

A concentration of vehicles was observed on the north end of the street block. Between 3:00 and 3:30 p.m., city staff also observed vehicles parked and student pick-ups on the street block during the dismissal time for Beverly Vista Middle

School.

City staff also conducted random spot counts on Jan. 15 and 16 several times of the day and found an average of 21 vehicles were parked on the 200 block South Crescent Drive.

Similar observations were also found from doing spot counts after the return to in-person classes.

"Is it really a problem that can be resolved by more restrictive parking, or by enforcement by what we have already? Is more restricted parking really the solution? The status quo is one hour parking. There already is restrictive parking in place." said Mayor Robert Wunderlich.

Some public comments referred to employees of the school parking for longer than allowed and shoppers overstaying the one hour limit.

"That would be prohibited by the existing restrictions on that street. If those existing restrictions were enforced that would not be a problem. And making it even more restrictive, making it no parking, unless that's enforced, that would not be a solution," said Wunderlich.

The Council will revisit this matter at a future study session.

Residents Voice Concerns Over Proposed Changes at Virginia Robinsons Gardens

At the Nov. 16 City Council meeting many residents called in to voice concerns they had over proposed changes to Virginia Robinsons Gardens that the county is looking into.

The Virginia Robinsons Gardens is located at 1008 Elden Way.

The county is at the very beginning of the review process for the proposed changes and they have indicated that they intend to prepare a supplemental environmental impact report.

The Virginia Robinson Gardens is a historic estate that was built in 1911. It was once the residence of retail giants Virginia and Harry Robinson and is the first luxury estate built in Beverly Hills.

A virtual community meeting was held on Nov. 15 to discuss the proposed operational modifications at the Virginia Robinson Gardens. These changes are intended to allow greater public access to the facility, however, many neighbors believe it will have a negative impact.

Most of the property is under county jurisdiction and not under the authority of Beverly Hills. In terms of land use, the city does not have much say on what goes on.

Some residents mentioned how the county was proposing these changes to help serve underprivileged people and criticized how these changes would only benefit affluent people.

The proposed project would not include any demolition or construction on the property, but rather a change in the operation of the facility. Specifically, keeping

the facility open seven days a week and changing the hours for public use to 9:30 a.m. to sunset. The number of patrons in attendance will increase up to 200 visitors per day. In addition to existing events, the county will also consider family ceremonies such as weddings and increase the number of special uses from four to 24 special use events a year.

The city is planning on bringing an information


The applicant filed a request to extend the expiration date of the approved entitlements to Aug. 9, 2022.

A summary of this Ordinance follows:

The Ordinance renumbers an existing Article 5 (Cross Connection Control Program) of Chapter 1 of Title 6 of the Beverly Hills Municipal Code to Article 6.

The Ordinance also adds a new Article 5 to Chapter 1 of Title 6 the Beverly Hills Municipal Code entitled "Mandatory Organic Waste Disposal Reduction." The Ordinance will be effective and amendments to the Municipal Code will become operative thirty (30) days after its passage. Pursuant to Senate Bill 1383 ("SB 1383"), the California Department of Resources Recycling and Recovery ("CalRecycle") developed regulations ("SB 1383 Regulations") to reduce organics in landfills as a source of methane. The SB 1383 Regulations impose requirements on cities to adopt and enforce an ordinance to implement relevant provisions of the SB 1383 Regulations. As such, this Ordinance adopts requirements for (1) mandatory organic waste disposal reductions for single-family, multi-family, and commercial business organic waste generators, (2) commercial edible food generators, (3) food recovery organizations and services, (4) haulers (including selfhaulers and haulers that are solid waste enterprises), facility operators, and community composting organizations, (5) direct service providers and vendors regarding recovered organic waste product procurement, and (6) inspections, investigations, and enforcement by the City.

Theatre 40 actress Jean Mackie thought she would be donating a kidney to her friend. When she found out she was not a match, she ended up donating it to a stranger at Phoenix Mayo on Nov. 2

Mackie did what is called "pairing" which occurs when a kidney donor is incompatible with their preferred recipient but does match another person in the database. Because she donated her kidney to a stranger, her friend was also able to receive a kidney from another donor.

Mackie was paired with a recipient within three hours of being in the database. However, days before she went to Mayo for her surgery, she got a call informing her that her donee had gotten terribly sick and she was not able to do the surgery. They quickly found her another match.

"It feels even better because I got to help two people. And I find it rather exciting who that other person is. And my friend finds it rather exciting who she got a kidney from," Mackie said.

Mackie was not at all reluctant to give her kidney to a stranger and hopes to meet her recipient one day.

When people at Mayo asked her why she was donating a kidney she informed them that this was not even close to the hardest thing she has had to do. She said this was a "walk in the park" compared to giving up her addiction to alcohol.

"I'm in recovery for alcoholism. Seventeen years ago I was intervened by my family and I felt like I was kicked out of an airplane. I was being asked to give away the one thing that I thought I could at least make me feel ok about myself. Truth is, it was the best day of my life. My life is grand because I have been in recovery for 17 years," Mackie said.

Throughout her whole experience, Mackie was not nervous.

"The hardest part for me was actually telling my friend, because for me to pull out would have created so much shame," Mackie said.

Mackie is recuperating well.

"It's just a couple of days that you're really sore. I was even walking the first day, very slow, very hunched over. But it hasn't even been two weeks yets. I have zero pain. I am definitely tired at times because my one kidney is doing the job of two and kind of learning how to do that," Mackie said.

Her boyfriend, former Public Works Commissioner Steve Weinglass, has been very supportive of her decision.

This Thanksgiving Mackie is very grateful for this experience.

"Several doctors messaged me saying 'this is life transforming' they said you're actually allowing a person to have a normal life by doing this. There's just no price tag you can put on it. There's no check you can write large enough that would compare to the feeling it is. One of the biggest things is I can't get over how easy this was for me to do. You know I should have been kind of nervous, and I just wasn't," Mackie said.

Mackie was honored at the Beverly Hills Rotary Club on Nov. 15.

COURAGEOUS KID

On Nov. 7 ten-year-old Sophia Ucer, who is a fifth grader at Hawthorne Elementary School, was brought to the Cedars-Sinai Emergency Department thinking she had appendicitis, turns out she had an infected kidney stone which led to sepsis in her bloodstream.

"In the morning I woke up and my side started hurting, so we went to the hospital. We thought it was appendicitis but it

turns out it was a kidney stone and it got infected. I had to stay in the hospital for a week," Sophia said.

She went through an Ultrasound, CT Scan, and lots of blood work to try to determine the problem. The doctor determined she had an infection and needed to be admitted for treatment. She was scheduled for emergency surgery the next morning at 2:00 a.m. They placed a stent to help drain the infected kidney. The stent came out on Nov. 16 along with the kidney stone.

Her son will be turning six and her daughter will be turning four, both in Dec. She is working as a full time security coordinator for In-N-Out Burger and has been with the company for 12 years. She is also going to start school in the new year to become a LVN.

her experience was the pain and nausea she felt. After surgery, she could not eat or drink for four days. She was able to cheer herself up by looking at the art in the hospital.

"The art was really pretty. My mom and I would go on walks and see the art. It was fun," Sophia said.

Her mom Caroline Ucer says Sophia is very grateful to the team of doctors and nurses who helped save her life and for her new love of art. Sophia misses the team of doctors and nurses she had checking on her regularly and her art walks, but overall has a lot to be thankful for.

"I am grateful for being healthy again," Sophia said.

Sophia is looking forward to seeing her friends again once she has fully recovered.

BHHS Basketball Player Signs Letter of Intent

Forward Jac Mani has become the first Beverly High boys' basketball player to sign a letter of intent to accept a college scholarship while playing for the Normans since Chance Comanche signed with Arizona in 2014, according to Normans coach Jarvis Turner.

The 6-foot-9-inch Mani said he chose UC Davis over the seven other schools that offered him scholarships because "they wanted me the most, they cared for me the most."

"I felt I fit perfectly their system," Mani said. "The coach had a lot to do with it too. They were in contact with me every day. Coach (Jim) Les came to house a couple times."

Mani also made visits to the University of Denver, University of Montana and an unofficial visit to UC Riverside, who had all offered him a scholarship. He said he also received scholarship offers from the University of Portland, Cal Poly, Howard and Bradley.

Turner said he "reached out to quite a few schools" on Mani's behalf "but Jac also had some interest generated from him playing travel ball but what really provided a great opportunity for him was" June's Section 7 tournament in Phoenix the Normans played in.

Turner called Mani "a very skilled and very talented big man" with "a natural feel and understanding for the game" and "a high basketball acumen."

Les said Mani "has a rare combination of size and skill that will allow him to be an impact player at UC Davis for years to come.

"We have watched him grow as a player and believe he has the drive and ability to continue to improve on an already impressive skill set," said Les, who has coached the Aggies since 2011 after coaching at his alma mater Bradley from 2002-11. Les played in the NBA from the 1988-89 through 1994-95 seasons, including six games with the Clippers in the 1989-90 season.

Les said one reason he offered Mani a scholarship was that "he possesses the type of personality and character that we look for in the young men we recruit."

"I have no doubt he will have a positive impact when he arrives," Les said after Mani signed his letter of intent Nov. 11.

Mani attended Pressman Academy until eighth grade, spent his first two years of high school at Milken Community School, then transferred to Beverly High in part because of Turner.

"I knew that he would help me the most, help me to reach where I wanted to reach," Mani said.

Another reason was "I have a good chance of winning something at Beverly High," Mani said.

A difference between the schools is "they care more about sports at Beverly," Mani said.

"The teams you play at Beverly are more competitive than teams you play against at Milken," Mani said.

Mani had 25 points and 13 rebounds and junior point guard Jameson Caruso had 24 points and eight assists as the Normans opened the season with a victory over the Gorillas in a nonleague game at the Swim-Gym.

Mani, Jameson and Alex Nokes all scored in double figures as the shorthanded Normans won an intersectional game at the Swim-Gym Friday.

Beverly Hills played without one starter for nearly the entire game after he sustained a high ankle sprain in the opening five minutes while a reserve was not able to play because he was in a class with a student who tested positive for the coronavirus

"We didn't have quite the depth that we wanted to have but the guys were able to rally together," Turner said.




