

Community Members Voice Opposition to Bikeways

At the Dec. 2 Traffic and Parking Commission meeting several residents voiced their concerns over proposed bikeways for Charleville Boulevard and Gregory Way, including the Southwest Homeowners Association.

Although some people were in favor of the bikeways, the public comments made were largely in opposition.

'You have received numerous letters and emails from southwest residents who feel strongly that one, Charliville and Gregory are obviously too narrow, having been designed decades ago, to accommodate a bike lane. Two, that removing parking from either or both streets would impair the ability of residents including those in the 100 block who use Charleville for parking since there is way too insufficient parking in their older building to maintain their quality of residential life. Three, bikers virtually always fail to observe the stop signs at each of the intersections, making travel for pedestrians, vehicles, and themselves more dangerous. And four, narrowing the already narrow vehicle pathways on those two streets make them unsafe," President of the Southwest Homeowners Association President Ken Goldman said.

Charleville Boulevard and Gregory Way are both residential streets with one travel lane in each direction and on-street parking on both sides of the street. Staff will be proposing that Charleville Boulevard and Gregory Way be included as Class III bikeways in the proposed quick build "minimum grid" network. This will have no impact on vehicle travel lanes or parking on either street because there is no separation between bicyclists and drivers.


If approved by the City Council, this would provide basic bikeways on these two streets.

City Council Discusses County Project to Change Operations at Virginia Robinson Gardens

At their Tuesday Study Session, the City Council discussed a project proposed by the County to change operations at the Virginia Robinson Gardens located at 1008 Elden Way.

The Virginia Robinson Gardens property served as a private residence for Harry Winchester and Virginia Robinson from 1911 to 1977. The estate was then transferred to the County of Los Angeles for the purpose of an arboretum open to the public.

In 1980 the County Board of Supervisors certified an Environmental Impact Report (EIR). This included provisions to limit hours of operation and number of

daily visitors, types of events, and number of employees allowed on the site. Operating hours were by appointment only from 11 a.m. to 3:30 p.m. Tuesday through Friday, and closed on holidays. A maximum of 100 people and 20 cars were allowed on the site during the operating hours and two fundraising events were allowed to be held each year.

The county however, made operational changes to the Gardens in 2014 including: open to the public Monday to Saturday from 9:30 a.m. to 4:00 p.m.; four special events allowed each year; allowing parking on property with advance reservation; programming allowed including children's programming, musical and arts programs, other scheduled staff and public programming; and allowing up to 100 visitors per day with advanced reservation.

The County is currently proposing operational changes at the Gardens and is preparing a Supplemental Environmental Impact Report (SEIR).

The operational changes proposed at this time are: the Gardens would be open to the public seven days a week from 9:30 a.m. to sunset; up to 24 special events would be allowed per year, no more than four per month; family ceremonies such as weddings would now be allowed; and up to 200 visitors per day would be allowed with advanced reservation.

The County held a scoping meeting for the SEIR on Nov. 15, which was attended by Beverly Hills staff and neighbors of the property were also in attendance at the meeting who provided comments to the County representatives. The concerns made by Beverly Hills residents were specifically related to potentially adverse impacts with increased traffic, noise, water usage, valet parking demand, light, and the change to the nature of the operations with an increase in private events.

Many residents also called in during the City Council Study Session to voice concerns they had over the proposed changes.

The County anticipates that the Draft SEIR will be ready for review beginning in April 2022 and the final SEIR will be prepared by Aug.

City Council Approves Request for Vanity Fair Party

At their Tuesday Study Session the City Council approved a request from Vanity Fair to have the next post-Academy Awards Party hosted in Beverly Hills on Sunday, March 27. This requires a street

closure of the 400 block of North Crescent Drive from Tuesday, March 15 until Thursday, March 31.

Vanity Fair was also approved for an additional two years for the event to take place again on North Crescent Drive in 2023 and 2024. Council approval has been granted for this event in three-year increments since 2015.

Vanity Fair's annual post-Academy Awards Party has held the last six oc-

casions in Beverly Hills in between City Hall and the Wallis. The event attracts an average of 800-1,000 attendees. These guests include Oscar winners and nominees, as well as actors, celebrities, politicians, and dozens of national and international media outlets.

Adjacent residents and merchants will be notified of the upcoming activity and closures, including local churches on North Santa Monica Boulevard for the event day specifically.

This event takes place the weekend after the LA Marathon.

City Council Discusses 100% Green Power for the Entire City

At their Tuesday Study Session the City Council discussed changing the default energy product to 100% green power for the entire city under the Clean Power Alliance (CPA).

Beverly Hills is a member of the CPA that provides renewable electricity to the community. Members are required to select a Default Energy Rate. The options are Lean Power, which is 40% carbon-free hydropower, Clean Power, which is 50% renewable/carbon-free power, or 100% Green Power, which is 100% renewable energy. Beverly Hills is currently set at Clean Power.

If the City Council approves the change, it would go into effect in Oct. Customers who are currently enrolled in the Lean Power, 100% Green Power or have opted out of the CPA will not be affected by City Council's decision.

The potential change to 100% Green is intended to reduce the city's overall greenhouse gas (GHG) emissions by 12%, but slightly increase rates by about 2-3%.

Beverly High To Debut New Music Industry Center

Beverly High is expected to hold a ribbon cutting ceremony for the new Music Industry Center on Wednesday, Dec. 8, after the Weekly's deadline.

They are also expected to announce the anonymous donor who made the art facility possible and share some student demos of the equipment.

Beverly High has an Arts Media Entertainment pathway, which offers a series of Audio Production courses. Additionally, they provide students in these courses music industry real-world experience, with guest speakers, field trips, industry certifications, and career exploration activities that are intended to equip them to pursue production during or post-college.

The new center is a three-room suite with instruments, such as drum sets, piano, keyboards, synthesizers, and more; a composing space of 35 tech stations of audio production equipment; and a recording booth combined to provide music production spaces so students across the district can compose, record, produce and eventually publish music.

Beverly High currently offers three-level courses: intro, advanced, and a capstone for about 45 students, available during the school day and after school electives. They also host after-school GATE music-making experiences for elementary students in fourth and fifth grade for Hawthorne and Horace Mann students.

The Audio Production courses are team-taught by Alex Breitman and Rodney Mitchell.

In 2009 Breitman was teaching geometry at Beverly High and one of his students was the daughter of security guard Rodney Mitchell. Breitman and Mitchell ended up deciding to collaborate at Breitman's home studio on a track. A few months after Mitchell came over to Breitman's studio he told him about an Audio Production class that the ROP department was considering.

"This news was incredible to imagine, so I met with the ROP director at that time, Steve Rappaport, who wanted to create this class and asked me to review the curriculum. The curriculum was mind blowing to me and I was obviously extremely interested, but year after year went by with no movement. I had all but given up on this opportunity when I met with Mr. Rappaport one more time and he told me that he will start this class before he retires. Not much later we made our first purchases of computers and me and Rodney Mitchell had officially made the class," Breitman said.

Cindy Dubin took over for Rappaport after he retired.

"With her incredible help, working alongside amazing administrators and board members, we together have created a once in a lifetime student centered career based music creation program with a fully functioning professional music studio, a student computer lab and a creative space complete with piano, drums and synthesizers! My motto is 'You have to have a dream to make a dream come true' and this is my dream, and it has come true," Breitman said.

Rent Stabilization Commission Defines 'Mom and Pop' Landlords

At their Dec. 1 meeting the Rent Stabilization commission defined the term "mom and pop" landlord in regards to relocation fees and approved a 25% reduction in relocation fees for "mom and pop" landlords with tenancies less than 10 years and a 15% reduction for tenancies over 10 years.

The commission decided to define the term "mom and pop" landlord as a landlord with no more than four units and one single-family residence in Beverly Hills.

The Beverly Hills Rent Stabilization Ordinance (RSO) provides that an owner may evict a tenant for use and occupancy by the landlord or landlord's spouse, children, or parents provided that the landlord pays the tenant a relocation fee, among other things.

The following are the Beverly Hills 2021 relocation fees: for a studio, the fee is \$6,988.87 and \$8,988.87 for a senior, disabled person, or minor; for a one-bedroom the fee is \$10,323.61 and \$12,323.61 for a senior, disabled person, or minor; and for two and three bedrooms the fee is \$13,986.75 and \$15,986.75 for a senior, disabled person or minor.

A statewide "no just cause" eviction already requires a one-month rent payment to the tenant in the event of an eviction.

The revisions will be recommended to the City Council to be made to the RSO to modify the current relocation fee provisions for both Chapter 5 and Chapter 6 of the RSO relating to the reduction in relocation fees for owner occupancy for "mom and pop owners."

City Council Honors Beverly High Veteran

At their Tuesday meeting the City Council honored Beverly High alum-

nus Captain Robert H. Wolff who was recently awarded the Legion of Honour, France's highest award.

Wolff is a winter 1940 Beverly High

grad, who enlisted in the U.S Army Air Corps. In 1943 his plane malfunctioned, leading to his capture and being held as a German Prisoner of War. He was liberated in April of 1945 and is 100 years old.

Wolff was nominated for the proclamation by *Beverly Hills Weekly*.

Frieze Week in Beverly Hills to Launch February 2022

Frieze, which has previously held events in cities such as London, New York, and Los Angeles, has partnered with Beverly Hills to launch 'Frieze Week in Beverly Hills' on Feb. 17-20. This will be the first time the city has worked with Frieze to bring temporary public art projects to the city as well as a weeklong program of events to celebrate art and culture.

"I am excited that the City's Arts and Culture Commission as well as our Community Services Department has worked hard to make this collaboration a reality. Beverly Hills is a City that has a deep history and appreciation of art and we look forward to welcoming everyone to experience exhibits and events in such a beautiful and iconic setting," Mayor Robert Wunderlich said.

Frieze Week in Beverly Hills will have its main fair take place at 9900 Wilshire Boulevard.

The launch of the fair in Los Angeles took place in 2019 and featured works from over 90 art galleries, attracting 35,000 visitors over its four-day run.

The 2022 fair will be overseen by Christine Messineo, Director of Frieze Los Angeles and Frieze New York, and will showcase works by today's most prominent emerging artists alongside major figures in contemporary art in a range of solo, dual and thematic presentations.

On Dec. 8 Frieze will give Beverly Hills residents exclusive priority booking for early bird tickets for the art fair beginning at 8:00 a.m. until 11:59 p.m. in which residents can save up to \$52 off full-price tickets. When available, pre-sale tickets can be purchased by visiting frieze.com/presale.

Additionally, Frieze will also give residents a 15% discount and pre-approved applications on Frieze 91, a new membership that affords patrons premiere access to fairs, studio visits, artist foundations, cultural events and special museum exhibitions across the globe.

Board Approves Agreement for Stage Repair

At their Tuesday meeting the Board of Education approved a ratification of an agreement with Garza Construction, Inc. for stage repair services at Beverly High.

To repair the water damaged Theatre 40 stage at Beverly High, the Maintenance and Operations Department solicited quotes from different qualified contractors and contracted with Garza Construction, Inc. as the "lowest responsible and responsive bidder."

The total cost for the repair is \$26,900. Since this is an insurance claim related project, the district will be reimbursed for the total cost, less than the deductible amount.

Board Approves Notice of Completion for Restoration of Logo

At their Tuesday meeting the Board of Education approved a notice of completion for the restoration of a logo at Beverly High with Boss Graphics, Inc.


On Aug. 24 the Board approved the contract with Boss Graphics, Inc. for restoration of a branded logo and replacement of an old logo that was worn and at the end of its life on the east facing exterior gym wall at Beverly High in the amount of \$33,425.

The project was completed as of Oct. 1 for a total cost of \$35,025 and was funded by the Deferred Maintenance Funds.

South Beverly Drive Post Office Closed Tuesday

On Tuesday the South Beverly Drive Post office was closed.

According to post office manager Bran-



dy Player, this was due to "employee availability."

"We are alarmed to learn of this closure and my office is in touch with USPS to get a firm answer on what happened and what we can do to prevent this from happening in the future. Any constituents in Beverly Hills who are having issues with their mail service should reach out to my office for casework support," Jenna Bushnell, a spokesperson for Congressmember Ted Lieu's office said.

'Visions of the Future' Popup Art Series Returns to Beverly Hills

On Thursday, Dec. 2, the Next Beverly Hills Committee, in partnership with the City of Beverly Hills' Arts and Culture and Human Relations Commissions will launch a new pop-up art exhibit located at 445 N Cañon Drive featuring work by artist Kevin HEES.

The temporary installation will feature seven works from the American artist's latest MUSIC! series that pays homage to favorite musical genres, tempos, and rhythms. HEES' work is known for featuring geometric shapes and colorful circles that are intended to represent the circular perfection of the physical and spiritual universe in an effort to outline the human pursuits of health, wealth, and happiness.

Slated to be on display for one month, this is the second pop-up to launch as part

of the 'Visions of the Future' program intended to activate public spaces with vibrant, visual pop-up art experiences for residents, business owners, and visitors from the Los Angeles area and around the world.

Beverly Hills to Host Virtual Wildfire Evacuation and In-Person Outdoor **Warning System Community Meetings**

In an effort to inform the community about wildfire evacuation planning and also to test its new Outdoor Warning System, the Beverly Hills' Office of Emergency Management will host two virtual community meetings on Dec. 14 at 10 a.m. and Dec. 15 at 6 p.m. The agendas will be the same.

During the virtual meetings, the Police Department, Fire Department, Department of Public Works and City Manager's Office will present various ways which residents and community members can prepare as well as share how each department has worked to prepare for and mitigate against the threat of wildfires and other potential disasters. Community members will have the opportunity to learn about how to build out their emergency plans and supplies.

Additionally, community members will have an opportunity to hear firsthand the city's planned Outdoor Warning System at two in-person meetings on Dec. 13 at Roxbury Park (near the south end of the park) at 4:00 p.m. and Dec. 15 at Greystone Mansion at 10:00 a.m. The siren demonstration will be a test only, and may be heard throughout the city; no action will be required and the siren will last about 30 seconds. A recording of the siren demonstration will also be shared at each virtual meeting.

"We hope the community joins us for either a virtual meeting or in-person siren demonstration as an additional resource to further prepare for a wildfire disaster that could impact them or their families," Emergency Management Manager Meena Janmohamed said.




In prior years, they had a "Trump Tower" with a wall where people were climbing over it.



BHHS Boys' Basketball Team Loses To Undefeated Sierra Canyon

The Beverly High boys' basketball team was "a little overwhelmed" because of "the environment" and "the atmosphere" in its 93-64 loss to Sierra Canyon, ranked ninth in the nation by ESPN, Norman coach Jarvis Turner said.

Playing before a capacity crowd at the Chatsworth school that included LeBron James and Scottie Pippen, who have sons who play for the Trailblazers, Beverly Hills trailed by 15 points early.

"I thought we had good practices leading up to the game but when the game started their intensity and their athleticism had an effect on our approach to the game and I think it took us out of the game and we were a little rattled," Turner said after last Thursday's nonleague game.

Turner said the Normans "did a pretty good job" in the second and third quarters settling down and "trying to get into the rhythm and flow and playing with those guys."

Junior point guard Jameson Caruso was Beverly Hills' leading scorer. When asked who played well for his team, Turner responded, "we had a couple of guys on our bench that came off and played well," specifically citing forward Danny Far and Mike Stan.

Center Alex Nokes "didn't show up in the stats box but he competed and played hard," Turner said.

"He was one of the kids who wasn't intimidated and he kind of stood up to those guys which was also positive," Turner said.

Guard Amari Bailey scored 23 points for Sierra Canyon (7-0). The 6-foot-3-inch Bailey is ranked as the nation's second-best high school basketball player by the college sports and recruiting website Rivals.com and has signed a letter of intent to accept an athletic scholarship from UCLA.

Two other Trailblazers have also signed letters of intent.

Kijani Wright, a 6-foot-9-inch forward ranked 37th by ESPN, has signed with

USC

Ramel Lloyd Jr., a 6-foot-6-inch guard who is ranked by ESPN as California's eighth-best high school player, has signed with Nebraska. Lloyd's father, Ramel Lloyd Sr., played for Syracuse and Long Beach State and 10 years professionally.

Two days after defeating the Normans, Sierra Canyon was a 71-53 winner over St. Vincent-St. Mary, James' alma mater, at Staples Center.

The game provided the Norman players with exposure, Turner said.

"Every high school media outlet that is on social media was there and we've created a little buzz and a little following behind a couple of our better players," Turner said.

Turner said he scheduled the game because "I always try to schedule some of the best opponents we possibly can."

"For us it's really hard trying to find games because I think we do have a pretty reputable, successful program but we're kind of like the mid-major (where) you have a lot to lose if you actually play us and lose to us," said Turner, whose team lost to the Trailblazers, 89-69, May 20 and hopes to play them again.

"There's not really much to gain for them."

What's Next?

Beverly Hills faced Birmingham in a championship quarterfinal of the Beverly Hills Basketball Tournament Wednesday in a game that ended after the Beverly Hills Weekly's deadline.

If the Normans won, they would face the winner of the Brentwood-Santa Clarita Christian game, at 6:30 p.m. Friday.in a championship semifinal.

ARREST MADE IN AVANT CASE

By Danielle Berjikian

On Monday the Los Angeles District Attorney's Office announced that 29-year-old Aariel Maynor has been charged with murder for the killing of Jacqueline Avant and attempted murder for opening fire on an unarmed securi-

ty guard at the Avant's residence.

The security guard was not injured.

Avant was shot three times in the abdomen after Maynor entered her residence by breaking a sliding glass door with a rock, according to The Los Angeles Times.

When police officers arrived at the scene they Aariel Maynor found Avant with her hus-

band, who was cradling her head inside their home, The Times reported.

Maynor is also being charged with two counts of residential burglary with a per-

son present and felon with a firearm.

The Beverly Hills to anyone thinking of Police Department (BHPD) announced on Thursday, Dec. 2 that Maynor was arrested in connection with the killing of Avant after shooting himself in the foot.

Maynor, who is on parole and has an extensive criminal record, was found at another home in Hollywood Hills just one hour after killing Avant. He was allegedly attempting to rob the residence when he accidentally shot himself.

According to The Times, Maynor called 911 when he was attempting to rob the Hollywood Hills home and claimed someone in a ski mask and jack-

> et had shot him. He was apparently yelling out phrases like "help me, I'm bleeding out," and "I'm a Christian."

Multiple surveillance videos, including city cameras, showed the suspect's vehicle heading eastbound out of Beverly Hills shortly after Avant was shot early Wednesday morning.

Following a thorough investigation by LAPD, it was determined that a burglary

BEVERLY HILLS CRIME SPREE CONTINUES

On Nov. 30 the Beverly Hills Police Department arrested a juvenile suspect who led police on a foot pursuit.

According to Lt. Giovanni Trejo, at approximately 7:38 p.m., a Beverly Hills Police officer in a marked police vehicle stopped a silver Kia with no license plates for a vehicle code violation near the intersection of South Santa Monica Boulevard and Rodeo Drive.

While the officer was standing with one foot on the ground and the other foot inside the police vehicle, the silver Kia reversed, struck the police cruiser, and fled westbound on South Santa Monica Boulevard at a high rate of speed, leading the officer on a vehicle pursuit.

After a short vehicle pursuit, the occupant(s) of the silver Kia abandoned the vehicle in an alley west of Linden/ north of Charleville Boulevard and fled on foot

A police containment was set up and a male suspect was located and within the containment were two handguns.

It was unknown as of press time if the suspect is connected to any other crimes in Beverly Hills.

On Friday in the 700 block of North Bedford Drive an unknown male entered a house through what is believed was an unlocked door.

The male was confronted by the homeowner at which time, the male locked himself inside a bathroom.

Upon arrival, patrol units decided to treat the incident as a barricaded suspect which elevated police response to a SWAT call-out.

SWAT and Crisis Negotiators tried for over 90 minutes to communicate with the subject but were unsuccessful.

Officers standing outside the bathroom could hear the sound of glass breaking and things being thrown around inside. SWAT breached the door to the bathroom and found the unresponsive male bleeding from several lacerations.

According to Trejo, it appears some of his wounds may have been self-inflicted.

Beverly Hills Fire Department paramedics treated the male at the scene and transported him to a local hospital.

A positive identification of the suspect had not vet been made because he is inaccessible, according to Trejo.

His condition was unknown as of press time and no criminal charges have been determined
