"What's Your New Year's Resolution?" [Issue #1161]

Here are my New Year's wishes for 2022 with three introductory comments:

1. These comments are my own as a resident and not as a member of the Planning Commission and the Citizens Climate Action Advisory Committee intended to be general in nature and do not prejudge or imply a commitment to support or oppose any proposal that may come before the Commission or the Committee;

2. I recognize that some of these wishes are likely to be controversial but I cannot please everyone all the time; and

3. I have not mentioned the pandemic because that is not, in most respects, a City issue except to note that I am hopeful (if not optimistic) that we can soon return to in person meetings of all City operations and that I am tired of hearing COVID-19 used as an excuse for all delays.

With those conditions in mind, I wish for the following:

•A city-operated electric or hydrogen powered very frequent shuttle service with two or three E/W routes, two or three N/S routes and on call service elsewhere;

•Density/height development incen-

tives sufficient to allow for a modest number (maybe two per year as contrasted with current two per decade) of financially feasible market rate multifamily condo or apartment projects with a modest (e.g. 10%) number of affordable housing units; new projects are helpful for upgrades and rejuvenation; some affordable housing is a drop in the bucket and tokenism but the right thing to do; notably, those who have chosen to live near commercial corridors must accept that there are both benefits and burdens associated with these choices including the benefits and burdens of some modest development on those corridors; (Of course, these thoughts are subject to the City's obligations respecting the Revised Housing Element of the General Plan and RHNA requirements);

•City subsidies for shelters for homeless in nearby appropriate areas (likely in City of LA) adequate to allow lawful enforcement of no camping on public property ordinances and City subsidized nonprofit development of more permanent housing in appropriate areas; some subsidized senior housing in the City if we can restrict it to current Beverly Hills residents;

•City acquisition of Virginia Robinson Gardens if it makes financial and program sense;

•More robust roles for the Mayor and the City Manager;

•Term limits for elected officials; I support the three term limit currently proposed but would prefer a two term limit; •City-financed elections with funds conditioned on no additional self or outside funding with the exception of modest in kind contributions;

Active and effective discouragement of \$ from Political Action Committees by all candidates; it will be difficult for me to support a candidate who does not succeed in the efforts to discourage such support;

•A substantive campaign for the June 2022 elections from candidates who demonstrate leadership and vision; platitudes about "I love the city and want to give back" or "there is so much more to do" make me cringe; the City Council in particular has legislative, administrative and quasi-judicial roles and we can and should expect all candidates to explain, not avoid their approach, including substantive as well as procedural views and philosophies for fulfillment of these roles;

•Substantial increase in size AND training of BHPD; more visible presence throughout the City and substations at METRO stops; and

•Improved litigation counsel -- once we make a well-considered decision and take action in furtherance, we must have the fortitude and capability to defend it; of course, if we make mistakes, we should admit them and responsibly address the consequences.

BLM Holds "Smash and Grab" Protest

A Black Lives Matter (BLM) flyer circled around social media Dec. 23 threatening a "smash and grab" demonstration in the city.

The flyer, obtained on instagram and Twitter, has the BLM logo on it claiming they are seeking "justice" from "white



capitalism." They posted it on the BLM Los Angeles Twitter and wrote "THURSDAY, 12/23/2021 4PM – #BlackXmas Action at Beverly Gardens Park in Beverly Hills – It's a different kind of "smash and grab"! SMASH white capitalism; GRAB justice! Meet us in Beverly Hills for sign-making, justice carolling (SIC), dancing, and beloved community. #BlackLivesMatter."

The social media posts stopped short of actual threats of lawlessness.

"BHPD became aware of this flyer two days ago. We are monitoring social media and we brought in additional police resourc-

AN ORDINANCE OF THE CITY OF BEVERLY HILLS RENUMBERING EXISTING ARTICLE 5 (CROSS CONNECTION CONTROL PROGRAM) OF CHAPTER 1 (CITY UTILITY SERVICES) OF TITLE 6 (UTILITIES AND FRANCHISES) OF THE BEVERLY HILLS MUNICIPAL CODE TO ARTICLE 6 (CROSS CONNECTION CONTROL PROGRAM), ADDING NEW ARTICLE 5 (MANDATORY ORGANIC WASTE DISPOSAL REDUCTION) TO CHAPTER 1 (CITY UTILITIES SERVICES) OF TITLE 6 (UTILITIES AND FRANCHISES) OF THE BEVERLY HILLS MUNICIPAL CODE, AND MAKING A DETERMINATION OF EXEMPTION UNDER CEQA

Notice is hereby given that the City Council of the City of Beverly Hills adopted Ordinance No. 21-O-2854 during the regular City Council meeting on December 21, 2021.

A summary of this Ordinance follows:

The Ordinance renumbers an existing Article 5 (Cross Connection Control Program) of Chapter 1 of Title 6 of the Beverly Hills Municipal Code to Article 6.

The Ordinance also adds a new Article 5 to Chapter 1 of Title 6 the Beverly Hills Municipal Code entitled "Mandatory Organic Waste Disposal Reduction." The Ordinance will be effective and amendments to the Municipal Code will become operative thirty (30) days after its passage. Pursuant to Senate Bill 1383 ("SB 1383"), the California Department of Resources Recycling and Recovery ("CalRecycle") developed regulations ("SB 1383 Regulations") to reduce organics in landfills as a source of methane. The SB 1383 Regulations impose requirements on cities to adopt and enforce an ordinance to implement relevant provisions of the SB 1383 Regulations. As such, this Ordinance adopts requirements for (1) mandatory organic waste disposal reductions for single-family, multi-family, and commercial business organic waste generators, (2) commercial edible food generators, (3) food recovery organizations and services, (4) haulers (including self-haulers and haulers that are solid waste enterprises), facility operators, and community composting organizations, (5) direct service providers and vendors regarding recovered organic waste product procurement, and (6) inspections, investigations, and enforcement by the City.

AN ORDINANCE OF THE CITY OF BEVERLY HILLS EXTENDING URGENCY ORDINANCE NO. 21-O-2853 TO PROVIDE OBJECTIVE STANDARDS FOR SENATE BILL 9 PROJECTS IN SINGLE-FAMILY RESIDENTIAL ZONES

The proposed ordinance would extend Interim Urgency Ordinance No. 21-O-2853 for an additional ten (10) month and fifteen (15) day period, pursuant to Government Code Section 65858. The interim urgency ordinance established objective development standards for residential developments in the single-family zones constructed pursuant to Senate Bill (SB) 9. If the City Council decides to extend the interim urgency ordinance, it will be active for a one year period in total, which will provide additional time to study the effects of enacting such regulations, and to provide an opportunity to discuss whether such regulations should be considered for permanent adoption. The staff report for the December 7, 2021 City Council meeting describes the contents of Urgency Ordinance No. 21-O-2853, and is available on the City's website.

ENVIRONMENTAL REVIEW

The draft ordinance has been assessed in accordance with the authority and criteria contained in the California Environmental Quality Act (CEQA, Public Resources Code Sections 21000 et seq.), the State CEQA Guidelines (California Code of Regulations, Title 14, Sections 15000 et seq.), and the environmental regulations of the City. Upon review, the ordinance does not appear to be considered a project under CEQA, and it can be seen with certainty that there is no potential for such ordinance does not authorize construction and consists of additional regulations on future development, which will be treated ministerially pursuant to the stipulations of SB 9.

EXTENSION OF AN INTERIM URGENCY ORDINANCE NO. 21-O-2833 OF THE CITY OF BEVERLY HILLS AMENDING SECTION 10-2-303 OF THE MUNICIPAL CODE REGARDING ADJUSTING LOT LINES THAT ARE BETWEEN JURISDICTIONAL BOUNDARIES AND DECLARING THE URGENCY THEREOF

The Council will consider extending the interim Urgency Ordinance for an additional period of one (1) year, in accordance with the provisions of Government Code Section 65858. In summary, the interim ordinance amends section 10-2-303 of Article 3 of Chapter 2 of Title 10 of the Beverly Hills Municipal Code to prohibit a lot line adjustment that would either create or expand a lot that crosses the City boundary. Staff also seeks direction from the City Council regarding the contents of a permanent ordinance that would be adopted in place of such interim ordinance in the near future. The staff report for the March 2, 2021 City Council meeting describes the contents of Urgency Ordinance No. 21-O-2833, and is available on the City's website.

ENVIRONMENTAL REVIEW

The draft ordinance has been assessed in accordance with the authority and criteria contained in the California Environmental Quality Act (CEQA, Public Resources Code Sections 21000 et seq.), the State CEQA Guidelines (California Code of Regulations, Title 14, Sections 15000 et seq.), and the environmental regulations of the City. The adoption and implementation of the Urgency Ordinance represents minor alterations in land use limitations and do not result in any changes in land use or density, and the average slope of the City is less than 20 percent. It can therefore be seen with certainty that there is no possibility that the proposed amendments may have a significant effect on the environment. Accordingly, the City Council will consider the staff recommendation to find the Urgency Ordinance exempt from the environmental review requirements of CEQA pursuant to Section 15305 of the California Code of Regulations.

fraudulently submitting an estimated \$355 million in claims related to the 1-800-GET-THIN Lap-Band surgery business.

Julian Omidi and an Omidi-controlled Beverly Hills-based company, Surgery Center Management LLC (SCM), were found guilty of 28 counts of wire fraud and three counts of mail fraud. Omidi also was found guilty of two counts of making false statements relating to health care matters, one count of aggravated identity theft and two counts of money laundering. Omidi and SCM were found guilty of one count of conspiracy to commit money laundering.

Omidi, a physician whose license was revoked in 2009, controlled, in part, the GET THIN network of entities, including SCM, that focused on the promotion and performance of Lap-Band weight-loss surgeries. Omidi established procedures requiring prospective Lap-Band patients, even those with insurance plans he knew would never cover Lap-Band surgery, to have at least one sleep study. Employees were also in-

City staff has begun to work on an update to the Safety Element of the General Plan. State law requires that every jurisdiction's General Plan include a Safety Element to address the mitigation of short- and long-term risks resulting from disasters such as wildfire, flooding, and earthquakes. The City's current Safety Element was last updated in 2010, and must now be updated to include additional information to address climate change adaptation and resiliency in compliance with recently adopted state laws. centivized with commission to make sure the studies occurred, according to evidence presented at his trial.

Omidi used the sleep studies to find a reason, the "co-morbidity" of obstructive sleep apnea, that GET THIN would use to convince the patient's insurance company to pre-approve the Lap-Band procedure.

After patients underwent these sleep studies, GET THIN employees would often falsify the results. Omidi then used the falsified sleep study results in support of GET THIN's pre-authorization requests for Lap-Band surgery.

Relying on the false sleep studies - as well as other false information, such as _______a patient's

Even if the insurance company did not authorize the surgery, GET THIN still was able to submit bills for approximately \$15,000 for each sleep study, receiving an estimated \$27 million in payments for these claims.

procedures.

The victim health care benefit programs include Anthem Blue Cross, Aetna, Tricare, UnitedHealthcare, Health Net, Operating Engineers Health, Welfare Trust Fund, and others.

Prosecutors believe Omidi's total fraudulent billings are around \$355 million.

Omidi faces a statutory maximum sentence of 20 years in federal prison for each of the mail fraud, wire fraud, and money laundering counts, as well as a mandatory consecutive two-year sentence for aggravated identity theft.

In 2014, the government seized more than \$110 million in funds and securities from accounts held by individuals and entities involved in the criminal scheme, including Omidi. The government is seeking

forfeiture of some or all those funds in the criminal case, and intends to pursue civil forfeiture of some or all of the assets.

On Dec. 20 prosecutors filed fraud charges against a 24 year old New Jersey man who allegedly posed as a former player for the New England Patriots, which allowed him to purchase family versions of the team's 2016 Super Bowl championship ring - supposedly as gifts to relatives of quarterback Tom Brady - one of which was sold at an auction for over \$337,000.

Scott V. Spina Jr. was charged with one count of mail fraud, three counts of wire fraud and one count of aggravated identity theft in an alleged scheme that allowed him to purchase three Super Bowl rings engraved with the name "Brady" on them and offer them for sale with the false claim that Tom Brady had given the rings to relatives.

Spina agreed to plead guilty to the five felony offenses.

In 2017 Spina purchased a Super Bowl LI ring awarded to a Patriots player who subsequently left the team. Spina, who bilked the former player by paying for the ring with at least one bad check, sold the ring for \$63,000 to a well-known broker of championship rings, according to court documents.

When Spina obtained the ring, he also received the information that allowed the former player to purchase Super Bowl rings for family and friends that are slightly smaller than the player rings. "Spina then called the Ring Company, fraudulently identified himself as [the former player], and started ordering three family and friend Super Bowl LI rings with the name 'Brady' engraved on each one, which he falsely represented were gifts for the baby of quarterback Tom Brady. The rings were at no time authorized by Tom Brady. Defendant Spina intended to obtain the three rings by fraud and to sell them at a substantial profit," according to the criminal information.

Spina entered into an agreement with the man who purchased the player's Super Bowl ring to sell him the three family rings that Spina claimed Brady had given to his

Sisters Working Towards a World Free of Plastic Pollution

Beverly High graduates Dianna and Julia Cohen founded Plastic Pollution Coalition in 2009, a global alliance of 1,200 organizations, businesses, and thought leaders in 75 countries working toward a world free of plastic pollution.

What are some ways your group has reduced plastic?

Julia: We work to educate, connect, and advocate for a world free of toxic plastic pollution. We do that by sharing information on a very deep portal of our website and [in] over 12 years

we've amassed an incredible amount of resources and information, a place where even politicians, congressional staff, and members of congress go to find examples of policies and laws from cities, states, countries, [and] even international treaties

We've helped support, and continue to support the passage of things like single use [bans or fees on] plastic bags, plastic straws, comprehensive foodware ordinance, [and] support

[of] stimulus for reusable systems. We are currently part of the effort for the federal 'Break Free From Plastic Pollution Act' and also have been working in support of an international global plastic pollution treaty. We work to advocate, educate, and also connect our coalition members, groups, and businesses with each other and the general public. We have [about] 20 different companies that produce straws, whether they are seaweed straws or stainless steel straws. And also reusable systems, so you can order take out in a reusable stainless steel tiffin that you return to the restaurant. So, on a multitude of fronts we've been working to reduce plastic all over the world.

You graduated from Beverly High in 1983 and 1986, were there any teachers or classes you took that inspired you?

Dianna: There was a class I really liked with Linda Wolf. She was a Latin and Spanish teacher, I had her for neither class. But she taught a class at night

One of your organization's visions is for people to embody zero-waste values, can you elaborate on that?

Dianna: In our work, we believe that it's possible to live in a world that's free of the toxic impacts of plastic. That would mean on a personal

level and also in what is made available to people in terms of the way that we work with businesses and companies that provide alternative materials that vou could choose and use containers for your foodservice purchase and for beauty and health supplies that are packaged in glass, packaged in reusable steel, packaged in wood, packaged in ceramic, [and] packaged in paper that's not coated with chemicals. Basically, we believe that it's possible to create a world that we can all live in that is regenerative and toxic-free and so that's what we're aiming for. It's a very ambitious goal. It's possible and it needs to come from not just a personal choice, but also within our schools and how we educate people around this issue and our governments, and policies.

And business, and what businesses are able to do when they look at how they deliver products to people, or how they produce the things that they make or package them. With this growing awareness and this huge move and com-

The same day that the buyer tried to back out, and the same day that Spina actually received the rings in Nov. of 2017, mitment to sustainability and companies waking up to the reality of the impact of climate change our use of plastic and single use plastics directly attributes to exacerbating climate change. It releases greenhouse gases, it pollutes, and it disproportionately impacts [Black, Indigenous, People of Color] and fenceline communities across the U.S and around the world.

And then as a waste management issue that generally comes down to dumping it in the environment, or in waterways, or the ocean, or to burning it. Which generally has euphemistic names for that, like 'waste to energy' or 'waste to fuel'. They sound really good but a lot of these pollutants just poison us again by releasing particulate pollution and Dioxins into the atmosphere. Plastic is this incredible material, but it was never designed to be recycled. And industries really push this idea that we should just recycle better and have put the responsibility on the public. That's all kind of just a tangled web and it's not realistic. As we wake up to this, what we've been able to do as Plastic Pollution Coalition is help create tools and guides that help people.

For example, we've produced with Made Safe Certified, a healthy pregnancy guide and a healthy baby guide. Those are really plastic free guides that guide you away from exposure to these toxic chemicals and plastic. And we've also created a global legislative database that can be used to create laws, policies, and bills. We've also created an 'understanding packaging' scorecard, the <u>https://upscorecard.org/</u> that can be used by businesses that can sign up and go into it and use it to compare different packaging materials.

That's what we continually do. We work on it every day. Looking at how we can help educate people, create guides, raise awareness, and advocate for this change. And then help shepherd it along so that we are moving in the right direction. And we are seeing a huge amount of movement. One of the most basic things too is to get people to understand plastic is made primarily by fossil fuels with these other chemical additives, phthalates and bisphenol, that are endocrine disruptors. They are bad for our bodies, they turn things on and off in our bodies and they've been linked to a number of different health issues. As this consciousness grows around the issue people are committed to and willing to change. And we've watched in the last 3 years a lot more businesses join our coalition. We saw a big uptick. Now we are about 50/50 businesses and organizations.

What do you hope to accomplish in 2022?

Julia: Part of what we are aiming to do for next year is the 'Flip the Script on Plastics' initiative. We've just launched

it with this initial baseline research but we're really looking to grow next year where we will be working much more closely with a handful of shows, with showrunners, writers, producers, set directors, artists, [and] other cultural creatives working in film and television to help really change the storyline not just behind the scenes. There's been a lot of effort behind the scenes not that there couldn't be more.

There are storylines that help educate folks, not only about the problem and the connection between plastic. Plastic is

becoming the new coal and will produce more greenhouse gases than coal in the next 20 years.

There are solutions. There are great, cool, hipster refill



hipster refill Julia Cohen shops and less

expensive traditional reusable, refillable concepts all over the world. Bringing those kinds of things back, kind of like bringing back the milkman and having your milk delivered in glass, those kinds of things. We'll be expanding that program by working with the cultural creatives and shows. Working with researchers to conduct further research as storylines are incorporated and changed to show the impact of that.

Also, taking those folks on tours. Whether it's in the LA area just to see the oil rigs and the drilling and what that means and does. And how close that is to all of us. Even especially on the Beverly Hills campus and the issues related to that. Also, waste management. What happens when it first rains in LA and the first flush in the LA river, and all our trash, most of which is plastic, comes rushing through that.

You know, the trash on the beach and pickups and those kinds of things. And then what really happens to it. What's the waste management? Where does it go? Seeing the full life cycle in person, smelling it. There's toxic tours that happen in the Houston area and take people on the campus corridors of all the petrochemical companies and you can smell the toxic stuff in the air.

And then what are the positive solutions? Where are those refill shops? What's happening in local communities? We're part of and helped create the reusable LA coalitions that's been pushing not only for policies but also for promotion, support, incentives, and our tax dollars being used for change. That's a big part of next year.

Cedars-Sinai Receives \$100 Million Gift

On Dec. 16 Cedars-Sinai announced they have received a \$100 million gift, the largest lifetime gift in Cedars-Sinai's 119year history.

According to Cedars, the gift is intended to advance an ambitious vision for children's healthcare to fill a critical gap in care for young patients in Los Angeles and

In addition to current intensive care pediatric beds, an inpatient space with 26 beds is now under renovation and is scheduled to open in the spring of 2022. The setting will feature a movie and game room, an outdoor garden, children's art by local artists, a family lounge for adults, and furniture that converts into beds for parents who wish to stay with their children at night.

Guerin Children's has been made possible by the Shapell Guerin Family Foundation and its president, Vera Guerin, who currently serves as board chair of Cedars-Sinai Health System.

The CITY may also determine at any time that the prequalification process will be suspended for the Project and the Project will be bid without prequalification.

Contractors who submit a complete prequalification package will be notified of their qualification status no later than ten business days after submission of the information. The CITY may refuse to grant prequalification where the requested information and materials are not provided by the due date indicated above. There is no appeal from a refusal for an incomplete or late application, but re-application for a later project is permitted. Neither the closing time for submitting prequalification packages for this Project will be changed in order to accommodate supplementation of incomplete submissions, or late submissions, unless requested by the CITY in its sole discretion.

In addition to a contractor's failure to be pre-qualified pursuant to the scoring system set forth in the prequalification package, a contractor may be found not prequalified for either omission of or falsification of, any requested information.

Where a timely and completed application results in a rating below that necessary to pre-qualify, an appeal can be made by the unsuccessful Contractor. An appeal is begun by the Contractor delivering notice to the CITY of its appeal of the decision with respect to its prequalification rating, no later than two business days following notification that it is not pre-qualified. The notice of appeal shall include an address where the Contractor wishes to receive notice of the appeal hearing. Without a timely appeal, the Contractor waives any and all rights to challenge the decision of the CITY, whether by administrative process, judicial process or any other legal process or proceeding.

If the Contractor gives the required notice of appeal, a hearing shall be conducted no earlier than five business days after the CITY's receipt of the notice of appeal and not later than five business days prior to the date of the Notice Inviting Bids for this Project. Prior to the hearing, the Contractor shall, in writing, be advised of the basis for the City's pre-qualification determination.

The hearing shall be conducted by a panel consisting of three members of the Depart-

ment of Public Works senior management staff (the "Appeals Panel"). The Appeals Panel shall consider any evidence presented by the Contractor, whether or not the evidence is presented in compliance with formal rules of evidence. The Contractor will be given the opportunity to present evidence, information and arguments as to why the Contractor believes it should be pre-qualified. Within one day after the conclusion of the hearing, the Appeals Panel will render a written determination as to whether the Contractor is pre-qualified. It is the intention of the CITY that the date for the submission and opening of bids will not be delayed or postponed to allow for completion of an appeal process.
