## “City Council Overturns Tobacco Hardship Exemption” [Issue #1165]

Your article says that hotels are allowed to sell tobacco products. In fact, hotels are not allowed to have gift shops that sell tobacco, and they are not allowed to sell tobacco to the public. This is very similar to the Appellant’s restriction, as he may not sell tobacco to the public, and not in his shop. The small carve out exemption for hotels is that they may only sell via concierge service and only to hotel guests.

While my heart goes out to the Appellant, he had and still has an opportunity to replace tobacco with other products. The overwhelming majority of square footage of his Convenience Store is dedicated to selling products that are unrelated to tobacco and are not injurious to innocent bystanders. In Los Angeles County the vast majority (85 to 90%) of people buying gas are nonsmokers. Of the remaining nearly 10% of gas purchasers who might smoke, not all will go elsewhere. So a very small percentage of gas purchases might relocate outside of the City due to the ordinance. The more likely cause of

a drop in gasoline sales revenue would include gas prices, a shift to electric vehicles or even traffic patterns.

I am proud of our esteemed City Council for implementing and enforcing policies that support health, our number one resource.

## “Full Docket for Planning Commission in 2022” [Issue #1165]

Christine Skirmuntt Ford writes in last week’s issue of Beverly Hills Weekly about the clash between the Planning Commission actions and the expectations of the vast majority of the residents of Beverly Hills. Commissioners are appointed by and serve at the pleasure of the Council and as a result are not directly accountable to us - the voters.

The Planning Commission does not listen or consider the desires of the residents. Instead of RESIDENTS FIRST, it is developers and lawyers first.

The Architectural Commission spends full hearings looking at one aspect of a proposed development as if it stands alone. Its members may consider a garden, but ignore the six-story proposed project that needs the garden next to it and originally triggered the hearing. Staff prohibits any mention of the proposed project, as if the public (usually neighbors - long time residents) is a nuisance that needs not be considered.

Commissioners bring with them an urge

to serve, to be a contributing part of the community. So what goes wrong? Too much staff control? Not enough Council direction and leadership?

Developers like to accuse residents of being anti-development to silence any voices not in line with their own. They come to our City and their first order of business is to ignore and attack anyone who might not be aligned with their plans to make a great deal of money in this amazing community called Beverly Hills.

Residents care about Beverly Hills and their responsibility is to protect its special character and nature. We know that every single-story house that is demolished in favor of a two story box-like structure that fills the lot to a maximum is lost forever. (This phenomenon used to be called McMansionization) We also are acutely aware that each open lot that is built (usually with extra height and density allowances and other waivers) adds to the choking density of a new Beverly Hills residents do not want.

Commissioners serve at the pleasure of the Council, and final decisions always rest with the Council. So it is up to us - residents of Beverly Hills - to elect Councilmembers attuned to the needs of the City and the well-being of its stakeholders.

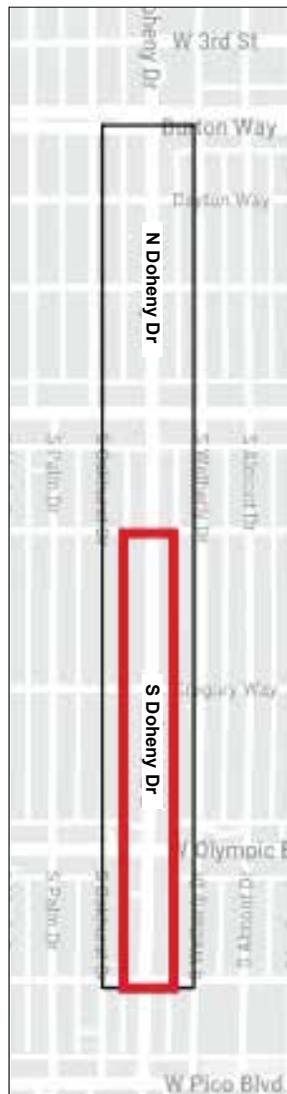

## Traffic and Parking Commission to Discuss Doheny Drive Bike Lanes

The Traffic and Parking Commission is expected to discuss proposed bike lanes on Doheny Drive between Burton Way



and the southern City limit at Whitworth Drive.

Doheny Drive south of Burton Way is identified as a high priority project in the Complete Streets Action Plan.

This bike-way would connect with other proposed bikeways on Clifton Way, Charleville Boulevard, and Gregory Way, along with existing bike lanes on Burton Way.

Doheny Drive between Burton Way and Whitworth Drive has on-street parking and one travel lane in each direction.

Proposed bike lanes on Doheny Drive would not result in any reduction in the number of vehicle travel lanes, turn lanes, or on-street parking spaces.

Feedback received from the Commission will be incorporated into the bikeway design, which is anticipated to be finalized in spring and brought to City Council for consideration.

Installation of the bikeway on Doheny Drive is estimated to cost approximately \$5,000.

## Board to Issue RFP; Blake Out?

In a special session Tuesday, the Board of Education authorized a Request for Proposal (RFP) for Bond Management Services for its ongoing construction program. The vote was 4-1 with Board member Noah Margo dissenting.

"If there are issues that the Board majority is having with the current program I think it would have been prudent for us to discuss those with the current program manager. But we are refusing to do that. And I feel that going out for the RFP tonight, or even giving direction to get one prepared, is like breaking up with a girlfriend over text," Margo said.

The move could effectively end the role of Don Blake's Team Concept Development Services (TCDS), which has been fraught with controversy in recent weeks.

After the departure of the previous Bond Manager, Totem, the Board approved the contract for Blake in 2017 with no bidding process, upon the advice of BHUSD counsel Terry Tao.

Margo previously advocated for a five year contract renewal for Blake. Even the superintendent cannot receive a contract longer than three years, according to California law.

"I have a big issue with what you are saying, Noah. You're suggesting that we are not in support of the program. What we keep saying over and over again is that we are in support of the program, yet we would like to go through a process to understand that what we are getting is market. Those are two different things," Board member Gabriel Halimi said.

In Issue #1165, the Weekly previously reported about blurry invoices submitted by Don Blake. Other issues have included Blake's expired contractors license.

In a 4-1 vote the Board also approved an agreement on Jan. 18 with Pierce, Kavcioglu, Espinosa & Cesar LLP for a limited scope review of the BHUSD construction program. Margo was the sole dissenting vote against an audit.

On Oct. 21 the Board of Education held a special Study Session for a Master Plan update and executive summary to confront the financial challenges faced from implementing the plan.

While closing El Rodeo School entirely for reconstruction in 2019 was supposed to expedite its completion and save money, the opposite actually proved to be true: the new campus is now not scheduled to open until late 2024, two years later than promised.

Blake's contract is scheduled to end in June.

## Board Holds COVID Study Session

At their Jan. 25 meeting the Board of Education held a COVID Study Session and discussed the current measures and mandates the District is enforcing.

Board member Gabriel Halimi presented a presentation regarding the overall impacts the current mandates have on students and recommended the Board do a risk analysis to look into whether the preventive measures outweigh what the actual risk of COVID is to children.

"I think we are sitting on a crisis that we are going to look back on this years from now and be like 'how did we not see this? How were we in a position of power to do something and we didn't do more for our students at that time? I believe from the bottom of my heart that we will all be saying that years from now,'" Halimi said.

The Board was in agreement with potentially modifying the outdoor mask mandate.

"A policy is not effective if it can't be enforced. So, to the outdoor masking I think we are all on the same page here. Is that something we can revisit and take some of the burden off?" Board member

Noah Margo said.

The Board also discussed the current testing policy in place. Currently, unvaccinated students are tested once per week and vaccinated students are tested randomly. This is not mandated by the County and comes from the District.

The Board will revisit the testing mandate at their Feb. 8 meeting.

## BHFA Reach Agreement Regarding COVID Protocols

The Beverly Hills Firefighters Association (BHFA) have reached an agreement with the City regarding the implementation of enhanced practices regarding COVID protocols.

"I am pleased that a consensus has been reached and the community of Beverly Hills will receive the highest level of service it deserves," Fire Chief Greg Barton said.

By Oct. 1, 2021, the LA County Department of Public Health required all health care workers, including paramedics and emergency medical technicians, to be fully vaccinated against COVID or submit to weekly testing if an exemption is granted.

Currently, the vast majority of BHFA members are vaccinated with 18 members having been granted vaccination exemptions due to medical or religious reasons.

The 18 unvaccinated employees will have to submit to daily COVID testing, and wear enhanced personal protective equipment when interacting with medical patients.

"We are pleased with the agreement reached with the city so that the community of Beverly Hills will receive the highest level of service it expects and deserves. We will continue to comply with the LA County Health order through this ongoing crisis for the protection of the community we serve, as well as our firefighters," Board Member of the Beverly Hills Firefighters' Association, Victor Gutierrez said.

According to Chief Communications Officer Keith Sterling, all new hires for the City have to be fully vaccinated.

Beverly Hills Firefighter Josh Sattley is the only firefighter who has been placed on leave without pay, according to his Instagram post dated Jan. 11.

## Traffic and Parking Commission Expected to Discuss Bike Share Update

The Traffic and Parking Commission is expected to discuss an update on bike share programs and provide input to City staff regarding next steps for a new bike share program for the City.

Beverly Hills was the second city in the County to implement a bike share program with 50 smart bicycles distributed among 10 bike share stations. The City contracted with CycleHop in 2016 to operate the new Beverly Hills Bike Share program.

In April 2019, Beverly Hills Bike Share joined Santa Monica, West Hollywood, and UCLA to launch the regional Bike Share Connect bike share network operated by CycleHop. The four-bike share systems integrated into a combined service area, allowing users to travel between

jurisdictions without incurring additional fees.

Both Santa Monica and West Hollywood have since retired their bike share programs and on Aug. 4, 2021 the City's contract with CycleHop expired.

In 2018 residents and business owners expressed concerns regarding safety, interference of shared mobility users with pedestrians on sidewalks, and improper parking of shared mobility devices. The City Council adopted an urgency ordinance on July 24, 2018 to prohibit the use, placement, parking, and/or the rent of use of shared mobility devices in the city. On Dec. 11, 2018, the City Council approved an ordinance extending the prohibition of shared mobility devices in the city through Jan. 18, 2020. On Nov. 19, 2019, the City Council approved an ordinance extending the prohibition of shared mobility devices in the city through Jan. 10, 2021.

On Dec. 1, 2020, the City Council approved an ordinance extending the ban of shared mobility devices, such as electric scooters, in the city until one year after either the State lifts the COVID-19 State of Emergency, or the City Council lifts the State of Emergency, whichever is later.

The Commission is expected to give feedback on the following questions: should the City join with neighboring cities/regional bike share systems or pursue a stand-alone system; should the new bike share program be similar to the previous program or implement a permit system for a private bike share company to operate in the City; it is anticipated that the next program would be primarily, if not exclusively, comprised of e-bikes. Should additional shared mobility devices be considered, such as scooters; and should the City hold off on a bike share system until Metro develops concrete plans for their future bike share program?

## Rent Stabilization Commission to Continue Discussion on Habitability Standards

At their Wednesday meeting the Rent Stabilization Commission is expected to discuss possible amendments to the Rent Stabilization Ordinance regarding the City's habitability standards.

On Jan. 5 the Commission was presented with reports on possible amendments to the ordinance regarding habitability standards; proactive inspections; mediation/administrate board to address habitability violations and associated rent reductions; and to restrict rent increases for properties with habitability violations.

The Commission discussed the issues and requested additional information from staff and decided to continue the discussion at their next meeting.

The Commissioners requested additional information regarding surrounding jurisdictions with habitability standards that exceed the state standards, a report from the Building Inspector Manager regarding the rental housing inspection program and frequency of proactive inspections, among other things.

The state establishes habitability standards. West Hollywood is the only surrounding City to Beverly Hills that has additional habitability/maintenance standards.

West Hollywood's maintenance standards include: repainting rental units every four years; replacing window coverings and carpet every seven years; provide new vinyl or linoleum floor coverings every seven years; replace wallpaper every seven years; maintain appliances in working order; replace common area carpets, draperies, window coverings every seven years; and repaint common area interior every seven years.

The Commission is expected discuss any revisions that should be recommended to the City Council to be made to the ordinance to add Beverly Hills habitability standards, proactive inspections, have the Commission serve as an administrative board to hear complaints concerning habitability violations and determine associated rent reductions, and to restrict rent increases when there is a failure to comply with habitability standards.

## Sunshine Task Force Discusses Revocation Ordinance

At their Jan. 24 meeting the Sunshine Task Force Committee discussed a revocation ordinance in regards to permits for developments.

The potential ordinance would revoke a permit from people who include inaccurate information in an application, or in a presentation at a hearing, for development of a new building or for a remodel of an existing building by more than 50%.

"I am an advocate in the city. As advocates, I think all of us try to be as very specific as we can about the projects. And if necessary the ordinances that we support or oppose. We can't get away with just generally saying people have come before us and they have lied and we've had to pull things out. The people who are promoting the ordinance need to have some specifics to what the problem is. And give us examples of when that has occurred, when the system which Beverly Hills has, which is a terrific system, and is very precise, has failed in this regard,"

Harvey Englander, founder of Englander Knabe & Allen (EKA), said.

EKA recently represented the One Beverly Hills project, which was approved last year.

## Rodeo Drive Committee Approves Podcast for New Season

At their Jan. 27 meeting the Rodeo Drive Committee Liaisons, Mayor Robert Wunderlich and Vice Mayor Lili Bosse, approved a recommendation to City Council for the third season of the Rodeo Drive Committee podcast series titled "Only On Rodeo Drive."

The podcast is dedicated to luxury and

fashion on Rodeo Drive. It was initially approved by the City Council on April 21, 2020. The second season was in 2021 and the third season will be in 2022.

The podcast is intended to guide listeners on a journey through the past and present of Rodeo Drive. Each episode will be about 30 minutes long and will cover topics such as: luxury collections, destination experiences, and the architecture of Rodeo Drive.

The Committee proposed to continue to use President Kathy Gohari as the voice on the street. She will also be joined by co-hosts Pari Ehsan and Jason E.C.

Wright.

The Rodeo Drive Committee has raised about \$30,000 to cover the partial cost of the podcast series and is requesting \$20,000 from the City to cover the remaining expenses. The total cost of the podcast is \$55,000.

The item will be taken to the full City Council for approval at a later date.

## Human Relations Commission to Move Forward with PSA

At their Jan. 20 meeting the Human Relations Commission approved a new work plan item for a new engagement project for BHUSD.

The Commission was asked to review the status of their existing work plan for adoption at their next meeting. The current work plan is intended to focus on integrating the principles of tolerance, acceptance, and civil discourse into community services events, programs, and services. During the past year, the Commission promoted these principles through the continuation of the annual Embrace Civility Award, the celebration of Civility Month, and Kindness Week.

The project will consist of a 15-minute presentation intended to teach young students about "diversity, love, acceptance, civility, and anything that will help us make a better world," Chair Rhoda Sharp said.

The Commission was previously involved with a production of an anti bullying video. This will be an ongoing project for the Commission.

## AMIE'S AMBITIONS

### Recreation and Parks Commission Chair Amie Sherry on Giving Back to Her Community

#### What made you want to join the Rec and Parks Commission?

A few years ago my husband [Dean Sherry] and I participated in the Team Beverly Hills program and we are both lifelong residents, born and raised here. This really gave us an opportunity to see our City in a new life with greater appreciation as to what it takes to operate the City of Beverly Hills. Not long after that, I saw an opening on the Recreation and Parks Commission.

I grew up in a family where Beverly Hills civic politics was something I was really familiar with. My mom [Nancy Nebenzahl] had served on the Fine Arts Commission and my dad was behind many of our past mayor's campaigns and donated a lot of his free time to the Beverly Hills Fire Department. So, having this opportunity come at this time felt like the perfect fit for me to give back to the City that had given so much to me and my family.

**You grew up in Beverly Hills and graduated from Beverly High in 1992. What made you want to come back and raise your family here?**

Well, I went to school [at UC] Santa Barbara so I wasn't far away. I was always drawn back to Beverly Hills because it was such a small community. It just felt comfortable to me and I wanted to be close to my family. It just seemed like the right place for me to settle down and begin my adult and professional life.

**You are a school-aged parent, which is unusual for this Commission, do you believe you bring the point of view of a younger parent to the Commission?**

I do, I think it's really allowed me to zero in on those programs that otherwise might have been overlooked that I myself participate and my children are

active in. Such as the Adventure Camp which is our after school program. Our Teen Advisory Committee, which is a way to get our middle aged kids involved in our community. My children participate in those and it's sort of a way to impact our younger generation in terms of showing them how to be involved in their City as well.

**To what degree are your sons having the same experience you had growing up in Beverly Hills?**

They [Jack and Beau] are going to the schools [Beverly Vista and Horace Mann] that my husband and I both went to. That's fun because they have some of the same teachers and similar experiences. They are both active in sports. I grew up on Roxbury Drive so being at Roxbury Park was the place that I grew up and had so many experiences that really formed who I am as a resident of this City and how I care for our community. We now live close by there so it's the place where our children have grown up too, and there's something really special about that.

**La Cienega Park is due for renovation, but the plans were put on hold. Is this an issue your Commission plans to revisit?**

We haven't discussed it as of right now. It's sort of been tabled. Seeing that this Pandemic has hit everybody tremendously, our Community Services Department has gone through a lot of changes in this last year. They have really had to pivot their focus. When the Pandemic hit they were incredible in terms of how quickly they were able to move a lot of our classes that were in person, online. We really felt as residents that we were not missing out on so many of the classes we depended on or relied upon that brought us joy,
