City Council Delays Approval for Proposed Doheny Drive Bike Lanes

The City Council delayed the approval of a proposed conceptual design of Class II Bike Lanes without removal of vehicle travel lanes or parking spaces on Doheny Drive between Burton Way and the southern City limit at Whitworth Drive, at their Tuesday Study Session. The Council decided to continue the discussion in order to get more input from residents.

Doheny Drive between Burton Way and Whitworth Drive is mostly a residential street with on-street parking and one travel lane in each direction throughout the majority. Proposed bike lanes on Doheny Drive would not result in any reduction in the number of vehicle travel lanes, turn lanes or on-street parking spaces.

The section of Doheny Drive from

Whitworth Drive to Charleville Boulevard is 46 feet wide with one 23-foot shared travel and on-street parking lane in each direction. This segment has one 16-foot travel lane in each direction when on-street parking is utilized. Bike lanes would narrow the travel lanes to 10-feet wide to accommodate six foot bike lanes in each direction.

At the Doheny Drive/Olympic Boulevard intersection, additional travel lanes and turn pockets are provided. Bike lanes approaching the intersection would convert to combined bike lanes/right turn pockets, similar to the configuration of eastbound North Santa Monica Boulevard at Beverly Boulevard.

At the southwest corner of Doheny Drive/Olympic Boulevard, the southbound curb-adjacent travel lane is proposed to be converted to a combined bike lane/right turn lane into the Hillel Academy student loading zone. Hillel Academy did not oppose the changes, but requested that a dedicated bike lane be provided instead of the combined bike lane/right turn lane if determined feasible. If approved by the Council, this would be explored as part of the final design phase.

The block of Doheny Drive from Charleville to Wilshire Boulevards is a 46-foot wide commercial street with two travel lanes in each direction and a center turn lane with access to parking garages. All travel/parking lanes range from approximately 9 to 9.5 feet wide. This block is proposed to have sharrow markings instead of actual bike lanes so that there are no impacts to peak hour travel lanes.

The segment of Doheny Drive from Wilshire Boulevard to Burton Way is 42 feet wide with one 21-foot shared travel and on-street parking lane in each direction. The street width is too narrow to add bike lanes in both directions while keeping both travel lanes and on-street parking. Therefore, this segment is proposed to have a six foot bike lane in the northbound direction and sharrow markings in the southbound direction.

Installation of the bikeway on Doheny Drive is estimated to cost approximately



\$5,000.

One Step Forward for City

The City Council discussed a request by Mayor Robert Wunderlich regarding the possible implementation of a local City shuttle system and expressed interest in pursuing it, at their Tuesday Study Ses-

The Climate Action and Adaptation Plan (CAAP) Community Advisory Committee (CAC) has also identified a shuttle system as a way to help the City reduce greenhouse gas emissions.

The City does not currently operate a regular transit service for the public. The Complete Streets Plan recommends that the City explore a shuttle system, which would connect the future Purple Line subway stations to the business district.

According to the staff report, Beverly Hills currently offers multiple trans-



portation programs. including dial-a-ride transport for resident seniors and disabled persons and provides the City-owned trolleys

for special

event char-

ters and shuttle service between the Third Street tour bus under a joint contract with West Hollywood, with each program operating independently and restricted to residents of each city. In anticipation of the opening of the

Metro subway stations along Wilshire Boulevard, the current work plan for the Traffic and Parking Commission and staff includes exploring shuttle service options for the public between the future subway stations, major Metro bus stop connections and the business district.

The CAC will work together with Traffic and Parking Commission Chair Sharon Ignarro, who is also on the CAC,

as the connecting point. They also intend to flesh out the routes and operating details and involve BHUSD for input and development costs.

Board Discusses Implementing Grandparent Permits

meeting Superintendent Michael Bregy suggested implementing permits to allow the grandchildren of residents to attend schools in BHUSD. These are known as Grandparent permits.

Blake Employee Criticizes Citizens Bond Oversight Committee Member Comments


Pam Johnson, who was hired by Bond Manager Don Blake's Team Concept Development Services (TCDS) as the Program Administrator for the BHUSD construction program, sent a letter on March 11 to members of the Citizens Bond Oversight Committees CBOC) addressing comments made by some committee members in regards to Blake.

On Feb. 17 Committee member Marc Carrel questioned if having the Board hire the financial auditor was the best practice.

"Is that the best practice to have the Board hire an auditor and have that auditor be answerable to the Board where the oversight committee does not have control of the auditor?" Carrel said on Feb. 17.

Carrel said he was not being critical of the Board and was pleased with how they did not automatically rehire Bond Manager Don Blake due to the fact he did not have a valid contractor's license.

Johnson stated that her opinion is that no "state certification" is currently required to provide bond management services.

"It is true that the Board of Education has requested that the bond manager acquire a contractor's license. Even though legal opinions and IR A-3 from the Division of State Architect conclude no contractor's license is necessary because the bond manager acts as an agent of the Board, the bond manager has agreed, as a courtesy to the Board, to apply for the license," Johnson said.

Johnson failed to state what the actual legal opinion was and who rendered it

Johnson also cites the "DSA Interpretation of Regulation A-3" to support her claims that Blake does not need a valid license. It describes several levels of "construction manager": Construction Manager (CM), Construction Manager Multiple Prime (CMMP), and Construction Manager at Risk (CMAR). Citing the IR A-3 may be inapplicable as it only applies to a "construction manager."

Johnson also criticized committee member Harry Kraushaar's comments stating that the construction updates were not helpful to the CBOC and that Team Concept Development Services needed to point out what the committee should be looking for. Johnson then listed in her letter the complexity and hardships faced in the BHUSD program.

Johnson said that the program is very complex and has gone from a "program in disarray to a top tier program in the five years of leadership under Don Blake." She continues that "the story is not just Don Blake. It is also the talent of the team he has brought to Beverly Hills," this includes herself. Johnson failed to state that she was not brought to Beverly Hills by Don Blake, she was actually an employee of the District, Acting Head of its Facilities Department but left to work for Blake in 2017.

Johnson also claimed that Blake "developed a full-spectrum security program" but stopped short of mentioning that the original security company Blake contracted with, iXero, sued Blake, former BHU-SD attorney Terry Tao, and then the BHU-SD. If the District does not rehire Blake as the bond manager, Johnson will most likely no longer work on the construction program.

"So, here is my opinion: Irrespective of the direction the Board of Education chooses for the future of the bond program, what the committee should seek to understand -- and be concerned about -- was verbalized by [Committee member Lee] Egerman during the meeting: 'A change like this [replacing the bond management team] will; impact construction by millions of dollars... and to (understand) what it means when you replace or talk about replacing a project manager, the bond manager... This is a huge change and will directly impact the whole District," Johnson said.

An anonymous group calling themselves the "Citizens Against Corruption Association (CACA)" wrote to the Board of Education, to refute some of Johnson's claims.

"Pam Johnson: Stay in your lane," the letter warned.

Board to Change COVID Testing Protocols

The Board of Education gave direction to Superintendent Michael Bregy to give the COVID testing contractor Doctor Now notice to terminate the Districts contract on April 22 for PCR Testing services, at their March 8 meeting. The District is required to give a one month notice upon termination of the contract.

For the next two weeks, the current testing policy will remain the same. This means unvaccinated students will still be tested once per week and vaccinated students will be tested randomly.

They will review changes at their next board meeting but suggested they might test both vaccinated and unvaccinated randomly, once per week rather than the current policy in place.

"I don't think it's logical any longer to say 'you're vaccinated so, therefore, you can't transmit it, so why do we need to know?' That just doesn't seem logical," Board member Mandy Stern said.

Regardless of any changes, the PCR testing will end on April 22.

Although the PCR testing will soon come to an end, rapid antigen testing will continue indefinitely. This means, regardless of vaccination status, any visitor or volunteer entering inside any BHUSD building for more than 15 minutes before 4:00 p.m. on school days, must go to the District Office and take a Rapid Antigen Test prior to entry.

As of March 14, students were also no longer required to undergo health screening but the district will continue with thermal testing of students.

The Board gave direction to send testing kits home for use upon returning from spring break.

The Board will re-evaluate data at the next board meeting to see whether or not masks have an impact on infection rates.

Library to Restore Hours

The Beverly Hills Public Library has announced they will be restoring hours.

As of this week, the hours are as follows: Monday through Thursday 10:00 a.m. to 8:00 p.m.; Friday and Saturday 10:00 a.m. to 6:00 p.m.; and Sunday 12:00 noon to 6:00 p.m.

Phone services are as follows: Monday through Thursday - 9:30 a.m. to 7:30 p.m.; Friday - 9:30 a.m. to 5:30 p.m.; and Saturday and Sunday - no phone service. Customer Service and Passports hours are as follows: Monday through Thursday - 9:30 a.m. to 7:30 p.m.; Friday and Saturday - 9:30 a.m. to 5:30 p.m.; and Sunday - no service.

During the week of March 21 the library will reopen the Teen Zone from 3:15 p.m. to 6:15 p.m.

The tentative regular schedule is set for April 14

Margo Calls for End to Endorsements; Board Appoints Committee Members

Board of Education Vice President Noah Margo called for an end for Board members endorsing candidates in both city and Board of Education elections, at their

March 8 meeting.

"The whole process is awkward. City officials feel pressured into lending their names. Most of them, there are good candidates that can't get our support because we are already spoken for or they came into the race much later on. The whole process creates a sense of unease that can be eliminated rather simply," Margo said.

Margo also said that it could force positions on certain issues that are related to both entities. Margo proposed the Board draft a resolution or a bylaw that no sitting board member can endorse in a city council or school board election. He also suggested the City Council draft a similar governing language.

As of March 9,

Margo was listed as an endorser of current City Council candidate Andy Licht. He also previously endorsed Board member Mandy Stern, first elected in 2020.

"Yes, I recognize that some of us up here have been the beneficiary of endorsement or have loaned their name to campaigns. But that will always be the case until this rule is put into effect," Margo said.

The Board also appointed members to both the Finance Committee and the Facilities and Construction Committee.

Joy Hayes was appointed by Mary Wells to the Finance Committee and Kim Hartley was appointed by Mandy Stern to the Facilities and Construction Committee.

Planning Commission Discusses Accessory Dwelling Unit Ordinance

At their March 10 meeting the Planning Commission received a study session regarding the City's Accessory Dwelling Unit (ADU) Ordinance that focused on by-right ADU regulations in single family zoning districts. A future study session will be provided to the Planning Commission to discuss ADUs in multi-family zones as well as other process and program changes related to ADUs.

By-right ADU regulations do not require entitlements or permits preceding the building permit if minimum requirements can be met)

An ADU is defined as an independent living facility on a residentially-zoned lot, accessory to a primary dwelling unit on the same lot. An ADU must also include a cooking facility and may be rented as a separate unit.

The City's ADU regulations were updated in 2017 in order to comply with Calif. laws. Since then, the state has ad-

opted extensive changes to the ADU law to further incentivize the development of these units and, thus, the City must update its current regulations accordingly.

The current state regulations provide greater flexibility for the development of ADUs than the City regulations and, where such standards conflict with existing City regulations, the state regulations prevail.

Beverly Hills Municipal Code outlines a two-tier system for ADUs: those that are allowed by-right, and those that may be approved through a discretionary permit. At a minimum, city staff will create an ordinance that complies with current state

The City plans to hold a workshop with the community in order to get further input. Staff will then return to the Planning Commission in the future to present a draft updated ADU Ordinance for consideration. Once the Planning Commission recommends a draft ADU Ordinance, staff will forward the ordinance to the City Council for adoption.

No Need for Dog Waste Bags on South Beverly

The Public Works Commission received a report on the need for dog waste bags on South Beverly Drive at their March 10 meeting and did not find there was a demand for them.

Currently, there are 35 dog waste dispensers and receptacles installed and operational at City parks. Locations include: Beverly Gardens Park, La Cienega Park, Roxbury Park, Coldwater Park, Reeves, Arnaz, Oakhurst and Hamel mini-parks and the Dog Park.

In Beverly Hills, it is unlawful that ani-

mal defecation is left on public and certain private properties.

The City's efforts to reduce dog waste on public property have been focused on public outreach and education which includes providing signs that say "It's your Doo-ty.. Pick it up!" to residents to post on their property.

The City has not installed dog waste dispensers and receptacles in the business area because there is no demand for this, although, Public Works received a total of six service request calls to clean up dog waste in the commercial areas from 2021 to present. There were more calls for service requests related to human waste than dog waste up to now.

In addition, installing dog waste bag dispensers and receptacles in non-park locations would add another good sized asset that needs to be maintained and could impact pedestrian traffic, according to the staff report. South Beverly Drive is currently a heavy pedestrian traffic area.

According to the staff report, "To help manage the pedestrian traffic existing trash receptacles are placed strategically to reduce pedestrians from overflowing outside of the sidewalk. Installing dog waste bag dispensers and receptacles would reduce available sidewalk and may impact pedestrian safety."

Public Works staff clean the South Beverly Drive sidewalks three times a week and conduct a daily site assessment to identify areas where immediate action should be taken, according to the staff report.

Public Works staff said they will continue to monitor the dog waste service requests on City sidewalks. If the current cleaning service is not sufficient, staff will revisit the item for possible implementation.

"This is a tough one because I take my dog out for a walk and then realize the little dispenser was empty and you have to come back or find a discarded newspaper or something like that to pick it up. But [for someone] to expect a doggy bag station on South Beverly [they] are not planning on picking it up in the first place, unfortunately," Chair John Millan said.

If Public Works staff decided to install the dog waste service on South Beverly Drive, it would cost approximately \$1,150.

Legislative Lobby Committee Gives Ok for Ballot Initiative Resolution

Councilmembers John Mirisch and Julian Gold were in favor of presenting the City Council with a resolution in opposition to a ballot initiative that would limit local governments' ability to raise revenues for government services, at their March 8 Legislative Lobby Committee meeting.
