

"Chamber of Commerce Candidates' Forum"

There was never an excessively large development project which was not promoted by the Beverly Hills Chamber of Commerce, without any reservations whatsoever, and without any concerns for residents' interests.

For instance, the Chamber was all in favor of Cheval Blanc, the up to 9 story project which is way out-of-scale for our village and which would bring traffic on little Santa Monica to a grinding halt. Nevertheless, such large projects which violate our building codes, are consistently recommended by the Chamber of Commerce as a matter of course without any study, and the Chamber's priority remains businesses without any consideration whatsoever for residents' interests.

As a candidate for City Council, I received an invitation to meet with the Beverly Hills Chamber of Commerce "Leadership PAC" to discuss my candidacy. Although it was represented in the e-mail message that the PAC acts independently of the Chamber, the message was sent under the logo of the Beverly Hills Chamber of Commerce.

I also received an e-mail message advising that the Chamber of Commerce was organizing a forum for city council candidates and requesting my participation. However, the message further explained that instead of a full candidates' forum. there would be two separate, consecutive 1 1/2 hour sessions of the candidates' forum. Further, the Chamber had scheduled all of the city council incumbents and candidates most likely to favor the views of the Chamber, for the first 1 1/2 hour session, and relegated the remaining candidates to the second session so they would lose all members of the audience who did not wish to sit for 3 hours.

I objected to the unfair procedure and inquired as to who had decided which candidates would be in which session. However, rather than addressing my query, I received an e-mail message from Todd Johnson, President & CEO of the Chamber, stating that if I wanted to participate, great, "but if not, move on."

Besides favoring incumbents and candidates who share the Chamber's views, a further conflict of interest exists because city council incumbents decide how much of the city's money is allocated to the Chamber of Commerce.

Candidate forums should be encouraged and televised for the benefit of all residents. But no one should waste their time participating in or viewing a bifurcated kangaroo forum. And the endorsements of the Chamber and its PAC should be respected commensurate with the Chamber's level of objectivity and fairness—or in other words, not at all.

Brazen Smash-and-Grab Burglary on South Beverly

On Tuesday at approximately 1:46 p.m. BHPD received a call of a burglary in progress in the 200 block of South Beverly Drive.



Approximately five people weilding sledgehammers got out of a car and used the sledghammers to break out the plate glass window of a jewelry store. The suspects removed property from the display window and fled on foot out of the area. The vehicle they got out of was left behind and it is a reported stolen vehicle.

According to KTLA, Peter Sedghi, the store's owner, said his employees pushed the store's panic button and that the amount of what was stolen could be up to millions of dollars.

Detectives will be conducting an investigation and BHPD said they are adding a camera trailer, extra security patrols, and extra special watch from officers to South Beverly Drive.

Board Approves Construction RFP

The Board of Education approved a final request for Proposal (RFP) for bond management services regarding the construction program, at their Tuesday meeting. The vote was 3-1, with Board Vice President Noah Margo opposed and Board member Gabriel Halimi absent.

The Board previously directed staff to create an RFP for Bond Management Services because the current contract with Don Blake's Team Concept Development Services (TCDS), who now provides these services for the District, expires July 17.

The move could effectively end the role of TCDS, which has been fraught with controversy in recent weeks.

After the departure of the previous Bond Manager, Totem, the Board approved the contract for Blake in 2017 with no bidding process, upon the advice of BHUSD counsel Terry Tao.

All Proposals are due by 4:00 p.m. on Monday, May 23.

Board member Rachelle Marcus said she has been following the monthly payroll for TCDS and the last one she saw for the last two weeks of Feb. was for \$121,000 and the previous two weeks were for \$147,000. In one month that added to \$268,000 for Feb. alone.

"If I were to project that over a whole year, that we would be paying \$3.2 million for one year alone for payroll for the project. I found that amount unbelievable," Marcus said.

TCDS is budgeted to bill approximately \$9 million in fees and hourly rates for the 2021-2022 school year.

Margo has been against sending out an RFP during the whole process. He said he does not believe there is any company that can duplicate the success that TCDS has had. Margo also said that Blake can not send out an RFP because he is too busy getting his contractor's license and that it is the Board's fault that he has to do that.

"As Declan McManus once said 'well, I just don't know where to begin.' I have spent months thinking about this moment. It has come down to what I hope I can say

to stop this train from completely derailing. The decision that is about to be made by this governing body is in fact the most dangerous and impactful decision I have ever been a part of. For the past five years we have been building under a bond program led by Don Blake and his team at TCDS," Margo said.

Blake was supposed to present an agenda report providing a construction update, but left the meeting after the Board approved the RFP

"What we really need as a Board is not binders, pie charts, and lots of pretty pictures. What we actually need is information that is substantial that allows us to make informed decisions to be the stewards of our bond program," Board President Mary Wells said.

Margo walked out at the end of the meeting prior to the end of Wells' comments.

A change.org petition started by Deena Wachtel also circulated on Facebook requesting signatures in an effort to stop the

"As a BH resident and taxpayer, I am concerned about the plan to embark on an RFP cycle to potentially replace TCDS in the District's construction program without any apparent data or rationale that warrants not moving forward with the current provider and their sub-contractors. It seems to me that this process would unavoidably increase the time and cost to complete the program and there does not appear to be any evidence that TCDS is not performing their role satisfactorily," the petition said.

El Rodeo Still Behind **Schedule**

At the Tuesday Board of Education meeting BHUSD parent Judy Kermani Manouchehri called in during the public comment period to address the Board regarding a video she recorded that shows no activity at the El Rodeo construction site.

In the video, Manouchehri recorded a vacant site with only one truck and three worker cars nearby.

"Don Blake, this is Judy, please give me a call. We can have a discussion, man-toman since none of the men who have been representing our community cares to put their foot down and do a damn thing," Manouchehri said in the video.

El Rodeo School closed entirely for reconstruction in 2019 in order to expedite its completion and save money, however, the opposite actually proved to be true: the new campus is now not scheduled to open until late 2024, two years later than prom-

7:00 p.m. on March 24 because the commission decided to send the project back with revisions to address the issues that were raised.

On March 3 the City received correspondence from the Applicant's representative stating:

"We appreciate the Commission's detailed comments, questions and requests made at the February 24, 2022 hearing on the Project. We are engaging in detailed studies regarding options for addressing the issues identified at the hearing. Those studies will take time, and we are therefore requesting continuance of consideration of the Project to a date uncertain."

After receipt of the continuance request, the City also received correspondence from the representative of neighboring retailers, Hermes, Armani, and Chanel. This correspondence acknowledges their understanding that the Applicant has submitted the continuance request and advises the Commission "that we will withhold further public comment and temporarily suspend pursuing the potential reversal of the alley until such time as the new LVMH hotel plan is re-submitted"

It is expected that the Planning Commission will postpone the hearing and contin-

ue it to a date uncertain.

City Council Extends Discussion on 1001 North Roxbury Drive House

Councilmember John Mirisch requested that an item be placed on the City Council March 15 agenda to determine if there is Council support to call up for review a Certificate of Ineligibility decision issued for the residence located at 1001 North Roxbury Drive.

A certificate of ineligibility bars the Cultural Heritage Commission or the City Council from initiating landmark designation proceedings concerning a particular property for a period of seven years from the date of issuance. While a certificate of ineligibility is in effect, the subject property cannot be listed on the local inventory, or subject to the provisions of the Municipal Code pertaining to designated and/or eligible historic resources in the City.

On Feb. 1 a memorandum was prepared by City staff, pursuant to an application received from the property owner, and circulated to the Cultural Heritage Commission. Along with the memorandum, a Historic Assessment Report prepared by the applicant's historical consultant (ESA) and a peer review memorandum prepared by the City's historic Consultant, Jan Ostashay of

Ostashay and Associates Consulting (OAC), was circulated.

The circulation of the documents to the Commission allowed a period of review by the Commissioners during which they were able to provide any additional pertinent information to the staff as the review of the eligibility of the property is undertaken. During the circulation to the Commission, there was no additional information provided to staff regarding the eligibility of the property. The staff memorandum, the applicant's consultant's assessment, and the peer review by the City's consultant all concluded that the residence did not meet the criteria for local historic designation.

On March 2, staff completed the review and concluded that the residence did not meet the strict criteria for historic designation outlined in the Municipal Code. A decision granting the certificate to the applicant was subsequently issued and then circulated to the City

AN ORDINANCE OF THE CITY OF BEVERLY HILLS TO AMEND THE BEVERLY HILLS MUNICIPAL CODE TO CLARIFY OR ADD LANGUAGE RELATED TO DEVELOPMENT PLAN REVIEW EXEMPTIONS FOR INCREASES IN BUILDING HEIGHT, THE ALLOWABLE HEIGHT EXEMPTION FOR ROOFTOP ELEVATOR ENCLOSURES ON COMMERCIAL BUILDINGS, THE ALLOWABLE HEIGHT EXEMPTION FOR ROOFTOP DECKING MATERIALS AND PARAPETS ON MULTIFAMILY RESIDENTIAL BUILDINGS, THE ALLOWABLE ROOFTOPS USES AND STRUCTURES FOR A MULTI-FAMILY RESIDENTIAL AND MIXED USE BUILDING, THE DEFINTION OF A PRIVATE TRAINING CENTER, AND REQUIREMENTS FOR FENCE OR WALL FINISHES

This Ordinance is part of an ongoing effort to amend language in the Beverly Hills Municipal Code (BHMC) to improve clarity, remove outdated references, and align code language with current practices. The proposed amendments included in the Ordinance do not represent substantive changes to the current meaning or interpretation of the code sections being amended. The proposed ordinance would modify the BHMC as summarized here:

- •BHMC §10-3-3100: Adding a threshold for an increase in building height that is exempted from the requirement for a Development Plan Review application;
- •BHMC §10-3-100: Amending the definition of height for commercial buildings to increase the allowable height exemption for an elevator enclosure on commercial buildings;
- •BHMC §10-3-100: Amending the definition of height for multi-family residential buildings to allow the addition of decking materials for rooftop amenities, and a proportionate increase in the parapet height;
- •BHMC §10-3-100 and 10-3-1880: Adding an allowable height exemption for residential rooftop amenities and structures for multi-family residential buildings and mixed use buildings, and clarifying that the multi-family definition of height applies to mixed use buildings;
- **•BHMC §10-3-100:** Amending the definition of 'private training center' to be consistent with the regulations in BHMC §10-3-1617; and
- **•BHMC §10-3-2420, 10-3-2516, 10-3-2616, and 10-3-2814:** Adding requirements related to the finishing of fences or walls in residential zones.

The draft ordinance was previously reviewed by the Planning Commission at their February 24, 2022 regular meeting, and the Commission unanimously recommended this ordinance for approval by the City Council.

This Ordinance has been assessed in accordance with the authority and criteria contained in the California Environmental Quality Act (CEQA, Public Resources Code Sections 21000

et seq.), the State CEQA Guidelines (California Code of Regulations, Title 14, Sections 15000 et seq.), and the environmental regulations of the City. The adoption and implementation of the Ordinance represents minor semantic changes to the existing code and does not represent substantive changes in meaning or interpretation of the code. It can therefore be seen with certainty that there is no possibility that the proposed amendments may have a significant effect on the environment. Accordingly, the City Council will consider the recommendation to find the Ordinance exempt from the environmental review requirements of CEQA pursuant to Section 15061(B)(3) of Title 14 of the California Code of Regulations.

The City Council may order a review of any decision made by any commission, board, or official of the city.

Cultural Heritage Commission Chair Craig Corman and Commissioner Jill Collins who were part of the review process, were also present at the meeting. As of March 14 at 11:59 p.m., two articles from two different publications had been discovered by Collins. Part of the reason the Certificate of Ineligibility was granted was due to no discovery of architectural publications. Since there are two new publications, the City Council directed staff to review the articles in order to determine if the Certificate of Ineligibility is equitable.

'The new information, which are two articles that have yet to be produced, is very strange. One article that we were able to find does not meet any of the guidelines of the City ordinance. What is particularly interesting is that the article they claim was so important in this magazine, doesn't even mention or show a picture of the architecture of the house. It's all about interior design. Nothing that they said meets the criteria of the City Ordinance. It's disappointing that they led the Council into believing that it did. I think the Council was very generous to these people and the Council should be upset that they were misled," EKA founder Harvey Englander, who is representing the property owner, said.

The discussion will continue at their April 12 meeting.

"I think that we do have to open up our investigation further afield in the future. The two publications I was able to find, [are] Architectural Digest, which I think is an accredited magazine, and Lux Magazine, you know, trade magazines do count. I think they should be looked at, and I think we should see what else is out there," Collins said.

City Council Approves Extension for Temporary Outdoor Dining Tent for NusrEt

At their March 15 meeting the City Council approved the extension for the temporary outdoor dining tent for NursEt to Dec. 31, as long as all interested parties have reached an agreement.

At their March Study Session the City Council discussed and recommended the extension of the temporary OpenBh program to the end of this year. The City created the OpenBH program in June 2020 to allow businesses to temporarily expand their services to adjacent outdoor areas such as private parking lots, sidewalks, and metered parking spaces, otherwise known as parklets, through a no-fee Special Event Permit. This was in response to the pandemic.

At their March 1 meeting the City Council also directed the representatives of NusrEt restaurant located at 184-88 North Cañon Drive to work collaboratively with the property owners for the 190 North Cañon Drive building to find a solution regarding the temporary outdoor dining tent for NusrEt located in the 100 block of North Cañon Drive.

The OpenBH permit for NusrEt for the temporary outdoor dining tent in the 100

block of North Cañon Drive was set to expire on March 31.

The City Council previously denied Nusr-Et's extension request at their March 1 meeting after concerns were raised around increased litter, loitering, decreased parking, and the structure of Nusr-Et's tent, which goes past their property line.

The three resolutions presented by City staff are as follows: a Reduction in tent size by 18-20 feet; Reduced valet hours; and updates to the traffic control equipment and signage to be more aesthetically pleasing, and less like a temporary road closure.

If all interested parties reach an agreement, the temporary outdoor dining tent will be extend until the end of the calendar year.

City Council Approves Appointment of Knabe as Interim Deputy Fire Chief

The City Council approved the appointment of Wolfgang Knabe as Interim Deputy Fire Chief for the City, at their March 15 meeting.

Former Deputy Fire Chief Joseph Matsch retired from service on December 21, 2021, creating a vacancy for the position.

The City has posted a recruitment for the permanent appointment of the Deputy Fire Chief and intends to secure the specialized

services of a qualified person to serve as Interim Deputy Fire Chief on a temporary, interim basis while the City seeks to permanently fill the position.

Knabe retired as Fullerton/Brea's Fire

Chief in 2018 after a public safety career that spanned four decades. He recently served as Interim Fire Chief for the cities of Manhattan Beach and Santa Monica and has extensive experience in managing fires in both urban and hillside settings.

"I am thrilled to welcome Wolfgang to Beverly Hills. His vast expertise across Southern California will bring tremendous value and support to our department," Fire Chief Greg Barton said.

The Interim Deputy Fire Chief would not be a candidate for the permanent appointment.

Board Awards RFP for Financial Auditing Services

At their Tuesday meeting the Board of Education awarded an agreement to Christy White, Inc. (dba Chirsty White Associates, Inc.) to perform District and Bond financial audits.

In conjunction with a need to contract with a new Auditing Firm, a Request for Proposals (RFP) was prepared for District and Bond financial auditing services and sent to potential professionals. Proposals for these services were received from five firms. A committee that included District staff, Citizen's Bond Oversight Committee, and Finance Committee members, evaluat-

ed all proposals and identified three firms to be interviewed.

These firms were invited for an interview on March 10, 2022: Christy White, Inc. Crowe, LLP Nigro & Nigro, PC.

The contract total for Christy White, Inc. is not to exceed \$53,429.00.

Human Relations Commission Receives BHPD Update

On March 17 the Humans Relations Commission received a summary from BHPD Lieutenant Giovanni Trejo regarding some of last months crime statistics.

The police department handled approximately 234 calls for service involving homeless people with 22 of the contacts resulting in arrests for a variety of reasons which included felony warrants, drug charges, providing false information to a police officer, and delaying or resisting arrest.

"We are working with community service to provide solutions to some ongoing problems. The concern is we see repeat offenders daily and our vision is to provide the folks with more help and assistance to break the cycle," Trejo said.

The department is also engaged in an aggressive recruitment campaign. They

are processing about 16 new candidates through the selection process. Statistically only a small percentage of those numbers will make it through the entire selection process which includes the academy and field training.

"We are making a lot of progress," Trejo

Planning Commission to Discuss Updated Safety Element

The Planning Commission is expected to consider a resolution recommending the adoption of a revised Safety Element to the City Council, at their Thursday meeting. They will also consider recommending that the City Council find this categorically exempt from further environmental review.

The State requires every city to have a Safety Element in its General Plan. The City of Beverly Hills' current Safety Element was adopted in 2010. The City's Local Hazard Mitigation Plan for 2017-2022 was adopted in 2019 and is included as part of the existing Safety Element of the General Plan.

The General Plan is a long-term document that guides the development of the city, addresses issues affecting the region and city, and sets forth its priorities for initiatives and programs through the various goals and policies of each element.

The Safety Element specifically looks at how to reduce and plan for the potential risks associated with natural disasters, and public emergencies, including the risk of death, property damage, and social and economic disruptions. The Safety Element includes policies and goals that outline preparedness methods to address risks associated with wildfires, floods, geologic and seismic hazards, hazardous materials, noise, and man-made disasters.

According to the staff report, the Local Hazard Mitigation Plan is a subsection of the Safety Element that looks at the activities that may be able to reduce risk and prevent loss from future hazard events. This analysis is considered to be the first step for disaster prevention and allows the city to be eligible for federal mitigation funding when disasters occur and to apply for mitigation grants used prior to disaster events. The mitigation plan also includes a variety of resources to assist city departments, residents, and private and public organizations in planning for disasters and hazards.

The Planning Commission was previously presented with an introductory overview of the Safety Element Update at their Nov. 18 Study Session. At this meeting, the Commission had several comments regarding potential updates to the Safety Element. Two comments related to maps that are in the Local Hazard Mitigation Action Plant. These comments will be conveyed to the team that will update the Local Hazard Mitigation Action Plan soon. An additional comment was made about including a reference to the new Just In Case BH Program. This program helps create a Neighborhood Emergency Response Team, comprised of trained citizens, and provides education on disaster preparedness. References to this program have been added to the Safety Element.


Additionally, the draft Safety Element documents were presented to the Commission during their Jan. 13 study session meeting. The Commissioners provided their comments on the draft, which included the following: include additional information regarding the City's communications system for disasters; include information regarding resources for evacuating disabled populations during a disaster; Policy 3.6, which discusses the need to retrofit public facilities and infrastructure from climate change hazards, could also mention upgrades to private facilities; and potentially include the expansion of City transportation services within existing or new policies.

These comments have been addressed in the revised Safety Element documents.

The draft Safety Element Update was also included as an informational "C Item" on the agenda for the City Council meeting on Feb. 8. This was intended to make the Council aware of the current status of the Safety Element Update. No comments were provided by the Council at the time of the meeting.

Due to recently adopted State laws, the Safety Element must also be updated to address climate change and the risk of fire for land in designated very high fire hazard severity zones. The city includes land in a Very High Fire Hazard Severity Zone, which is all of the land area located north of Sunset Boulevard.

The Commission is expected to discuss the information presented in the revised Safety Element Update documents and provide their comments. If the Commission adopts the resolution recommending the adoption of the Safety Element to the City Council, it is expected to be presented to the City Council for adoption at their first regular Council meeting in May.

Jewish Federation CEO Rabbi Noah Farkas Discusses his First-Hand Account of Visiting the War-Torn Area

Recently appointed Jewish Federation of Greater Los Angeles President & CEO Rabbi Noah Farkas, along with the Jewish Federations of North America (JFNA) and Federation Campaign Chair

Lynn Bider, traveled to the Ukraine border on a humanitarian mission from March 13 - 16. Rabbi Noah met with refugees, ensured the impact of funds raised by the Federation, and provided emotional and spiritual support to those in need.

Currently, the Federation and its partners are assisting approximately 100 families per day, to flee Ukraine and settle in Israel. This work includes helping these refugees with documentation, travel logistics, and providing vital medical and nutritional resources.

You recently travborder on a humanitarian mission. Tell us about that.

I am the President

and CEO of the Jewish Federation of Greater Los Angeles. As part of the international work that we do, we fund a number of really important programs in Eastern Europe including home aid, mental health work, and medical work in Ukraine and Poland. When the invasion happened, many of our recipients obviously were deeply and greatly affected. So, I went on a delegation with

my colleagues from the largest city federations in North America to Poland and to Ukraine to see the work that had been done on the ground, hoping to get refugees out and turn several of our pro-

> gramming centers into refugee centers. And doing a needs assessment so we can raise additional funds. I was only there on the ground for two days, but it was an extraordinary event. What I saw was really powerful.

What I saw were two stories happening simultaneously. The other devastation and despair that this invasion and this war have rotted on men, women, and children. Especially the elderly, the frail, [and the] children. It was typical that I would see a woman or a couple of women hoarding a group of children. eled to the Ukraine despair with this rising Probably three or four children, and sometimes more across the border. The men have been required to

> stay in Ukraine to fight for their homeland. The number of times I saw young kids playing with each other with their older siblings kind of looped in their cell phones lying on a bench, and moms exhausted staring into the horizon not knowing what to do next, that image I saw over and over again.

That level of exhaustion, despair, and trauma was met with what I think is actually the second story. Which is the hospitality of the Polish and the world community that has met this rising tide of despair with this rising tide of goodness and charity. I was in a refugee center and it was a converted shopping mall. They had taken over different stores and converted them for different purposes. The first store you saw was an old shoe store that was converted to a registration center for Polish people to register their vehicles so they can become drivers for refugees to take them anywhere they need to go. That area was just packed with lines and lines of people waiting to register their vehicles to turn them essentially into refugee taxi services. When vou cross the border it is now surrounded by tent after tent. It is like a reverse farmers market where everyone in the tent is trying to give away their goods and services to refugees. If you needed shampoo, clothing, a stroller, hot food, a cup of tea, a sack lunch, it was just quite an extraordinary thing.

Jewish people in Beverly Hills and other cities across the nation have been subject to anti-Semitic flyers being sent to their homes. How is your organization dealing with this matter?

Like other Jewish organizations, our federation is trying to combat anti-Semitism on a very broad and concerted effort. It is hard to say 'what are we going to do about flyers being thrown on lawns?' We are not going to be out there patrolling every night to make sure every single lawn of every Jew in Beverly Hills is protected. What we are doing is working with the police department. We are working to track these incidents and events. We are trying to encourage the greater Los Angeles community, city, and county to take these kinds of events seriously. We are trying to find avenues in which we can act. Of course, when these incidents occur we reach out to families and make sure they are ok, and see what kind of resources they need.

You helped rebuild the Gulf Coast Jewish community after Hurricane Katrina. Tell us about that.

I was in rabbinical school. Ever since I was a young adult I was involved with volunteerism and working on areas of social care and social justice. When Hurricane Katrina came to the United States, it destroyed I think around 100,000 square miles of US territory. To give you a sense of how big that is, it's the size of Great Britain. So we lost an entire county

inside our county.

The call was put out to see if there was anyone who wanted to help, so I applied and they took me. Twice a month I would fly from my apartment in New York City to Biloxi, Mississippi. I would be there for about 72 hours or so and go back to school on Monday morning. I wouldn't take all the credit, but what I helped to do there was meet with Jewish families. I helped them in their trauma. I discussed with them issues that have come up. A lot of pastoral work and teaching Torah. And helping to rebuild their sense of Jewish life. There was a little bit of anti-Semitism happening in certain areas, so we helped advocate for that. Over the course of a two years period, slowly trying to heal this community so they can move on. Help rebuild their board structure. Help them allocate funds to clean up the local Jewish cemetery which had been ripped apart because of the storm. By the time I left they had allocated funds and had voted on blueprints to rebuild their congregation. That was a prideful moment for me.

How can our readers help the Ukrainian people?

The best thing you can do is to send money. It is the fastest way to supply support. I know folks want to donate items, but donating items through private channels is very slow and very expensive. The best way is to really help monetarily and to send funds. We have a Ukraine relief fund on our website. We pass through 100% of those funds to those on the ground through vetted partnering organizations that help with temporary housing, transportation, food, medical costs, and trauma relief. And for those who are Jewish who want to move to Israel, we help them move to Israel.

If you want to volunteer, what they need now are highly skilled volunteers. You have to speak Russian, Polish, or Ukrainian. You have to have a background in social work, law, or international aid. If you have those skill sets and you're willing to commit to two weeks of volunteerism, they will take you. They don't have room right now for unskilled

BHHS Alumnus Michael Schwartz Hired As East Carolina Men's Basketball Coach

1994 Beverly High graduate Michael Schwartz has been hired as East Carolina University's men's basketball coach after being on Tennessee's coaching staff the previous six seasons, the last three as associate head coach.

Schwartz said in a Zoom news conference March 16 he was "extremely, extremely excited to have the opportunity, honored and humbled and so thankful to Chancellor (Philip) Rogers, (athletic director) Jon Gilbert, the executive leadership staff to have the belief in me to help build a special program at ECU."

Schwartz replaces Joe Dooley, who was fired March 11 after posting 44-67 record in four seasons in his second stint as the Pirates' coach, including a 15-15 mark in

the 2021-22 season.

(Dooley also coached East Carolina from 1995 though 1999, when the Pirates were 57-52. He was fired in 1999 after back-to-back losing seasons.)

Schwartz has been the Volunteers' defensive coordinator the past five seasons, with his schemes resulting in Tennessee leading the Southeastern Conference in scoring defense three times in the past five seasons, including the past two.

The Volunteers were 27-8 in the 2021 season, their fourth-most victories in a season, and won the SEC Tournament for the first time since 1979. Tennessee was seeded third in the NCAA Tournament's South Region. The Volunteers' season ended with a 72-68 loss to 11th seeded Michigan

Saturday.

The hiring reunites Schwartz with Gilbert, who was Tennessee's executive senior associate

athletics director from 2011 through early 2017. Gilbert's son Kent is a guard for Tennessee

"Mike is highly regarded in the basketball industry," Gilbert said. "I really feel like we're fortunate to have him on board to lead the program. He has an infectious personality and he brings a lot of enthusiasm and positive energy daily.

"He really is going to emphasize accountability, academics, player development. He and I have talked long about engaging our community and region and making sure that we build a program for sustained success."

Located in Greenville, North Carolina, East Carolina has played on the Division I level since the 1964-65 season. The Pirates reached the NCAA Tournament in 1972 and 1993, losing in the first round both times. They have had non-winning records for nine consecutive seasons.

Schwartz began his college career playing two seasons at Division II Sonoma State, then transferred to Texas, beginning a long association with Rick Barnes, then the Longhorns' coach, who Schwartz said he considers "a father figure to me."

"I owe him everything," Schwartz said. "Coach Barnes, as great of a coach he is and as special of a coach he is, he is even a better person, a better man and he's taught me that. He's given me that foundation for coaching but he's also provided a foundation for me for the way I live my life as a father, as a husband."

Barnes called Schwartz "the total package and one of the sharpest basketball minds I've known."

"He's been prepared to lead his own program for several years now," Barnes said in a statement released by East Carolina. "He's had multiple opportunities, but he's been very deliberate in waiting for the 'right' opportunity.

"Jon Gilbert's vision and leadership align perfectly with Mike's, and I have no doubt that they will build a championship culture in short order at East Carolina. Mike is going to put together an incredible staff, and they'll be relentless in recruiting and developing outstanding players who are high-character young men."

Schwartz began his coaching career in 1999 as a graduate assistant under Barnes, keeping the position through 2001, where he moved to Long Beach State as an operations/video assistant.

Schwartz returned to Texas in 2002 as a video coordinator. He was an assistant coach at UTSA in the 2004-05 season, coordinator of basketball operations at Miami from 2005-07 and an assistant coach with the Hurricanes from 2007-11, assistant coach with Fresno State from 2011-14 and the Bulldogs' associate head coach in the 2014-15 season and an assistant coach with Tulsa in the 2015-16 season before being reunited with Barnes in 2016.




