Bosse Installed as Mayor

Lili Bosse was installed as Mayor at the City Council's annual reorganization meeting on Tuesday at the Wallis. She succeeds Bob Wunderlich, who will continue to serve on the City Council.

Bosse was first elected to the City Council in 2011. She previously served as Mayor in 2014 during the City's Centennial year and in 2017. Bosse's oath was administered by former Ambassador to

the Bahamas Nicole Avant. Julian Gold was also named Vice Mayor. Gold was first elected to the City Council in 2011 as well.

Bosse outlined her initiatives, which fo-

cused on public safety, mental wellness, support of local businesses, and communication with residents.

Bosse introduced her first initiative, BHPD alert, a text message tool to immediately notify the community of police activity. Additionally, a new Real-Time Watch Center will allow for around-theclock live monitoring of cameras across both residential and business corridors. Bosse also announced the launch of LIVE 911 which will enable Beverly Hills police officers to hear 911 calls live in the field as they come in, allowing them to immediately respond rather than waiting for instructions from dispatch.

Bosse said she will host "Business with

Bosse", showcasing the offerings and services of businesses in the City. She is also bringing back the 60-second Shout Out at City Council meetings to honor businesses with a proclamation. The first 60-second Shout Out will take place at their next City Council meeting.

Bosse also announced LIVE with LILI. LIVE with LILI will be a new monthly townhall meeting where residents can share opinions on issues

and topics directly with the mayor.

"My passion and purpose on the City Council has always been to provide a safe and healthy City for the people and businesses of Beverly Hills: Healthy people, Healthy economy, Healthy government. I

truly believe the initiatives I've outlined tonight will bring us back to the core soul of who we are: Police, fire, schools, safety, health, and community," Bosse said.

Suspects Arrested in South Beverly and Rodeo Drive Robberies

Three recent robberies have citizens on edge as crime continues to spread havoc in Beverly Hills.

The Beverly Hills Police Department (BHPD) took two men into custody who allegedly committed a robbery on Rodeo Drive on March 31.

At approximately 1:31 p.m. the BHPD received reports of a grand theft that had just occurred in the 200 block of North

Two suspects working in tandem entered the location and removed store property without making an attempt to pay. A store security officer attempted to detain one of the suspects but was subsequently pushed out of the way which escalated the theft to a robbery.

Police units, assisted by City contracted security officers, arrived on the scene and took this suspect into custody. The second suspect was located a couple of blocks away by responding units. One suspect, Dante M. Scott from Los Angeles, was arrested for robbery. The second suspect, Wilfred S. Atlas from Los Angeles, was arrested for conspiracy to commit grand theft. The stolen property was recovered.

A man has also been arrested and charged in connection with an armed

robbery that occurred on South Beverly Drive on Feb. 25.

On Feb. 25, at 3:09 p.m., BHPD Officers responded to the 200 block of South Beverly Drive for an attempted armed robbery. Prior to police arrival, one suspect fled on foot while a second suspect was left in a white SUV.

During a search of the area, it was discovered that the suspect had discarded a loaded handgun which was found in a nearby alley inside a metal trash bin. Detectives identified Kavian Sims-Petty as the suspect who discarded the handgun.

On Wednesday, March 9 Los Angeles Police Department and BHPD detectives served a search warrant at a location in Los Angeles. During the service of the warrant, Sims-Petty was arrested for an unrelated homicide investigation in Los Angeles. The BHPD investigation connected Sims-Petty to the attempted armed robbery in Beverly Hills.

On March 10, Sims-Petty, who is from Victorville, California, was charged by the Los Angeles County District Attorney's office with the Beverly Hills attempted robbery and Assault with a firearm. He was also charged with a homicide that occurred in Los Angeles.

The BHPD said they continuing the investigation for other individuals, including a second suspect seen on multiple videos, attacking a victim.

The BHPD has also arrested five suspects for a commercial burglary that took place on March 28, at 6:58 p.m. in the 200 block of North Rodeo Drive for a commercial burglary.

Multiple suspects entered the location, removed store property, and fled on foot. As they were running away, a suspect physically assaulted a store security guard who attempted to stop them, escalating the burglary to a robbery. The suspects ran to an awaiting vehicle and drove out of the area. The security guard sustained minor injuries.

BHPD officers and detectives began collecting evidence and identified a vehicle license plate number.

On March 29 detectives, assisted by the California Highway Patrol, attempted to stop the vehicle, which was occupied by five suspects. A short vehicle pursuit ensued. The suspects abandoned the vehicle and ran on foot. Four suspects were immediately arrested by BHPD detectives. A fifth suspect—the driver of the vehicle—climbed onto the rooftop of a nearby residence in the 4900 block of Maymont Drive in the Windsor Hills area. BHPD personnel, assisted by California Highway Patrol officers and LASD deputies, convinced the suspect to surrender to police

A loaded handgun was also recovered from one of the suspects and detectives recovered all the merchandise that was stolen.

San Francisco, California, charged with 211 PC – Robbery, 182 PC – Conspiracy, and 148 PC – Resisting/delaying a public officer; Rodney Dewayne Moultrie Jr., 21-year-old male from San Francisco, California, charged with 211 PC - Robbery, 182 PC – Conspiracy, and 148 PC – Resisting/delaying a public officer, 25850 PC - Possession of a loaded firearm; Dewan Lewis, 20-year-old male from San Francisco, California, charged with 211 PC - Robbery, 182 PC - Conspiracy, and 148 PC – Resisting/delaying a public officer; Juandell Carnelius Joseph, 33-yearold male from San Franciso, California, charged with 211 PC - Robbery, 182 PC Conspiracy, and 148 PC – Resisting/delaying a public officer; and Antonio Lewis, 33-year-old male from San Franciso, California, charged with 211 PC - Robbery, 182 PC - Conspiracy, and 148 PC Resisting/delaying a public officer.

BHPD said they do not believe these suspects are responsible for any other similar incidents in Beverly Hills.

Candidate Forums Take Off

A candidate forum hosted by the Chamber of Commerce took place last Wednesday where Shiva Bagheri, Kevin Kugley, and Robin Rowe discussed why they should be elected to the City Council. Candidates Akshat "A.B." Bhatia and Darian Bojeaux did not attend.

There were several topics discussed but the majority of the forum was focused on crime and COVID regulations.

When asked why they were running for City Council Bagheri said she is running to protect people's freedoms.

"Nobody has fought for people's freedoms here in Beverly Hills like me," Bagheri said

Kugley said he is running for small businesses and the safety of the community.

"The small businesses are the ones that need help. The corporations have the money. What you want is a City Council that represents the people and fights for your safety," Kugley said.

Rowe said he is running because it is part of his civic duty.

"I just want to make the City a better place to live," Rowe said.

Traffic and Parking Commission to Discuss Transit Service Study

At their Thursday meeting the Traffic and Parking Commission is expected to discuss an overview of the scope of work and schedule for transit service planning for a potential City shuttle service.

The Climate Action and Adaptation Plan (CAAP) Community Advisory Committee (CAC) has also identified a shuttle system as a way to help the City reduce greenhouse gas emissions.

At their March 15 Study Session, the City Council directed staff to begin developing a transit service plan with the Traffic and Parking Commission as the advisory body. Traffic and Parking Chair Sharon Ignarro also serves on the CAC and will act as the "bridge" between the two groups.

The City does not currently operate a

regular transit service for the public. The Complete Streets Plan recommends that the City explore a shuttle system, which would connect the future Purple Line subway stations to the business district.

According to the staff report, Beverly Hills currently offers multiple transportation programs, including dial-a-ride transport for resident seniors and disabled persons and provides the City-owned trolleys for special event charters and shuttle service between the Third Street tour bus under a joint contract with West Hollywood, with each program operating independently and restricted to residents of each city.

In anticipation of the opening of the Metro subway stations along Wilshire Boulevard, the current work plan for the Traffic and Parking Commission and staff includes exploring shuttle service options for the public between the future subway stations, major Metro bus stop connections, and the business district.

"If the Council sends it to them [Traffic and Parking Commission] rather than the Climate Adaption CAAP advisory committee, it will get buried in bureaucracy. And that's what's happened here," said Climate Action and Adaptation Plan Committee Co-Chair Peter Ostroff.

Over the past two weeks, staff has interviewed four consulting firms with experience with transit service planning and operations. The objective is to, by the first week of April, enter into an agreement with the most qualified firm that will assist the City in obtaining public and stakeholder input and analyzing transit needs, according to the staff report. At their Thursday meeting, staff will report to the Commission on the scope of work and tentative schedule for these tasks.

Rent Stabilization Commission to Discuss Surcharges and Rent Increases

The Rent Stabilization Commission is expected to discuss recommendations to the City Council regarding possible amendments to the Rent Stabilization Ordinance (RSO) for both Chapter 5 and Chapter 6 of Title 4 of the Beverly Hills Municipal Code (BHMC) regarding surcharges that allow housing providers to pass through costs to tenants relating to water service penalties and/or surcharges, refuse fees, and for Chapter 5 tenants only, capital expenditures, improvement expenses mandated by law, including seismic retrofit, utility expense, and additional tenants. The commission is also expected to discuss possible amendments to Chapters 5 and 6 regarding the maximum allowable annual rent increases.

The RSO provides the maximum allowable annual rent increases that can be charged for an occupied unit in BHMC at 4-5-303 (Chapter 5) and 4-6-3 (Chapter 6)

"In setting the maximum allowable rent increase, the City seeks a balance between protecting tenants from excessive rent increases with the ability to provide housing providers with a fair rate of return on their investment," according to the staff

report.

Units subject to the maximum allowable rent increases are those with continued occupancy. Once a unit is vacated, it can be returned to market rate and when the unit is reoccupied, it becomes subject to the RSO's maximum allowable rent increases, according to the staff report.

Chapter 5 tenants are those whose original rent contracts are \$600 or less per month and live in a structure completed before Sept. 20, 1978. Chapter 6 tenants are those who have original rent contracts that exceed \$600 per month and live a unit in a building that has a certificate of occupancy issued on or before Feb. 1, 1995.

Health and Safety Commission Receives Earthquake Preparedness Month Update

At their Monday meeting the Health and Saftey Commission disccused an update regarding earthquake preparedness month.

Earthquake Preparedness Month is held each April in an effort to encourage community members to take simple steps to prepare for earthquakes. A variety of outreach activities designed to reach all segments of the community will be conducted throughout April.

The City will focus on the importance of earthquake preparedness with the "When It Rocks...Are You Ready to Roll" campaign. The campaign has two components: employee preparedness and community preparedness.

The City encourages residents to review their disaster plans, stockpile supplies, and sign up for emergency alerts from the City.

Businesses are also encouraged to become Disaster Ready partners. Disaster Ready is a formal recognition of emergency preparedness efforts taken by the business community. Disaster Ready materials and instructions on how to become an active preparedness partner in the community are available at www.beverlyhills.org/disasterready.

Employees can also evaluate their disaster plans and supplies. All employees are classified as Disaster Service Workers (DSW), meaning they are federally mandated to report to work in an emergency or disaster situation, if the situation dictates.

Educational information will be made available throughout the month. The community will have access to this information as follows: When It Rocks...Are You Ready to Roll" banners displayed on City streets and at City facilities; earthquake-themed social media campaigns, and information on the City website.

Residents and employees can also download two new earthquake safety applications. Report-A-Quake: This is an application that will allow users within Beverly Hills to self-report the impact of an earthquake. Visit the webpage at www.beverlyhills.org/reportaquake for more information.

Susie DeWeese is the Chair of Think Pink. "Think Pink for Women's Wellness", is an Irene Dunne Guild annual event that focuses on health education and awareness for women and their families. The Irene Dunne Guild, a support group of Saint John's Health Center Foundation, created Think Pink over 17 years ago as a gathering meant to educate women on important health issues. The event is Wednesday, May 4 from 8:30 a.m. - 3:00 p.m. at the Upper Bel Air Bay Club.

Tell me about the Think Pink for Women's Wellness Luncheon event coming up.

Think Pink for Women's Wellness was started 35 years ago by a woman named Fran Flanagan. Fran invited some of her friends to a luncheon and she called it 'Think Pink for Women's Wellness.' That is what started it all. It has grown from there. We now seat 250 women and we have to turn people away. We hold it at the Bel Air Bay Club, the upper club. It starts at 8:30 in the morning and goes until 4:00 in the afternoon. We have a boutique with 10 or 12 vendors, we have a beautiful luncheon and we have speakers. In the morning prior to the luncheon, we have four speakers. Two earlier in the morning and two later in the morning. They are doctors or something close to doctors who talk about their fields of medicine

For our morning speaker, the first one we have is Lauren Rudichuk. She is a genetic counselor at the Center for Clinical Genetics and Genomics with Providence Health and Services of Southern California. She is going to speak on comprehensive assessment of risk and education.

We have Stephen Siderosf. His topic is 'learn the secrets of becoming more resilient and successful.' He is an internationally recognized psychologist consultant and expert in resilience and optimal performance, addiction, Nero feedback,

stress, and mental health. He is an assistant professor at the Department of Psychiatry and Biobehavioral Sciences at UCLA.

Then we have Tiffany Grumwald. She is speaking on aging well, a female plastic surgeon's perspective. She is the division chief of plastic and reconstructive surgery and the executive medical director of women's health and wellness institute at Providence Saint John's.

The last speaker for the morning is Shanphi Gowrinaphan. He is a psychiatrist and Psycho-oncologist. He is the director of Psycho-oncology in cancer support services at Providence Saint John's. His topic is hormonally mediated changes in cognition and mood in women.

You are Chair of the Irene Dunne Guild support group. Tell me about

We are a group of 100 plus women who support Saint John's by raising money. Our goal every year is \$100,000. We have a patron drive. We have met our goal most years. During COVID we actually did more than that, furnishing the hospital with all kinds of things. One of the things I think is the most interesting is we bought surgical lights for the rooms. They were unable to take the COVID patients to the operating room so they had to have surgical lights to operate in the rooms. We furnished those. We have furnished all kinds of things throughout the years. We have funded the Neonatal Intensive Care Program. We have funded the Beauty Bus, which is a group of women who come and give manicures and pedicures to the patients at the hospital. We have funded a stroke program.

They needed a stroke bed for the emergency room, instead of us funding we asked the hospital to fund three beds and then we upgraded them to stroke beds. We purchase fetal monitors for the babies. And an AccuVein viewing system. An AccuVein viewing system shows you exactly where the vein is when they are putting an IV in a patient. Those are some of the things we have funded with our patron drive. We do it every year and every year we get very close to our goal.

Who was Irene Dunne Guild?

She was a very well-known actress. She discovered Saint John's and decided she wanted to start a support group for Saint John's to help them. She started the group and it has grown and grown. Now it is over 100 women. We work very hard to support Saint John's. Think Pink is not particularly to support Saint John's. It's for mothers, daughters, and dear friends to celebrate women's wellness and to learn about various parts of medicine. That's the purpose of it and that's what it's called.

What are some other projects your group is working on?

We have a lot of the group who volunteer at Saint John's in all kinds of areas in ER to being on the floors with the nurses. We haven't been able to for the past two years because of COVID and they are just starting to bring us back as volunteers. A good portion of the group volunteers at Saint John's.

FIVE QUESTIONS FOR THE CITY TREASURER CANDIDATES



HOWARD FISHER

Why are you running for City Treasurer?

Howard Fisher: I'm running to continue the legacy of excellence established by past treasurers. During these past five years that I've invested the City's fund, which now total \$742 million, the City has not lost a penny on any of my investment decisions. I've headed a committee that solved the City's biggest fiscal problem - a \$361 million pension/benefit deficit. We have now reduced the deficit by more than \$100+ million, and have implemented a plan to pay it off over 20 years. We have revised the City's investment policy to include ESG, Anti-boycott and best practices. I participated in financially guiding the City during the worst health pandemic in more than 50+ years. If re-elected, I want to work with the City Manager and Council to develop a new budget process - what's known a 'zero base' budgeting, rather than the current system of looking at 'enhancing' the budget from the prior year - which is the current process.

Jake Manaster: I am running for City Treasurer because I care deeply about our community. I felt the same way about "paying it forward" when I ran for school board and won. Each generation needs to build on the work of the prior generation. Our past is our guide and our foundation, our future is up to all of us who need to step up and carry the torch. In this case, the Treasurer's office is about stewardship of our financial future, economic stability and resources needed to continue to support this cherished place we call home.

Gabrielle Pantera-Rowe: Like most normal people, I had no interest in being in politics. I said no at first, but kept getting asked. I'm running for office to stop the City wasting taxpayer money, to prevent higher taxes.

What do you think are the most significant issues facing the City Treasurers' office?

Fisher: Looking at an organizational chart of the City, the treasurer is off to the right, with dotted lines con-

necting the office to the public and to the Finance Department. The treasurer is technically not a part of any City department which makes the position a difficult and lonely office. The Finance Department provides the staffing and resources to oversee the investments, prepare the monthly reports, and to perform all of the required functions. With the treasurer being somewhat on the 'outside' of the government structure, to be effective, requires a treasurer to have strong relations with the City staff and Council.

Manaster: Our community has come through the worst of the pandemic. We were not prepared, no one was. In the future, the Treasurer's Office will need to be ready to support Council and respond to future emergencies. My goal is to increase the effectiveness of the office in concert with Council. I lead large organizations operationally and financially, that experience is what will contribute to better serve our City Council and community's existing needs and thereby effectively and swiftly bring us out of the pandemic economically and prepare us for our future longevity and stability. My goals for this campaign and once in office are the following:

- 1. Re-establish the City Council appointed committee used to recover from the Great Recession, and this time use it for advice on how to now raise residents and businesses out of the pandemic calling it the "The Bring Back Beverly Hills Committee"
- 2. Respectfully request that the City Council establish, from Surplus Funds, a "Resiliency Fund" to prepare for future emergencies. This would be separate and apart from the City's Reserves or a Rainy-Day Fund and be exclusively for unknown threats to the well-being of the community and for support of resident needs. It would prevent the need to borrow from the General Fund, avoid disruptions in services and create a best practice of being prepared and having resources for our "known unknowns and unknown unknowns".
- 3. Utilize my financial and business

experience to be the best forward and future looking steward for the city's financial needs and investments.

4. Educate and familiarize constituents as to the bottom-line function and responsibilities of the Treasurer's Office.

Pantera-Rowe: Transparency, that's the issue facing the City Treasurer's office. Nobody can tell where the money has gone in the City finances. The budget is unreadable.

Beverly Hills has a large and complex municipal budget. What skills specifically do you have to manage this?

Fisher: My 'day job' is a certified specialist tax attorney. The City's main sources of income are from 'taxes' (sales, property, business, and transit & occupancy). I have more than 40 years of experience in all of these forms of taxes. For 40+ years I have been on boards, and routinely work with clients on nine-figure budgets and their investment committees. Having lived in the City since childhood my personal ties to Beverly Hills coupled with my tax experience brings a very unique, seasoned and invested interest in creating a healthy and vibrant Beverly Hills. The Treasurer is not formally involved in the process of developing the City's budgets (we have an operating budget and a 'capital improvement' budget). Many years ago, Council asked the Treasurer to head a "Citizen Budget Review Committee." The committee was disbanded by Council a few years after I became Treasurer. I've been active behind the scenes in trying to bring common sense and community sensitivity to the budget so that there are adequate funds to take care of things the community cares about. Over the past several years, I have kept in constant contact with the Assessor businesses the Chamber, the VCB, the RDC - to be sensitive to anything that would adversely impact our City's revenue sources and the City's budget.

Manaster: The City Treasurer does not manage or review/approve the municipal budget. That is a power reserved for the City Council, City Manager and City CFO, reporting to those offices. It is true that the treasurer, like all citizens, can offer advice, information and perhaps even suggest a process where requested by the City Council. However, the act of managing the budget is not within the treasurer's purview. Instead, the treasurer manages and has a custodial and fiduciary role over City funds that are invested. The treasurer oversees direct investments of the surplus funds

and works with the City CFO and the Director of Finance to make sure investments are wise, risk appropriate, follow the City's Investment Policy, reported, and allows for adequate liquidity to run all necessary City Services while also providing flexibility for City Council and Staff directed initiatives.

Pantera-Rowe: Gabrielle Pantera-Rowe is not a tax attorney or wealth manager. Other candidates for City Treasurer typically come from those practices. I have never obscured funds in a budget or manipulated financial reports to help the rich avoid paying taxes. My accounting skills are not in hiding wealth, but in getting people paid. I've managed payroll and accounts receivable at multiple companies. I've built asset management systems at UCLA and The Walt Disney Company.

The City Treasurers' office typically does not get a lot of attention. Why do you think that is?

Fisher: As treasurer I have hosted/ participated in scores of public meetings (e.g., Audit, Foundation, etc.), and no one from the community attends. As the City's former head of Public Works was fond of saving - if they did everything perfectly, no one ever thinks of them it's only when something goes wrong that the residents seem to care about the department. It's like with the treasury the City has been fortunate to have great treasurers (e.g. Joan Seidel, Frank Fenton, Eliot Finkel), so the community expects, and has received excellence from its treasurers - hence the community had paid little attention is paid to the position - because it has functioned so well for decades. The function of the treasurer is very limited. The treasurer's main functions are to invest the City's funds (\$742 million), which investments are limited by law to government issued bonds/ notes, and investment grade paper, and to issue a monthly report to the public. The treasurer is not a junior councilperson. As chair of the committee to solve the City's unfunded pension/benefits deficit - which was \$360+ million, we developed an extensive report, and developed a plan to solve the problem (we have reduced the deficiency by more than \$110 million). I've revised and updated the City's Investment Policy, including anti-boycott provisions. Neither of these accomplishments received any press - why, the community expects and demands the best - and it has received the best from all of its treasurers.

Manaster: To put it plainly, it's not exactly exciting stuff! It's like the roof on your house. You need it, you want it, but you don't pay attention to it until it's leaking and rarely does anyone care about it until it does leak. There seems to have not been a contested treasurer race in nearly 40 years. People sort of handed the office over to the next willing person without a discussion because in all honesty, it is a "side-car" to the City Council. It is, properly so, meant to be operational, enabling and supportive. I think the role is forgotten or misunderstood at

times. The Office also provides Investment Reports to the City Council and a Portfolio Statement. The limitations of the role are also the beauty of it. It is a pillar of stability and purpose and I intend to keep it that way but bring a more robust and useful urgency to the office by offering to the City Council to facilitate their goals and provide a space to flush out some new needs that are now appar-

ent after experiencing this pandemic.

Pantera-Rowe: The City Treasurer's office should get more attention. City of Beverly Hills financial reports seem written in a way to prevent scrutiny. Could it be the City Treasurer's office hasn't wanted attention?

What one thing do you want the voters to know most about you before they cast a ballot for City Treasurer?

Fisher: Handling successfully invested the City's \$742 million, and how that fits into the City's operating requires skill and experience. I have both. If it ain't broke, don't fix it. There is no need for a change. Having successfully invested the City's \$742 million and helped the City navigated the pandemic with the required skill, humanity and financial experience. Thus - If it ain't broke, don't fix

it!! There is no need for a change!!

Manaster: I am "Bottom Line Jake!" Pantera-Rowe: I oppose higher taxes and City budget waste. What Beverly Hills voters need to know about Gabrielle Pantera-Rowe is I will bring sensible money management to the City, where it is urgently needed.






