The LA County Democratic Party (LAC-DP) held their endorsement meeting last week where they interviewed several candidates.

They endorsed incumbent Bob Wunderlich and Sharona Nazarian.

## **Castanon Claims She Has Received Threats**

At the April 5 Board of Education meeting, Beverly Hills Education Association President Alana Castanon told the Board and members of the community to do better and be more polite as community members have threatened her career.

Castanon said that due to her past public comment at a Board meeting, she has been exposed to imagery of self-harm which she has perceived as threats.

"It is my firmly held belief that any person engaging in the education community should not have to face social media smears, newspaper attacks, threats of physical harm, visual representations of selfharm, or threats of career ruin," Castanon said.

Castanon said she has since then had

conversations with numerous people and has concluded that these types of social issues are extending to all corners of our lives. She said that people need to do better to understand each other, stop stoking fears, and stop perpetuating half-truths and rumors.

"Each person we encounter has history, life stories, hurt, families, and their own hopes and dreams. It's time to once again see each other as people first. Let's assume positive intent. It cost nothing and can mean everything and make all the difference in the world. It is my plea to you, please choose kindness and thoughtfulness in our interactions," Castanon said.

## **Board Approves Amendment** for B1 and B2 Modernization

At their April 5 meeting the Board of Education approved Amendment No.10 to the Construction Services Agreement with ProWest Constructors for Beverly High Buildings B1 and B2 Modernization, finalizing the Guaranteed Maximum Price through Phase 4 (PGMP 4) of the modernization of Buildings B3 and B4 in the amount of \$23,456,658.

This amendment excludes the demolition of the bridge so that it can be used for educational purposes.

Construction Manager Don Blake recommended excluding the bridge from the Amendment because the bridge would not get worked on for at least two years and the price would be very off than if they were to bid it out today due to the state of the market.



"If we're going to bid something two years out from now and bid out the subcontractor prices two years out, I think that would not be in the district's interest today in the market we are experiencing today to price something two years out. ## **City Council Discusses Real Time Watch Center**

At their Tuesday Study Session the City Council discussed the implementation of a Real Time Watch Center, which will be comprised of the following elements: closed circuit television (CCTV) cameras, automated license plate readers (ALPR), unmanned aerial systems (drones), Live911, and an intelligence unit.

There are over 2,000 CCTV cameras throughout the City, including four mobile CCTV trailers. The cameras are recorded and typically reviewed after an event or criminal activity has occurred rather than in real time.

According to the staff report, CCTV cameras can be reviewed with an AI suite called BriefCam. BriefCam provides rapid video review and search, facial recognition, operator alert features, quantitative video insight, multicamera search, people and vehicle counting, and path analysis.

"At this time, while BriefCam has robust post-investigative capabilities and the potential for some real time capabilities, it may not be the best system for real time management, communication, and coordination for our combined technological resources," according to the staff report.

BHPD and IT are currently conducting a review of potential real time watch center, web-based management software solutions. These systems include the ability to map all resources and quickly gather information to send to field personnel, including patrol officers, detectives, traffic control officers, and private security guards.

The immediate goal is to have two live CCTV operators to monitor camera feeds and coordinate with units in the field.

The City also has 23 Automated License Plate Readers (ALPR) throughout the City and an unnamed Aerial System (UAS) Drone program.

Live911 technology, which can integrate into the Real Time Watch Center operations, police officer vehicles, and will support the Drone as First Responder (DFR) program, allows 911 calls to live stream directly to first responders in the field. It is expected that this technology will improve officer response times to calls, improve de-escalation, will help keep officers safer by increasing situational awareness, and will improve overall officer and citizen safety.

The Real Time Watch Center is expected to: integrate all available technology to more proactively identify criminal threats before they strike; integrate new technology overlays; improve the safety of all field personnel, residents, and visitors; and develop an efficient, proactive system in anticipation of major future events in the City. One event includes the opening of two Metro Transit stations starting in 2024.

## **City Council Discusses Creation of a Public Health** Department

At their Tuesday Study Session the City Council discussed an update regarding the creation of its own Public Health Department, at the request of Mayor Lili Bosse.

On Dec. 1, 2020, the City Council requested city staff to explore the possibility of creating a public health department as well as the associated costs; roles and responsibilities for a public health department; and a potential timeline. At their Dec. 8, 2020 meeting staff provided a broad overview of creating a City public health department. The City Council also directed staff to continue to explore creating a City public health department and to bring their findings back to Council.

The City is currently part of the LA County Health Department.

According to the staff report, city staff has obtained quotes from two consultants to potentially assist the City in exploring the various avenues for creating a public health department and is currently searching for a third potential consultant to ensure competitive pricing. The hiring of a consultant is expected to be completed over the next several weeks.

Once the consultant has gathered enough information, an overview and summary for the Health Department will be created.

Long Beach and Pasadena, both larger cities, have their own health department.

## **Cultural Heritage Commission Initiate** Landmark Proceedings

At their Wednesday meeting the Cultural Heritage Commission initiated the nomination proceedings for inclusion on the Beverly Hills Register of Historic Properties for the property located at 9884 South Santa Monica Boulevard.

The property was preliminarily evaluated through City survey review and was determined to be eligible for placement on the California and National Register of Historic Places. Preliminarily, it appears that the property meets the required criteria for local landmark designation, according to the staff report.

The property was designed in 1946 by local contemporary architect John Lautner, who is on the List of Master Architects. The commercial building, commonly known as the "Darrow Office Building" was built for the original owner, John Darrow. The original building permit from 1946 lists Douglas Honnold as the architect, although the building's design is actually attributed to Lautner, who was part of Honnold's architectural design team at the time, according to the staff report

Lautner designed 188 structures, 64 of which are listed on the National Register of Historic Places, over his 50-year career. Lautner was known for his unique, modernist designs that revolved around organic ideas and were deeply influenced by another Master Architect, Frank Lloyd Wright. Post World War II, Lautner worked on more commercial projects and designed the Darrow Office Building.

According to the City's preliminary commercial survey, the subject building is a rare, extant example of a commercial building designed by John Lautner.

## **Planning Commission to Discuss One Beverly Hills Overlay Specific Plan**

At their Thursday meeting the Planning Commission is expected to discuss the Vesting Tentative Tract Map and Development Plan Review for the One Beverly Hills Project.

The City Council recently adopted the One Beverly Hills Overlay Specific Plan.

The plan was approved by the City Council in June 2021 and includes 340 residential condominium units distributed throughout three buildings; a new conference center; a new amenities building associated with the Beverly Hilton Hotel; and 12.7 acres of open space, of which 4.5 acres will be publicly accessible.

No changes are proposed to the project as previously approved by the Council.

## **City Council Approves Request for Street Closures** for Father's Day Car Show

At their Tuesday meeting the City Council approved a request for funding and street closures for the Rodeo Drive Concours d'Elegance Beverly Hills Father's Day Car Show to be held on Sunday, June 19

The Rodeo Drive Concours d'Elegance (Concours) has been held in City since 1993. The show was not held in 2020 due to COVID-19 and in 2021 a modified version called the Tour d'Elegance was held on Father's Day as a touring car rally through the streets rather than the all day Rodeo Drive car show. The Concours event has drawn crowds as high as 46,000 attendees over the course of the entire day to Beverly Hills and Rodeo Drive in particular.

The event is scheduled for Sunday, June 19th from 11 a.m. to 4 p.m. on Rodeo Drive. This year's event will also include a curated VIP/Sponsor vehicle tour of cars

traveling from City Hall through the streets of Beverly Hills and concluding on Rodeo Drive the morning of Father's Day. This will give spectators the opportunity to see the vehicles in motion.

This year, Beverly Hills luxury auto dealership O'Gara Coach will return as the top sponsor showcasing some of their rarest and most historic vehicles. Additional sponsorships will be secured at various levels including other local brands in the City.

The 2022 Concours event will require the following street closures: Crescent Drive (From S. Santa Monica Blvd. to North Sana Monica Blvd.) for the Start of the Driving Tour on June 19 from 7 a.m. to 11 a.m.; Rodeo Drive (From Wilshire Blvd. to South Santa Monica Blvd.) from June 18 at 9:00 p.m. to June 19 at 10:00 p.m.; Dayton Way (From Rodeo Drive to the alleyways on either side) from June 18 at 9:00 p.m. to June 19 at 10:00 p.m.; and Brighton Way (From Rodeo Drive to the alleyways on either side) from June 18 at 9:00 p.m. to June 19 at 10 p.m.

The event organizers requested \$199,150 from the City in base funding. Additionally,

the City Council Liaisons recommended an enhancement "Option A" for an additional \$29.820 to add video monitors, cameras. and switching equipment. The total request of \$228,970 for the 2022 Concours is available in the Fiscal Year 2021-22 Policy and Management Department Tourism and Marketing budget.

## **Rent Stabilization Commission Approves Resolution for Habitability** Standards

At their April 6 meeting the Rent Stabilization Commission approved a resolution regarding amendments to the City's habitability standards; proactive habitability inspections; establishment of an administrative board to hear appeals regarding rent reductions in connection with unaddressed habitability violations; and to prohibit annual rent increases for units with unaddressed habitability violations.

The resolution is a recommendation to the City Council to establish a proactive inspection program with an initial baseline inspection of all RSO units with units assigned to a tier-based system with three tiers. 100% of units in tier 3 would be in-

spected every two years and 50% of the units in tier 2 would be inspected every four years and 25% of the units in tier 1 would be inspected every six years.

A baseline inspection would also occur for any unit upon change of ownership. Landlords and tenants would share the cost of the proactive inspection program equally. The habitability inspection proactive inspection program is based on standards of habitability established by state law. There would be a prohibition on rent increases at such time a habitability violation is identified until it's been cleared. And that the Rent Stabilization Commission be established as an administrative hearing board to determine rent reductions related to habitability violations.

The resolution will be sent to the City Council for final approval.

## **Public Works Commission** to Discuss Single-Use Plastic and Styrofoam Local Ordinances

The Public Works Commission is expected to discuss an introduction to Single-Use Plastic and Styrofoam Local Ordinances at their Thursday meeting.

The Commission was previously scheduled to consider a single-use plastic and polystyrene ban, but due to the pandemic, it was determined to focus on phasing in a single-use plastic and polystyrene ban by requiring disposable foodware accessories to be made available upon request.

The City Council adopted a Disposable Foodware Upon Request Ordinance, which established that disposable foodware accessories are a significant contributor to street litter, ocean pollution, harm to marine and other wildlife, landfill waste, and greenhouse gas emissions.

According to the staff report, over 100 cities in California have implemented stricter bans that address the elimination of single-use plastics and polystyrene, also known as Styrofoam. A proposed ordinance at a later date would ban the distribution of expanded polystyrene food containers at restaurants, grocery stores, convenience stores, and other businesses.

City staff will be drafting a single-use plastic and polystyrene ordinance. The draft ordinance and stakeholder process plan will be presented to the commission in the summer and will be taken to City Council shortly after with a goal implementation

The Planning Commission of the City of Beverly Hills, at a REGULAR meeting on April 28, 2022, will hold a public hearing beginning at 1:30 PM, or as soon thereafter as the matter may be heard to consider:

Review and Potential Amendment of a Development Plan Review. The Planning Commission will review and potentially amend a previously approved Development Plan Review (DPR) that regulates rooftop uses for the buildings located at <u>9800 Wilshire</u> <u>Boulevard & 121 Spalding Drive</u>. The rooftop areas of these buildings are primarily utilized by a business called Spring Place, which is a co-working office and private membership club that also occupies offices within the buildings. The Planning Commission previously reviewed the operations of Spring Place at its October 24, 2019 study session, and its November 12, 2020 regular meeting, which resulted in the adoption of Planning Commission Resolution No. 1927 that regulates the rooftop uses and certain operations on the site. Pursuant to Condition No. 12 of said resolution, the Planning Commission has requested to review the operations of Spring Place and their compliance with the conditions of approval as a result of receiving several complaints related to activities on the site, and an active Community Preservation case. At this hearing, the Planning Commission will review all current operations and compliance with the conditions of approval of Resolution No. 1927, and may add or amend other conditions of approval affecting Spring Place's rooftop operations.

This project has been assessed in accordance with the authority and criteria contained in the California Environmental Quality Act (CEQA, Public Resources Code Sections 21000 et seq.), the State CEQA Guidelines (California Code of Regulations, Title 14, Sections 15000 et seq.), and the environmental regulations of the City. Upon review, the project appears to qualify for a Class 1 Categorical Exemption (Existing Facilities) and Class 21 Categorical Exemption (Enforcement Actions by Regulatory Agencies) in accordance with the requirements of Section 15301 and 15321 of the state CEQA Guidelines.

The Class 1 exemption is applicable to the operation, repair, maintenance, permitting, leasing, licensing, or minor alteration of existing public or private structures, facilities, mechanical equipment, or topographical features, involving negligible or no expansion of use. The project does not involve any physical development, and will be limited to potential changes in the operational limitations of the rooftop areas on the project site.

The Class 21 exemption is applicable to actions taken by regulatory agencies to enforce or revoke a lease, permit, license, certificate, or other entitlement for use issued, adopted. or prescribed by the regulatory agency or enforcement of a law, general rule, standard, or objective, administered or adopted by the regulatory agency, including the adoption of an administrative decision or order enforcing or revoking the lease, permit, license, certificate, or entitlement for use or enforcing the general rule, standard, or objective.

This project is being reviewed by the Planning Commission to ensure and enforce compliance with a previously issued entitlement, and to potentially revoke and/or modify said entitlement. Accordingly, the Planning Commission will consider a recommendation to find the project categorically exempt, pursuant to Section 15301 and 15321, from further environmental review under CEQA.

## Branding and Licensing Committee Approves Agreement for Use of City Shield

At their April 6 meeting the Branding and Licensing Committee approved an agreement for use of the City Shield by Universal Studios Orlando Theme Park and Universal Studios Japan Theme Park; and a request for use of the City Shield by Universal Studios Beijing Theme Park.

The Committee originally met in Nov. to discuss this item and provide direction. At that time, Bradford Licensing LLC, the City/Chamber of Commerce's previous branding agency for the prior Universal Agreements, was in attendance to receive feedback and direction.

The Committee directed Bradford Licensing LLC to work with Universal Studios on the following items and return to the Committee when reconciled: include an escalator annually in the permission agreements; provide a comparison to other licensees such as "I Love NY"; reduce the renewal period to 4 years for Orlando and Japan to align with the Singapore Agreement scheduled to end in 2025; offer a 4 year term for Beijing to be through 2025; and obtain theme park attendance numbers.

The City's prior agreements for Universal Studios Orlando and Universal Studios Japan for the use of the Shield expired on Dec. 31, 2021. Additionally, Universal Studios is seeking a new agreement for the use of the Shield for Beijing, which opened in Sept. of 2021. The Committee encouraged the licensing parties to work in good faith to achieve an agreement and return back when an agreement had been reached, even if that was after the expiration date.

Bradford Licensing LLC was not able to achieve the requested items and relinquished the licensing negotiations back to the City to be handled by CMG Worldwide, the City's current licensing agency.

CMG Worldwide began negotiations with Universal Studios and reported back to the Committee with the following agreement proposals that include an escalator annually. The term of the agreements was not able to be reduced to 4 years and instead is listed as 5 years. Universal Studios is not able to provide park attendance numbers. The representatives from CMG Worldwide are also not able to share proprietary licensing terms for other brands.

In addition to the requested renewals and new theme park license request, the City has one other existing license agreement with Universal Studios for its theme park in Singapore which was renewed in 2021. In January 2021, the City Council approved the continuation of the license agreement with Universal Studios for using the likeness of the City's shield at its Singapore theme park with compensation to the City at \$5,000 per year for five years for a total of \$25,000. This approved agreement will expire on Dec. 31, 2025.

The committee approved renewing Universal Studios Orlando and Universal Studios Japan each for five years for a total of \$30,000 per theme park over the term of each renewal agreement. CMG Worldwide also recommended the Committee enter

into a new agreement for use of the City Shield with Universal Studios for Universal Studios Beijing for five years for a total of \$30,000.

This brings the total licensing agreements with Universal Studios for these three theme parks to \$90,000 between 2022-2026. With the previously signed agreement for Singapore, the total revenue for all four Universal Studios theme parks would be \$115,000 between 2021-2026.

The agreements will be placed on a future City Council meeting for formal approval.

"I think at some point, not now but we would want to discuss the Appropriateness of having IP in certain countries in terms of human rights. I'm okay about that," Councilmember John Mirisch said.

## Yaroslavsky Appears on Beverly Hills View

Former LA County Supervisor Zev Yaroslavsky appeared on Beverly Hills View Friday with host Josh Gross to discuss takeaways from the pandemic, Los Angeles politics, and the race for LA Mayor.

Yaroslavsky sees Karen Bass and Rick Caruso as the top contenders.

When Yaroslavsky addressed the Mayor's race, Gross asked if he thought it's a replay of the 1993 Dick Riordan vs Mike Woo election.

"That's the question. Is this a 'tough enough to turn LA around' moment? Increasingly I believe it is," Yaroslavsky said.

Yaroslavsky also said that City Hall has been plagued by a number of corruption scandals.



## Lili Bosse Lays Out Her Initiatives as Mayor

## What is it like being mayor a third time?

It is a big honor but it is a different time because the world is different and I feel that we are different. I think being mayor now in 2022 requires different leadership [and] different initiatives than in the past.

## Tell us what you want to accomplish over your mayoral term.

I really value that our City is a healthy city. That's something that has been very important to me in all my years of leadership. That is healthy people, a healthy economy, and a healthy government. To feel healthy as a person one has to feel safe. My lead initiative is to restore everyone's feeling of personal safety again. I've been working with the Chief

and [the] police department and I have rolled out a few initiatives.

BHPD Alert is a text program that will go out to residents whenever there is any incident in the City. The information

will go out directly to those who sign up. In the past what I've seen these last few years, is there have been chats and people using their own social media to share what they feel is happening in the City. Which is often not accurate. I really wanted the community to know in real-time from BHPD what's happening.

I am excited to announce the Real Time Watch Center. We have over 2,000 cameras in our City. This center will allow for live monitoring of the cameras. The cameras we have had in our City have been fantastic. We have been able to use them to solve crimes. Having the live monitoring of the cameras in my mind will be a proactive way to hopefully curb crime. The Chief will be rolling out a phased-in approach at our Council meeting.

Also, LIVE 911 is a wonderful program that will cut down on response time. Which we already have among the best in the world, under three minutes. This will cut down even further. If somebody calls 911 the police cars will get that information so they can get to the location even quicker.

The City will be signing up for 30 by 30, which will encourage having more

women in the police department as well. We are actively recruiting for more police officers. We have just put five more police officers on the streets this week [and] we have 16 in the recruitment process. We are a City that funds our police, supports our police, and will always give any necessary revenue that they need.

I am also very passionate about the recall of District Attorney George Gascon. I came up very early on having him be recalled. He was elected in Nov. and in March I had asked for a vote of no confidence. And then in Jan. for him to be recalled. My feeling is even with all the security in place that we have, if there is no consequence to crime we are living in chaos. There has to be a consequence to crime. That is something that is really at the top of my list, is really having people

feel personal safety in their homes and on the streets.

> I also feel that these last two years have taken a toll on us. I feel that living through a global health pandemic, having to be apart from another, the po-

litical divide, and the increase in crime in Beverly Hills and Los Angeles County has taken a toll on our mental well being. So, I have partnered with mental health experts Dr. Deepak Chopra as well as Dr. Edith Eger who is a holocaust survivor and a psychologist who has written a book called The Choice. Both of which focus on resilience and moving forward. I continue to stand up to anti-Semitism and hate of any kind. I will always speak out against that and do whatever we can to ensure that there is no hate in our community.

I support our business community. I have brought Business with Bosse. Which is a new twist to supporting businesses where I will be back out in the business community showcasing all of our new businesses in our City and some of our favorites where I will bring our community to that business. Business owners will be there and it will be a great opportunity for the community to be together as well. I will also be doing our 60-second shout out at every council meeting where I will be highlighting businesses as well and presenting them with a proclamation.

Lastly, what is really important to me



Lili Bosse and Captain Elisabeth Albanese is healthy government. Just more ways for the community to know what is happening behind City Hall. I want to allow for a monthly town hall meeting called LIVE with Lili. Which will enable the community once a month to come and share their thoughts, ideas, concerns, and look for solutions together. I have also added 'Coming to City Council.' Our City Council meetings are generally on Tuesday, and on Friday the agendas come out. But very few people know what is on the agenda. They just know there is a Council meeting. What I have added now is 'Coming to City Council.' Everybody will know on Friday what the items are that we will be discussing. It will give them the opportunity to see if any of the issues that will be coming to the Council are something they want to tune into. Also, during the meeting, I will have live on the screen the telephone number that they can call in [and] the email address that they can write in. Generally in the past, the telephone number was mentioned in the beginning and never again during the meeting. So, I want during the entire Council meeting that whenever they tune in they see the phone number that they can call in and see the email so they can write to us so they always feel that they have an opportunity to let us know what's on their mind throughout the entire Council meeting.

I definitely have a lot of initiatives to get done this year but I am very confident that I will and that we will as a community. These issues in terms of safety, mental wellness, in terms of connecting with each other and with ourselves, are necessary after these last two years.

## How would you evaluate how the City Staff performed during COVID?

I think our City staff was stellar. They kept everything going. They were still there to communicate with any resident who needed [anything]. Whether it was their trash that needed to be picked up, whether it was a safety issue, anything with their utilities, nothing stopped. Our City ran very smoothly during COVID. I think everybody worked so hard. Our City staff worked hard. My fellow Councilmembers worked hard, our commissioners worked hard. Even though we weren't able to be physically together, City Hall really ran incredibly well. I am very proud. I view the city staff as city staff family. Because I view our City as a community and that our staff is an extension of that family.

How is this Council different from other Councils you have served with?

I think this Council for the last two years has worked harder.

I feel these last two years have felt like 10 years. We as a Council were a representation of what we as a community, we as a nation, we as a world were experiencing. Having a global health pandemic that had no guidebook, we had no idea to the extent of what that would look like. Having political division, people feeling a sense of isolation and not being able to be with their families, losing people that we love to COVID. I think it was very devastating to our community [and] to our world. And I think this Council that I've worked with over the last two years has experienced something that no prior councils have ever had to deal with. We have never had to deal with this type of global health pandemic. I am really grateful to my colleagues for their dedication.

The LVMH project was sent back by the Planning Commission. When do you anticipate that getting to the City Council and what are your thoughts on it?

I haven't heard the date of when it goes to the Planning Commission. I think that would be information you could get from [Director of Community Development] Ryan [Gohlich]. What I can tell you is that it will go through the Planning Commission process and when it is through that process, it will come to the City Council. What I do know is that the City has a rule that no big projects are ever addressed during the summer months. That project or any big project wouldn't come to the Council during the summer months; it would happen after Labor day. That is not specifically to LVMH, that's specific to any large land use project. We have always had a policy that we really want the most amount of public participation and we don't do that during summer months.

## Have you decided if you will seek a fourth term in 2024? I will not.



The CITY reserves the right to adjust, increase, limit, suspend or rescind the prequalification rating based on subsequently learned information. Contractors whose rating changes suffi-ciently to disqualify them will be notified, and given an opportunity for a hearing consistent with the hearing procedures described below for appealing a prequalification rating.

While it is the intent of the prequalification questionnaire and documents required therewith to assist the CITY in determining bidder responsibility prior to bid and to aid the CITY in selecting the lowest responsible bidder, neither the fact of prequalification, nor any prequal-ification rating, will preclude the CITY from a post-bid consideration and determination of whether a bidder has the quality, fitness, capacity and experience to satisfactorily perform the proposed work, and has demonstrated the requisite trustworthiness.
