

“Beverly Hills City Council Election”

Voters receive guides and slate mailers listing which candidates to vote for, from organizations bearing legitimate sounding names like California Voter Guide, Senior Advocate, Citizens for Good Government, Democratic Voting Center Guide, Republican Voting Center Guide, Coalition for Senior Citizen Security, Council of Concerned Woman Voters—and so on. Voters reasonably assume that intelligent people within such organizations have scrutinized all of the candidates and have determined that the listed candidates are the ones who are worthy of our votes.

Little do voters realize that these voter guides and slate mailers are simply advertisements by candidates willing to pay to be “slated” together to attempt to win an election, and do not reflect informed endorsements by legitimate organizations.

Is such misleading advertising fair and ethical? And can we trust candidates who pay to be listed in such guides?

Campaign filings for candidate expenditures posted at our city’s website demonstrate that three city council candidates spent thousands of dollars for listings in

such misleading voter guides and slates: one spent over \$12K; one spent about \$5K, and one spent \$3K.

Also, several of these voter guide organizations bearing different names originate from the very same address at 22410 Hawthorne Boulevard, Suite 5, Torrance, CA, 90505.

To top it off two Democrat city council candidates endorsed by the pro-over-development PAC-like Board of the West Hollywood/Beverly Hills Democratic Club, paid to be on a Republican voter guide slate, so Republican voters would assume that the Democrat city council candidates were Republicans.

It is indeed disappointing that a number of candidates feel they cannot win fair and square on their own merits, and have found it necessary to misrepresent themselves in one manner or another.

Planning Commission Sends Back Hillel Project

The Planning Commission sent back a proposed project involving the renovation and expansion of Harkham Hillel Hebrew Academy, located at 9120 Olympic Boulevard at their May 26 meeting.

Harkham Hillel Hebrew Academy is a private school for early childhood through eighth grade, with enrollment that ranges from 516 to 721 students. About 25% of students are from Beverly Hills with the remaining being from the City of Los Angeles, according to the applicant.

The campus is currently composed of two buildings, generally identified as the Oakhurst building and the Doheny building on the northern portion of the project site along Olympic Boulevard with a partially subterranean parking structure located on the southern portion of the project site and accessed through South Doheny Drive.

The project primarily focuses on the southern portion of the site where a new gym and classroom building was proposed adjacent to South Oakhurst Drive and an addition to the existing Doheny building is proposed along South Doheny Drive.

The overall project includes 44 total classrooms and would have provided 45 parking spaces within the existing parking area.

At their April 26 meeting the Planning Commission meeting approved a motion to bring back a resolution for conditional approval. Direction was given to develop project-specific conditions that would minimize potential impacts to the neighboring residents. The scope of the project-specific conditions directed by the Commission, includes:

Capping enrollment at 650 students; limiting the use of the rooftop to the hours of 7:30 a.m. – 6:00 p.m. Monday-Friday and one weekend day per month (for the months of April, May, and June the

outdoor game court may be used for one weekend day per month between the hours of 7:30 a.m. – 8:00 p.m.); requiring sound absorbent and/or turf material on the rooftop; prohibiting the use of amplified sound on the rooftop; prohibiting the use of stadium-style lighting on the rooftop; requiring a right-only turn restriction for vehicles exiting the drive aisle onto South Oakhurst Drive; requiring a dedicated staff transportation coordinator; requiring the applicant prepare a pick-up and drop-off plan that includes provisions for a minimum number of students in each vehicle; requiring a staggered pick-up and drop-off schedule; and limiting the types of outdoor activities within the outdoor play areas.

At the May 26 meeting many public comments expressed concerns regarding the existing vehicle queueing currently experienced on Olympic Boulevard, a portion of which may be attributable to the existing pick-up and drop-off configuration in front of the school on South Doheny Drive, which can only accommodate three vehicles at a time.




of optimal things I think would work better. I object to an enrollment cap of 650. I think that is too high and I would suggest that whoever does support this does bring it down to 600. At this point I agree that we would need more information to ensure that it is a safe and good project," Commissioner Myra Demeter said.

The Commission directed the applicant to come back with a revised traffic and parking plan and enrollment numbers. Rather than capping enrolment at 650 students, the Commission agreed that the number should be decreased to 600.

"I think we need more detail in the resolution. I also believe that there is an immediate need to address the parking issue and I don't want to wait until the project is completed. I think if the school is in good faith when they say they encourage carpooling and they encourage biking they should demonstrate that this time and implement immediately as a condition a detailed car pooling plan and a detailed staggered schedule plan. I visited the site earlier this week and I was sobered by the amount of traffic that backs up from Doheny all the way to between Palm and Maple. I was quite troubled by it and that is why I see an immediate need," Commissioner Gary Ross said.

The Commission will revisit the project at their June 23 meeting.

Board Weighs in on RFP Results

The Board of Education has received seven proposals for Bond Management Services for its ongoing construction program.

The Board did not receive a proposal from Don Blake's Team Concept Development Services (TCDS), which has been fraught with controversy.

After the departure of the previous Bond Manager, Totem, the Board approved the contract for Blake in 2017 with no bidding process, upon the advice of BHUSD counsel Terry Tao.

"The [Board of Education] is very pleased that we received such a positive response to our RFP and we will now move quickly to the vetting process. We are committed to transparency and accountability and completing our program in a timely fashion," Board President Mary Wells said.

The firms that sent proposals were: Telacu Construction Management, Cumming, Fonder-Salari, Inc, CBRE Heery, Inc, Paragon Engineering & Management, Rachlin Partners, and Anser Advisory.

A five year contract for Bond Management Services between the BHUSD and Don Blake's Team Concept Development Services, Inc (TCDS) had been listed on the Board of Education agenda twice without approval, ultimately resulting in the Board issuing an RFP.

Voters passed Measure E in 2008, issuing \$334 million, and Measure BH in 2018 for another \$385 million in bonds. The bonds were intended to provide funding for the modernization of BHUSD facilities.

The construction program is currently behind schedule with some projects no longer expected to come to fruition. In Blake's Oct. 21, 2021 study session presentation he reported that the program is

at a shortfall of \$129 million. He later dropped that number down to a \$69 million shortfall.

While closing El Rodeo School entirely for reconstruction in 2019 was supposed to expedite its completion and save money, the opposite actually proved to be true: the new campus is now not scheduled to open until late 2024, two years later than promised.

The Board will interview the applicants and intends to move quickly through the process to make a final decision.

Blake's contract expires on July 17, which is when the new bond manager will take over.

ed survey results to the Board of Education at their May 24 meeting where it was revealed that many community members were interested in having their grandchildren attend BHUSD schools through what is known as grandparent permits.

The district sent out two separate surveys, an internet survey, and an intention form. The district received about 189 re-

sponses to the internet survey for a total of 327 grandchildren, and about 71 responses to the intention form for a total of 122 grandchildren. The vast majority of respondents, 96.8% said they are interested in having their grandchildren attend BHUSD.

When the Board first brought up the topic of the permits it was originally intended to increase enrollment in the mid-

dle school and high school, however, the majority of respondents had grandchildren elementary-aged.

Board member Gabriel Halimi said although he is in favor of permits, he has some questions and concerns. Halimi said that as a former permit recipient himself, he resented that he had to start school a few days later than everyone else because the District had to see whether or not there was room for him.

"I started behind. I was really anxious and uncomfortable with whether Hawthorne and later the high school was going to have room for me and accept me. I don't think that's fair for the students and the family. So we have to decide if we let even one kid in for next year, are we making a firm

commitment to that student that they have a seat in class for the tenure of their time at that school? Through their time through 12th grade? Are we saying that we open up new classes if we have time?" Halimi said.

Board Vice President Noah Margo suggested that there be a cap on enrollment. He also questioned if the permits would deter people from moving into the City.

Board member Rachele Marcus has also been in favor of permits but said that although she thought there would be more interest in the middle school, she said those kids could eventually trickle up to the middle school and high school.

"I'm in favor of it and would like to see the financial impacts, but I am not disturbed by what I've been hearing so far," Marcus said.

The Board will continue this discussion at a future study session.

Rosen Confirmed As Assistant Secretary of the Treasury

Paul Rosen, a 1996 Beverly High graduate, was confirmed by the US Senate last week as Assistant Secretary for Investment Security, United States Department of the Treasury.

As Assistant Secretary, Rosen will address transnational economic issues, covering areas such as international trade, finance and security, and sanctions. His office will review foreign investment for potential national security risks.

Rosen has more than 15 years of experience in national and homeland security, investigations and law enforcement matters, including a dozen years in public service.

In government, Rosen served in various leadership positions at the U.S. Department of Homeland Security during the

Obama-Biden Administration, including as Chief of Staff to DHS Secretary Jeh Johnson. Prior to that, he worked at the Department of Justice in various roles, including as a

federal prosecutor in the Criminal Fraud Section where he investigated and prosecuted financial crime. For this work, Rosen was recognized by the Council of Inspectors General on Integrity and Efficiency (CIGIE) with the Investigative Award of Excellence.

Rosen started his legal career as Counsel on the Senate Judiciary Committee after clerking for United States District Judge Gary Allen Fees (Ret.) in the Central District of California.

Rosen received his J.D. from the University of Southern California where he graduated Order of the Coif, and his Bachelor's Degree, summa cum laude, from the University of Colorado.

City Council Approves 2022 BOLD Summer Proposal

At their Tuesday meeting the City Council approved a proposal from the Rodeo Drive Committee for a 2022 BOLD Summer activation. This activation would run from July 25 through Aug. 21 on Rodeo Drive.

In 2017 Beverly Hills created the BOLD program including a BOLD Summer and BOLD Holidays marketing campaign that the Rodeo Drive Committee, Beverly Hills Conference and Visitors Bureau (CVB), the Beverly Hills Chamber of Commerce, and the City all participated in. The BOLD Summer activation has included kick-off events, concerts, weekly programming, and more. This year the Committee proposed a Red Carpet Experience that consists of various social media installations along Rodeo Drive as well as enhanced audio along the street and street pole banners. Some stores also plan on extending their hours.

To carry out the 2022 BOLD Summer Red Carpet Experience, the fiscal impact will be \$296,954.

THE 2022 CITY OF BEVERLY HILLS WATER QUALITY REPORT RELATIVE TO PUBLIC HEALTH GOALS (PHG)

The California Health and Safety Code Section 116470 requires public water systems serving more than 10,000 customers to prepare a report every three years including information on the detection of any elements in the water at levels above Public Health Goals (PHGs) or Maximum Contaminant Level Goals (MCLGs). PHGs are adopted by the California State Office of Environmental Health Hazard Assessment (OEHHA). Similarly, MCLGs are set by the United States Environmental Protection Agency (USEPA). A public hearing is required to accept and receive public comments on the report.

Staff has prepared the report entitled, "Public Hearing of the 2022 Public Health Goals Report" to provide information regarding the quality of its drinking water supply relative to adopted PHGs and MCLGs.

Copies of the report will be available for public view online at the City's Public Water Resources Division webpage at www.beverlyhills.org/PHG and at the Beverly Hills Library.







PLANNING COMMISSION EXPECTED TO CONDITIONALLY APPROVE CHEVAL BLANC

The Planning Commission unanimously approved a motion to bring back a resolution that recommends to the City Council to conditionally approve the Cheval Blanc project, a proposed luxury hotel with restaurants, a private club, and street-level retail uses with North Rodeo Drive, at their May 26 meeting.

The project site is located at 456 and 468 North Rodeo Drive.

The Planning Commission held public hearings regarding the Cheval Blanc Project on Feb. 10 and 24. Public comments were received

and the Commission provided comments and direction at the two hearings. At the conclusion of the Feb. 24 meeting, the Commission continued the Project hearing to March 24. The City received a request from the Applicant to continue the hearing to a date uncertain so that they could have more time to study options to

address the issues raised at the hearings.

The commission had many concerns regarding the operation of the motor court and whether the number of vehicles would result in excessive delays for vehicles exiting the motor court, particularly during the evening peak period. The concerns were: whether the resultant delays could cause vehicle back-ups within on-site circulation and potentially spilling onto South Santa Monica Boulevard; and whether the amount of traffic exiting the motor court during busy afternoon traffic on South Santa Monica Boulevard would negatively affect roadway operation.

The main goal of the project changes was to reduce the number of vehicles exiting the motor court during the p.m. peak hour by the equivalent of providing a down ramp to subterranean parking

within the motor court.

To reduce the number of vehicles using the motor court the Applicant revised the Project to remove retail customer trips from the motor court and reduce restaurant customer trips using the Project's motor court. This results in 148 vehicles exiting in the p.m. peak hour, which is a 37% reduction from the previous version of the Project.

Many comments made at the Feb. 24 meeting were devoted to the operation of the relocated alley. Three Rodeo Drive merchants submitted a joint correspondence to the Planning Commission requesting that the Commission and the Council consider reversing the direction of travel on the alley to resolve their concerns regarding the effect on their businesses. The commission recommended the Applicant and the group of Rodeo Drive merchants with alley concerns should engage in good faith negotiations to resolve the outstanding issues.

“We only ask that the concerns about the reconfiguration and operations of the public alley be addressed to everyone's satisfaction, not just the applicant,” Hermès Managing director Samantha Peterson said.

The commission did not feel it was appropriate to address the concerns regarding the alley because they believed

that should be handled by the Transportation Division. The issues regarding the alley will be reviewed by the Traffic and Parking Commission. However, it is ultimately up to the City Council to formally approve the reversal of the alley.

“It's not every day that we are going to approve a nine-story building. But it's

not every day that we have a proposal like this that offers so many benefits to the community. And it's not that we are overlooking the fact that it's a tall building, which it is in our context. But the benefits in my view outweigh whatever perceived detriments there may be from that or the fact that it's a larger building. But I think this offers a great deal,” Commissioner Peter Ostroff said.

The project is expected to move forward to the City Council for final approval.

“I believe that in moving this project forward we are advancing the greater good of Beverly Hills. We will be bringing to this City a beautiful artifact. I do not think people are going to be obsessed with the height of the hotel. The massing of it is such that it will not appear to be grand. What it will appear to be is beautifully articulated, wonderfully rendered work of art that will be a feature of the northeast end of the business triangle for a long time. I believe that the financial benefits that will contribute to the City and the types of the people who will find their way back to Beverly Hills as a result of this hotel being here will more than justify the time and effort that so many people have put into it over the years,” Vice Chair Thomas Hudnut said.




