## Assistant City Manager Nancy Hunt-Coffey Appointed as City Manager

Assistant City Manager Nancy Hunt-Coffey has been promoted to City Manager in 4-1 vote by the City Council at their Tuesday meeting following the announcement that George Chavez is retiring at the end of this year. Councilmember John Mirsch was the sole dissenting vote.

“As I mentioned at the Council meeting, I support the appointment of Nancy as City Manager. I feel she deserves to be given a shot. I won’t go into a lot of detail, but I feel the process was unnecessarily rushed, with no public input, and I feel it would have been appropriate to have let the new Council make the decision about the new City Manager and the terms of her contract,” Mirsch said.

Hunt-Coffey was the Director of the Glendale Library prior to being appointed as Assistant Director of Community Services in Beverly Hills in 2008. She was subsequently appointed as Community Services Director in 2016 and then Assistant City Manager in 2019.

Hunt-Coffey will be appointed to a term of three years from January 1, 2023 to December 31, 2025. The base salary for Hunt-Coffey will be \$366,221, with an annual cost of living increase, and she will also receive Management Incentive Pay, set at \$975 monthly, with a 4% annual increase.

The City Council will review Hunt-Coffey’s performance in June of each year beginning in 2023. At that time, the Council may consider any performance pay or any other change in compensation, although it is not required.

## Hillel Asks to Postpone Review of Project

Harkham Hillel Hebrew Academy has requested that the Planning Commission postpone the review of their proposed project to a date uncertain after the Commission requested more details from the applicant.

According to a letter sent by Shane Stuart Swerdlow from Craig Lawson & Co., LLC on behalf of Hillel, the school is undergoing a change at the Administration and Board levels, and the new leadership has to be brought up to speed and sign off on any resolution that is put forth.

Harkham Hillel Hebrew Academy is a private school for early childhood through eighth grade, with enrollment that ranges from 516 to 721 students. About 25% of students are from Beverly Hills with the remaining being from the City of Los An-

geles, according to the applicant.

The campus is currently composed of two buildings, generally identified as the Oakhurst building and the Doheny building on the northern portion of the project site along Olympic Boulevard with a partially subterranean parking structure located on the southern portion of the project site and accessed through South Doheny Drive.

The project primarily focuses on the southern portion of the site where a new gym and classroom building was proposed adjacent to South Oakhurst Drive and an addition to the existing Doheny building is proposed along South Doheny Drive.

The overall project includes 44 total classrooms and would have provided 45 parking spaces within the existing parking area.

After the Commission reviewed the project at their May 26 meeting, the Commission requested more details on the current and future enrollment numbers, staggered pick-up and drop-off schedules, a mandatory carpool plan, information on how the pick-up and drop-off configuration would operate, and documentation on the adequacy of the proposed parking for faculty and staff. There was also an interest by the Commission in having certain operational conditions become effective immediately.

Many concerns have been raised by residents in regards to the traffic impact on Olympic and the surrounding noise to nearby homes.

If the Planning Commission postpones the project hearing, it will continue to a date uncertain as requested by the project representative.

## Mead to be Appointed as Director of School Safety

Superintendent Michael Bregy has announced that Beverly High Principal Mark Mead is the finalist for the Cabinet Level Position of Director of School Safety, subject to Board of Education approval.

“Although I understand that losing Mr. Mead as the Principal of BHHS is disappointing, it is of critical importance that we helm the new School Safety team with the best possible leader,” Bregy said.

The District is rolling out a new safety and security structure with an emphasis on ‘accountability, transparency, and proactivity.’ Bregy says the district will have a fully functional Command Center which allows the opportunity to centralize and leverage surveillance tools, an integrated CCTV camera program, radio channels district-wide, investigation technology, and crisis monitoring to work hand-in-hand with the Beverly Hills Police Department. The BHUSD Safety Team will be led by the Director of School Safety and supported by a Command Center Manager, Command Center Specialist, and part-time programmer.

Although security is a critical element in

the role of Director of School Safety, there are other components, including but not limited to areas such as; School Site Council Meetings, PTA Meetings, ensuring that school signage is compliant with Education Code, and checking that school calendars are reflective of accurate events. The new Director of School Safety will lead school-based administrators, staff, community members, and school site councils in the development of their specific comprehensive school safety plans.

The position requires intimate knowledge of school functionality. They will be responsible for creating a new District School Safety and Security Committee that includes students, staff, parents, and community members.

During a crisis situation, the Director of School Safety will also be the boots-on-the-ground liaison between BHUSD and BHPD.

“I have had such wonderful experiences at the high school during the last 16 years. There are so many people to thank (and I will continue doing so when I see you in the hallways and at events), but I do want to specifically thank Drew Stewart and Kim Decatrel who have been such faithful leaders and companions to me, our staff, and our students. They will continue the great work that BHHS has been doing. The good news is that I’m not going far and look forward to being able to keep working with you all,” Mead said.

Mead said we will continue his principal responsibilities during the transition period.

“I would also like to say how excited I am to take on this new responsibility. It is an incredible opportunity in my leadership career as the district is moving into a new phase with a reimagined safety and security structure. I am honored to have been selected to work with Dr. Bregy, our cabinet, staff, BHPD and city partners to further develop our plans to keep students safe, physically and emotionally,” Mead said.

Mead was appointed Beverly High Principal in 2017. Prior to that, he taught English and ASB (student government).

## City Council Approves Doheny Drive Bike Lanes

At their Tuesday Study Session meeting the City Council expressed consensus for the implementation of Class II bike lanes and sharrows on Doheny Drive between Burton Way and Whitworth Drive. The bike lanes will not remove any vehicle travel lanes or parking spaces.

At the Feb. 3 Traffic and Parking Commission meeting, staff presented the proposed conceptual design of Class II bike lanes and sharrows on Doheny Drive and provided their support for the project.

Staff presented the proposed conceptual design to City Council for consideration at the March 15 Study Session meeting and expressed support for the conceptual design, but directed staff to conduct more community education regarding the different types of bikeways in the design, such as bike lanes vs. sharrows, and to send a Citywide notice regarding City Council consideration of the project at a future date.

Installation of the bikeway on Doheny Drive is estimated to cost approximately \$5,000.

## Board Tables TCDS Staffing Plan

At their June 14 meeting the Board of Education tabled an agenda item that would have approved the staffing plan for Don Blake's Team Concept Development Services (TCDS) for a total of \$125,480, covering the remainder of the TCDS contract period, ending July 17.

Board President Mary Wells addressed concerns that TCDS owner Don Blake would be working 10 working days for a total of 100 hours, making him work more than full time. There were also several other employees listed in the staffing plan who were listed to work more than full time, including one employee working 14 hour days.

"I believe in the contract there was something in the language about not working overtime or something to that effect in the contract. I understand that they are putting those hours in there but likely they may not be billing for those hours. But, I don't see the point of putting it in there in the first place," Board President Mary Wells said.

Assistant Superintendent of Business Services Wade Roach said that in discussions with TCDS they said they expect to be working some weekends in July due to the transition of a new Bond Manager and if they do under this agreement the District would pay for those hours worked.

"I would prefer they put that into a 40 hour work week and if they wanted to work more hours they came back and made it an amendment or something to that effect," Wells said.

An amendment to the staffing plan will be included in order to not exceed 40 hours per employee without Board approval. The Board is expected to formally approve this amendment at their June 28 meeting.

## City Council Reappoints Commissioners

At their Study Session the City Council approved the reappointment of the following commissioners whose first two-year terms are ending on June 30; Arts and Culture, Liliana Filipovic; Cultural Heritage, Josh Flagg; Health and Safety, Erica Felsenthal; Human Relations, Rhoda Sharp; Planning, Myra Demeter; Public Works, Wendy Nystrom; Rent Stabilization, Lou Milkowski, Neal Basemen, and Kathy Bronte; and Traffic and Parking, Ron Shalowitz.

## Board Approves ProWest Audit

The Board of Education approved an agreement last Tuesday with Moss Adams to perform a construction cost compliance audit support services of ProWest for the District related to the B-3-B4, El Rodeo, and the Oil Well Construction projects. The vote was 4-1 with Board Vice President Noah Margo as the sole dissenting vote.

This decision comes after it was discovered that ProWest billed BHUSD for costs in excess of actual charges, resulting in an overbilling to BHUSD of millions of dol-

lars.

"I think that the audit of B1 and B2 was very fruitful and showed us a certain pattern of conduct and use of the funds and I think it would be very prudent to have a similar type of deeper dive into B-3, B4, El Rodeo, and the Oil Well Construction projects," Board member Mandy Stern said.

The audit is expected to be completed within three to four weeks.

"If you base it off of the b1 and b2 audit, at one point in time we were \$7 million ahead in payments to ProWest. Right now we are in the middle of our projects with B3, B4, and El Rodeo. B1 and B2 were \$60 million and B3 and B4 are \$128 million and so is El Rodeo. If we are potentially ahead of payments in those two projects - the reason that's important to know right now is that we pay [Bond Manager] Don Blake a fee of two in a half percent based on those costs. If we've paid him two in a half percent and we are ahead in payments we've overpaid Don Blake and we want to know that today," Board President Mary Wells said.

ProWest is overseen by Don Blake's Team Concept Development Services (TCDS); whose responsibility was to advocate on behalf of the district.

## City Council Approves Street Closures for Beverly Hills Cop 4

The City Council approved a request from Netflix and Paramount Pictures for temporary street closures and special film elements associated with filming "Beverly Hills Cop 4" in Beverly Hills, at their Tuesday meeting.

"Beverly Hills Cop 4" is the latest installment in a comedy franchise that features a stylized version of Beverly Hills, and its Police Department, with Detective Axel Foley, portrayed by Eddie Murphy.

The first film that was released in 1984 had portions filmed in Beverly Hills. In order to maintain the authenticity of the film's location, the film production team has requested to utilize actual locations in the City for some scenes.

A temporary street closure for an intersection of Wilshire at one of three proposed locations (McCarty, Crescent or Doheny Drive) for about 12 hours on a Sunday, likely in Oct., is expected to take place. Intermittent street closure and traffic control for wrong-way traffic filming on Rodeo Drive from Wilshire to North of Dayton for another 12 hour duration on a date in Sept. or Oct. is also expected to take place.

The film project will also be making a separate request for use of the Beverly Hills trademarked City shield, possible location establishment shots, and marketing for the movie.

The final dates and duration of the film days, closures, and intermittent traffic control will be administratively reviewed, approved, and permitted with City departments.

The approval is contingent upon a review of script pages depicting Beverly Hills by designated representatives from the Beverly Hills Police Department (BHPD) and the City Manager's office.

## City Council Shuts Down Review of Certificate of Ineligibility

The City Council has declined to call up for review a Certificate of Ineligibility decision issued for the residence located at 910 North Roxbury Drive.

A certificate of ineligibility bars the Cultural Heritage Commission or the City Council from initiating landmark designation proceedings concerning a particular property for a period of seven years from the date of issuance. While a certificate of ineligibility is in effect, the subject property cannot be listed on the local inventory, or subject to the provisions of the Municipal Code pertaining to designated and/or eligible historic resources in the City.

On May 31 after a review of the subject resource, it was concluded that the residence did not meet the strict criteria for historic designation.

The subject single-family residence located at 910 North Roxbury Drive was built in 1934 by E.P. Dentzel and designed by Robert V. Derrah in a Regency Revival architectural style. Derrah is recognized

for his contributions to the urban development of the city as a Master Architect and is currently listed on the City's Local List of Master Architects. Dentzel was a well-known builder and contractor who built many homes in Beverly Hills and served as a mayor. Although not an architect, Dentzel was previously listed on the City's Local List of Master Architects until his name was removed from the list in 2015.

Although the house is at least 45 years old, the subject property did not meet any other criteria requirements outlined in the Municipal Code. The property also cannot meet the definition of "exceptional work"

## Beverly High Student Awarded National Merit Scholarship

Maya Goldkorn has been awarded a \$2,500 scholarship after participating in the 67th annual National Merit Scholarship Program.

On Sept. 15 the National Merit Scholarship Corporation (NMSC) announced the names of approximately 16,000 Semifinalists who participated in the 67th annual National Merit Scholarship Program. Goldkorn, Sarah Lepkowitz, Ethan Stone, and Tian Yang were among the four students from Beverly Hills who qualified.

High school juniors entered the 2022 National Merit Scholarship Program by taking the Preliminary SAT/National Merit Scholarship Qualifying Test. The pool of Semifinalists, representing less than one percent of high school seniors, includes the highest-scoring entrants in each state.

To become a Finalist, the Semifinalist and a high school official must submit a detailed scholarship application. A Semifinalist must have an outstanding academic record throughout their high school career, be endorsed by a high school official, write an essay, and earn ACT or SAT scores that confirm the student’s earlier performance.

## Beverly Hills Man Pleads Guilty For Attempting to Hire a Hitman

Twenty-five-year-old Scott Quinn Berkett from Beverly Hills pleaded guilty on June 13 to a federal murder-for-hire charge for attempting to hire a hitman to kill a woman he briefly dated and who repeatedly tried to break off their relationship.

According to the affidavit, Berkett met the victim online in 2020, and the woman flew to Los Angeles to meet Berkett in late Oct. 2020. The victim, who described Berkett’s behavior as “sexually aggressive,” tried on several occasions to break off the relationship following the trip.

In April 2021, a family member, who had learned that Berkett continued to contact the victim, called and sent text messages to Berkett’s father’s phone, and, on April 20, Berkett appears to have responded by saying “consider this matter closed.”

Berkett admitted in his plea agreement that, soon afterward in April 2021, he solicited and paid for murder-for-hire services via a website on the darknet that purportedly offered such services. Berkett provided the darknet group with specific directions and details about his target. As payment for the victim’s murder, Berkett sent the darknet group bitcoin payments totaling approximately \$13,000.

In May 2021, an undercover law enforcement officer contacted Berkett while posing as the hitman Berkett believed he had hired from the darknet group. The undercover officer sent Berkett pictures of the victim. Berkett confirmed that the pictures showed his intended victim and that he had made bitcoin payments to obtain her murder. Berkett further requested proof of her murder and made an additional \$1,000 payment to the undercover officer via Western Union for her death.

A sentencing hearing is scheduled for Sept. 12, at which time Berkett will face a statutory maximum sentence of 10 years in federal prison.

## Planning Commission Approves Summer Camp for Young Israel of North Beverly Hills

At their Thursday meeting the Planning Commission approved an amendment to a previously approved Conditional Use for Young Israel of North Beverly Hills to allow a summer day camp for children in an existing synagogue facility located at 9261 Alden Drive

Young Israel of North Beverly Hills has served the Beverly Hills community since 1991, and it is a Modern-Orthodox-Zionist congregation.

The previously approved CUP permits allow the synagogue to hold services at the following times: Monday to Friday: 6:00 AM to 8:30 AM and 4:30 PM to 10:00 PM; Saturdays and Sundays: 6:00 AM to 11:00 PM; and Thirteen times per year (as dictated by religious practices) services may be held between the hours of 7:30 AM to 5:00 PM, Monday to Friday.

No social events that are unrelated to a religious service are permitted on site, including celebrations for weddings and gatherings not related to a religious ser-

vice. Per the existing resolution, youth group programs and childcare/child enrichment programs shall only be provided for members during religious services.

The proposed project consists of a request to amend the most recent resolution to allow for a summer youth day camp to occur outside of the permitted hours, and not in conjunction with a religious service. The proposed summer youth day camp would operate from Monday to Friday from 8:30 a.m. to 12:00 p.m. and would run for 6 weeks during the summer vacation. The camp would have a total of three employees and 12 children and would be held within the existing social hall building.

Due to the limited number of children that would be participating in the proposed camp, staff does not anticipate negative impacts to the neighboring properties, according to a staff report.

The Commission approved the request with the condition that would require the applicant to obtain any license that may be required by law regarding the operation of the program.

## Human Relations Commission Discusses Civility Month

At their June 16 meeting the Human Relations Commission discussed possible events for Civility Month in the City.

In 2017, the Commission declared Oct. as Civility Month to further the civility initiative in the City. Banners and posters will be displayed throughout the City to commemorate the month. Embrace Civility pins will also be available for Commissioners, City staff, and Ambassadors to distribute to the community demonstrating civility.

The Embrace Civility Award has been the primary event during Civility Month in the past. Commissioner Laura Hornwood Margo recommended a Citywide donation

day which the Commission unanimously agreed to explore. Margo suggested that there be five different charities where residents can come and drop off items.

The Commission will finalize any plans for Civility Month at a future meeting.

It can be used anywhere, anytime. You don’t have to do it at home. For example, the foot peels that make you shed a whole layer of skin. It takes a long time, it’s unsightly. But this exfoliates and hydrates almost instantly. And it’s just very convenient for those that are on the go.

**You are a compounding pharmacist.**

**Did that contribute to your wanting to do this?**

**Jasmine:** Definitely, I have been doing this for 13 years. It was a lot of trial and error to get the consistency correct to make sure it absorbs quickly but doesn’t leave an oily residue. A lot of creams and foot balms leave an oily residue afterwards and you can ruin your shoes, floors, or bed sheets. It’s just not convenient. **What future business goals do you have for the product?**

feet in water. You can use it on dry skin. So, you're saving time and water. And then you put the serum on right afterward, it dries in a second and you can put your shoes on and just be out the door. Since it is so easy, it'll make people more compliant and make them use it on a daily basis if need be. When I used to get a foot peel or foot scrub it would be so messy and so inconvenient. I would probably just use it once and leave it in my cupboard and not use it again. And then I still suffered from cracked heels. As a pharmacist, I've stood on my feet for a long time and when I got pregnant I gained a lot of weight. And that weight gain along with standing on my feet for so long, I had horrible cracks in my heels. This product we made was the only thing that cured my heels. I don't have any cracks on my feet. **Candice:** The best part about our product is that it takes under a minute. In between filing, applying the serum, and drying, it literally takes under one minute.

#### ORDINANCE NO. 22-O-2862

AN INTERIM ORDINANCE OF THE CITY OF BEVERLY HILLS EXTENDING INTERIM ORDINANCE NO. 21-O-2841 ESTABLISHING A MORATORIUM ON FRACTIONAL OWNERSHIP OF RESIDENTIAL AND COMMERCIAL PROPERTY, DECLARING THE URGENCY THEREOF AND MAKING A DETERMINATION OF EXEMPTION UNDER THE CALIFORNIA ENVIRONMENTAL QUALITY ACT (CEQA)

THE CITY COUNCIL OF THE CITY OF BEVERLY HILLS HEREBY ORDAINS AS FOLLOWS:

#### Section 1. Legislative Findings.

A. California is experiencing a housing supply crunch. Existing housing in this state, especially in its largest cities, has be-

come very expensive. California needs an estimated 180,000 additional homes annually to keep up with population growth, and the Governor has called for 3.5 million new homes to be built by 2025.

B. Fractional ownership of residential property for use or possession of the property for a period of less than a full year, akin to a vacation time-sharing property model, reduces the availability of residential property for long-term occupancies in the City. Thus, creating the need for more housing. Moreover, the use of fractional ownership can be detrimental to the City and its residents because such multiple occupancies disturb the stability of residential neighborhoods.

C. Fractional ownership of residential or commercial property, can adversely impact future development, redevelopment, safety, and proper maintenance of the property as a result of the complexities associated with the incongruent and changing objectives, intents, and goals of multiple owners.

D. The City Council believes that unregulated fractional ownership of residential or commercial properties with time-based occupancy restrictions would unduly impact the City. The City Council therefore believes there is a current and immediate threat to the public health, safety and welfare that is presented by such ownership models, and that a moratorium is necessary to continue studying the regulation of fractional ownership.

E. On July 15, 2021, the City adopted Interim Urgency Ordinance No. 21-O-2841, which imposed an initial 45-day moratorium on the fractional ownership of residential and commercial property within the City during the pendency of the City's review and adoption of permanent regulations governing fractional ownership in the City. The initial 45-day moratorium expired on August 29, 2021.

F. On August 17, 2021, the City adopted Ordinance No. 21-O-2842, which extended the Interim Urgency Ordinance No. 21-O-2841 for an additional ten (10) months and fifteen (15) days, with an expiration date of July 15, 2022.

G. The City Council continues to find that the time provided by the moratorium will allow for a comprehensive analysis of residential and commercial property ownership models, including fractional ownership, with time-based occupancy restrictions. During the extended period of the moratorium, the City will continue to analyze potential impacts on public health and safety related to time-based occupancy restrictions; and impacts on the public welfare due to the removal of full-time housing units from the market and replacing them with vacation or part-time units, the inference with the stability of residential neighborhoods and the impact on the maintenance and redevelopment of properties. The City Council finds that these analyses will help the City Council determine how to best prevent impacts to the public health, safety and welfare. The City Council further finds that extension of the moratorium will allow time to achieve a reasonable level of assurance that there will not be serious negative impacts to the overall community and ensure a positive and mutually acceptable set of outcomes for the City's residents, business community, and property owners.

H. Based on the foregoing, the City Council ultimately finds that if the City fails to extend the moratorium, fractional ownership of properties with time-based occupancy restrictions may be allowed under outdated zoning regulations that do not address the unique impacts of such ownership models before the City Council is able to review the matter in order to adequately protect the health, safety and welfare of the residents, business community, and property owners of the City. Therefore, a current and immediate threat to the public safety, health and welfare remains in existence.

I. A written report describing the measures taken to alleviate the conditions which led to the adoption of the aforementioned Interim Urgency Ordinance was issued by the City Council on June 2, 2022 which was at least ten (10) days prior to the expiration of the Interim Ordinance on July 15, 2022, in compliance with State law.

J. Pursuant to Government Code Sections 65858 and 65090, the City Council conducted a duly noticed public hearing on June 14, 2022, at which time the City Council considered

this Ordinance to extend the existing moratorium on the establishment of the fractional ownership of residential and commercial property for an additional one (1) year period.

#### Section 2. Authority.

Pursuant to Government Code Section 65858, the City Council may adopt, as an urgency measure, an interim ordinance that prohibits any uses that may be in conflict with a contemplated zoning proposal that the City Council is considering, studying, or intends to study within a reasonable period of time.

#### Section 3. Urgency Findings.

The City Council finds and determines that there is an immediate threat to the public health, safety, or welfare, and that fractional ownership of residential and commercial properties with time-based occupancy restrictions constitute a threat to the public health, safety or welfare. As described in Section 1, the staff report accompanying this Interim Urgency Ordinance, and other evidence in the record, such fractional ownership in the City could threaten the health, safety and welfare of the community through negative impacts that include, but are not limited to, removing full-time housing units from the market and replacing them with vacation or part-time units, interference with the stability of residential neighborhoods and interference with the maintenance and redevelopment of properties. To preserve the public health, safety, and welfare, the City Council finds that it is necessary that this Interim Urgency Ordinance take effect immediately pursuant to Government Code Sections 65858 to prevent such harm.

#### Section 4. Moratorium Extended.

Based on the facts and findings set forth in Sections 1 through 3 of this Interim Urgency Ordinance, and notwithstanding any other ordinance or provision of the Beverly Hills Municipal Code, the City of Beverly Hills hereby extends the following moratorium:

A. Definitions. For the purposes of this moratorium, the following phrase has the meaning given herein.

1. "Fractional Ownership" shall mean shared ownership of real property, entitlement to ownership rights of real property, entitlement to use of real property, or possession of real property through any of the following means:

- Direct ownership of the property;
- Indirect ownership of the property through a membership, stake, interest, share, association, or similar device in the owner of the property or a subsidiary or parent of the owner of the property; or
- A membership, stake, interest, share, association, or similar device in an entity, group, association or similar device which by virtue of such membership, stake, interest, share, association or similar device grants entitlement to ownership rights or the use or possession of the property.

B. Time-Based Occupancy Restrictions. Unless approved by a specific plan, fractional ownership of any real property in the City shall be prohibited if such ownership includes any arrangement, schedule, plan, scheme, or similar device, whether by agreement, sale, lease, deed, license, right to use agreement, or by any other means, whereby an owner of the property or a fraction thereof, receives ownership rights in, or the right to use, the property for a period of time less than a full year.

C. Request for Hearing. Any person with a fractional ownership in the City who is threatened with enforcement of time-based occupancy restrictions or to whom an administrative citation is issued pursuant to this Ordinance may apply to the City Council for a hearing to review the time-based occupancy restrictions as applied against the property with such fractional ownership. Any such application shall be in writing and shall be received by the Community Development Department. Any application as a result of an administrative citation shall be received by the Community Development Department within thirty (30) days after the date of the administrative citation.

D. Notification for Hearing. Hearings pursuant to this Ordinance shall be preceded by public notice by the following method:

1. Mailed Notices: The applicant shall mail notices providing, at a minimum, the property address of the property involved with the

hearing, general scope of the request, basic hearing information, and City contact information to recipients of the notice. Such mailed notices shall be sent via private courier service with the ability to track delivery of the notice, and shall be mailed at least twenty (20) days prior to such hearing by the reviewing authority. Mailed notices shall be sent to properties within a 300-foot radius, measured from the exterior boundaries of the property involved with the hearing.

**2. Affidavit/Proof of Mailing:** The applicant shall submit an affidavit to the Community Development Department within five (5) days of mailing the notices required by this section, verifying that the mailings are in compliance with this section.

**E. Exception to Time-Based Occupancy Restrictions.** The time-based occupancy restrictions shall not apply to real property with fractional ownership if the City Council makes the following finding:

1. The fractional ownership of the property will not disturb the stability of a residential neighborhood or residential building and will not adversely impact future development, redevelopment, safety, and proper maintenance of the property.

**Section 5. Enforcement.**

The provisions of this Interim Urgency Ordinance shall be enforceable pursuant to the general enforcement provisions in Title 1 of the Beverly Hills Municipal Code.

**Section 6. CEQA Findings.**

The City Council hereby finds that it can be seen with certainty that there is no possibility that the adoption of this Ordinance may have a significant effect on the environment. This Ordinance does not authorize construction and, in fact, imposes greater restrictions on certain properties in order to protect the public health, safety and general welfare because the Ordinance will impose a temporary moratorium on certain fractional ownership in the City in order to protect the public health, safety and general welfare, and will thereby serve to avoid potentially significant adverse environmental impacts during the term of the moratorium. In addition, the Ordinance consists of minor alterations in land use limitations and do not result in any changes in land use or density. It is therefore not subject to the California Environmental Quality Act review pursuant to Title 14, Chapter 3, Sections 15305 and 15061(b)(3) of the California Code of Regulations.

**Section 7. Severability.**

If any section, subsection, subdivision, paragraph, sentence, clause, phrase, or portion of this Ordinance or its application to any person, place, or circumstances, is for

any reason held to be invalid or unenforceable by the final decision of any court of competent jurisdiction, such invalidity or unenforceability shall not affect the validity or enforceability of the remaining sections, subsections, subdivisions, paragraphs, sentences, clauses, phrases, or portions of this Ordinance, or its application to any other person, place, or circumstance. The City Council hereby declares that it would have adopted each section, subsection, subdivision, paragraph, sentence, clause, phrase, or portion hereof, irrespective of the fact that any one or more sections, subsections, subdivisions, paragraphs, sentences, clauses or phrases hereof be declared invalid or unenforceable.

**Section 8. Effective Date: Approval and Extension of Ordinance.**

This Ordinance, being an Interim Ordinance adopted as an urgency measure for the immediate protection of the public safety, health, and general welfare, containing a declaration of the facts constituting the urgency, and passed by a minimum four-fifths (4/5) vote of the City Council, shall take effect concurrent with the expiration of Interim Urgency Ordinance No. 21-O-2841, as extended by Ordinance No 21-O-2842, at midnight on July 15, 2022, and shall remain in effect for a period of one year, through and including July 14, 2023, in accordance with California Government Code Section 65858.

**Section 9. Publication.**

The City Clerk shall certify to the passage and adoption of this Ordinance and shall cause its publication in accordance with applicable law.
