"Extending Film Tax Credits and Arts Payroll Grants"

So much of Beverly Hills' fame, economy, culture, lifestyle, and social life is tied to Hollywood, the arts, celebrities, showbiz, and the entertainment at-large, the City's citizens and business sector recognize the importance of subsidies through tax credits mandated from Sacramento.

On June 15, I strolled into the Sacramento Capitol Building to attend the Assembly Committee On Arts, Entertainment, sports, Tourism, And Internet Media Hearing which focused on helping show business in California stay above the tidal wave waters of competitive entertainment industry subsidies and hemorrhaging runaway film and television production.

On the table for favorable committee vote passage were bills SB 485 and SB 1116.

SB 485 gives the California Film Commission in Hollywood the authorization to give out film and television tax credits for another 5 years through June 2030. Hollywood honchos will have more assured predictability in their business dealings for eight more years.

SB 1116 lets small and underfunded small nonprofit performing groups hire and keep employees and administrative staff on their payrolls through a grant program funded by the Performing Arts Equitable Payroll Fund through the (California) Small Business Advocate.

HBC Unveils Plan to Transform Saks Fifth Avenue

HBC Properties and Investments, HBC's real estate and investments portfolio business announced at a banquet on June 23 their 5-year plan to restore, develop and revitalize properties affiliated with Saks Fifth Avenue around Wilshire Boulevard in Beverly Hills.

"Drawing on HBC's rich 350-year history of entrepreneurship and reinvention. The 9600 Wilshire project is an exciting and important step on our journey to build a future-facing holding company of luxury online and brick and mortar retail, highend real estate and an intellectual property incubator that launches new businesses such as our growing, global flexible office offering," HBC Governor, Executive Chairman, and CEO Richard Baker said.

The project will include the restoration of the Saks building façade; the adaptive reuse of the Barney's building as the new home of Saks Fifth Avenue Women's store; the construction of two Class-A office buildings; the development of complementary residential apartments on the surface parking lots, and new retail, dining, membership club, and related commercial uses on the remaining portions of the site.

Board Approves New Bond Manager

The Board of Education approved a contract for Bond Program Management Services for the ongoing BHUSD construction program intended to modernize facilities with Fonder-Salari. Inc.

"It is fair to say that as a result of going through the public bidding process the district will be paying nearly half of the fees that we paid to TCDS for the same services and will save millions of dollars and for those in the community who have been asking, Fonder-Salari is licensed and meets the requirements of Government Code section 4525," Board President Mary Wells said.

Fonder-Salari, Inc. is a women-owned full-service construction consulting firm that offers services in construction management, program management, preconstruction, contract management, facilities management, and construction support services in Southern California. They have worked on a number of school related projects, including the Antelope Valley College – Sage Hall, Gymnasium Renovation, Program Management, Cedar Hall, and the Castaic Union School District – Live Oak Elementary School Modernization.

The Board previously directed staff to create an RFP for Bond Management Services because the current contract with Don Blake's Team Concept Development Services (TCDS), who now provides these services for the District, expires July 17.

After the departure of the previous Bond Manager, Totem, the Board approved the contract for Blake in 2017 with no bidding process, upon the advice of former BHU-SD counsel Terry Tao.

At the Oct. 26 Board meeting, Board President Mary Wells pulled an agenda item regarding a revised agreement for Bond Management Services between BHUSD and TCDS. Had the Board approved the agenda item, Blake would have been granted another contract for five years. Blake would have also been compensated 2.5% of the total construction costs for projects under the unapproved contract.

There has been a lot of controversy regarding Blake's management of the construction program, including the fact that his contractor's license expired in 2000.

In 2019 a lawsuit was also filed against TCDS and Tao personally by iXero, with whom a contract was created to provide a state of the art security program for the BHUSD. The lawsuit alleges that Tao advised BHUSD not to pay iXero, and that TCDS wanted iXero to "union bust", or to get rid of district security personnel so that only outside armed guards of TCDS choosing remained.

The Board will formally approve a contract with Fonder-Salari, Inc. at a future meeting.

City Council Discusses Annual Rent Increase

The City Council discussed a report on the most recent Consumer Price Index (CPI) data and its relationship to the RSO annual rent increase.

On May 10, 2022, the City Council adopted amendments to the urgency ordi-

nance and the maximum allowable rent increase at the end of the rent increase moratorium. The ordinance ended the rent increase moratorium and established a maximum rent increase of 3.1% for the period of June 1, 2022 through June 30, 2023.

The 3.1% rent increase was only authorized for units that would have been eligible for a rent increase during the period of July 1, 2019 through June 30, 2020, but either

did not increase the rent at all or imposed an increase of less than 3.1%. At this time the ordinance does not allow any other rent increases, which means that approximately 74% of the RSO units continue to be precluded from issuing any rent increases.

The City Council requested that staff return with a report on the annual rent

increase for the period from July 1, 2022 through June 30, 2023 once current CPI data became available.

The May CPI numbers are higher than normal due to rising inflation. Without the current rent increase limitations imposed by the most recent ordinance amendments, the rent increases that would otherwise

be allowed for the period of July 1, 2022 through June 30, 2023 would be 6.15% for Chapter 5 Tenants and 8% for Chapter 6 Tenants.

Currently, Santa Monica is raising their rent increase in Sept. to 6%.

Given that the previously approved 3.1% increase only applies to certain RSO units, and a significant number of RSO units continue to be precluded from any rent increases, staff asked the City Council if they wished to uniformly apply a rent increase

Although 74% of the RSO units are precluded from issuing any rent increases, the City Council decided to not make any changes to the ordinance.

City Council Approves Certificate of Ineligibility for North Roxbury Home

At their June 21 meeting the City Council approved a Certificate of Ineligibility for the residence at 1001 North Roxbury Drive after they ordered a review of the Director of Community Development's March 2 issuance. The vote was 4-1 with Councilmember John Mirisch as the sole dissenting vote.

A certificate of ineligibility bars the Cultural Heritage Commission or the City Council from initiating landmark designation proceedings concerning a particular property for a period of seven years from the date of issuance. While a certificate of ineligibility is in effect, the subject property cannot be listed on the local inventory, or subject to the provisions of the Municipal Code pertaining to designated and/or eligible historic resources in the City.

Subsequent to the issuance of the Certificate of Ineligibility, Mirisch requested that an item be placed on the March 15 agenda to consider a call for review of the Certificate of Ineligibility. During the City Council meeting on March 15, two previously unknown articles that discussed the residence were brought to the Council's attention by Cultural Heritage Commission Chair Craig Corman and Commissioner



Jill Collins. Due to the fact that there was not sufficient time to review the articles and determine if they could have a material impact on the City Council's discussion, the City Council continued the item to the April 12 meeting.

On April 12 the City Council discussed the item to consider the merits of the two newly discovered publications, Luxe Interiors + Design and Architectural Digest Russia, which were previously brought forward. The Council ultimately voted to call up the decision for review to further analyze the publications and verify the legitimacy of the Architectural Digest Russia magazine.

Many speakers and written comments expressed opposition to the issuance of the Certificate of Ineligbity.

"I still don't understand how you can look at a property like this and say 'this is a great piece of land, let's tear it apart and build what we want," Collins said.

The residence was designed and constructed in a Regency Revival architectural style by Carleton Burgess in 1942. Although Burgess was a designer and contractor, he is included on the City of Beverly Hills List of Master Architects for his important contributions to the urban development of the City.

The municipal code requires that for a publication to be applicable, it must substantively discuss or photographically depict the work of the Master Architect, which in this case is Carleton Burgess. Each publication does include at least one photograph of the front façade of the home, and the publications do include some text that makes reference to the beauty and old Hollywood feeling of the home. However, the primary focus of each of the publications is the interior and backyard remodel work performed by Mark Rios. The nature of the publications do not directly pertain to the work of Burgess, but rather are intended to recognize the work of Rios.

Ultimately four members of the Council decided that the issuance of a Certificate of Ineligibility is the most reasonable out-

"Last [week] was a sad and disgraceful moment for our Community and for historic preservation in Beverly Hills. Yet again, the Council majority has placed money and power above the common good and above our City's past, present, and future,' Mirisch said.

City Council Receives Roxbury Drive Protected Bike Lane Pilot Project Update

The City Council received an information update on their June 21 Study Session

agenda regarding an update on the Roxbury Drive Protected Bike Lane Pilot Project installed in late 2021, which includes a southbound protected bike lane and northbound conventional bike lane on Roxbury Drive south of Olympic Boulevard.

On Sept. 19 the City Council approved the implementation of the Roxbury Drive Protected Bike Lane Pilot Project and began the evaluation period in Jan. 2022. According to the staff report, the City has not received any new comments or complaints regarding the pilot project during the second quarter.

During the second quarter, staff painted meter numbers within angled parking stalls adjacent to the bike lane in an attempt to reduce confusion about which meter corresponds with each parking stall. This will also be monitored over the third quarter to determine if the issue is addressed.

The City has also started to utilize the existing CCTV cameras to evaluate the project to conduct user counts. According to data from April, there are on average 26 bicyclists riding the block per day and up to 40 bicyclists per day.

According to the staff report, plastic delineators as buffers between parked cars and bike lanes continue to be a maintenance challenge because drivers tend to push their vehicles into the delineators or maneuver between them.

Falling tree leaves and debris have also been accumulating every day and city staff is exploring grant opportunities to purchase an electric mini street sweeper that would allow for more efficient sweeping and could also be used for enhanced alley

A third quarter informational update on the pilot project is expected to be completed in fall.

Planning Commission Discusses Extended Hours Permit for 76 Gas Station

Commission discussed an Extended Hours Permit allowing for the 24-hour operations of the convenience store for the 76 Gas Station located at 9460 Olympic Boulevard. The Commission approved in a 4-1 vote to allow for the continuance of the Extended Hour Permits with Commissioner Myra Demeter as the sole dissenting vote.

The Commission previously approved a Conditional Use Permit and Extended Hours Permit for the applicant Morris Pouldar. Under one of the conditions, the project shall be reviewed by the Commission two years after the expansion has been completed and operations have commenced to determine whether the project is causing any adverse impacts and whether

The expansion and operations commenced in May 2020. On April 5, the applicant submitted an application for the review of the Conditional Permits related to the operation of the gas station and convenience store.

Some public comments were made stating that the Extended Hours Permit was responsible for causing loitering, littering, and safety issues to the area. However, the majority of the Commission was not persuaded that the gas station is responsible for these complaints.

"We have a lot of things going on in our community that we wish we didn't have. But, I don't think they are caused by or in any way exasperated by the operations of the gas station and convenience store," Commissioner Peter Ostroff said.

Next BH Discusses 'Next Night'

At their June 16 meeting the Next BH Committee discussed planning details for 'Next Night' which is expected to take place in late Oct.

Next Night is a block party/street fair on South Beverly Drive that Next BH has traditionally put on but has stopped for the past two years due to COVID. During the event, the street is closed off with talent, food, and vendors.

For talent, the Committee suggested possibly bringing back some violinists or drummers from past years, as well as possibly getting a local DJ or comedian. Possible themes where people dress up were also discussed.

The Committee will finalize any plans at a future meeting.







You are the Senior Vice President of Torey Pines Bank. Tell us about that.

In my role at the bank I am Senior Director and I run the region of Beverly Hills and West LA for the bank. We opened up our Beverly Hills office 10 years ago and I came on board to open up the office, hire the team, and expand the bank into Beverly Hills and the westside.

Banking is a traditionally male-dominated industry. How were you able to rise the ranks in that industry?

There's a lot more work to do to get women into executive roles and on to the board of companies. But I think that is true across a lot of corporate America still. But I find that organizations are working more on that and here at this company [where] I've been for 10 years, hard work is certainly recognized and I've found myself able to move up.

What made you want to get involved in the Chamber?

I got involved with the Chamber ten years ago when we opened this office in Beverly Hills. And I knew the Chamber has a phenomenal reputation and I got involved because I really wanted to meet the local businesses. I wanted to see what I could do as someone who offers business loans and business banking. 'What could I do to help some of the local businesses? What were their needs?

Who were the people "I'd like to help build behind the businesses? And how can I be helpful?' I've been very glad ever since I've gotten involved.

> What's your strategy for attracting new businesses and retaining existing businesses?


