

CBOC Presents Annual Report

The Citizens' Bond Oversight Committee (CBOC) presented its annual report regarding the 2020-2021 fiscal year bond funds for Measure E and Measure BH for the period from July 1, 2020 through June 30, 2021, at last Tuesday's Board of Education meeting.

The CBOC is charged with overseeing bond fund expenditures and ensuring they are used for their intended purpose.

The CBOC said that a lack of a staffing plan for the Bond Manager resulted in poor oversight and possible unchecked growth in staffing expenditures.

According to the report, there was no clear staffing plan or budget that regulated labor costs for the bond manager, TCDS, which is run by Don Blake. TCDS staff were given several raises and then the District was charged those higher rates, without any Board oversight or approval. Moving forward, in order to assure cost controls, the CBOC recommended that the District create and approve a clear staffing plan with an accompanying budget and provide greater oversight on any pay increases with the bond manager and other vendors. The District has also taken steps toward addressing this issue.

The CBOC is also concerned with how the District provided TCDS with a con-

tract to develop a comprehensive security program.

According to the CBOC, there is little transparency about the security project, making it unclear exactly what the security contract requires and are concerned that this project may not be appropriate to be spent out of bond funds. The contract was initially planned for \$3 million and ended up costing \$12 million. The CBOC recommended that the Board review the security program, provide greater transparency to the CBOC and the community, determine whether this project should have been conducted using Bond funds, and examine why the cost of the project grew so much.

The CBOC recommended the District hire experienced personnel to oversee expenses and evaluate that costs are within contract and guidelines because they believe the District had insufficient staff in place to oversee the bond program and has been relying solely on the contractor's billings.

The CBOC also stated that frustration has grown within the community as the bond program's budget shortfall has become clear. They believe that presentations at Board meetings are not sufficient to keep the community informed as to the progress of campus projects and the budget issues. They believe that the District should conduct more proactive community outreach to update parents, taxpayers, and stakeholders.

Lastly, the CBOC recommended that the Board of Education undertake a more comprehensive audit focused on charges from the general contractor, ProWest based on their concerns about the lack of transparency, and the results of the Audit of projects B1 and B2 at Beverly High, and poor oversight of expenditures.

The Board has since issued an RFP and will approve a new contract for bond management services with Fonder-Salari, Inc.

"The CBOC recommendations are aligned with the changes recently made by the BOE and the District to the Construction and Security program. Many of these recommendations have been part of the Moss Adams Audit report repeatedly since 2016. All of these changes are critical for effective management and oversight of our Bond Program and will provide better transparency and accountability," Board President Mary Wells said.

Board Discusses Recording Committee Meetings

At last Tuesday's meeting, the Board of Education discussed whether the district should start recording committee meetings, such as the CBOC, and uploading them onto the district website for the public to view.

Prior to COVID, the district did not record committee meetings and now that many meetings are coming back in person they are not being recorded.

"My preference would be that we make those Zoom licenses available to our committee members and whether or not they're meeting in person or virtual, someone just opens up zoom, record, and at some point, we upload the committee meeting just in the interest of transparen-

cy," Board member Gabriel Halimi said.

Assistant Superintendent of Business Services Wade Roach said that the District is currently working on the technology to be able to tape the meetings and then upload them but that is not feasible quite yet.

Halimi recommended that the committee bylaws be updated to have an expectation to use Zoom or Google Meet to record committee meetings and post them on the District website within 72 hours.

Traffic and Parking Commission to Receive Slow Streets Program Update

The Traffic and Parking Commission is expected to receive an informational update regarding the Slow Streets Program, at their Thursday meeting.

The City has installed nine Neighborhood Slow Streets designations. Neighborhood Slow Streets are residential street blocks restricted to local traffic by using the entire street width for walking, cycling, or other modes of non-motorized transportation.

Neighborhood Slow Streets are not street closures and allow local traffic access for residents and their visitors, delivery vehicles, street sweeping, trash pickup, and emergency vehicles.

The program requires a resident sponsor who lives on the proposed street block to nominate their street block for consideration, serve as the block sponsor in obtaining the support of their neighbors, monitor the signs and conditions on the street, and communicate with City staff.

As of June 28, 2022, no new applications have been received and ten applications are pending receipt of the qualifying number of signatures from street block residents.

Slow Streets signs have been installed

on the following street blocks: 400 block of South Camden Drive; 400 block of South Crescent Drive; 400 block of South Peck Drive; 200 block of South Rodeo Drive; 300 block of South Maple Drive; 100 block of North Oakhurst Drive; 400 block of South Clark Drive; 400 block of Spalding Drive; and 300 block of South Clark Drive.

Rent Stabilization Commission to Discuss Surcharges

At their Wednesday meeting the Rent Stabilization Commission is expected to discuss recommendations to the City Council regarding possible amendments to the Rent Stabilization Ordinance (RSO) regarding surcharges that allow housing providers to pass through costs to tenants relating to water service penalties and/or surcharges, and refuse fees.

For Chapter 5 tenants only, the Commission is also expected to discuss capital expenditures, improvement expenses mandated by law, including seismic retrofit, utility expense, and for additional tenants; as well as possible amendments regarding the amount of the maximum allowable annual rent increases.

On April 6 the Commission discussed the pass through and maximum allowable rent increase topics and on May 4 discussed the "just and reasonable return" doctrine and the rent adjustment application process.

The Commission is expected to discuss pass through comparison of surrounding jurisdictions; pass through sample calculation of applied existing pass throughs; additional tenant passthrough by other ju-

Hochman Questions Bonta's Publication of Concealed Carry Permit List

Nathan Hochman for California Attorney General had issued a statement in response to California Attorney General Rob Bonta publishing the state's concealed carry permit holders list last week.

"In releasing its 2022 Firearms Dashboard Portal, following the Supreme Court's Second Amendment decision in Bruen, Bonta claimed that he was trying to improve transparency by sharing firearms-related data about the issuance of Concealed Carry Weapons permits and Gun Violence Restraining Orders. 'Transparency is key to increasing public trust between law enforcement and the communities we serve,' said Bonta in his press statement. Instead of increasing trust, Bonta's massive leak of privacy data of hundreds of judges, law enforcement officers, prosecutors, and domestic violence victims' full names, home addresses, and dates of birth has irreparably broken the public's trust in Bonta's ability to handle extremely sensitive and private data. Bonta's Department of Justice has now facilitated criminals' ability to target the homes of hundreds of judges, law enforcement officers, prosecutors and domestic violence victims. His feeble solution to provide 'credit monitoring services' to those affected is like trying to put a band-aid on a potentially life-threatening wound. If he were president of a public company, such a grave error would result in the board firing him immediately. As Attorney General, the public will have that chance when it votes him out of office in November," Hochman said.

Newsom Approves Funding for California Holocaust Survivor Assistance Program

On June 30 Governor Gavin Newsom approved the 2022-23 State Budget, which includes \$36 million dollars in funding for the California Holocaust Survivor Assistance Program.

very good patient. She's just been really tough and my daughter has formed the first phase of the restorative part. We are trying to save the teeth that we can. Dr. Doug Galen did the extractions to [eight] teeth that were hopeless. She's still healing and healing well, but we did not want to delay the restorative part because the decay can get deeper. So, we are trying to save the teeth that we can.

What dental work did you do?

What we are doing is restoring the teeth with fillings, crowns, and get what's called a removable ridge. In the meanwhile, we're giving her back the smile she had. We're just in the throes of restorative work. There's a lot to be done and she may need other attention like root canals and things like that because the decay is deep in a couple of the teeth.

How much would the cost of the work have been had they paid out of pocket?

[About \$30,000], I think that's a fair estimation.

Tell us about the car the Temple is trying to get the family and how people can help.

I think they have been trying to get the word out and perhaps this article will be helpful in that. Maybe if someone has a vehicle they are not using and they want to give it away as a tax deduction.





You are the Regional Vice President and General Manager of the Beverly Wilshire. Tell us about that.

I got here in summer of 2018, so I've been fairly new to Beverly Hills but I've been with Four Seasons for the last 22 years. When I joined the Beverly Wilshire I was asked to join the CVB.

Which is obviously wonderful because it was a great opportunity for me to get to know the community and some of the stakeholders. [CVB CEO] Julie [Wagner] asked me to join the Board I think six months after I got here. And then I served as the President the summer of 2020 – 2021. Obviously, that wasn't the year I had imagined when I was appointed Chairman the first 2020. Not necessarily time around. So, this time I said to Julie 'give me another try' because I think we have a lot left to be done that I was unable to complete in my first year. This is kind of how I ended up in my second time as Chairmen for the CVB.

What location were you at before Beverlv Hills?

I came from New York. I was at the York downtown, which was a fabulous hotel [and] location. people that come here Pre-pandemic New to shop but there is a York was incredibly energetic, busy, and just a huge place. So, I had a wonderful couple of years in New

York. But, my family and I used to live in California before when I worked at the Four Seasons in San Diego many years ago. We always wanted to come back to Southern California. When the opportunity presented itself to move to the Beverly Wilshire it was too good to be true because I was able to professionally grow my career and at the same time my

family could come back to a place they fell in love with. My sons were actually born in La Jolla. We really felt lucky when we returned to Southern California in 2018 for the second time. My wife has made it very clear that this is her home she's here to stay and whatever happens to me she will not ever leave again. She

> just loves this place. I actually met her in LA at UCLA many years ago. California's just a very special place for us.

What are some goals you have for the CVB?

Our first goal is to re-establish Beverly Hills as a luxury destination coming out of you that Beverly Hills COVID. I don't have to tell you that Beverly Hills suffered quite a bit in the summer of 2020. Not necessarily because of COVID but because of all the but because of all the civil unrest that we had. the other hotels. That really is our number one goal, to go out to the world and say 'Beverly Hills is better and stronger and more beautiful than ever before.'

Have you noticed tourism is back since the Pandemic?

Tourism is back, but tourism isn't back in full force Domestic clients have returned to Beverly Hills. What we are not seeing yet in the same numbers is the international travelers. We are still missing a certain percentage from Europe. We're missing a lot of the Chinese business. The Middle Eastern business has come back to a good extent. The rest of the world has not so much yet. But when you look at it on the world map, America is very strong. The rest of the world, not so much yet. It has to do with that until recently it was somewhat challenging to come into the US with travel restrictions and COVID testing. Until this is fully removed, I don't think we will see the same numbers. But I think hotels and tourism-related businesses will start to do better again. Are we back to pre-COVID levels? Not quite. But I think we are very optimistic that in 2023 and beyond we are able to quickly regain what we have lost and then add on top of that. I think unless we get into a recession next year, the future looks very promising.

What kind of questions do foreign tourists ask about Beverly Hills?

It's the same questions as pre-pandemic. Which is, 'what's there to do?' 'Where should I go and experience LA?' Sometimes people come to Beverly Hills not just because of Beverly Hills but because we are smack in the middle. They use it as a centralized location to explore LA. Which includes Santa Monica, Malibu, Beverly Hills, LA, and Hollywood. So, I think that's always the first question. 'What's there to do?' What's exciting?' And I think all of our hotels are trying to stay informed and be able to speak to our clients with the newest and latest things that have opened or changed, especially in the restaurant scene. That's always the number one scene. What is the best restaurant, or coolest restaurant? That's really what people are asking when they come to a place like Beverly Hills. The shopping you don't have to explain. That's sort of self-explanatory. Rodeo Drive doesn't need an explanation. It's more – what there is to do aside from that

Tell us about your family.

I met my wife [Angelika] in LA at UCLA. We lived here in 2005. I have twin boys [Leopold and Maurus] who were born in La Jolla. I have two girls. They are 20 [Leonie] and 17 [Valentina]. So, a total of four kids. My oldest one is a student at UCSB - University of California Santa Barbara. My second daughter is a senior in high school. We live outside the city, just next to Calabasas in Oak Park, which is a small place. We are a very outdoorsy family. Which is why we picked that small spot. We love to go hiking. We are avid mountain bikers. We love to go to the beach, buggy board, and surf. We love to take advantage of all that California has to offer. We are also big into skiing. Mammoth, Lake Tahoe, Big Bear, the winter is where we spend the weekends. We truly enjoy the outdoors and have a fun time that we can do year round. Which is something we missed on the east coast where six months out

of the year the weather is really bad and there's not much you can do. That's what we enjoy most in Southern California as a family. We spend quite a bit of time together and enjoy the outdoors as much as we can.

In Issue #1033 of the Weekly, incoming Conference and Visitors Bureau Chair Eliot Finkel said there is a lot of cross connection between the CVB and the Chamber of Commerce. How do you see the CVB and the Chamber of Commerce working together to achieve common goals?

Yes, he is absolutely right. I actually would expand it a little bit. It's the CVB, Chamber of Commerce, and the City Council. I think these are the three forces in Beverly Hills who partner. We partner to have all the businesses. The CVB is predominantly focused on growing tourism. The Chamber is focused on the well-being of the businesses. But at the end of the day, we're all following the same goal – which is to make sure all of our businesses prosper. And I think the City Council of course needs to make sure there is balance between tourism, the businesses, and the folks that live in Beverly Hills. I think the beautiful thing about Beverly Hills is that we're much smaller than LA but it allows us to have a much more amicable environment. We truly know one another. We know what the strengths of these organizations are. We can complement each other and really make sure to move forward in unison. I think that's very important. I worked at Cities where it's very disjointed where each of these organizations just does what it believes is right. In Beverly Hills, there is a strong sense of unity between the City Council, the CVB, and the Chamber of Commerce. And that allows us to achieve these goals much quicker and much faster, which is to the benefit of all three stakeholders.

What do you hope to accomplish as **CVB President?**

What I really would like to do during my Presidency this year is make sure that we re-establish ourselves as set initially. We have a lot of work to do filling the hotels and restaurants. We need to accelerate tourism and TOT. Which is a big indicator - which is the tax the City collects from the hotels. Which is used to fund the CVB. It can only happen if you fill the hotels. Obviously, it's important to make sure to not just bring tourism to town. We also need to get jobs back. A lot of hotels have not brought back the entire work force that we had pre-pandemic. So, we want to make sure we get people back to work, all of them. We want to make sure with the tourism that comes back to Beverly Hills we get to fill the restaurants; we get to fill the businesses. People spend money. I really see us a bit as an economic engine. If we do well, the hotels and the rest of the City will too. My primary goal is to accelerate the growth so we all benefit from that.




