BHUSD Receives a Meager \$1M in Metro Case

The District has received a judgment of approximately \$1 million in the Metro (MTA) case Friday after spending millions in legal fees. BHUSD demanded \$15 million and Metro offered \$1.2 million. The jury came in slightly less than Metro's final offer.

Litigation against Metro from BHUSD began in 2012 when the district filed suit to block the Westside subway route. In 2019 the eminent domain lawsuit case began after the district lost all of its appeals.

"We are very disappointed with the results. Unfortunately, the results represent years of decision-making by the prior board majorities along with former attorneys and construction/bond manager. Thankfully, this chapter of our history is over and I am excited to move forward with greater transparency as well as better fiscal and legal management with our new team in place," Board of Education President Mary Wells

Eminent domain is a constitutional action where the government exercises ownership over private property for public use. When the government exercises that right, they then have to pay damages. Pursuant to construction of the subway tunnel under the school, Metro filed a lawsuit in 2019 that alleged that they were going to take domain of some of BHUSD's private prop-

Metro sought an easement underneath the district office on Lasky. The second easement is by the athletic fields where the district was planning to build Building C and the new aquatic center. Part of what Metro wanted was to go underneath where

Building C was going to be developed.

According to the plan, building C was going to be developed with spreading footers. BHUSD determined that because they were going to do spreading footers and build a three-level parking garage, Metro was going to have to pay increased costs.

BHUSD is no longer planning on building the three-story parking garage, and intends to build a one-story underground parking garage instead. However, no plans have yet been finalized due to the shortfall in funds.

"The jury verdict is a complete vindication of Metro's decade-long position that subway construction under the Beverly Hills [Unified] School District property was safe and that the value of the subsurface easement was minimal. The \$1 million. that the jury awarded Beverly Hills could have been negotiated in less than an hour over a decade ago. But BHUSD chose to spend in excess of \$20 million to prosecute a frivolous, politically motivated lawsuit that enriched the lawyers and short changed the taxpayers and students of Beverly Hills. These funds should have been spent on the education of Beverly Hills students," former County Supervisor Zev Yaroslavsky

Judge Reduces Felony Charge Against Friedman

A Superior Court judge on Monday dropped one felony count of identity theft against Adam Friedman, one of Councilmember Lester Friedman's sons. The judge did not drop the second misdemeanor charge of internet/electronic impersonation.

Friedman is accused of setting up a fake online account in April for Sharona Nazarian when both Nazarian and Lester were running for City Council. The fake account was an Instagram page titled "Sharona-4Gascon" that included statements in support of Los Angeles County District Attorney George Gascón.

"It's political satire, it's political parody. That's something that comes with the territory of being a political and public figure," Leonard Friedman, the attorney representing Adam, said.


Scully was awarded the key to the city by Councilmember John Mirisch in 2017. Tuesday night's City Council meeting was also adjourned in Scully's honor.

According to her website, Dodes' platform includes school safety, mental health support for students, academic recovery, and expansion of pathways.

Dodes' said she will advocate keeping armed guards and push for d e d i c a t e d SROs to be re-

instated at school sites. She said in addition to the Norman Aid Center at Beverly High and the Bulldog Aid Center at Beverly Vista, she will press for similar centers to be implemented at the K-5 schools. She also hopes to continue to build out course offerings to provide robust learning experiences in addition to the Career & Technical Education (CTE) offerings.

"In education, the whole child approach is a philosophy built on the premise that supporting a child's academic needs is not enough — one must support their social/emotional needs and physical health as well. As a Board Member, I will take a whole district approach, ensuring that everyone in our community — students, teachers, staff members, and parents — remain an integral part of our schools' success, and are invited to participate in policy conversations, extra-curricular activities, and the ongoing mission of supporting our students and teachers," Dodes said.

Beverly Hills Seeks Default Judgment Against YouTube Creator

The City of Beverly Hills has filed a default judgment against a YouTube video creator to compensate for police and administrative costs associated with a parade that caused the closing of Rodeo Drive.

On Oct. 26 the City filed a lawsuit against YouTube creator Austin McBroom who allegedly held an unauthorized assembly in the form of a parade through the streets of Beverly Hills. The City is seeking \$200,000 for the cost of police and related administrative costs.

According to the complaint, McBroom promoted a boxing event in May of 2021 that sought to sell pay-per-view streams of the fight. The other defendants in the case include Sheeraz Hasan and his company Sheeraz, Inc.

In the City's application for a default judgment filed last Friday, lawyers state all three defendants have ignored the litigation and should be found in default. The city is

seeking \$21,307 in damages and \$2,455 in costs.

The City alleges that in order to promote the boxing match, McBroom conspired with the other defendants and hatched a scheme to hold an unauthorized parade through Beverly Hills.

In order to hold a parade in Beverly Hills, an event organizer must request a permit and work closely with city staff to help ensure that any public safety concerns are addressed, along with the collection of permit fees and procurement of insurance providing liability coverage for the parade.

None of the defendants applied for or received any permit for this parade, according to the complaint

The city became aware of the planned gathering through McBroom's social media posts. The Beverly Hills Police Department (BHPD) knew this event would be a non-permitted parade event and subsequently formed a plan. This plan involved over 35 BHPD officers, seven Santa Monica Police Department officers, 13 armed guards, one airship, several administrative personnel, and contingencies for more personnel to assist in the event of any mass bookings or arrests.

According to the complaint, the city alleges that McBroom posted a flyer on his Snapchat advertising a "YouTube Takeover Parade" on Saturday, May 29, 2021, at 4 p.m. at 347 North Rodeo Drive. In the flyer, McBroom implores his fans to "BE READY TO TAKE OVER THE STREETS." Hasan also promoted the parade, through his company.

City Council Calls Upon UN to End Independent International Commission of Inquiry

The City Council adopted a resolution calling upon the United Nations (UN) to end the Independent International Commission of Inquiry on the Occupied Palestinian Territory, including East Jerusalem, and Israel due to the bias of the Commission against Israel, anti-Semitic statements made by two of the assigned Commission members; and the questionability of whether or not those two Commission members can be impartial in their analysis.

Previously, the City Council had adopted a resolution opposing the UN's resolution to deny Jewish historical and religious claims to the Temple Mount and the Western Wall in Jerusalem, as well as another decision of the UN's High Commissioner for Human Rights to release a list of companies that do business in Israeli settlements in the West Bank.

Navi Pillay (South Africa), Miloon Kothari (India), and Chris Sidoti (Australia) are the three members serving on the Commission.

During a presentation of a report from

the Commission to the UNs Human Rights Council, Sidoti, said "Accusations of antisemitism are thrown around like rice at a wedding", which is viewed by Israel as an anti-Semitic statement, according to the staff report.

On July 25 Kothari participated in an interview with Mondoweiss Podcast, a publication known to be critical of Israel's policies toward Palestinians, according to the staff report.

During the interview, Kothari said "I would go as far to raise the question of why they are even a member of the UN as the Israeli government does not respect its own obligations as a UN member state. They consistently, either directly or through the US try to undermine UN mechanisms."

Due to the bias of the Commission and the anti-Semitic statements made by two of the assigned Commission members, Councilmember John Mirisch requested the City Council consider adopting this resolution calling upon the UN to disband the Commission.

Planning Commission Approves Medical Use Regulations Ordinance

At last Thursday's meeting the Planning Commission approved an ordinance to amend medical use regulations applicable to certain commercial zones in the City. The draft medical regulations would replace the Medical Conversion Urgency Ordinance that will expire in Nov.

Since Nov. 2020, the City has implemented an urgency ordinance that allows the conversion of existing commercial spaces to medical spaces. The ordinance was intended to create more flexibility for property owners with regard to the use of space in commercially zoned properties during the COVID-19 pandemic, when vacancies of commercial spaces were increasing and demand for typical commercial uses was decreasing. The City Council extended the urgency ordinance for its maximum effective period, with an expiration date of Nov. 16.

The Council recently directed staff to work with the Planning Commission to develop permanent regulations to replace those in the urgency ordinance that will become effective before the urgency ordinance expires.

On June 9 the Commission discussed the regulations that should be included in the permanent version of the urgency ordinance, based on the direction provided by the City Council. The Commission expressed support for the existing regulations and proposed some changes to the regulations. These changes included the removal of the requirement for a tenant lease and business tax license prior to conversion of the space to medical, more flexibility for medical uses on the ground floor and surgery uses by potentially relaxing the restrictions, and allowing new medical uses to be established in newly constructed buildings.

The draft ordinance will be presented to the City Council for final approval.


You received your B.A. in Music from the University of Belgrade/Serbia-former Yugoslavia, and your M.M. from UCLA. Tell us about that.

cuss possible amendments to the Rent Stabilization Ordinance (RSO) to the Beverly Hills Municipal Code (BHMC) regarding surcharges that allow housing providers to pass through costs to tenants relating to water service penalties and/or surcharges, and refuse fees, at their Wednesday meeting.

The BHMC allows for surcharges that provide for a housing provider to pass through certain expenses without undertaking a rent increase application process. Housing providers for both Chapter 5 and Chapter 6 tenants may pass through the following surcharges: water service penalties and/or surcharges, at a rate of 90% of the penalties and/or surcharges imposed by the City; and Refuse fees imposed by the City, at a rate of 100% of the fees.

The BHMC also allows housing providers to pass the following additional surcharges to Chapter 5 tenants only: capital expenditures surcharge; improvement expenses mandated by law; utility expense surcharge; and additional tenant rent increase - the property owner may raise the rent a maximum of 10% of the base rent for

each additional tenant until the additional tenant vacates the unit.

At their July 6 meeting, the Commission came to a resolution on a recommendation to the City Council regarding the maximum allowable rent increase and continued the second issue on surcharges to be discussed at their next meeting.

BHHS Football Team To Open Fall Practice Monday

Beverly High will begin fall football practice Monday with about 30 players, coach Marquis Bowling said.

Bowling said he was a "little disappointed" by the reduced turnout.

"I thought we were trending in the opposite direction," said Bowling, who is beginning his second season as the Normans' coach.

Beverly Hills had 49 players on its roster to begin the 2021 season, Bowling said. The Normans began the 2019 season with 25 players, according to then-coach Jarrod Bunch. Plans to play a four-game schedule in March and April 2021 were dropped because Bowling had to leave the area because of the death of a relative, he

The lack of players has been a key reason the Norman football program has struggled in recent years, with players forced to play offense, defense and special teams with little time for rest on the sideline.

Beverly Hills has had 10 consecutive seasons of three victories or less, including in 2021 when it was 1-9.

At least three players who played for the team in 2021 and were eligible to return for the 2022 season have opted not to play, Bowling said. Arian Naim, who had been a starting cornerback, decided to concentrate on track. Running back Cameron Park and special teams player Nathan Yashouafar will be team managers in 2022 instead of players, Bowling said.

Under Southern Section rules, the first three days of practice are a conditioning period, where football shoes, helmets and footballs are the only equipment allowed to be used and body contact, including blocking and tackling, is prohibited.

The Normans are set to open their season Aug. 26 with a nonleague game at Maranatha. Beverly Hills lost to the Minutemen, 38-0, to open the 2021 season.

2018 Beverly High graduate Dominique Petrie is among 116 players set to participate in the 2022 USA Hockey Women's National Festival which begins Monday in Buffalo, New York.

The five-day festival will be used to evaluate players seeking to make the 2022 U.S. Women's World Championship or the U.S. Collegiate Select Team rosters. The rosters for those teams will be announced Aug. 14.

Petrie completed her Harvard career in March tied for 45th on the Crimson's career scoring list with 71 points in 76 games over three seasons. Harvard's 2020-21 season was canceled by the Ivy League because of the coronavirus pandemic.

Petrie earned All-Academic status from ECAC Hockey all three seasons she played for the Crimson. She received a bachelor's degree in economics in May. She will play for Clarkson University in the 2022-23 season.

Petrie was a member of the U.S. team in the 2017, 2018 and 2019 International Ice Hockey Federation Under-18 Women's World Championships, winning gold medals in 2017 and 2018 and a silver medal in 2019.

Solomon Margo on The Tokens reboot "Wimoweh"

Solomon Margo, who is the grandson of the Tokens' co-founder Phil Margo, will be performing at Concerts on Canon on Aug. 25 with the band "Wimoweh". Wimoweh is a reboot of the band the To-

kens, best known for the #1 hit song "The Lion Sleeps Tonight". Margo is also a 2017 graduate of Beverly High.

You are one of the key members in the band Wimoweh, which is the Tokens reboot. Tell us about

I am the grandson and great-nephew of two of the founding Tokens members [the late Phil and Mitch Margo]. After their passing, we couldn't quite sit with the thought of never hearing the Tokens' music on stage again. Even though their major hit

single "The Lion Sleeps Tonight" will echo in the musical halls of fame for decades and possibly even centuries in the future, we knew that most of my family's musical legacy would be erased. While the majority of the show will still be the songs you have known and loved for the past sixty years of touring, we really wanted to include some of the deep cuts that never made it to the public's eye.

We last spoke in Issue #1076 in May of 2020, where you told us you had just released your first single "Shelter"

and planned on creating an album one day. What came of that single?

I am definitely still in the throes of finding an audience and haven't quite aced the whole "marketing" aspect of the music world, which is a bigger part of the music business than most would want to admit. I have released eleven singles to date and produced and engineered for many other artists as well. When we last spoke, I think I was strictly writing songs on guitar. Since then, I have acquired a

strong taste for computer-based music production, and that has allowed me to spread my wings to other opportunities. I met some awesome people while I was in New York for college [at Fordham University], and I am excited to see who I will meet and work with here in Los Angeles.

What made you want to continue the musical legacy of the Tokens?

Phil was the best grandfather one could have. He had unconditional love for all of his grandchildren and never ceased to be so vocal about his love. When I was a kid, we would watch westerns and talk about the Cosmos. I would watch him perform and bask in the awesomeness of my family's history. Phil did so many things in his life. He rode horses, hang-glided, was a cop, a pilot, and a creative prodigy. He wrote films, music, and novels. His bedroom was filled with gold records, memorabilia, and a whole lot of butterscotch candies. He had undying support for my acting career, and I wish he could have seen where I will take music.

Phil used to say "If you hang around long enough, you can grow your own band." Would you say that has come

I definitely don't need to explain much on this one. It has come true in a beautiful way. My cousin [Ethan Ginsberg-Margo] and I are both new members of the band, and my father Noah is still on the drums. It is sad but also beautiful to see new leaves grow where old ones have

On Aug. 25, what can we expect to see at the Concert on Canon? What's in store in terms of the playlist?

The playlist will consist of old songs you know and love like "Tonight I Fell in Love," "Knock Three Times," and of course "Lion." We will also be playing many of the amazing songs from Phil and his brother Mitch that fell off the radar. Phil and Mitch released some incredible albums like "Cross Country" and "Intercourse" later in their career. Many of these songs truly deserve to be played religiously, as in so much because the art is so good.

Tell us about the other members of the band. Who does what?

My cousin Ethan Ginsberg-Margo

(who is technically my half-brother due to our fathers being identical twins and having the same DNA) is taking over the keys. He has a background in jazz piano and electronic music production. We have been best friends since we were children, and now we finally live together as roommates, chasing a similar career together, and complimenting each others' talents. Next up is Rebecca Curci. Becca has actually performed with the Tokens at previous shows, as she was a part of one of Phil's passion projects, "Those Girls." Rebecca is holding down the background vocals and singing lead on many songs as well. She easily has the most well-trained vocals in the group, and we are super lucky to have her on board. We are also very lucky to have bassist Nico Wicklin. He is a true magician on the bass, and he even came to the first band rehearsal completely offbook. That's some dedication right there. Penultimately, we have previously existing Tokens one-man-horn-section and musical genius, Jay "Jaysie" Leslie. Last but not least, my father Noah Margo will still be slamming away on those drums, and we really owe it to him because he conceived of this entire tribute.


