Traffic and Parking Commission Discusses Beverly/Cañon/Lomitas Traffic Safety Analysis

At last Thursday's meeting the Traffic and Parking Commission discussed the safety analysis completed for the Beverly/Cañon/Lomitas intersection, which will be used to evaluate potential traffic control improvements, including a roundabout

"I have felt for a very long time this is a very dangerous intersection. In my humble opinion, it doesn't matter if it's tourists, residents, or commuters. It's dangerous, we've seen video after video. This isn't because of COVID, this isn't because of after COVID. It's existed for a very long time. I am very in favor of a roundabout there," Commissioner Lisa Schwartz said.

At their May 5 meeting, the Commission was provided with an introduction to the traffic and safety issues observed at the intersection and discussed an evaluation being conducted by engineering design firm, GHD, Inc. This evaluation will identify possible design alternatives to improve traffic safety.

GHD, Inc. has concluded the following regarding the safety analysis: there are persistent conflicts/near misses occurring all day and at all six approaches to the in-

tersection; drivers familiar with the configuration tend to be less likely to wait in line to approach the intersection and exhibit aggressive driving behaviors; there are few people walking and biking across the intersection; and excessive speeding and stop sign violations are not above normal levels compared to statewide data.

GHD will identify possible design alternatives to improve traffic safety and efficiency at the intersection using the results of the safety analysis as a foundation.

The potential design options will be presented at a future meeting.

Suspects Sentenced for Beverly Hills Robbery

Four suspects who were arrested back in April entered guilty pleas for robbery and grand theft charges.

On April 27 Beverly Hills Police officers responded to the 9600 block of Wilshire Blvd for an armed robbery investigation. At the time, it was reported that three suspects approached the victim from behind. One suspect grabbed the victim around the neck, while a second suspect pressed an unknown object to the victim's side. The third suspect removed the victim's property.

Using both City-owned and private cameras, detectives identified a suspect vehicle. This information was relayed to surrounding law enforcement partners. Later that evening, officers from the Los Angeles Police Department located the wanted vehicle and detained the occupants. BHPD Detectives responded to LAPD Southwest Division and connected the suspects to the Beverly Hills robbery and booked them. Through additional detective follow-up investigation, a fourth suspect was identified.

On Tuesday, August 30, 2022, all suspects entered guilty pleas and were sentenced to a combination of jail time and probation as follows: Keith Clark pled guilty to robbery and received three years in prison and a second strike for being on active parole at the time of the crime; Milton Course, driver of the vehicle, pled guilty to grand theft and received 32 months in prison; Nicholas Henry pled guilty to robbery and received one strike and three years probation with time served; and Tyree Dixon, the suspect who grabbed the victim from his neck, pled guilty to robbery and received a four-year sentence.

Planning Commission to Discuss 313-323 North Rodeo Drive Project

At their Thursday meeting the Planning Commission is expected to discuss a proposed project that involves the demolition of two existing commercial buildings located at 313-323 North Rodeo Drive.

The proposed project includes the demolition of the existing commercial buildings and surface parking lot and the construction of a new three-story commercial building with rooftop uses, a small surface parking lot, and an alternative parking facility located in the subterranean parking level. Access to the proposed building would be provided via the main

pedestrian entrance along North Rodeo Drive.

Retail uses would be located on the ground and second floors. A restaurant with open-air dining would be located on the third floor along with a reception lobby and a private dining room. A paved terrace and rooftop penthouse is proposed and would include various amenities including a lounge area, coat room, closet, pantry, and dressing rooms. A courtyard that opens towards the sky and rooftop is also proposed.

The parking for the proposed project would be provided through a combination of existing in lieu parking spaces previously approved for the two properties, new in lieu parking, a small surface parking lot, and a subterranean parking level that would include an alternative parking facility. An alternative parking facility is an off-street parking facility where vehicle storage is accomplished with mechanical parking lifts and/or automobile elevators that are operated by a valet or other driver. The alternative parking facility proposes to utilize mechanical lifts to allow two automobiles to occupy a single parking space.

The Planning Commission is expected to conduct the public hearing and possibly adopt a resolution conditionally approving the project.

Traffic and Parking Commission Approve Permanent Neighborhood Slow Streets Program

At last Thursday's meeting the Traffic and Parking Commission unanimously approved a recommendation to transition the temporary Neighborhood Slow Streets Program to a permanent program for the City.

As a response to the pandemic, the City launched the Neighborhood Slow Streets program in April 2021 as an effort to provide for safer use of streets while reducing speeding traffic and discouraging cutthrough traffic on neighborhood streets.

Neighborhood Slow Streets are residential street blocks restricted to local traffic by using the entire street width for walking, cycling, or other modes of non-motorized transportation.

Neighborhood Slow Streets are not street closures and allow local traffic access for residents and their visitors, delivery vehicles, street sweeping, trash pickup, and emergency vehicles.

The program requires a resident sponsor who lives on the proposed street block to nominate their street block for consideration, serve as the block sponsor in obtaining the support of their neighbors, monitor the signs and conditions on the street, and communicate with City staff.

As of Aug. 22, the City has received a total of 22 slow street applications. Ten residential street blocks completed the resident petition process and Slow Street designations were implemented. In Dec. 2021, residents on the 300 block of North Oakhurst Drive requested the removal of their slow street signs due to the subsequent installation of a speed hump on



The Planning Commission of the City of Beverly Hills, at its REGULAR meeting on **Thursday, September 22, 2022** will hold a public hearing beginning at **1:30 PM**, or as soon thereafter as the matter may be heard to consider the following:

Conditional Use Permit. A request for a Conditional Use Permit (CUP) to allow a vehicle sales use at <u>9777 Wilshire Boulevard</u>. The applicant, Galpin Lotus, proposes to occupy the ground floor of an existing multi-tenant building. The project site is zoned Commercial (C-3) and, pursuant to Beverly Hills Municipal



Code (BHMC) §10-3-1604, vehicle sales are permitted only if authorized by a CUP.

This project has been assessed in accordance with the authority and criteria contained in the California Environmental Quality Act (CEQA, Public Resources Code Sections 21000 et seq.), the State CEQA Guidelines (California Code of Regulations, Title 14, Sections 15000 et seq.), and the environmental regulations of the City. Upon review, the project appears to qualify for a Class 1 Categorical Exemption (Existing Facilities) in accordance with the requirements of Section 15301 of the State CEQA Guidelines. This exemption is applicable to the minor alterations of existing public or private structures involving negligible or no expansion of existing or former use. Accordingly, the Planning Commission will consider a recommendation to find the project categorically exempt, pursuant to Section 15301 from further environmental review under CEQA.

In order to be read at the meeting, written comments will be allowed with a maximum of 350 words, which corresponds to approximately three (3) minutes of speaking time. If a comment is received after the agenda item is heard, it will not be a part of the record.

Any written comments received by end of the day on Tuesday, September 13, 2022 will be attached to the agenda report regarding this item. Any comments received after Tuesday, September 13, 2022, but prior the public hearing, will be distributed to the Commission under separate cover.

their street block.

Eleven applications were initiated but did not submit the qualifying number (51%) of signatures from street block residents. One application was denied due to the size of the street and the volume of traffic that it typically handles.

In June the City sent out a survey to eight slow street blocks. The City received 25 survey responses out of 218 addresses. Overall, responses indicated mixed opinions about the program. Several comments note that the temporary slow street signs are frequently hit and damaged by cars. Some respondents expressed concern that the slow streets are advisory and not enforceable.

This item will move to the City Council for final approval.

Beverly Hills Selected as 2022 Finalist as Most Business-Friendly City in Los Angeles County

Last Thursday the Los Angeles County Economic Development Corporation (LAEDC) announced that Beverly Hills is a finalist for their 'Most Business-Friendly City' award.

Cities from across the County applied for this title, submitting testimonials from their local businesses to demonstrate the strong partnership between themselves and City Staff who ensured they were supported for all their needs, especially to those facing economic hardships from the pandemic.

"Our businesses are part of our City's heart and soul," Mayor Lili Bosse said. "We proudly create a supportive environment for them to prosper and grow without having to jump through unnecessary hoops or red tape thanks to our incredible City Staff who make things happen – we treat our businesses like family members that keep our community thriving!"

In 2020, the City introduced its Open-BH Program, aimed at allowing temporary outdoor operations during the pandemic so that businesses could continue operating while following strict health and safety protocols. The program is currently still in place and will be up for City Council review in Dec. The City has also created the Small Business Task Force,

Board Approves New CBOC Member

At their Tuesday meeting the Board of Education approved the appointment of Jasmine Yadgari as the newest member to the Citizen's Bond Oversight Committee (CBOC).

The CBOC is charged with overseeing bond fund expenditures and ensuring they are used for their intended purpose. The committee also reviews Measure E bond expenditures and presents an annual report to the board.

Seven members serve for a two-year term without compensation and for no more than three consecutive terms. The committee must include; one member who is active in a business organization representing the Beverly Hills business community; one member active in a senior citizens' organization; one member who is a parent or guardian of a child enrolled in the district; one member who is both a parent or guardian of a child enrolled in the district and active in the PTSA; and one member who is active in a bona fide taxpayers' organization.

The current members on the Committee include Chair Les Bronte, Vice Chair Nathan Kruger, Richard Baron, Bill Bymel, Marc Carrel, Lee Egerman, Paris Elias-Benyamin, Harry Kraushaar, Yoav Tamir, and Don Wyse.

We've had a meeting about how to receive grants, how to get more money for your business, and we've had a meeting about boundaries. One of our meetings was about building self-confidence. Every month we have a theme that we dive deep into. Aside from

the educational part of our Committee, we also are referral-focused - building each other's businesses in the way of referring to each other business. We actually act as an ambassador for each other to further build our businesses.



What are some goals you have as Chair?

Definitely education on business is number one. Having a plan of where women want to go, what their ultimate goal is, and achieving [them] together is probably my biggest goal for the committee. And network building. The committee is not known for having data that backs up their referrals. They don't have a referral-focused part of the Chamber. Bowling is optimistic Beverly Hills (0-2) "can take advantage" of some of Ver-

bum Dei's weaknesses.

home opener Friday night at Nickoll Field.

"I've told our kids that we won't be the biggest, strongest or fastest but the one thing we can control is our effort. For too many of the kids I didn't see that effort. It was so disappointing that it was the lowest I think I've been since I've been at Beverly Hills," said Bowling, who is in his second season as the Normans' coach.

The team "seemed like (when) we got on the field we were deer in headlights," Bowling said.

"I don't know what it was that stopped us from doing the things we said we were going to do," Bowling said. "We didn't try. There were too many times where the effort was below sub-par. It was disheartening. It was so disappointing.'

The Knights (2-1) are one of the Normans' two nonleague opponents they did not face in 2022. When asked if was a mistake for Beverly Hills to schedule Bishop's, Bowling responded, "it was not the ideal team to play."

Bishop's was 8-3 in 2021, losing to Rancho Bernardo, 15-14, in a San Diego Section Division 2 first-round playoff game.

The Normans trailed 41-0 at the end of the first quarter, 55-0 at halftime and 62-0 entering the fourth quarter.

The loss was Beverly Hills' most one-sided since a 69-0 loss to El Segundo, Oct. 14, 2016.

Bowling praised the play of senior defensive end-offensive tackle Carson Tay-

"He was able to apply some pressure and held his point of attack really well," in his first game since 2019, Bowling said.

PURPOSE

The Beverly Hills Unified School District (the "DISTRICT") desires to commission a reprographics firm (the "VENDOR") to perform reproduction and document management services for the DISTRICT's facility improvement program. The DISTRICT encourages responses from reprographics firms who have strong capabilities in the furnishing of web-based reproduction and document storage, retrieval, and delivery in support of architectural and construction documents and drawings.

INTRODUCTION

The DISTRICT is currently performing modernization programs at one high school campus and one elementary school campus, remediation of oil wells on the high school campus, and other district-wide renovation and modernization projects at various sites. 
