

## City Council Continues Discussion on Health Department

At last Tuesday's meeting the City Council continued their discussion on the formation of a local public health department and agreed to explore the idea further. Specifically, the Council agreed that more information was needed in order to better understand the requirements of forming a health department, such as what services the City has to offer, and that more information was needed about cost and funding.

On Dec. 1, 2020, the City Council reviewed the closure of outdoor dining by the Los Angeles Health Officer. During the discussion, Mayor Lili Bosse requested staff explore the possibility of creating a local public health department, which the City Council unanimously supported.

Some advantages a local public health department may have that are listed in the staff report are: the ability to build programs tailored to the community and create targeted interventions; focus on residents of highest need without having to split resources among vulnerable populations across the County; and the authority to create their own budgets as well as establish taxes.

Some disadvantages listed in the staff report are: limited autonomy due to state-mandated compliance; delays in managing cross-jurisdictional disease investigations and inefficient use of resources for disease surveillance; potentially creating duplicative administration infrastructure or redundant public health services; and loss of economy of scale - a smaller health department is typically more expensive to run than one serving a larger city or entire county.

The cost to provide an annual operating budget for a local health department is unknown and dependent on the level and type of service the City wishes to provide.

"Initially, when we were thinking about this I was very excited about it and when I started to do some research I became a little more concerned because it takes a lot of people to run a health department. We would need to look at how many people we would need to hire or bring in to have a health department of our own. The primary issue I was thinking about was how much it would cost to fund our own health department," Councilmember Sharona Nazarian said.

Nazarian also recommended that the City look into possible ways to expand current services the city offers, such as homelessness.

The City indirectly pays Los Angeles County for public health services, as part of the City's General Services Agreement.

Bosse and Vice Mayor Julian Gold will act as liaisons for the Council to explore the possibility further.

"Mark my words, at some point we will

have our own health department," Bosse said.

## City Council Approves Medical Use Ordinance

In a 4-1 vote, the City Council approved an ordinance related to medical use regulations in certain commercial zones in the City. Councilmember John Mirisch was the sole dissenting vote.

Mirsch has historically been opposed to granting more medical use in the City.

This ordinance allows the conversion of some commercial space to medical space.

An urgency ordinance has been in effect since Nov. 2020 that allows the conversion of existing commercial spaces to medical space through the issuance of a building permit.

The urgency ordinance was intended to create more flexibility for property owners with regard to the use of space in commercially zoned properties during the pandemic when vacancies of commercial spaces were increasing and demand for typical commercial uses was decreasing.

Since the urgency ordinance expires in Nov., the City Council recently directed staff to work with the Planning Commission to develop permanent regulations to replace those in the urgency ordinance. On July 28 the Planning Commission adopted a resolution to recommend the ordinance for approval by the City Council.

Mirsch also addressed concerns he had about the parking.

"I would be concerned for conversions that are along certain areas that are close

to residential for the same reason that we before required free parking. I would ask for that as well," Mirisch said.

The ordinance requires one parking space per 350 square feet of floor area.

The ordinance also prohibits ground floor medical uses and limitations on surgery uses.

## Skechers Requests Use for City Shield

At the Sept. 12 Branding and Licensing Committee meeting, City Council Liaisons Lester Friedman and John Mirisch approved a request from Skechers to use the Beverly Hills Shield on a series of footwear items and apparel. The request will move to the full City Council for final approval.

The City receives inquiries from people looking to use the Beverly Hills Shield on products and merchandise. As requests are received, they are referred to the branding and licensing consultant CMG Worldwide.

Skechers is the third largest footwear company in the world. Skechers x Beverly Hills limited edition collection will feature the Beverly Hills Shield surrounded by sunsets, palm trees, bold colors on sneakers, and slip-on shoes that commemorates Skechers' California heritage and Beverly Hills.

Skechers has indicated that once approved, they will explore finding a local Beverly Hills retailer to partner with for local sales. The collection is also proposed to include one to two T-Shirt and



Hoodie Style designs as well as a blanket.

The initial term of the agreement is proposed for one year with the option to renew for up to an additional two years if sales do well enough.

The approval of the city shield on these items would be conditioned upon receiving draft designs in advance of approval for production.

### Four Beverly Hills Students to Compete in the National Merit Scholarship Program

On Sept. 14 the National Merit Scholarship Corporation (NMSC) announced

the names of approximately 16,000 Semifinalists in the 68th annual National Merit Scholarship Program. Alexandra Bakshian, Ariel Goldberg, Suhh Yeon Kim, and Miles Kottler are among the four students from Beverly Hills who have qualified.

The Semifinalist will have the opportunity to compete for about 7,500 National Merit Scholarships worth around \$30 million.

To be considered for the award, Semifinalists must fulfill several requirements to advance to the final level of the competition. About 95 percent of the Semifinalists are expected to attain Finalist standing, and approximately half of the Finalists will win a National Merit Scholarship, earning the Merit Scholar title.

High school juniors entered the 2023 National Merit Scholarship Program by taking the Preliminary SAT/National Merit Scholarship Qualifying Test. The pool of Semifinalists, representing less

than one percent of high school seniors, includes the highest-scoring entrants in each state.

To become a Finalist, the Semifinalist and a high school official must submit a detailed scholarship application. A Semifinalist must have an outstanding academic record throughout their high school career, be endorsed by a high school official, write an essay, and earn ACT or SAT scores that confirm the student's earlier performance.

From the 16,000 Semifinalists, approximately 15,000 are expected to reach the Finalist level.

### Democratic Club Endorses School Board Candidates

The West Hollywood/Beverly Hills Democratic Club has endorsed Farrah Dodes and Rachelle Marcus for the Beverly Hills School Board.

Rachelle, with her background as a parent, teacher, and board member, brings a unique historical memory which greatly helps decisions at the Board level. Historical memory is invaluable during discussions about the future of the District," Club President Lillian Raffel said.

The endorsed candidates are vetted by the club's Executive Board and approved by a minimum of 60% of membership votes. A Candidate must be a registered democrat to receive the endorsement.

"Farrah, who is a parent and leader in the District, is part of a new generation that has a deep interest in the future of the District. With her combination of leadership skills, technical knowledge, and dedication, she will greatly add to the conversation and to Board decisions," Raffel said.

Due to COVID-19, Next Night did not occur for the past two years.

### BHHS Football Team Projected To Win Homecoming Game Friday

Beverly High will play its homecoming football game Friday against Firebaugh at 7 p.m. at Nickoll Field with the Normans projected to win for the only time in 2022.

The high school football website Cal-preps.com projects the Normans will defeat the Falcons, 27-17, in the final non-league game of the season for both teams.

The website also projects Beverly Hills (0-4) will lose all five of its Ocean League games by margins of between nine (Centennial and Morningside) and 62 points (Inglewood and Leuzinger).

"Firebaugh is a winnable game," Normans coach Marquis Bowling said. "I think there is another game or two maybe that we can actually be in the running."

Bowling said he plans to emphasize his team's running game against the Falcons as Beverly Hills attempts to end a three-game shutout streak.

"For us to control the clock and shorten the game as much as possible and have a chance at the end we have to run the football," Bowling said.

The Normans' only victory in a 19-game span dating back to 2019 was over Firebaugh on Sept. 24, 2021, winning 28-12.

(The 2020 season was canceled because of the coronavirus pandemic. Plans to play a four-game schedule in March and April 2021 were dropped because Bowling had to leave the area because of the death of a relative, he

said.)

The Falcons (1-3) will be playing for the first time since a 48-8 victory over Mark Keppel of Alhambra Sept. 9.

### Whittier Christian 39, Beverly Hills 0

The Normans "didn't contain outside runs" and their offense was stymied by penalties in a nonleague game Friday night at Whittier College, Bowling said.

"We got down to by the 10 a couple times and then we backed ourselves out" due to penalties, Bowling said.

The penalties included linemen jumping offside or lining up off the line of scrimmage for a too many men in the backfield penalty, "something simple like that," Bowling said.

"It's so frustrating," Bowling said.

The Heralds (3-1) led 14-0 at the end of the first quarter and 27-0 at halftime.

Bowling said he changed the team's offensive approach at the start of the second half to emphasize running, using a two-back set after the passing game was ineffective.

Bowling praised the play of Oscar Mantville who rushed for over 110 yards and had "double-digit tackles" and nose guard Max Siemons.

## CITY COUNCIL ADVANCES CHEVAL BLANC

### Development Agreement to be Discussed at a Future Date

At their Tuesday meeting the City Council discussed the Cheval Blanc project, a luxury hotel with public and private dining and ancillary uses, a private club, and street level retail uses facing Rodeo Drive.

In a 4-1 vote, the Council approved the certification of the Project's Final Environmental Impact Report, General Plan Amendment, Master Plan of Streets Amendment, and Zone Text and Map Amendments. The Council also approved the Specific Plan and encroachment agreements and denied an appeal of the Planning Commission's conditional approval of a Vesting Tentative Parcel Map. Councilmember John Mirisch was the sole dissenting vote.

The project site is located at 456 and 468 North Rodeo Drive, 449, 451, and 453 North Beverly Drive; and 461 through 465 North Beverly Drive. The proposed building varies in height across the site. The building would stand four stories, 51' tall on the North Rodeo Drive side, and a maximum height of nine stories, 115' tall on the Beverly Drive side.

On June 13 the Planning Commission unanimously voted to adopt a resolution recommending the City Council certify the Final Environmental Impact Report and approve the aforementioned findings. The Planning Commission also conditionally approved a Vesting Tentative

Parcel Map for the Project, contingent on the City Council's approval of the other required entitlements.

The Planning Commission discussed motor court operations at some of its past hearings where concerns about vehicle backup and delays were brought up, both for the on-site circulation and potentially onto South Santa Monica Boulevard, and a lack of a detailed 'micro-simulation' traffic analysis was cited by the traffic consultant KOA, who commented on behalf of some neighboring retailers.

The Planning Commission said they had concerns that vehicles could back up onto South Santa Monica Boulevard and the number of vehicles exiting the motor court during busy afternoon traffic on South Santa Monica could cause a negative effect. The Commission suggested potential changes to the Project, such as providing a down ramp within the motor court.

The Applicant later returned to the Commission with the following Project modifications: to reallocate the restaurant dining area on the 2nd and 7th floor to be accessible by club members, hotel guests and their guests only; reduce the size of the spa to one level; provide general retail parking off-site through participation in an in-lieu parking program and prohibit retail customers from using the motor court valet to access on-site parking; and

provide up to 15 on site VIP customers spaces.

The Commission also recommended prohibiting left turns from South Santa Monica Boulevard into the motor court.

The existing public alley that runs north-south across the Project Site that serves buildings on both North Rodeo Drive and North Beverly Drive was previously proposed to be relocated to the southern portion of the Project Site. The relocated alley segment would be accessed from North Beverly Drive instead of South Santa Monica Boulevard.

The operation of the alley was a controversial topic during the Planning Commission's review of the Project. After considering the issue, the Planning Commission provided direction to the Applicant to conduct outreach to other alley users and submit a request for the Traffic and Parking Commission to review. After review, the request could be brought to the City Council for a decision.

"You addressed every concern that was said, by every resident and every Planning Commissioner, back from Oct. 28, until the approval. From my perspective, from being on the Planning Commission myself, I don't think I recall ever seeing an applicant work so well with the Planning Commission [and] with the community to really try to get to yes in a very fair and balanced manner," Mayor Lili Bosse said.

On June 30 the City received an appeal petition from GK Law, on behalf of UNITE HERE Local 11, appealing four resolutions adopted by the Planning Commission. Three of the resolutions were recommendations to the City Council regarding proposed entitlements. One resolution is the approval of the subdivision map for the Project.

The City did not believe the Commission's actions to recommend to the Council regarding the environmental impact report and other entitlements were appealable. Thus, only the Planning Commission's action on the subdivision map

was appealable.

Since the Council had not yet reviewed the Project, and because the City Council could not review the subdivision map until they first considered the environmental impact report, general plan amendment, zoning changes, and Specific Plan, it was recommended that the appeal of the subdivision map approval be heard in conjunction with the City Council's review of the rest of the entitlements.

UNITE HERE Local 11 is a union that represents over 32,000 workers employed in hotels, restaurants, airports, sports arenas, and convention centers throughout Southern California and Arizona.

"While only the VTPM [subdivision map] was conditionally approved by Commission, this Appeal challenges all of the above-listed resolutions on the grounds of non-compliance with the California Environmental Quality Act and the Code, as set forth below and contained in the attachments enclosed. In short, the EIR [Environmental Impact Report] inadequately analyzes the Project's impact on traffic, vehicle miles traveled, air quality, greenhouse gas, and land use consistency. In doing so, the EIR masks significant impacts and avoids numerous feasible mitigation measures and project alternatives—particularly a project alternative with a meaningful housing component," attorney Jordan R. Sisson of GK LAW said on behalf of UNITE HERE Local 11 in the appeal application.

The Council denied the appeal and approved the Vesting Tentative Parcel Map.

The approval of the project is contingent upon the development agreement, which will be discussed at a future meeting.





